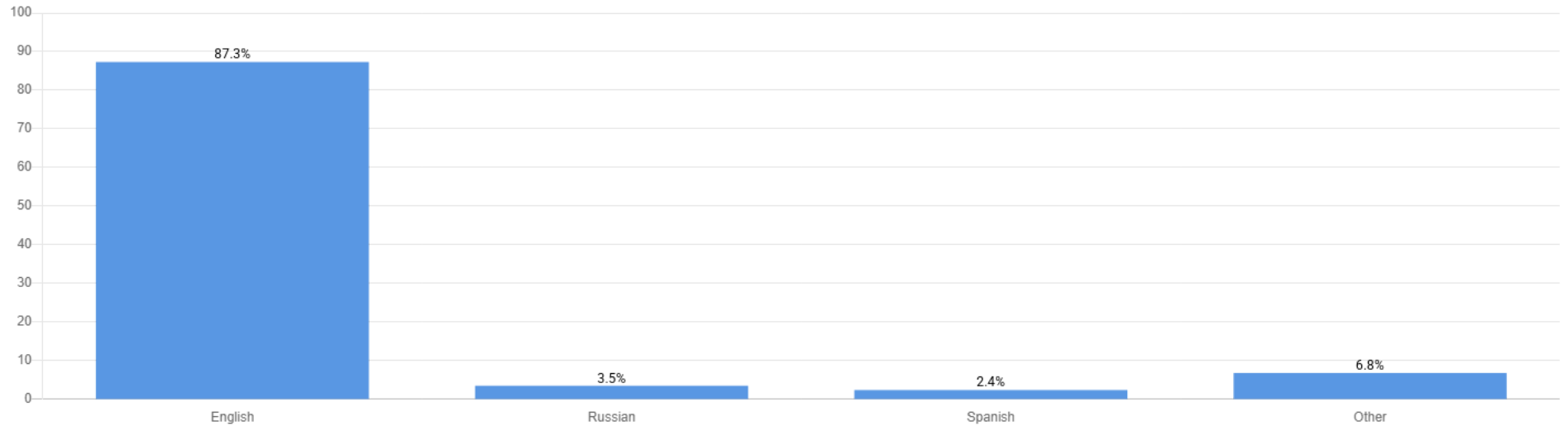

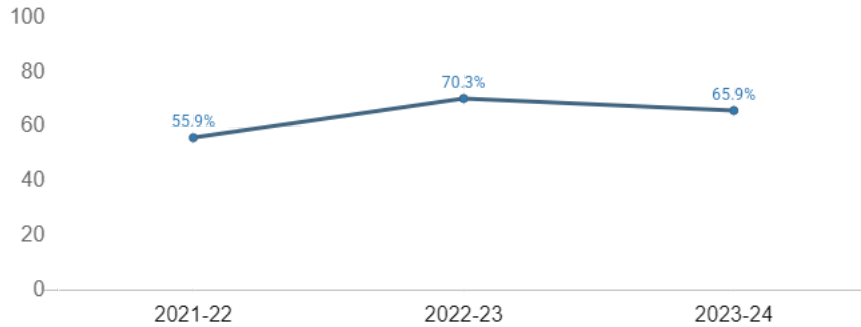

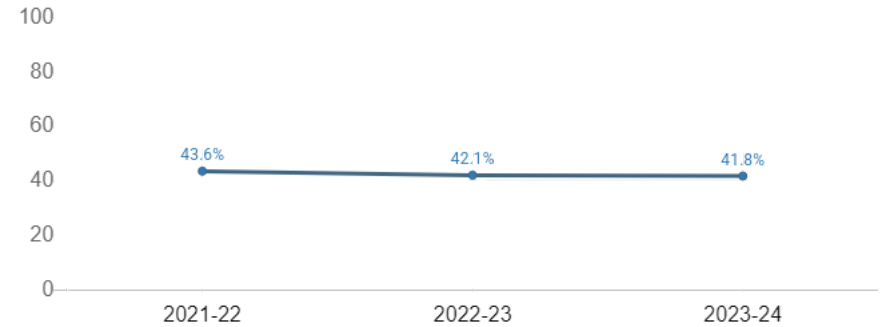
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 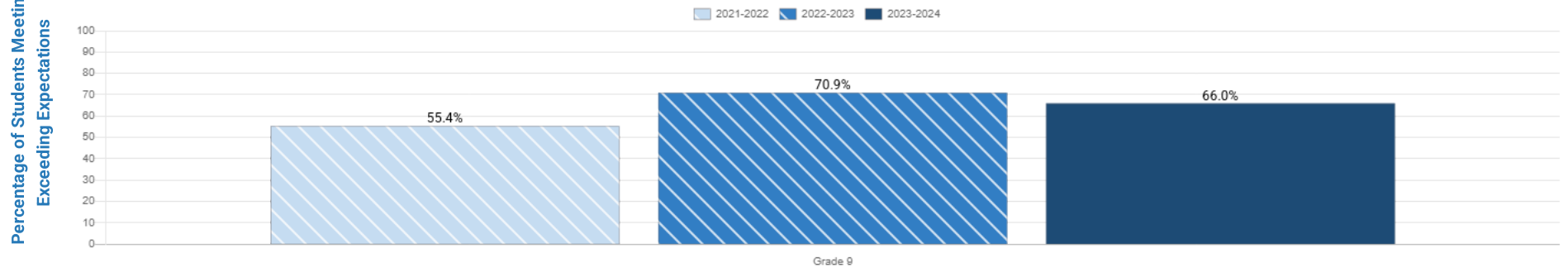

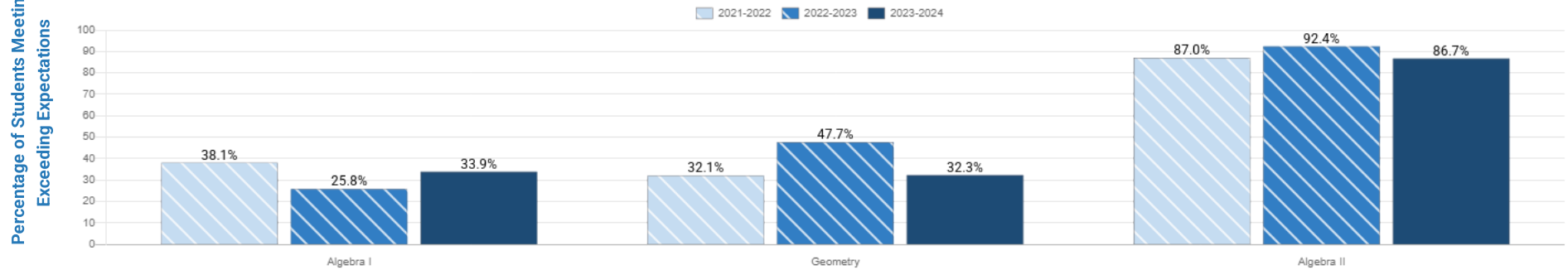

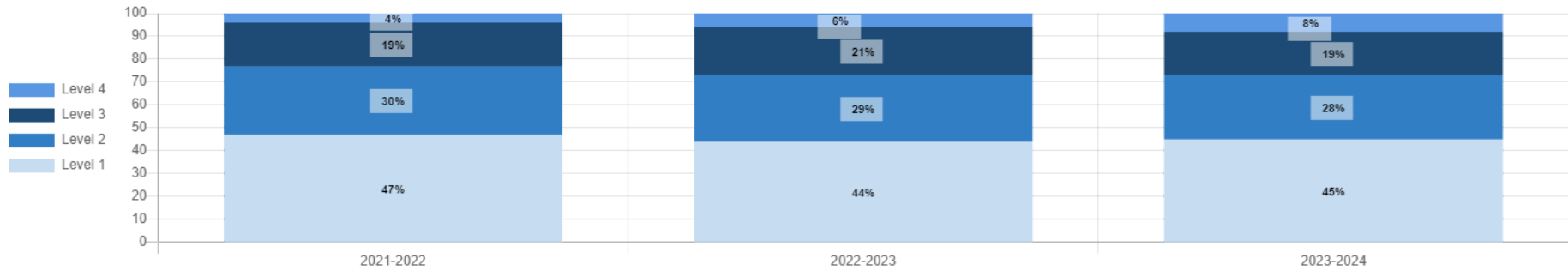

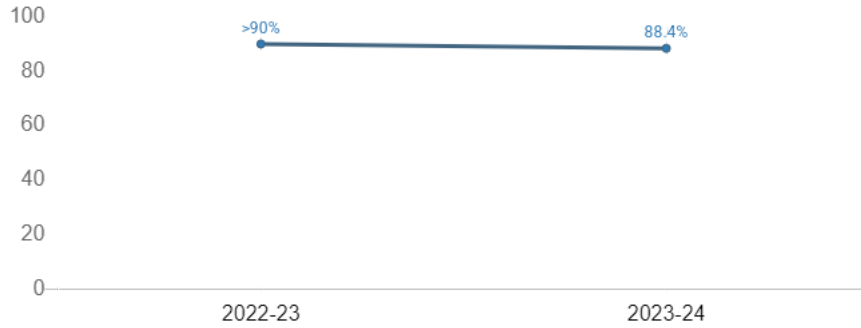

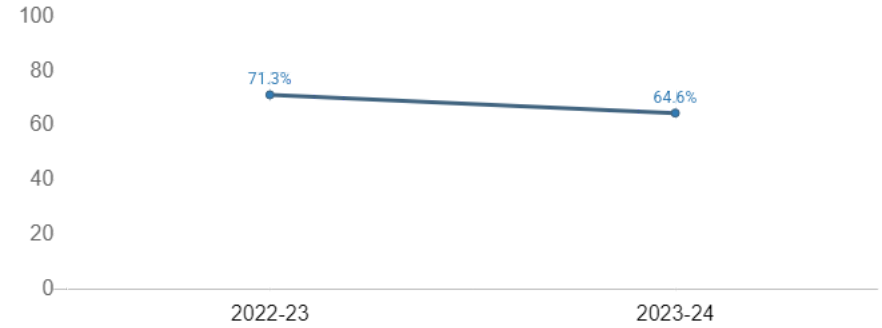

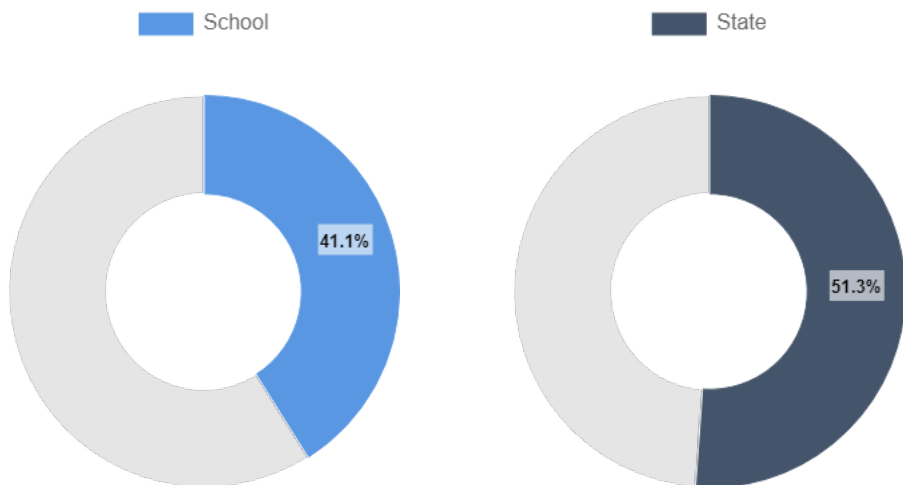

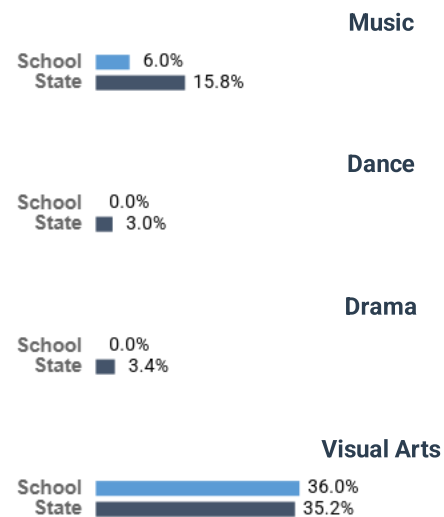

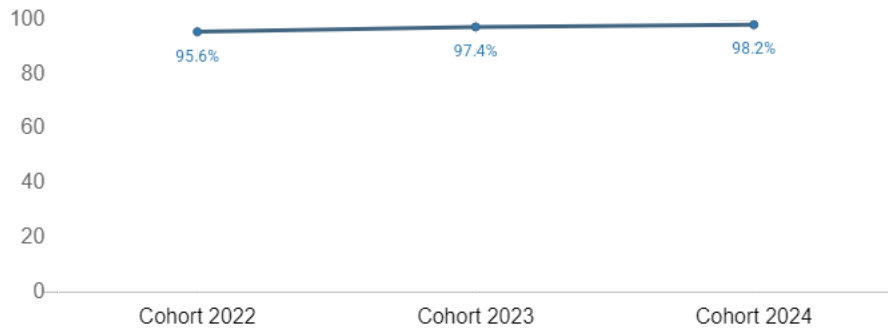

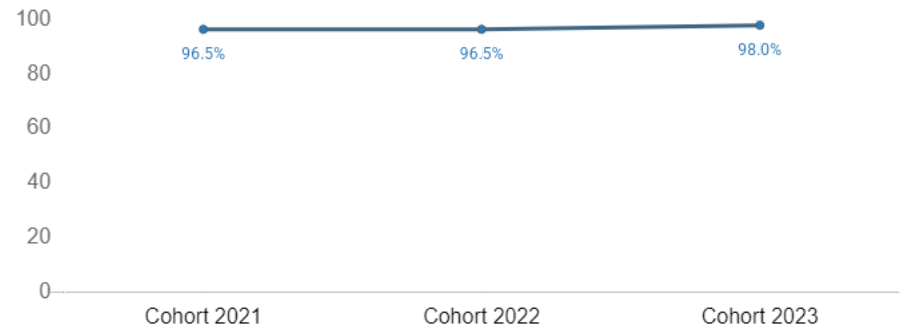

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

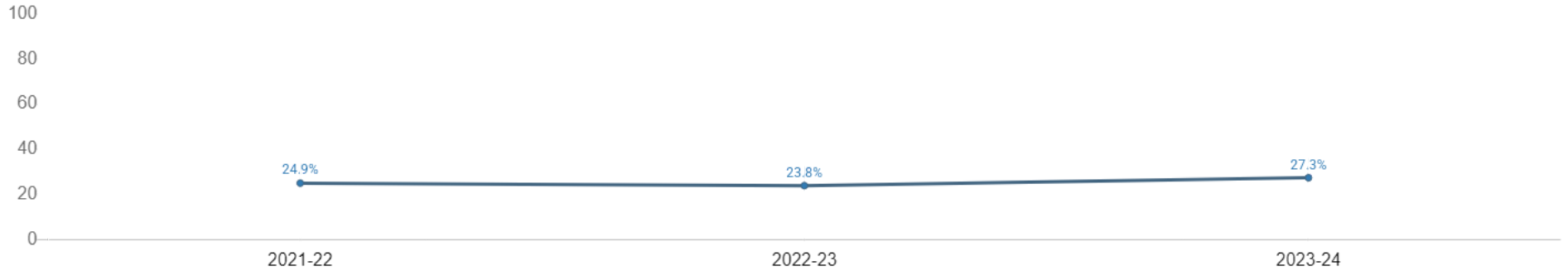

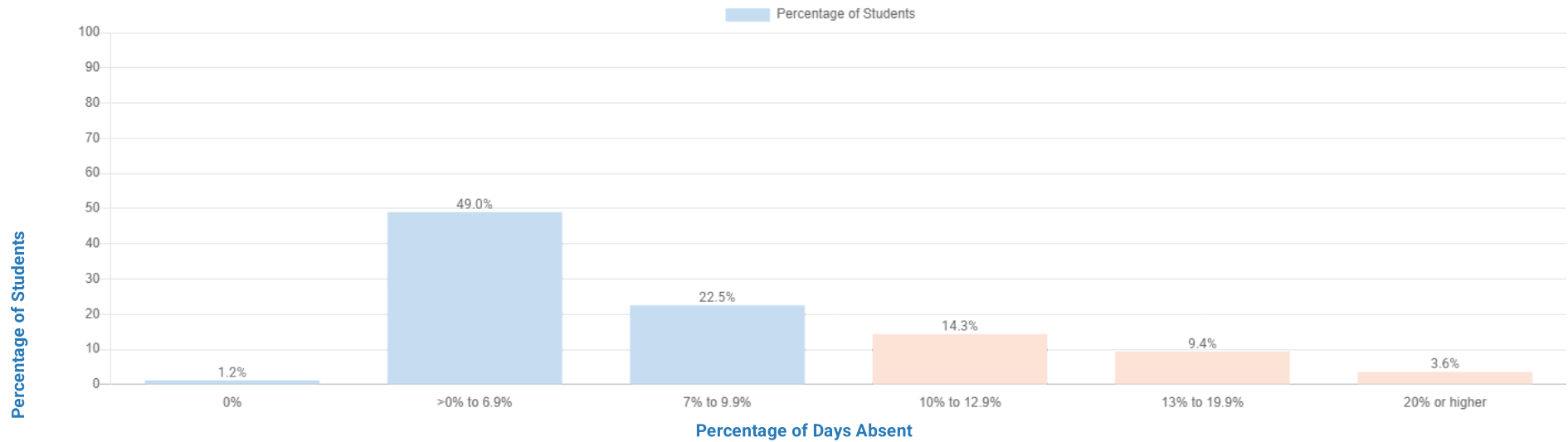

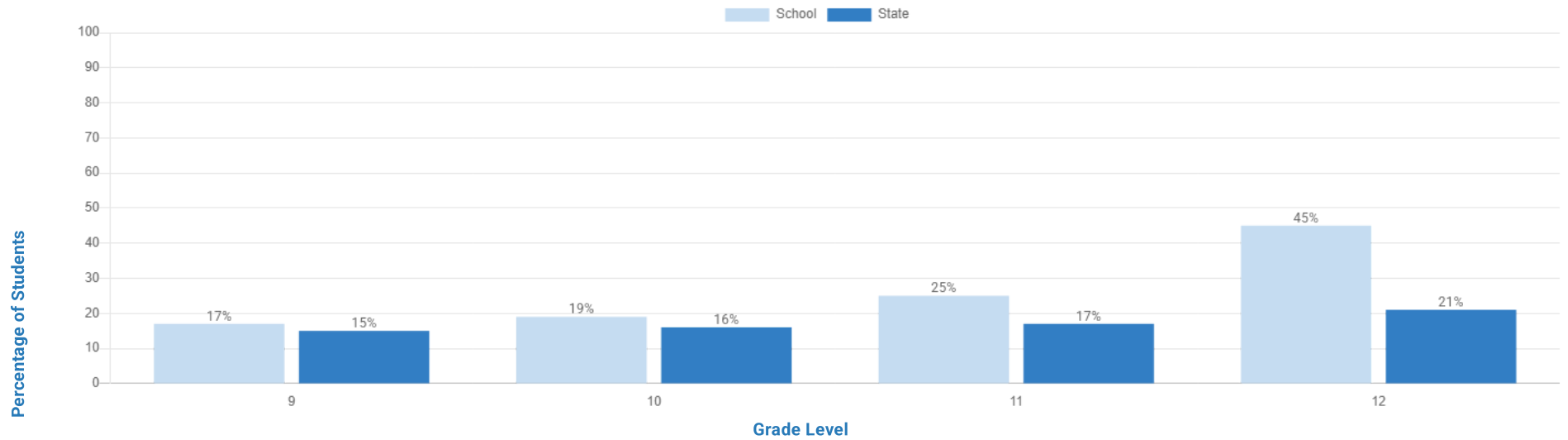

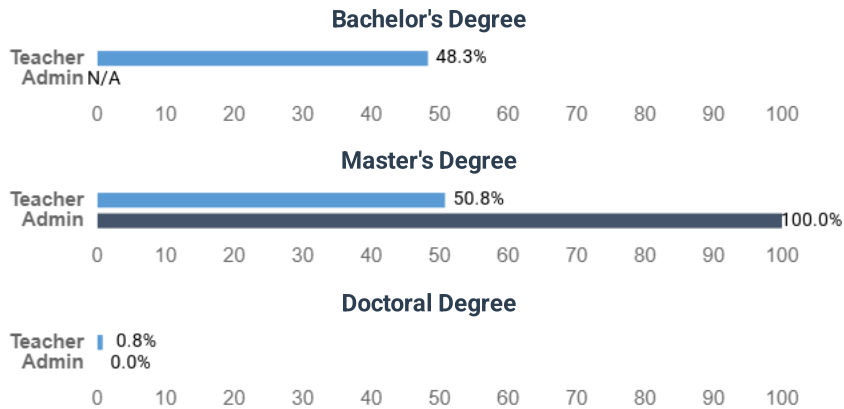

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Unique to Manalapan HS is the Health Professions Pathway Program as well as the Law Enforcement & Public Safety Academy and Science & Engineering Learning Center. These specialized programs allow students to pursue their passions within the comprehensive high school.

The staff and students at Manalapan High School work closely with Manalapan Township and the Manalapan Township Recreation Department to offer programs that benefit the larger community. From nighttime recreation programs for adults and children, to the Manalapan Youth Orchestra, our school serves as a hub for community-wide events, additional educational programs, community meetings, and other special gatherings.



Staff and Professional Learning:

A multitude of professional learning opportunities are available to staff including Professional Learning Communities, SciP committee programs, district-wide collaborative workshops, as well as training offered by professional organizations. All professional learning endeavors seek to maximize opportunities for students to develop important college and career readiness skills essential in a complex global society: critical thinking, collaboration, communication, and creativity. Staff are also provided professional development in Restorative Practices to proactively support the culture and climate of the school. School Counselors and Child Study Team Members enhanced their school-based counseling skills and group facilitation skills through on-going consultation and professional development on group facilitation, stress reduction tools, and executive functioning skills.



Postsecondary Information:

The Counseling Department provides students and parents with individualized information on college and career planning. A College and Career Counselor supports each Guidance Counselor as they collaboratively develop customized post-secondary paths for students based on the District's Guidance Road Map. Students in Grades 9, 10, and 11 are administered the PSAT during the school day. Additionally, FRHSD hosts college and career planning events including: a College Fair, 9th and 10th Grade Post-Secondary Planning, 11th Grade College Panel, 11th Grade College Planning Night, Senior Application Night, Financial Aid Planning, Career and Job Fair, and the College Application Boot-Camp.
