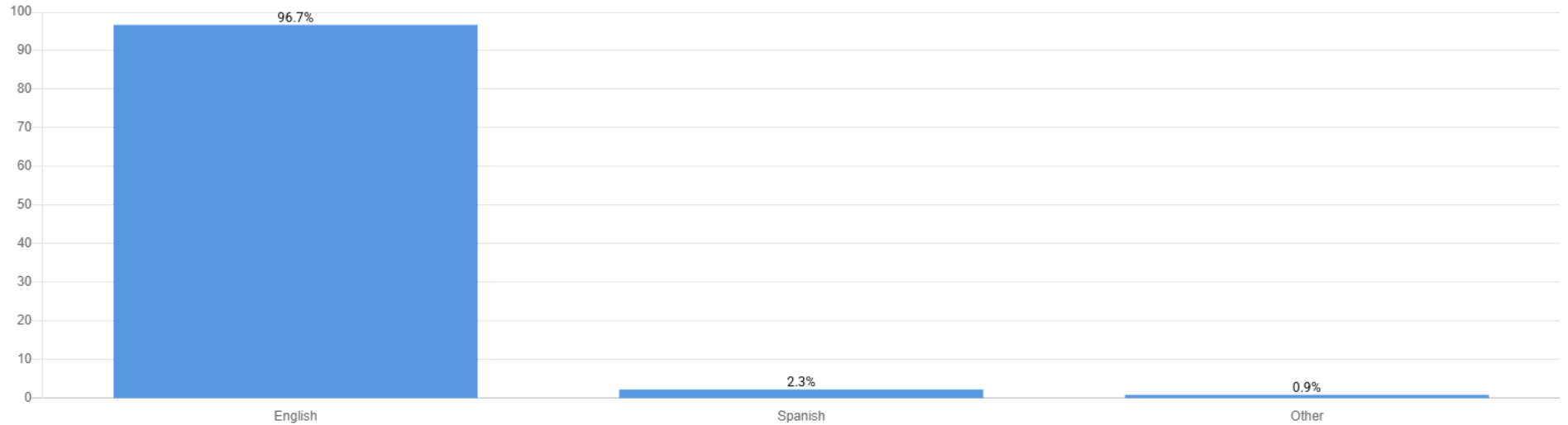

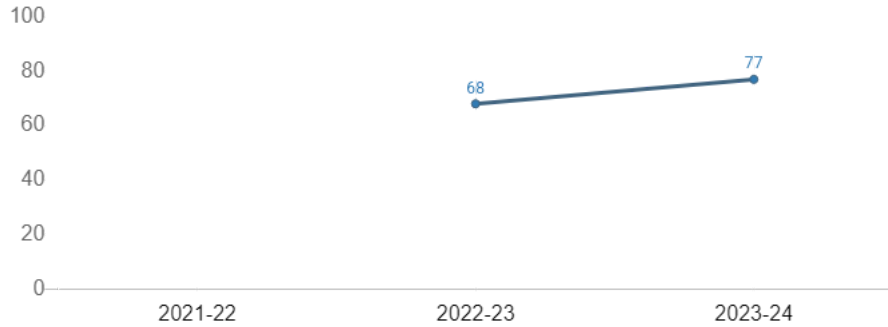

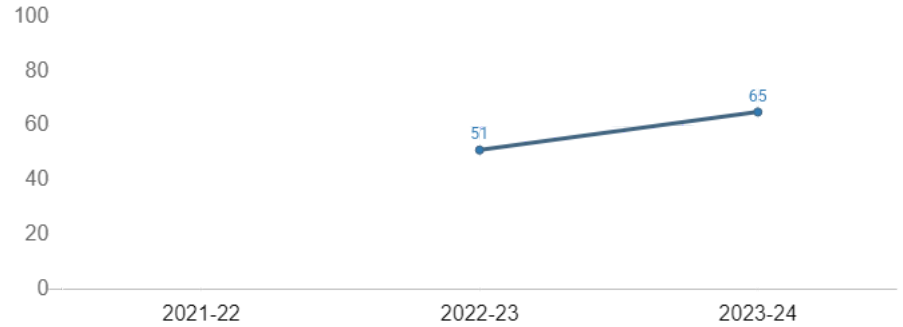

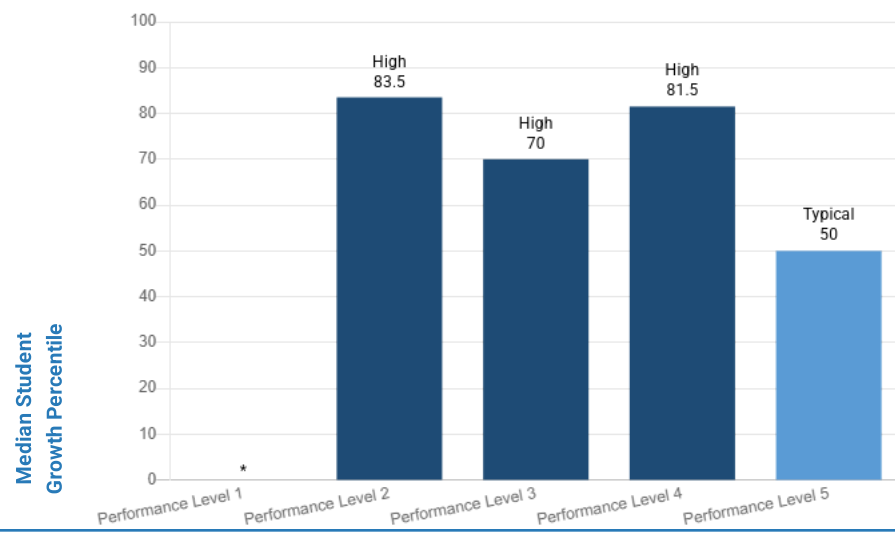

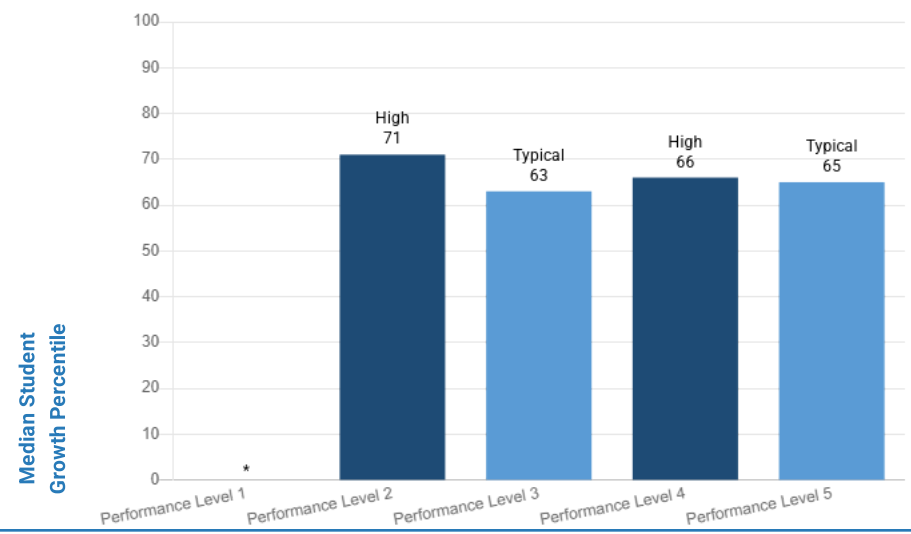

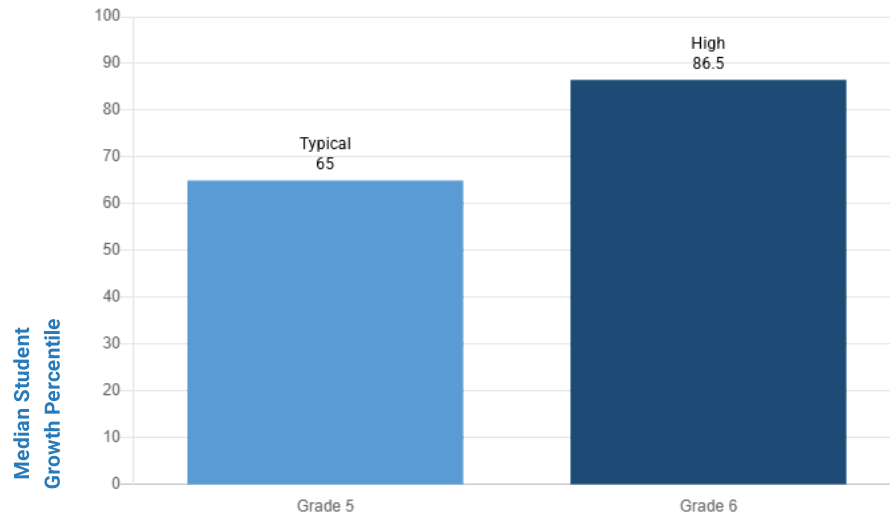

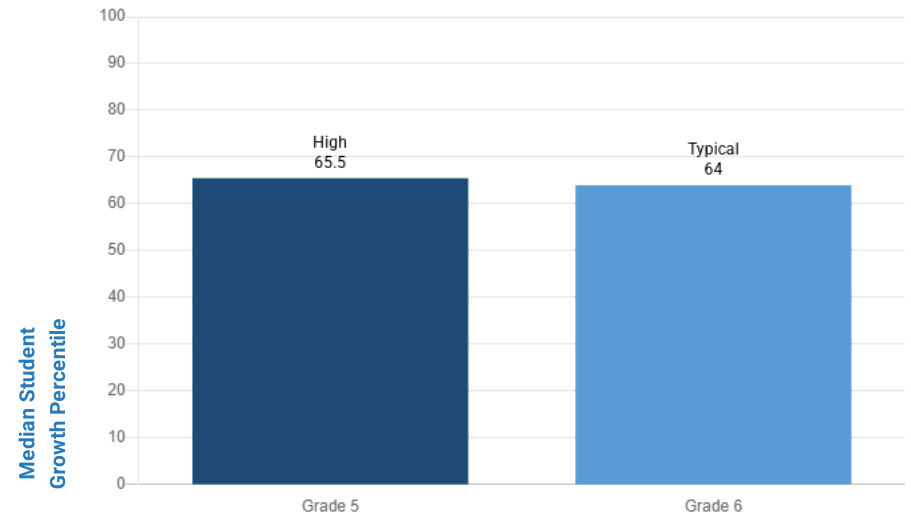

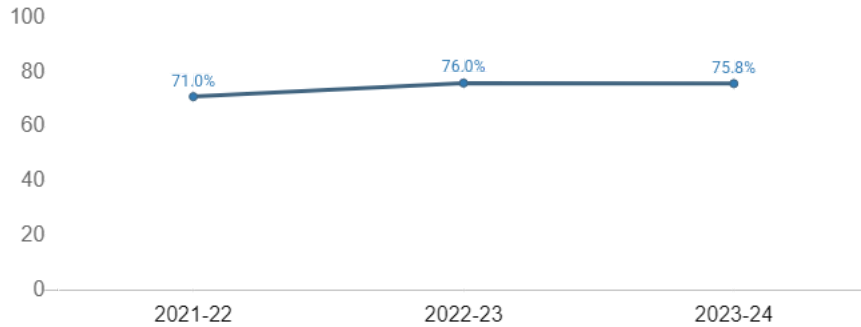

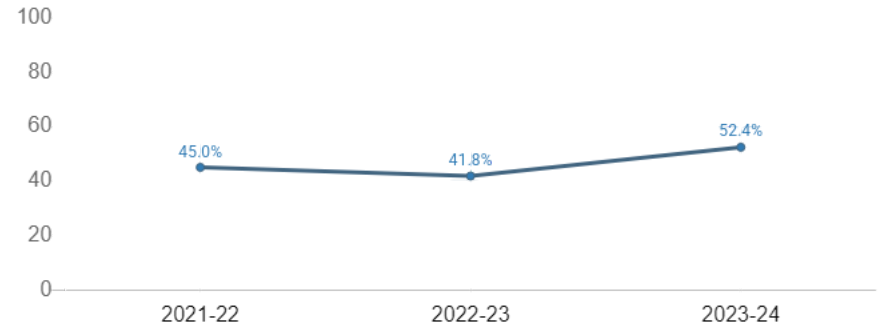
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 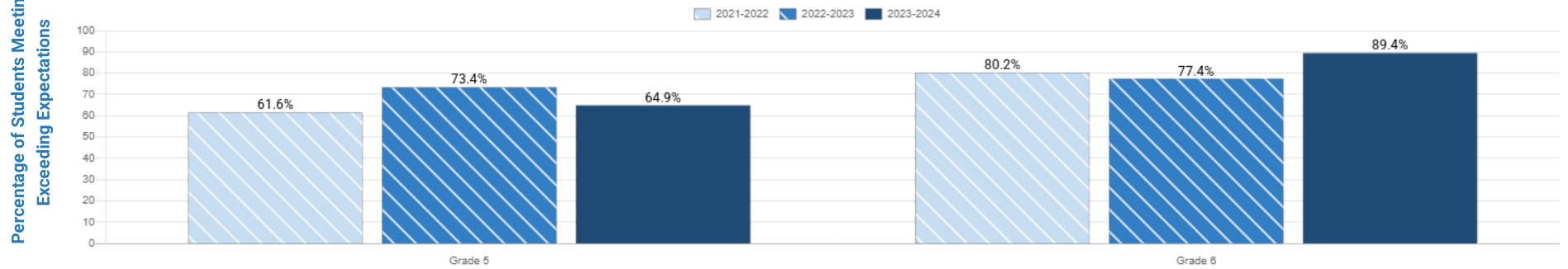

Mathematics Assessment - Participation and Performance

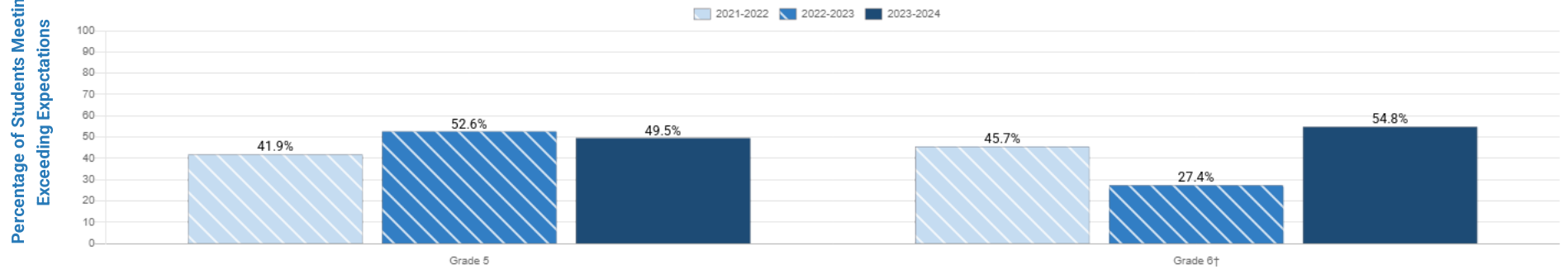

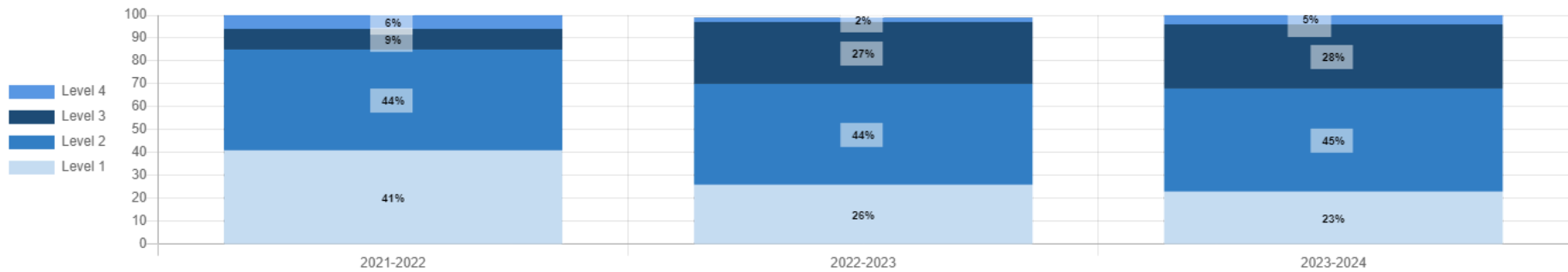

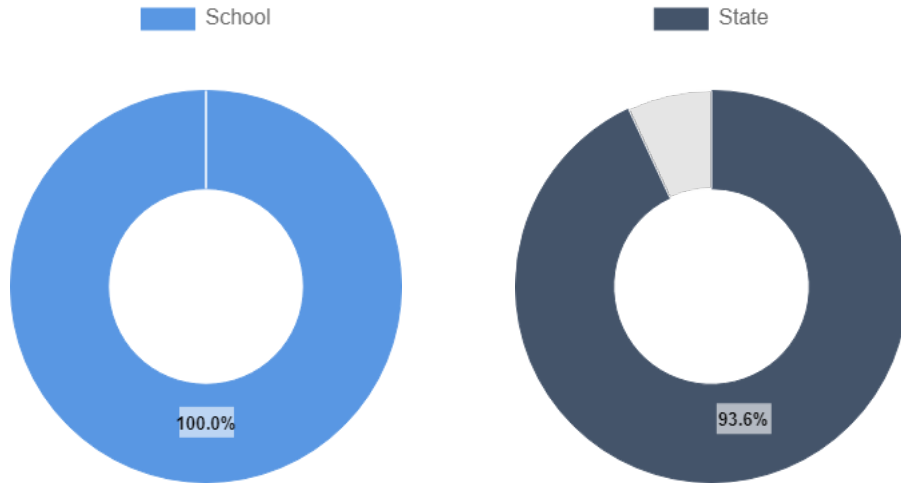

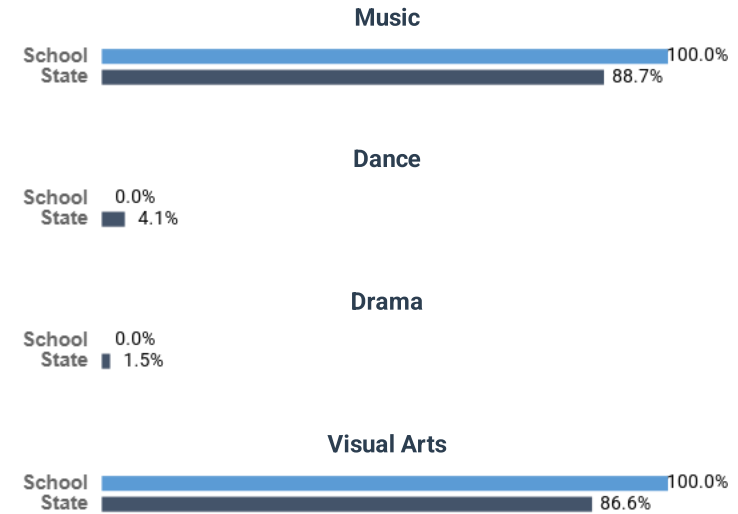

Students enrolled in one or more classes by discipline:



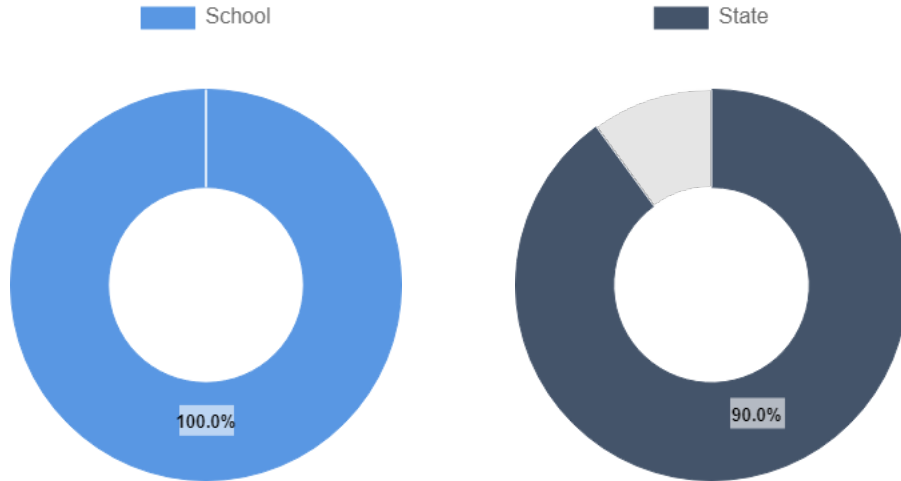

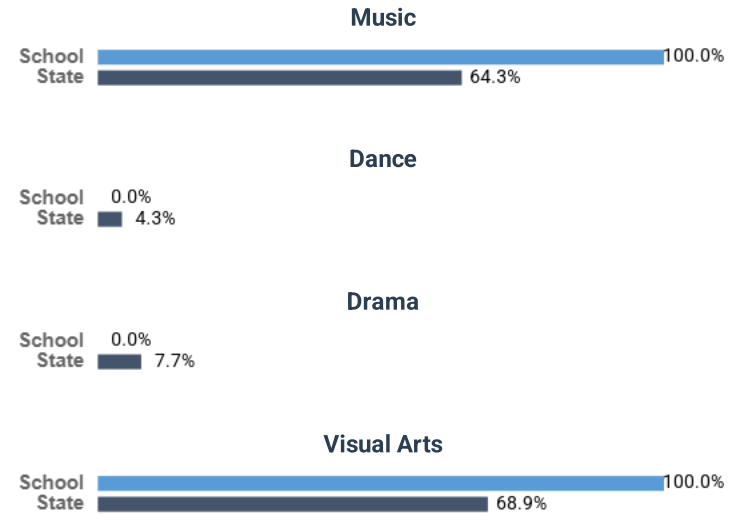

Students enrolled in one or more classes by discipline:



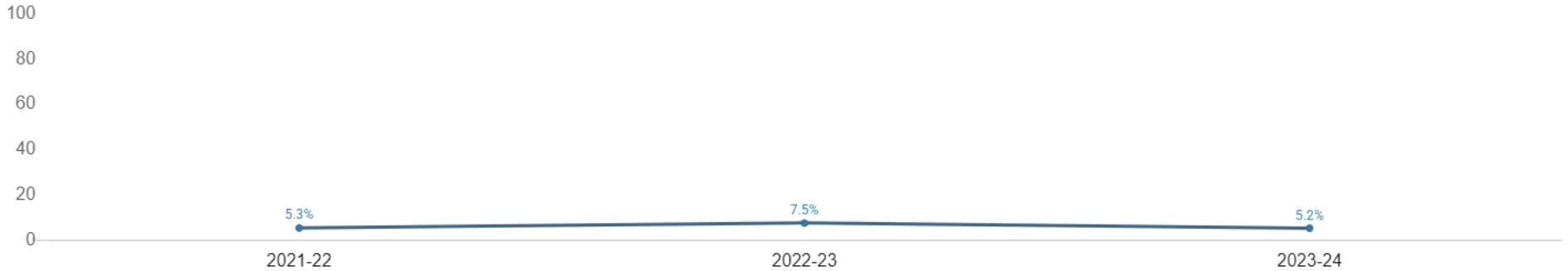

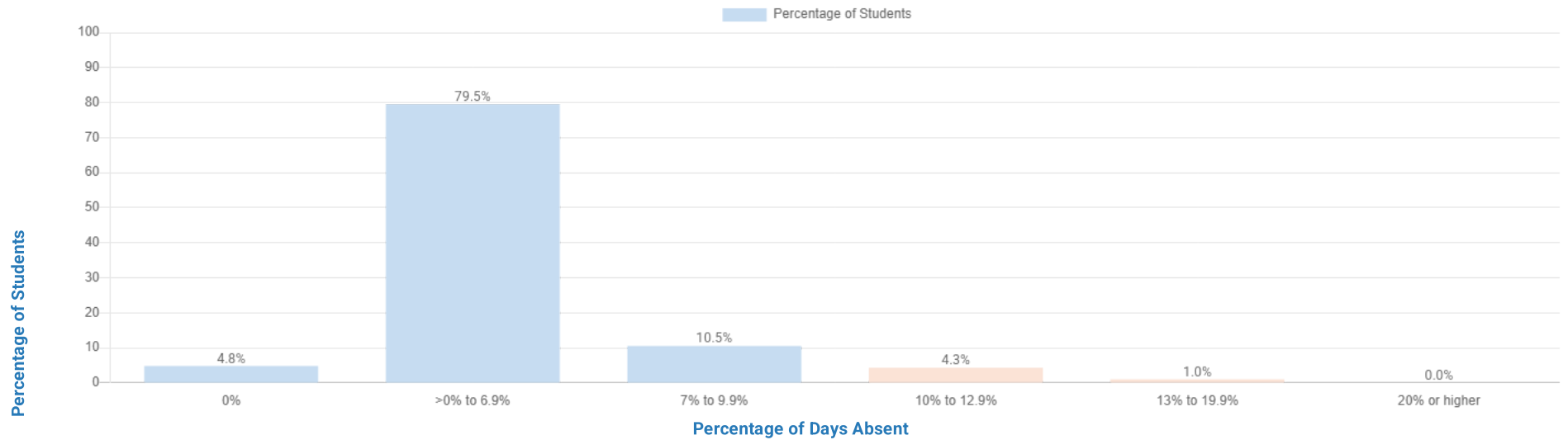

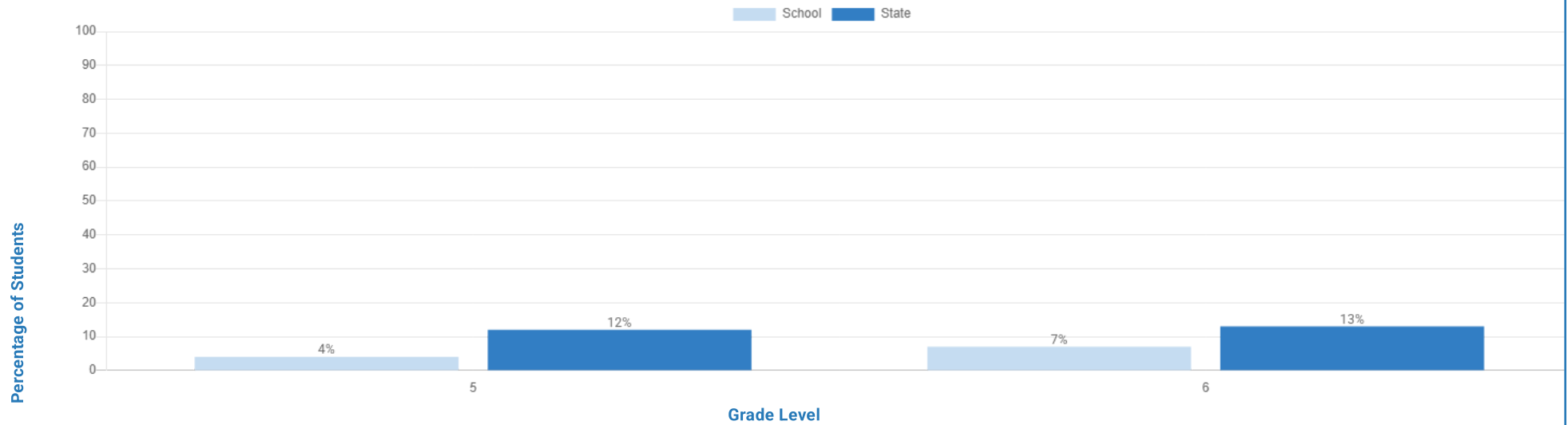

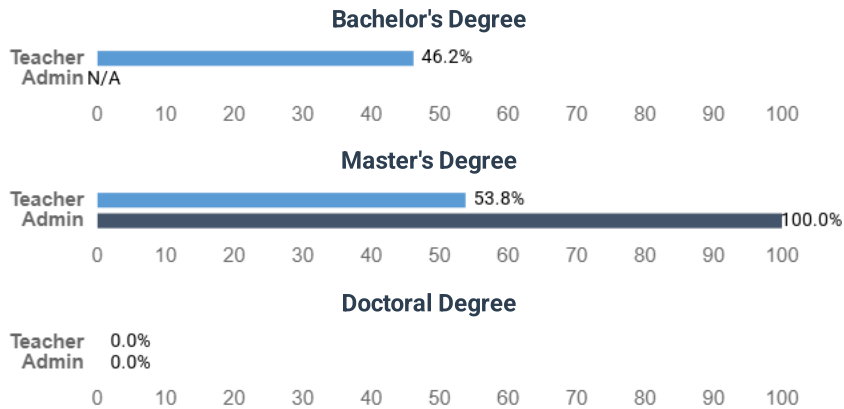

Staff

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. - Students access technology daily through a 1:1 Chromebook initiative and utilize the Google Education suite for learning beyond the school day.
- Student clubs and activities provide extracurricular study, social interaction, character development, and individuality.

Beers Street School's mission is to educate students so they may achieve their maximum potential. In the pursuit of excellence, Beers Street School, through a rigorous academic program with high expectations, will provide students with opportunities that lead them to become responsible, independent-thinking, global citizens. The school community implements this vision through ongoing and honest self-reflection with a commitment to continuous improvement.



Awards, Recognition, Accomplishments:

Beers Street School has been named one of the best elementary schools in NJ by U.S. News and World Report. Beers Street School continues to prepare students for success in the digital age. Beers Street School has Bronze Certification in the Sustainable Jersey Schools program for green practices and conservation of resources.

Courses, Curriculum, Instruction:

The school curriculum is designed to create well-rounded students, and instruction is delivered through a personalized learning approach. The curriculum includes an effective anti-bullying program and an extensive arts program incorporating vocal and instrumental music, general art, world language, coding, science, social studies, language arts, mathematics, and physical education. STEAM instruction is integrated throughout the school year. Students learn to build and program robots and explore different media, including film production with a green screen and podcasting. Students explore concepts related to circuitry, sound waves, and meteorology. Working collaboratively, students develop the skills necessary to face future challenges. During a daily W.I.N. (What I Need) period, students receive small group instruction focused on key standards using data to identify priority skills and key areas of need.



Clubs and Activities:

Clubs include Odyssey of the Mind, Yearbook/Photography, Drama, and Chess. Students also participate in an annual Spelling Bee, Geography Bee, and Field Day. Likewise, students' artistic endeavors are displayed at the annual art show. They can perform at the Talent Show, Winter Concert, and Spring Concert. There is a Halloween Dance, and a Spring Dance held each year.



Staff and Professional Learning:

The staff at Beers Street School are afforded twenty one-hour professional development sessions, not including two district-planned professional development service days, to collaborate with colleagues and to learn new strategies and best practices. Topics include multi-tiered systems of support, data analysis, personalized learning, and social-emotional skills development.

Student Supports and Services:

Support services for students with disabilities and a resource program are available district-wide. Intervention and Referral Services are provided, as well as after-school tutoring. A shared-time guidance counselor, a speech teacher, and a Child Study Team member are available. Physical and occupational therapy are also provided to students.



Student Health and Wellness:

There is a full-time nurse, a school safety team, and an AED unit. In addition to physical education and health classes, students enjoy daily active play during recess. Additional focus is on school readiness, gratitude, mental wellness, and personal growth. A police officer delivers L.E.A.D. instruction, a program focused on preventing drug abuse.



Parent and Community Involvement:

The P.T.O. takes an active role in the school by sponsoring assemblies, promoting activities, and contributing to special events, including field day, field trips, and book fairs. The P.T.O. meets regularly with teachers and the principal. School events, organizational goals, and finances are discussed at P.T.O. meetings.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students. An annual Climate Survey is administered to students to gauge their perception of the school environment, bullying, teacher relationships, and support services offered. The data is analyzed, and results are used for program initiatives and to better serve students.



Facilities:

Beers Street School features general education and special education classrooms, a speech room, art/enrichment room, music room, band room, full service cafeteria, gymnasium, sensory room, faculty room, child study team office, nurse's office, school counselor's office, conference room, main office and principal's office. The new STEAM Suite consists of an Engineering Lab, Science Lab, Collaboration Studio, Mindfulness Space, and Quiet Reading Nook. All learning spaces are equipped with Interactive White Boards, desktop computers, and document cameras. Outside learning classrooms have been added around the building.



School Safety:

School safety drills are conducted each month in accordance with the NJ Department of Education guidelines. A behavioral care and assessment team consists of trained staff members prepared to evaluate sensitive matters and determine appropriate student support. A SLEO Class III Police Officer provides additional security and support.

Technology and STEM:

Technology and STEM education includes programming Lego EV3 robotics, engineering, creating functional electronic circuitry, meteorological analysis, green screen applications, and stop motion film-making using digital editing software. All staff and students are issued Chromebooks and utilize the Google Education Suite. All classrooms are outfitted with smartboards. The STEAM Suite includes an engineering lab, science lab, and green screen film studio.



Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism. Interventions are provided for struggling students, and consequences are enforced for unexcused absences. Parents are very much involved in the process. The district's early warning system notifies parents or guardians when a student reaches a certain threshold of absences, including phone calls, letters, or scheduled meetings. The utilization of a truancy officer assists building principals by working with families to identify and address potential reasons for absences like transportation issues, health concerns, or family challenges.

Other Information:

Students earn awards that reinforce positive behavior. The B.A.R.K. LOUD program has been established to recognize students each month for demonstrating good behavior, having the right attitude, acting responsibly, and showing academic grit. Each month, a 5th grader and 6th grader receive the honor of Student of the Month. After each marking period, there is an awards assembly. Students are recognized for academic achievement and attendance. At the end of the year, students are recognized for participating in clubs and activities, and receive merit recognition for academic excellence in all subject classes. Communication is maintained through the school's website, Realtime notification system, social media, newsletter, P.T.O. meetings, Back-to-School Night, Parent/Teacher Conferences, progress reports, and report cards.
