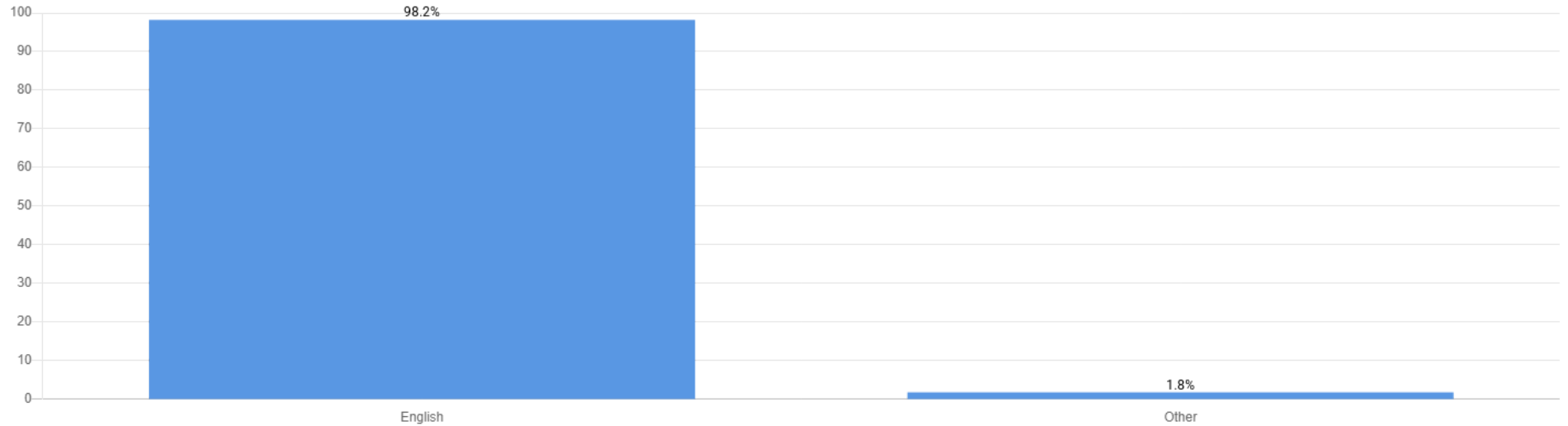

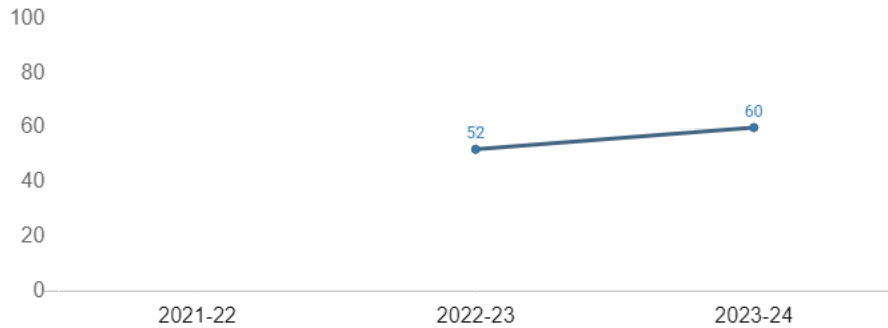

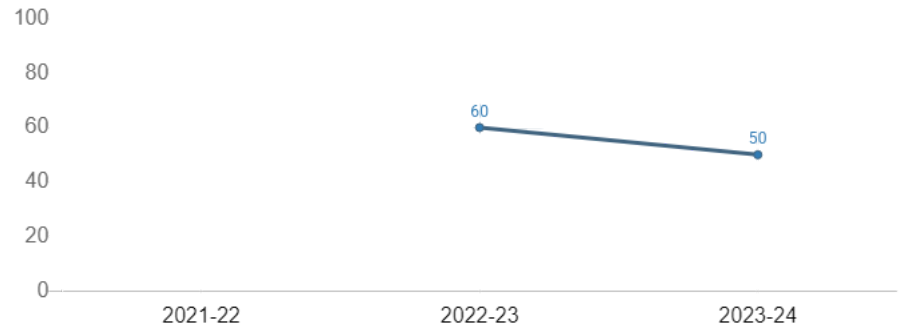

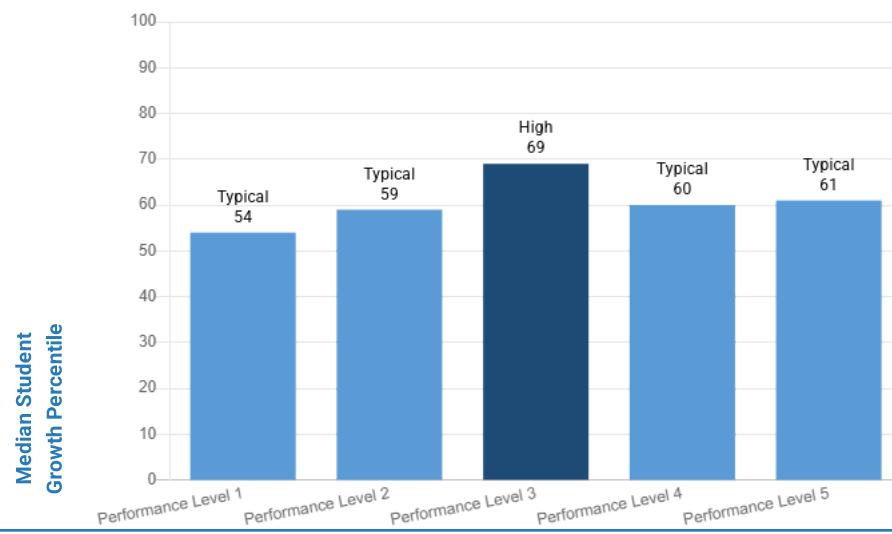

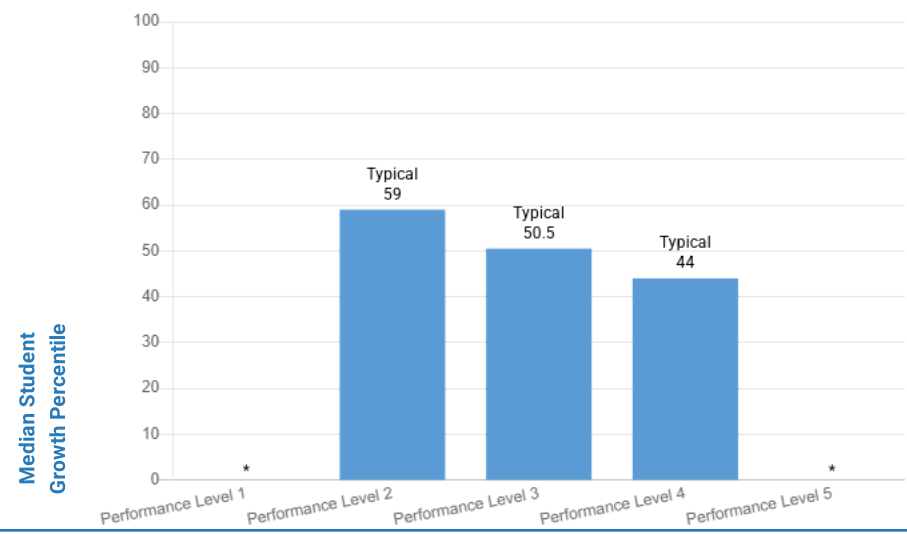

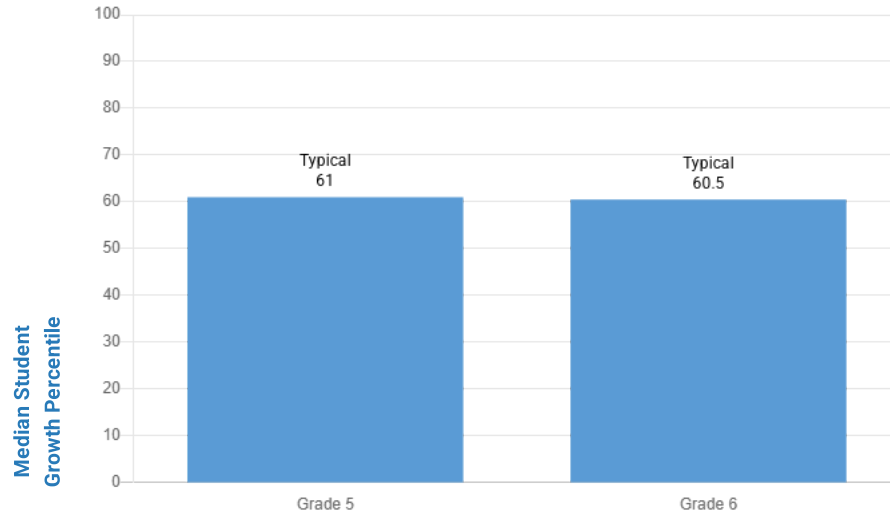

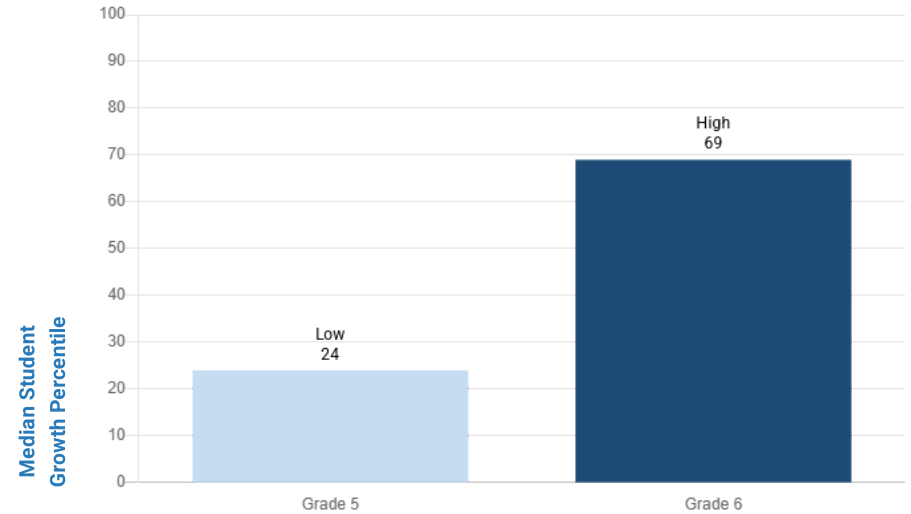

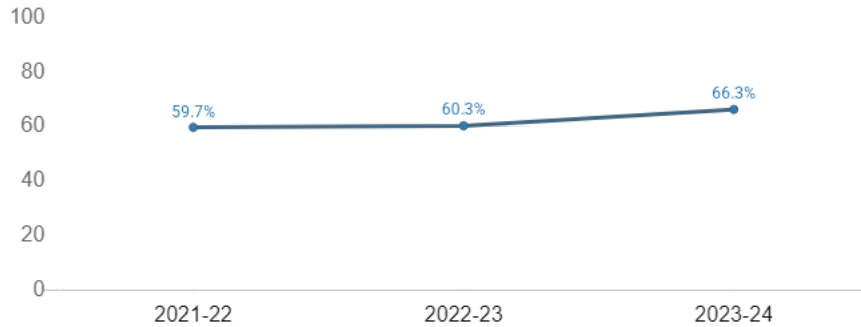

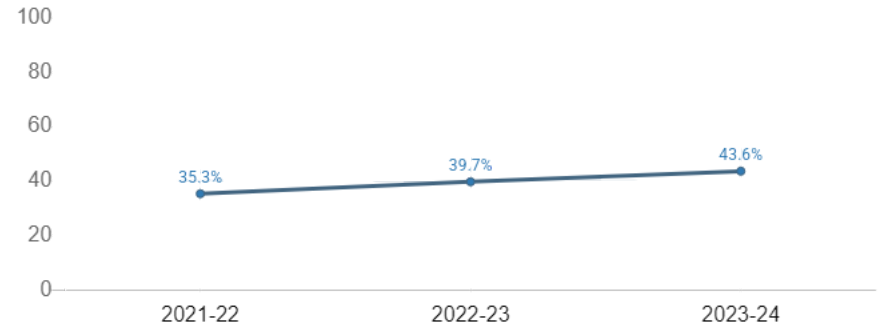
English Language Arts and Mathematics Performance Trends

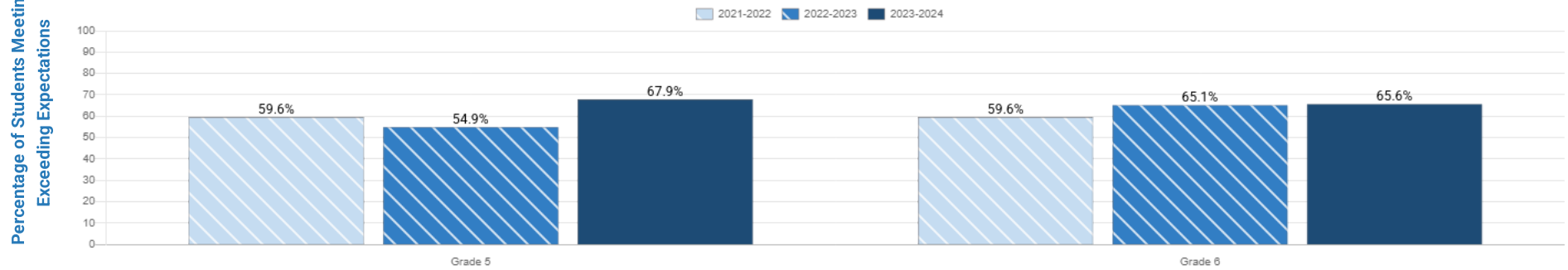

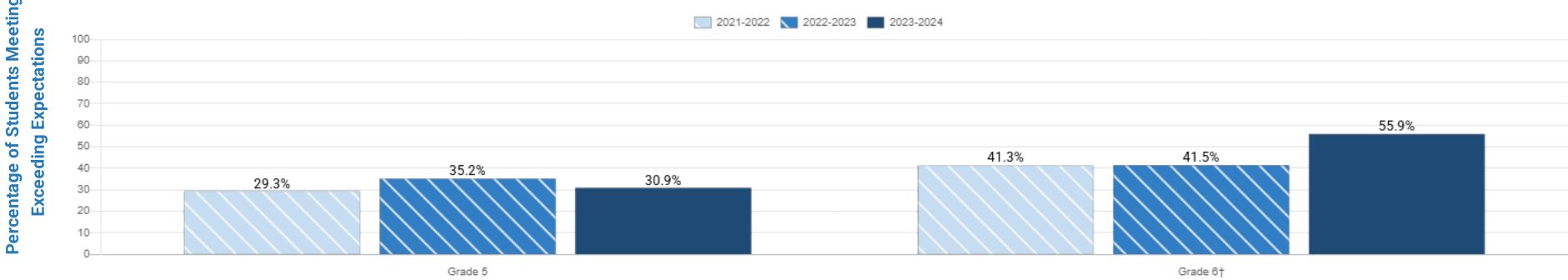

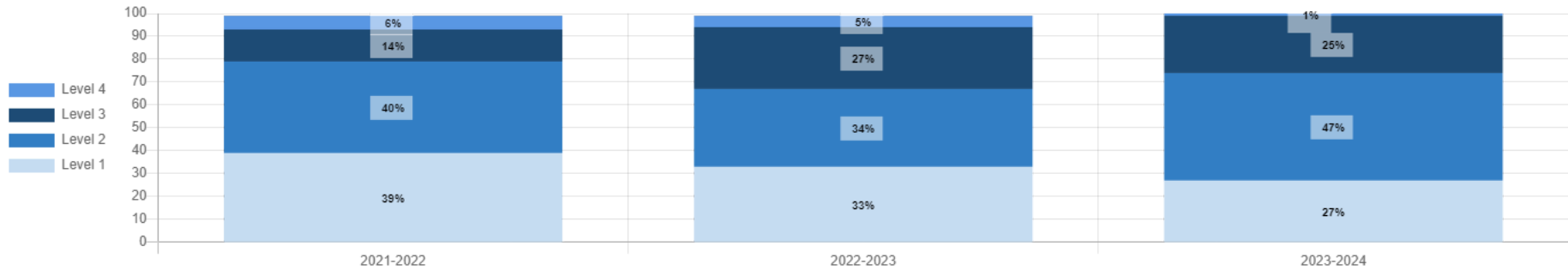

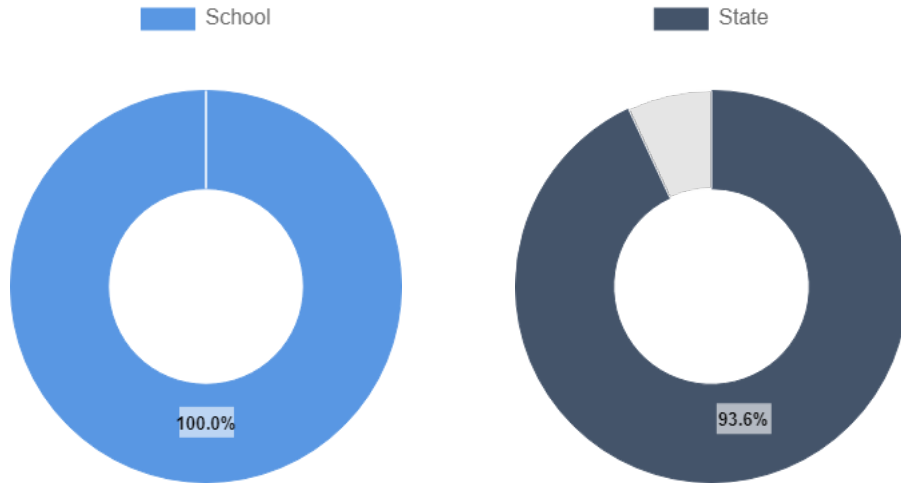

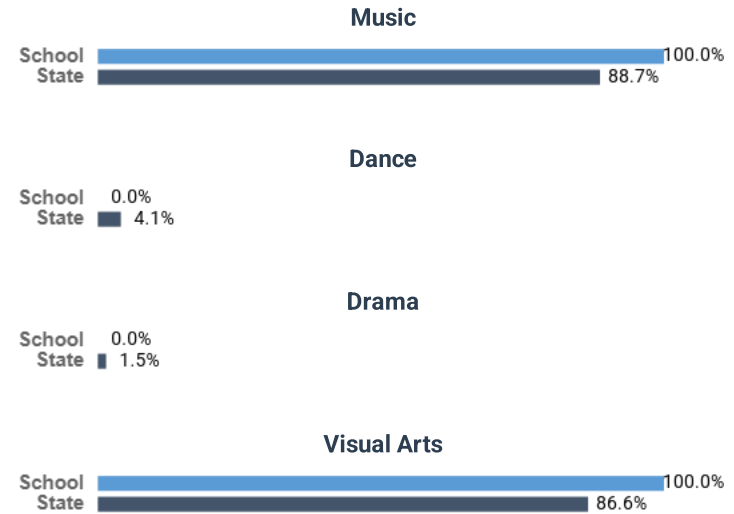

Students enrolled in one or more classes by discipline:



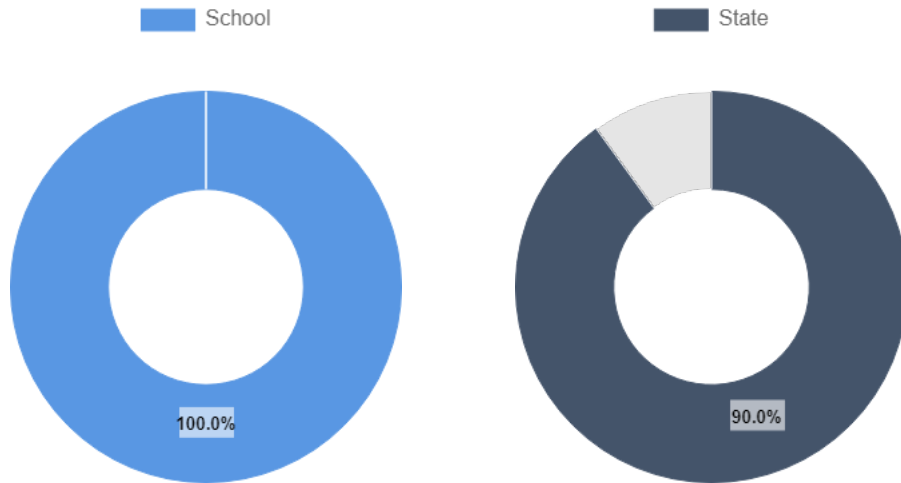

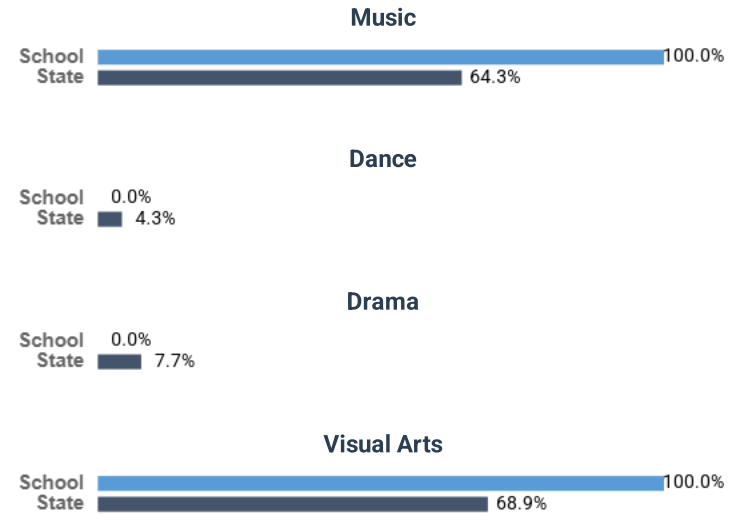

Students enrolled in one or more classes by discipline:



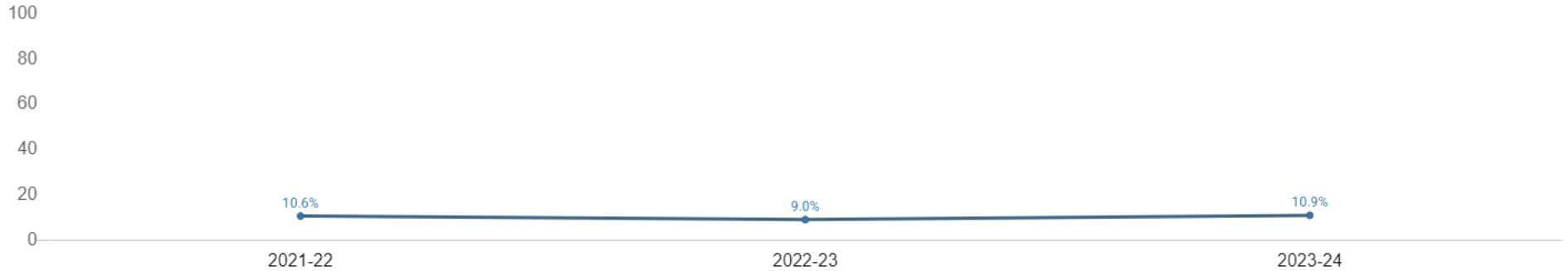

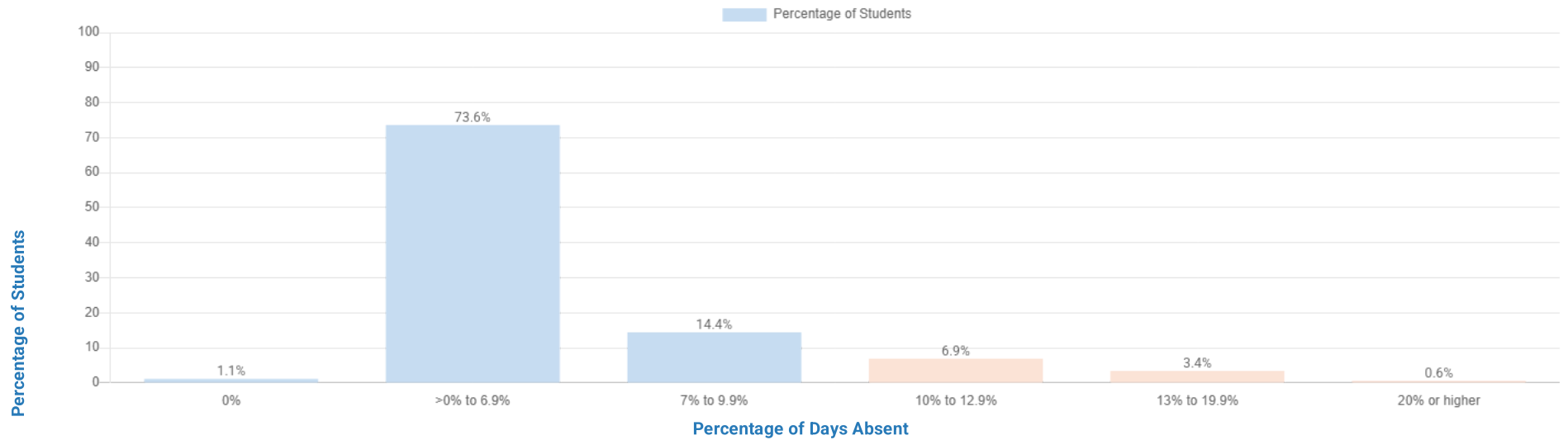

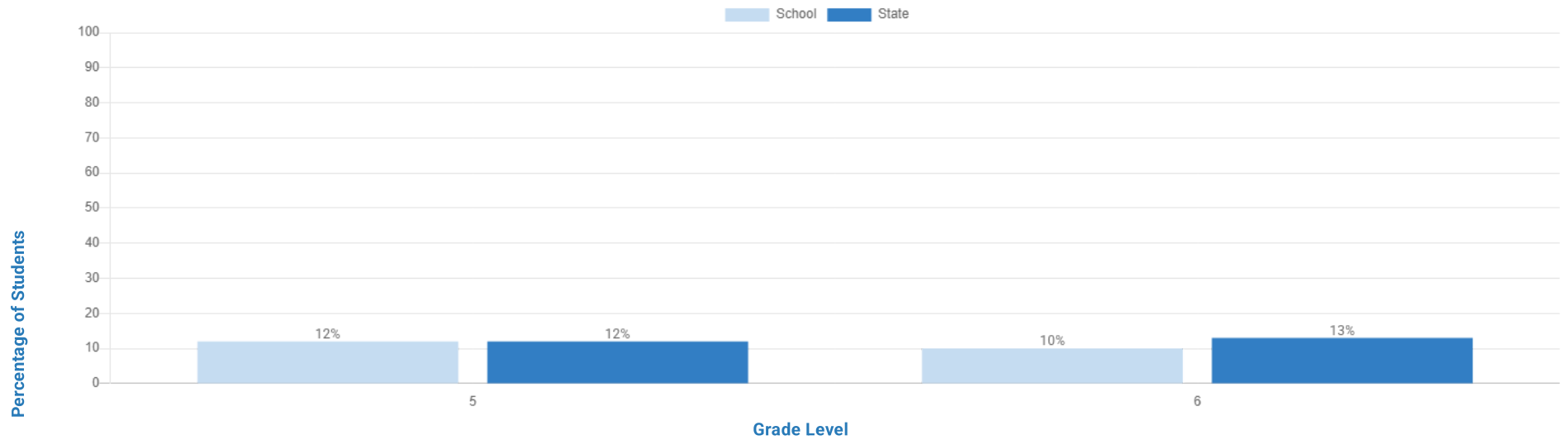

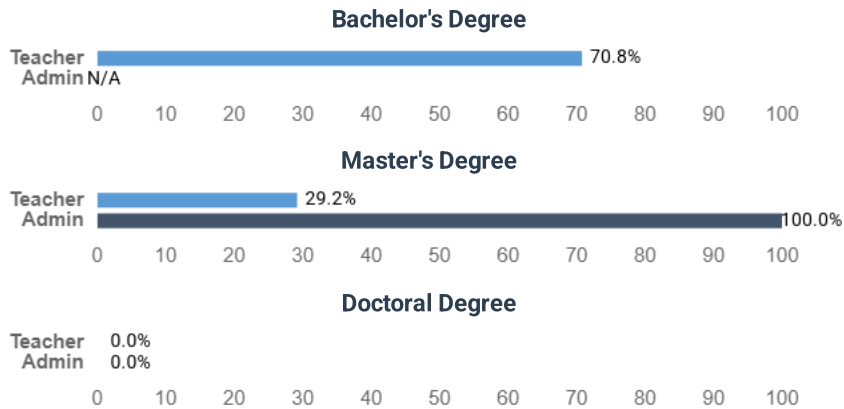

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Note that some teachers may teach in multiple subject areas and may be counted more than once in this table, or they may only be counted in their primary subject area. Additionally, in many elementary schools, teachers are not assigned to specific subject areas, so they will appear in the Elementary (Not Subject Specific) category and not in the other subject areas, but that does not mean those subjects are not being taught in the school. Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Courses, Curriculum, Instruction:

The Cove Road school curriculum is designed to ignite and create well-rounded global citizens. Delivery of instruction allows teachers to personalize the students' learning in the areas of language arts, mathematics, science, social studies, physical education, vocal and instrumental music, art, and world language. The S.T.E.A.M. suite has allowed students to immerse themselves in the discovery of the elements of robotics, how circuits operate, concepts of magnets, electromagnets, sound, frequency and wavelengths, programming, sketching, animation and media creation, product development and design, and architecture. Exposure to innovative learning possibilities at a critical time in learning maturation is allowing us to impact their college and career readiness.



Clubs and Activities:

Student clubs include, Mustang Ambassador Leadership Team, Garden Club, Activities Club, Reading Club, Odyssey of the Mind, Yearbook/Digital Photography Club, Art Club, and Drama Club. Odyssey of the Mind is a critical thinking program for selected 5th and 6th graders. Teams compete regionally, statewide and often at the world level. Cove Road students also participate in the annual Scripps Spelling Bee. A shared-time guidance counselor, a shared-time Title I Interventions Teacher, a speech teacher and a District Child Study Team member are available as needed.



Student Health and Wellness:

Cove Road School promotes healthy choices in meal selections and participation in physical activity. Physical Education classes are held weekly for all students. Cove Road also has a full time nurse on staff, and staff certified in CPR/AED, Glucagon, and Epi-Pen. Students participate annually in the American Heart Challenge. Cove Road puts an emphasis on social and emotional learning through lessons presented by the school guidance counselor. In collaboration with the Hazlet Police Department, the L.E.A.D program is presented to the 5th grade students and focuses on preventing drug use and abuse.

The P.T.O. takes an active role in the school by sponsoring assemblies, promoting activities, and contributing to special events, including field day, field trips, dances, and book fairs. At regular P.T.O. meetings, school events, organizational goals, and finances are discussed. School celebrations include Week of Respect, School Violence Awareness Week, Red Ribbon Week, Black History Month and Anti-Bullying Awareness Week.

Facilities:

Cove Road School features a S.T.E.A.M. (Science, Technology, Engineering, Art) suite equipped with the latest technology. Classes will continue to be taught with Google Jamboards, Smartboards, Whiteboards, TV's and interactive equipment allowing for learning both inside and outside of the classroom. Our facility features a science lab, math lab, media center, wellness room and general education classrooms. LED lighting, new ceilings, windows and HVAC equipment have been replaced. School Safety:

School safety drills are conducted each month in accordance with the NJ Department of Education guidelines. A behavioral care and assessment team consists of trained staff members prepared to evaluate sensitive matters and determine appropriate student support. A SLEO Class III Police Officer provides additional security and support.

The STEAM Suite includes an engineering lab, science lab, and green screen film studio.



Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism. Interventions are provided for struggling students and consequences are enforced for unexcused absences. Parents are very much involved in the process. The district's early warning system notifies parents or guardians when a student reaches a certain threshold of absences, including phone calls, letters, or scheduled meetings. The utilization of a truancy officer assists building principals by working with families to identify and address potential reasons for absences like transportation issues, health concerns, or family challenges.

Cove Road has implemented the Mustang Manners Program to identify and reward students who demonstrate Honesty, Respect, Kindness, Integrity, and Accountability. Two 5th grade and two 6th grade students are acknowledged weekly for demonstrating Mustang Manners. Additionally, Cove Road honors two 5th grade and two 6th grade students as Students of the Month. Cove Road is committed to providing a thorough, integrated educational program. We will always seek every opportunity to help each child achieve success, positive self-esteem, and personal development to their fullest potential.
