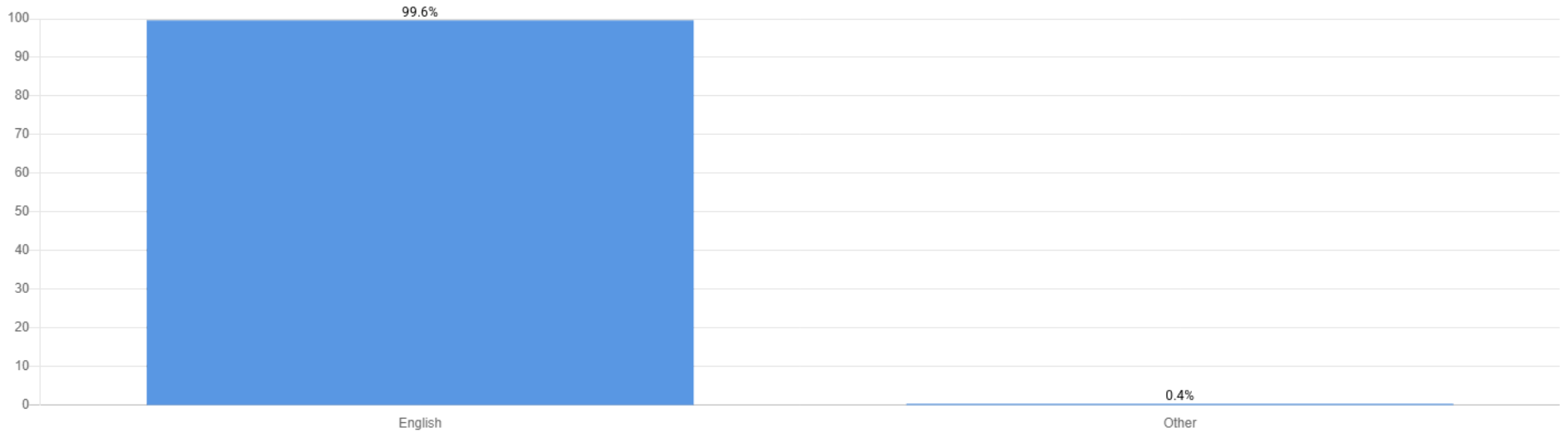

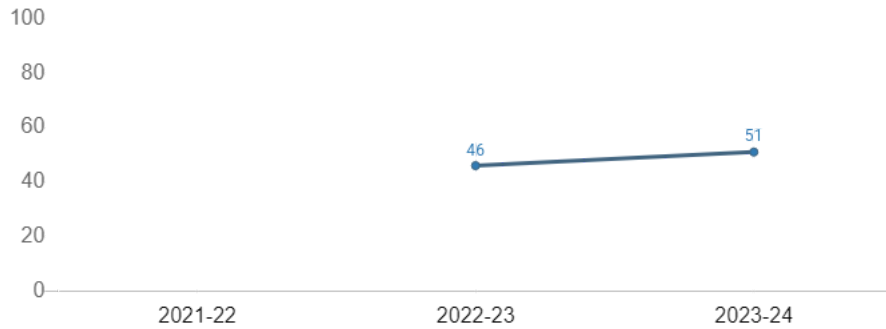

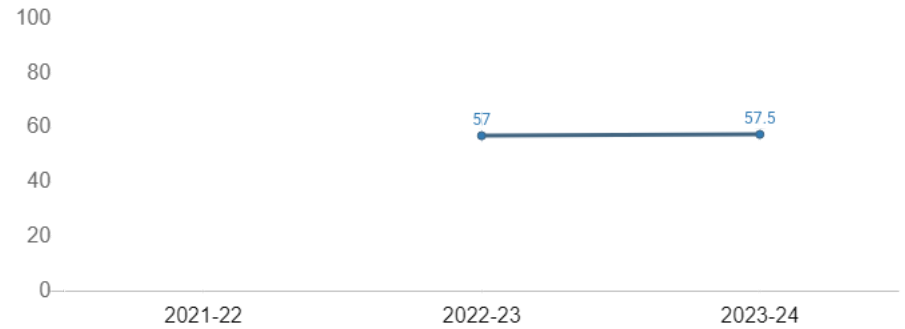

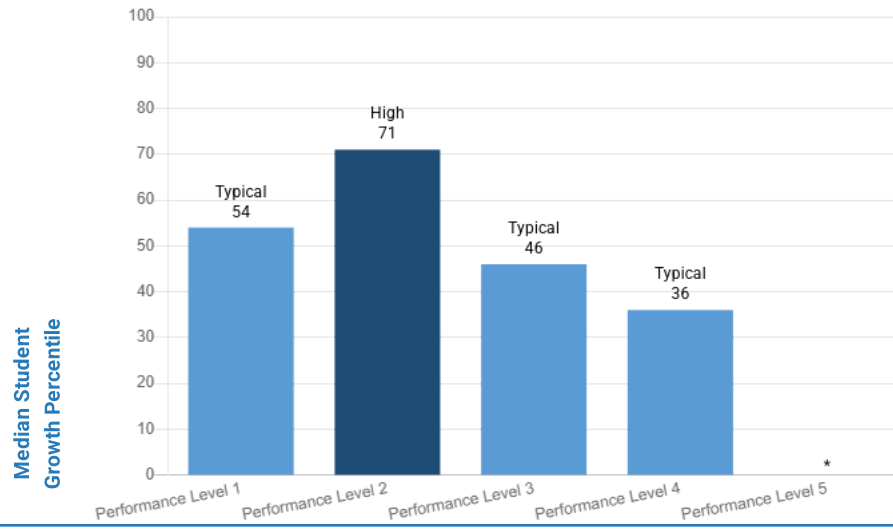

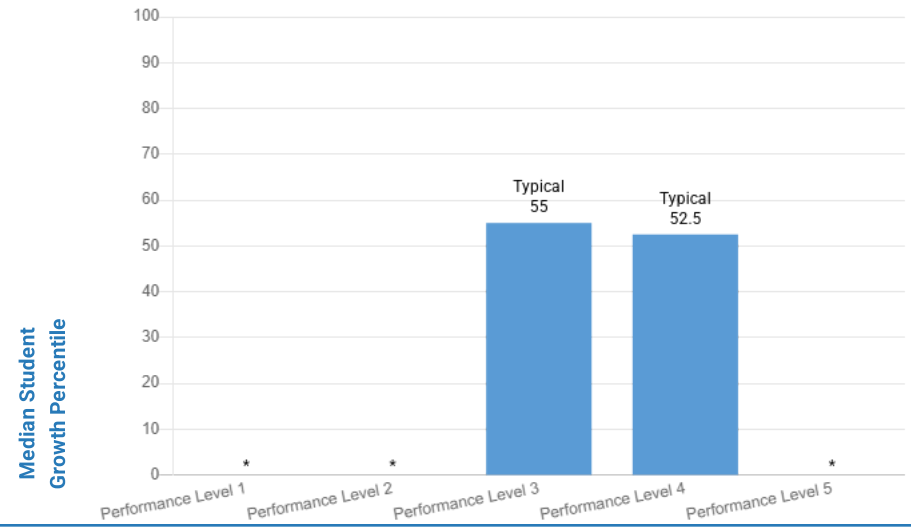

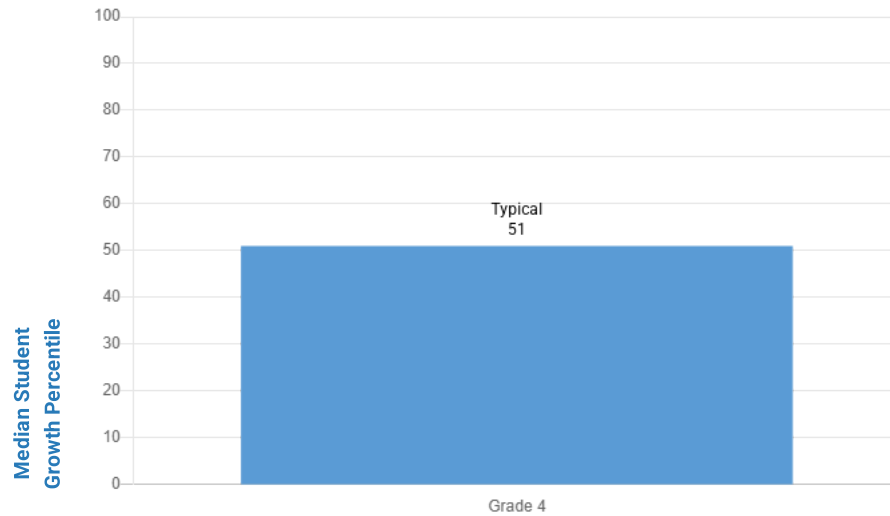

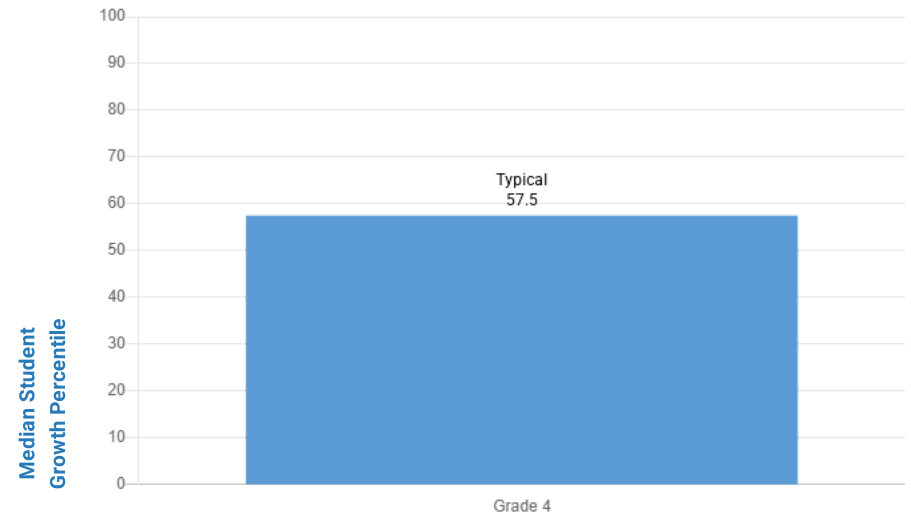

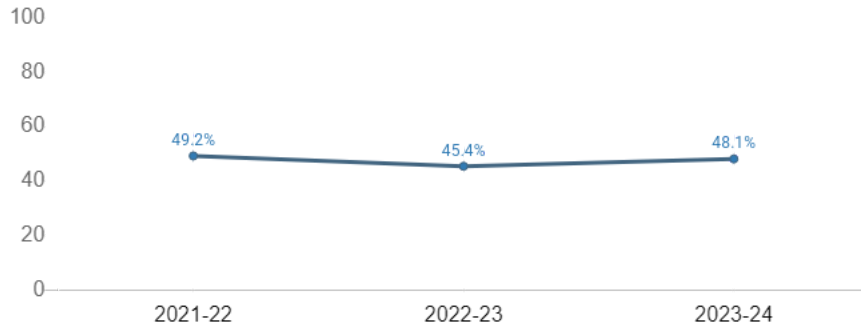

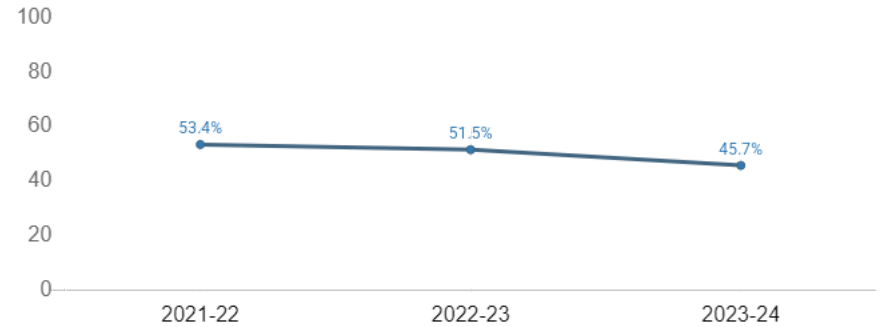
English Language Arts and Mathematics Performance Trends

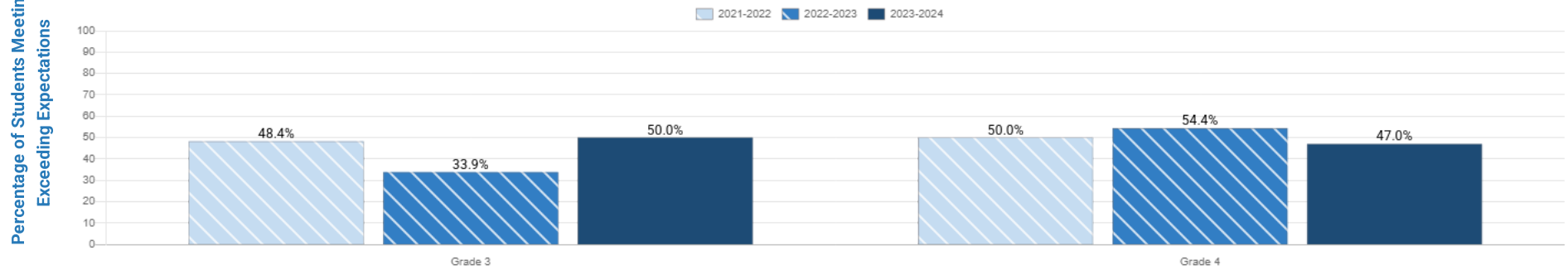

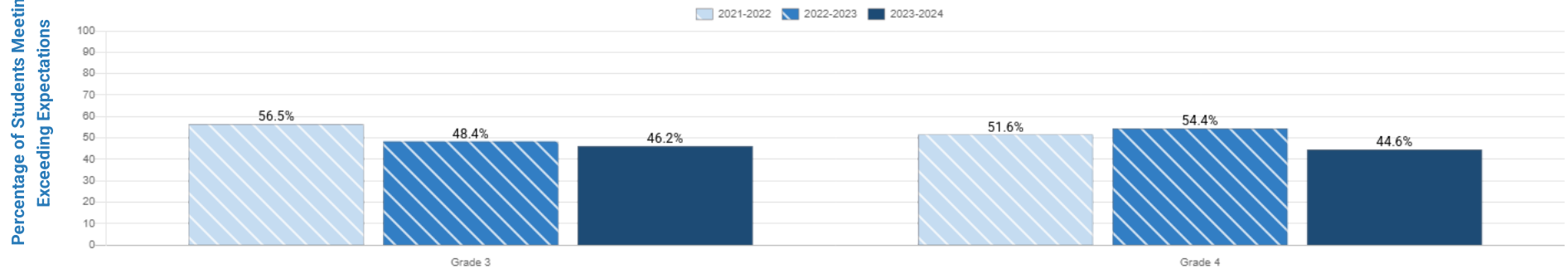

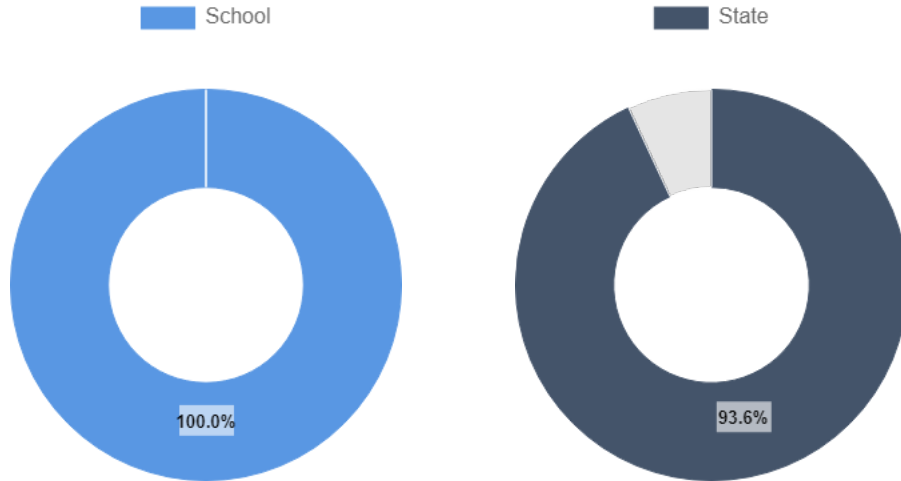

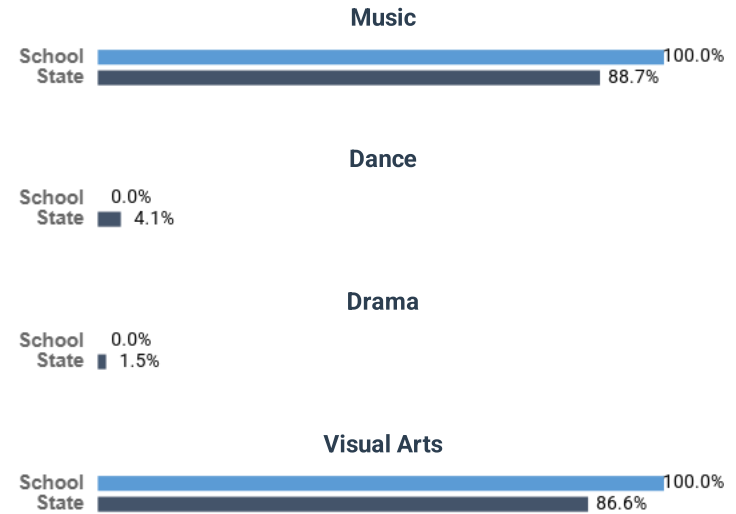

Students enrolled in one or more classes by discipline:



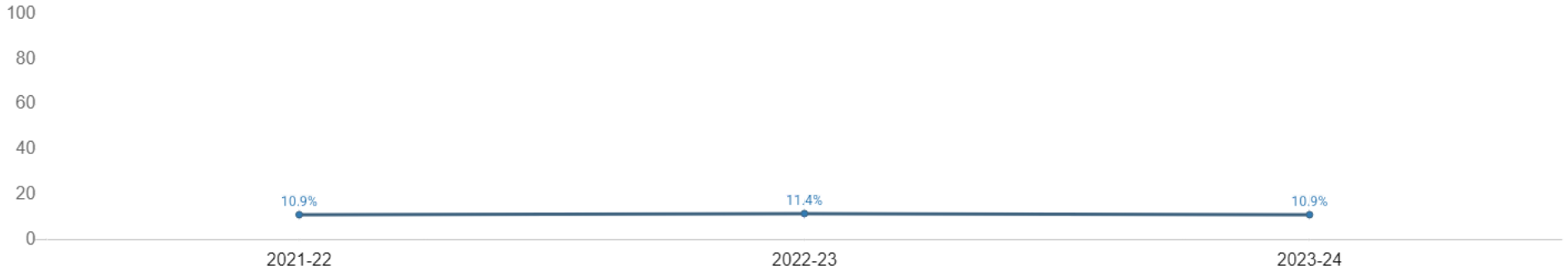

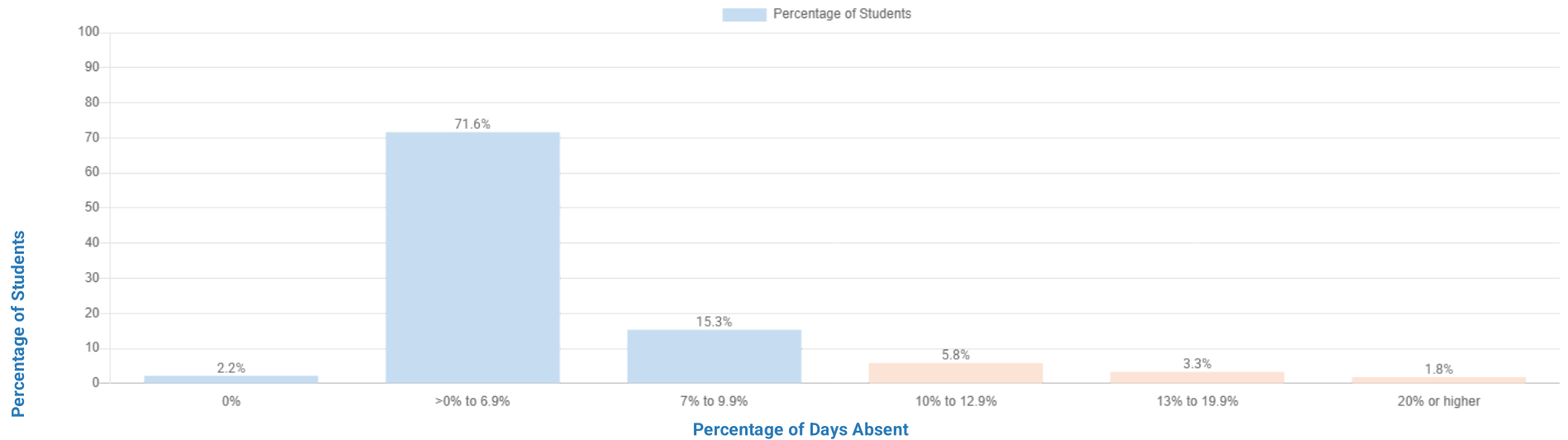

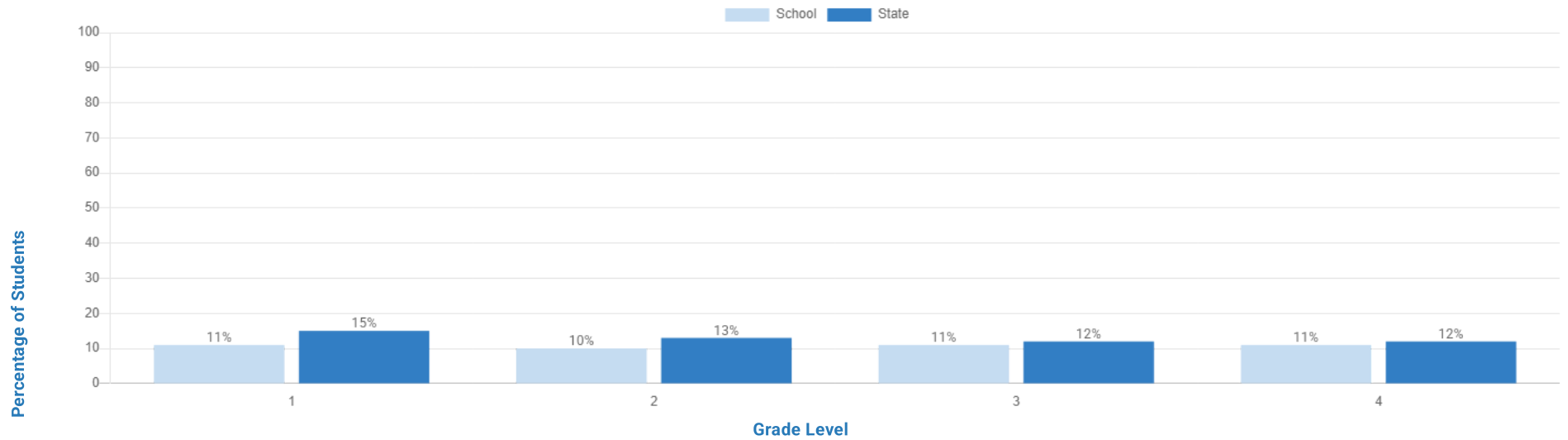

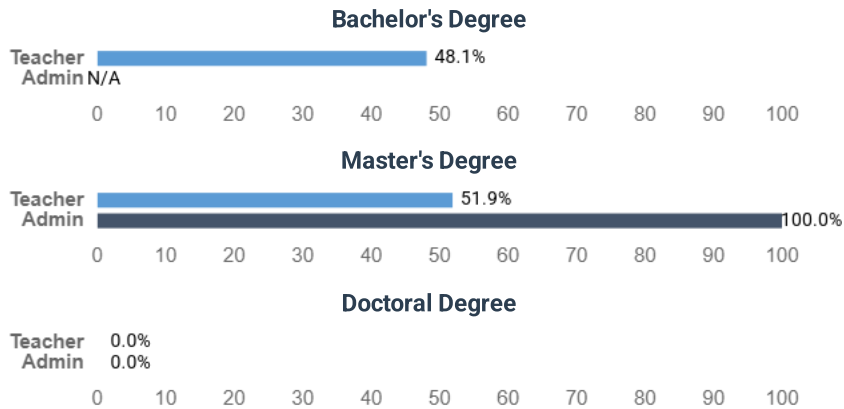

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Staff and Professional Learning:

Lillian Drive School and the district of Hazet offer 20 after school Professional Development opportunities for teachers to polish their craft, share best practices and increase the overall performance level of students through data analysis and trending methodology. Professional Learning Communities (PLCs) provide teachers with time to share ideas on pacing, interventions, differentiation, data analysis and the development of action plans for remediation. Weekly ONE Sheets shared with the staff address the tripod of initiatives in the district (Personalized Learning, Sustainable NJ, and Social-Emotional Learning) and offer weekly ideas/activities to enhance the classroom. Teachers continue to meet on original professional development ideas that enhance instruction and education in the classroom focusing on topics such as data based instruction, professional book clubs, I&RS collaboration for strategies and progress, etc.



Student Supports and Services:

Lillian Drive has an active I&RS team and a School Climate Committee who are dedicated to helping our students succeed in academics as well as social skills. Lillian Drive offers In-Class support and resource services for special education students. In addition, two Autism classrooms and one Emotional Regulation Impaired (ERI) classroom are housed at Lillian Drive.



Student Health and Wellness:

Our school participates in many healthy initiatives and activities. Our classroom teachers teach lessons on wellness and incorporate social-emotional skills during health class twice a week. The curriculum encourages students to lead a healthy lifestyle both physically and mentally. All students participate in physical education and health classes every week. We have a full-time Nurse (RN, BS), who monitors all health issues of our students and staff. We also utilize a BCBA and an RBT to support our students' behaviors. We follow all federal, state, and district guidelines related to health and wellness. The ERI classroom utilizes Zones of Regulation.

The Lillian Drive School as a result of the referendum have had many facilities updates. Classroom renovations have been completed, new L.E.D lighting, flooring, windows and HVAC equipment. There was also a complete renovation of the new Autism classroom added in 2022; An ERI classroom was added in 2023 and a second Autism classroom was added in 2024. A Playground area has been replaced with a new ADA accessible turf area and equipment for outdoor recreation. Also new graveled blacktop and basketball courts were added to the delight of the students. The students also have access to Chromebooks via the district's one-to-one Chromebook initiative. Outside learning classroom has been added.

A behavioral care and assessment team consists of trained staff members prepared to evaluate sensitive matters and determine appropriate student support. A SLEO Class III Police Officer provides additional security and support.



Technology and STEM:

Students are 1:1 with chromebooks and Technology is one of the specials that all students participate in weekly. Enrichment is offered to all 1st and 2nd graders and 3rd and 4th graders are offered Enrichment if they meet the district outlined criteria.



Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism. Interventions are provided for struggling students and consequences are enforced for unexcused absences. Parents are very much involved in the process. The district's early warning system notifies parents or guardians when a student reaches a certain threshold of absences, including phone calls, letters, or scheduled meetings. The utilization of a truancy officer assists building principals by working with families to identify and address potential reasons for absences like transportation issues, health concerns, or family challenges.
