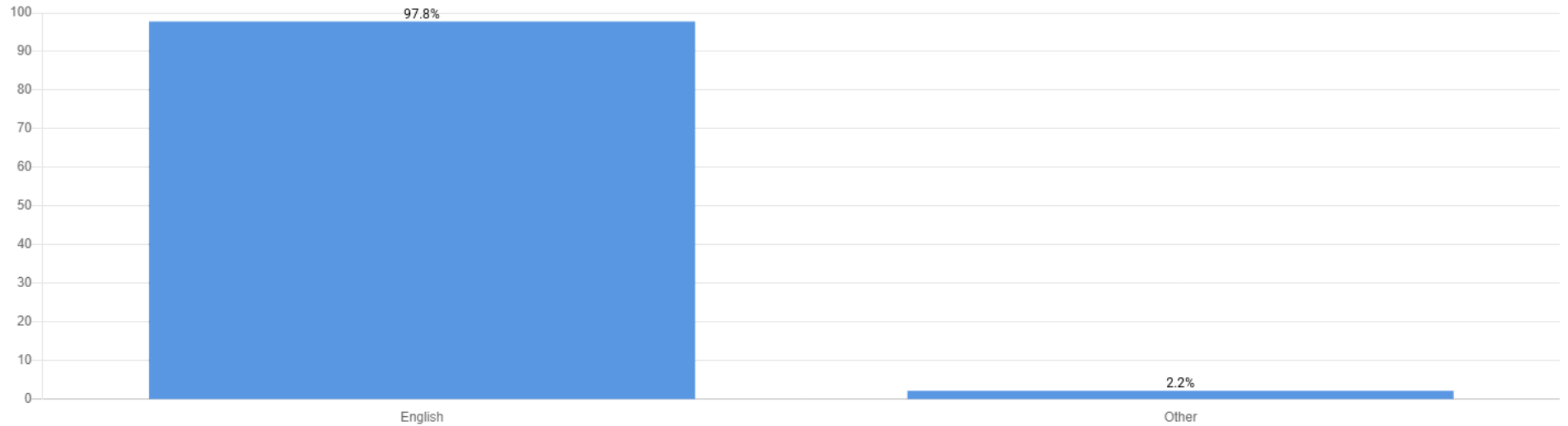

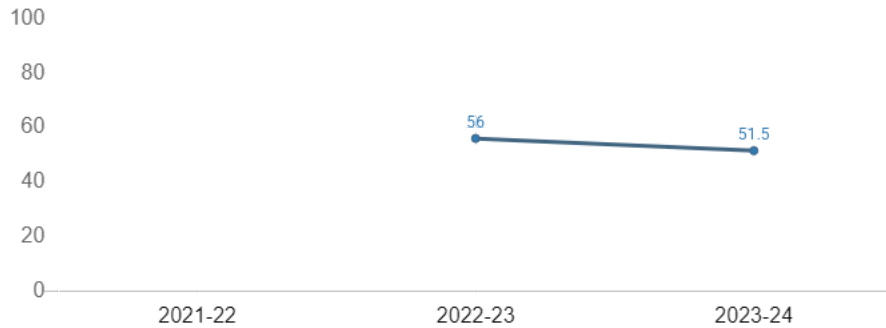

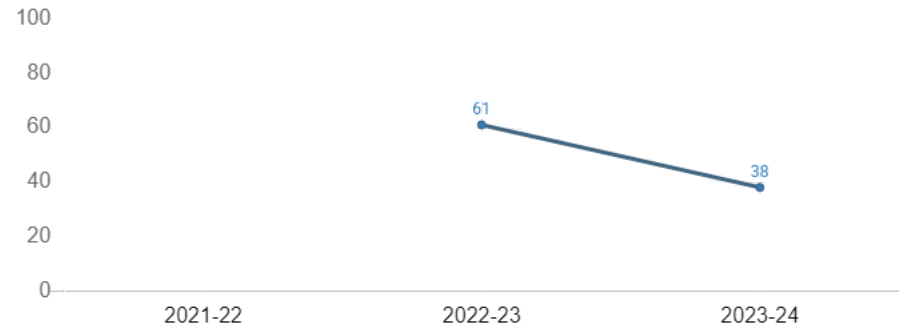

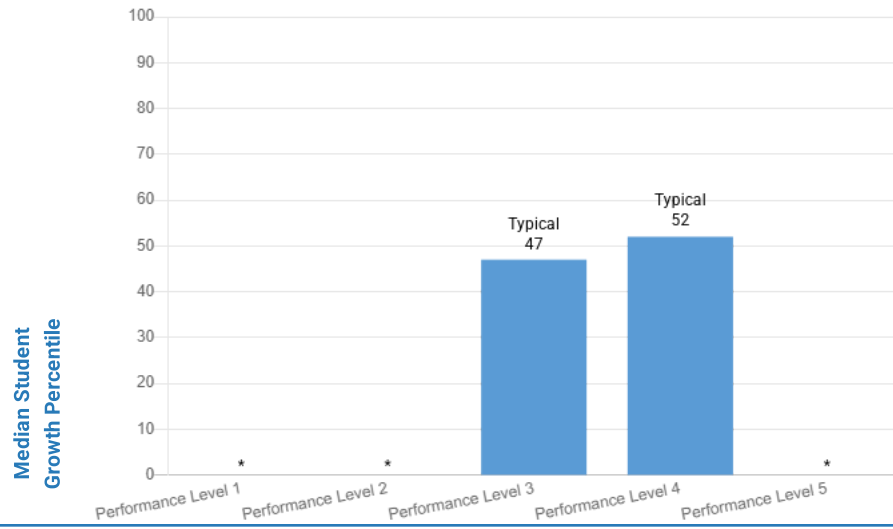

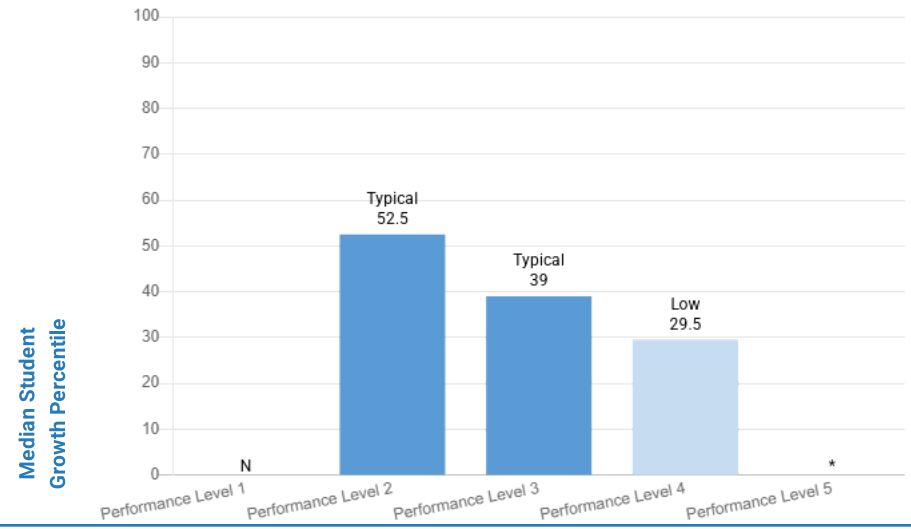

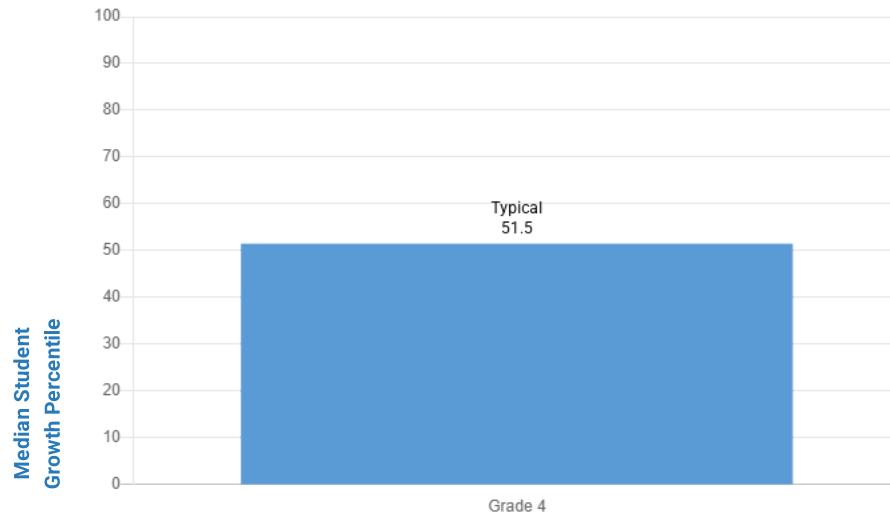

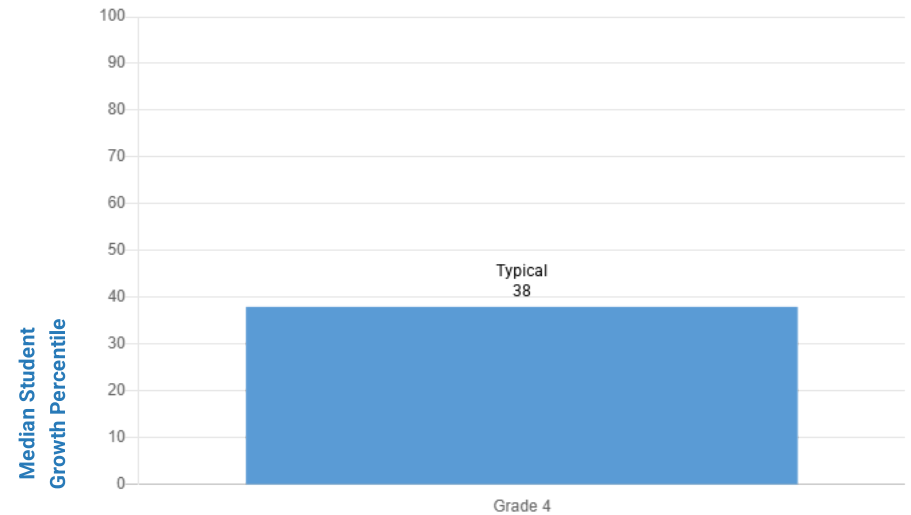

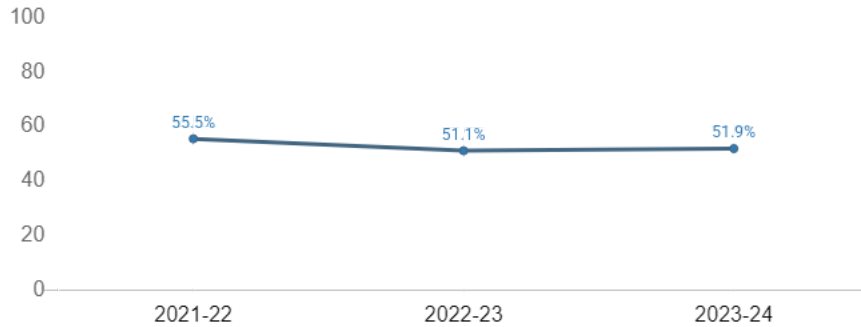

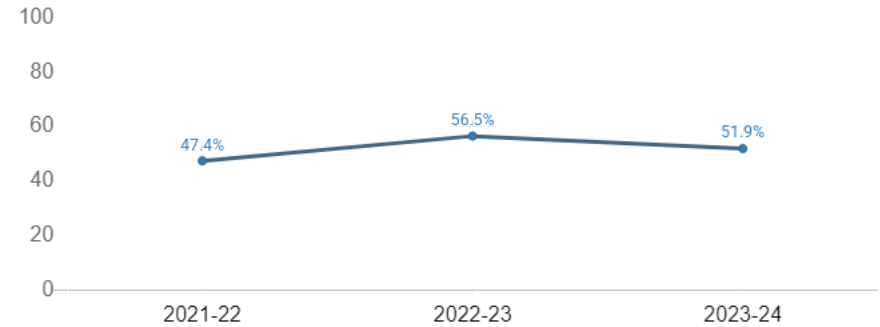
English Language Arts and Mathematics Performance Trends

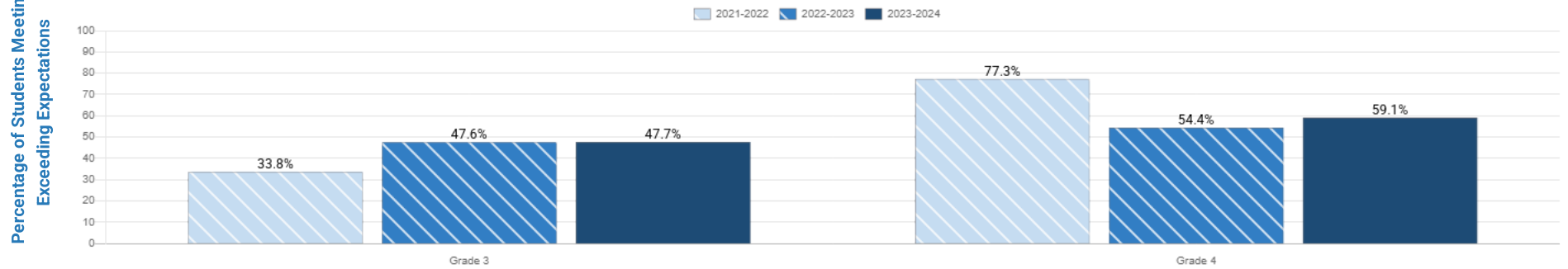

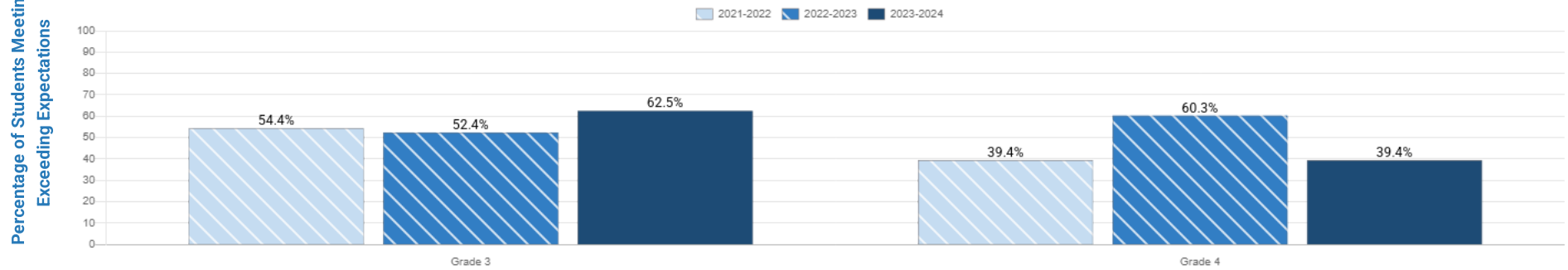

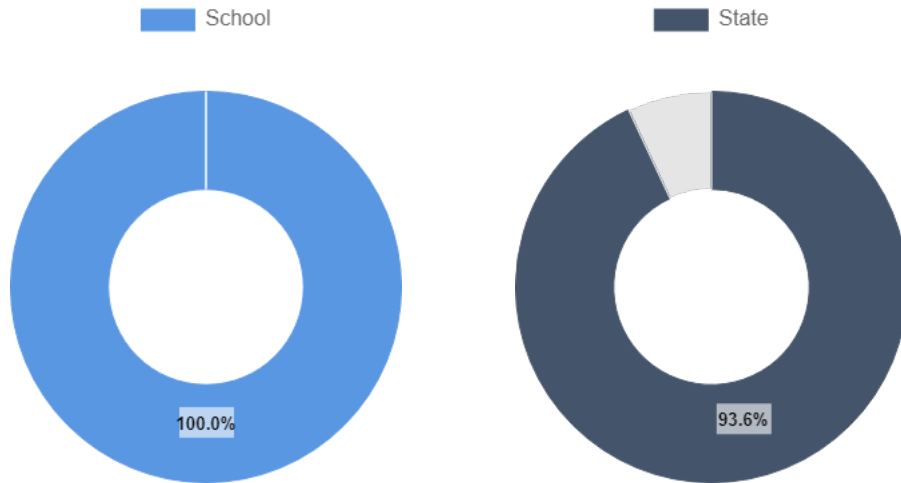

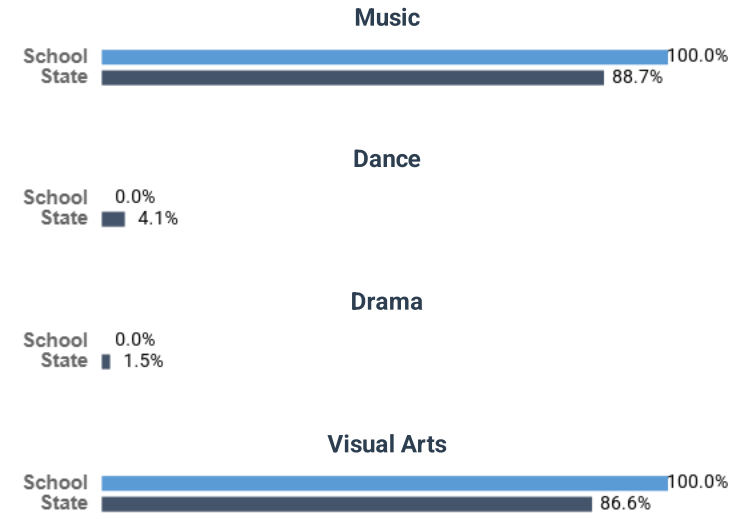

Students enrolled in one or more classes by discipline:



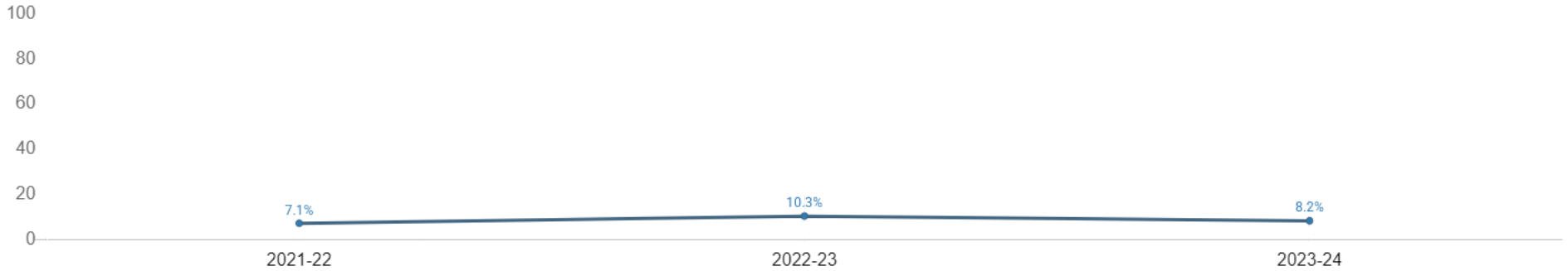

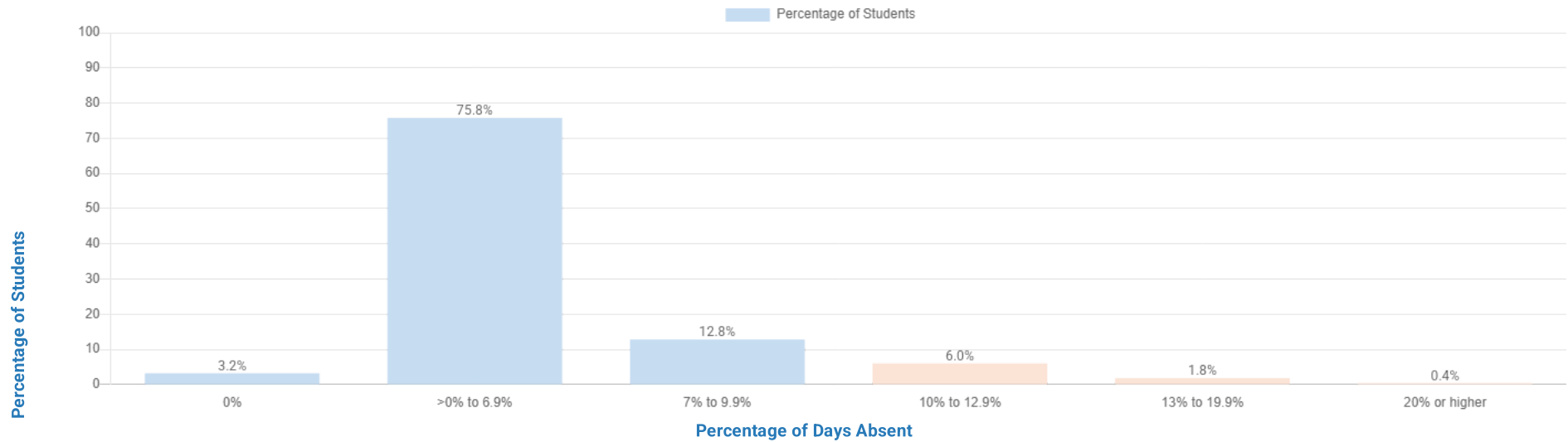

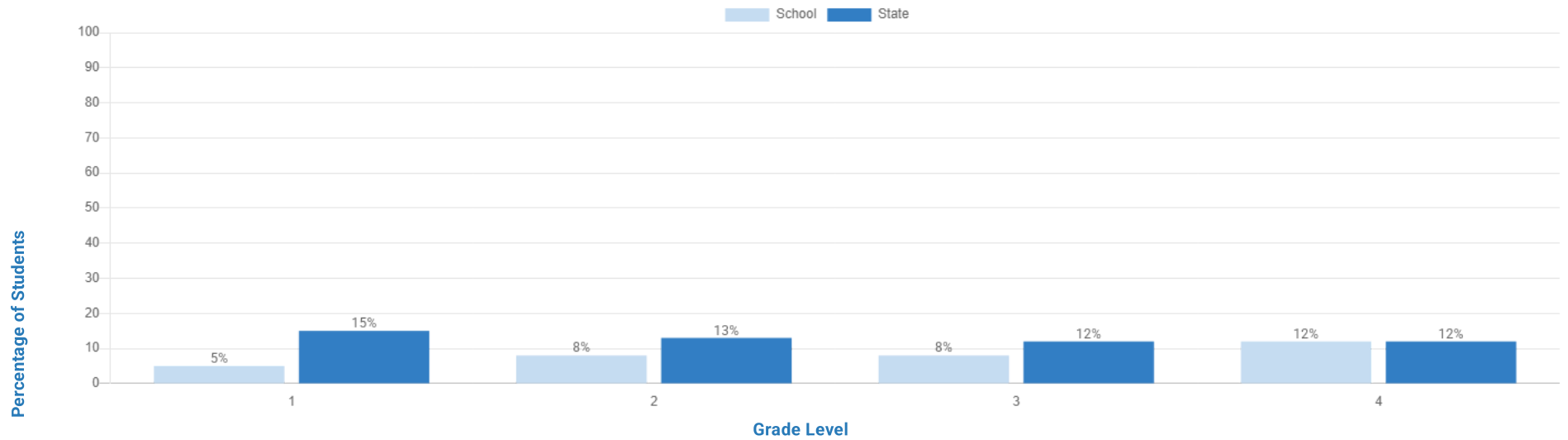

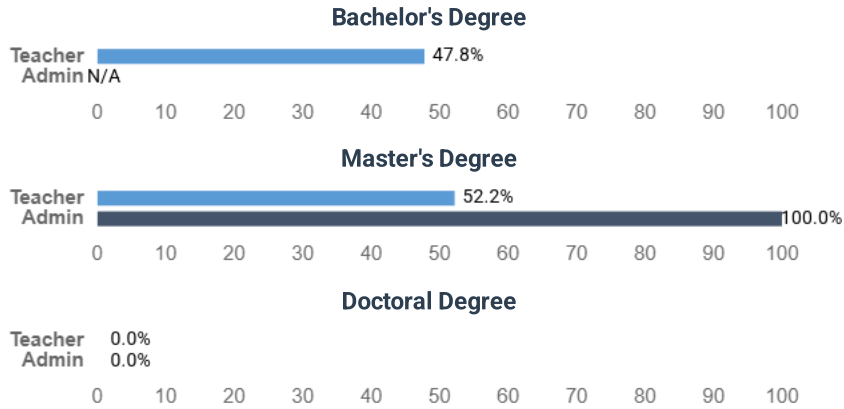

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. A behavioral care and assessment team consists of trained staff members prepared to evaluate sensitive matters and determine appropriate student support. A SLEO Class III Police Officer provides additional security and support.



Technology and STEM:

Technology and STEM education includes programming Lego EV3 robotics, engineering, creating functional electronic circuitry, meteorological analysis, green screen applications, and stop motion film-making using digital editing software. All staff and students are issued Chromebooks and utilize the Google Education Suite. All classrooms are outfitted with smartboards.



Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism.
