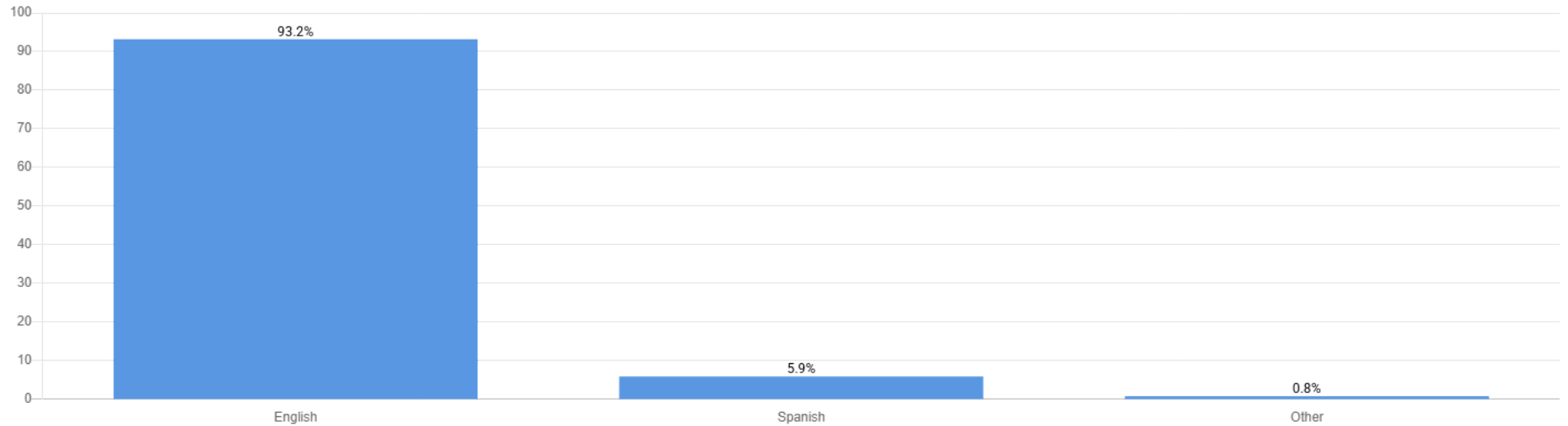

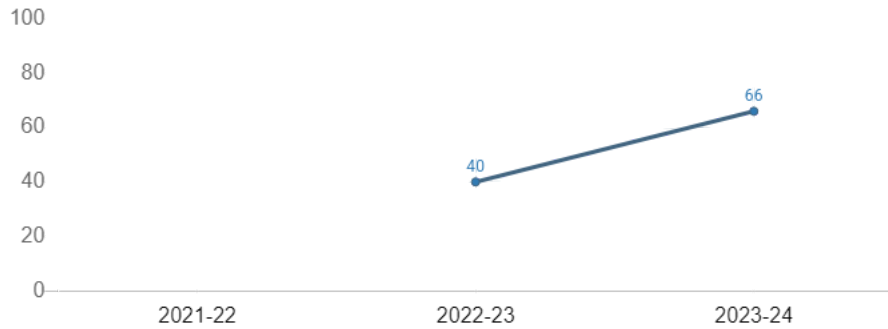

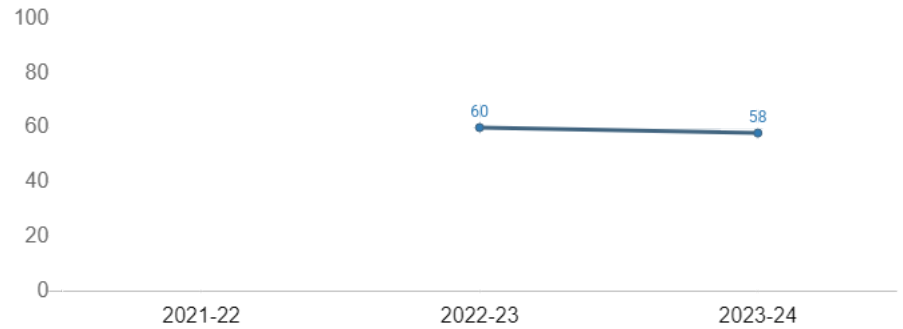

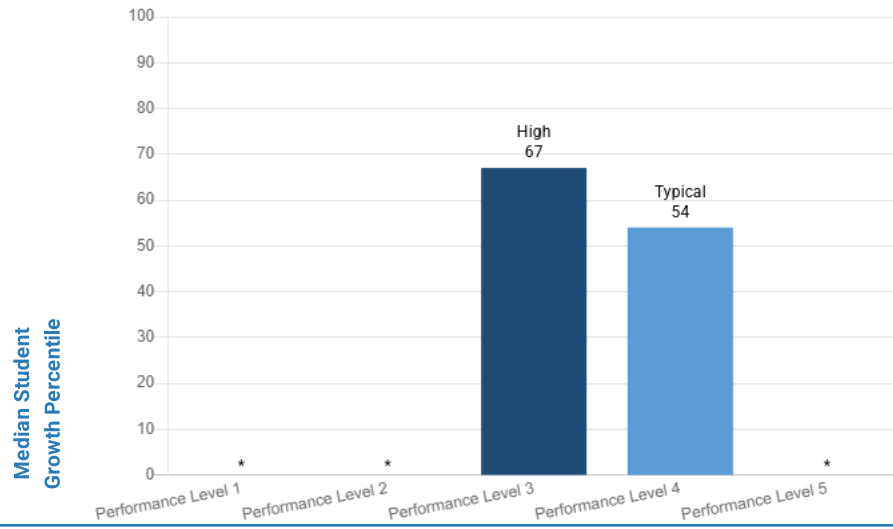

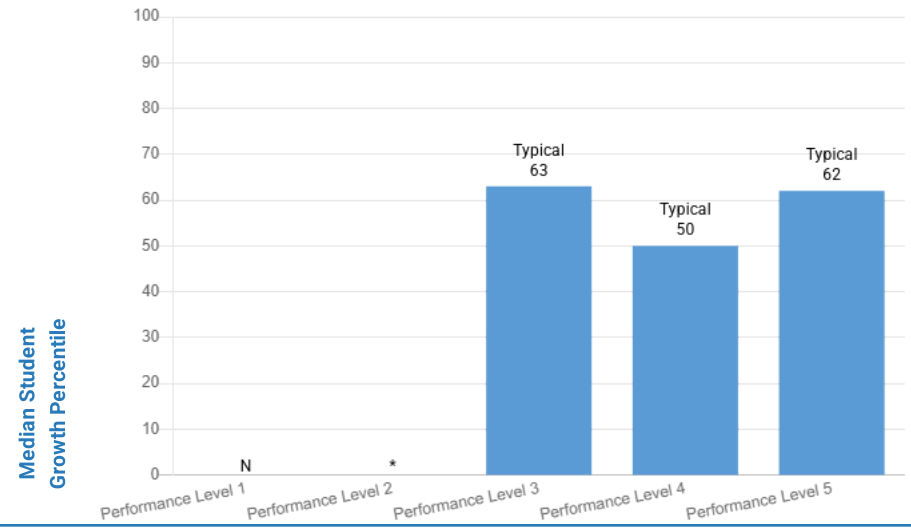

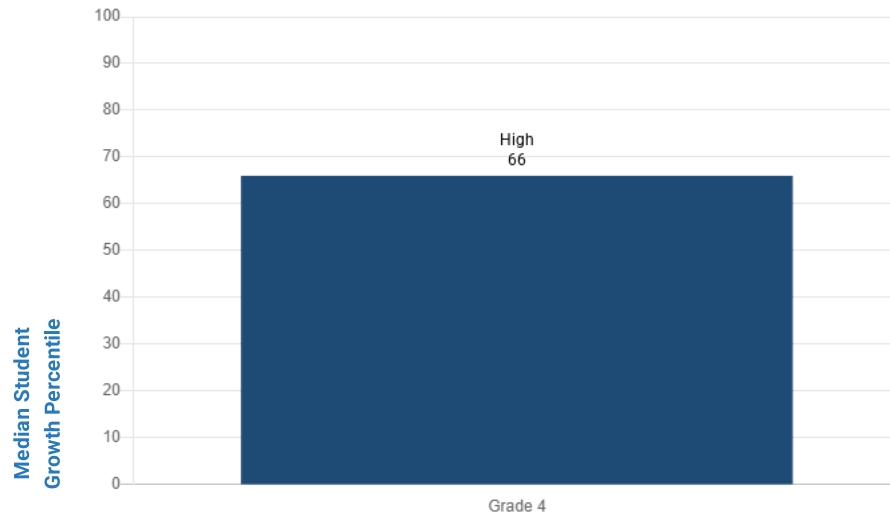

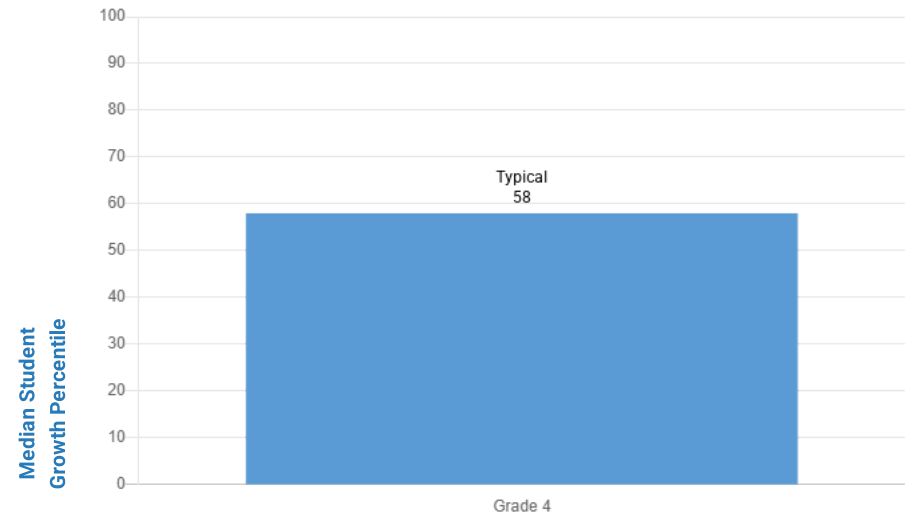

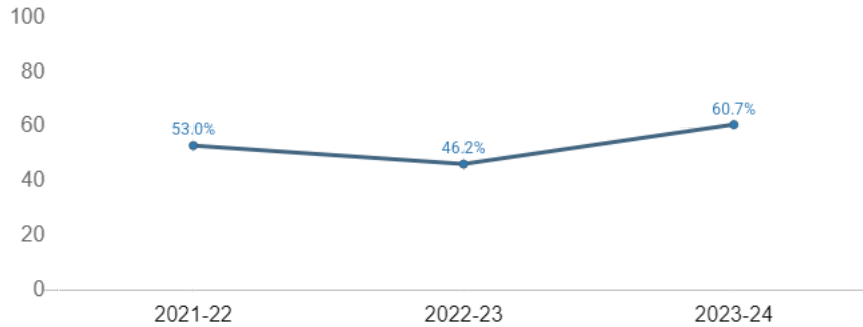

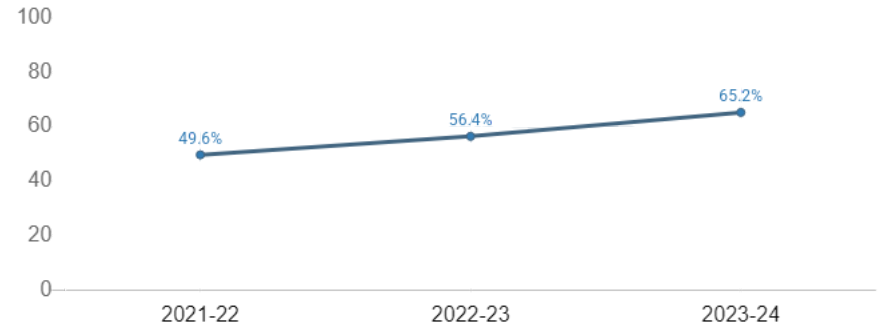
English Language Arts and Mathematics Performance Trends

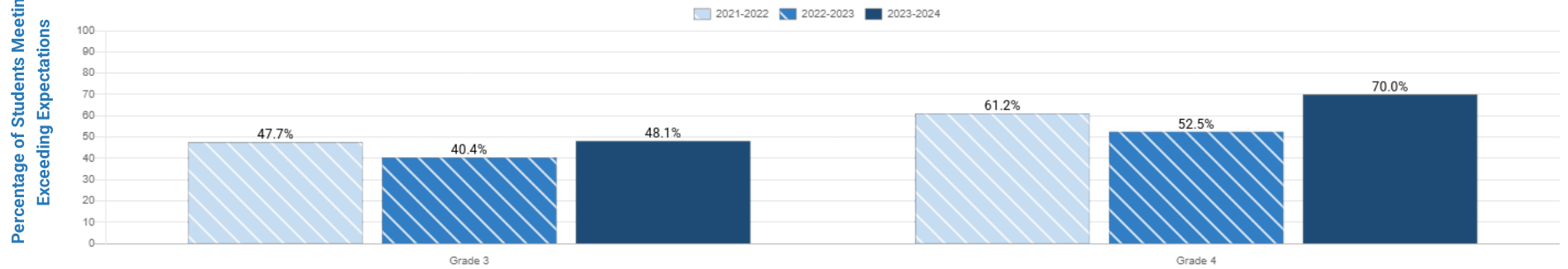

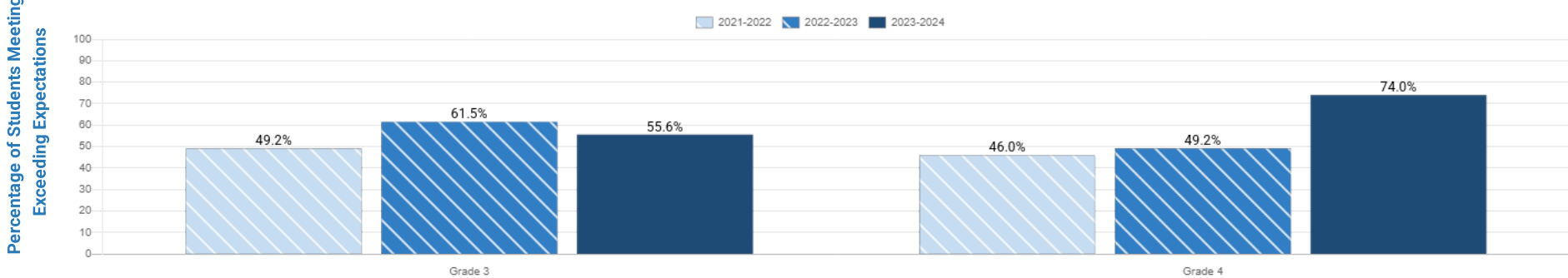

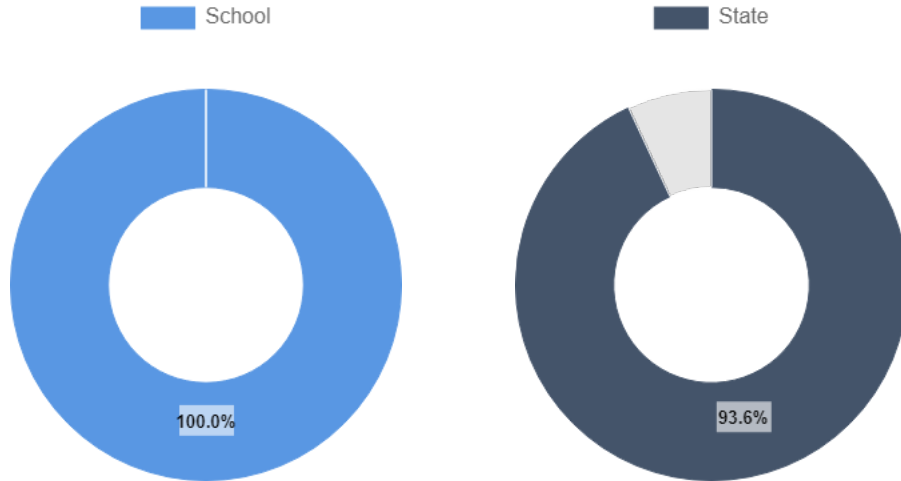

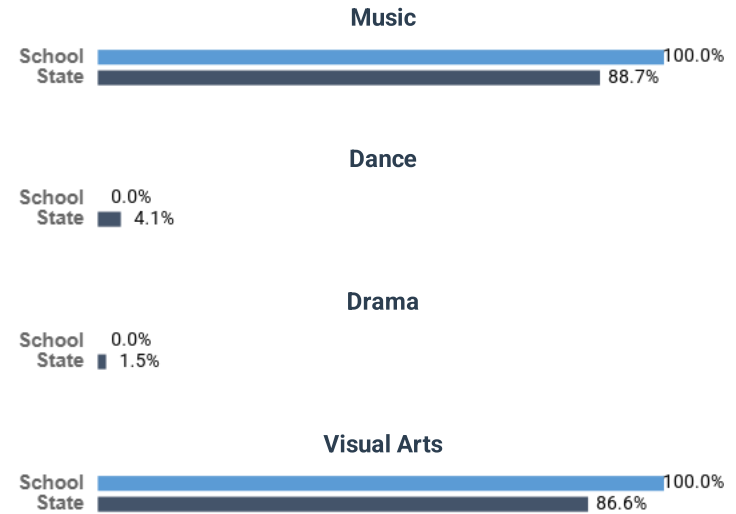

Students enrolled in one or more classes by discipline:



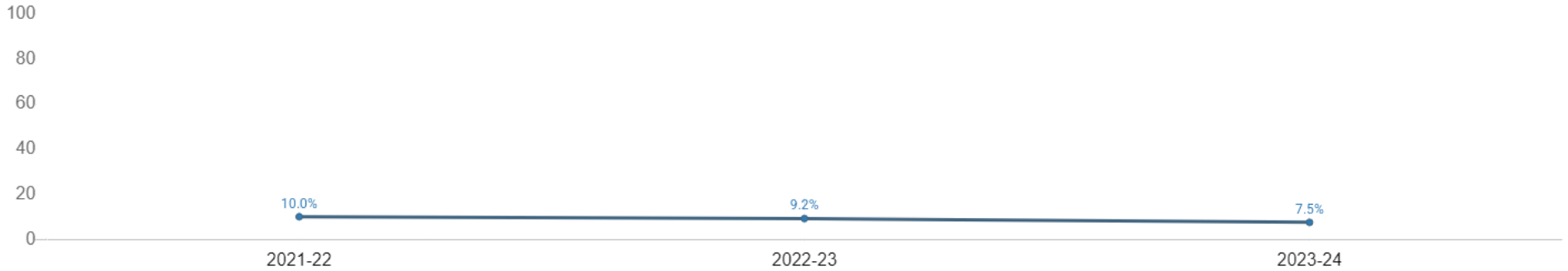

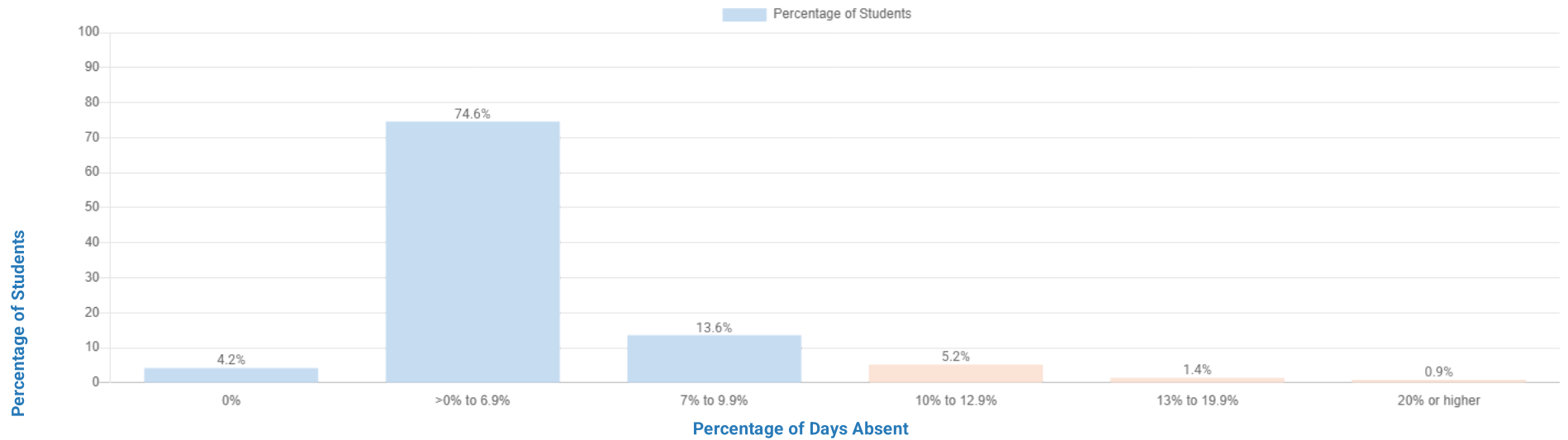

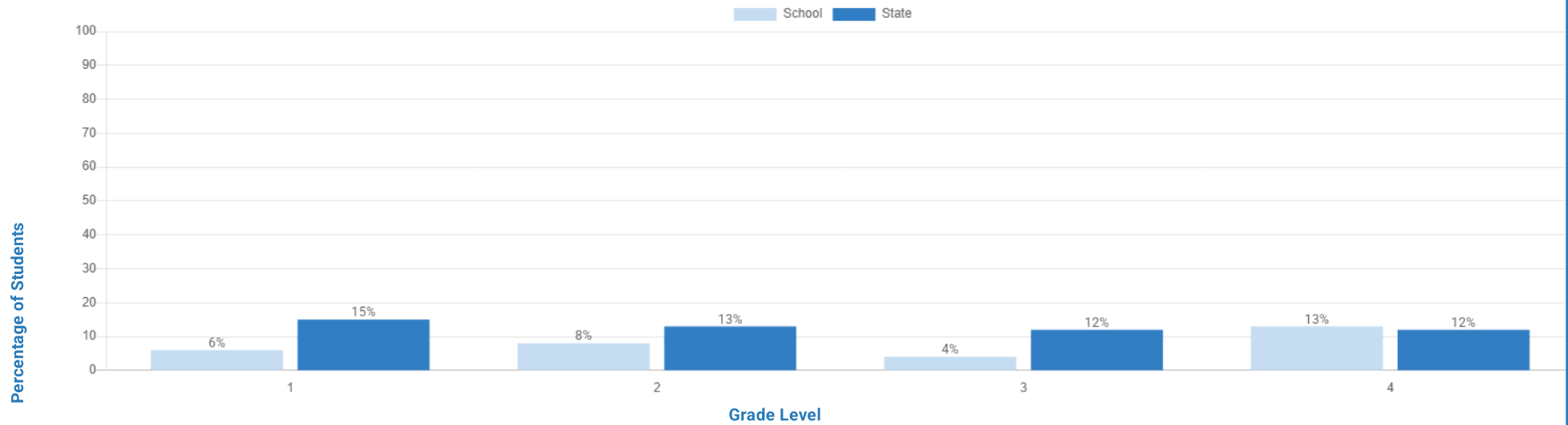

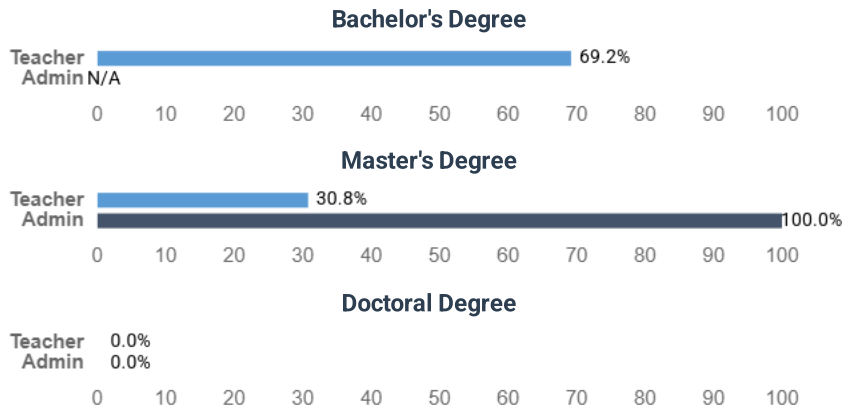

Accountability Summary by Student Group - 2023-24 School Year

Facilities:

Raritan Valley School is equipped for 21st century learning with wireless internet capability throughout the school with the appropriate bandwidth for fast internet browsing and streaming video.
