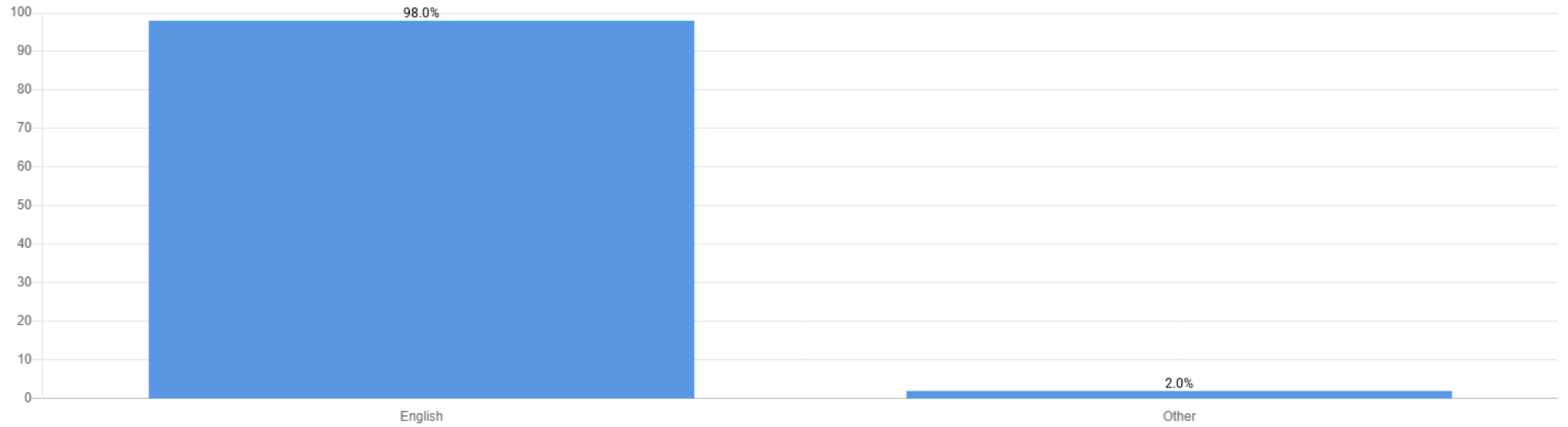

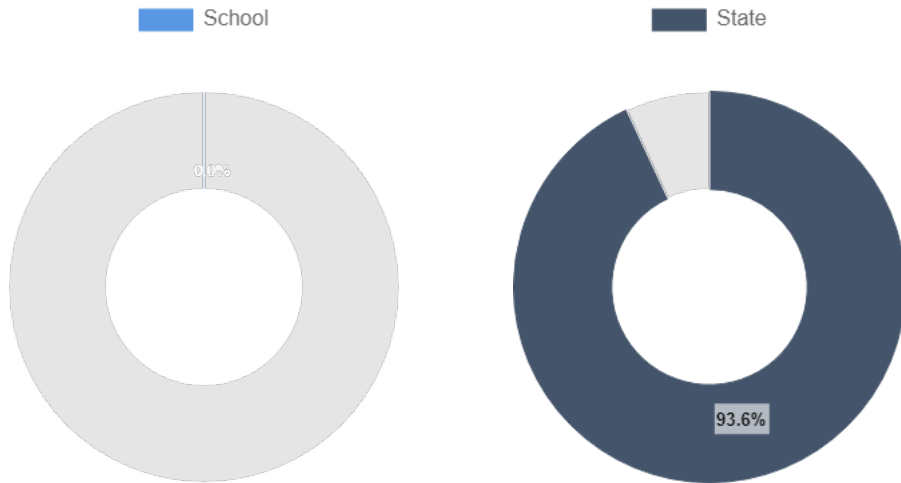

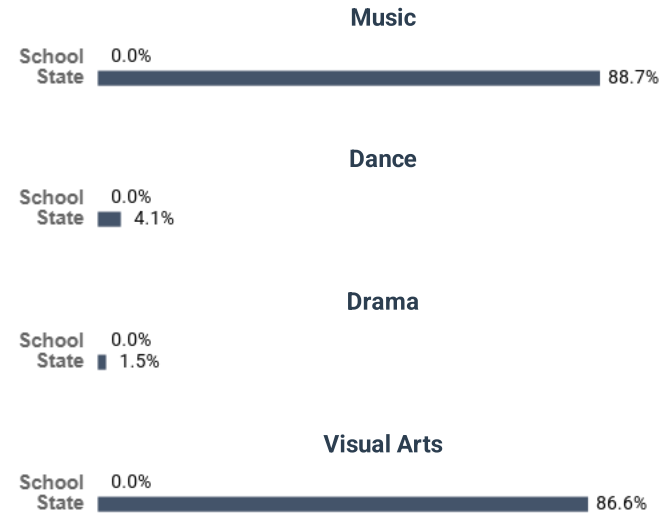

**Students enrolled in one or more classes by discipline:**



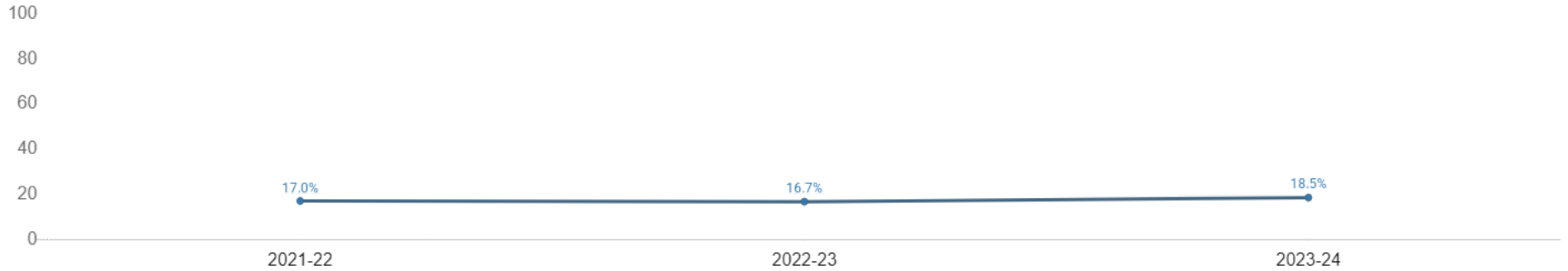

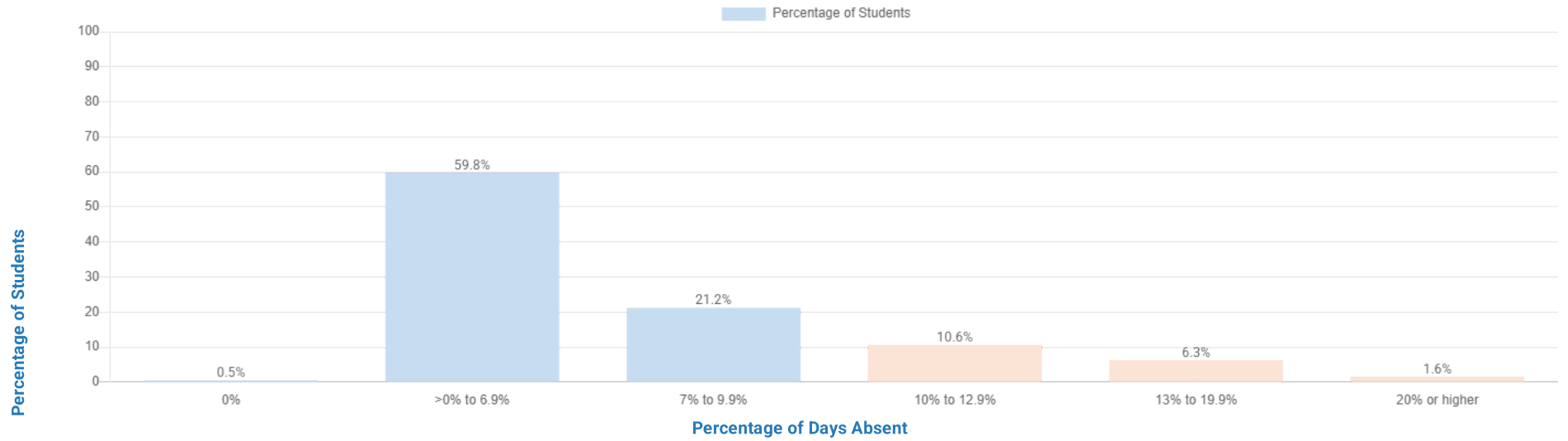

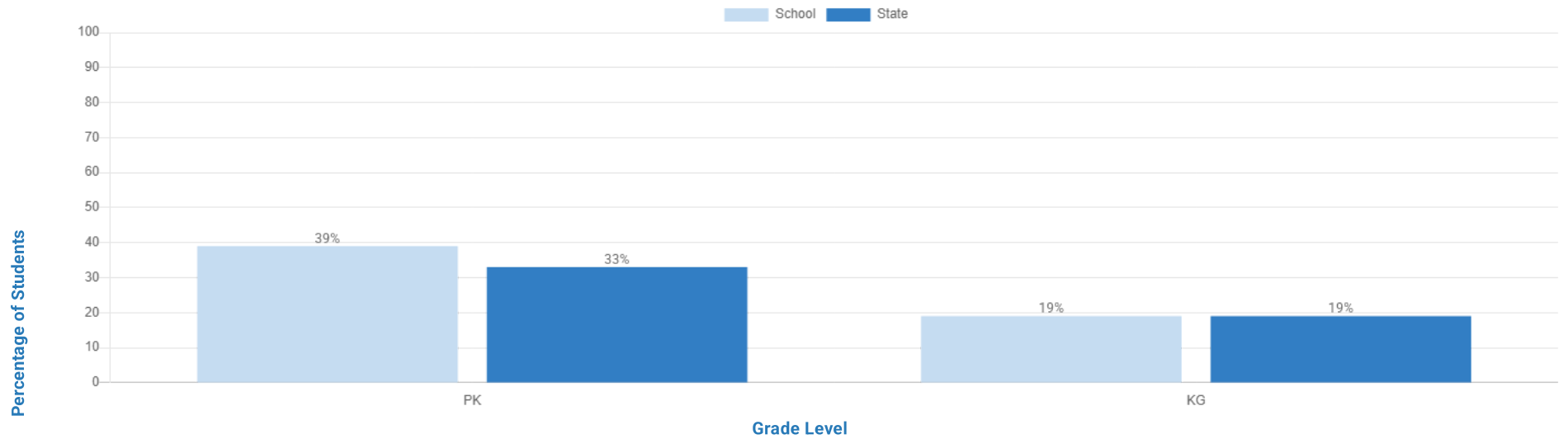

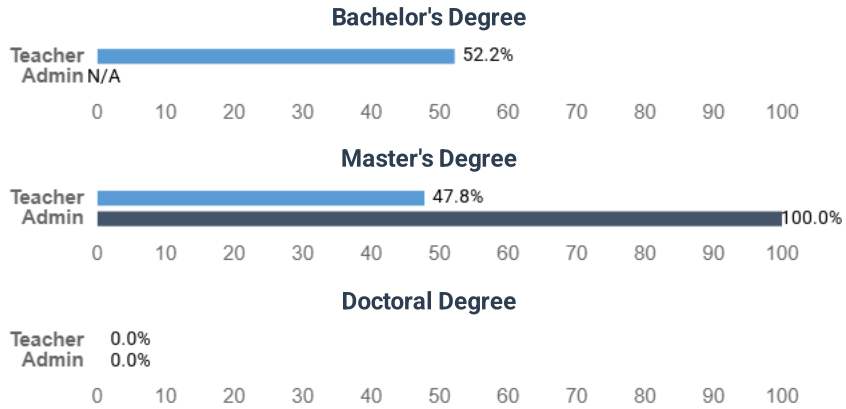

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). The course of study for preschool students is the center and play based Creative Curriculum approved by NJDOE and aligned to the Preschool Teaching and Learning Standards. In addition, preschoolers are exposed to phonics with Letterland Phonics. The Kindergarten curriculum is aligned to the New Jersey Student Learning Standards. Language Arts Literacy includes The Collaborative Classroom to provide systematic, explicit, phonics instruction. Pearson Envision Math 2.0, Mystery Science, Enrichment, Art, Music, Physical Education, and Spanish provide a well-rounded, child-centered educational experience.



### Before and After School Programs:

Before and after care services are provided by Right at School, servicing preschool and kindergarten students. The program opens at 7:00 am and closes at 6:00 pm. Students complete homework and engage in fitness, enrichment and outdoor activities in a safe, nurturing environment.



### Staff and Professional Learning:

Teachers are required to participate in 20 hours of professional development throughout the year in addition to two full days. The focus of training is based on District and building goals, as well as, Professional Development Plans. SD ECLC maintains a fully inclusive environment educating general education students with students with disabilities, offering the full range of services. ELL students are provided with in class support and pull out resources. I&RS identifies and creates action plans that may include Targeted Reading, ST, OT, PT and behavioral support. Various research-based approaches such as Applied Behavioral Analysis, individual and class reward systems, assemblies, principal recognition and school wide Positive Behavior and Intervention Supports (PBIS) are integrated throughout the school day.



### Student Health and Wellness:

SD ECLC adheres to our district's Wellness Policy that includes measurable goals to promote nutrition and health. We participate in Dental Awareness Week, Lions Club Vision Screening, and Sustainable New Jersey. SD ECLC has been recognized by PACNJ as an "Asthma Friendly School". Students participate in weekly Physical Education classes that incorporate nutrition and fitness. Students are encouraged to bring healthy snacks and lunches. All classrooms are "nut free" and adhere to a "No sugar as the first ingredient" policy. Students also have access to Guidance counseling services as appropriate.



### Parent and Community Involvement:

The SD ECLC staff and families partner to enhance educational programs and staff resources. An active Parent Teacher Organization (PTO), Reaching All in Need Everyday (RAINE) and District Wide events enable community stakeholders to support student development and learning. Our PTO welcomes new parents with open arms. Activities such as Fall Harvest Festival, Spookley Pumpkin Patch, Holiday Hoopla, Field Day and Art Show increase children's feelings of success. An Early Childhood Advisory Council (ECAC) composed of parents, educational practitioners, and community members meet and work together to ensure high quality preschool through grade three early childhood program implementation that accelerates all children's social, emotional, cognitive, and physical development.

### Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism. Interventions are provided for struggling students and consequences are enforced for unexcused absences. Parents are very much involved in the process. The district's early warning system notifies parents or guardians when a student reaches a certain threshold of absences, including phone calls, letters, or scheduled meetings. The utilization of a truancy officer assists building principals by working with families to identify and address potential reasons for absences like transportation issues, health concerns, or family challenges.
