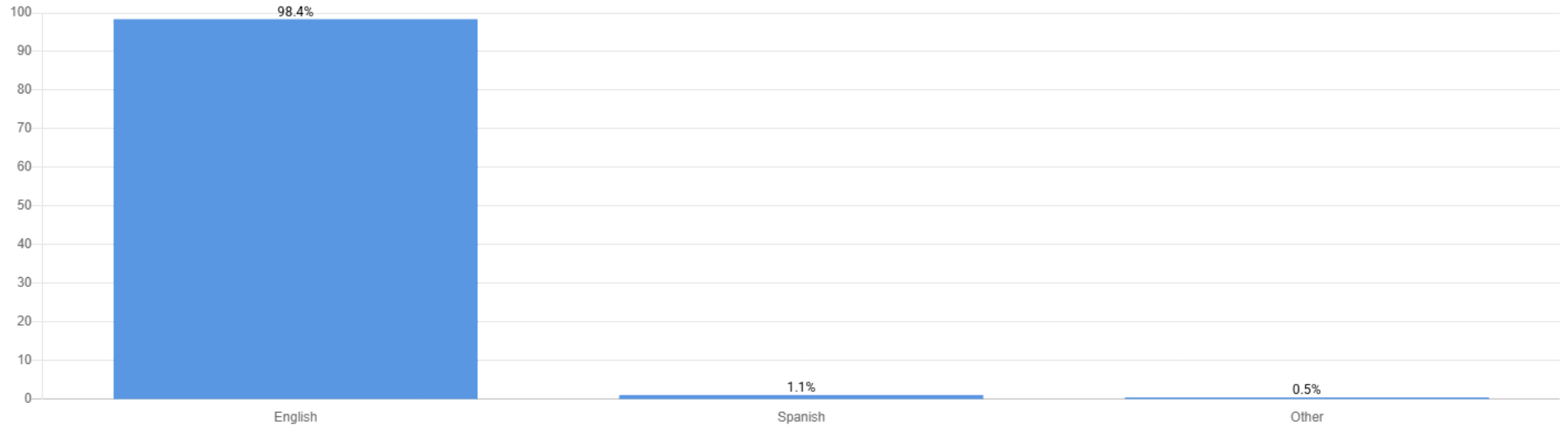

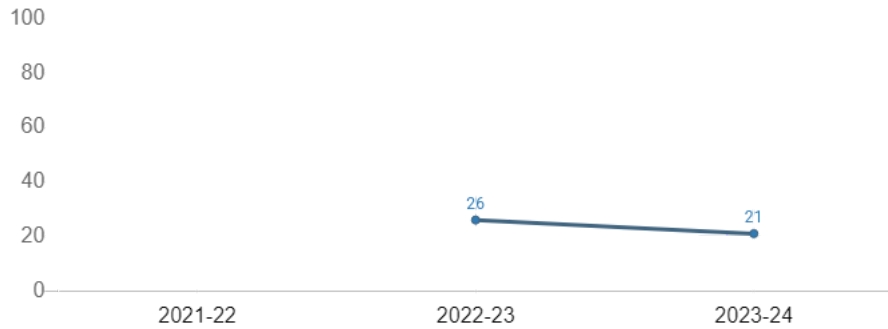

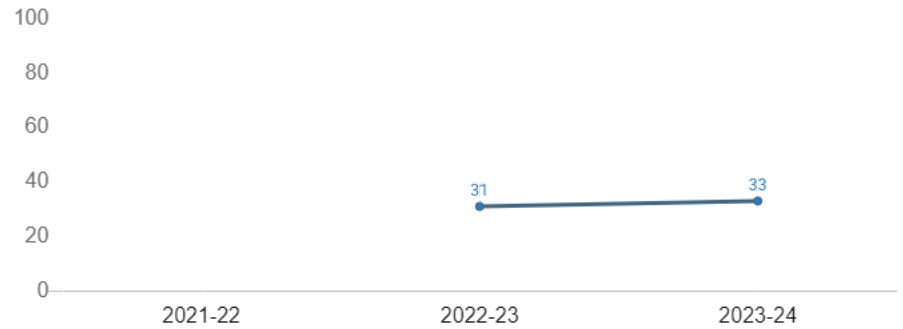

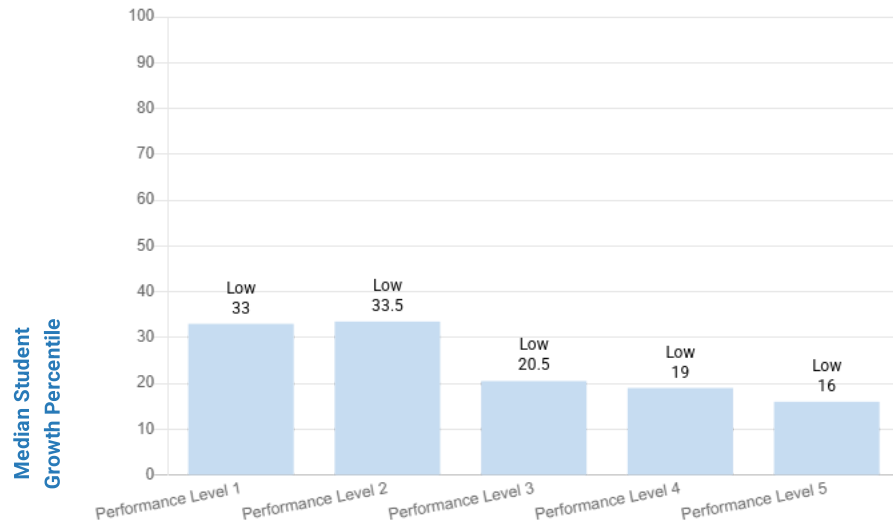

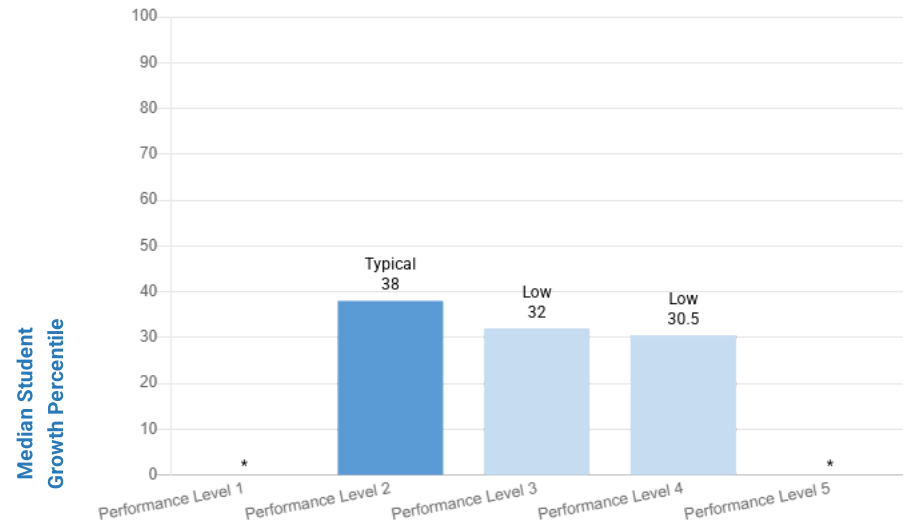

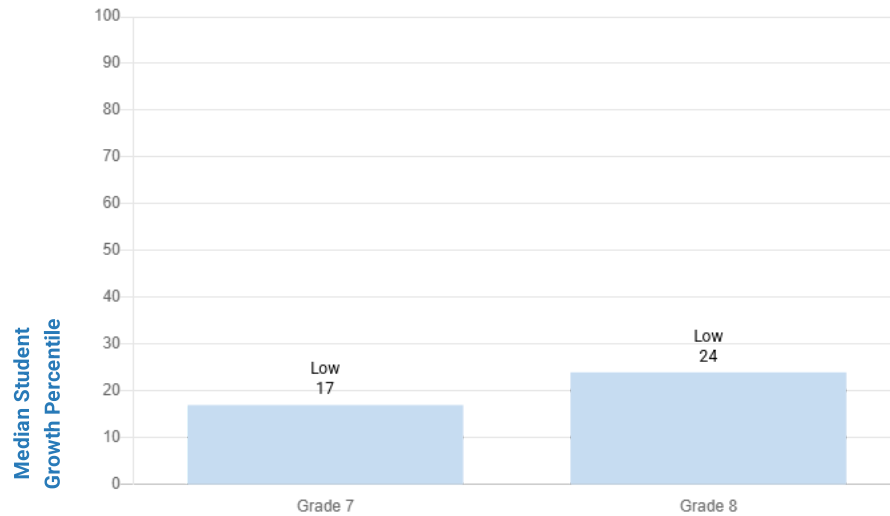

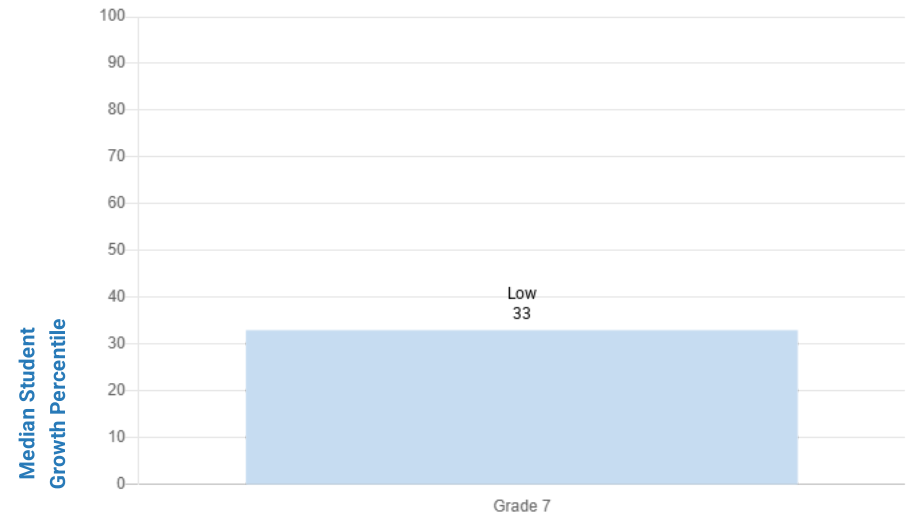

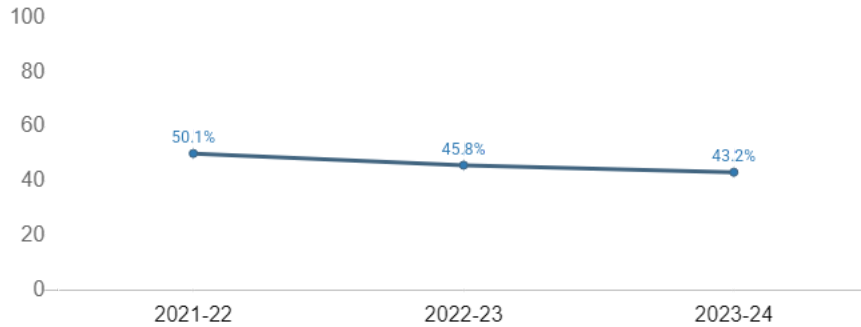

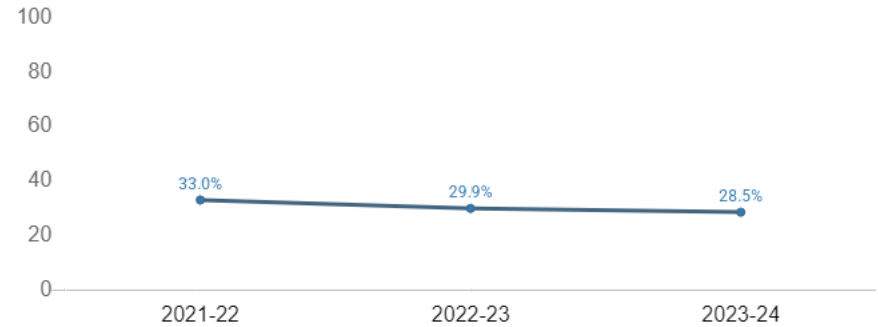
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 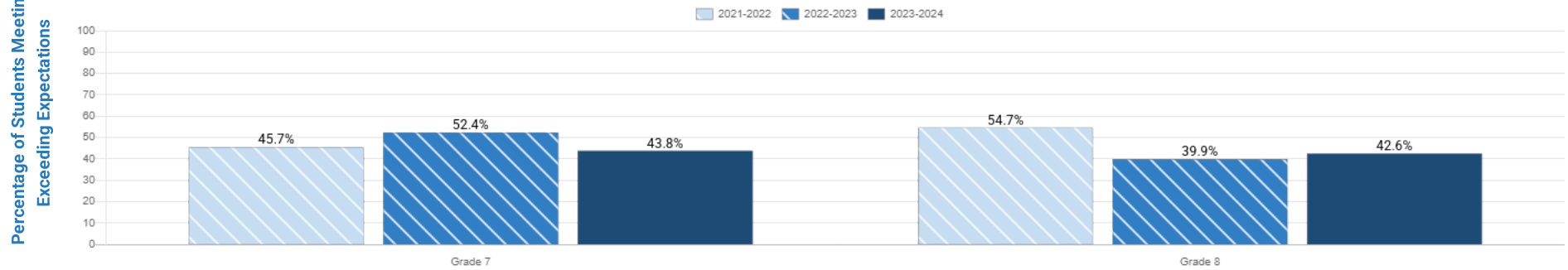

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. 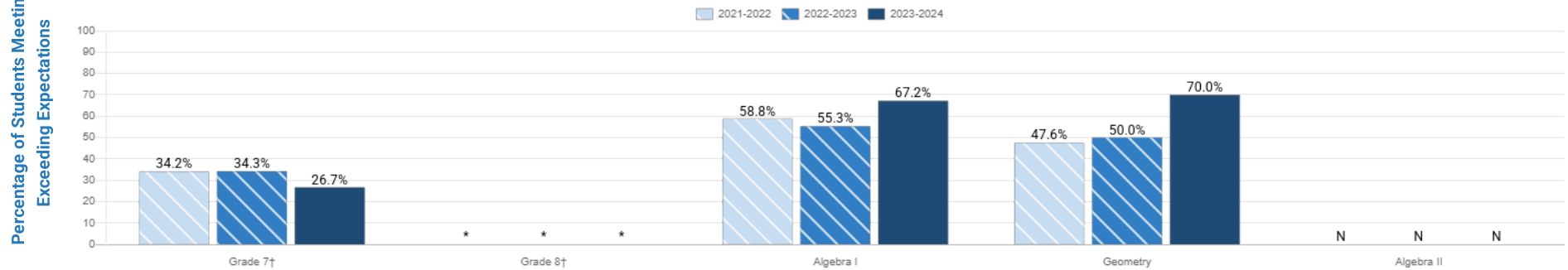

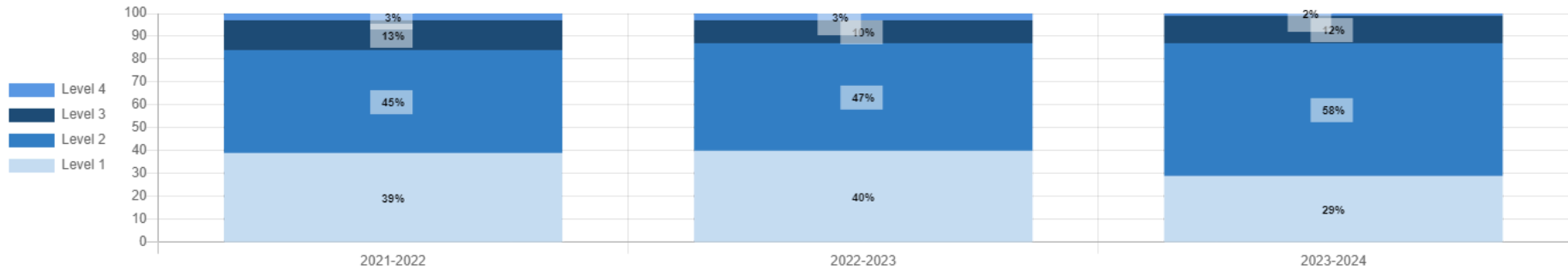

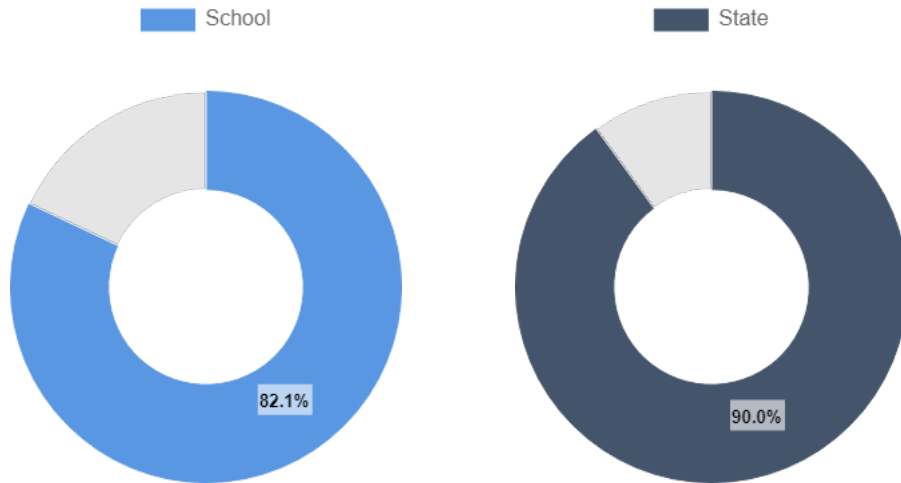

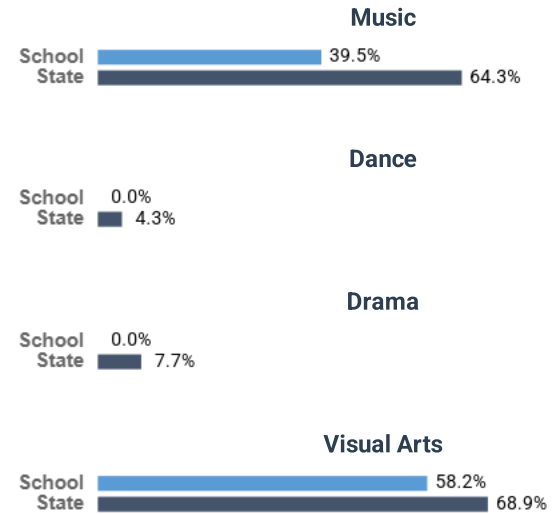

Students enrolled in one or more classes by discipline:



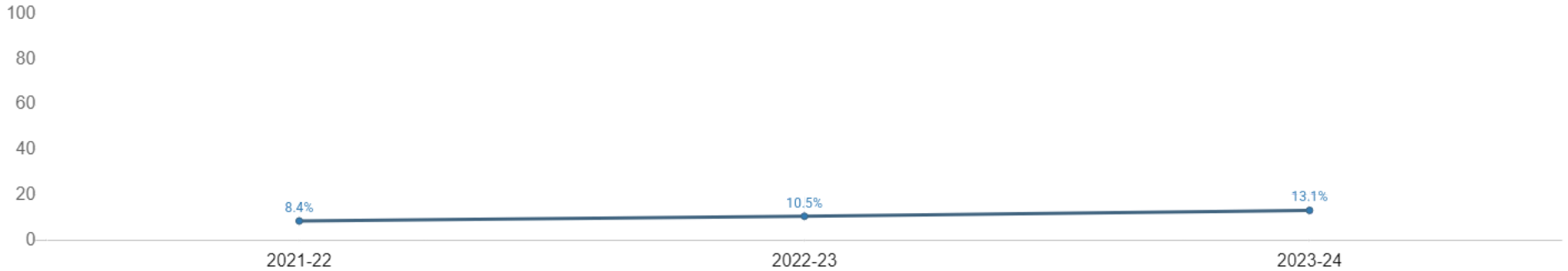
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. 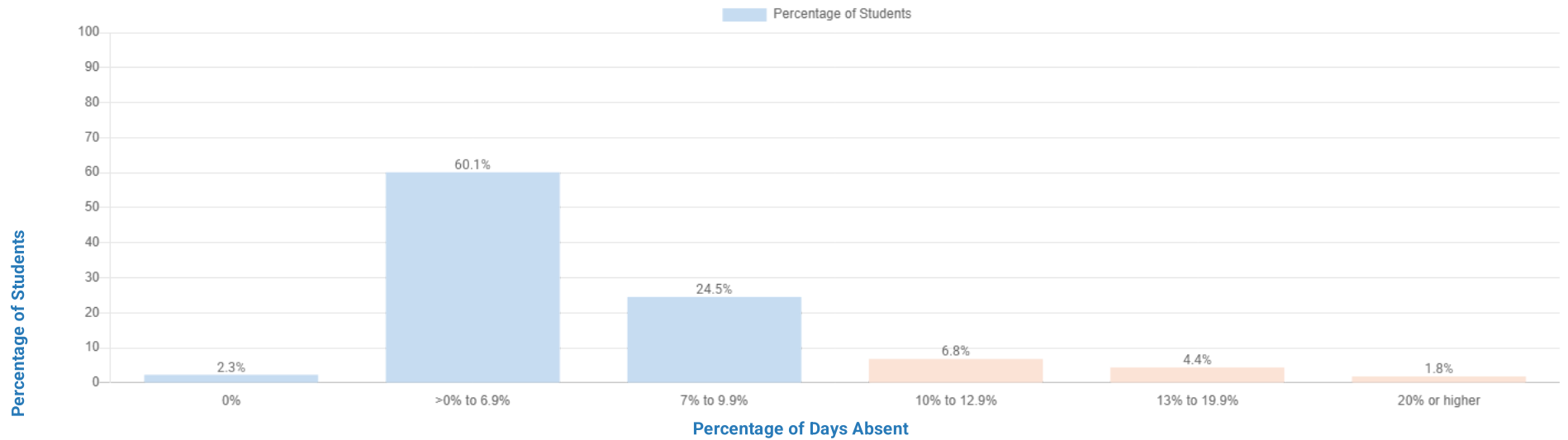

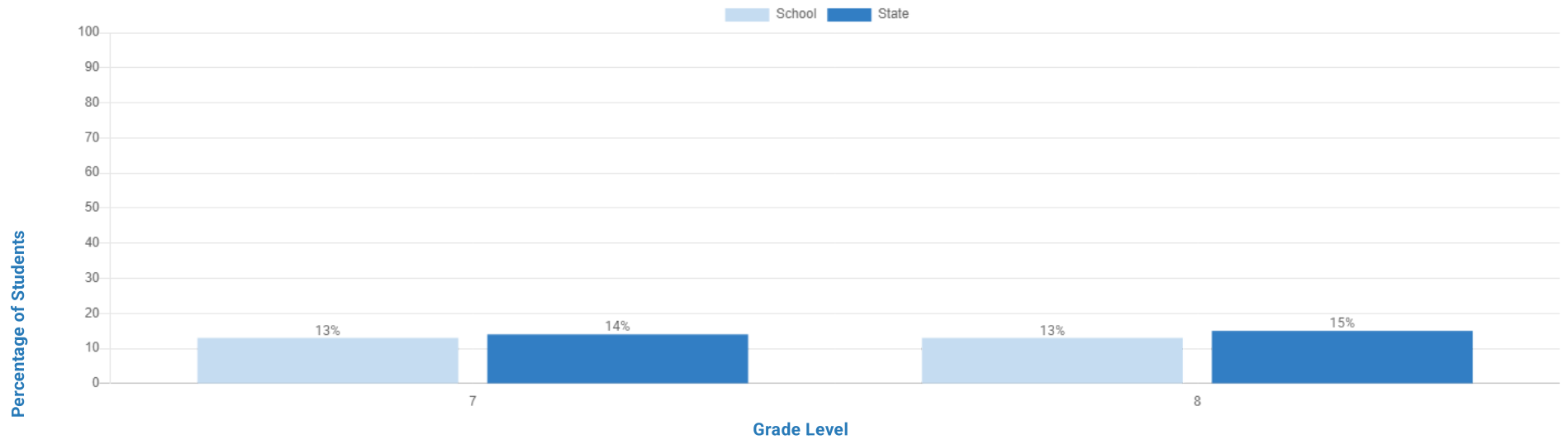

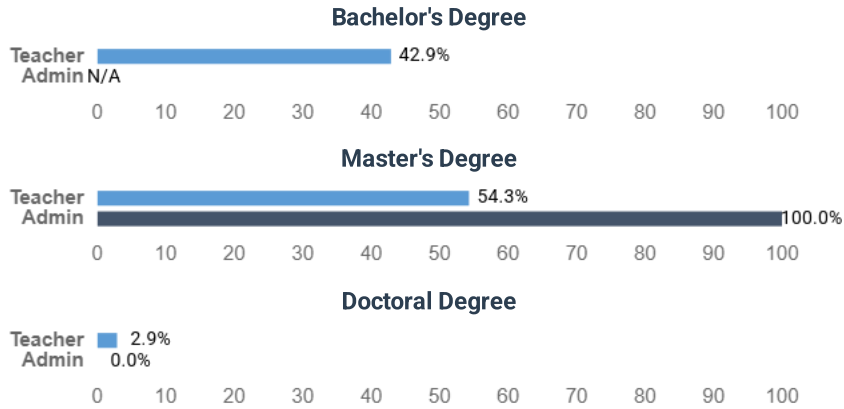

Enrichment elective cycles, honors level courses, and high school level courses offer students rigorous pathways. Technology integration is a consistent part of each school day, with all students utilizing 1:1 personal devices, specialized fabrication equipment and hardware, and a diverse set of applications and software to help supplement instruction.

We are committed to professional learning, to support teachers in their growth as master educators. Staff members collaborate, articulate and participate in workshops presented by administrators, teachers, and other professionals. In addition, they set personalized goals and are provided time to develop in the areas they choose. Through participation on the School Improvement Panel, District Evaluation Advisory Committee, Green Team, and School Safety Team, staff members take an active role in the school climate, culture, and academic initiatives.

The Hazlet Middle School PTO meets monthly and takes an active, collaborative role in school events, fundraising, and student field trips. Parents have on demand access to review student status and progress information, student records, and engage with staff about student needs. The school website, social media accounts, and weekly communication channels provide families with a steady stream of important news and information, timely student activity alerts, and special events and programming.

Facilities:

Hazlet Middle School was built in 1963 and has been renovated and meticulously maintained since then, including upgrades to bathrooms, lighting, flooring, classroom furniture and technology. We have upgraded science labs, network infrastructure, and sound systems. During the summer of 2018, new HVAC, windows and doors were installed. A STEM center, consisting of science and robotics lab classrooms and collaboration spaces were created, and the Media Center was transformed into a Learning Hub. Additionally, Promethean interactive white boards have been added to collaboration spaces in locations. During the summer of 2021 the main Gym floor was replaced with a new wooden floor , removing the Mercury Floor that was in place. Upgrades to Bathrooms and locker Room were completed in 2021. Interior fire doors were replaced in the summer of 2023.

School Safety:

School safety and emergency response drills are conducted each month in accordance with the NJ Department of Education guidelines. A behavioral care and assessment team consists of trained staff members prepared to evaluate sensitive matters and determine appropriate student support. A SLEO Class III Police Officer provides additional security and support.



Technology and STEM:

Technology and STEAM education includes programming robotics, engineering, creating functional electronic circuitry, meteorological analysis, green screen applications, and stop motion film-making using digital editing software. All staff and students are issued Chromebooks and utilize the Google Education Suite. Targeted collaboration spaces are outfitted with interactive screens and the building offers infrastructure for complete woodshop, engineering lab, science labs, and green screen filming.



Attendance:

The Hazlet Township School District implements a comprehensive attendance program to improve and monitor chronic absenteeism. Building leadership tracks and identifies chronic absenteeism. Interventions are provided for struggling students and consequences are enforced for unexcused absences. Parents are very much involved in the process. The district's early warning system notifies parents or guardians when a student reaches a certain threshold of absences, including phone calls, letters, or scheduled meetings. The utilization of a truancy officer assists building principals by working with families to identify and address potential reasons for absences like transportation issues, health concerns, or family challenges.
