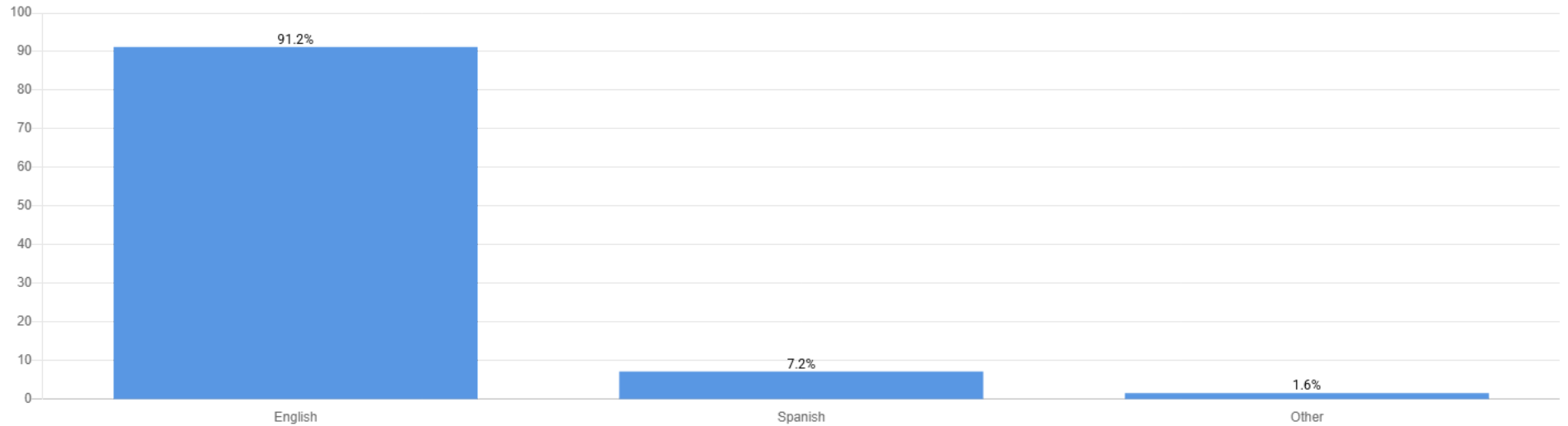

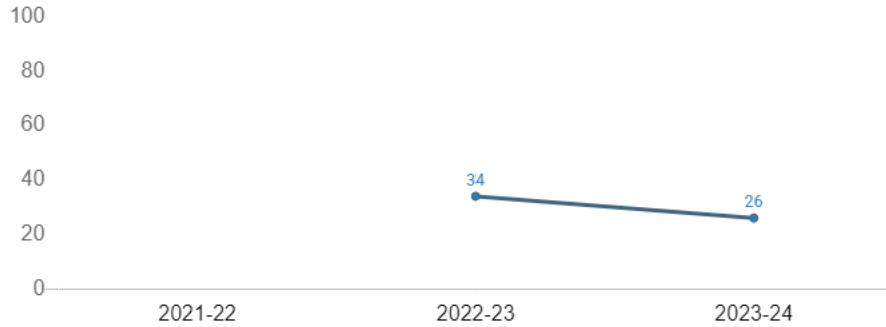

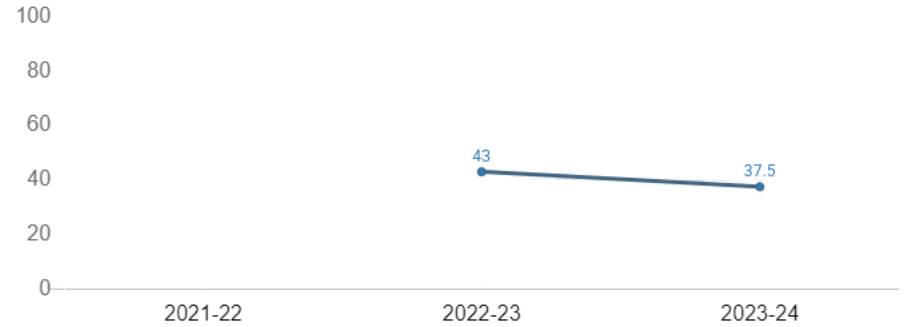

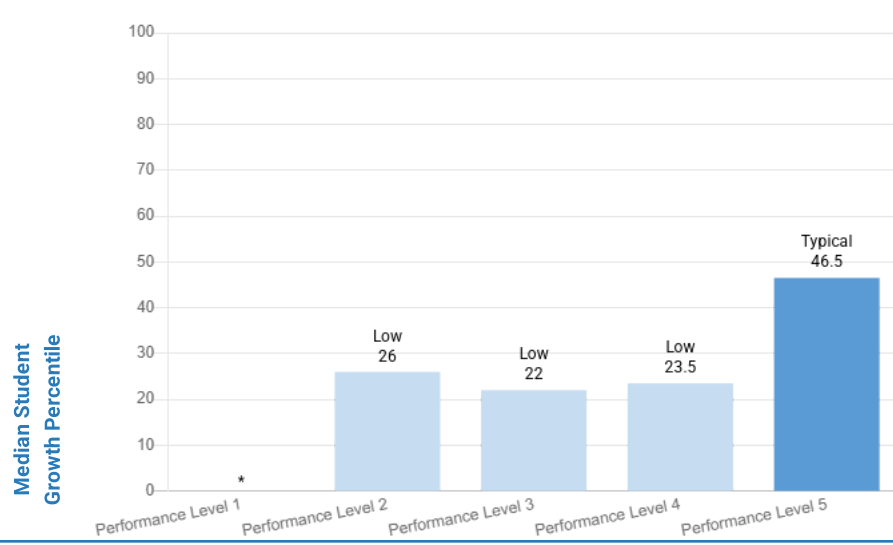

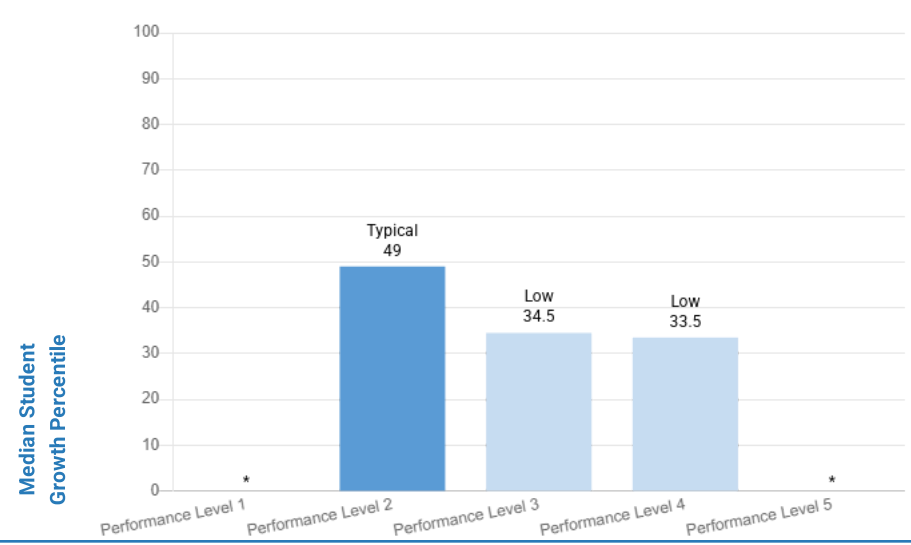

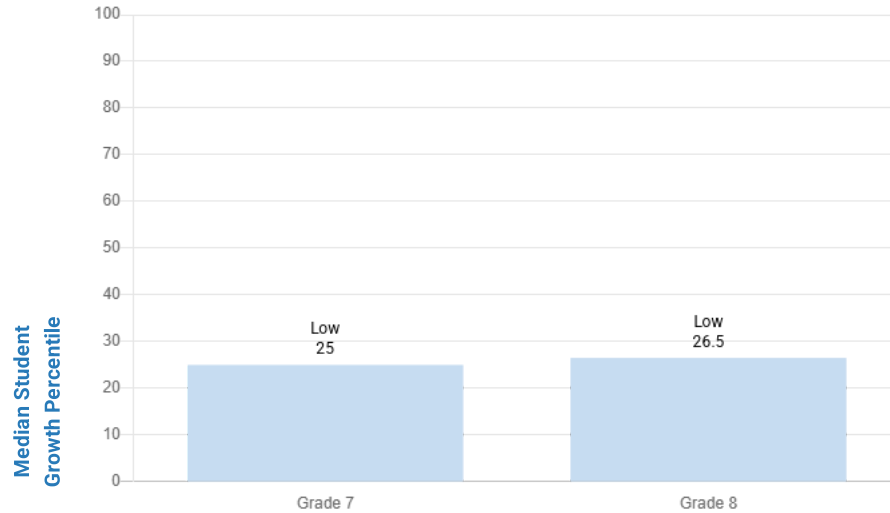

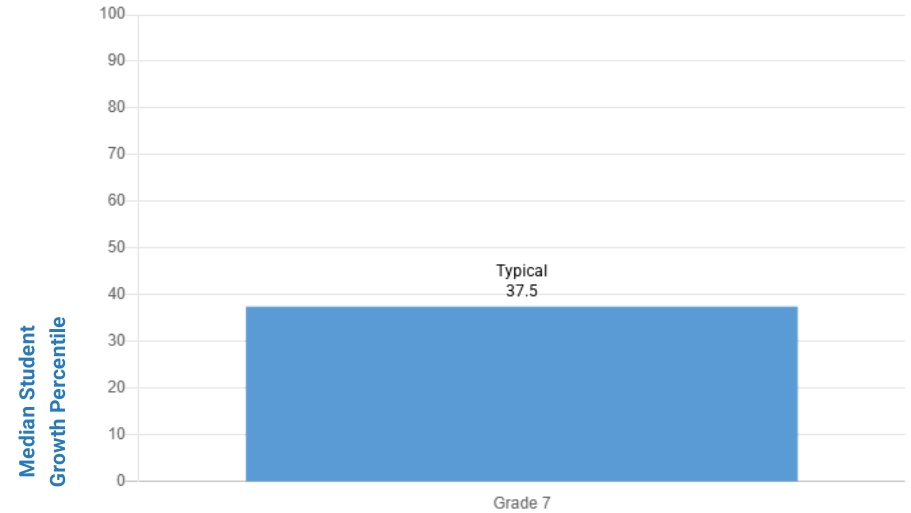

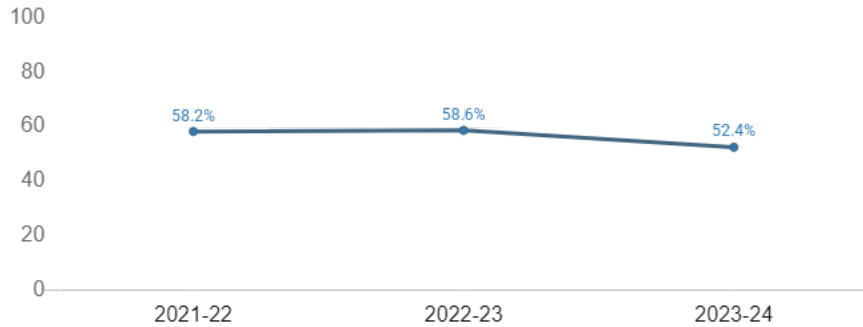

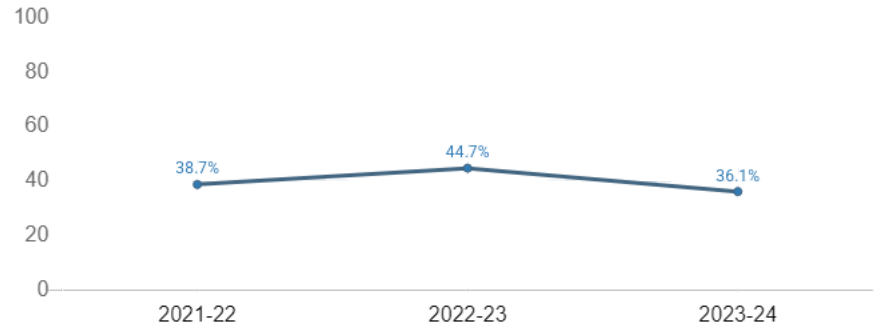
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 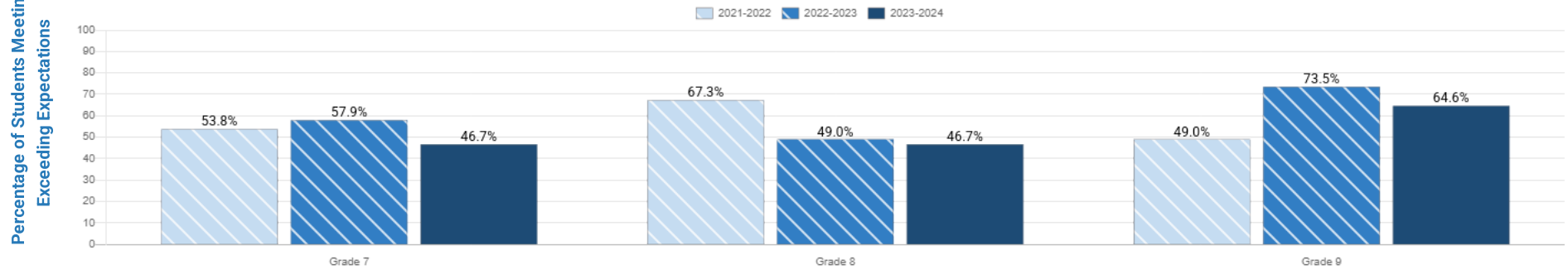

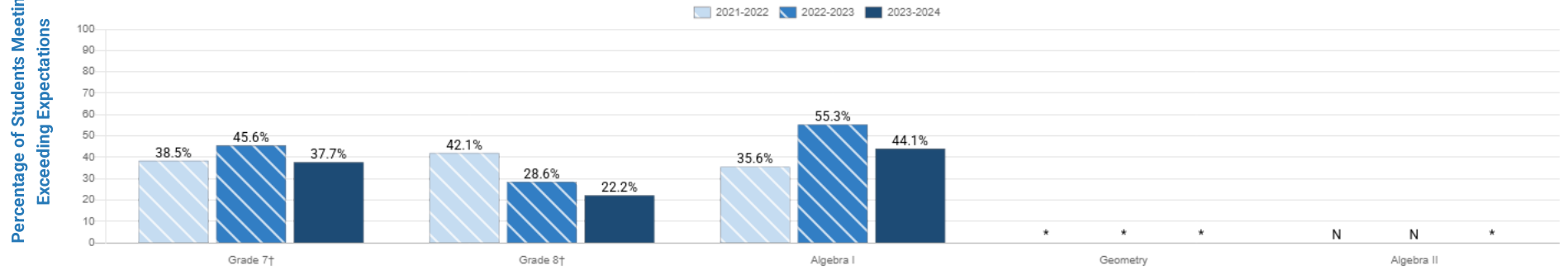

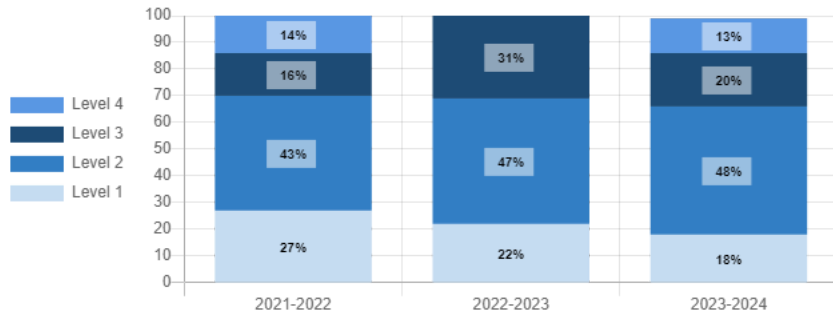

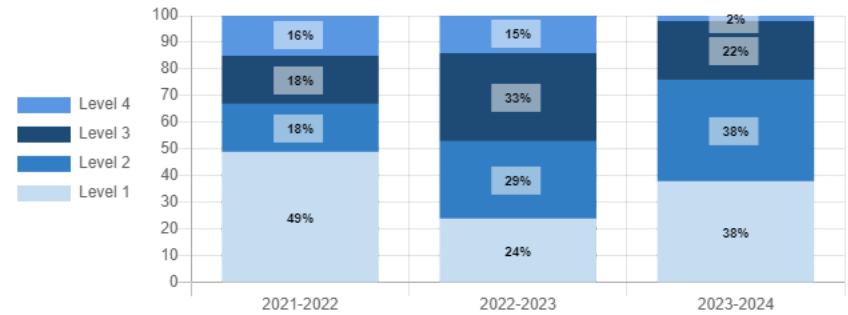
NJSLA Science Assessment: Grade 8 Summary

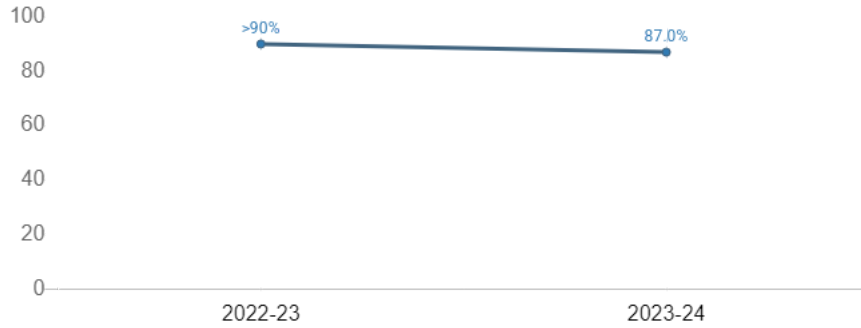

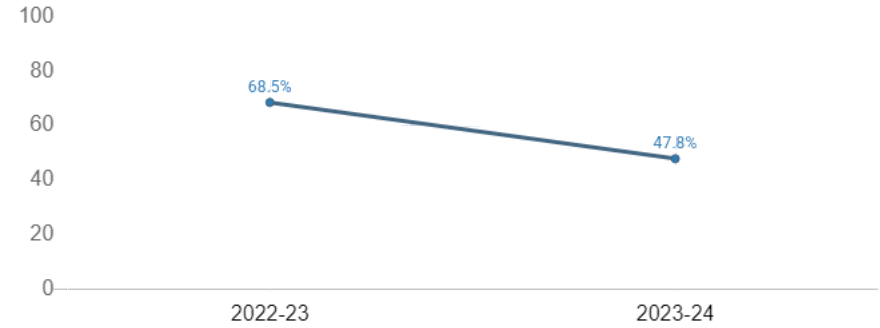

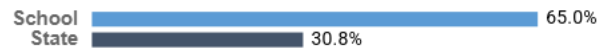

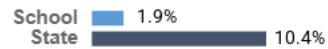

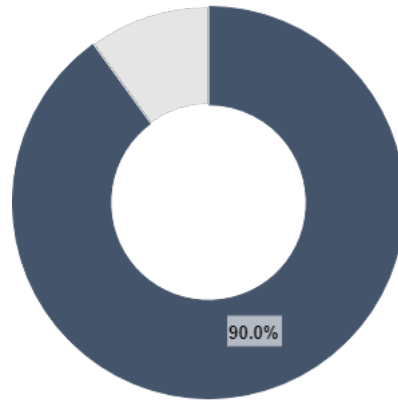
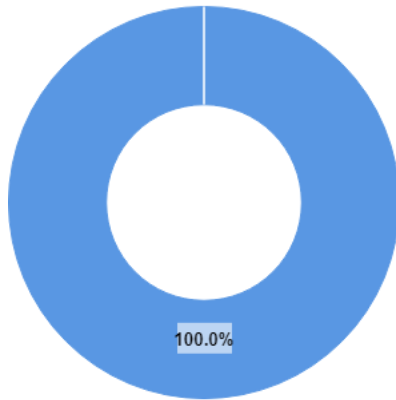

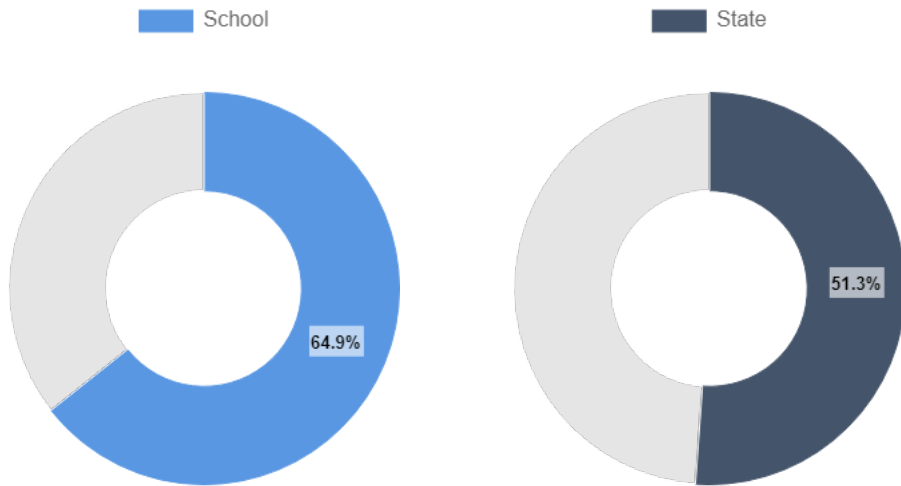

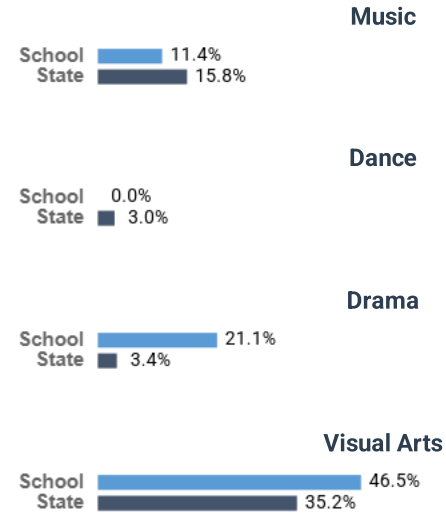

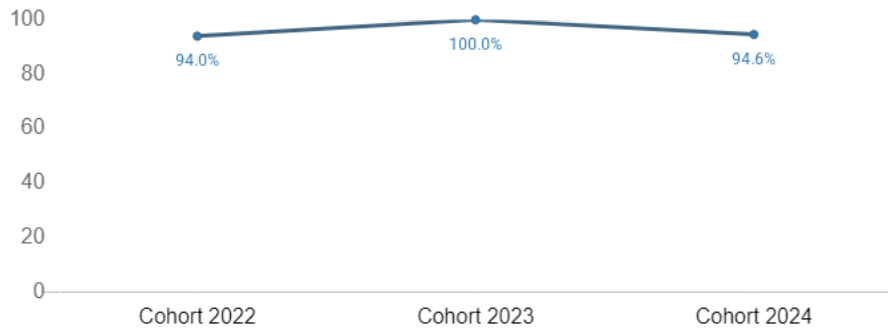

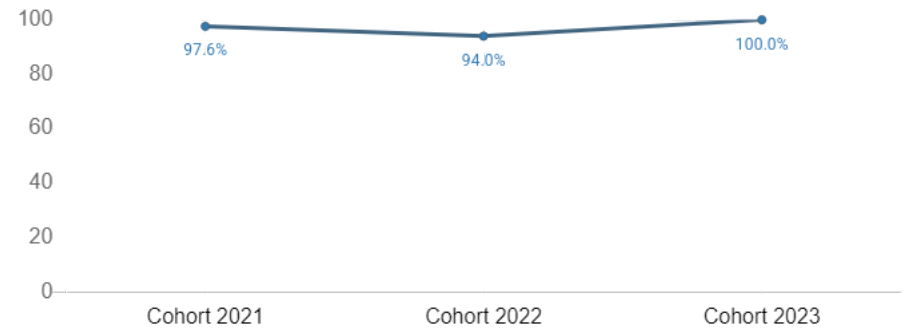

The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

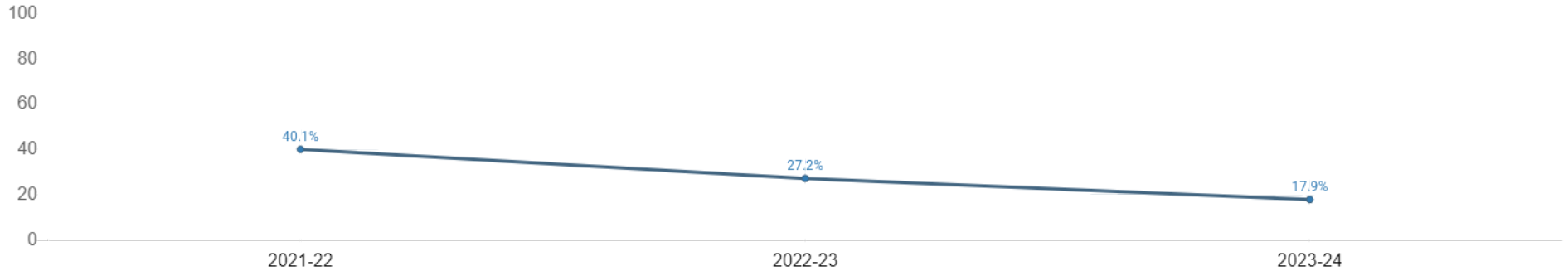

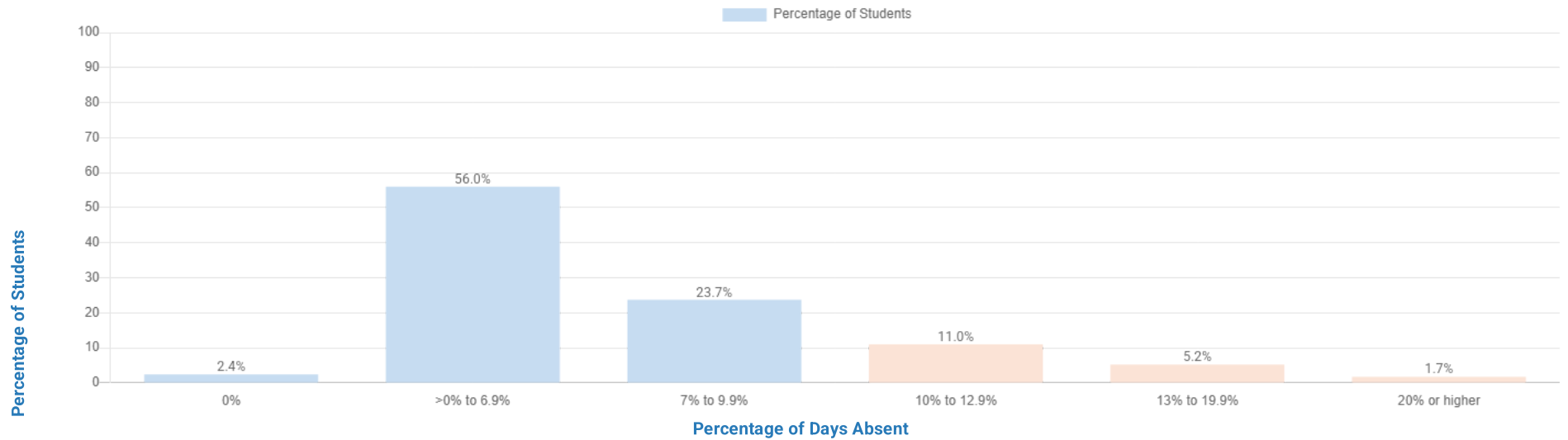

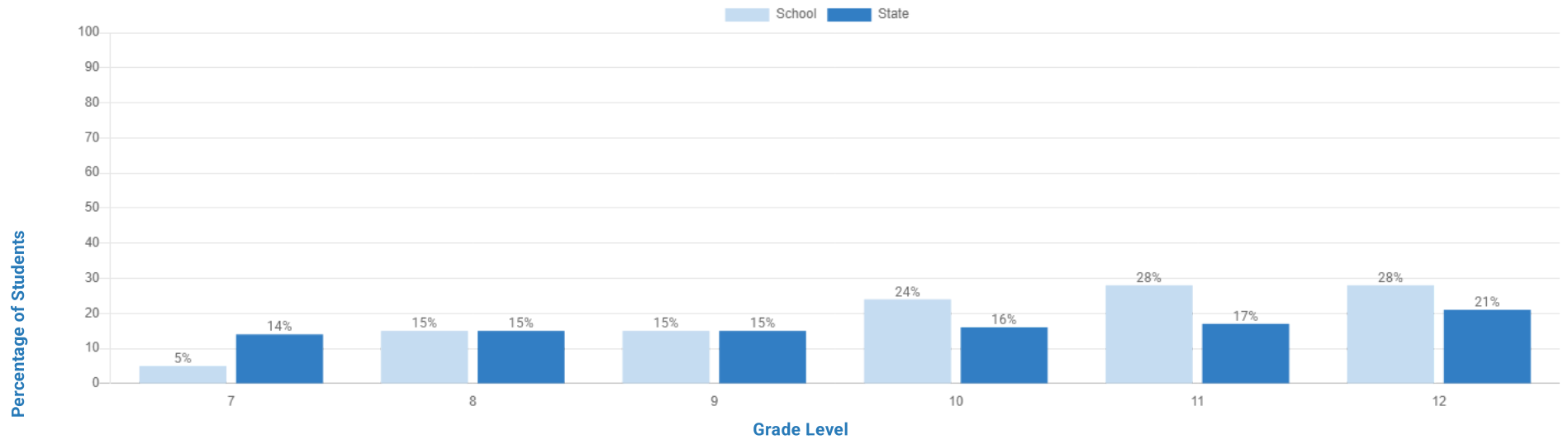

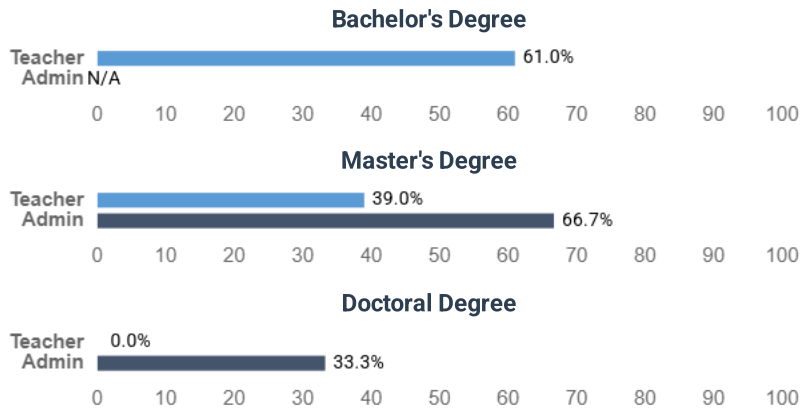

Accountability Summary by Student Group - 2023-24 School Year

Before and After School Programs:

Homework Help before and after school is provided by certificated teaching staff; homework help is free of charge to MS/HS; MS/HS-students are provided tiered interventions to prepare for the NJSLA/NJGPA; HHRS hosts Middle School Teen Arts and sends students to High School Teen Arts. Students have the opportunity to attend mindfulness workshops and yoga sessions throughout the school year. NJSLA, SAT, AP, and NJGPA prep is available in the Spring before the exams.



Staff and Professional Learning:

In service days provide a myriad of professional learning opportunities for all staff; digital learning is offered to all students in HS who are interested in a subject that is not offered to them at HHRS; this is fully paid by the Board of Education; teachers have administrative duty periods which are used to collaborate with their subject area peers and receive job embedded professional development throughout the year; teachers meet periodically by departments to discuss curriculum; AP teachers plan AP practice exams and tutorials; MS Team meets twice weekly to discuss curriculum and student achievement with the counselor. Instructional Coaches are available to assist teachers in best practices and classroom strategies.

Facilities:

38 classrooms including 6 science labs; three computer labs; media center with computers; gymnasium; Digital Video production lab; art room; music room; Makerspace room; Cafeteria/Auditorium/ additional gym space; building is 60 years old; new addition and renovations in 2005; Upper & lower playing fields; tennis courts; baseball and soccer fields in both towns utilized for athletics; most classrooms are air-conditioned; building is utilized by community through recreation; town of Highlands for meetings. New signage and athletic upgrades are in process. HHRS has overhauled the entire network over the summer of 2023. All non airconditioned rooms in the 100/200 wing recieved air conditioning over the summer of 2024. New score boards have been installed to the fields on campus.



School Safety:

The school has a Safety Plan that documents all the drills necessary for the safety of all our students and staff. There is a licensed safety specialist trained annually in the district. Twice annually the police, fire, and emergency responders meet with the safety team at HHRS students, staff, nurse, and administration to discuss safety concerns and plan drills. The Highlands Police Department frequently visits the school and performs periodic walkthroughs. Students and staff have an excellent rapport with local law enforcement. There are cameras in the building and tight security for visitors. The entire camera system has been upgraded with new cameras and blind spot coverage, including new cameras for the athletic fields. A threat assessment team has been developed and trained for the 23/24 school year.

Technology and STEM:

HHRS is in year seven of the STEAM Academy. Students apply to be in the Academy and follow a rigorous course of study. All students have a Chromebook issued to them in grade 7 and they are frequently exchanged for new ones when they are broken or updated. There are still several computer labs throughout the building; there is technology throughout the school. An upgraded WiFi system and greater bandwidth have expanded the use of digital learning in the classroom. A robust suite of Media Production classes allows students to gain real-world skills on professional-grade resources. A new project lead the way engineering class has been implemented for the 23/24 school year and a computer science class is scheduled to launch in 24/25.



Attendance:

Grant funding was essential in multiple areas of school safety, student wellness, and support for student performance. Our grant-funded after-school therapy program has given our students many hours of much-needed therapeutic services with a licensed professional counselor. HHRS was also able to train staff in wellness and yoga which has allowed in-house staff to have the capacity to support students during and after the school day. Utilizing grant funding, a dedicated program of student support was developed and implemented to assist students who were not making expected growth levels on local benchmarks, NJSLA, and NJGPA. Student data results show increases across multiple areas including large gains in NJGPA graduation ready from the 21/22 school year. Through grant funding, a much-needed security upgrade was completed that will ensure full coverage of the entire building and the addition of cameras on our athletic fields allowing for full campus coverage.

Other Information:

We provide a curriculum that is aligned with the New Jersey Student Learning Standards and fosters high academic achievement for all students. Although small in size, Henry Hudson Regional School offers a wide array of honors and Advanced Placement courses either in-house or through online education. Students in the twelfth grade can enroll in courses at Brookdale Community College, through a Dual Enrollment agreement between the two schools. Middle School students participate in a "school within a school" approach to learning. A team of teachers has been trained to work together during a common planning period to develop interdisciplinary problem-based learning opportunities for all 7th and 8th-grade students. Students are introduced to STEM activities through a dedicated Enrichment program as well as "push-in" classes offered by the STEM Coordinator. Henry Hudson Regional has one of the first STEAM Academies in Monmouth County accepting students for tuition. This rigorous program promotes creative thinking and problem-solving. Students follow a four-year plan which includes an internship and capstone project in senior year. Students will receive a special designation on their diploma at graduation HHRS also prides itself on having a Digital Production Program, which allows students to become young filmmakers. Many of our students have been recognized nationally and internationally for their creative film projects. Henry Hudson is the first school in Monmouth County to embrace the MC Arts MS/HS program and students may participate while BOE pays their tuition.
