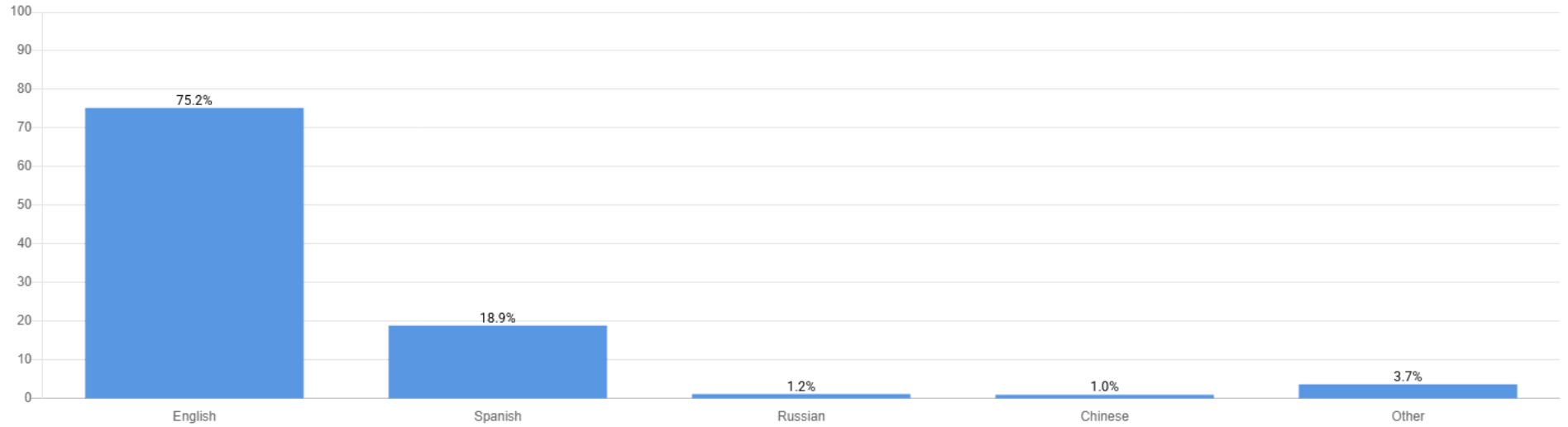

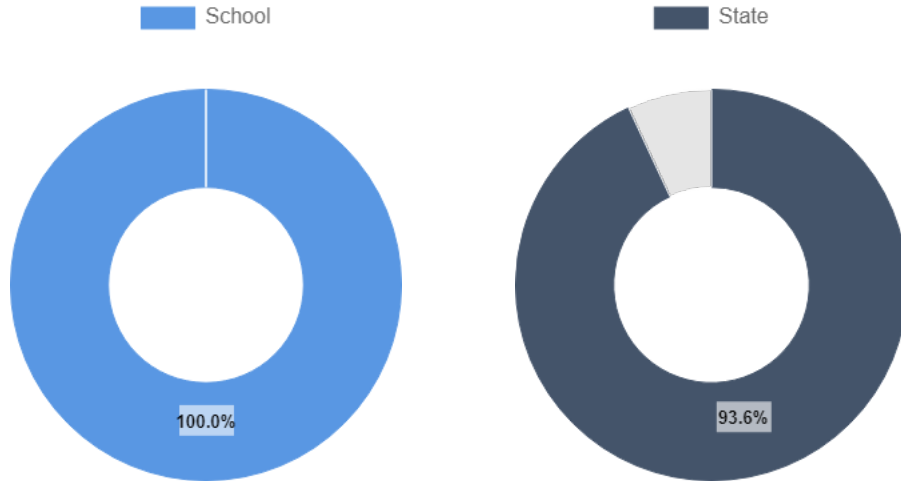

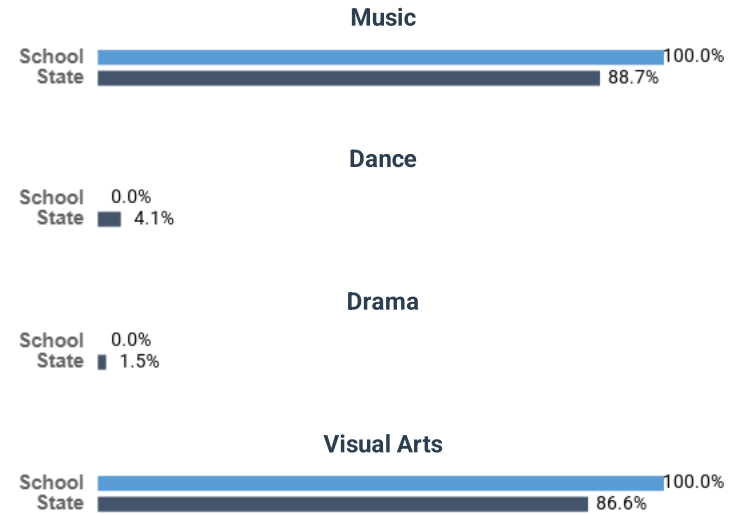

Students enrolled in one or more classes by discipline:



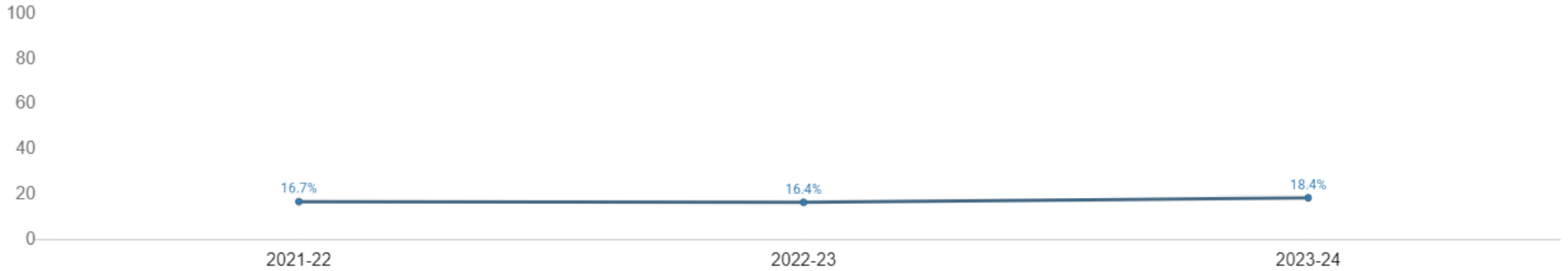

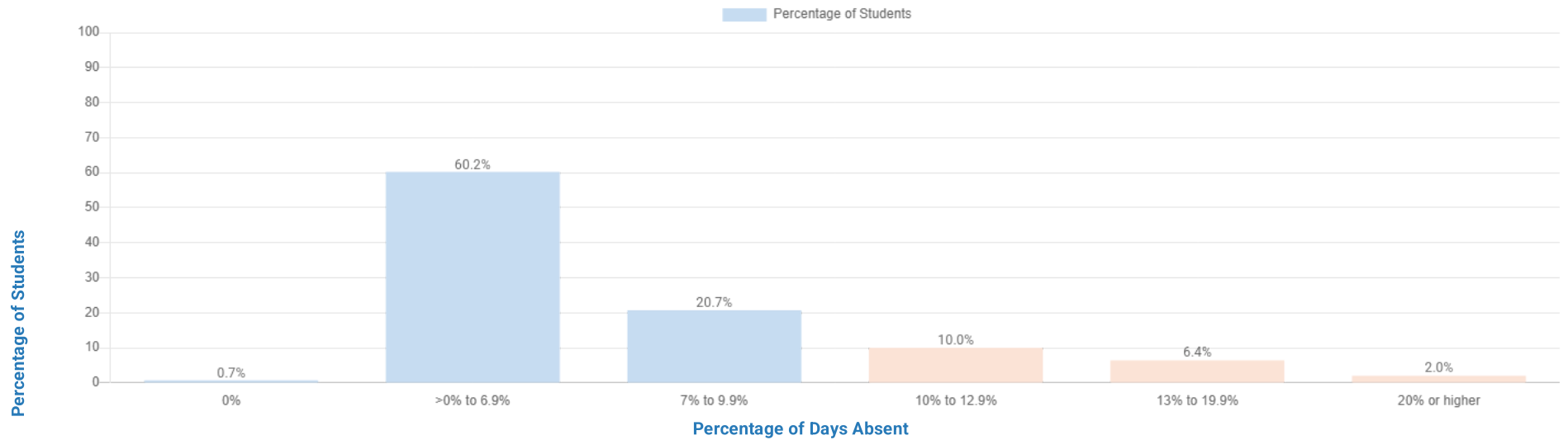

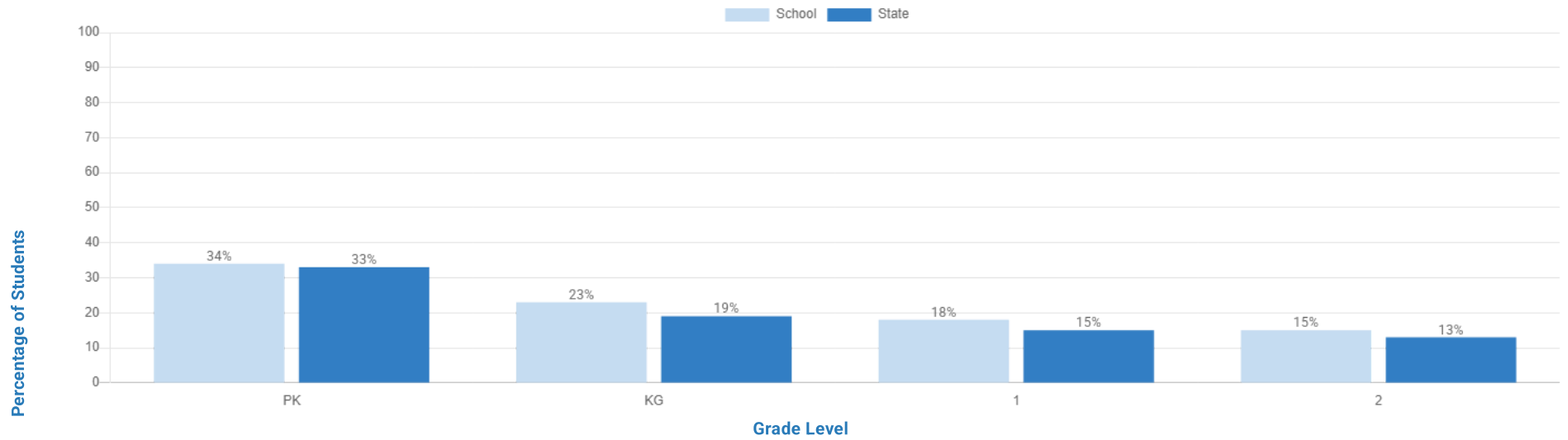

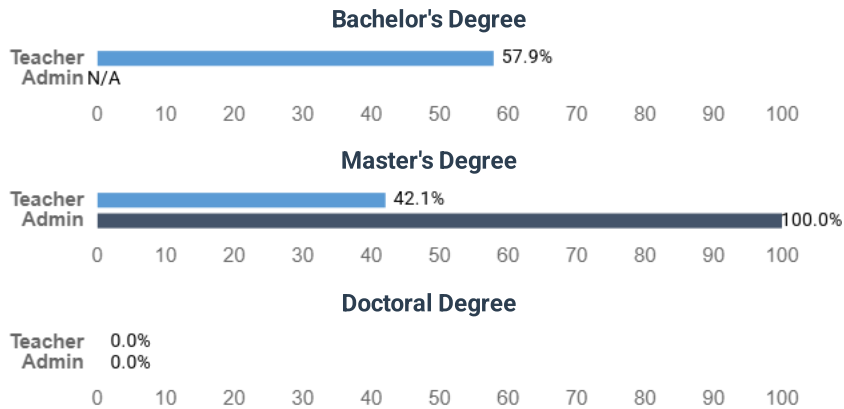

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

Courses, Curriculum, Instruction:

Administration and staff utilize various tools to network with all members of the school community. The communication methods and digital resources are the foundation of our success. This communication ensures an established partnership between home and school. Staff also connects with families through a daily learning plan which strengthens the home and school partnership to grow student success. Adelphia School continuously strives to educate families on schoolwide goals and efforts. The administration and staff implement multiple platforms to increase opportunity for community engagement and communication. A few areas to highlight include using Seesaw as a tool to reach all learners, posting daily happenings to the school Edlio website and Twitter. We also send information through School Messenger and PowerSchool. Additionally, parent evenings and workshops are made available to families to further educate and support families.



Before and After School Programs:

Before and after care is provided through a third-party vendor in most buildings, based on enrollment. Children in buildings without sufficient interest are shuttled to or from these buildings so that all students have eligibility. Before care begins at 6:30 AM, and after care runs until 6:00 PM.



Staff and Professional Learning:

Professional development for staff is on-going. There is evidence of teacher leadership opportunities, in-service opportunities, school based professional development, and weekly professional learning communities. Multiple opportunities are afforded to staff to best support teachers on their professional journey. Teacher learning experiences further support optimal learning environments to improve overall student achievement. The School Improvement Panel fosters collective efficacy amongst all stakeholders at Adelphia School. Collaboration creates opportunity to afford growth and new knowledge to both novice and veteran staff. By being current in our practices and aware of staff needs we can best plan for meaningful professional development in alignment with staff and student needs. Administration continually seeks input and reviews building observation summary data to plan in accordance with professional development to increase learning outcomes for all children.

Student Supports and Services:

A multitiered system of support is implemented to support instructional practices aligned with student need. The on-going progress monitoring of student performance through both formative and summative assessment supports student goal setting and interventions. The tracking of student progress within learning progressions yields feedback which is then aligned with instructional content. A collaborative team works in partnership to create goal setting for both remediation and acceleration of learning content. To support student social and emotional wellness, monthly classroom focuses are planned. All planning supports are based on focus habits as well as social and emotional anchor competencies. Progress is monitored through student surveys and our school-wide character education program: P.A.W.S Positive Actions Will Shine.



Student Health and Wellness:

Student health is instructed and guided by comprehensive health and physical education standards. All students engage in twenty minutes of recess time as well as daily health walks. The school counselor, school nurse, and school resource officer support peer groups, social skills groups, as well as classroom lessons. The support for students throughout the year is inclusive of important topics relating to safety, respect, kindness, and peer relationships. The Parent Teacher Association supports various cultural arts programs to support the growth and development of children. Many special evening programs and field trips are also part of the child's school experience. By teaching proactively we instruct our students through social and emotional experiences and empower children to exercise critical life skills to be successful both in and out of the school setting.



Parent and Community Involvement:

Adelphia School prides itself on fostering a school community that grows the academic, social, and emotional wellness of children. All efforts are made to foster and deepen our educational partnerships with all stakeholders. The school focus group and Parent Teacher Association meet with administration to continually involve parents and families in school-wide planning and decision making. Climate Surveys:

School culture and climate surveys are administered two times per school year for staff, parents, and students. A professional development needs assessment in the areas of foundational skills and social emotional learning needs are included in the staff survey to best identify and plan professional development. The results from the survey are reviewed by the SciP Team and action plans are then created based on building needs. All school-wide data is then shared at monthly staff meetings to foster collective efficacy amongst all staff. The staff survey also focused on rapport with administration and colleagues, as well as feeling inclusive in school-based decision making. The survey for parents and students focuses on safety, teacher interactions and administrative interactions, as well as school climate. Results are analyzed to further support the needs of all participants.



Facilities:

Adelphia School opened in 2003 and is a primary school ranging from students in preschool through second grade. Our school has an established literacy lab with resources designed to captivate and engage students in literacy based learning experiences. A 1:1 iPad ratio enhances and enriches learning experiences in support of digital learning communities. The technology lab affords another opportunity for students to engage in digital learning experiences.



School Safety:

The Howell district prides itself in the attention paid to physical and emotional safety. We maintain a high level of partnership with the local police departments, have a robust SLEO III program with SLEO IIIs assigned to all buildings, as well as district School Resource Officers.

Technology and STEM:

Learner led experiences support students in developing resiliency when faced with problem solving, thinking, and self-advocating within individual learning progressions. The needs of all learners are supported through a multitiered level of support inclusive of STEM activities, problem based learning, and various digital platforms. Daily learning plans are communicated with families, lesson planning is posted via OnCourse, and feedback is provided in Seesaw. Additionally, students are provided with opportunities both digitally and traditionally to apply interest, knowledge, and thinking skills based on self-selected areas of study. Lessons and activities are inclusive of digital programs such as Epic, Reflex Math, coding, and Scholastic Lit Pro.



Early Childhood Education:

Adelphia School has 4 preschool inclusion classes. The program is grant funded by the state and has a total population of 15 students per class. This program is full day and provides the students an opportunity to explore and engage in purposeful, meaningful learning through play plans.



Attendance:

To support school attendance parents are educated and informed of the need to make school attendance a priority. We take pride in establishing a school community that encourages and includes parent partnership. There is on-going communication with families when students are chronically absent from school. Phone calls are made home to check on student wellness and parents are encouraged to contact the school when a child is absent. Additionally when appropriate the school nurse seeks medical documentation. Administration works proactively to educate families by sending home newsletters and information regarding the importance of attending school regularly. Administration looks to identify trends in student absenteeism and then takes the opportunity to further communicate with specific families. To ensure common understanding and documentation attendance letters are sent home when a student misses a total of 10 days from school.
