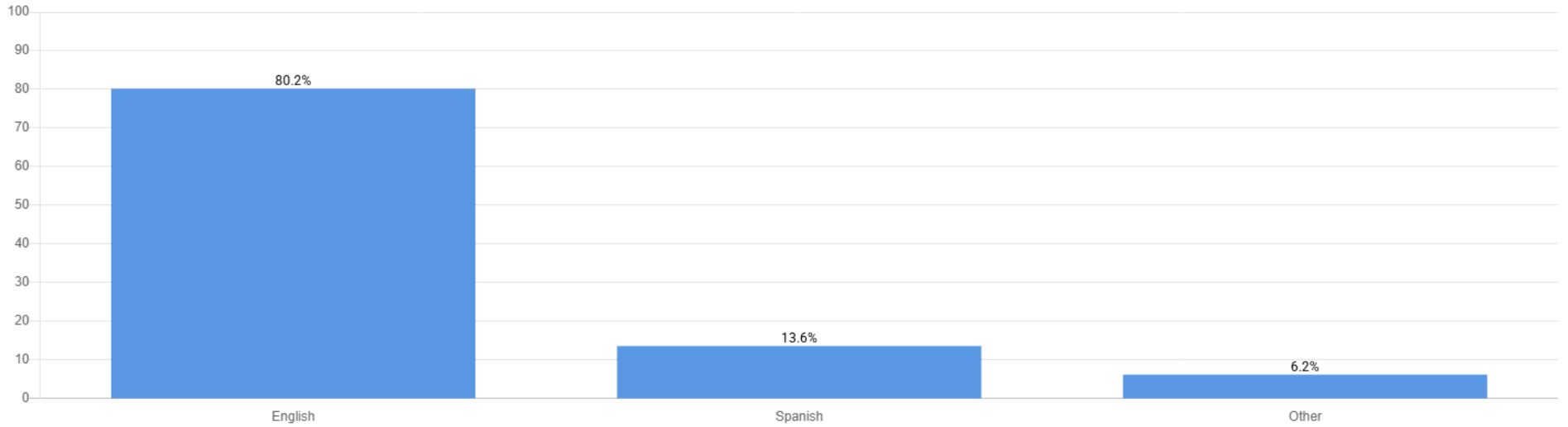

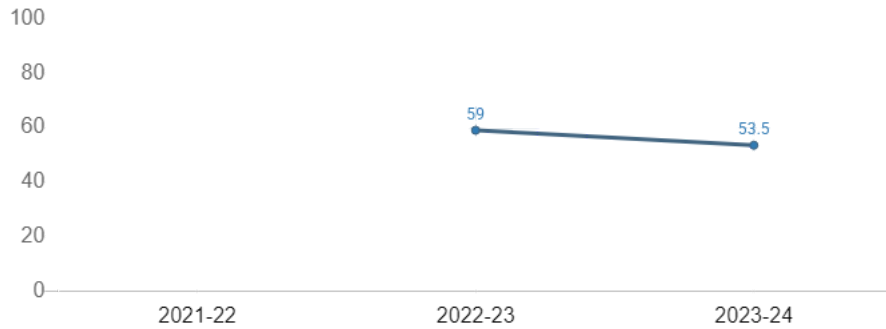

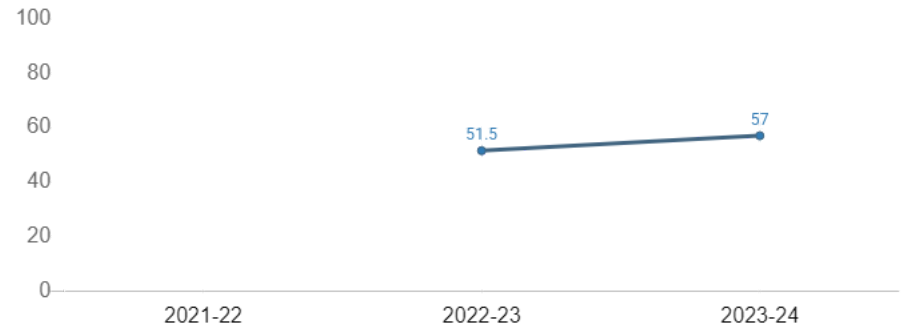

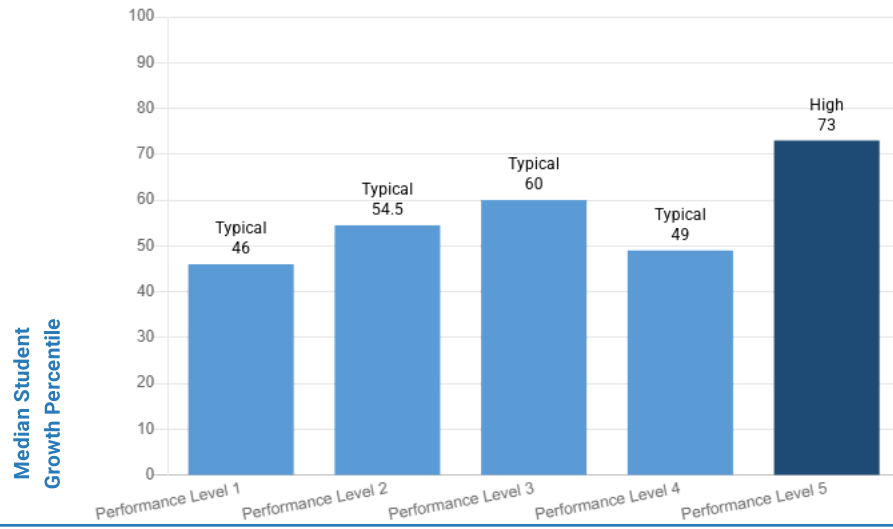

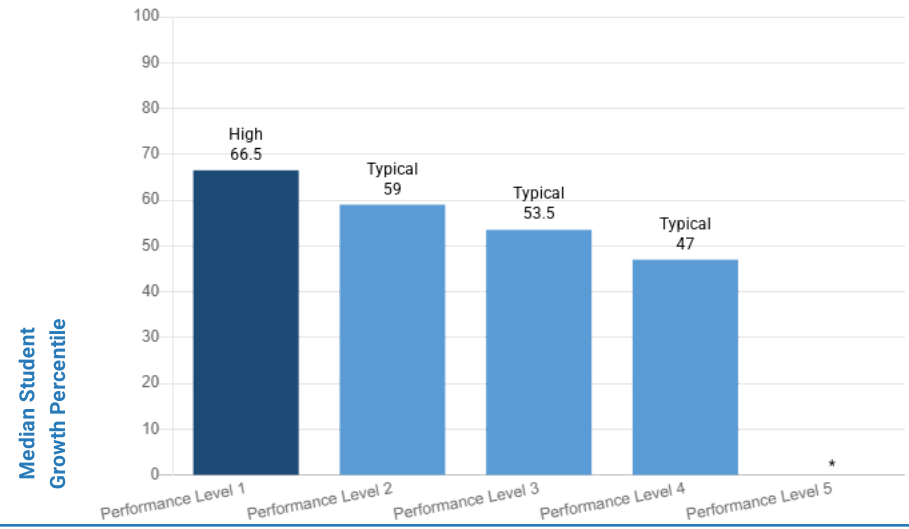

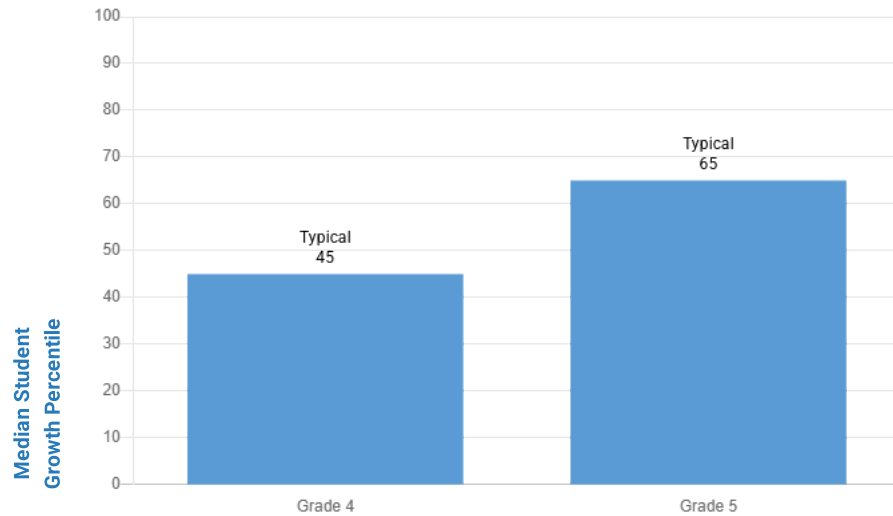

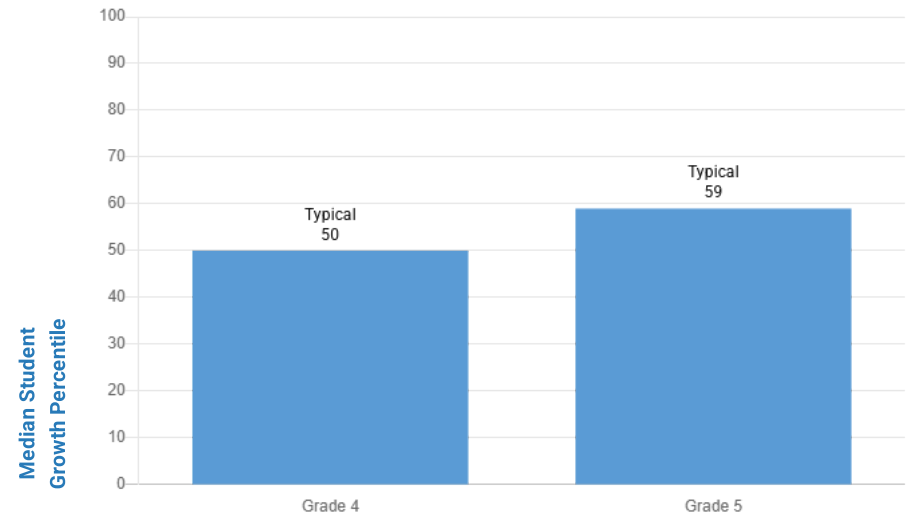

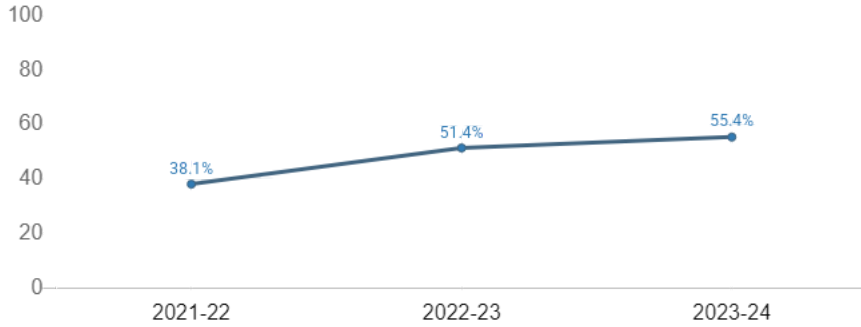

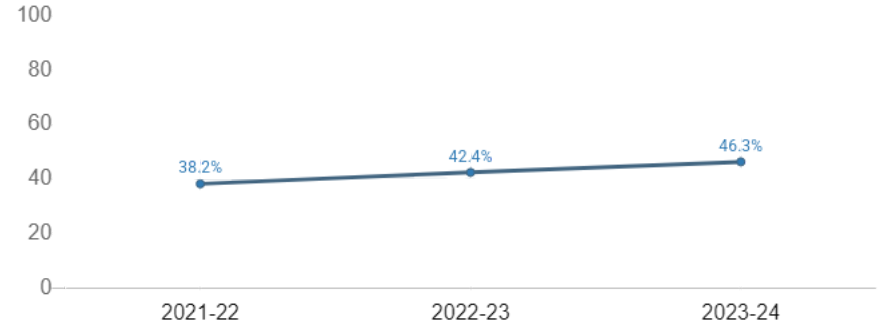
### English Language Arts and Mathematics Performance Trends

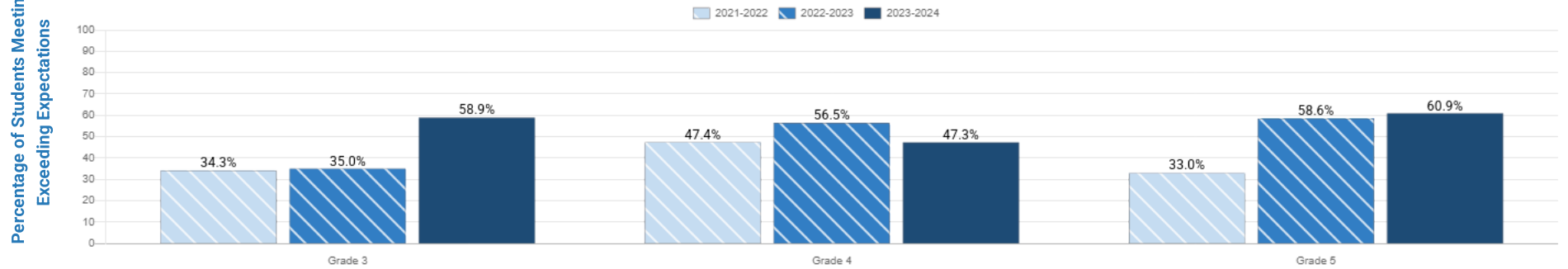

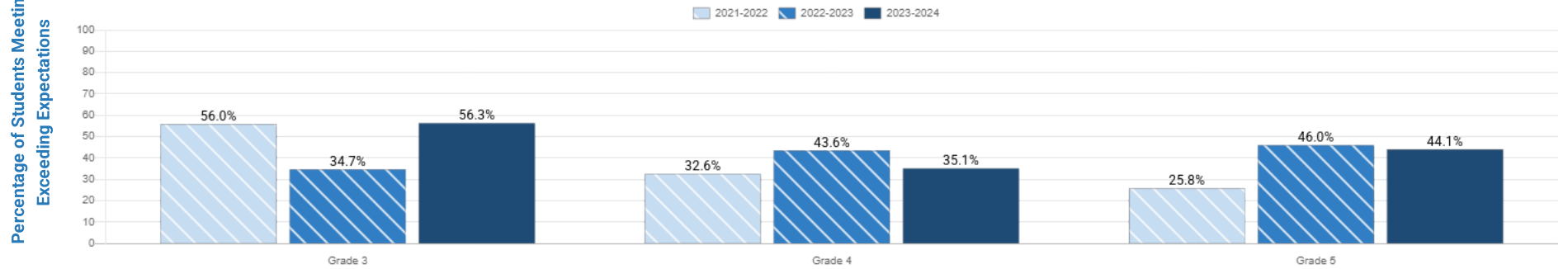

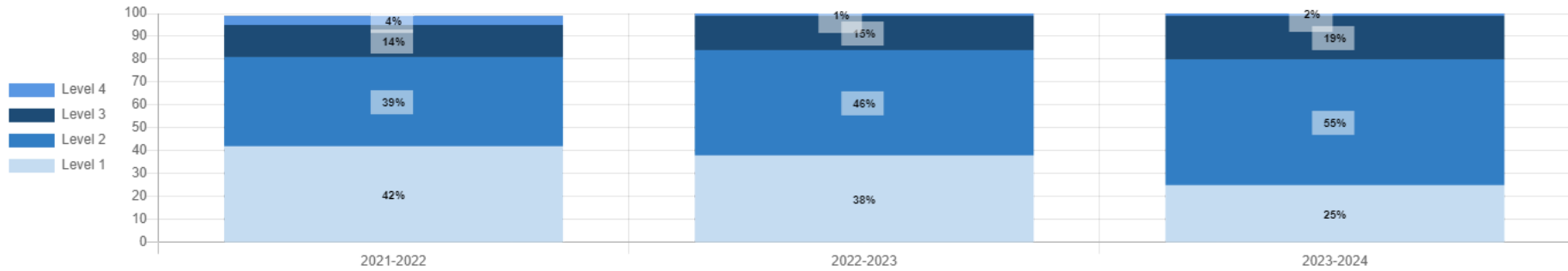

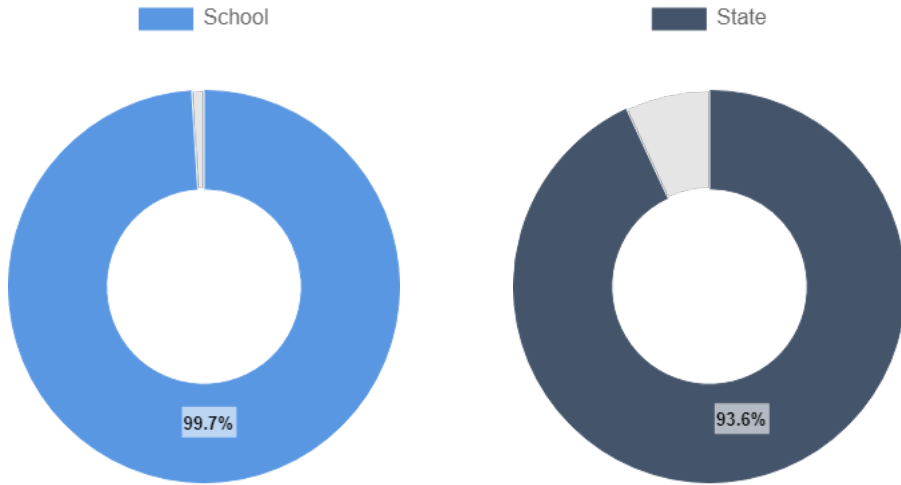

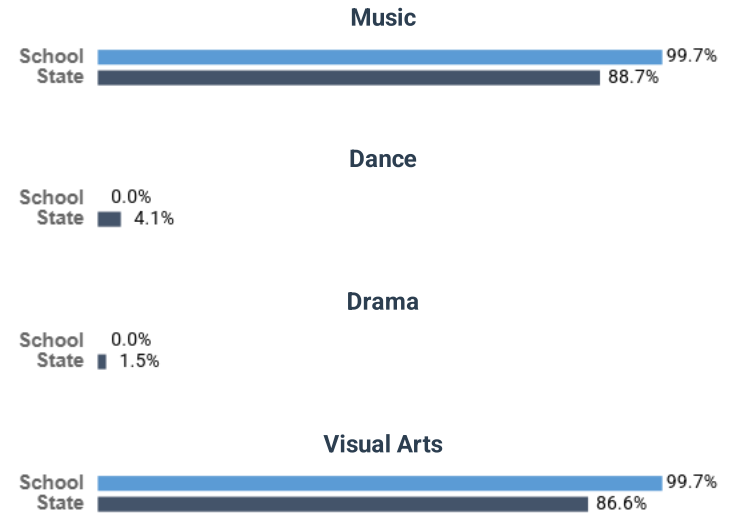

**Students enrolled in one or more classes by discipline:**



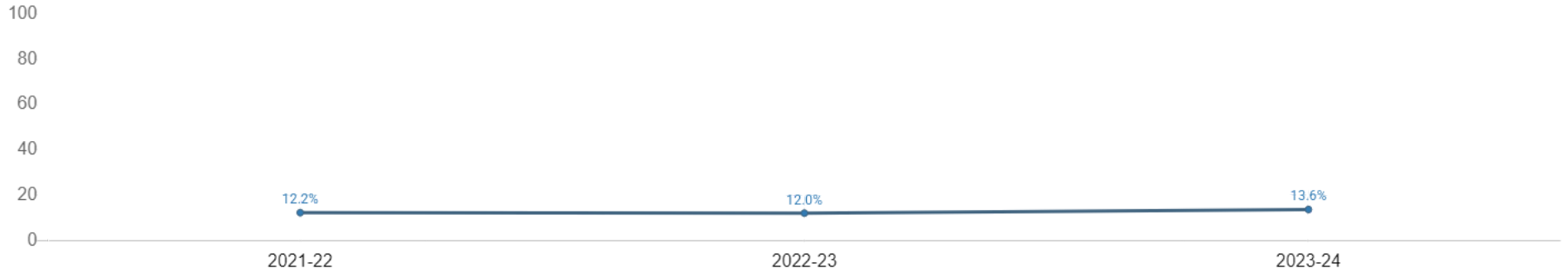

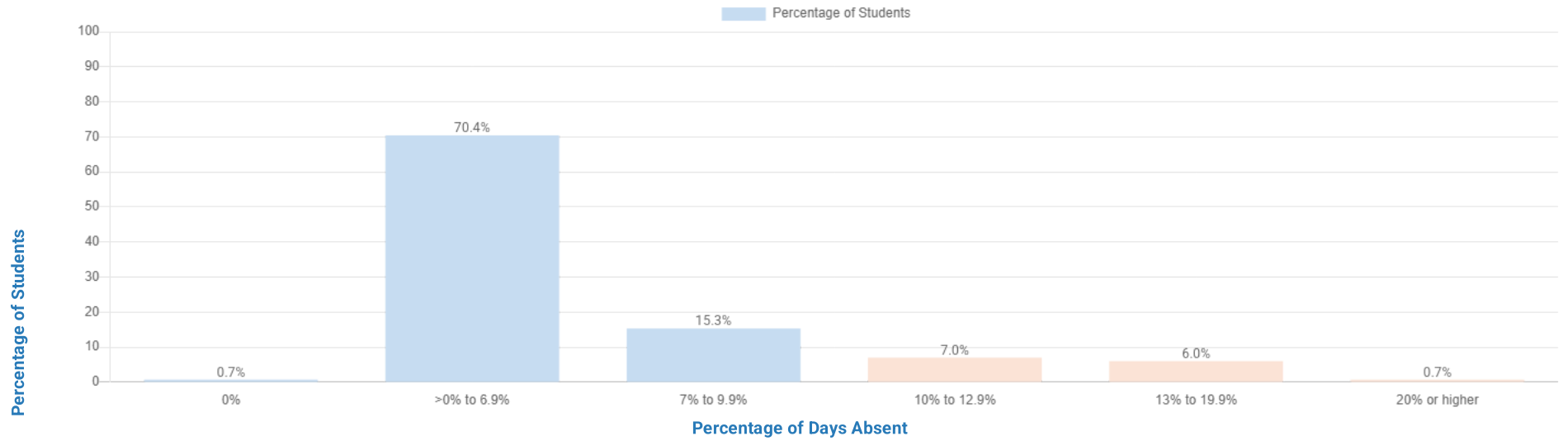

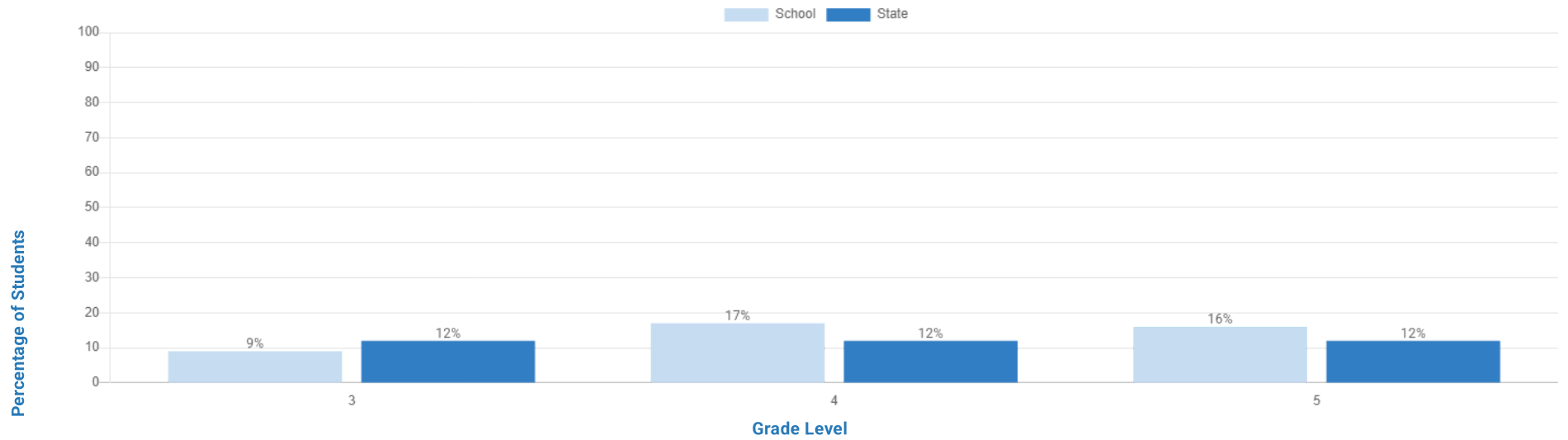

## Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

**Key terms for staff data:**

**Teachers:** All classroom teachers

**Administrators:** Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

### Teachers – Experience

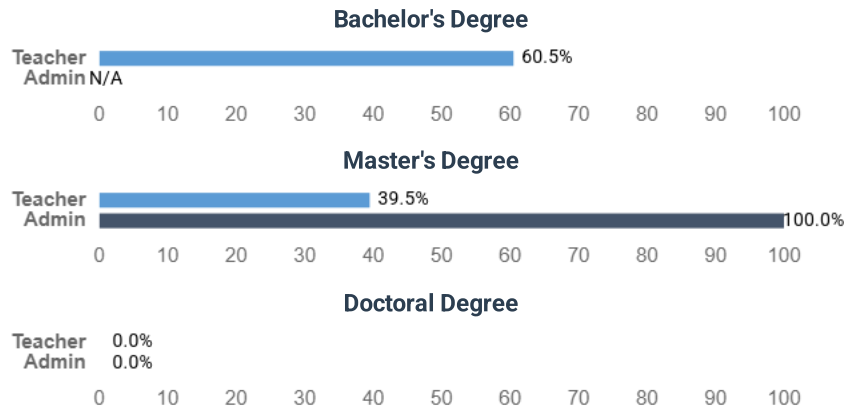

Curricular focus in the core areas of language arts and mathematics provide children with opportunities to develop skills in reading, writing, speaking, listening, viewing, understanding, and applying mathematical concepts and problem solving. On-going evaluation of our children's progress informs and guides instruction for each child. Coupled with our strong focus on standards, the results of national, state, and local assessments are analyzed to help guide instructional improvement. ### Clubs and Activities:

We value giving students voice and choice with their learning opportunities and therefore varied courses are developed to achieve this goal. We offer Student Council and Newspaper club for our 5th grade students. Student Council members engage in a variety of community service projects. The Newspaper Club writes and publishes the school newspaper three times per year. This provides the opportunity to write, proofread, interview various members of the school community, and perform the functions associated with a newspaper.

### Before and After School Programs:

Before and after care is provided through a third-party vendor in most buildings, based on enrollment. Children in buildings without sufficient interest are shuttled to or from these buildings so that all students have eligibility. Before care begins at 6:30 AM, and after care runs until 6:00 PM.



### Staff and Professional Learning:

The Ardena School Improvement Panel (ScIP) oversees, develops and delivers professional learning experiences for the staff, based on the building and district professional learning plan goals. Professional learning occurs throughout the school year during faculty meetings, in-service days, grade level meetings, and grade level and department PLCs. Professional learning experiences such as coaching, mentoring, coach modeling, and peer observations are also incorporated. Professional learning goals and activities are derived based on school data, staff surveys, and information coming through the PLC /ScIP communication channel. A member of the School Improvement Panel attends and participates in the district Learning Design Team to provide a connection between the school and district professional learning.



### Student Supports and Services:

Through RTI, we use a tiered approach to meet the needs of all of our students. Our Academic Support, ESL, and Special Education programs meet the unique needs of our students. The High Intensity Tutoring grant allowed us to provide tutoring services to select students after school hours. Our School Counselor and Child Study Team provide support to students with IEPs and 504 plans. Students can be selected to participate in Enrichment Cluster Groups (ECG) and are placed in homerooms with students in a cluster to collaborate together on a variety of enrichment opportunities throughout the school year.

### Student Health and Wellness:

Breakfast and lunch is available for purchase each day for all of our families and is available for all students who qualify for free and reduced lunch. In addition to our physical education program and recess, students are engaged in a variety of SEL activities. Every homeroom participates in a Morning Meeting which includes the following Responsive Classroom components and addresses students' social and emotional needs: morning message, greeting, sharing, and activity. Students at Ardena School have access to our beautiful campus during recess including a garden; soccer and kickball fields; multiple areas for swings and playground equipment; and a blacktop area for basketball, wall ball, four square, etc. Our physical education classes take place either in our gymnasium or outside.



### Parent and Community Involvement:

The Ardena Parent Teacher Association (PTA) has a very strong presence and partnership in our school community. They work with the school to provide additional activities and opportunities to all of our students. Parents are invited to volunteer in the building throughout the year for activities such as book fair, holiday bazaar, field day, class holiday parties, etc. Volunteer parents and families are currently involved with the maintenance of our natural playscape/outdoor classroom. Students are invited to have a family guest join them on their birthday to eat lunch in the cafeteria. Students may invite a relative or close family friend to celebrate Veterans Day during lunch and recess. Parents use the Parent Portal to access teacher and bus information digitally prior to the start of school each summer. Throughout the school year, the district communicates to parents when state testing, district testing, and report card results are uploaded to the Parent Portal for parent viewing.



### Climate Surveys:

Ardena School conducts surveys of students, staff, and parents, in order to gather input and feedback from all stakeholders. A highlight from our staff survey is that 96% of surveyed staff agreed with the statement, "My colleagues and I build strong relationships with each other and work well together." A highlight from our student survey is that 94% of students feel that their teacher cares about them and 96% of students feel they have friends to talk to at school. A highlight from our parent survey is that 100% of parents agree that "My child's teacher addresses his/her academic needs" and "I am comfortable contacting a staff member and/or administration if I have a concern."

### Facilities:

Our school was built in 1938 and is beautifully maintained by our highly skilled and dedicated custodial staff. Classrooms are climate controlled with air-conditioning and heat. Our school has two stories and includes a gymnasium, cafeteria, art room, media center, and classrooms for world language, music, and technology instruction. We have multiple playground areas and a learning garden available to students outside.



### School Safety:

The Howell district prides itself in the attention paid to physical and emotional safety. We maintain a high level of partnership with the local police departments, have a robust SLEO III program with SLEO IIIs assigned to all buildings, as well as district School Resource Officers.



### Technology and STEM:

Our school is 1:1 with an iPad for each student. We utilize technology throughout all content areas, including special area classes. Both teachers and students have the ability to project their screens in the classroom for use in activities and classroom discussions. The curriculum for both our Technology and Media classes incorporate STEM activities. Teachers leverage our Schoology platform to engage students, including students who are absent and may choose to work or access information from home.
