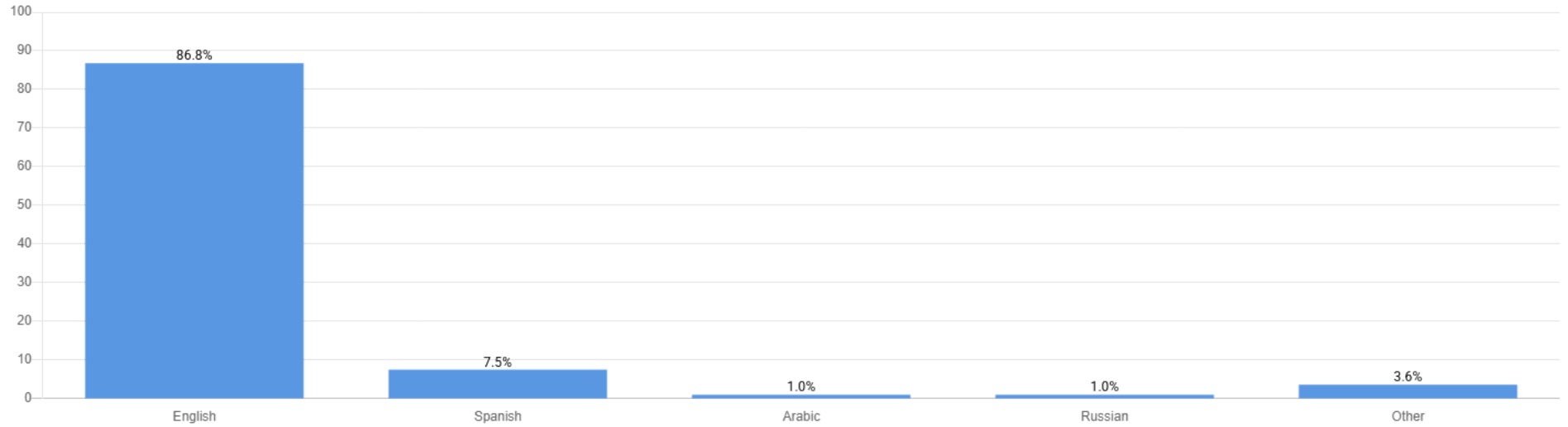

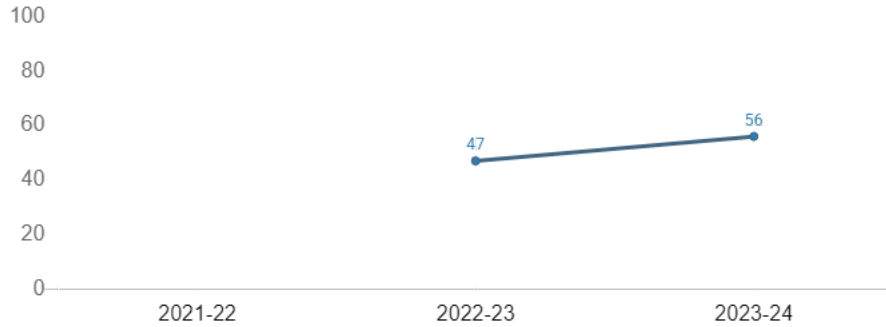

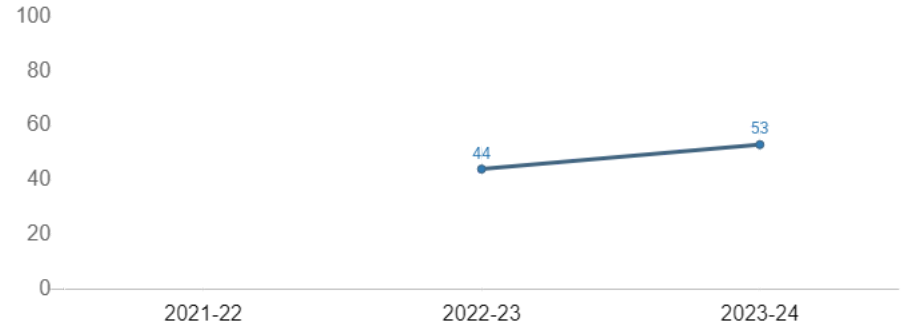

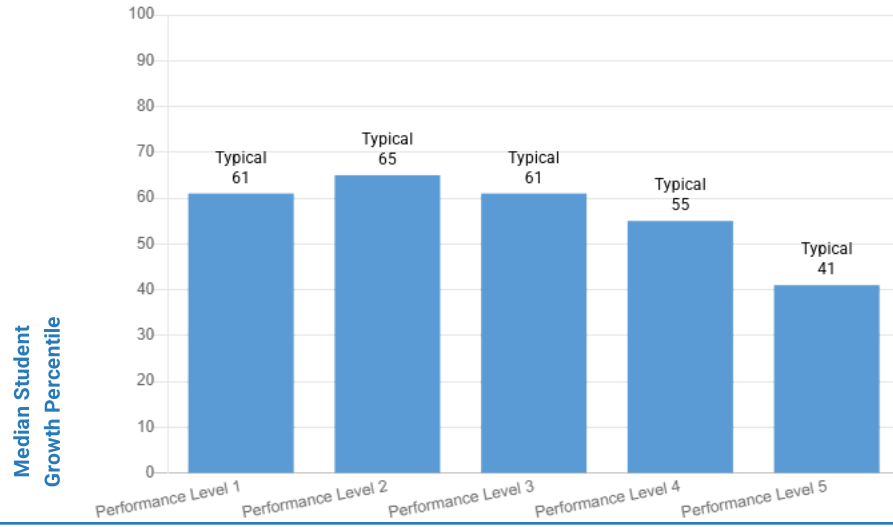

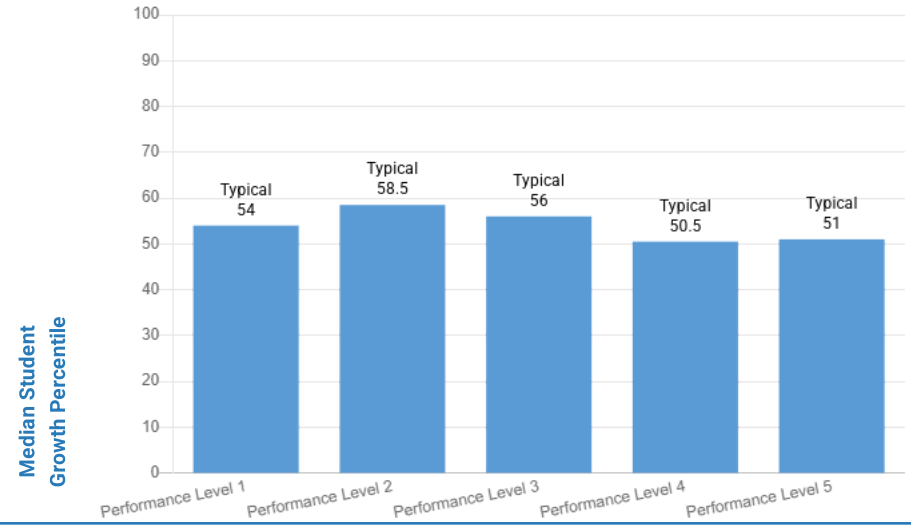

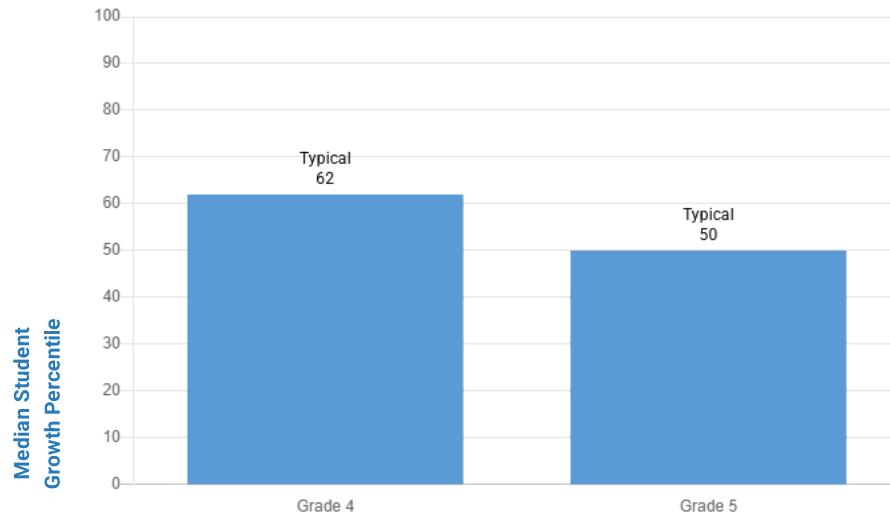

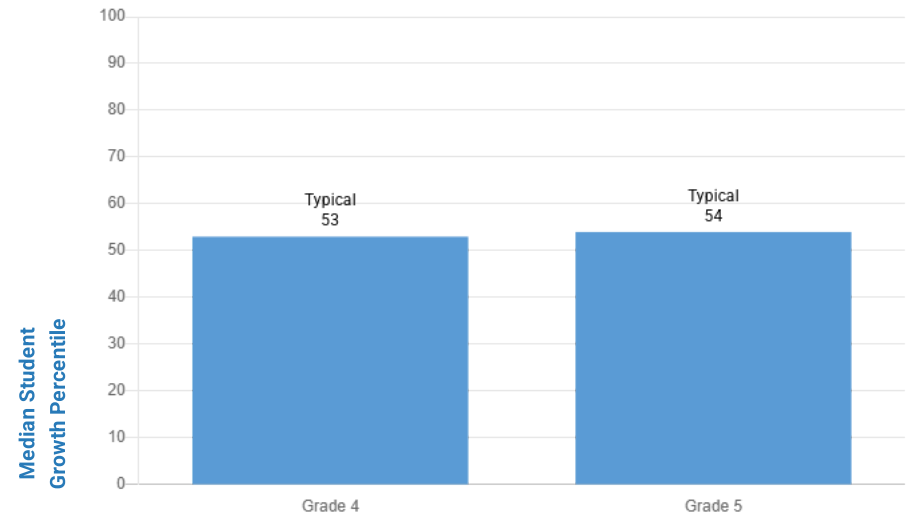

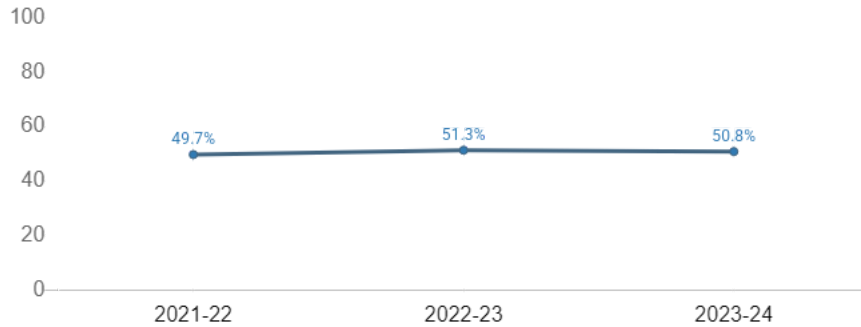

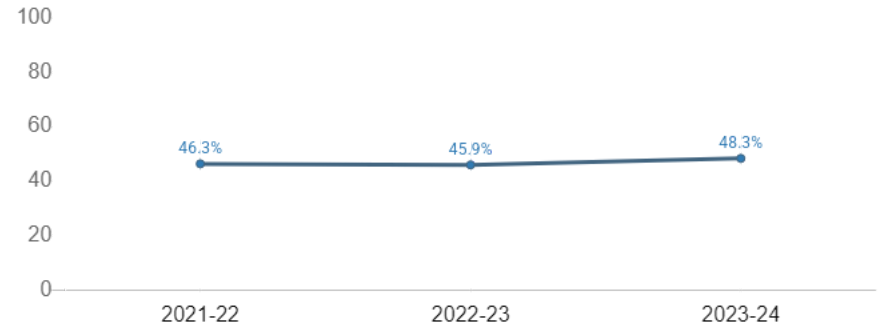
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 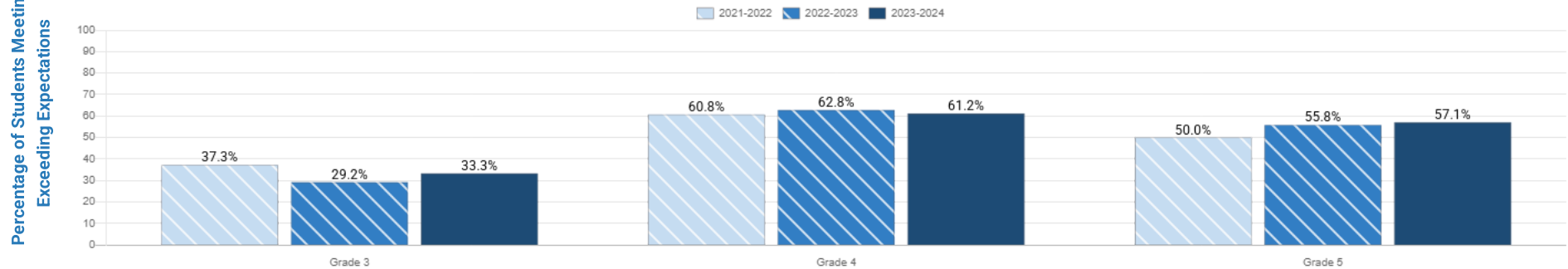

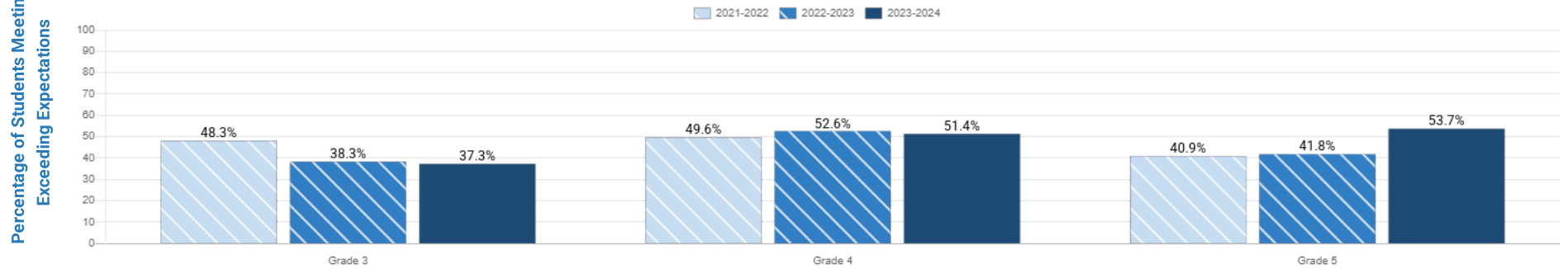

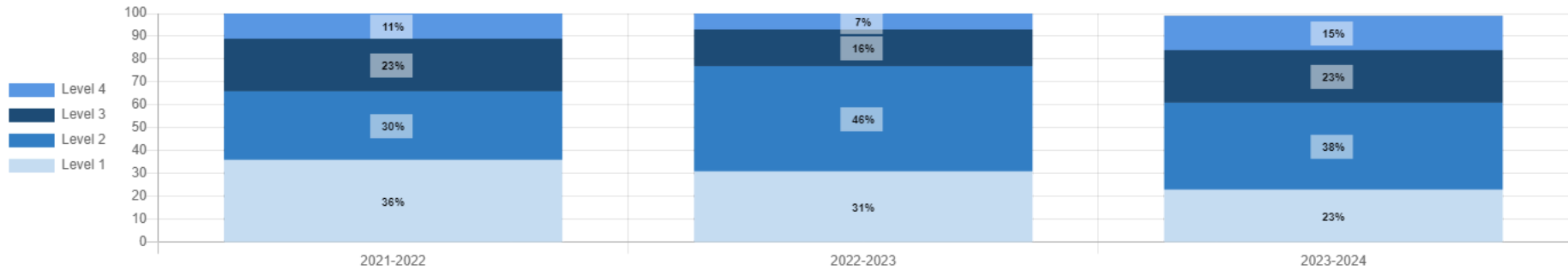

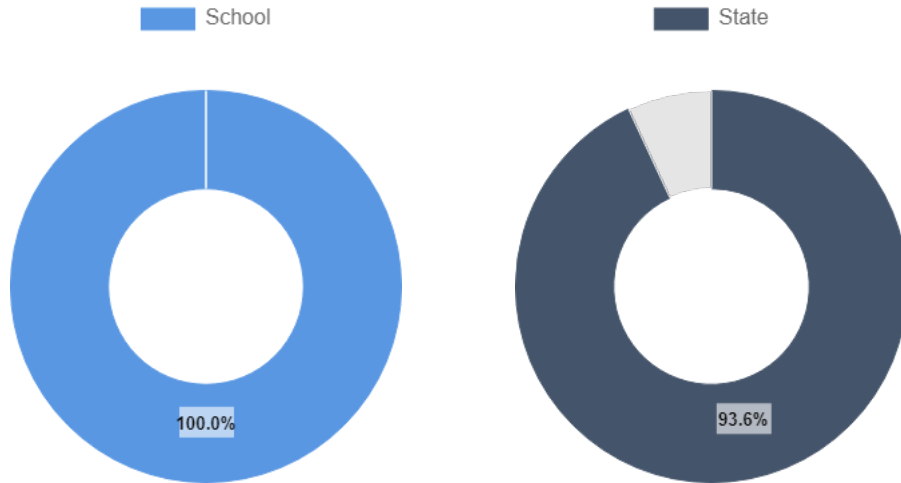

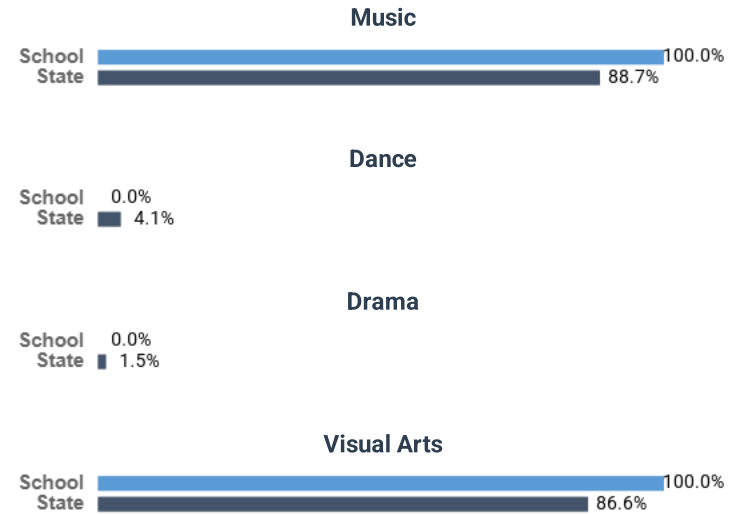

Students enrolled in one or more classes by discipline:



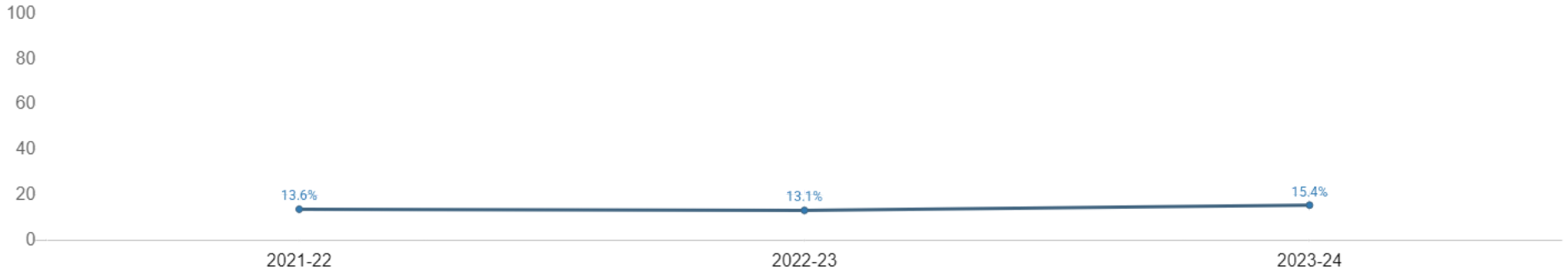

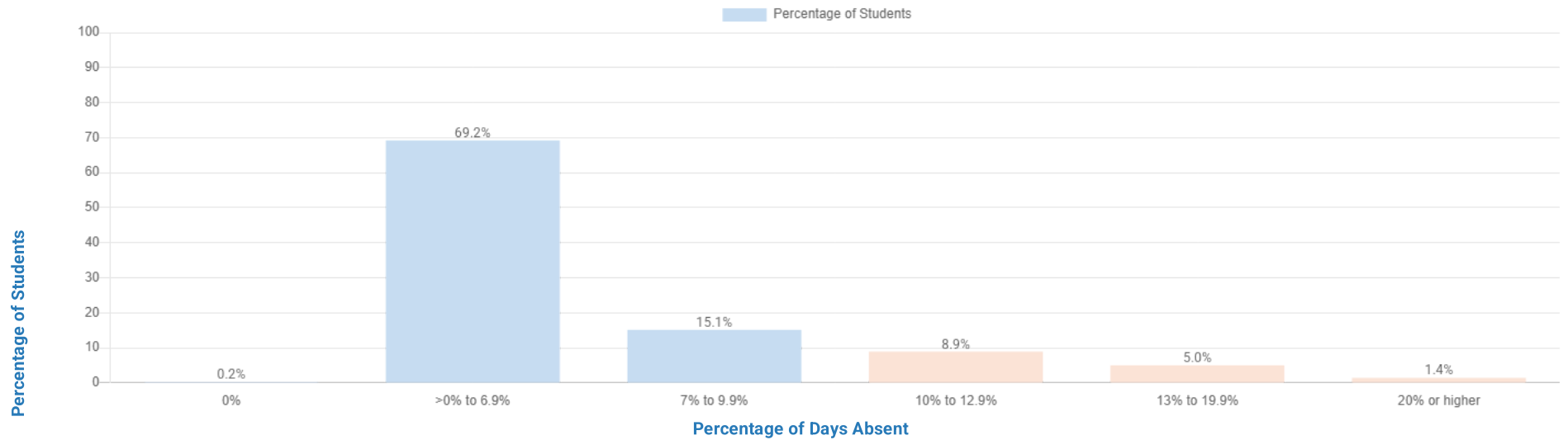

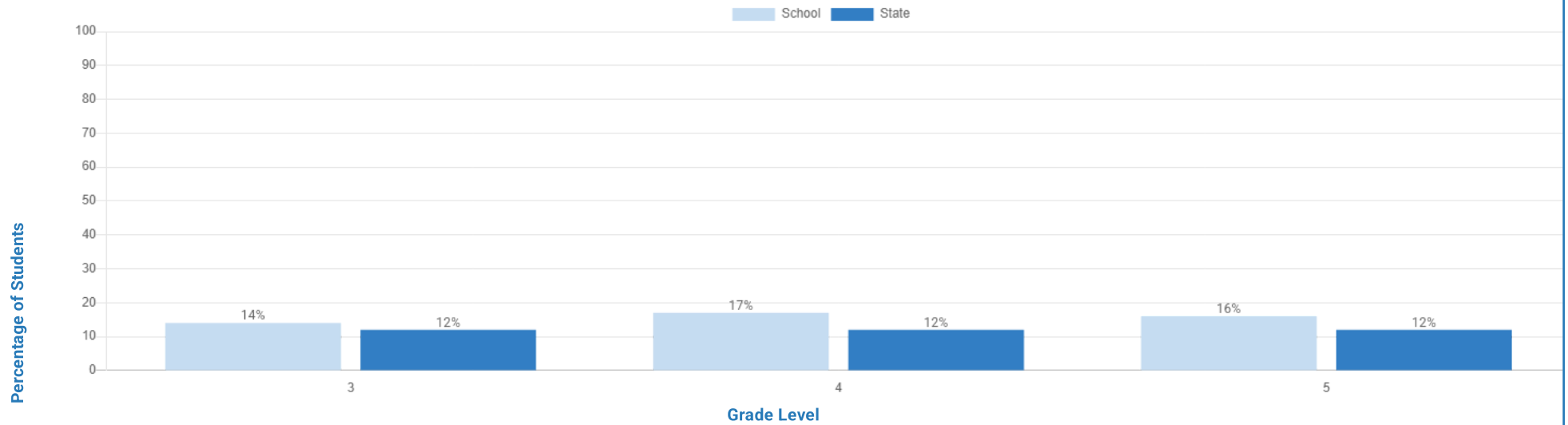

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

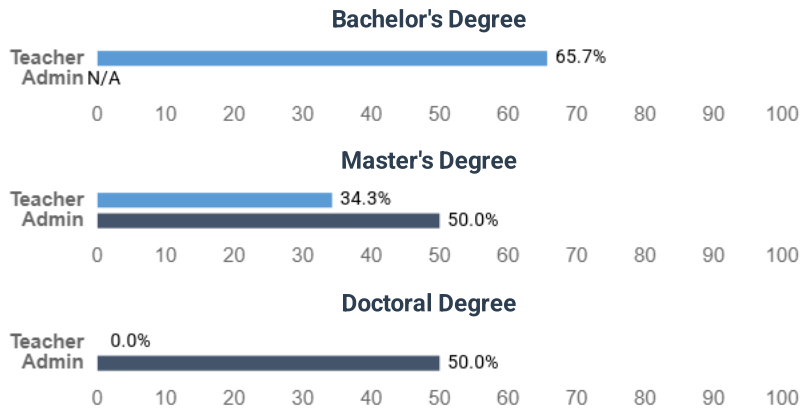

The students are led by a high quality staff that is offered many opportunities for professional development to keep staff current in instructional theories and methods. An emphasis on Personalized Learning takes place in our classrooms as we attempt to meet the needs of each student.

Along with a robust physical education program, our 5th grade students are provided the opportunity to take part on a 5th grade basketball team in intra district competition that is organized and run by our local basketball club. Our students also have the opportunity to take part in Field Day each spring, which is run by our physical education teachers, and there are many opportunities for participation in various sports offered by the recreational leagues within the town.



Clubs and Activities:

We offers a Student Council and Newspaper club at Newbury School. These clubs meet to discuss ways to improve the school and give back to the community. The Newspaper Club offers opportunities for students to publish creative writing pieces such as news articles. The Student Council works to bridge the school with the community. They assist with tours of the building and back to school night, while also providing the students and staff with fund raisers and spirit weeks. Student Council also provides support for Grandparents Day, Veteran's Day.

Before and After School Programs:

Before and after care is provided through a third-party vendor in most buildings, based on enrollment. Children in buildings without sufficient interest are shuttled to or from these buildings so that all students have eligibility. Before care begins at 6:30 AM, and after care runs until 6:00 PM.



Staff and Professional Learning:

The staff is offered professional learning opportunities throughout the school year through job-embedded strategically designed experiences. Professional development is guided by our School Improvement Panel, which meets regularly to review progress and identify the changing needs of our staff and students. Teachers also have the opportunity to attend district offered CEU courses. Additionally, learning opportunities outside the district are supported.



Student Supports and Services:

Support services for students and families take place through our Guidance and Special Education Departments. Support services are often personalized to meet the needs of students and families. Support for students include RTI, ASI, special education, and related services including guidance counseling, occupational therapy, speech therapy, and physical therapy. Newbury School also looks out for the well being of our school community by supporting families in need through the Newbury Food & Clothing Pantry as well as emotional support through the generosity of our community and partnerships with local, county, and state service providers.

A full time nurse is available at Newbury School to meet the medical needs of our student population. A health and wellness curriculum is also taught as part of both science and physical education throughout the school year. Exercise is important, so students receive physical education twice per week and daily recess. This is further supported by the many recreation and sporting activities available within the township. A Wellness Room was created to support staff and student well-being. We also offer a breakfast program to all of our students.

Through the assistance of a very supportive PTA, Newbury School is able to offer our students a wide variety of experiences outside of the classroom by participating in cultural arts events, field trips, fundraisers and other activities throughout the school year. We partner with the community for additional supports, such as NJ BizTown for financial literacy, the local Naval Base for patriotic activities like our Veterans Day assembly, and community organizations for class trips and assemblies.

Facilities:

The facilities at Newbury School are well maintained by our custodial and grounds department. The school has been a community hub for almost 50 years. Newbury School has a soccer field, baseball field, basketball court and playground for students and the community to use both during and after school.
