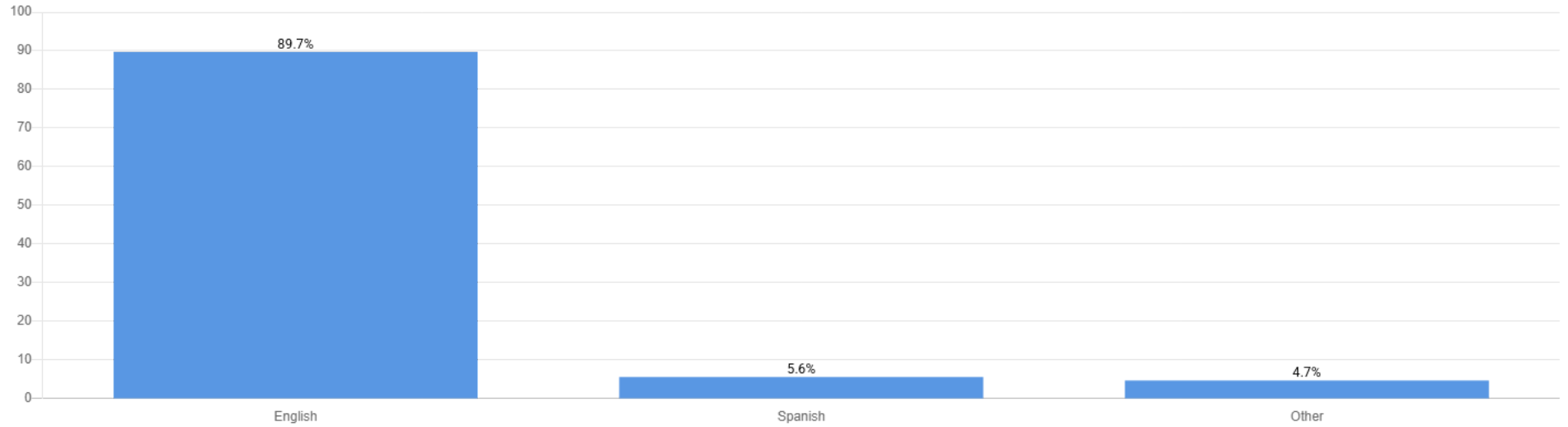

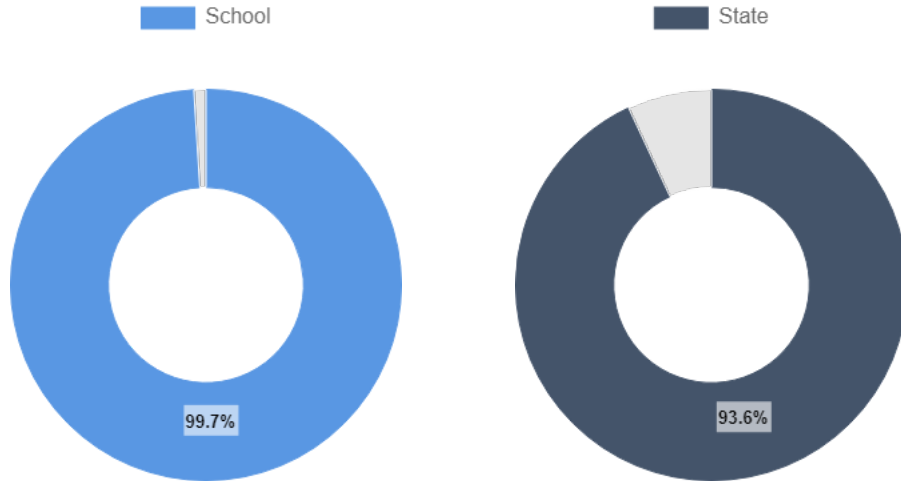

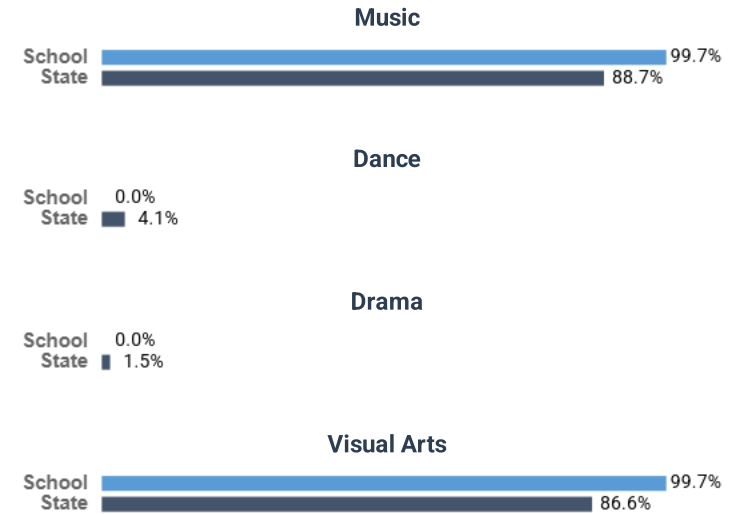

Students enrolled in one or more classes by discipline:



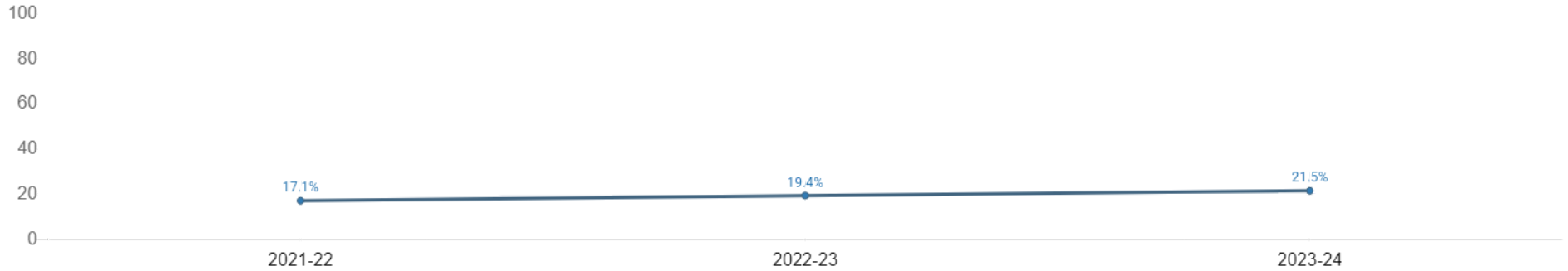

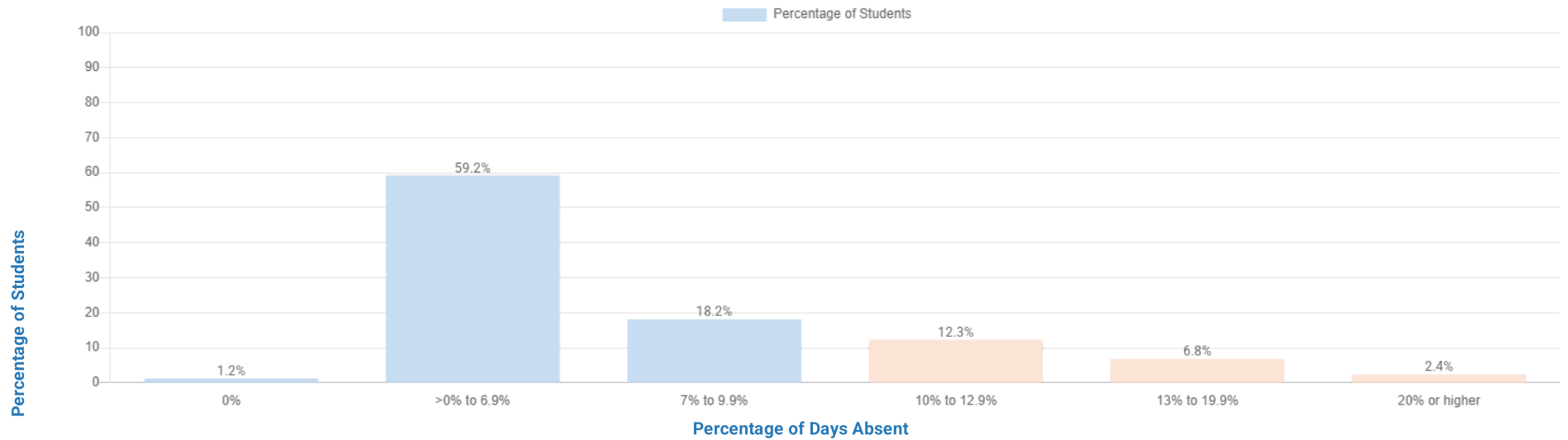

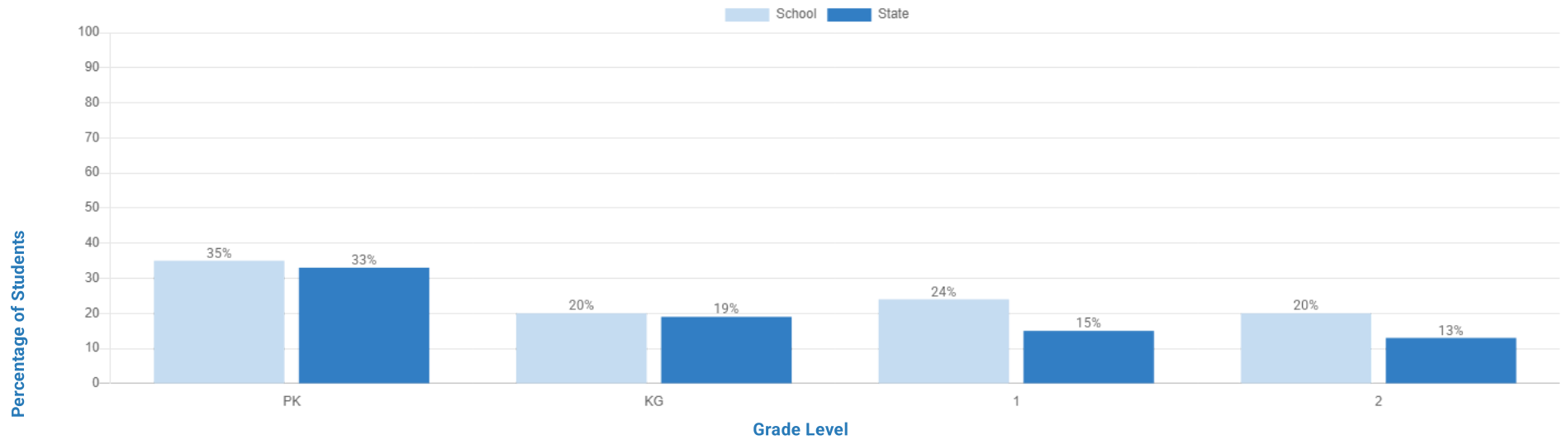

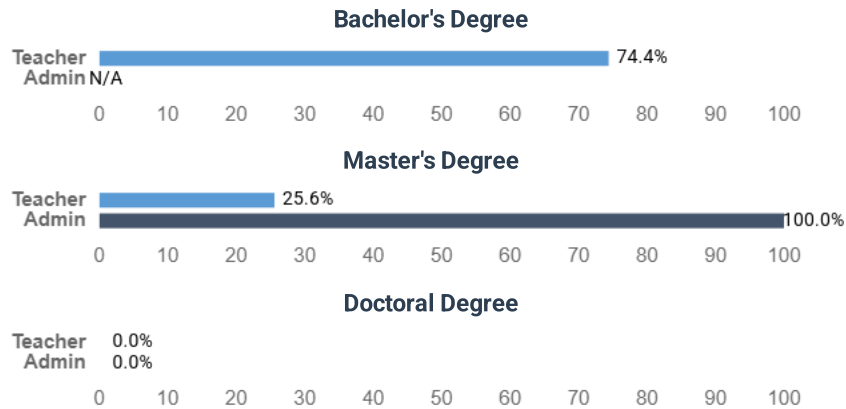

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

The NJDOE identified schools for CSI and ATSI status in fall 2023 based on data from the 2022-2023 school year, so the NJDOE did not identify schools for CSI or ATSI status based on 2023-2024 school year data. The NJDOE only identified schools for TSI status based on data from the 2023-2024 school year.

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

Taunton School creates enrichment opportunities for students on a weekly basis. Eagle Hour is a period in which students participate in enrichment opportunities in the areas of Art, STEM, Music, Technology, Social and Emotional Learning, and Physical Education. Students are provided with the lesson and activity overviews and they "sign-up" for the enrichment opportunity that interests them.



Before and After School Programs:

Before and after care is provided through a third-party vendor in most buildings, based on enrollment. Children in buildings without sufficient interest are shuttled to or from these buildings so that all students have eligibility. Before care begins at 6:30 AM, and after care runs until 6:00 PM.



Staff and Professional Learning:

Howell Township creates a Professional Learning Plan for the district. Taunton School has a building plan that directly aligns with district goals. Throughout the year, there are professional learning opportunities at the district and building level that support district initiatives such as Restorative Practices and Multi-Tiered System of Supports. School staff members participate on the School Improvement Panel, Data Team, and Professional Learning Communities as well as on the district's Learning Design Team. These groups communicate from district to individual school, personalizing the work to meet the needs of the building.

Services at Taunton School include: Resource Room, In-Class Resource, Supplemental Support, Academic Support Instruction, Multi-Tiered System of Supports for Tier 1, 2, or 3 students, Intervention and Referral Services, Individual and/or Group Counseling through Child Study Team or School Counseling Department, Social Skills groups through Child Study Team or School Counseling Department, Speech services for articulation or language, and Occupational Therapy.



Student Health and Wellness:

The district-adopted health curriculum promotes health and wellness. A breakfast program is available on a daily basis. While the School Counseling Department and Child Study Team promote social and emotional health and wellness, our Physical Education teachers and classroom teachers promote physical activity through PE classes and recess on a daily basis. Additionally, classroom teachers incorporate "social and emotional learning time" on a daily basis to practice social skills through role playing with peers. The school's two Sensory Pathways provide much needed "brain breaks" for our young learners while improving gross motor coordination and visual perceptual skills.



Parent and Community Involvement:

Taunton School has a very active and supportive Parent Teacher Association. Parents, staff, and the entire community work with one another throughout the year. The PTA has a website that details upcoming meetings, events, assemblies, fundraisers, and committees. PTA leads many fundraisers for causes such as the American Heart Association and Childhood Cancer. Furthermore, Taunton's PTA provides the students with wonderful learning experiences through school-wide assemblies such as author visits and anti-bullying assemblies. Fun opportunities for the the entire family include: Scholastic Book Fair, Fall Festival, Family Paint Nights, Family Cooking Nights, and much more.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. Through the School Counseling Department a school climate survey is administered to randomly-selected students at the building level. Students answer questions about safety, comfort level with staff, and the overall environment. Staff is surveyed to determine professional development needs. Parents are also surveyed to determine social, emotional, and academic strengths and weaknesses for incoming Kindergartners.
