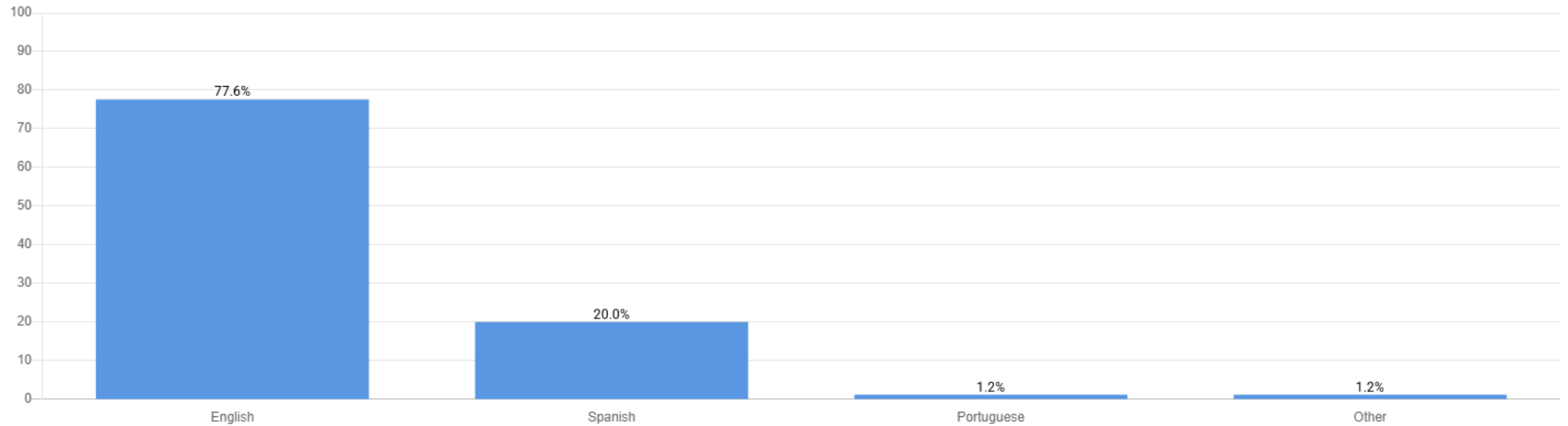

Staff

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 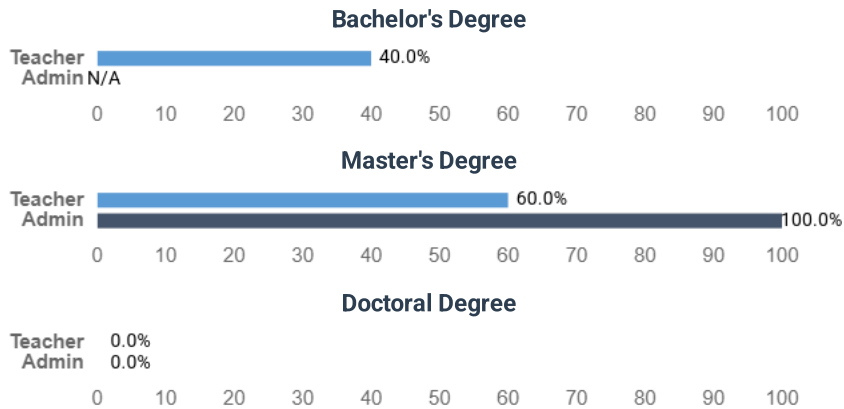

The focus of this learning is to co-create culturally responsive educational leaders and improve the quality of instruction and supports for bilingual acquisition in our school.

Courses, Curriculum, Instruction:

The Keansburg Early Learning Center uses the Tools of the Mind curriculum. This focuses on self-regulation and developmentally appropriate practices that are aligned to the NJ Preschool Teaching Guidelines and neuroscience to support student growth and family engagement.



Before and After School Programs:

Champions Before and Aftercare programs are offered at the Keansburg Early Learning Center. Preschool student can attend Champions from for a flat rate or may qualify for subsidy. Before care hours are 7:00 a.m. until the start of the school day (7:45.) After care hours are 2:00 to 6:00 p.m.



Staff and Professional Learning:

The Keansburg Early Learning Center has an ongoing professional development cohort model. This includes curriculum training from the curriculum developers at Tools of the Mind throughout the school year. We use the Global Compliance Network modules to meet all compliance modules. We partner with community organizations to provide topical trainings based on the needs of faculty. All employees are encouraged to attend local and state-wide professional learning workshops based. Administration and select staff are currently participating in the Building Early Learning Latina Educators to support our increasing latina population in collaboration with the National Institute for Early Education Research.

Student Supports and Services:

The Keansburg Early Learning Center has a tiered system to support all students regardless of native language, developmental disabilities and/or varying levels of performance. We actively participate in the NJ Child Find Initiative to identify and support people with suspected or known disability, including members that are highly mobile or homeless. Our special education department offers varying levels of programming to support children with special needs and their families. This includes a SEPEG and referrals for varying supports for both in and out of the classroom.



Student Health and Wellness:

The Keansburg Early Learning Center has many supports including vision screenings, dental screenings, hearing screenings, vaccination clinics and education. Students have weekly access to a Visiting Nurse Practitioner with parent permission. Breakfast and lunch are offered to all students free of charge through a grant. Select students and families participate in sampling menu items so they have feedback for what is being offered. Accommodations are made for students with special dietary needs. Students have access to two brand new playgrounds and a large indoor gross motor space for at least one hour per day.



Parent and Community Involvement:

There are many opportunities for parents to participate including district wide PTA, SEPEG, Early Childhood Advisory Council, District Parenting Meetings, Board of Education meetings partnerships with established community partners, faculty home visits, classroom events and parties, school level and district level programming, and partnering with Keansburg Borough Recreation Committee events. Parents have access to Genesis Parent Portal, IEP Direct for students with special needs, and Talking Points to use as a bidirectional direct messaging system at the classroom, school and district levels. Our Early Childhood Advisory Council interfaces with over 70 community organizations for referrals. and programming.

Facilities:

The Keansburg Early Learning Center was just built in 2022. The state-of-the-art facility has two large outdoor playgrounds with climbing equipment, covered seating, areas for the arts like pretend play and music. We have a giant indoor gross motor room where students engage in large muscle play daily. We have a Small Group instruction room designed for supervised cooking and life skills activities such as pizza making with local restaurants.



School Safety:

School safety is of the utmost importance. We have one dedicated security guard and one dedicated SLEO security officer. Our new facility has cameras on the exterior and common areas on the interior of the building. Adults must sign in at the main entrance. Adults signing children out must show ID.

Technology and STEM:

The Keansburg Early Learning Center facility is less than three years old. All classrooms are outfitted with an interactive board used for daily routines like the Message of the Day, music and movement activities, gross motor activities, and supporting interest based lessons through use of the Internet. There are one to one devices for all students should virtual learning be needed again.



Early Childhood Education:

The Keansburg Early Learning Center is fully funded by the NJ DOE PEA grant. We offer a full day program from 7:45-2:00. The max student to teacher ratio is one teacher and one paraprofessional for 15 students. We use the Tools of the Mind curriculum. Breakfast and lunch are provided for free through a grant. We offer general education/ inclusion and self-contained settings to support all students.



Attendance:

We offer educational programming on chronic absenteeism through ongoing data collection, partnering with families to offer support, education on what chronic absenteeism means and how it effects student growth. Information is addressed in the Family Handbook, Talking Points, daily communication and offering Parent Support Groups.
