













New Jersey graduates are matched to postsecondary enrollment data by NSC each year. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. In the 2023-2024 academic year, the district offered an after-school program designed to accelerate learning in both Mathematics and English Language Arts, with the primary goal of preparing students for success in the NJGPA and NJSLA. Building on the success of previous efforts, the district continued the Red Raider University (RRU), an innovative learning academy focused on addressing the critical learning gaps that emerged in the post-Pandemic period. RRU provided targeted support to students emphasizing skill recovery in Mathematics and Literacy.



At KPSD, our commitment to professional growth and development is a cornerstone of our approach. We believe that ongoing Professional Learning (PD) is essential for enhancing professional practices and encouraging self-reflection among our staff. We provide our educators with various avenues to engage in professional development that aligns with their Personal Development Plans (PDPs), district goals, strategic plan, and personal growth objectives. Our teachers have the flexibility to seek professional development opportunities both within and outside the district, allowing them to expand their expertise and stay current in their areas of specialization. In addition to self-directed opportunities, we offer in-district sessions conducted by administrators and external consultants to support our educational initiatives. We are proud to foster effective collaboration through department articulation meetings, Professional Learning Communities (PLCs), and Faculty Meetings.



68% of the Keyport High School Class of 2024 applied to and were accepted to a college or university. These students were accepted to 57 different institutions. 10 students in the Class of 2024 graduated with both a high school diploma and an associate degree from Brookdale Community College. The Keyport High School Counseling Department promotes college and career readiness through a proactive counseling curriculum. Student Supports and Services:

ESL services are provided for all ELLs. Additionally, content area teachers are trained and coached in Sheltered English Instruction. Keyport School District is dedicated to ensuring that all students have equitable access to educational opportunities. We proudly offer comprehensive English as a Second Language (ESL) services to support our Multilingual Learners, fostering their language proficiency, academic success, and overall growth in our diverse learning community. In our commitment to excellence, we ensure that all teachers actively participate in ongoing professional development, including the Sheltered Instruction Observation Protocol (SIOP), to enhance their instructional strategies and effectively meet the unique needs of our Multilingual Learners. A monthly Intervention and Referral Services Team meeting is held and supported through regular data collection and review. Students with Disabilities receive services and placement as determined by their needs.



Keyport High School participates in breakfast and lunch programs offered by Maschio's Food Services. KHS has partnered with the Visiting Nurse Association (VNA) to offer medical appointments during school hours for wellness visits, routine vaccinations, and other medical-related issues. Our partnership with the Keyport Ministerium Food Pantry has helped us reach students and families in need of supplemental food items over long weekends and school vacations. Staff are trained in recognizing signs of mental health challenges in students and suicide prevention.



Parent and Community Involvement:

KHS holds regular KSEPAG meetings. The Keyport High School Parent Club acts as the Booster Club and the Bilingual Parent Advisory meets guarterly. The Keyport Educational Foundation, Inc. is a non-profit organization dedicated to quality education for Keyport Public Schools. The Educational Foundation consists of both community and school stakeholders. Parents are able to access academic performance/records via our Genesis Student Database regularly. In addition, all parents are given access to SCOIR so they are able to work with their children on College and Career Readiness tasks at home. The School Counseling Department also hosts a Junior Planning Night with students and parents to help guide them in formulating their postsecondary plans. Our annual "Red Raider Night" is always successful, as it brings the community together to see the social, emotional, athletic, and academic opportunities provided by our district.

The School Climate Team at Keyport High School meets quarterly to review issues about school climate and culture including our Harassment, Intimidation, and Bullying data. We continue to focus on the social and emotional well-being of our students and offer training and professional development to all staff in this area. We are participants in Kean University's Restorative Justice Grant; a 3-year grant which focuses on education and implementation of restorative practices as it applies to our school community, climate, and culture. 2023-24 was year 3 of the grant with a focus on continuing to educate students, staff, and the community about restorative practices. Additionally, a student group was formed to promote restorative practices, give feedback to our school leadership, and mentor and support younger students.



KHS was built in 1927. Additions to the main building took place in the 1950s and 1960s. Additional upgrades took place in recent years. KHS has state-of-the-art Science Labs and e-Gaming lab. The district also recently built a new ADA-approved ramp leading to a secure vestibule entrance. Exterior waterproofing has been completed. Keyport High School has installed new heating and air conditioning systems, secure door hardware, new ceilings, a fire alarm system, a hot water boiler plant, electrical systems, and new light controls.



The Keyport School District has continued its partnership with the Keyport Police Department in employing a school resource officer in Keyport High School. The officer is present within the school daily and performs wellness checks when necessary. All staff members attend the necessary statemandated training for school safety. The Main Entrance doors in both schools have been upgraded and fitted with push locks to ensure the safety of students. At the high school, the vestibule has been upgraded to ensure safety and limit entrance into the building.

Keyport Public Schools utilizes a comprehensive 1:1 Chromebook take-home program for grades 4 to 12. Teachers are also equipped with Chromebooks, desktops, and interactive displays in every classroom to support their instruction. For the lower grades and special education, iPads complement the Chromebook devices, providing a variety of tools to enhance learning. Each classroom features an access point designed to meet students' and teachers' daily technological needs, facilitating a smooth educational experience. The curriculum across grades K-12 emphasizes STEM education, integrating STEAM learning opportunities. This approach engages students through hands-on activities and collaborative projects, fostering critical thinking and creativity in their learning journey.

For the 2023-2024 school year, evidence-based practices have been implemented to improve and maintain regular school attendance at Keyport High School. Strategies include early identification and intervention, where data is used to recognize attendance issues and provide targeted outreach to students and families. KHS is also fostering a positive climate through social-emotional learning (SEL) programs and Mental Health resources, helping students feel supported and engaged. Additionally, regular attendance is encouraged through incentives and recognition, such as awards and school-wide celebrations. These efforts have successfully promoted a culture of regular attendance, contributing to student success.
