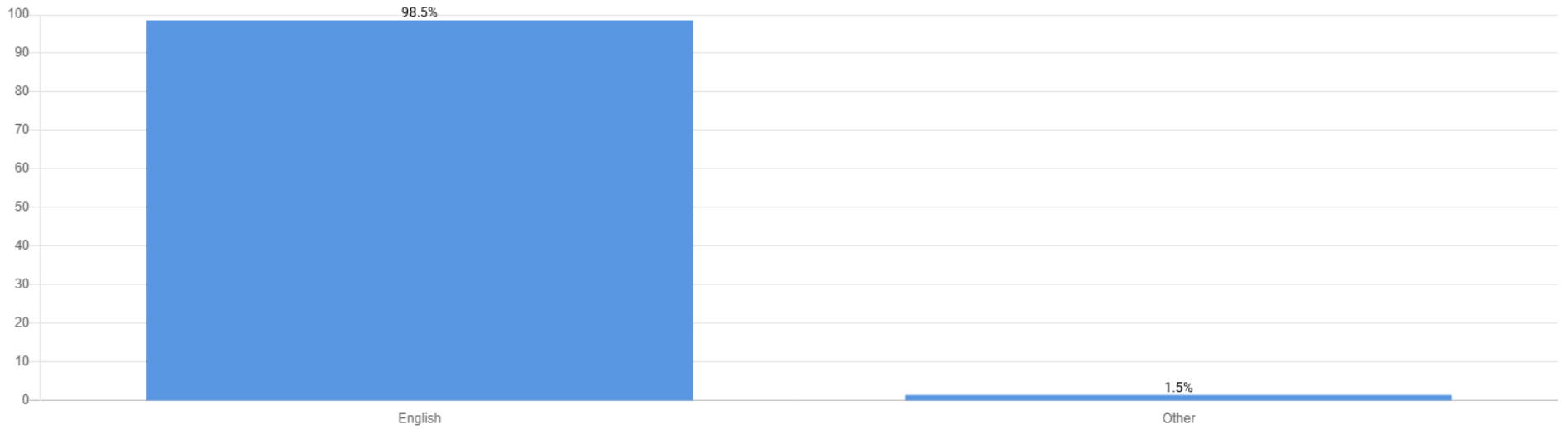

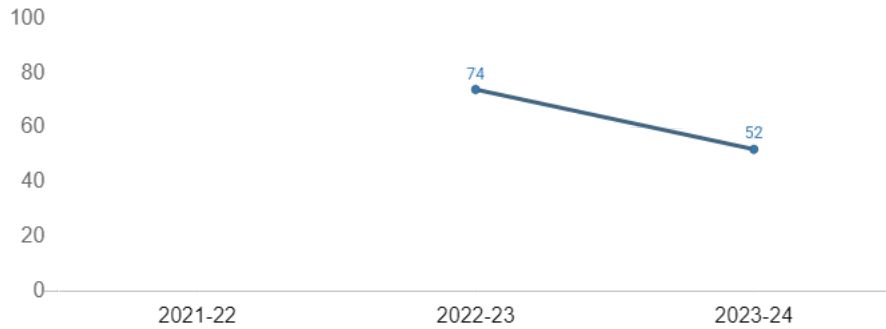

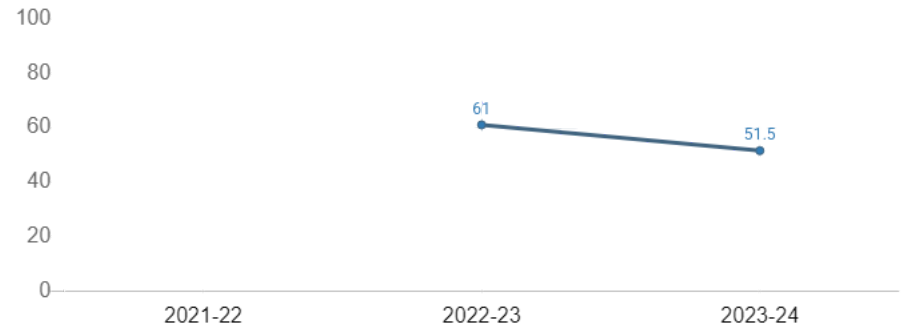

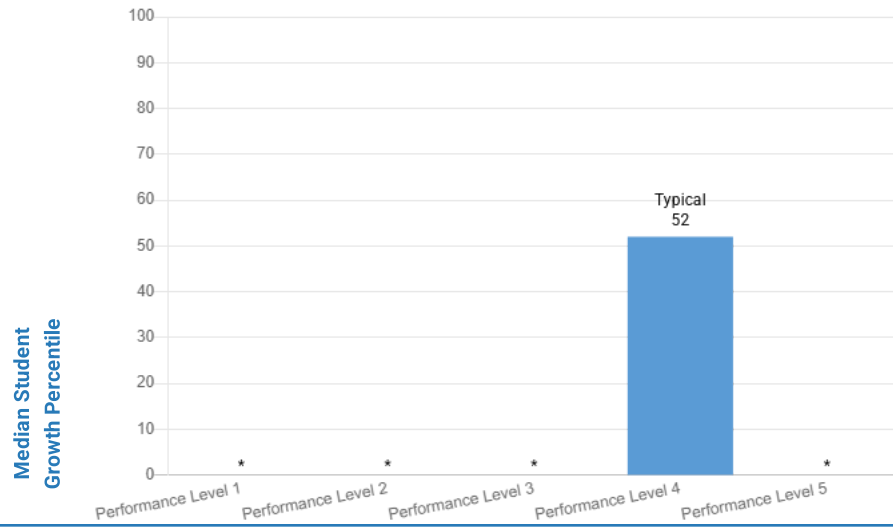

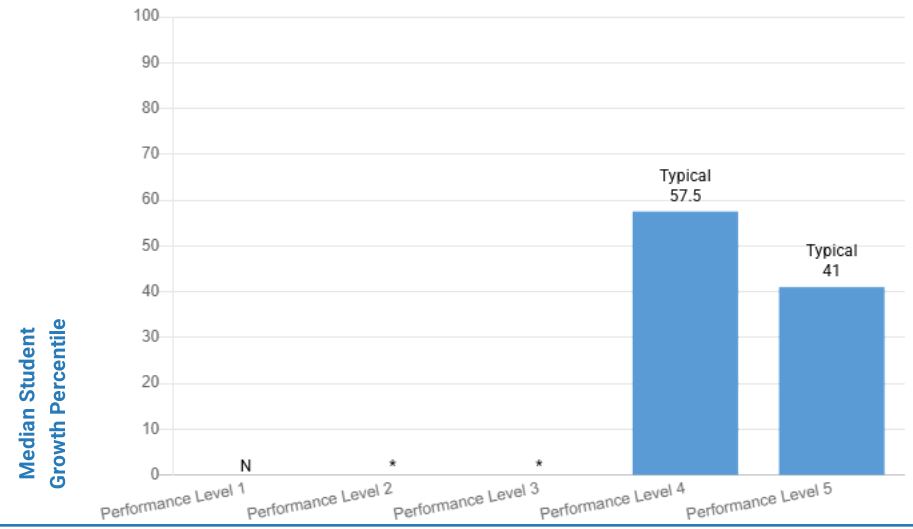

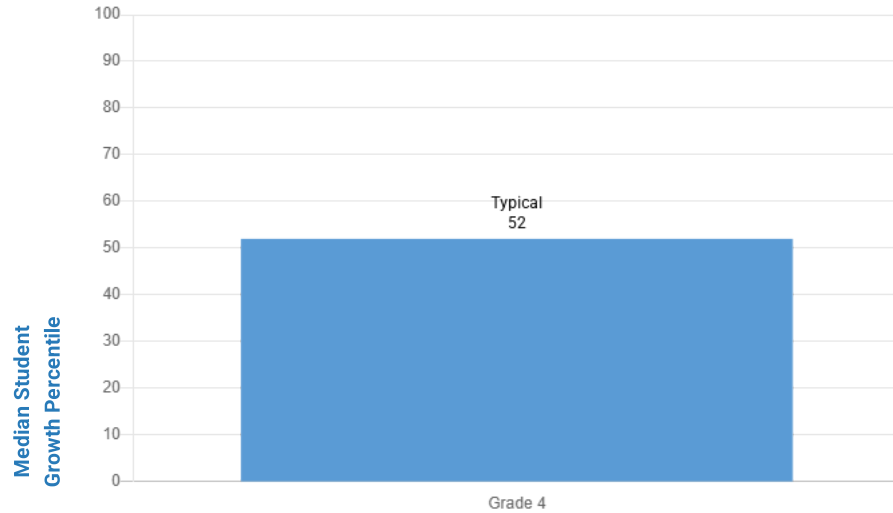

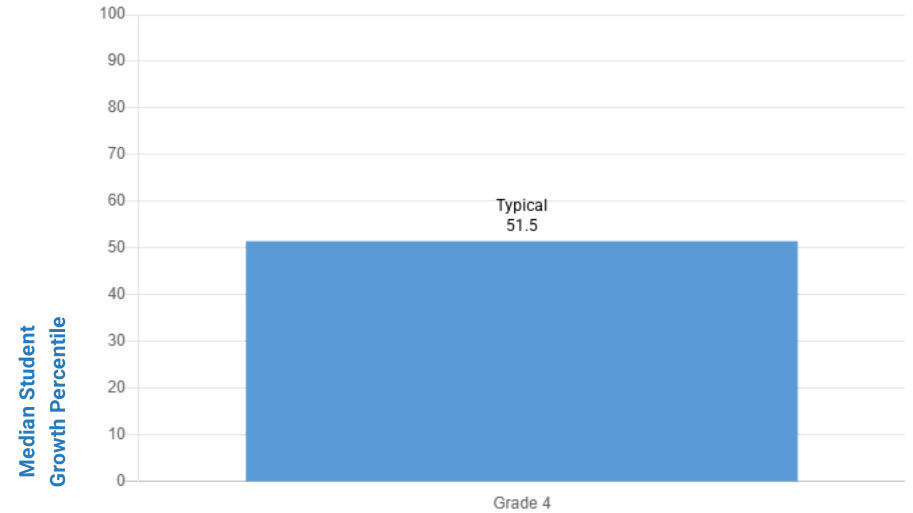

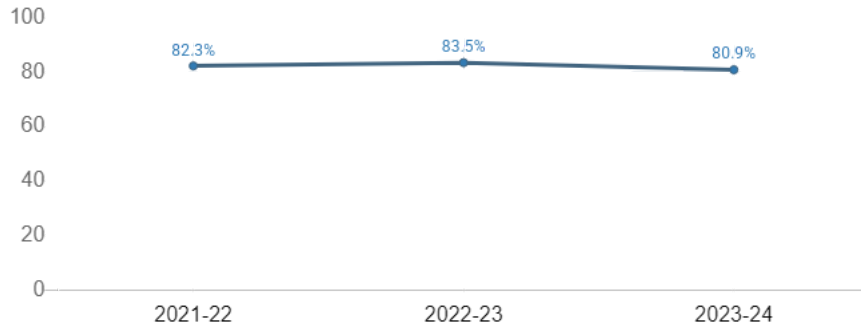

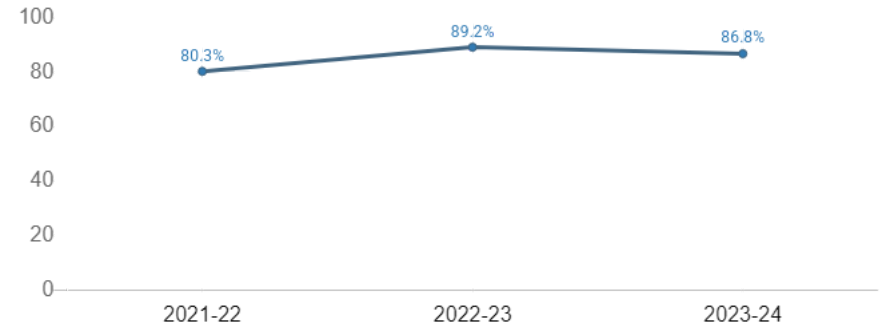
English Language Arts and Mathematics Performance Trends

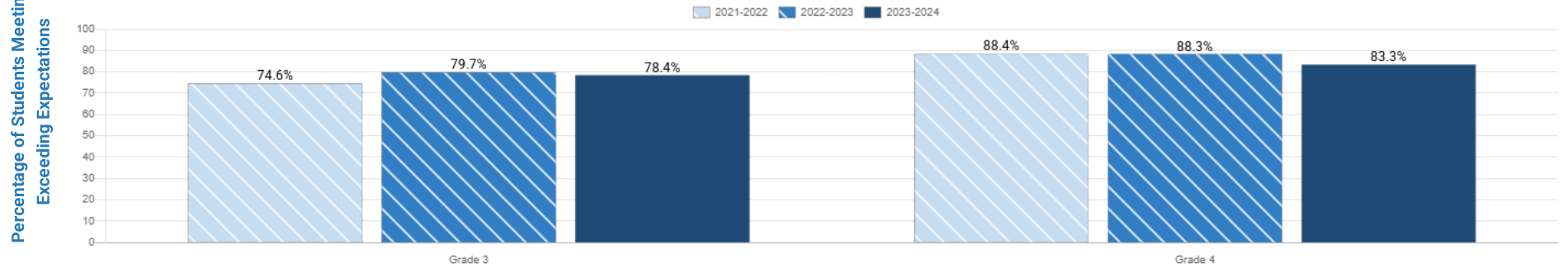

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

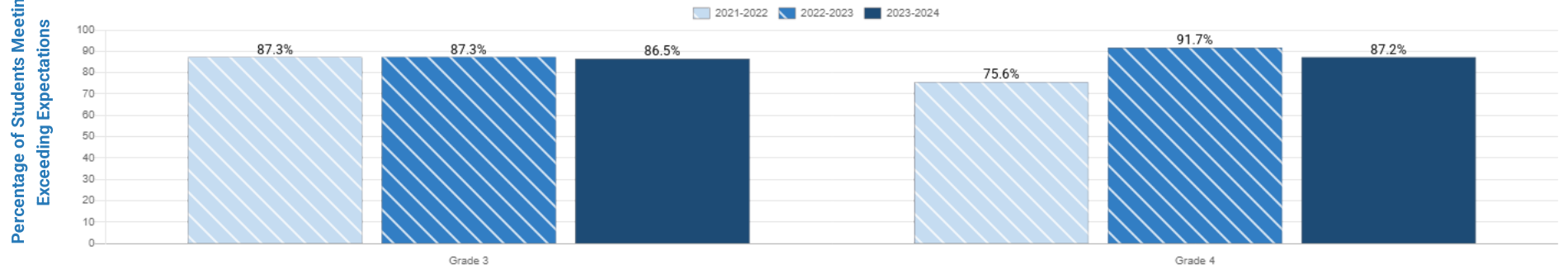

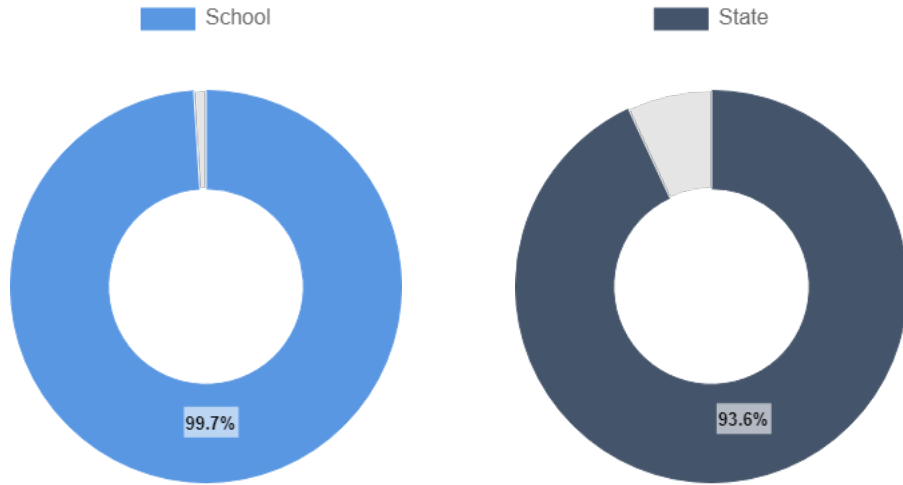

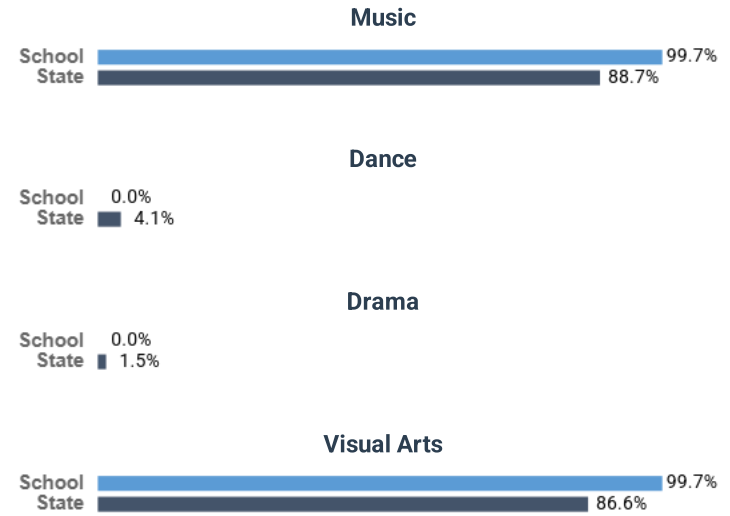

Students enrolled in one or more classes by discipline:



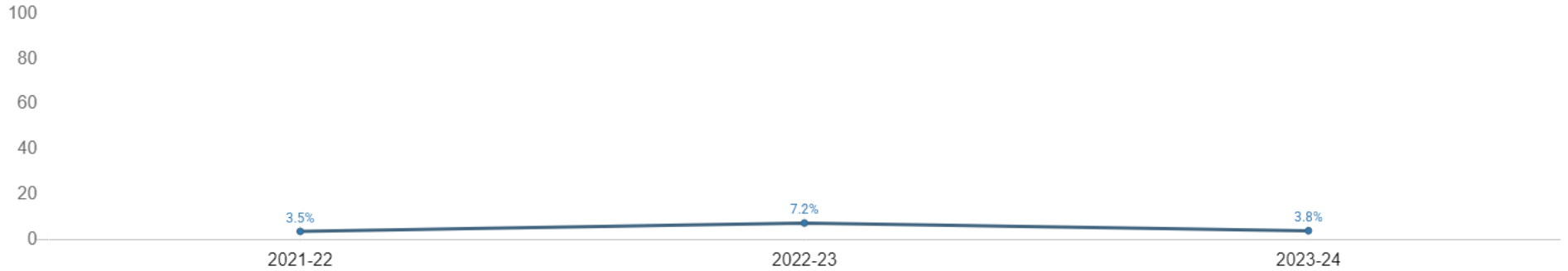

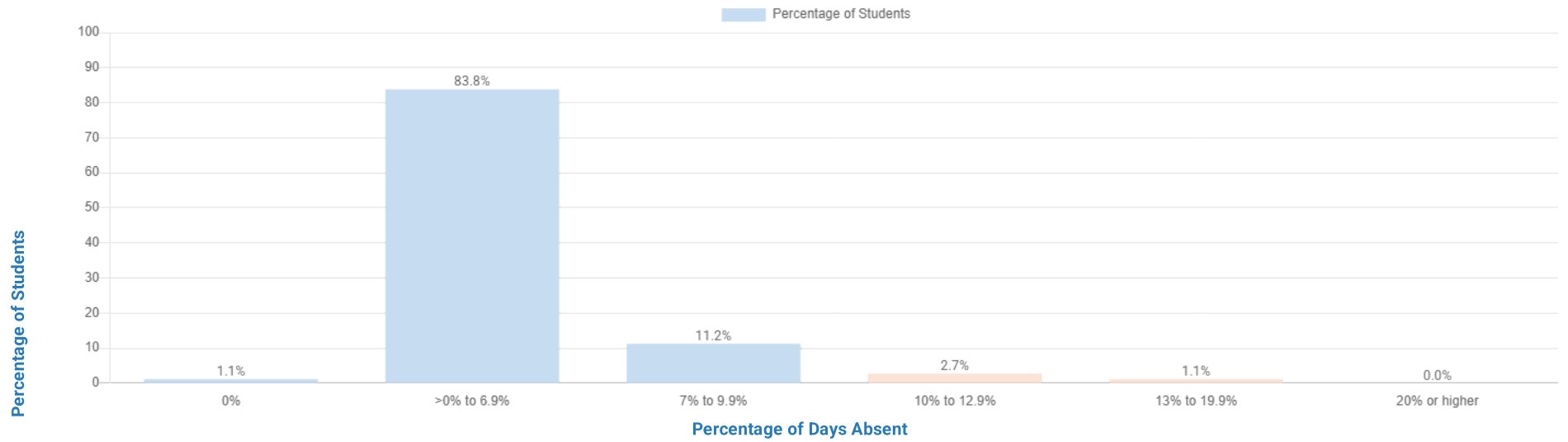

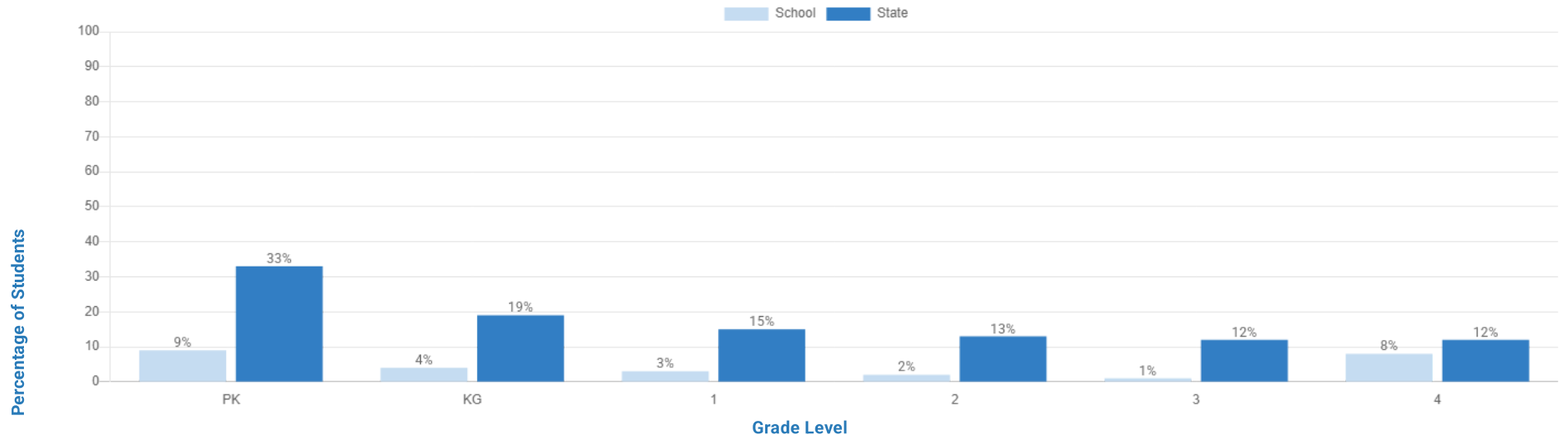

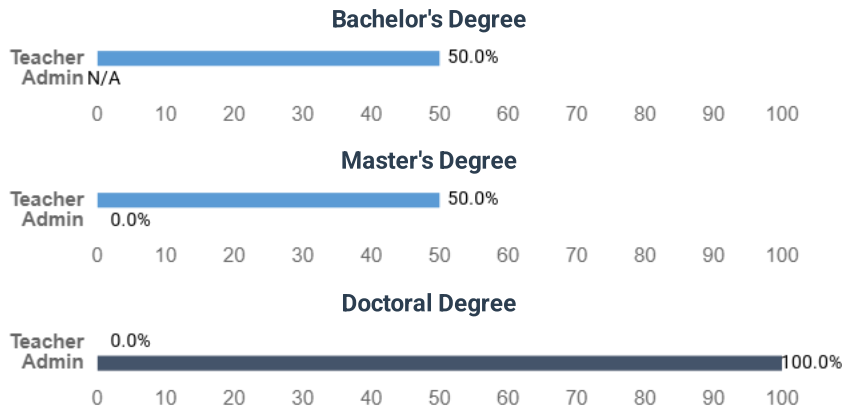

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Before and After School Programs:

Our facilities are utilized for community athletic groups such as rec and adult sports (basketball/soccer.) The PTO runs extracurricular activities after school such as Coding, Board Game, Bricks for Kids, Chess, and Theater to name just a few. We have scouting groups (boys and girls) who run programs at our school both after school and in the evening and they service students from grades one through high school. We have partnered with the YMCA and they run our After Care program which services seventy five students in grades kindergarten through fourth grade.



Staff and Professional Learning:

A critical component of increasing student achievement is providing opportunities for embedded and sustained professional development. The SciP committee assists new teachers to build a solid foundation of instructional strategies to enhance their teaching. Our experienced staff is surveyed yearly to ascertain their professional development needs. Utilizing data we develop teacher SGOs and district initiatives. All of the above drive professional development opportunities for our staff. During the school year, the staff is working in PLC groups on their Personal Professional Journey. They have identified an area of interest/need and have developed an active plan to achieve their goals.



Student Supports and Services:

Point Road School meets the differentiated needs of all of its students. Our I&RS (MMTS) committee in tandem with our Interventionists work with regular education students to remediate skill area deficiencies and supplement our mainstream curricular efforts. We offer multiple tiered supports including: in-class support services, resource rooms services; we have two, half day, integrated pre-school classes as well as multiply disabled class. Speech, counseling, OT/PT are available for students in need.

Student Health and Wellness:

Our school nurse and our Health/PE teachers spearhead our efforts in this area. They deliver our Health/Wellness Curriculum, by providing classroom instruction and teacher professional development (CPR, AED, Asthma, Lyme, etc.) They co-teach the Family Life curriculum. We are a nut free school for snack and lunch, and we have an approved Snack List for school celebrations that has been developed by the staff, parents and students. Our students have two, fifty five minute periods of PE in a six day cycle. They have thirty minutes of recess daily. We have integrated SEL into our daily schedule beginning with a whole school morning, meeting, focusing on social skills and continuing with more integration throughout the school day. Our students also participate in PE class daily, which supports the developmental appropriateness for movement in young learners' days.



Parent and Community Involvement:

Parent support is a dynamic force supporting our school's vision. They work to bolster the school programs with fiscal, technological, curricular and volunteer support; including teacher grants. The PTO has contributed to our cultural arts programs, our outdoor classroom, classroom furniture, playground equipment, Celebrating Different Learners Day and Multicultural Day. The EFLS has purchased a significant amount of equipment which has enabled us to live stream to our students during total remote or hybrid learning. In addition, they have provided items such as J-touch interactive TVs, teacher laptops, Document Cameras 1:1 Chromebooks and video equipment as well as our most recent outdoor story walk.
