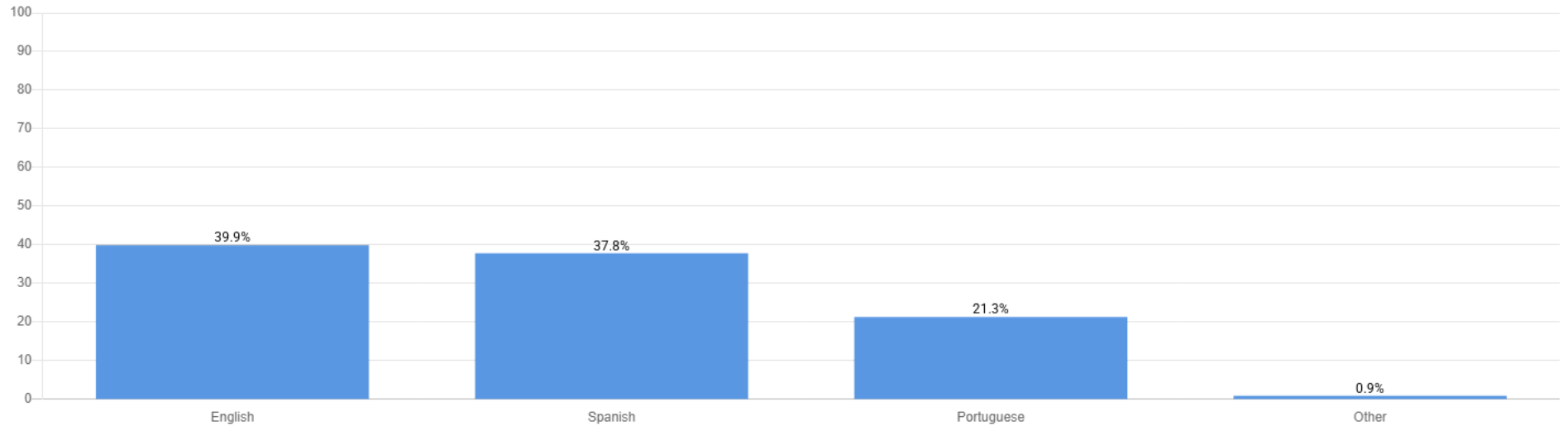

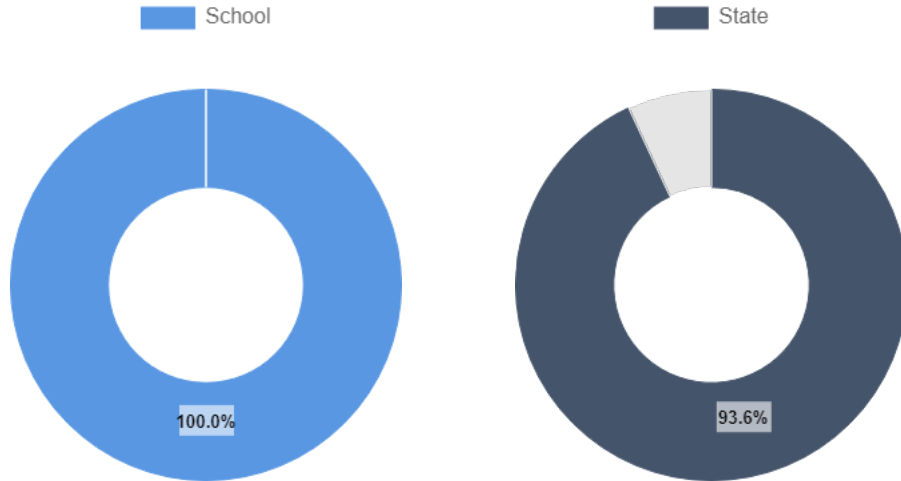

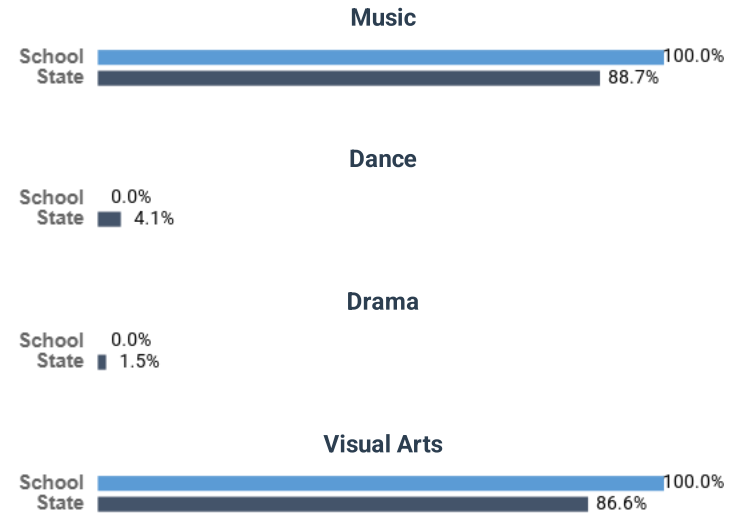

**Students enrolled in one or more classes by discipline:**





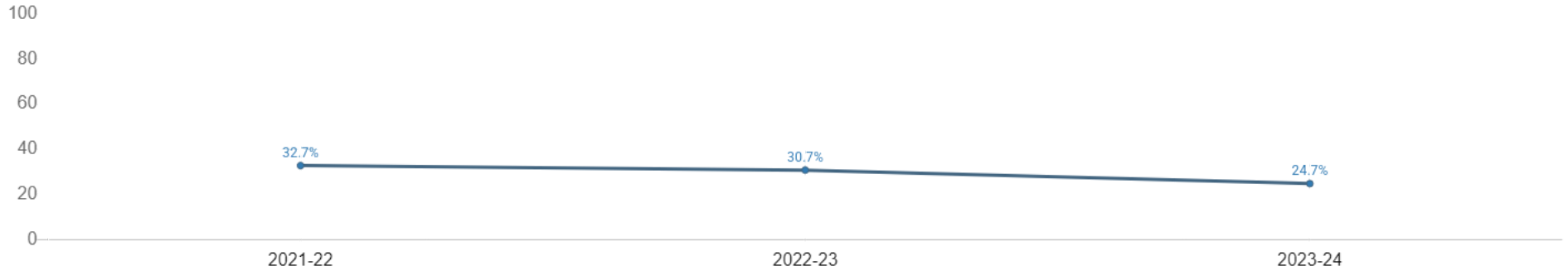

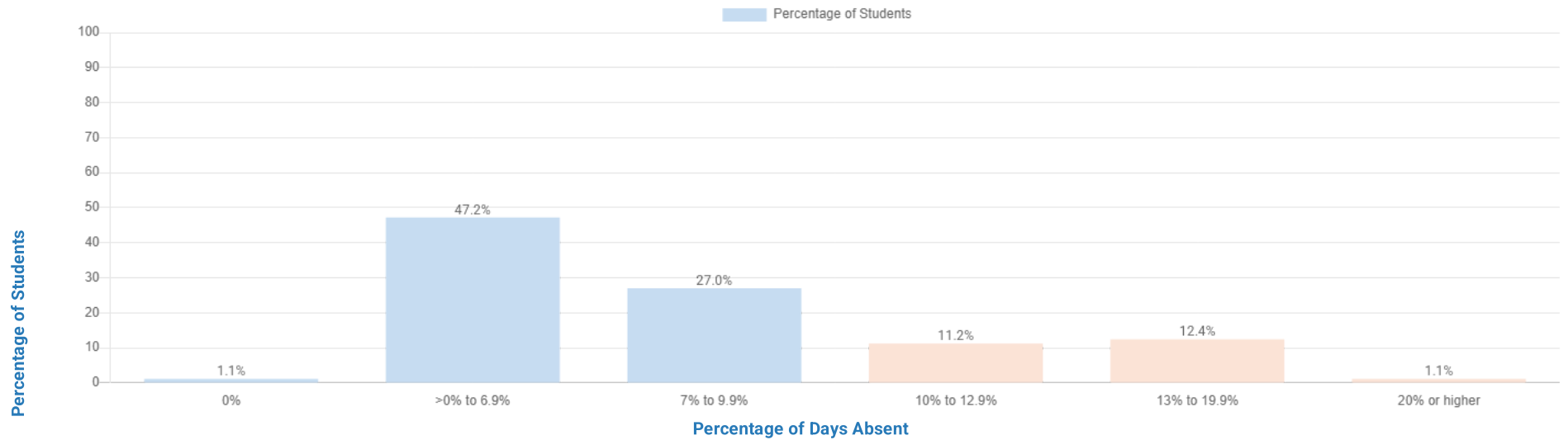

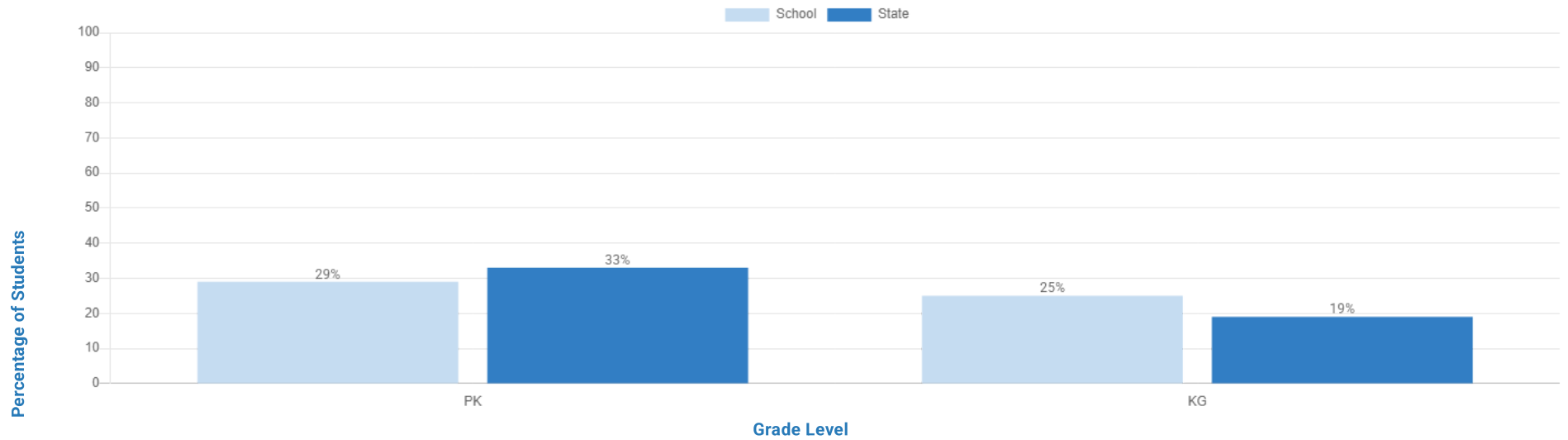

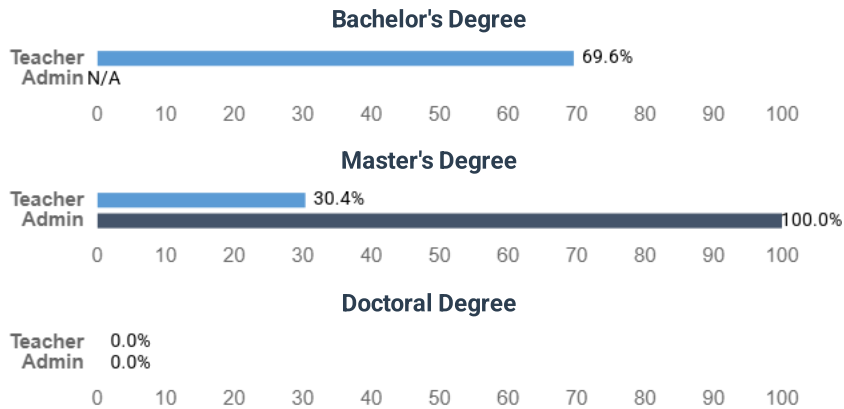

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

### Courses, Curriculum, Instruction:

Our preschool classrooms use the Tools of the Mind Curriculum for both Pre-K 3 and Pre-K 4 which provides our students with activities that build a solid foundation in developmental domains necessary for kindergarten. Our kindergarten classrooms use Everyday Math and have focused themes for Science and Social Studies. Our kindergarten classrooms use Scholastic Literacy which focuses on comprehension skills, high frequency words, vocabulary, fluency, phonemic awareness, and phonics.



### Before and After School Programs:

Before and after school wrap around services are offered to all students by our contract provider Champions.



### Staff and Professional Learning:

Weekly faculty meetings and Professional Learning Communities (PLC) provide professional development opportunities for all staff. The district provides full and half day sessions throughout the year based on survey results from all stakeholders. Instructional assistants are provided additional training to support their teacher.

### Student Supports and Services:

Multilingual learner support is provided to all kindergarten students using multiple measures including WIDA results. The school provides support through PIRS and I&RS services. A tutoring program is offered to kindergarten students who qualify. Special education services are provided to classified students. The Student Advisor and PIRS provides monthly social emotional learning lessons.



### Student Health and Wellness:

Our Physical Education and Health classes promote long-term health and wellness by making health and fitness fun. Our classes focus on teaching character traits such as sportsmanship, teamwork, cooperation, and perseverance. Students participate in monthly yoga and learn mindfulness techniques.



### Parent and Community Involvement:

The PTA (Parent Teacher Association) actively involves teachers, parents and students in a variety of events throughout the school year, such as holiday fundraisers and dances. Additionally, communication is enhanced through the use of our parent portal, school website, Instagram, Twitter, and Class Dojo. An Early Childhood Advisory Council (ECAC) representing staff, district, and community stakeholders, meet quarterly to address the needs of the school.

As a safety precaution, security drills are practiced on a monthly basis. A full-time safe school officer is present to screen visitors and assist with monthly security drills.

### Technology and STEM:

All classrooms are equipped with projectors and screens to offer multiple ways of reaching students and a better interactive learning experience. All classes are equipped with 1:1 Chromebooks for all students to supplement their learning. Kindergarten classes are equipped with six iPads for student use in addition to their Chromebook.



### Early Childhood Education:

The Joseph M. Ferraina preschool program is state-funded full day program for students beginning at 3 years old. This full day program aims to improve children's growth in areas they need to succeed in school and beyond including cognitive skills, self-regulation, school readiness, and SEL development. The current comprehensive curriculum, Tools of the Mind, gives teachers the tools to ensure every child becomes a successful learner.



### Attendance:

The Joseph M. Ferraina Early Childhood Learning Center implemented various incentives throughout the year including individual classroom attendance challenges. Classes with the best attendance received ice cream, pizza, or popcorn parties. Continued communication between parents, teachers, student advisor, and principal helped develop awareness and place an importance on student attendance. Letters were sent home to inform families of multiple absences and when their child was nearing chronic absenteeism status.
