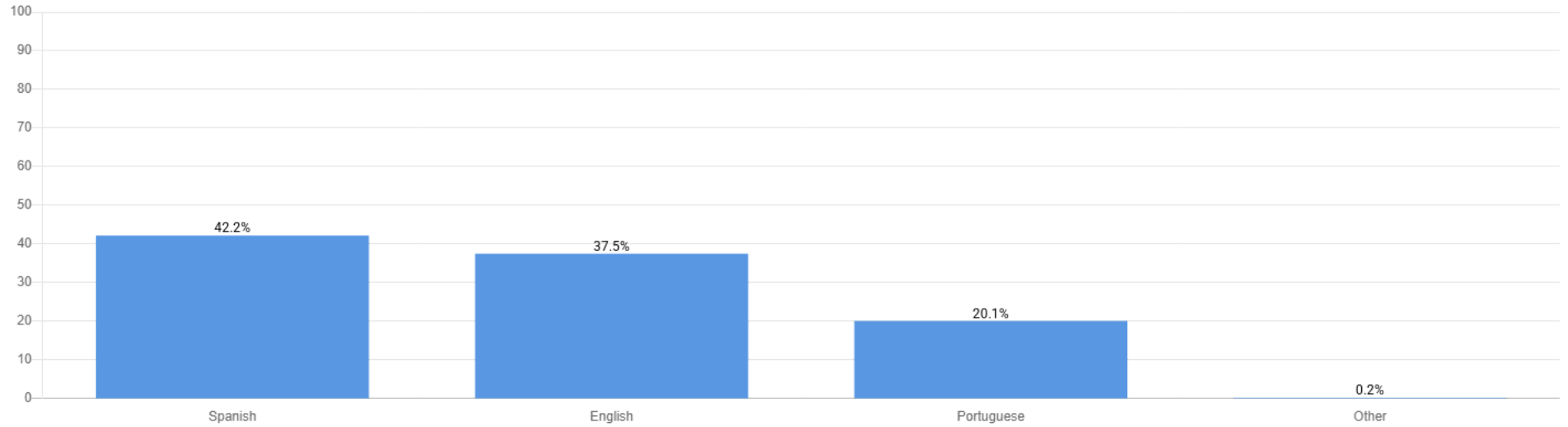

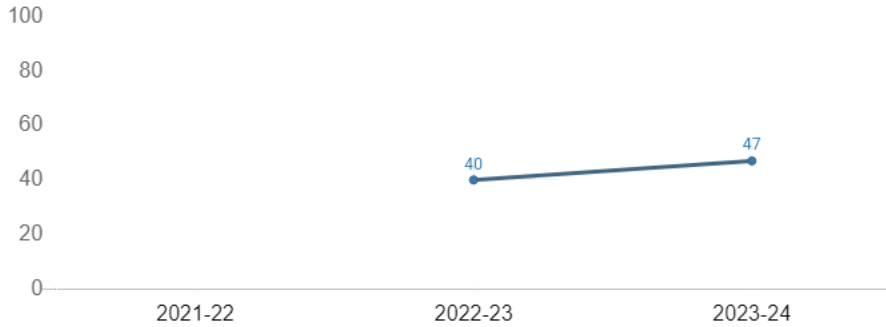

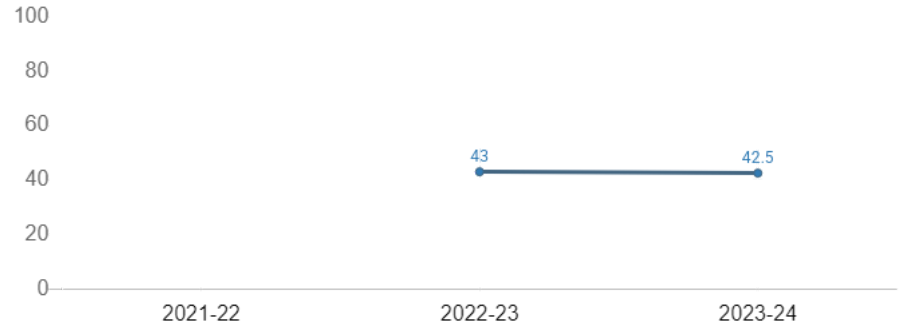

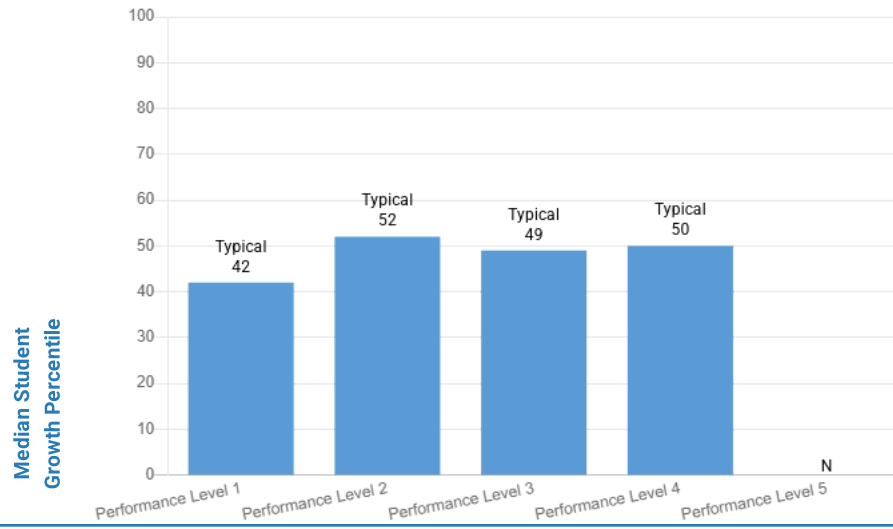

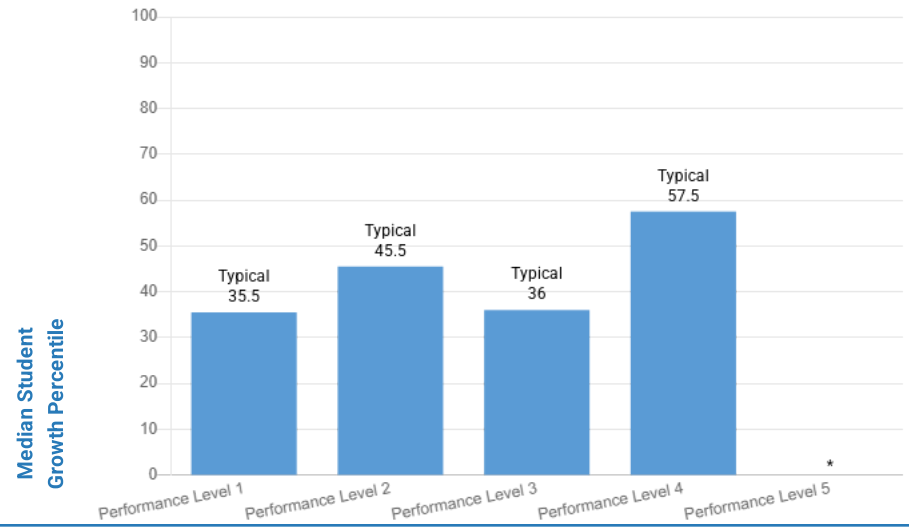

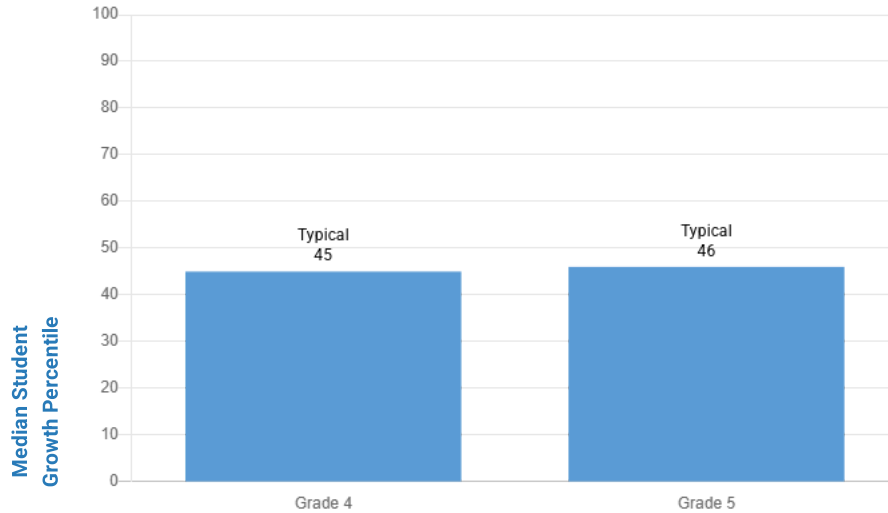

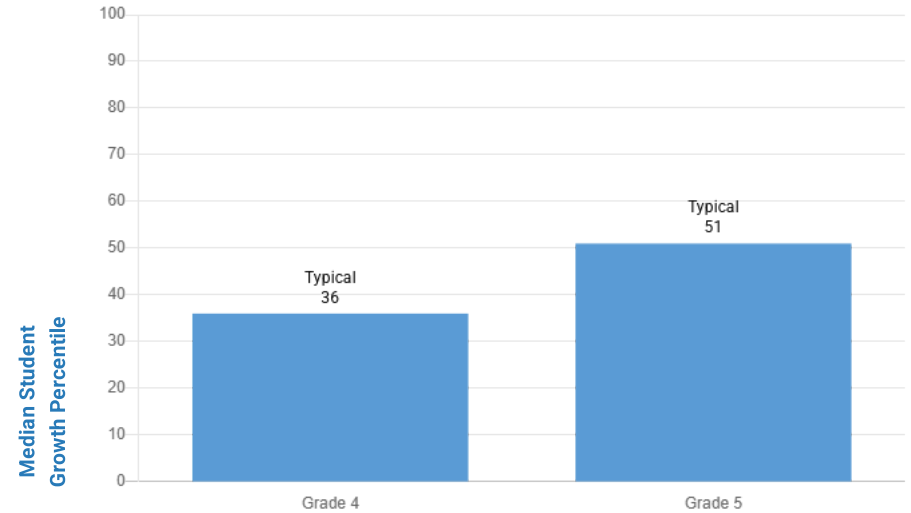

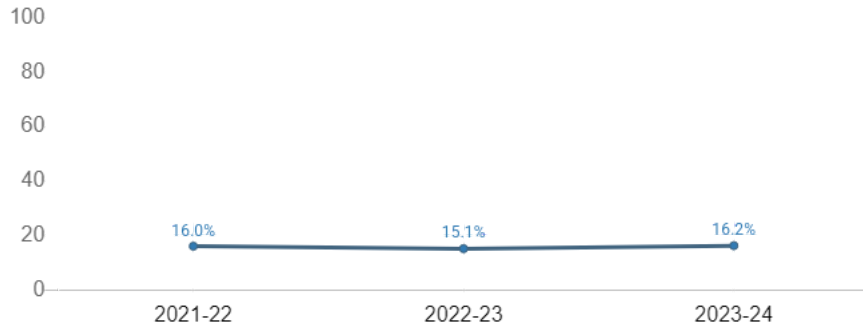

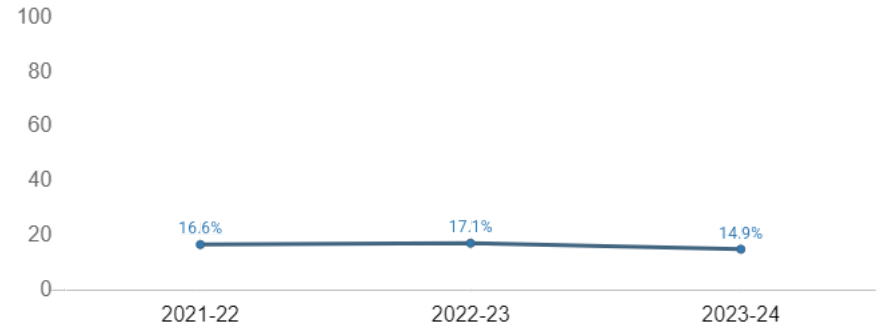
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 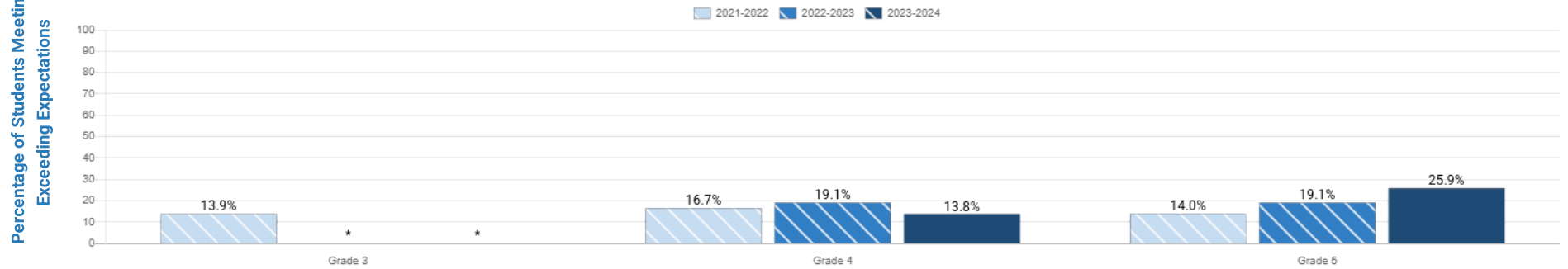

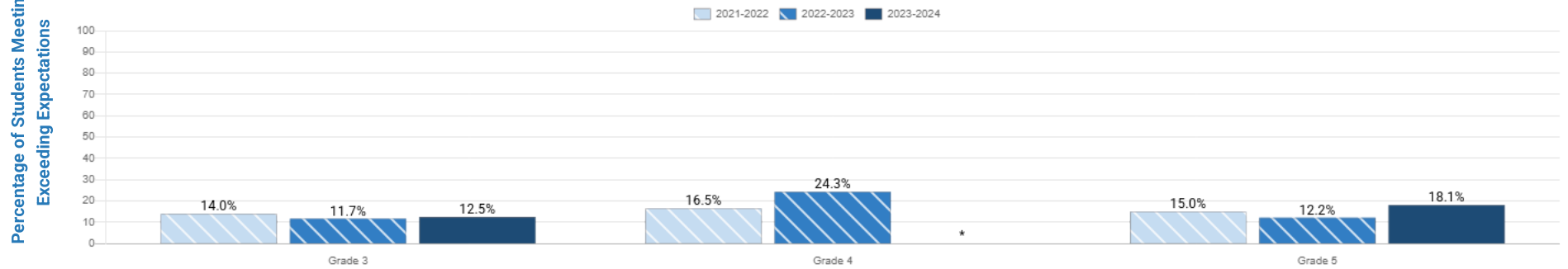

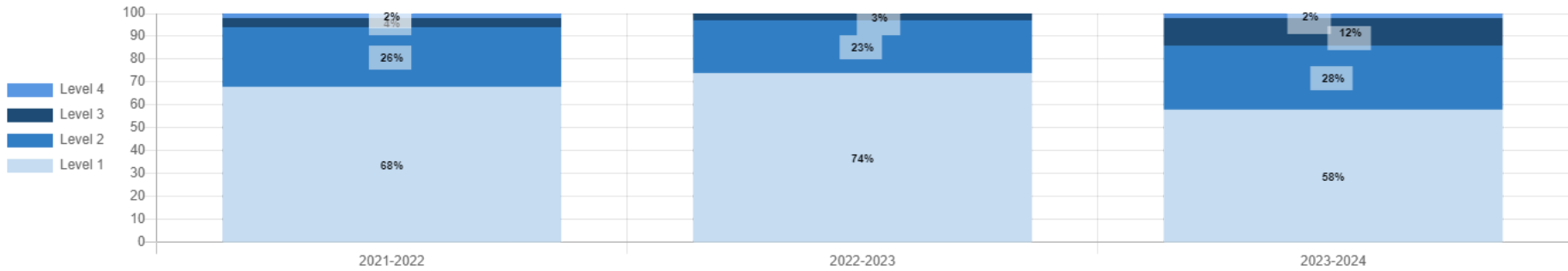

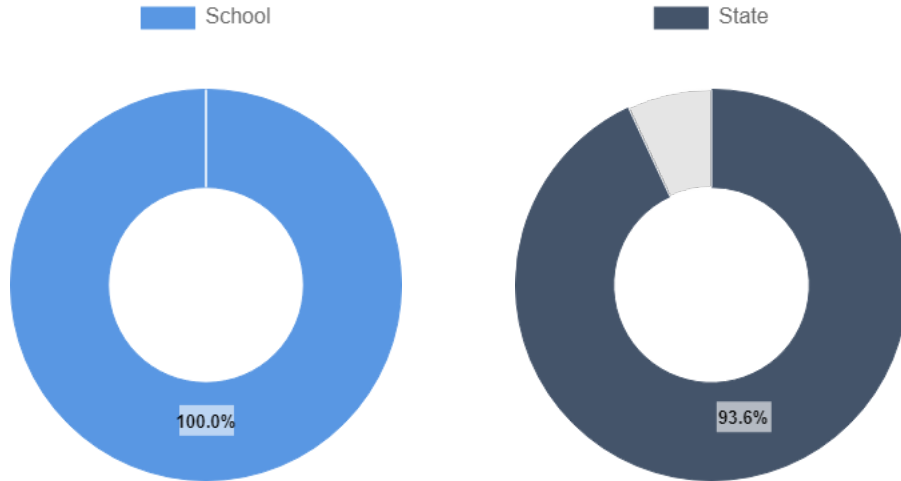

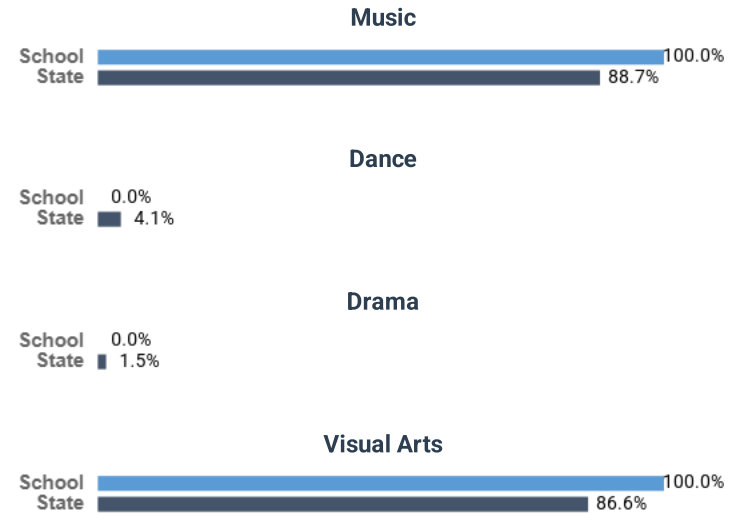

Students enrolled in one or more classes by discipline:



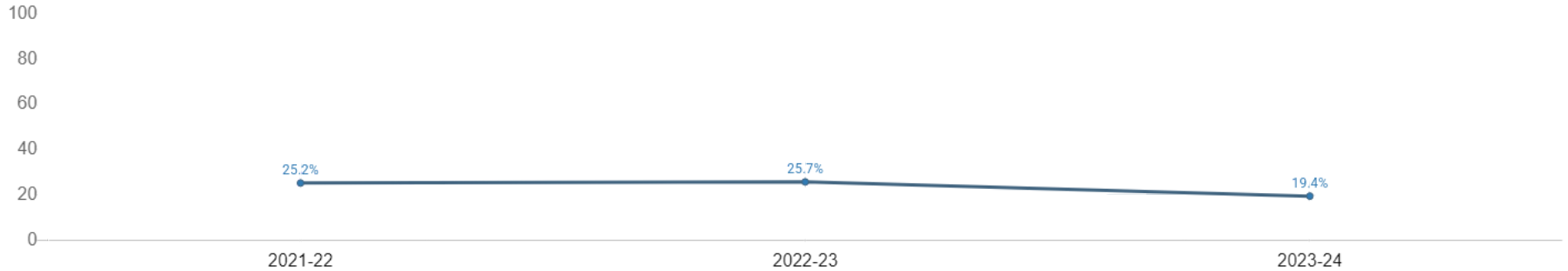

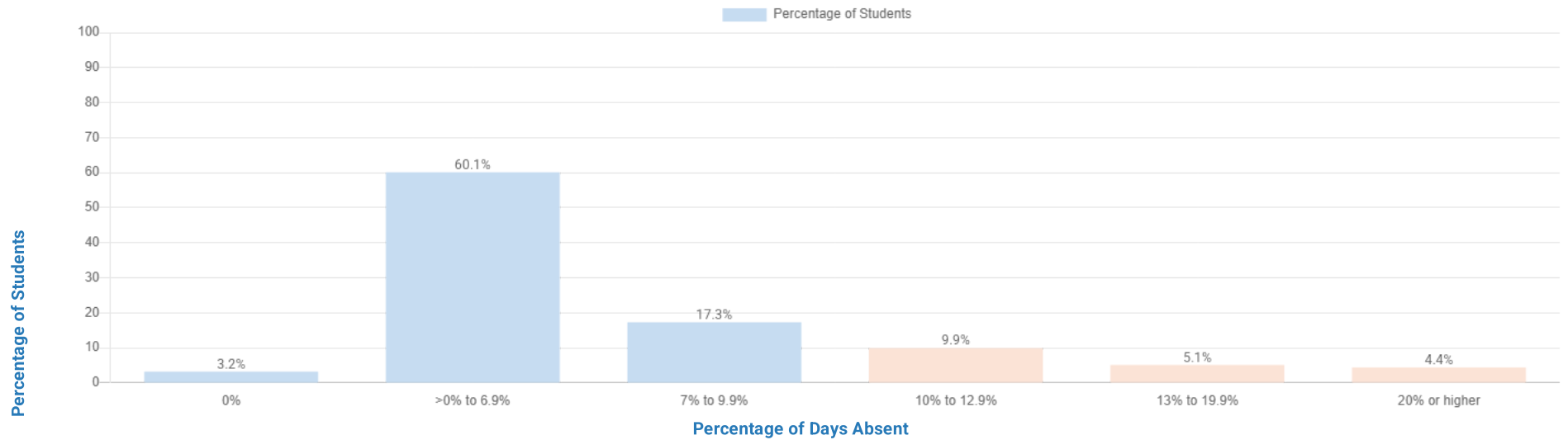

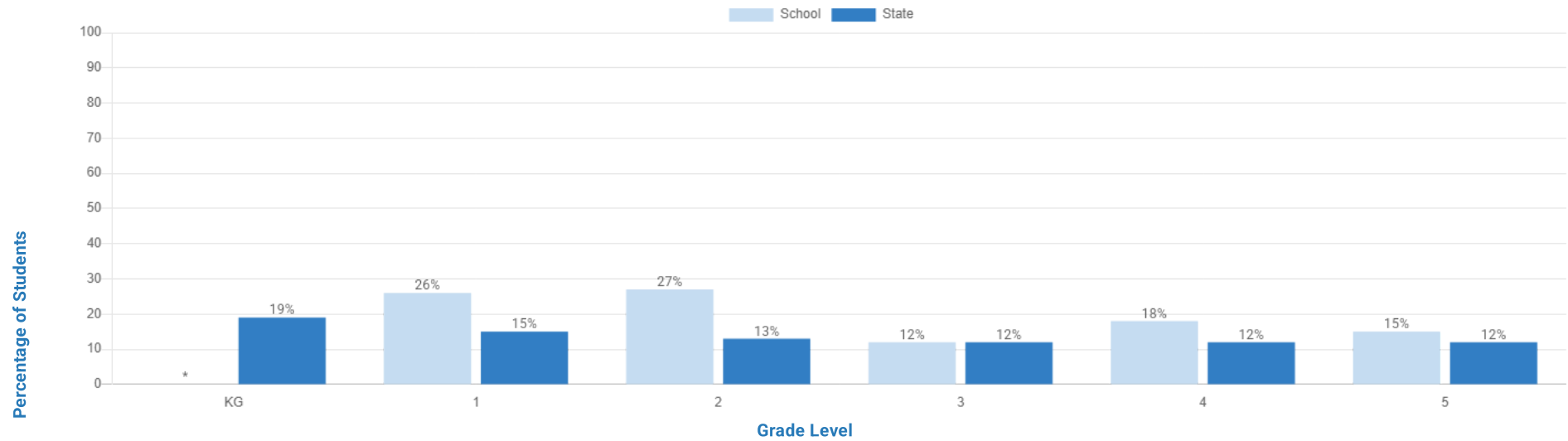

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. 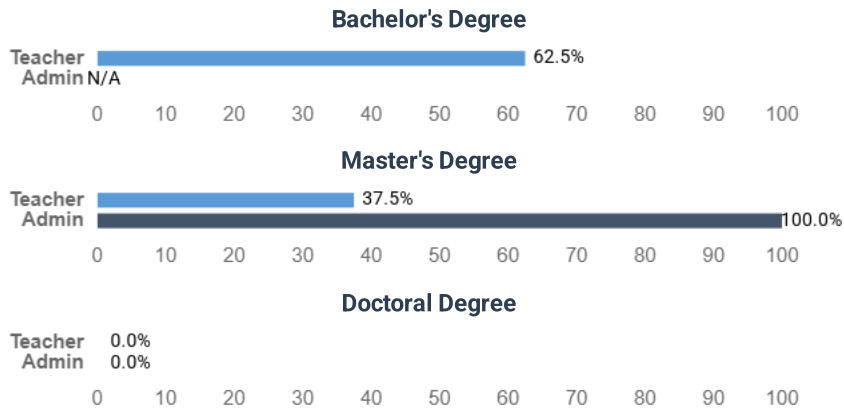

Gregory uses the Everyday Math program which focuses on real-life problem solving and student communication of mathematical thinking. ELA is taught through Scholastic Reading which utilizes high quality literature coupled with explicit instruction. Gregory utilizes the WAVE3 program in which students in the top percentage of grade levels are awarded the opportunity to participate in a push-in or pull-out enrichment program in which they practice and enhance their ELA and Mathematics skills.

With the partnership of the community, our school PTA is able to provide senior scholarships to former school students.

Gregory Elementary School utilizes the School Climate Survey prepared and facilitated by the School Transformation Project from Rutgers University. Facilities:

The Gregory School is a modern facility offering a fully equipped computer lab, in which students have multiple opportunities to enhance their technological skills. All students K-5 have one-to-one Chromebooks with Wi-Fi access, which allows students to collaborate with their peers and teachers regardless of their location, further develop their computer knowledge, and enhance their academic skills. In 2022-23, the playground was refurbished to increase safety and promote health and fitness.

School Safety:

To ensure student safety, supervision is provided on school grounds at all times. Visitors must register at the main office prior to entering the school, and a visitor's pass must be worn at all times. Staff are trained on the latest safety procedures and practice safety drills on a monthly basis. All staff desktops are equipped with "Crisis Go": an alarm system that alerts staff to any dangers and gives them directions on what to do.



Technology and STEM:

Gregory Elementary School was recognized by the state for meeting the challenges of digital learning as a Digital Star School. All students are issued a Chromebook and use a multitude of tools to transform their learning. Each educator infuses technology into their lessons. Students are driven to utilize technology to expand their learning process and support their growth.



Attendance:

The Gregory Elementary School enacted proactive and reactive approaches to improving student attendance. Attendance interventions included automated robo calls, outreach from an attendance team member, letters sent home to identify students at risk of being identified as truant, and parent meetings to collaborate on positive approaches to attendance. The Gregory School tied positive attendance to additional student and staff based incentives as well as academic interventions. Student attendance rate was factored into participation in selected programs and extracurricular activities. Gregory School staff hosted numerous parent events to educate parents on the impact of positive school attendance.
