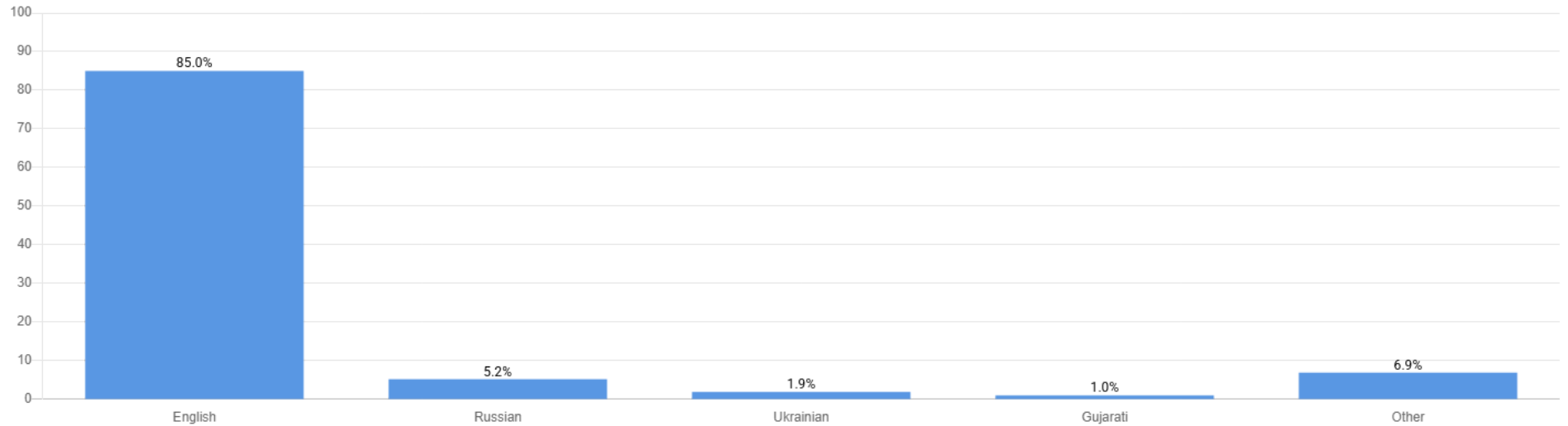

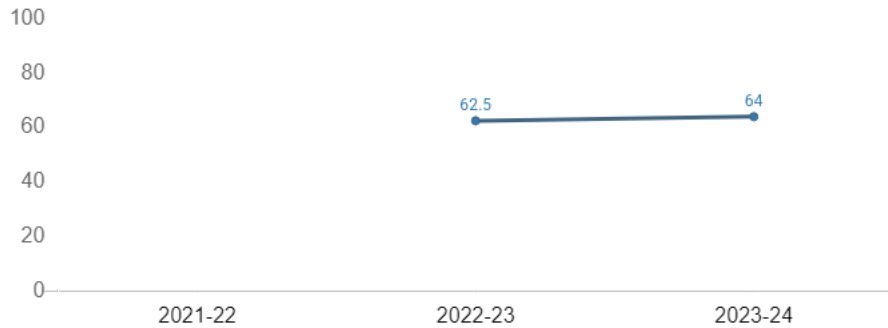

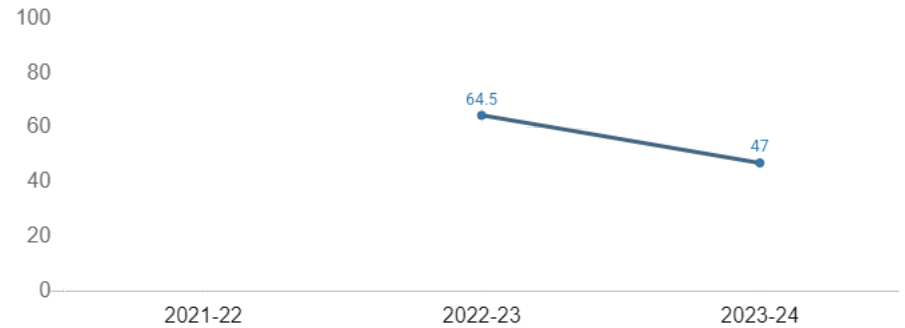

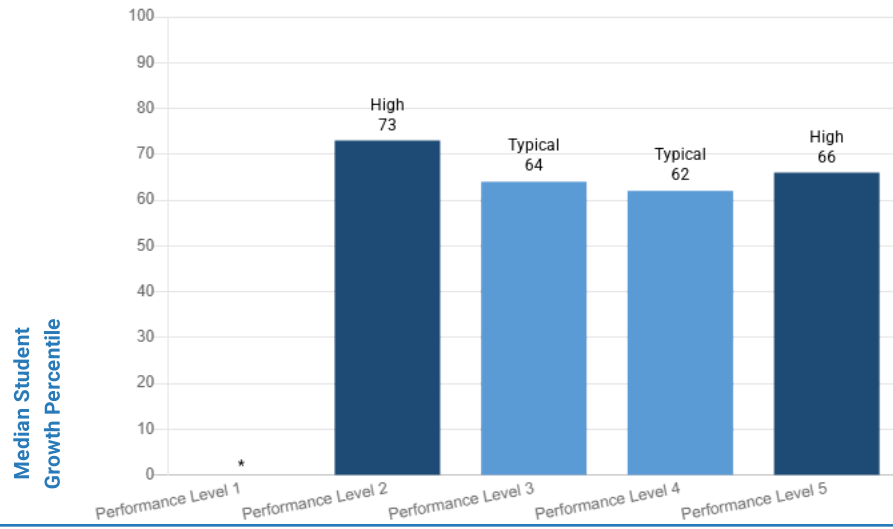

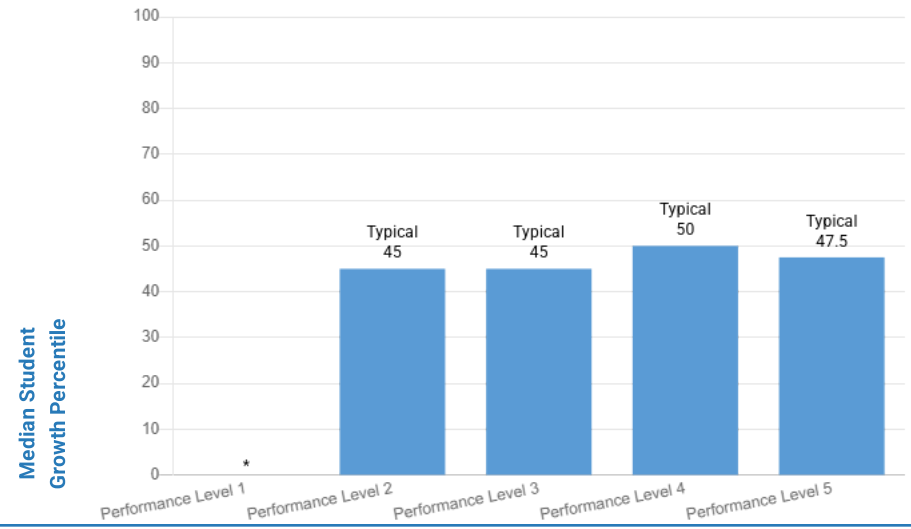

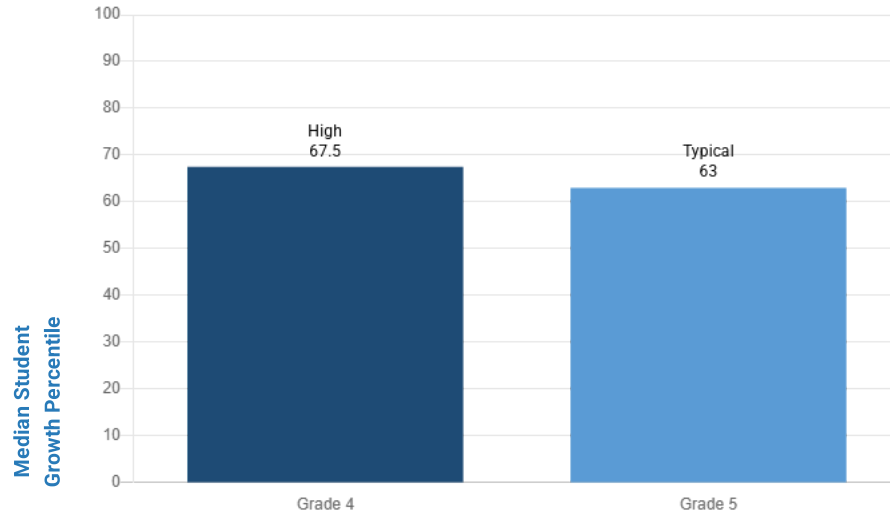

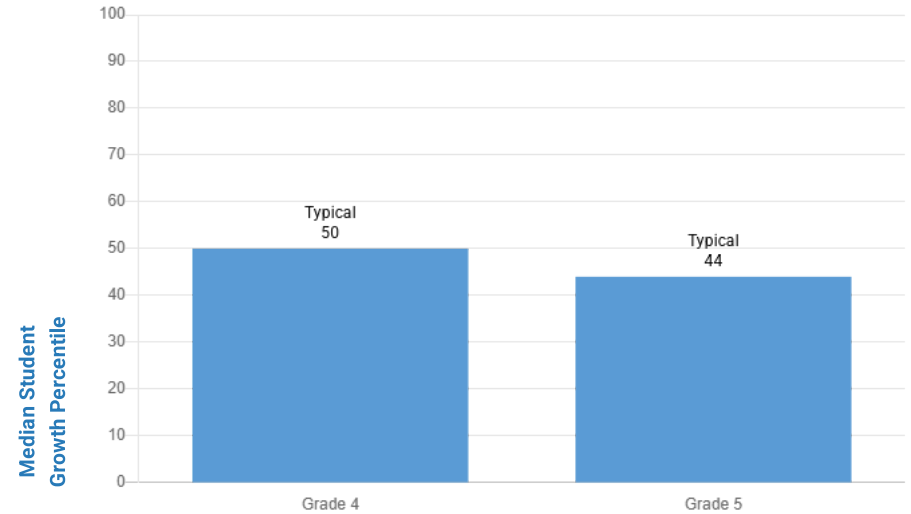

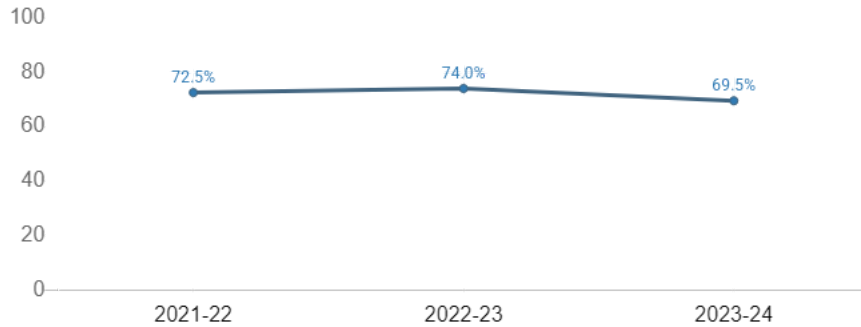

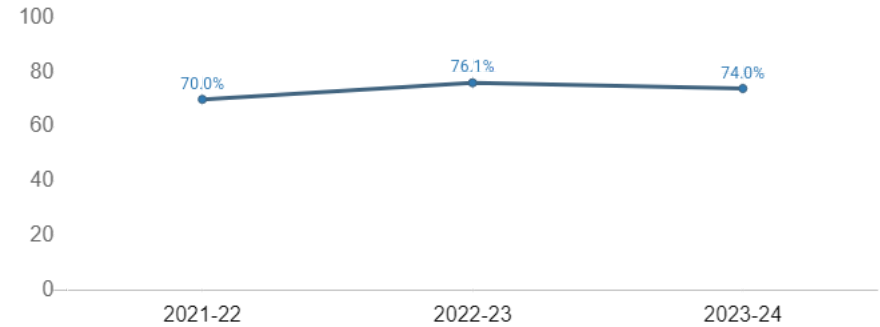
English Language Arts and Mathematics Performance Trends

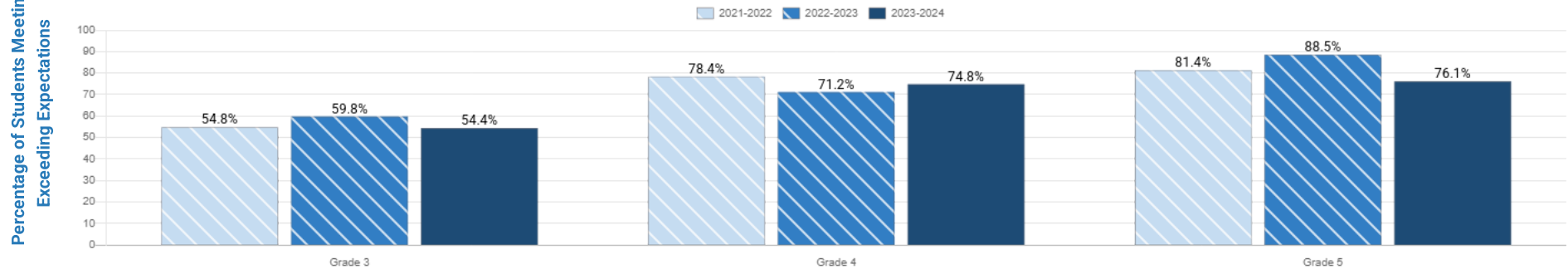

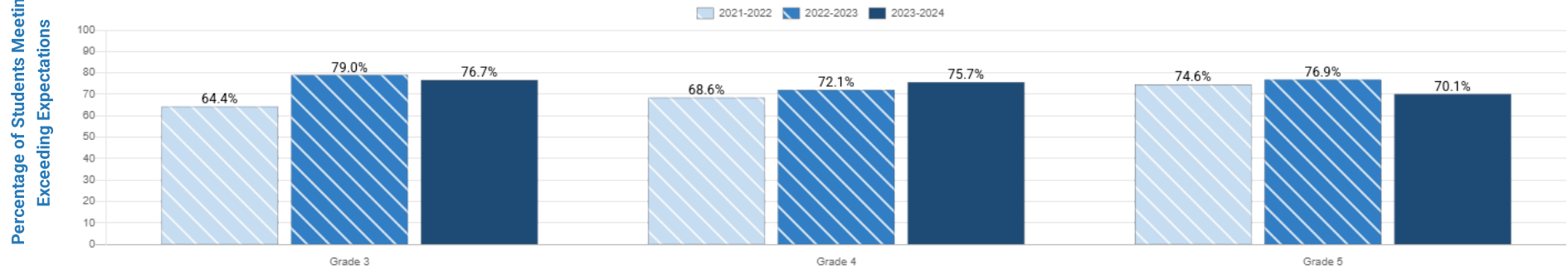

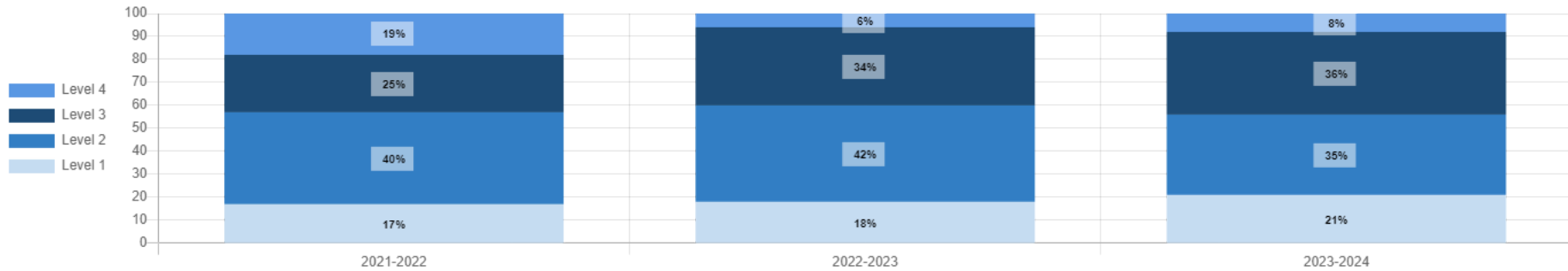

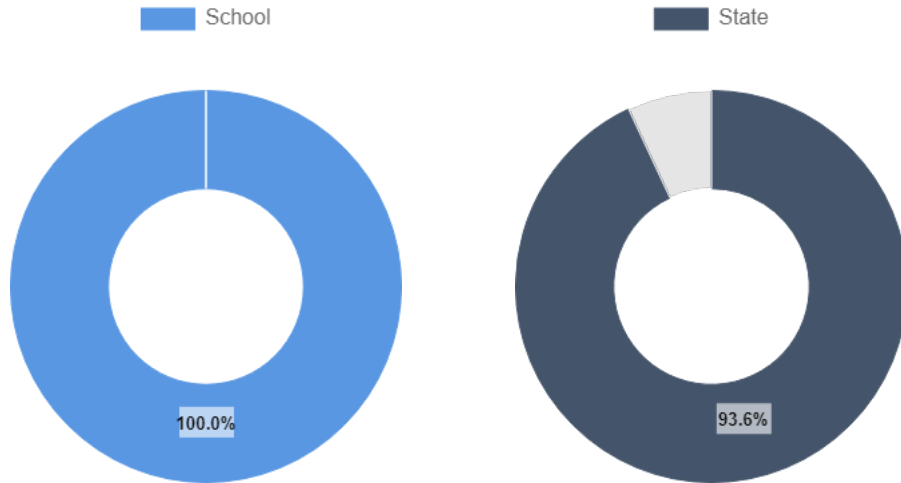

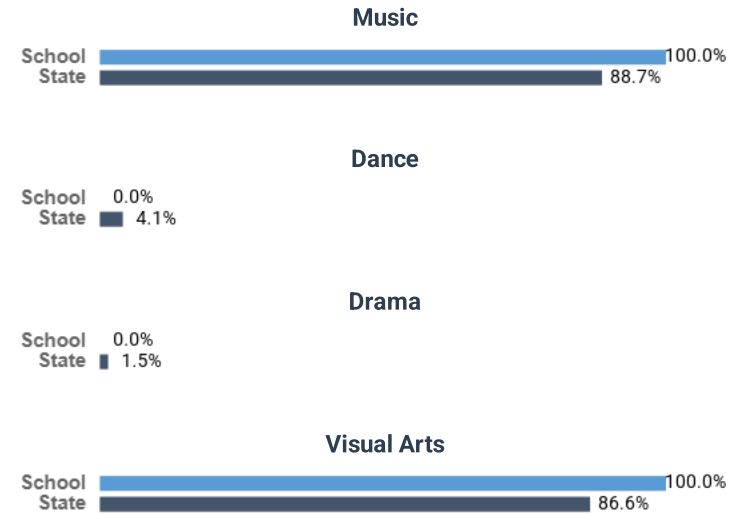

Students enrolled in one or more classes by discipline:



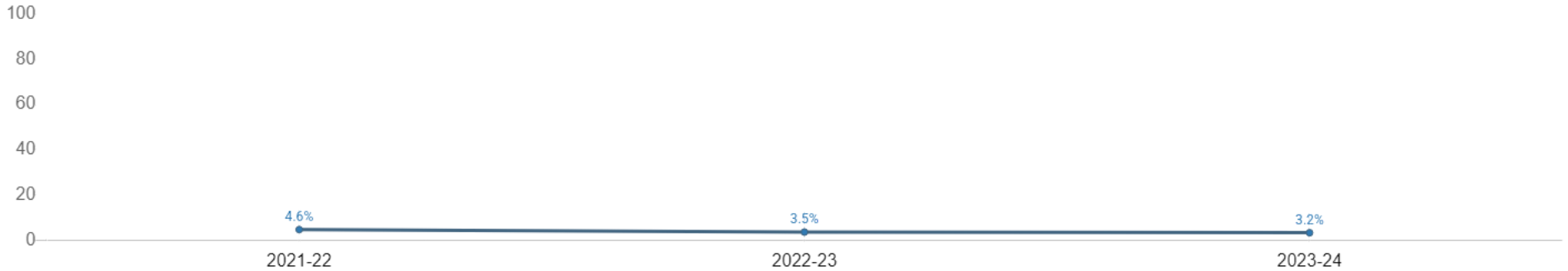

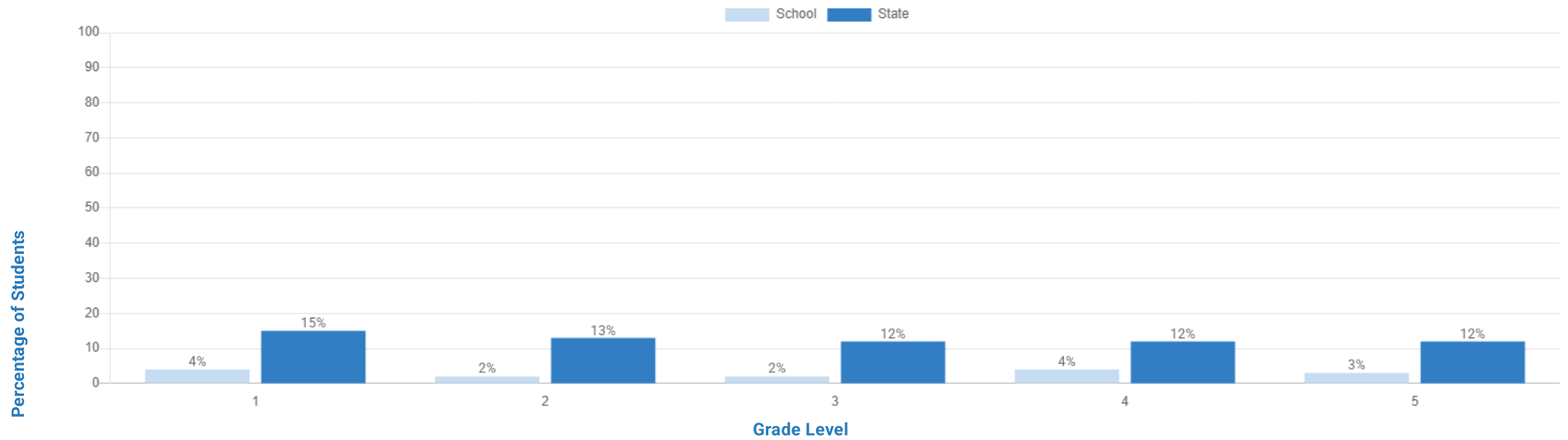

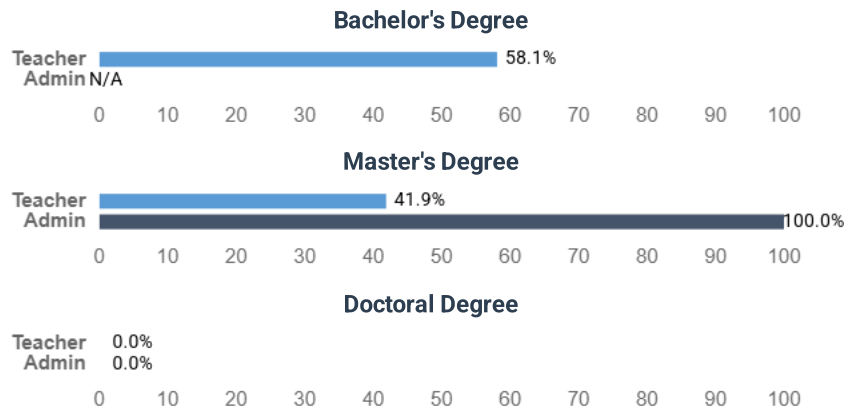

Courses, Curriculum, Instruction:

Our curriculum is aligned to the NJ Student Learning Standards. In grades 1-5, we use the Envision 2.0 math program and a Daily 3 math workshop model. We utilize various resources in language arts such as Project Read, author studies, and the TC Units of Study for reading and writing during our balanced literacy block. Science instruction is aligned to the Next Generation Science Standards and we use program such as Mystery Science and PLTW to engage learners. Various technology programs and websites such as ACHIEVE 3000, ST Math, Reflex Math, FRAX and IXL are utilized to enhance lessons and engage learners. Response to Intervention is used to remediate struggling learners' needs, and enrichment is available to qualified students in grades 1-5.



Clubs and Activities:

Clark Mills School offers a variety of school clubs for our students. Student Council participates in community-based learning and also promotes a positive school culture. Students engage in coding activities during our after school Coding Club. Selected students in grade 5 along with our CMTV Director, create daily morning broadcasts on our television studio. Other after school activities include Young Scientists, band, chorus, and orchestra. We also offer a plethora of PTO activities for our students.



Before and After School Programs:

Response to Intervention groups and High Impact Tutoring groups for reading and math are offered before and after school to students who need additional support in these areas. We also utilize Fast ForWord, an evidence-based, personalized, and adaptive reading and language program, to target language arts needs. Targeted intervention plans are created for students and interventions run for 15 weeks. Data is collected to assess student growth from these programs.

Professional development needs are obtained through a survey developed by our SciP Committee. Teachers are a part of Professional Learning Communities where they get to discuss professional literature, student data, and instructional strategies, which assists them in meeting our students' diverse needs. The continued use of the ICLE's Rigor and Relevance Framework and their Rigor, Relevance, and Engagement Rubrics remain a focus. Developing teacher leaders was an area of continued focus through the implementation of Pineapple Charts, Lesson Studies, and Microteaching. Professional development also focused on social-emotional wellness. In addition, many teachers present workshops for peers and participate in teacher-led book clubs.



Student Supports and Services:

At Clark Mills, we offer a variety of support services to meet our students' academic and social well-being. We utilize a problem-solving approach to identify students' needs and create intervention plans to target focus areas. A school counselor and school psychologist both offer guidance on our students' emotional, social, and behavioral needs and run groups on a variety of topics as needed. A variety of special education programs and intervention services are available to students when necessary.



Student Health and Wellness:

A comprehensive health and physical education program is implemented across all grade levels. In addition to bi-weekly physical education classes, recess time is built into each class schedule. Mandatory health and character education lessons are taught across each grade." The counselor reinforces with each class concepts on social thinking and anti-bullying strategies; small group and 1:1 sessions are also held. Social-emotional supports are weaved into every aspect of the classroom and school. For example, social-emotional skills are taught through morning announcements and are reinforced through classroom morning meetings; a sensory hallway provides a hands-on environment to help students self-regulate and manage their feelings, emotions, and actions; calming corners in each classroom further assist students in managing strategies for de-escalation of myriad emotions.

We have an extremely active PTO who offers parents many ways to get involved in our school community. They also provide a variety of fun events for our students. We continue to practice the required school drills so that our staff and students know how to respond calmly and efficiently to multiple emergency scenarios. In addition, the local police department conducts walk-throughs in the building regularly, and we have a full-time school security guard on staff who helps build a positive, safe, secure environment for staff and students.

Technology and STEM:

Technology is integrated into all aspects of the curriculum. Students in grades 2-5 have 1-1 chromebooks they frequently use throughout the day. Students in grade 1 have 1-1 ipads. Google Classroom is utilized as a way for teachers and students to communicate with each other regarding assignments and lessons. The students are provided with technology instruction every other week by a technology teacher. A variety of technology, such as ipads, Smartboards/Promethean Boards, document cameras, and educational websites are utilized to enhance lessons. Technology is also used for parent communication. We use an electronic backpack, a school website, and social media to provide information to parents and the community. In addition, the Media Makerspace offers students the opportunity to participate in STEAM lessons and to tinker and explore.
