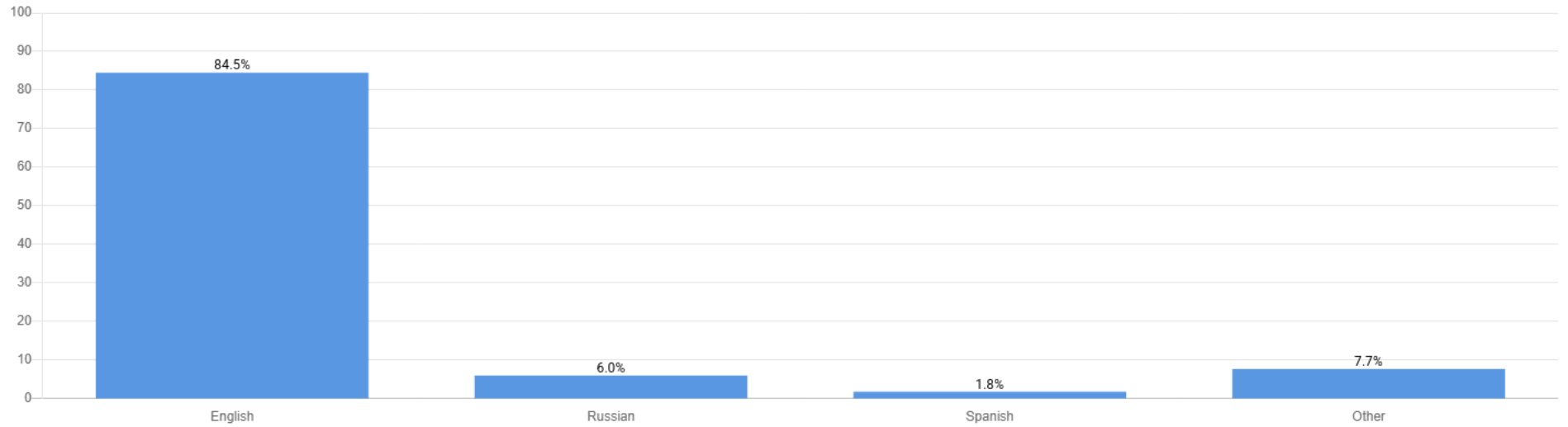

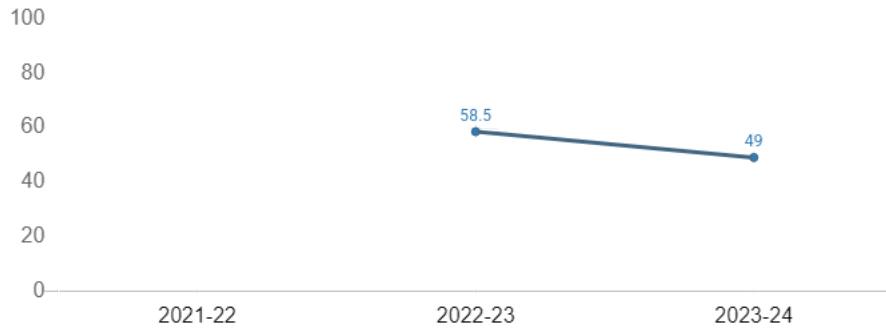

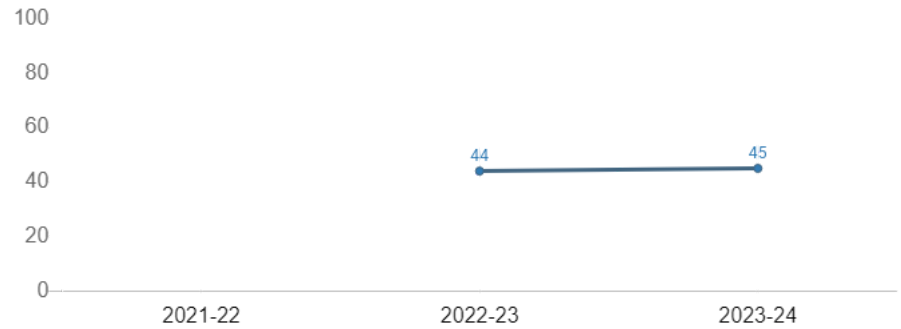

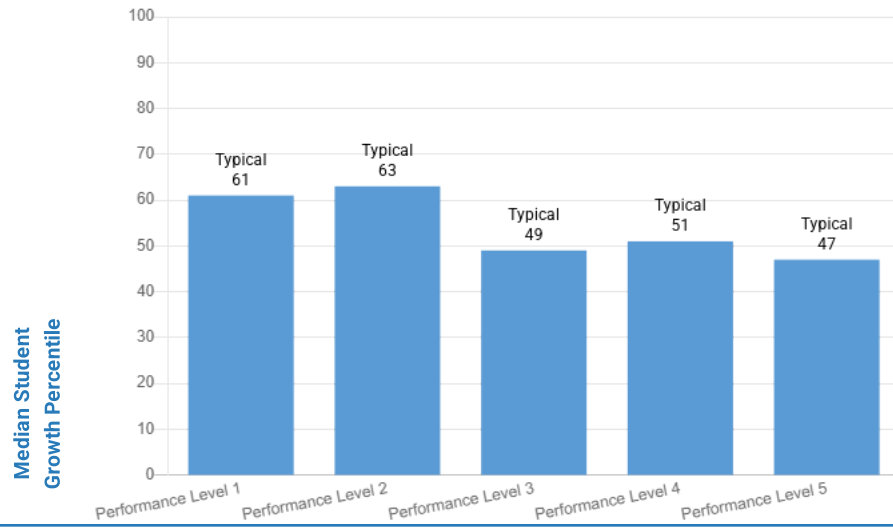

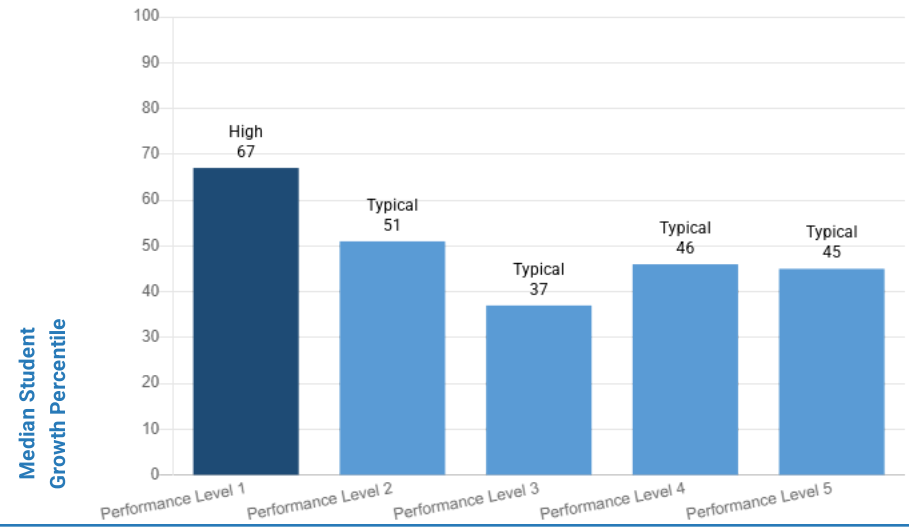

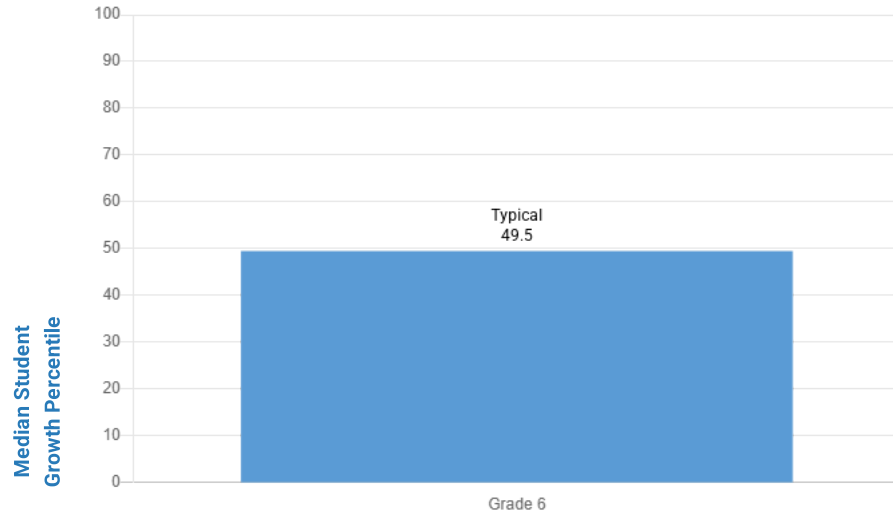

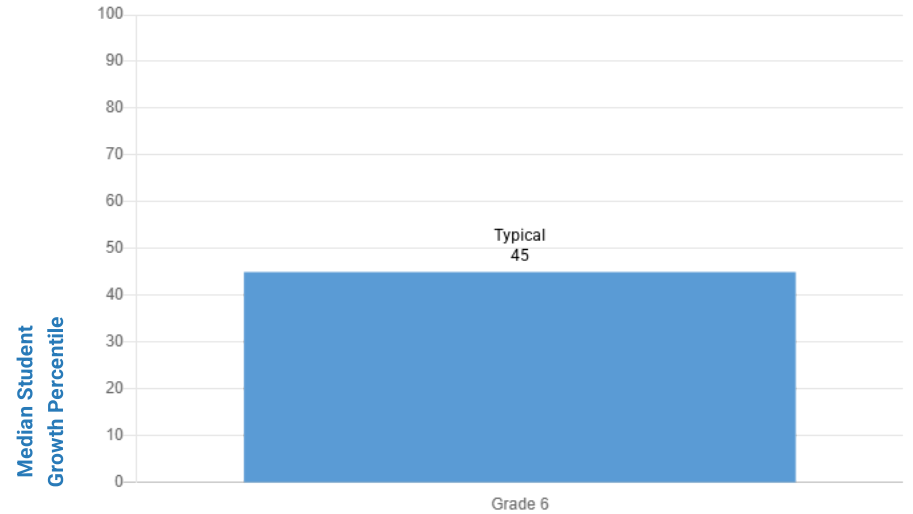

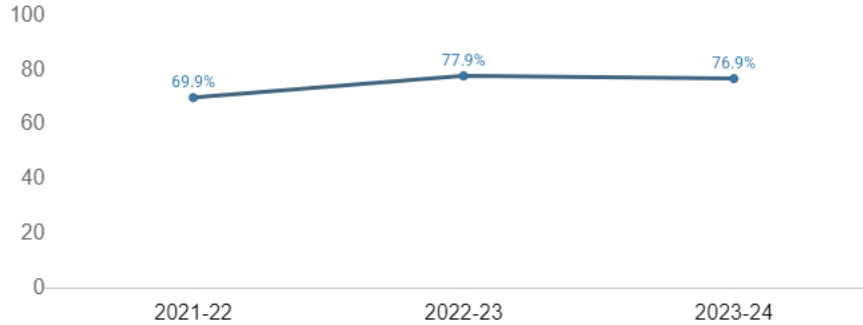

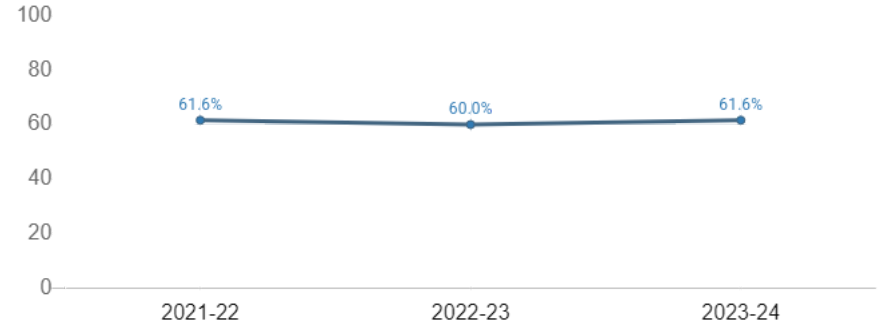
### English Language Arts and Mathematics Performance Trends

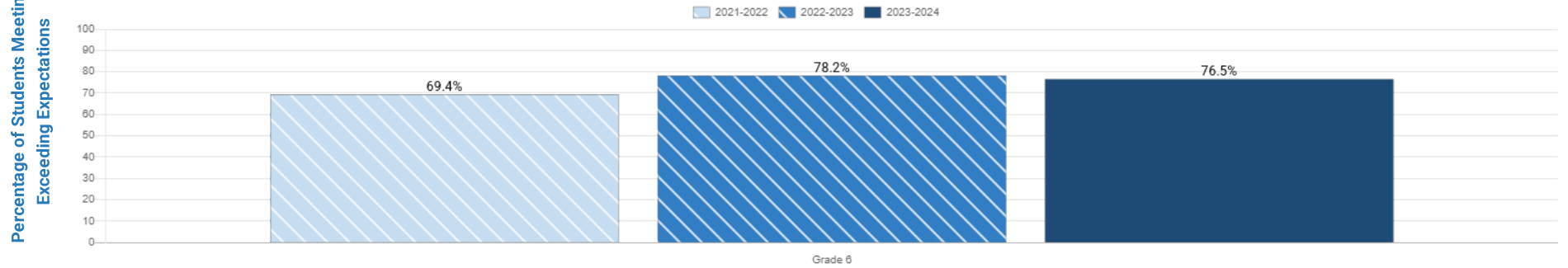

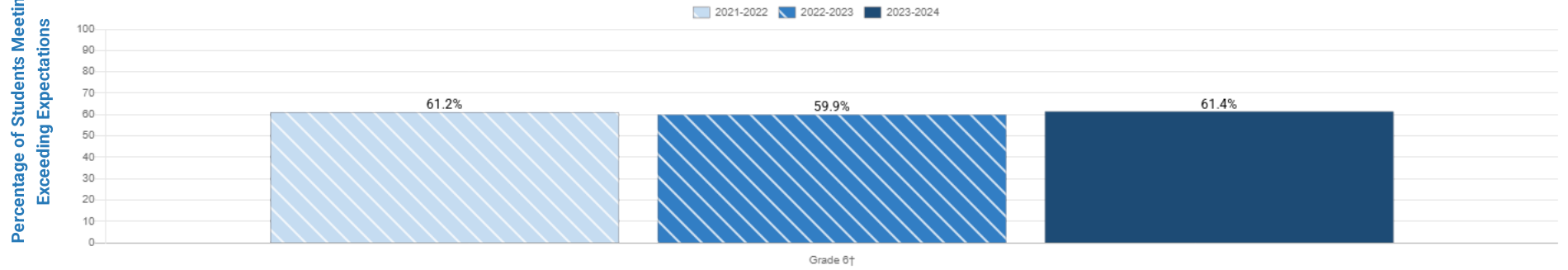

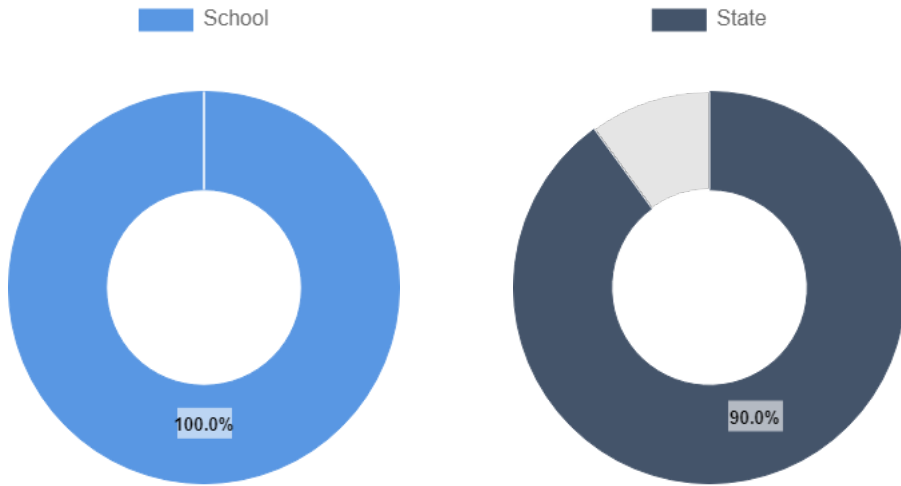

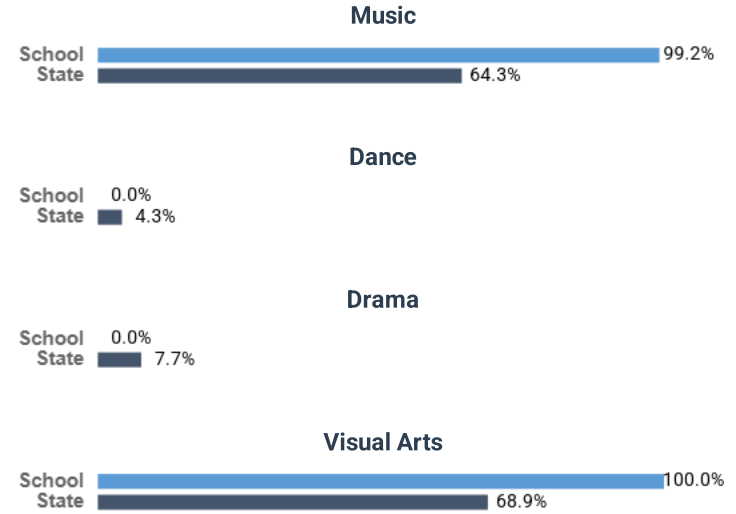

**Students enrolled in one or more classes by discipline:**



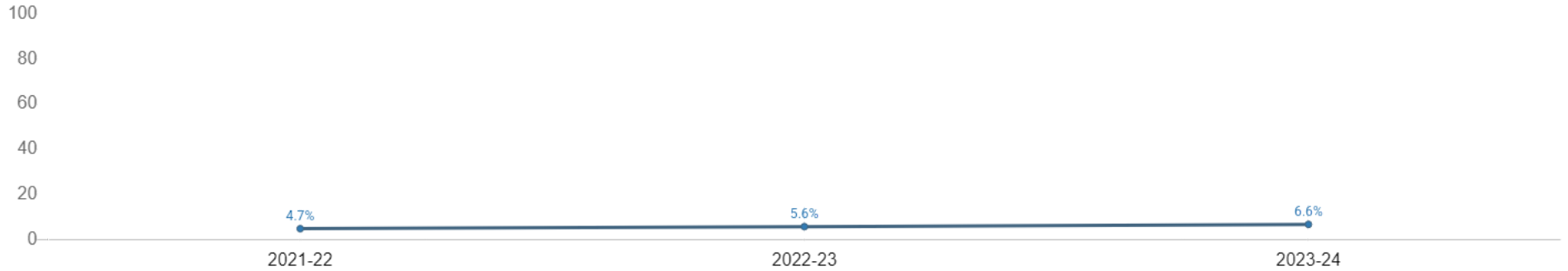

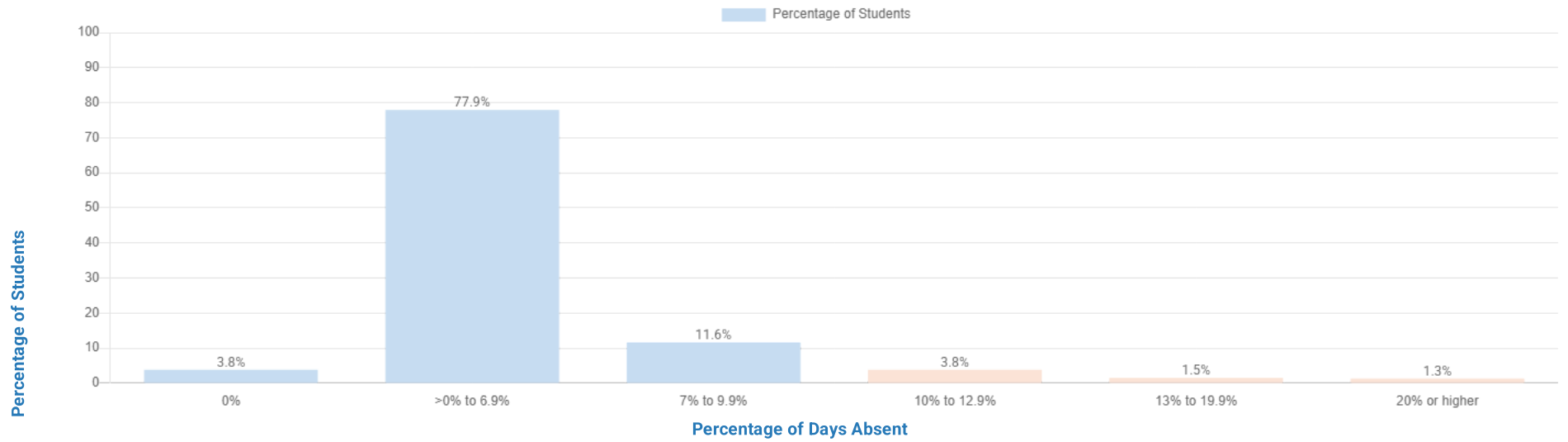

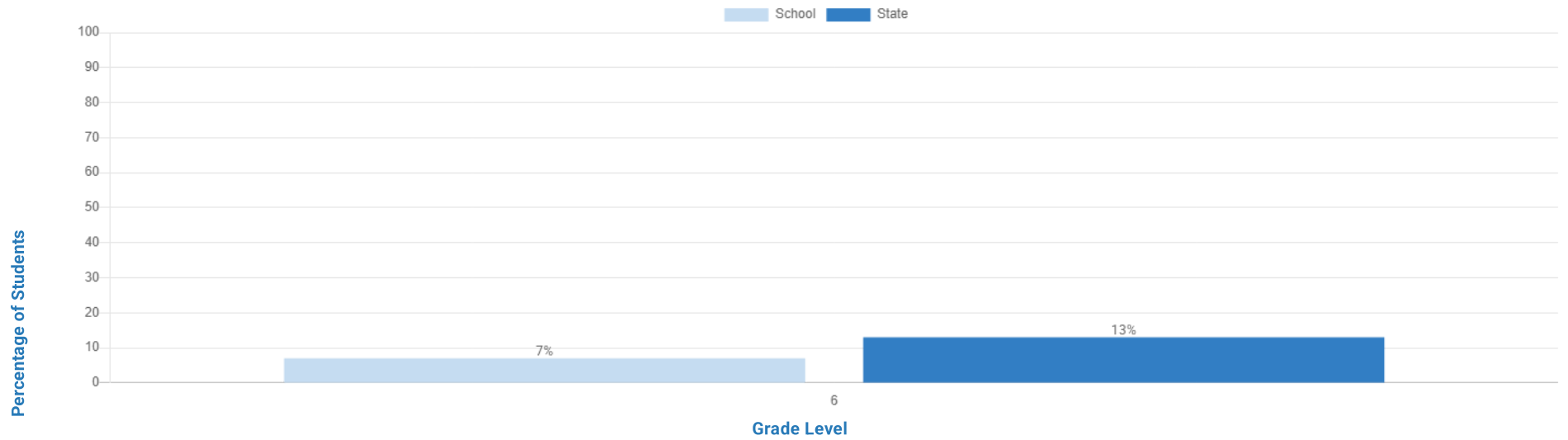

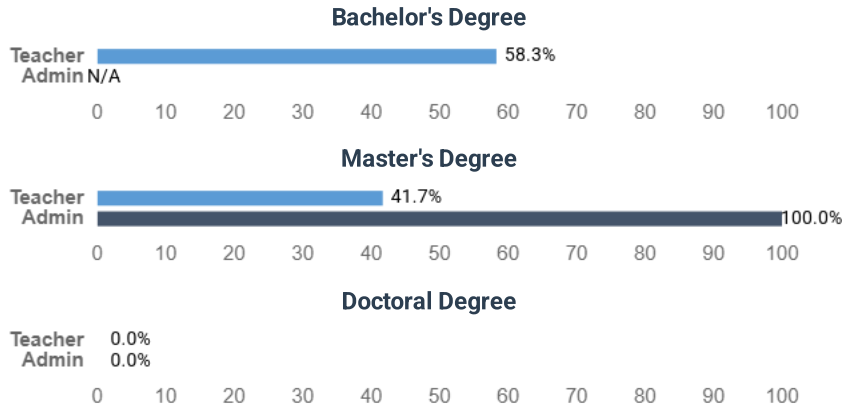

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. ### Courses, Curriculum, Instruction:

Our curriculum aligns to NGSS and NJSLs. Pine Brook offers three levels of math classes: Pre-Algebra A, Pre-Algebra B, and Mathematics 6. Students also have opportunities for enrichment in Language Arts through our With Distinction program. To support our instruction, Pine Brook utilizes Houghton Mifflin Harcourt Collections (2015), Achieve 3000, EnVision 2.0, IXL, Amplify, OpenSci, and Inq-ITS. We also maintain a wide range of District approved online resources to support the implementation of a rigorous sixth grade curriculum.



### Sports and Athletics:

All students are invited to participate in three non-competitive intramural sports activities after school during the year. We offer five week sessions of co-ed basketball, soccer and volleyball.



### Clubs and Activities:

Students can select a multitude of before or after school clubs and activities including, Student Council, Band, Jazz Band, Orchestra, Chorus, Math Club, Garden Club, Homework Club, Pine Brook Television, Young Scientists, Battle of the Books, With Distinction In Language Arts and National History Day.

### Before and After School Programs:

Various academic programs are available before and after school. In Project Achievement, District teachers provide research based, data-driven instruction to students identified as in need of additional support in Language Arts and Mathematics. Additionally, we have a training program for staff in Orton-Gillingham multisensory reading instruction to support students as identified. Pine Brook also offers homework club to students who need support while reinforcing daily lesson objectives.



### Staff and Professional Learning:

Teachers engage in an array of professional development opportunities. All participate in monthly PLC and department meetings and create individualized professional learning plans. Book clubs, independent studies, lesson studies and peer observations are encouraged. Attendance at conferences, including those hosted by Rutgers Literacy Consortium and Model Schools is common. The Science department has participated in a partnership with the RVCC Science Institute. We also offer online learning opportunities through programs such as Mobile Mind. Numerous teachers have become Google certified, presented with the building or District, as well as to surrounding districts, on topics ranging from their use of technology in the classroom to differentiation. Pine Brook continues to grow in its ability to provide 21st learning opportunities to students through teacher self-motivation, District provided support, and utilizing resources beyond the school to ensure our teachers are well equipped.



### Student Supports and Services:

Pine Brook delivers support programs including ESL and Special Education programs as well as related services including: OT, PT, and Speech. Supplemental support services for students include researched-based, targeted, and tiered interventions through RTI for academic, behavioral and wellness support. Weekly team meetings follow a problem solving model. PBSIS, Homework Club, Project Achievement, personalized digital learning programs, and counseling services support the various academic, social, and emotional needs of our students.

### Student Health and Wellness:

Pine Brook provides physical education classes to students twice in a six day cycle for the year and health one time in a six day cycle for the year. We deliver informative presentations on wellness including John Halligan's presentation on bullying and suicide prevention. We host the Monmouth County Sheriff's Department in bringing cybersafety and bullying presentations to our students. Our counselor conducts lessons focusing on esteem building, HIB, stress and time management and runs support groups for students who struggle in these areas. Newly, we have hired a mental health clinician to provide support to identified students.



### Parent and Community Involvement:

Pine Brook maintains a positive relationship with families and the community through the PTA, the District SEPAG, Back to School Night, Conferences, Parent University, and Parent Orientations. Family members are invited to support the financial literacy program available to students through NJ Biztown. Communication regarding student progress is key, so families are encouraged to use Genesis's Parent Portal and to attend team meetings to discuss their child's progress.



### Facilities:

Pine Brook features lockers for each student, two full-size gymnasiums, two acoustically-insulated music rooms, two science labs, a MakerSpace with 3-D Printers, magnetic circuitry, makey-makey, lego construction, engineering, and a video editing lab. Pine Brook also maintains an outdoor garden complete with a greenhouse. ViewSonic or Promethean Boards are located in all classrooms. High-speed internet access is provided through our secure network.

Pine Brook has been acknowledged for its dedication to preparing students for 21st century learning. Pine Brook provides each student with a chromebook and access to Google for Education. Pine Brook offers students daily lessons highlighting various STEM opportunities, ranging from our MakerSpace class, our greenhouse, our virtual reality and augmented reality headsets, and art projects.



### Attendance:

As a district we recognize the importance that attending school ultimately has on student success. A student who is chronically absent is at a greater risk of academic, social and emotional disadvantage when compared to his/her peers. Traditionally speaking, chronically absent students lag behind their peers when it comes to academic achievement and academic growth. In order to prevent chronic absenteeism and comply with state statute, our district implements a policy that includes but is not limited to: parental notification of absences, electronic letters via Genesis, and parent meetings.

Each student is a member of one of five different teams, each of which follows one of three building schedules. In this unique setting, we bring together students from five community-based elementary schools for the first time. We initiate numerous school-wide programs such as Character Education, a PBSIS kickoff, motivational end of year events, and The Week of Respect, to support team building activities that provide students with various effective means of working out conflicts, overcoming peer pressure, and developing a strong sense of community.
