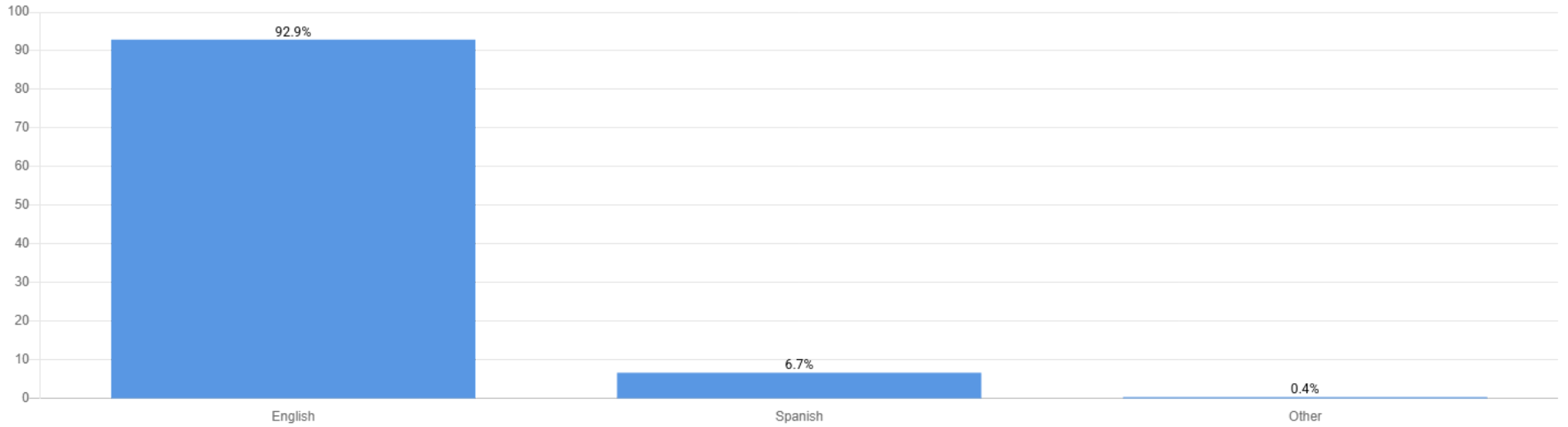

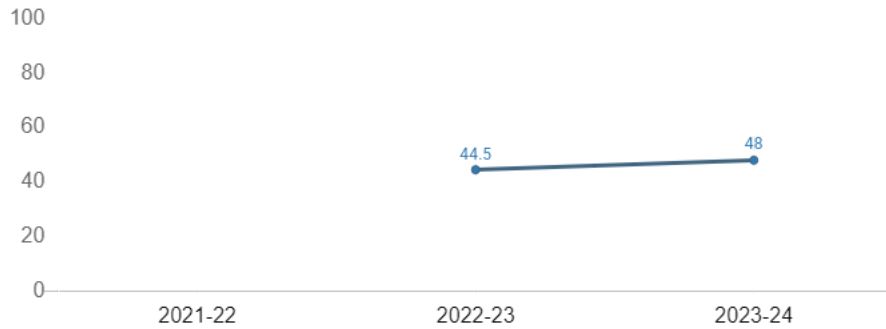

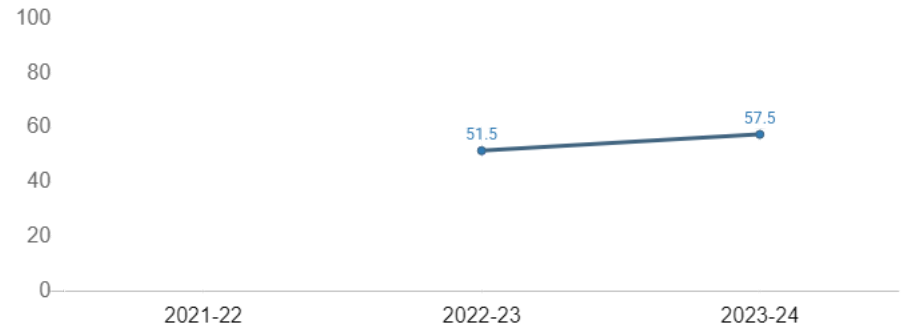

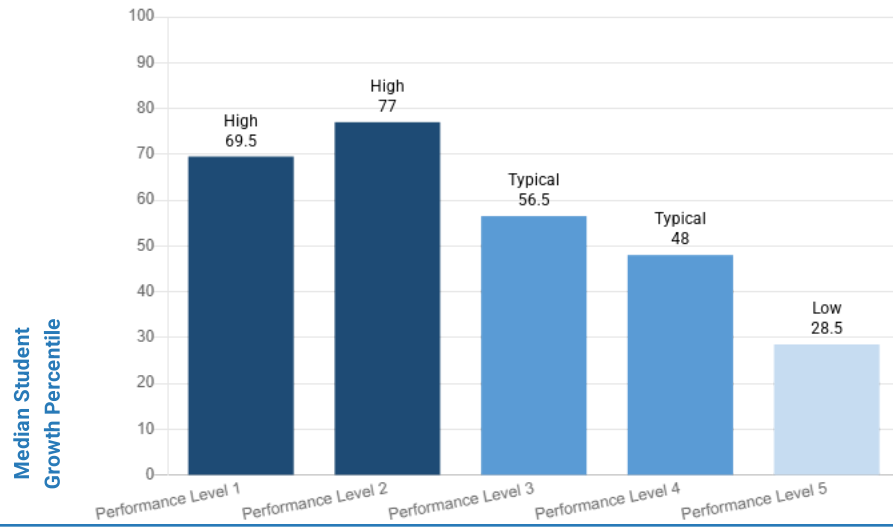

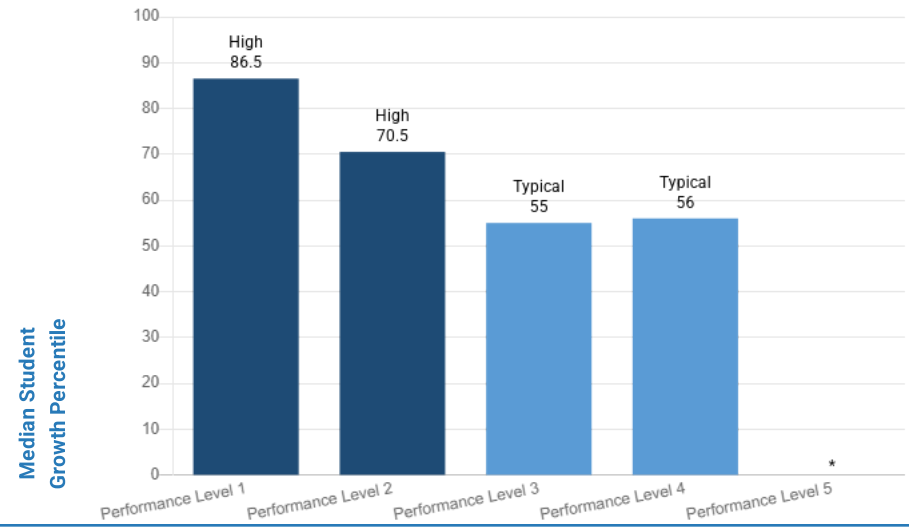

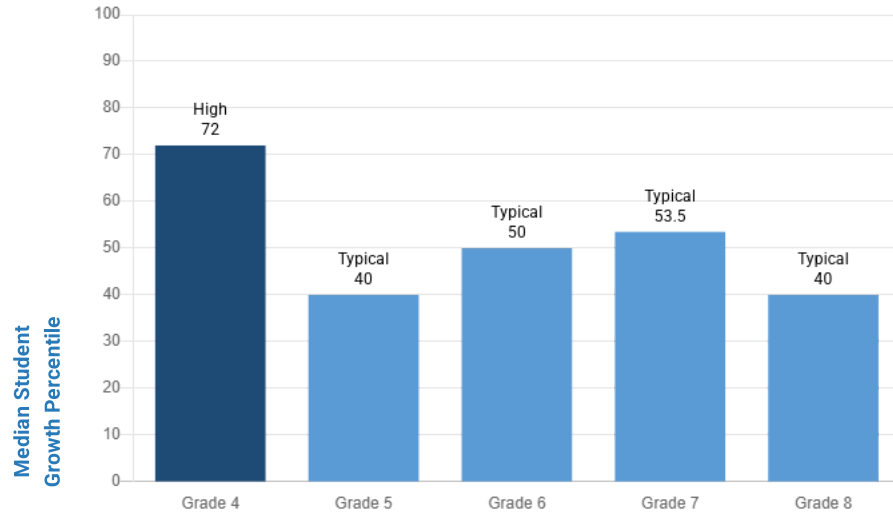

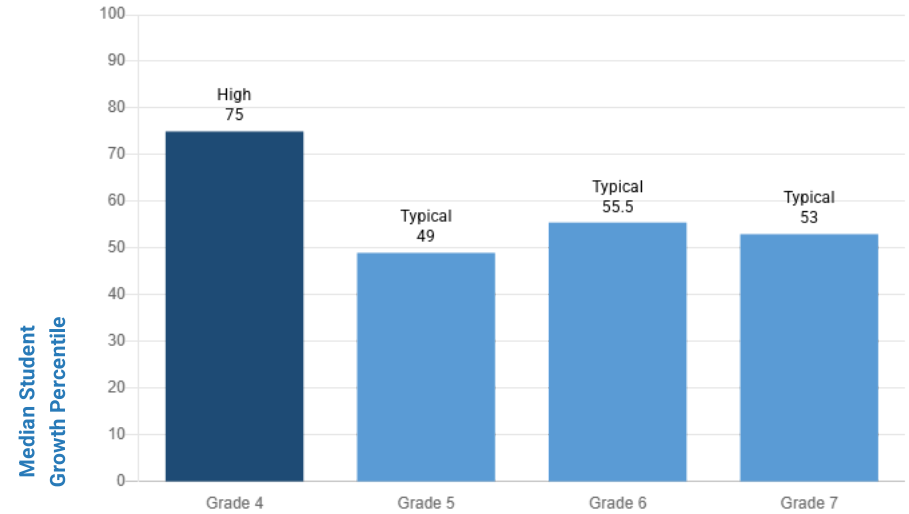

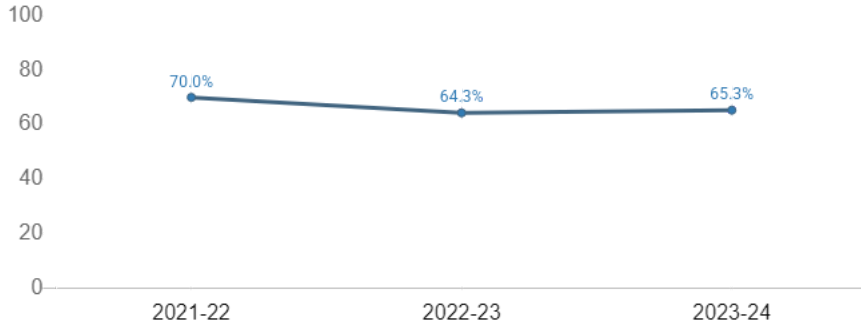

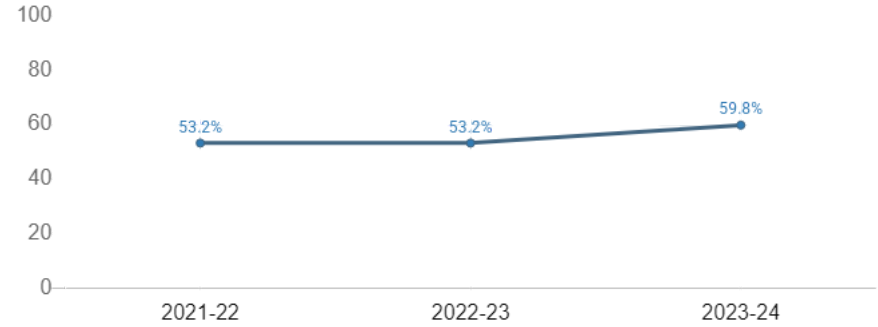
English Language Arts and Mathematics Performance Trends

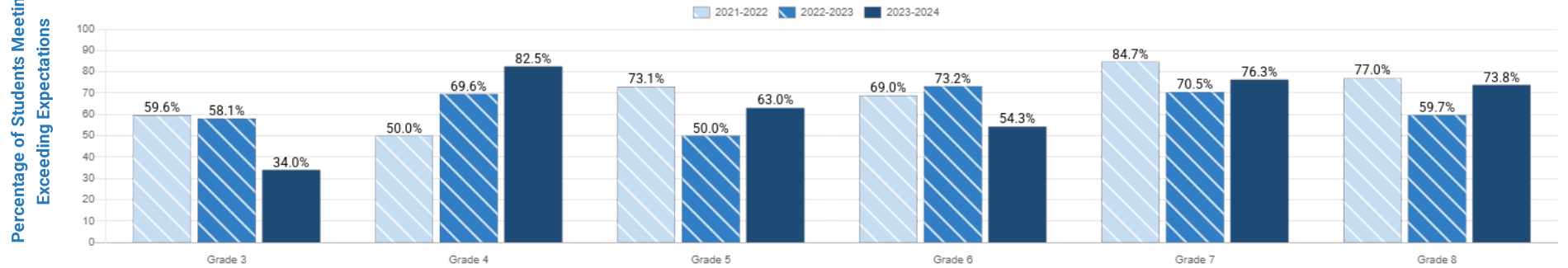

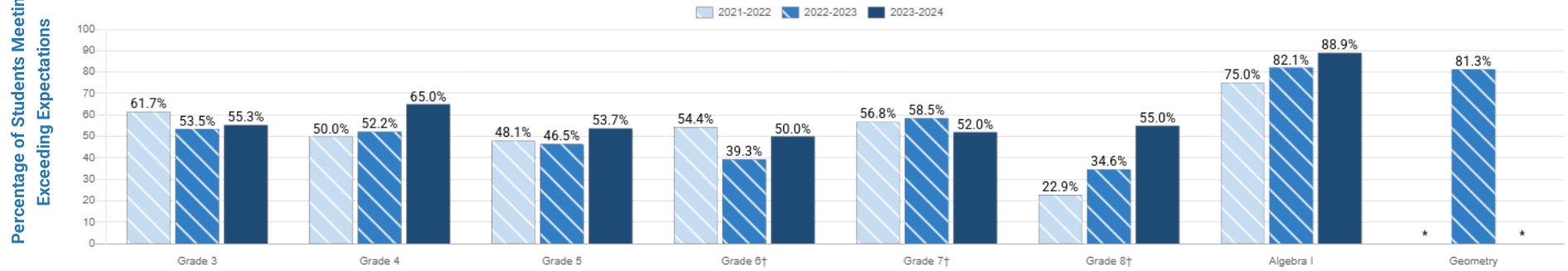

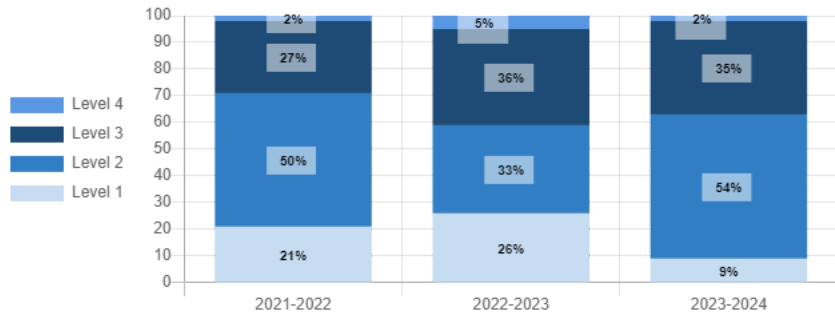

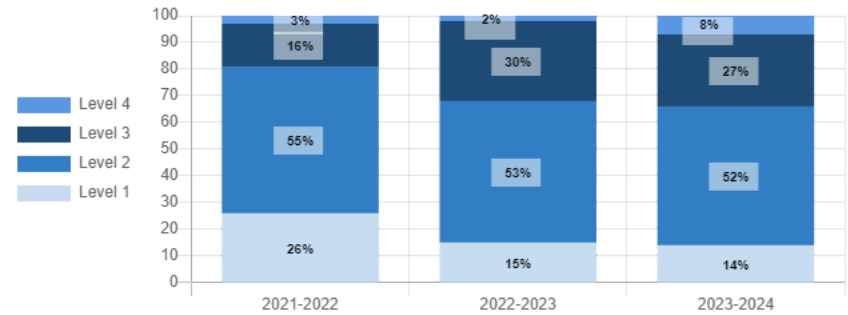

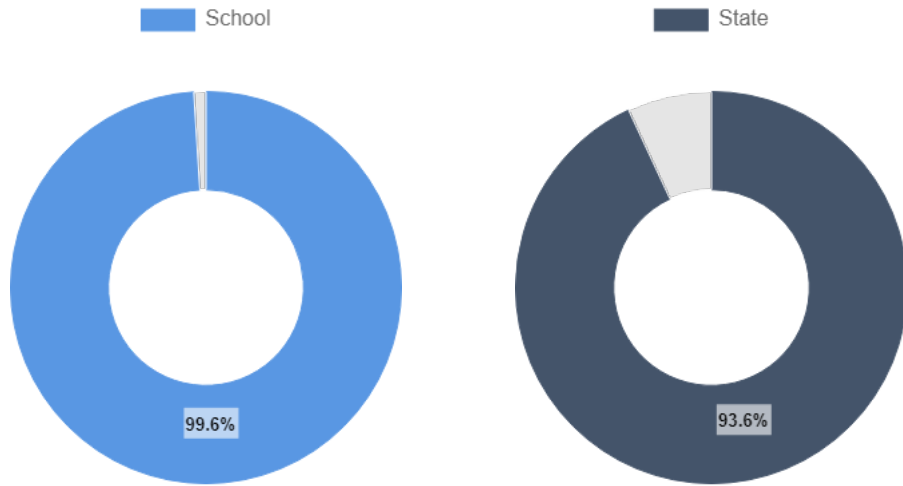

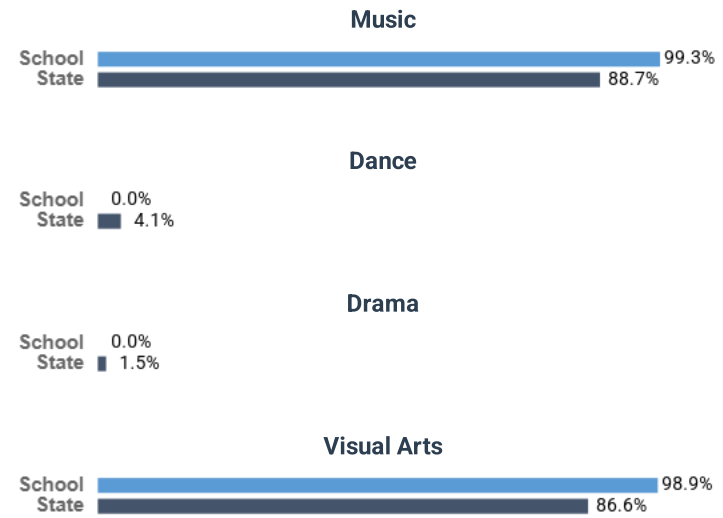

Students enrolled in one or more classes by discipline:



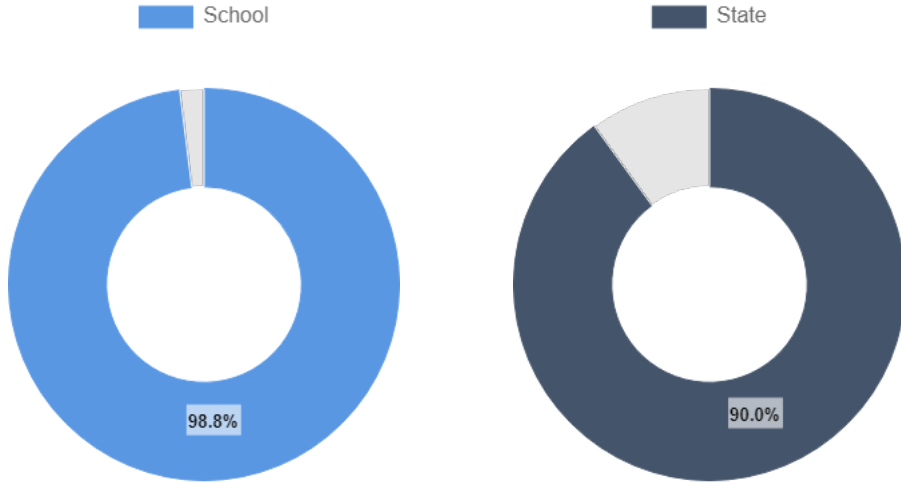

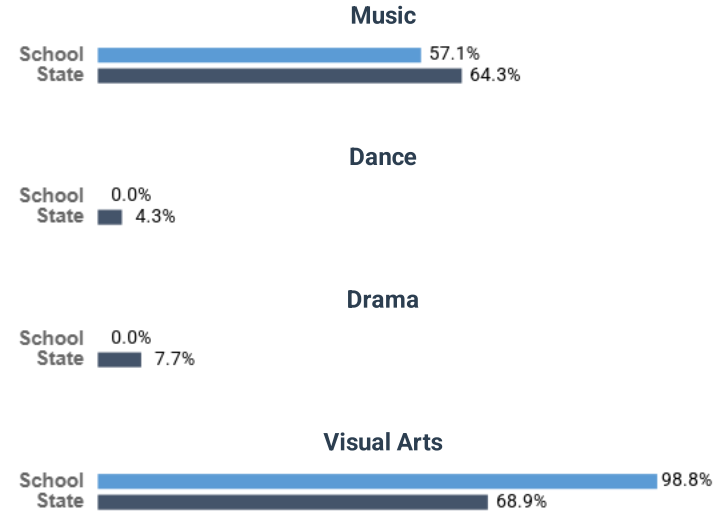

Students enrolled in one or more classes by discipline:



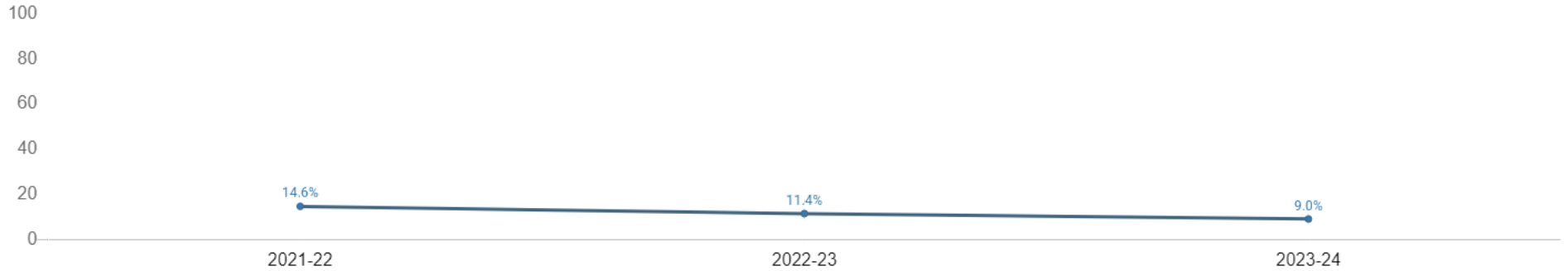
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 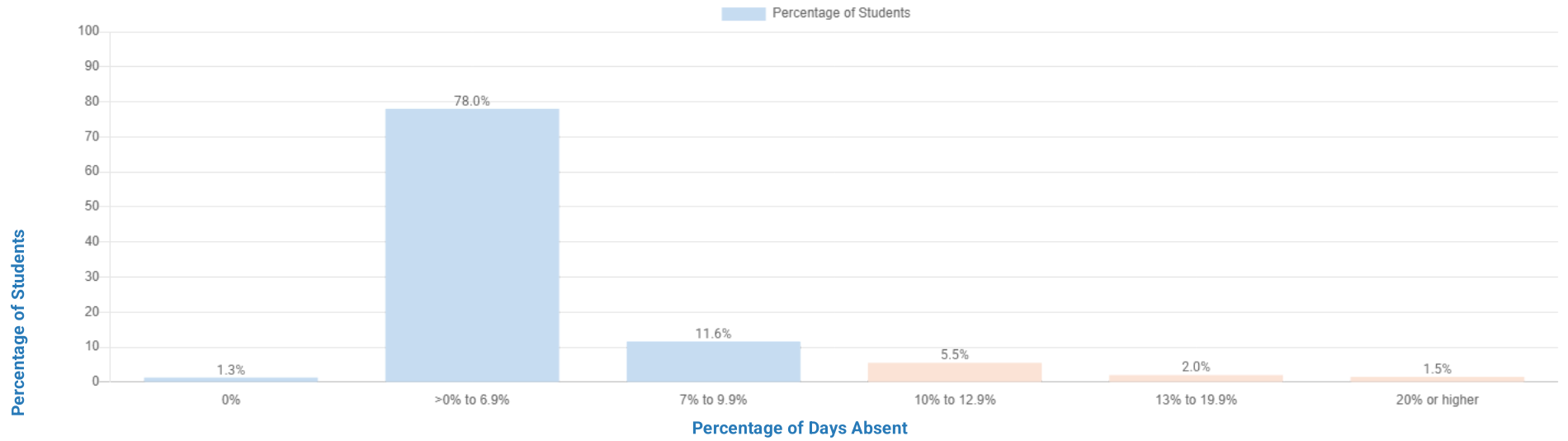

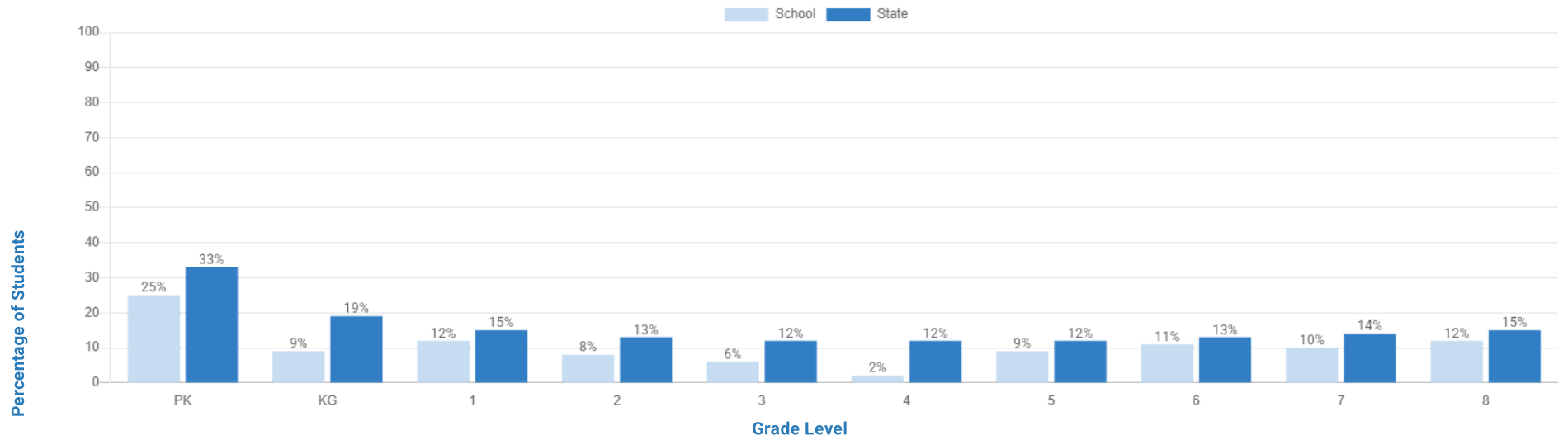

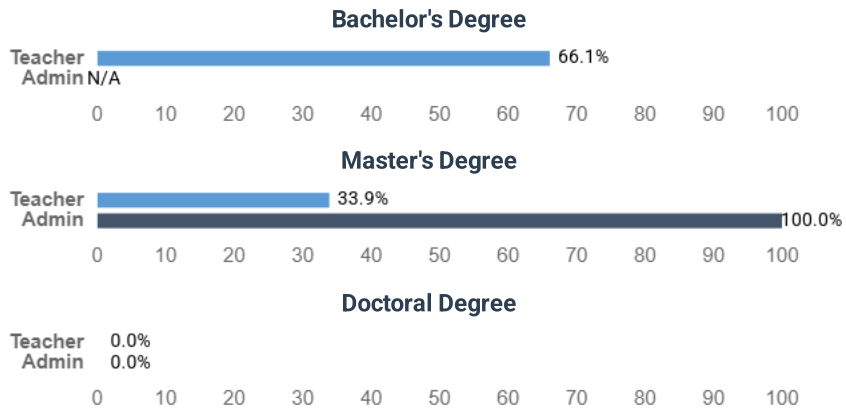

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. All curricula are aligned to the NJSLs. The literacy program is well-rounded, focusing on phonics with Wilson Foundations and the Geodes readers, as well as Wit and Wisdom for comprehension, vocabulary, background knowledge, and writing. STEM Education is across all grade levels, aligned to the Next Generation Science Standards via SAVVAS curriculum. World language instruction is taught in Spanish and French. Major subject area Honors classes are available in Grades 7 & 8. High school level Algebra & Geometry classes are available for identified 7th & 8th graders. In addition, the school has a Gifted and Talented program where students can be identified K-8 as Humanities, STEM, and/or visual arts.

Middle school students in Grades 6-8 have the opportunity to participate in a wide variety of athletic teams, including: Baseball, Basketball (Boys & Girls), Cross-Country (Boys & Girls), Cheerleading, Field Hockey, Soccer (Boys & Girls), Softball, Tennis (Boys & Girls), Spring Track and Field (Boys & Girls), and a Sending District Wrestling Team. Our school also partners with the community-based Recreation Program to offer our elementary and middle school students a variety of athletic opportunities throughout the school year in baseball, softball, basketball, flag football, dance, pickleball, bowling, and tennis.

Staff and Professional Learning:

Through quality professional development, our educators increased their effectiveness to promote high achievement. PLC meetings are held weekly and grade level/department meetings are held once every month for on-going communication and collaboration. K-8 teachers participated in ongoing ReadyMath training on curriculum and assessment tools. K-5 teachers also completed workshops on Geodes and Wit and Wisdom, which are part of the new literacy curriculum. Representative K-8 teachers have participated in training on sheltered instruction to support English Language Learners. Our K-8 teachers continued their collaborative content-specific professional development sessions with sending districts focusing on tiered interventions and differentiated instruction, technology tools, and enhancing content knowledge. A summer program with lead teachers and monthly articulation meetings introduced novice teachers to the school's culture, policies and procedures, as well as instructional pr



Student Supports and Services:

Our Child Study Team and Intervention & Referral Services Team collaborate to meet the needs of students experiencing learning, social, and/or behavioral issues. A full-time and part-time BCBA provide additional support and develop plans in collaboration with teaching staff. Teachers provide extra help for their individual students. A Peer Leader Program allows for peer tutoring to provide students with academic support and social interventions. Homework Club, which takes place after school, is available for additional assistance in students' classroom studies. Support services for students are also available for our English Language Learners, as well as support for their families, via our ELL school counselor who also provides translation assistance.

Student Health and Wellness:

The importance of fitness in our daily lives is promoted in our Physical Education and Health classes. Students also enjoy physical fitness during their daily recess times or as part of one of our many athletic teams. Students in grades 5-8 may opt to take an SEL course as their elective. In addition, mindfulness lessons are integrated throughout the grade levels. We have a Mindful Garden in the school that classes can visit, as well as staff members providing lessons on yoga, breathing techniques, and other calming and focusing strategies. School counselors meet with students on a regular basis to provide additional support or scheduled counseling depending on need.



Parent and Community Involvement:

Our PTO remains very active, organizing events such as a Book Fair, Science Fair, an Organic Garden, an Art Appreciation Program, and after-school enrichment activities. A variety of parent workshops on relevant topics are organized through our Guidance Department. A Special Education Parent Advisory Group and an ELL Parent Advisory Group are both active. Our students participate in local field trips to community businesses and organizations.

Facilities:

Our school includes three computer labs, an Art Studio, Music Suite, two gymnasiums, two science labs & a Media Center. The Media Center includes a fully equipped STEM Lab. One preK-4 cafeteria is utilized and a second multi-purpose cafeterium is used for Gr 5-8 lunches, basketball games, school events & performances. All areas of the building are air-conditioned. Two outdoor classroom areas have been created, as well as an outdoor amphitheater area. Athletic fields, a primary playground, a middle school playground, and a preschool playground area are all in place. Our community recently voted to pass a referendum which will result in upgrades to many of our existing facilities. This will include classroom renovations in addition to playground and HVAC equipment updates.



School Safety:

Our building includes a security vestibule where visitors are screened using the LobbyGuard Management System before being allowed to enter. All visitors and substitute teachers are required to wear a designated badge. All doors throughout the building remain locked during the school day. A District Security Officer is in place for an ongoing review of safety plans and procedures. All staff members are trained at the beginning of the school year on the proper implementation of our security plans, including all lockdown and evacuation procedures. On-going safety reviews occur regularly at every monthly faculty meeting.



Technology and STEM:

Inquiry-based STEM projects that employ the Engineering Design Process aligned with the NGSS are integrated into all K-8 curricula. Such projects are completed in our ActivBoard-equipped classrooms or in our STEM Lab, which houses iPads, tablets, 3D printers, coding and robotic programs, as well as makerspace materials. In addition to all K-8 students being enrolled in a technology course, elective classes in Podcasting, Multimedia Literacy, App Creation, and Medical Detectives are available to middle school students. Among the areas of emphasis in these courses are planning of content and visuals along with production and publishing by using current technological tools. These courses are supplemented by clubs in video production, as well as PTO-provided STEM enrichment opportunities. Our 1:1 technology program provides grades 5-8 students with Dell touch-screen laptops. Classrooms for PreK through grade 4 each have dedicated laptop carts.

Early Childhood Education:

Our school offers an integrated preschool program that includes preschoolers with disabilities, identified by the Child Study Team, attending programming with typical preschoolers who make application & pay tuition to attend. The district offers a 3 year old and 4 year old preschool program. Both programs utilize the Tools of the Mind curriculum. Tools of the Mind is a comprehensive, research-based curriculum based upon a specific set of beliefs about how children develop & learn. The purpose of this curriculum is to support the development of cognitive & social-emotional regulation, areas that have been found to have a stronger association with school readiness than IQ or entry-level reading or math skills. Embedded in our integrated preschool program are speech, occupational therapy, & adaptive physical education classes. These classes are provided weekly to supplement the strong academic program being provided.



Attendance:

Attendance is a priority for the school administration. Regular attendance reviews and communication with families regarding attendance issues allows the school to problem-solve and support families. This helps to ensure that students are in attendance on a regular basis, as this regular attendance is critical to student academic and social success.
