




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 
















Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. - MRHS introduced The Husky Prep Academy for incoming 9th grade students to assist in providing a safe and supportive environment for a successful transition to high school.
- MRHS collaborates with Rutgers University and NJDOE on the Enhancing School Mental Health Services Project to implement a comprehensive mental health system of support at the high school level.

The mission of the Matawan Aberdeen Regional School District is to foster a safe and equitable learning environment that celebrates our diverse learners and provides the necessary resources and supports to prioritize the social-emotional and academic development of all students. Students will become life-long learners, critical thinkers, and creative problem solvers who achieve success as valuable and contributing members of society.



Awards, Recognition, Accomplishments:

The Matawan Regional High School's Student Equity Team were the recipients of the Social Justice Award from Monmouth Universities Central Jersey Consortium for Excellence in Education. There were 156 students that received the President Education Award for Educational Excellence, 51 students received the President's Award for Educational Achievement and 37 students who achieved High Honor Roll Status for all 4 marking periods in the graduating class. Additionally, 11 students graduated with an Associates Degree from Brookdale Community College through the Husky Early College Academy and 7 students graduated with over 30 credits towards their Associates Degree in the Husky Middle College Academy. At our Senior recognition assembly, approximately 50 local scholarships were awarded totaling over sixty thousand dollars and our UNIFIED/ Special Olympics Team won the State Championship in Bowling.

MRHS offers the most rigorous academic courses while providing opportunities for all students to excel in diverse areas of our curriculum. We are committed to enhancing our curriculum offerings, implementing innovative programs and fortifying our school community partnership. MRHS offers 17 Advanced Placement Courses in addition to Honors Level and Dual Enrollment opportunities with local colleges/universities. Students are afforded the opportunity to select classes based on their future educational/career goals, graduation requirements, and areas for the exploration and development of special talents and interests. Teachers work collaboratively with administrators and specialists to revise curriculum, create new courses, and enhance existing units of study to foster higher levels of student learning across all levels and content areas. Curriculum is aligned to the New Jersey Student Learning Standards and is housed in Rubicon Atlas, a curriculum database for the district.

Before and After School Programs:

MRHS offers after school tutorial in academic subjects such as mathematics, language arts, biology, chemistry, physics and social studies. These subjects based tutorials are taught by high school faculty. Faculty recommends the program to students and parents and counselors monitor students attendance and participate during the tutorial sessions. Tutorials are available to all students in 9th through 12th grade.



Staff and Professional Learning:

All staff are afforded opportunities to engage in ongoing professional learning through district in-service days, as well as through monthly faculty and department meetings, peer-to-peer learning, and embedded coaching to grow and develop professionally, acquire new resources, and refine instructional practices. The MRHS staff participate in three full days of professional learning which are facilitated by high school staff members. Our School Improvement Committee, along with the high school administration, develops the learning opportunities for professional days. Faculty who engage in professional learning through outside workshops are encouraged to turnkey information to the staff for professional learning.



Postsecondary Information:

72% of the Class of 2024 attends a 2 or 4 year college. Financial Aid Night is presented to juniors to assist in the FAFSA application process. In addition, MRHS offers multiple "College Application Process" evening sessions to assist students with securing financial aid, ensuring that application packets are complete, and utilizing Naviance as a communication conduit with colleges. An SAT Prep Course is offered in the spring and fall to students at a reduced cost. Students not attending college after graduation chose the military or employment. Lastly, we have forged partnerships with local trades and bring them in for information sessions to work with students who are interested in entering the workforce immediately after graduation.

Student Supports and Services:

Counseling, intervention, and integrated social-emotional learning and mental health support services are in place to assist and support students. Additional Support Classes are offered at MRHS for all English Language Learners. The district is offering free ESL classes for families along with translators. MRHS offers Intervention and Referral Services, 504, CST for students struggling with learning, behavior, or health difficulties. The Effective School Solution (ESS) program has been initiated. An after-school subject-based tutorial program is available to all students.



Student Health and Wellness:

Prevention presentations and trainings are offered to students and school community focused on safety, healthy choices, county resources, and prescription medication prevention, all of which provides a holistic approach to health and wellness. Each grade level is receiving education on the dangers of vaping and e-cigarettes, as well as, staff and community members. Staff is receiving mental health and suicide training to assist students with mental health needs, along with the 9th and 11th grades participation in Lifelines training through physical education classes. Continued collaboration with outside resources to promote health, wellness, and safety of the school community by providing referrals, as needed. The 9th grade class is scheduled to receive CPR training. Breakfast and lunch are available for all students and is provided for students who qualify for free or reduced meals.



Parent and Community Involvement:

The MRHS PTO was re-established during the 2023-2024 school year with membership open to all families including our dedicated staff. The MRHS PTO is involved in fundraising activities that help foster a positive school climate and assist our student body in community projects. The MARSD Special Education Parent Advisory Group is an active group working closely with the district to advocate and support students and programs within our special education community. Additionally, community partnerships with NJ4S, Effective School Solutions, The Tigger Stavola Foundation and the Community YMCA have afforded us the opportunity to conduct parent training sessions on various topics throughout the year. The Matawan Aberdeen Regional School District also introduced MARSD Cares, a volunteer organization that works to support families in need within the community.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The School Safety Team, School Climate Committee and Equity Team meet regularly to discuss the climate and culture for students, staff, and the Matawan Regional High School community. Additionally, the new Principal's Student Advisory Group (P-SAG) meets monthly, providing students an opportunity to participate in school wide initiatives. School climate data is used to guide decision-making regarding student and staff supports, programs, and training.



Facilities:

Matawan Regional High School was constructed and opened in 1962. The building has gone through several renovations and building projects. Recently the Main Gym, Cafeteria and classrooms were updated to include a new HVAC system. The exterior was updated with a paver patio in the area adjacent to the cafeteria for students to access during their lunch period. Classrooms have been equipped with promethean boards, computer projectors, and chromebook carts allowing all students to have access in each of their classrooms throughout the day. Our athletic facilities include a full sized gymnasium, a strength and conditioning training center, a dance studio, a multi-purpose turf field, a 400 meter track, multiple track and field event areas, two regulation sized baseball fields, two regulation size softball fields, an additional multi-purpose grass field, 5 tennis courts and a storage/concession building.



School Safety:

Safety and security of the students and staff of Matawan High School is our #1 priority. In addition to the state-required security drills each month, school administration works closely with local police departments to conduct security walkthroughs throughout the year. The building is equipped with surveillance cameras that enable staff to monitor the interior hallways and exterior grounds. The district employs security staff that monitor the building during the school day and all visitors are subject to screening and must enter through a security vestibule during the day. The district has an agreement with the Aberdeen Police Department to provide a School Resource Officer who is stationed at the high school. Building administrators, security staff and SRO have hand-held radios to communicate. Each classroom door has a security magnet that allows the door to remain locked for immediate closing. Security procedures are reviewed with students and staff routinely throughout the year.

Technology and STEM:

MRHS offers a STEM Academy which includes advanced science courses such as Molecular Cell Biology and Engineering. Additionally, higher-level math and computer science courses include Multivariable Calculus, AP Computer Science A, and AP Computer Science Principles. Students at MRHS are issued their own Chromebook as incoming 9th graders and have access during their time at the high school. All math classrooms are equipped with a Promethean board. MARSD also established Technology Support Lead positions in each school. This staff member has the important responsibility of providing ongoing and embedded professional development and support for school staff.



Attendance:

The MRHS CORE Team, made up of the School Counselor and Child Study Team members work closely with building/district administration to combat chronic absenteeism. The team works to identify at-risk students and engage families in an effort to eliminate barriers, collaborate on solutions and provide support for families. The tracking of daily attendance coupled with student check-ins and bi-monthly team meetings work to identify students at-risk of losing credits due to excessive absenteeism. In-home visits are conducted with the assistance of the district SRO as necessary and an Attendance Review Committee has been established to assist with developing attendance contracts and tracking student progress and performance.
