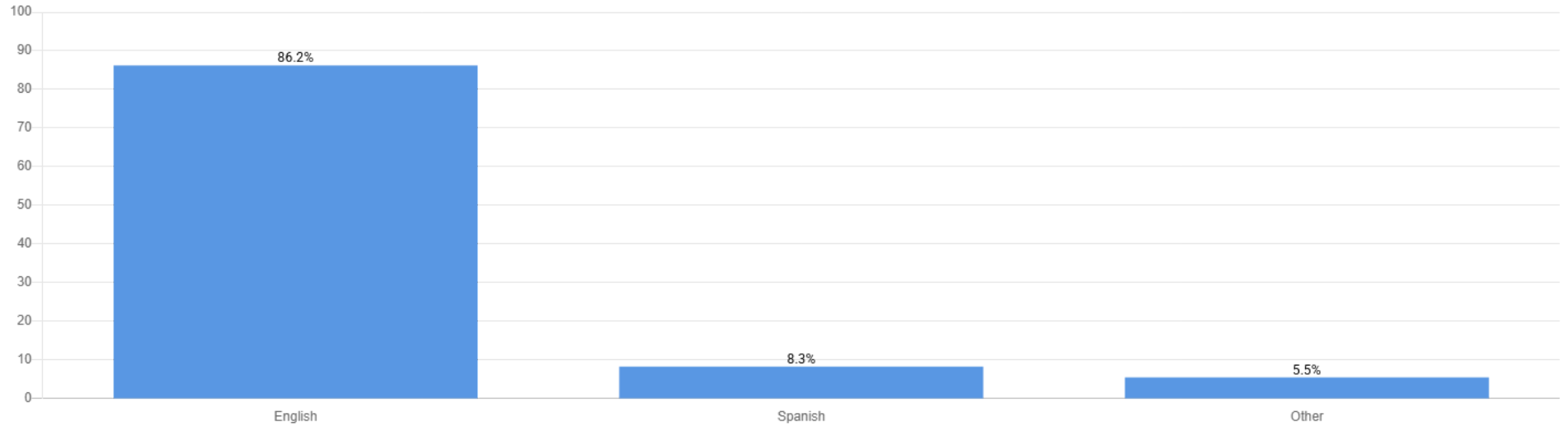

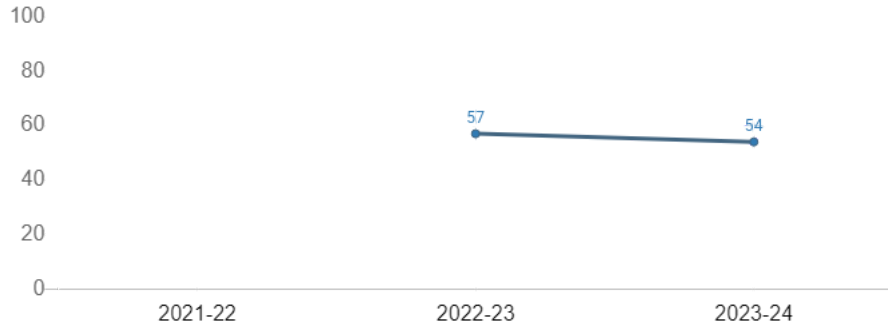

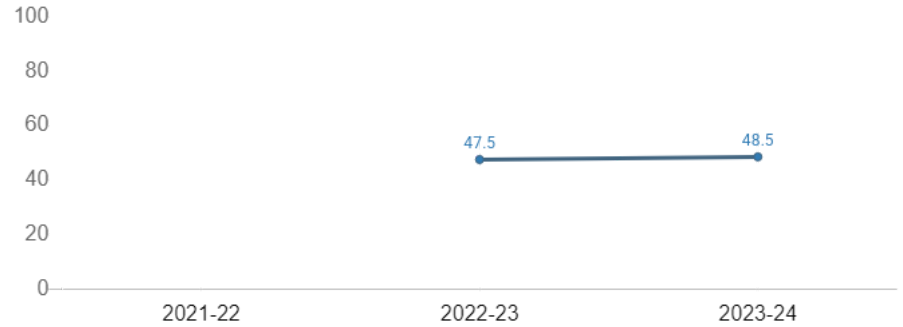

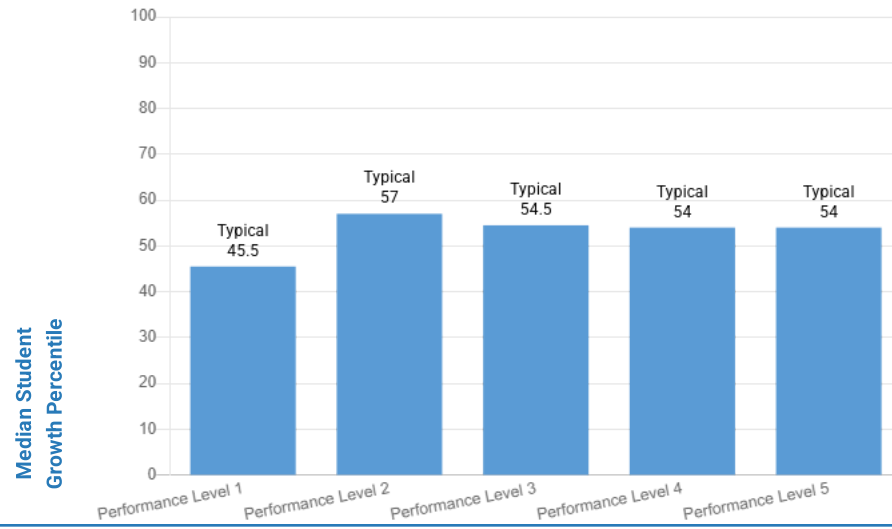

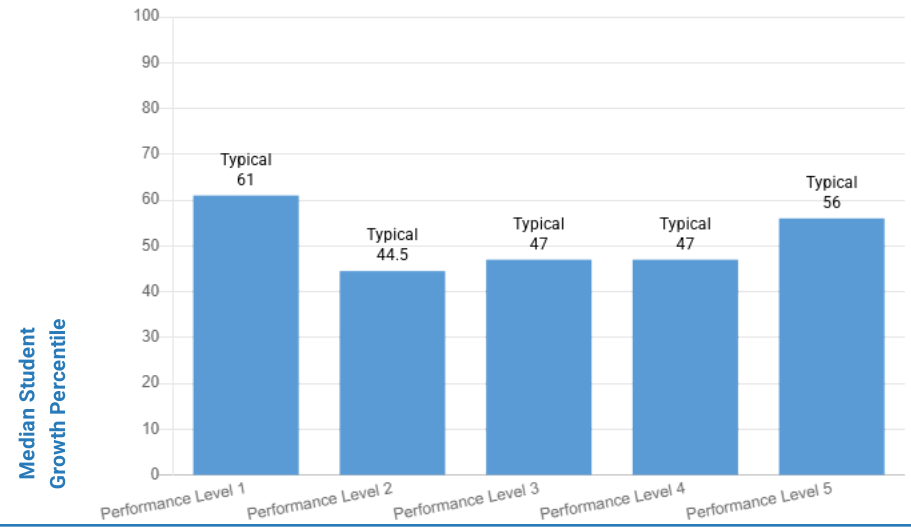

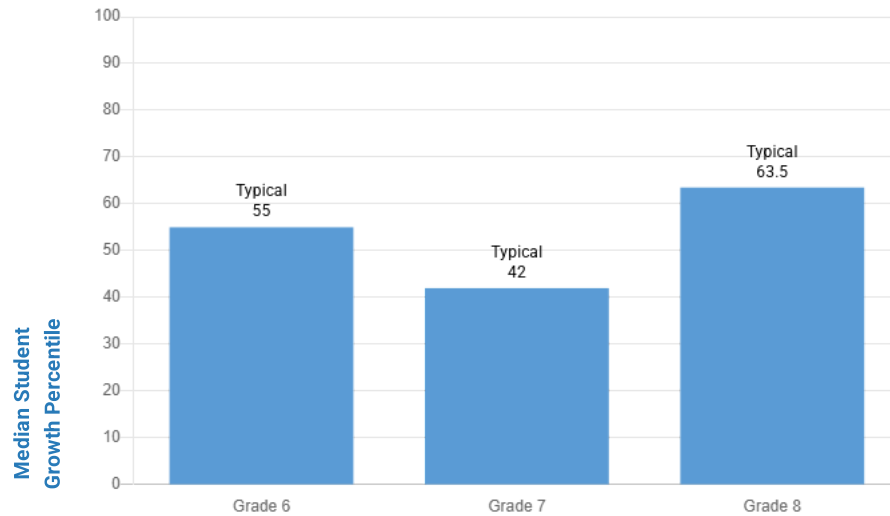

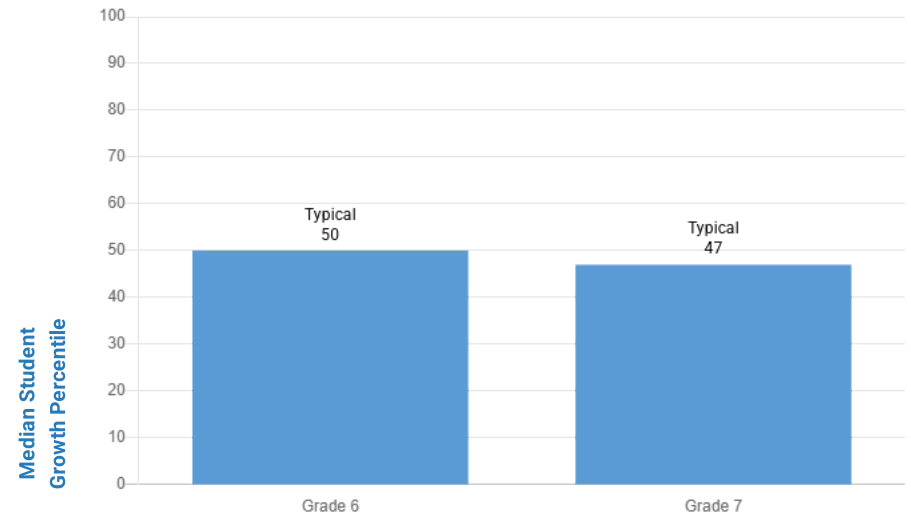

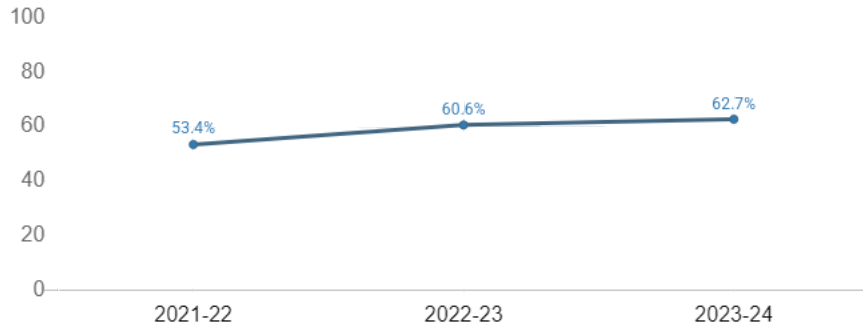

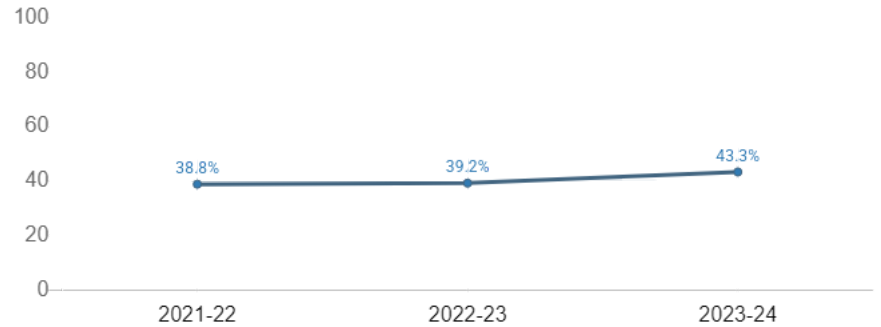
### English Language Arts and Mathematics Performance Trends

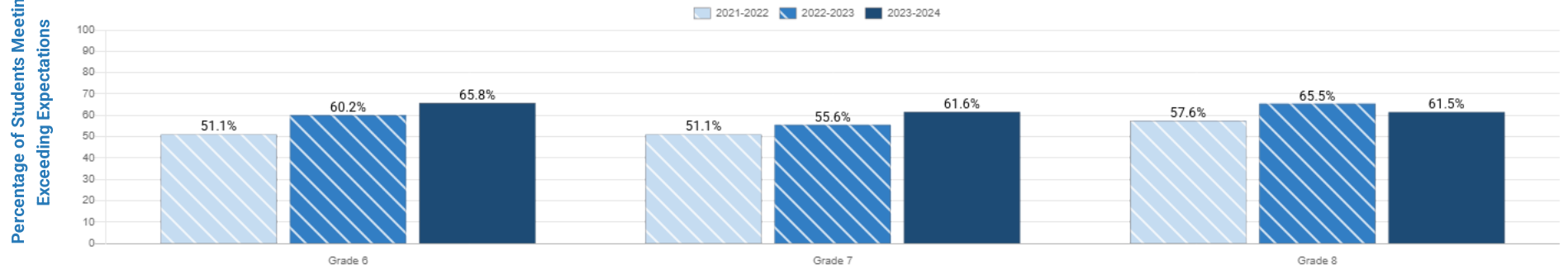

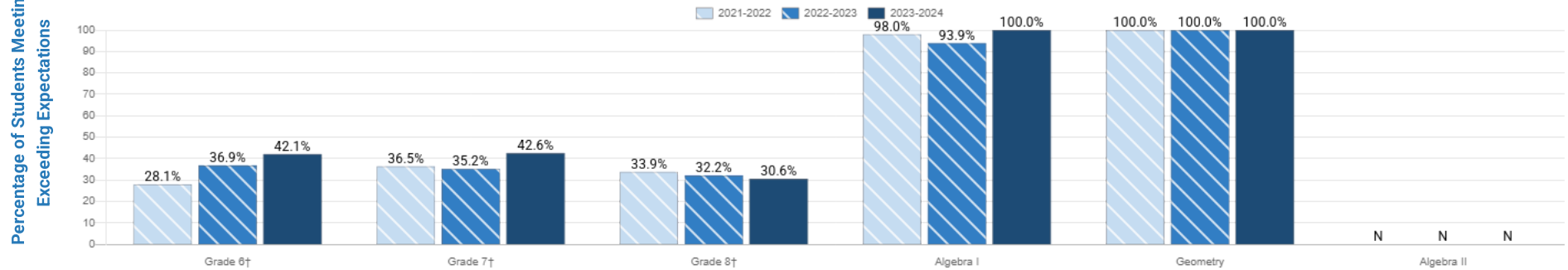

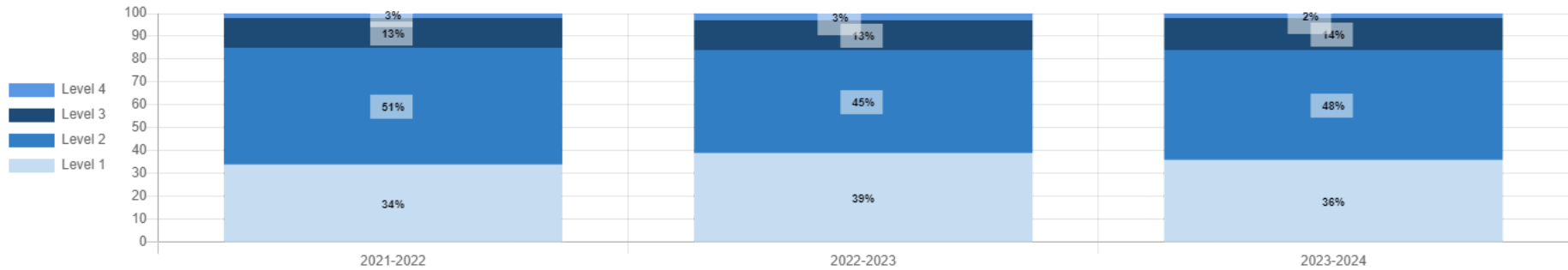

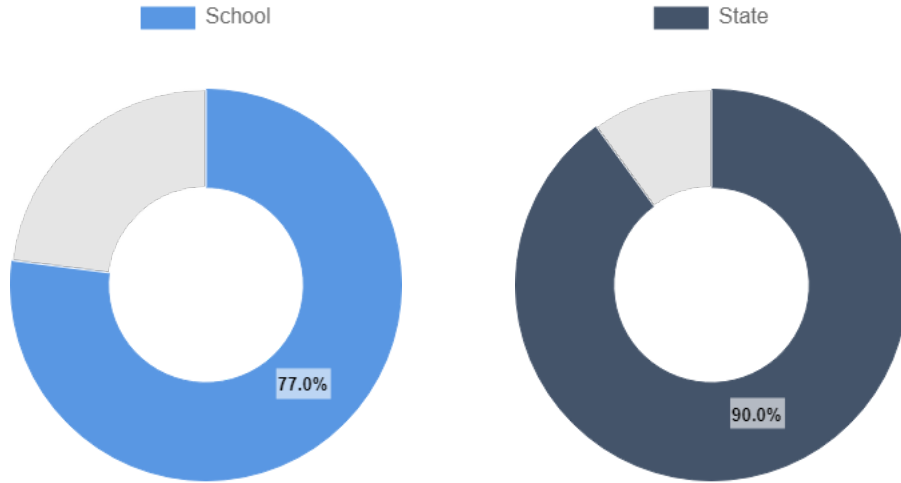

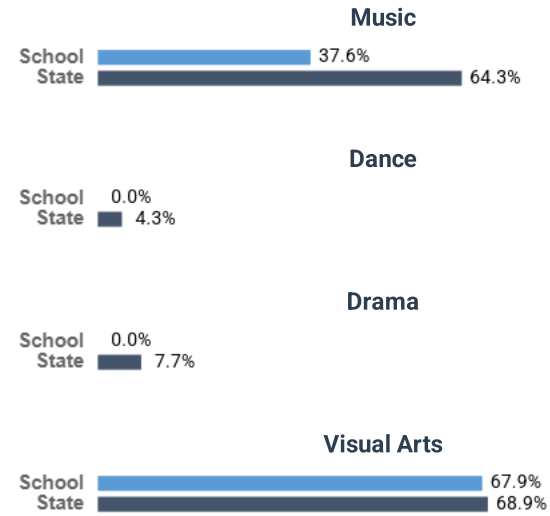

**Students enrolled in one or more classes by discipline:**



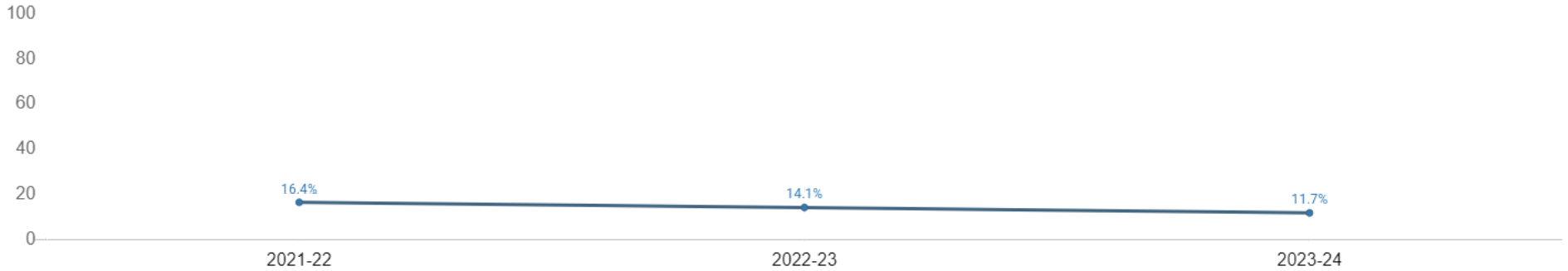

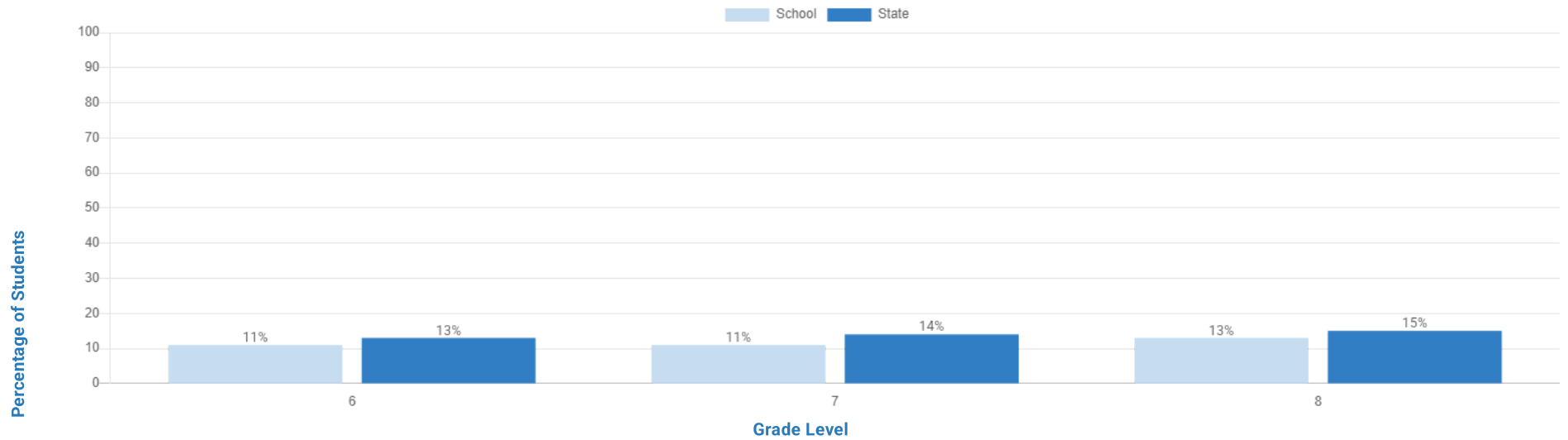

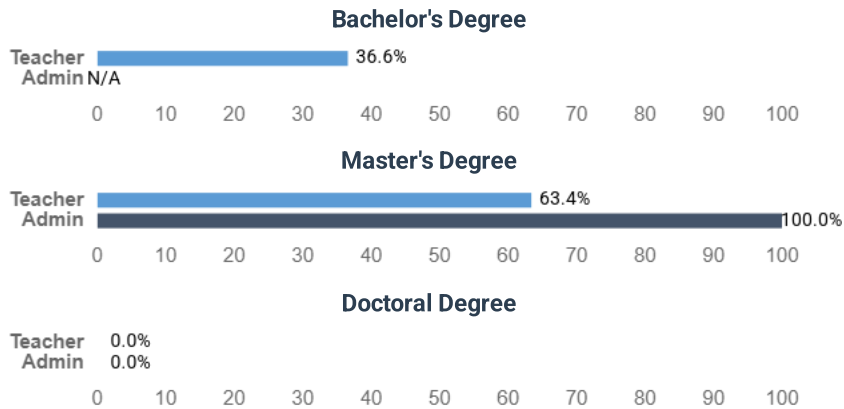

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. In addition to traditional athletic programs, MAMS offers students the opportunity to participate in intramural basketball, floor hockey, volleyball, bowling, and flag football. Students with disabilities have the opportunity to compete on the MARSD Challenger teams in both regional and state competitions for Special Olympics. MAMS also received a \$60,000 grant from Special Olympics of New Jersey to assist with building an Esports program.



### Clubs and Activities:

MAMS offers students many extracurricular clubs and activities. Some of the include: Intramural sports, Academic Bowl, Art Club, African-American Student Union, Band, Chorus, Chess Club, Environmental Club, Literacy Arts Magazine, Math Club, Multicultural Club, National Junior Honor Society, Peer Buddies, Peer Leadership (Dylan's Wings of Change), Safe Space, Student Council, School Newspaper, Science Competition Team, Technology Club, Spring Musical, Summer Theater, Speech and Debate, Yearbook, and Student Equity Team. Students are encouraged to participate in after-school programs and the district provides transportation for all students who stay after school.

### Before and After School Programs:

MAMS offers several after-school programs that provide students with academic, behavioral, and social/emotional support. The M.O.S.T. (Mentoring Our Students Together) program supports students in all subject areas and includes a counseling component and partnership with high school students who work alongside our students (while the high schoolers earn community service hours). The district also offers a comprehensive array of social-emotional, mental health, and wellness services to address the needs of our students.



### Staff and Professional Learning:

All staff are afforded opportunities to engage in ongoing professional learning through district in-service days, as well as through monthly faculty and department meetings, peer-to-peer learning, and embedded coaching to grow and develop professionally, acquire new resources, and refine instructional practices. Staff are also encouraged to participate in trainings offered outside of the district which are then "turn-keyed" during monthly department meetings.



### Student Supports and Services:

MAMS has school counselors at each grade level. Counselors serve as Anti-Bullying Specialists too. The Child Study Team includes two school psychologists, a learning disabilities teacher consultant (LDTC), and a school social worker. MAMS is partnered with Effective School Solutions (ESS) to offer counseling and wraparound services for students. The YMCA provides additional social and emotional support for students. The Intervention and Referral Services (I&RS) team works to provide strategies and resources to teachers to support their students. ESL services and supports are offered to identified students.

MAMS students start their day with an Advisory period. Students may obtain breakfast during Advisory so that all students are well-nourished to start their school day. Students participate in Health/Physical Education every other day and focus on lifelong fitness and establishing a healthy lifestyle.



### Parent and Community Involvement:

MAMS PTSO meets each month and holds numerous programs throughout the year to benefit both students and staff. The PTSO provides assemblies and extracurricular programs for all students that exist outside of the traditional budget process. Additionally, our dedicated staff members have the opportunity to apply for grants through the Matawan-Aberdeen Educational Foundation. This support creates opportunities to have special programs and new technology equipment to be purchased for student use. The district has established a Parent University which offers programs throughout the year on various topics to support students and their families.

MAMS utilizes a "pod" organizational system with grade levels housed separately from each other. This allows for students' classes to be in close proximity to each other. Recent facility upgrades include enhancements to the Life Skills room as well as upgrades to the main gymnasium and media center.



### School Safety:

In addition to the State-required security drills each month, the school administration works closely with local Police Departments and the district Student Resource Officer. Administrators and police conduct security walkthroughs of the campus on a regular basis. Additionally, the school visitor policy has been updated and all visitors must enter through a security vestibule where their identification is verified with a security database before access is granted into the school building.



### Technology and STEM:

MAMS offers STEAM classes, a STEM afterschool club, Esports team, and more. Students and teachers utilize an array of educational technology tools, platforms and online resources to support the integration of science, technology, engineering design, the arts, and mathematics. Digital citizenship and cyber safety are infused into the curriculum and students utilize Chromebooks regularly. MARSD also established Technology Support Lead positions in each school. This staff member has the important responsibility of providing ongoing and embedded professional development and support for school staff. MARSD is fully 1-to-1 and provides every student with a district-issued Chromebook to support learning.
