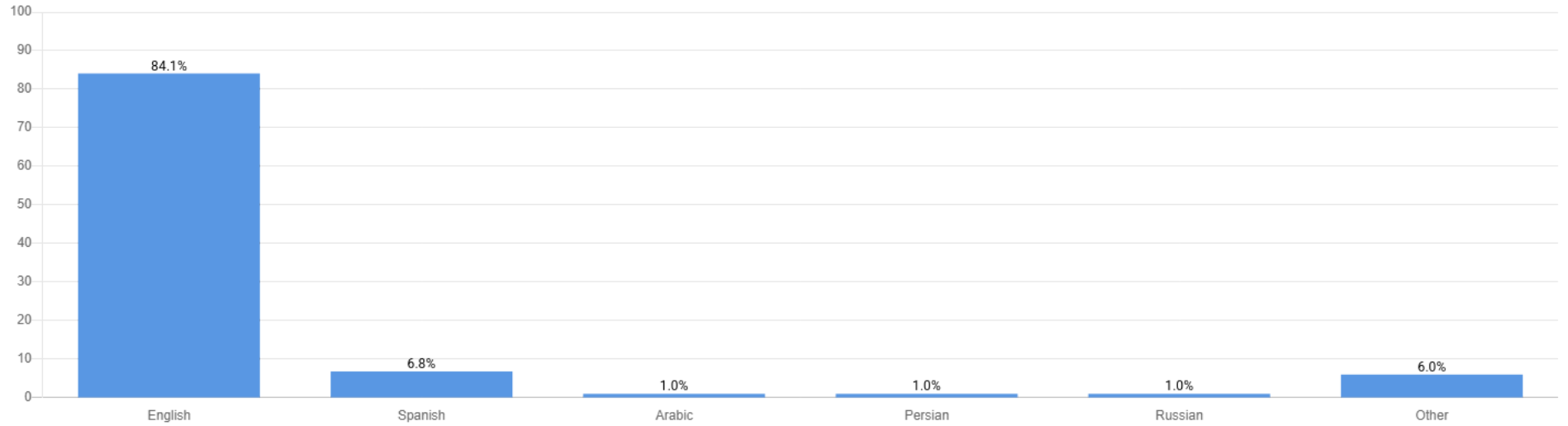

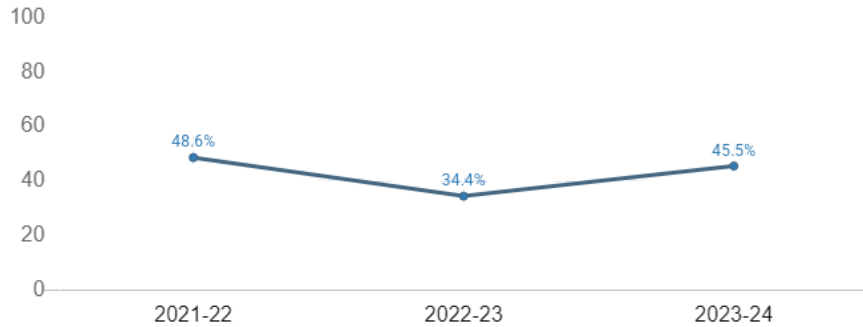

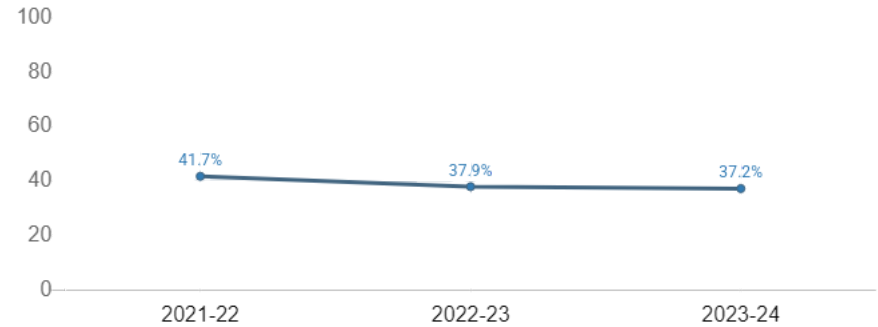
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 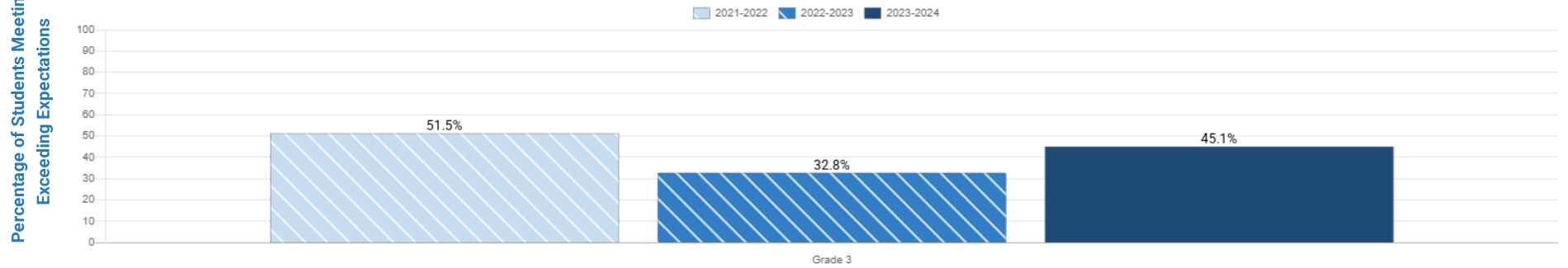

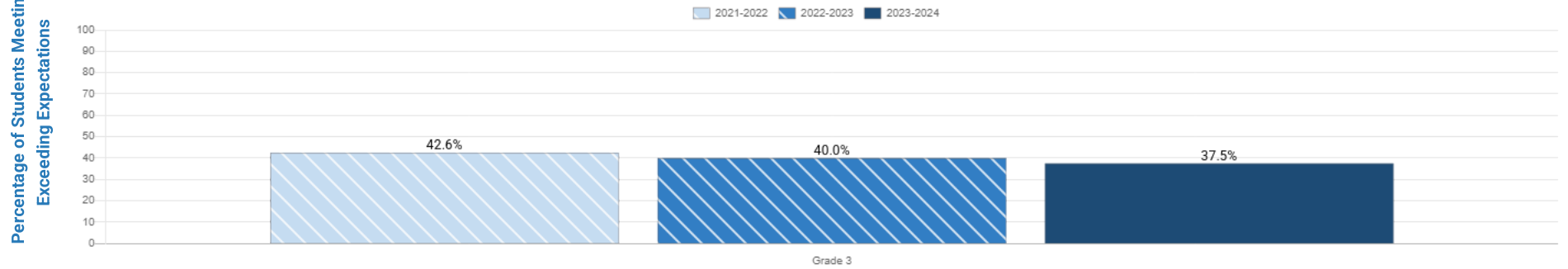

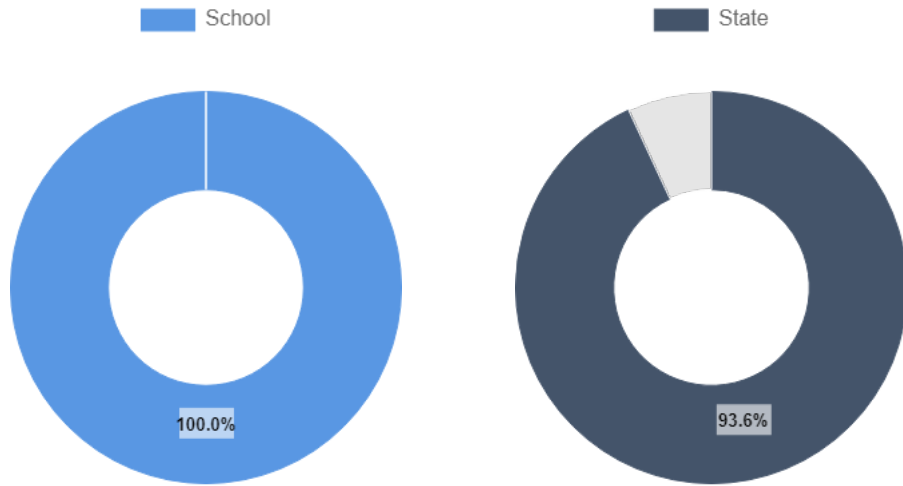

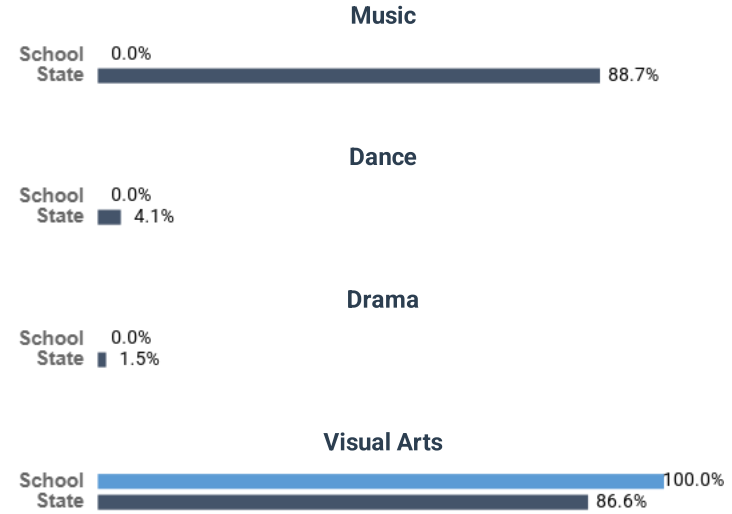

Students enrolled in one or more classes by discipline:



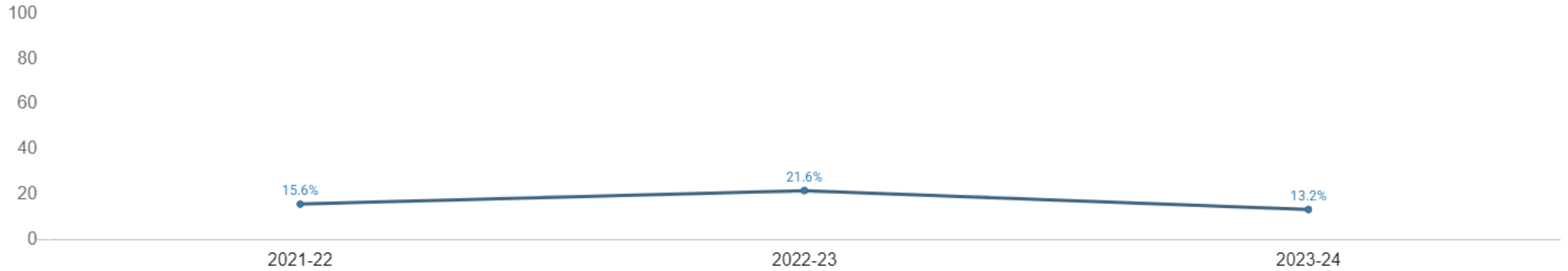
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 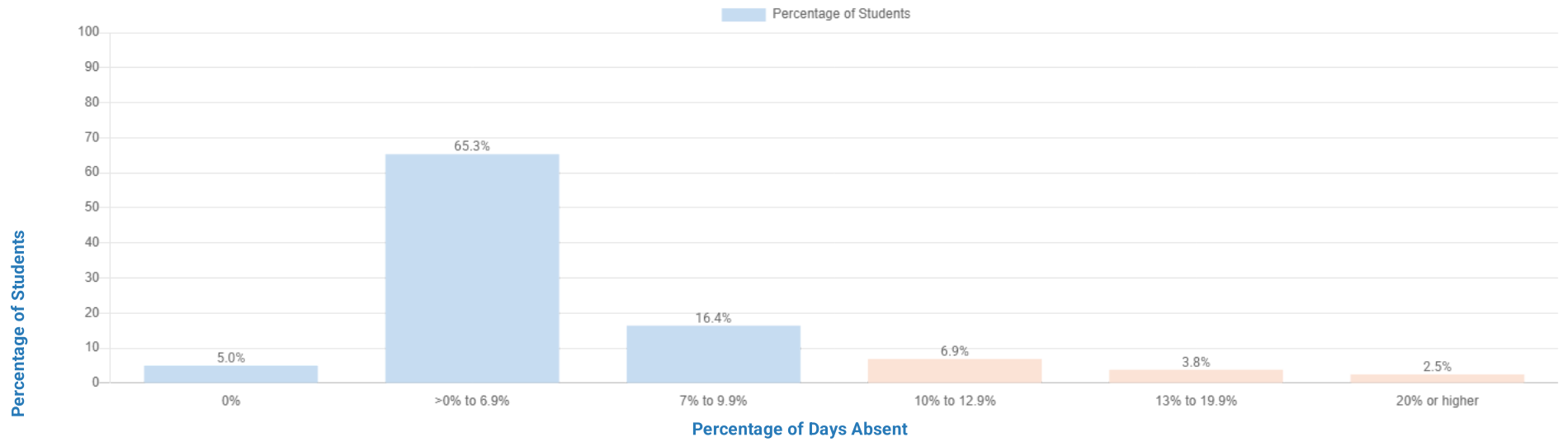

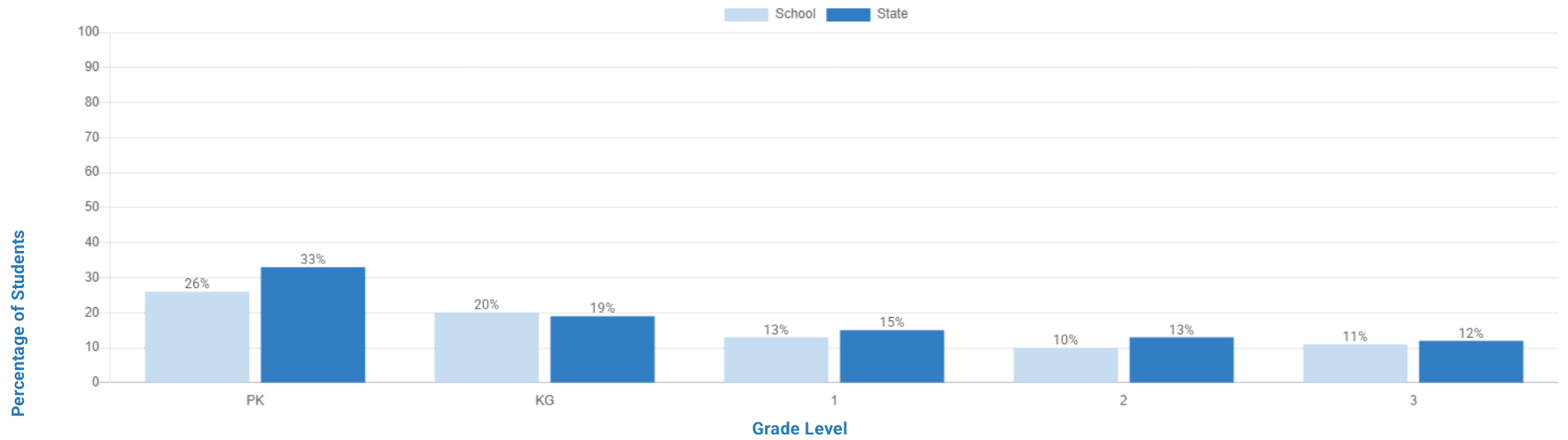

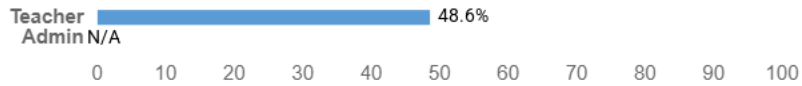

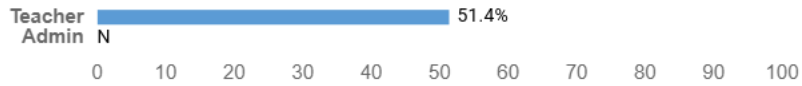
Teachers and Administrators - Level of Education

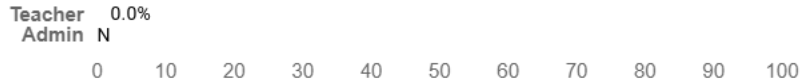
Bachelor's Degree

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Cliffwood has been recognized as a No Place for Hate award-winning school by the Anti-Defamation League for 5 consecutive years. Students are recognized through the Star Student program each month. Recognition is linked to the school's 10 monthly themes for social-emotional learning. Classes earn the Golden Awards each marking period. The schools beautiful Friendship Garden was recently recognized as a Certified Wildlife Habitat by the National Wildlife Federation.

Courses, Curriculum, Instruction:

All curricula is aligned to the New Jersey Student Learning Standards (NJSLs) and integrate Computer Science and Design Thinking, Career Readiness, Life Literacies, and Key Skills to ensure all students have equitable access to achieve academically. All curricula are available electronically via the Atlas portal on the district website. Our school utilizes myView Literacy, an integrated literacy program for grades K-5 grounded in the Science of Reading and equips students with the literacy skills they need to be college/career ready. During the 2021-2022 school year, the Everyday Math program was utilized to develop students' knowledge of math practices and content from basic fact fluency to higher-order thinking and problem-solving skills. All subjects integrate technology, interdisciplinary connections, and 21st Century College and Career Readiness, including hands-on learning and infusion of engineering design projects as part of the STEAM program.



Before and After School Programs:

Cliffwood Elementary is an approved schoolwide Title 1 building. The Title 1 program offers small group instruction during the school day following a multi-tiered system of supports, in addition Title 1 Family Nights to foster learning. We also partner with the YMCA to provide before- and after-school child care services.



Staff and Professional Learning:

All staff is afforded opportunities to engage in ongoing professional learning through district in-service days, as well as through monthly faculty and department meetings, peer-to-peer learning, embedded coaching, and out-of-district professional development workshops. Most teachers and staff have common planning time each day, regular before/after school meetings, and full-day in-services for growing professionally and enhancing practices. Teachers also have the opportunity to participate in staff Pineapple Days. On these special days, teachers voluntarily invite colleagues into their classroom to observe lessons informally and learn best practices from their peers.

Student Supports and Services:

Counseling, intervention, and integrated social-emotional learning support services are in place to assist and support all students. The Intervention and Referral Services (I&RS) team works to provide strategies and resources to teachers to support their students. At the elementary level, a Multi-Tiered System of Supports (MTSS) provides students with targeted supports and interventions in the areas of reading and math. ESL services and supports are offered to identified students. A supplemental tutorial program is also offered before school for identified students. Counseling and other related support services are available to our students.



Student Health and Wellness:

All Cliffwood classes participate in daily Morning Meetings and also integrate mindfulness activities into daily lessons. Our district has partnered with the New Jersey Mental Health Association to better support students in crisis and our school counselor leads monthly lessons in each classroom. Students receive weekly instruction in Comprehensive Health and Physical Education and directed physical activity (DPA) each day during recess. Breakfast and lunch meals are offered to all students and focus on healthy eating habits.



Parent and Community Involvement:

Cliffwood recognizes the importance of engaging families and other stakeholders in the school community. Parents and volunteers help in our classrooms and assist teachers with various activities. Cliffwoods PTO is active in the school and raises funds to enhance learning activities, enable students to attend class trips, and sponsor cultural arts programs throughout the year. The district has established a Parent University which offers programs throughout the year on various topics to support students and their families. Parent workshops and Family Nights are offered throughout the school year.

Technology and STEM:

At the elementary level, students and teachers utilize an array of educational technology tools, platforms and online resources to support the integration of science, technology, engineering design, the arts, and mathematics. Digital citizenship and cyber safety are infused into the curriculum and students utilize Chromebooks regularly. Science instruction promotes authentic learning and problem-solving using the engineering design process. STEM lessons are taught regularly by homeroom teachers and also monthly by specially-trained teachers for push-in enrichment lessons. MARS D also established Technology Support Lead positions in each school. This staff member has the important responsibility of providing ongoing and embedded professional development and support for school staff. New this year, Cliffwood students actively participated in lessons focused on coding and robotics with our new Dash and Dot program.



Attendance:

During the 2021-2022 school year, Cliffwood Elementary School operated a schoolwide Title 1 Program, including a supplemental tutorial program offered to identified students to address student learning loss as a result of the COVID-19 Pandemic. In addition, the district offers a comprehensive array of social-emotional, mental health and wellness services to address the needs of our students.
