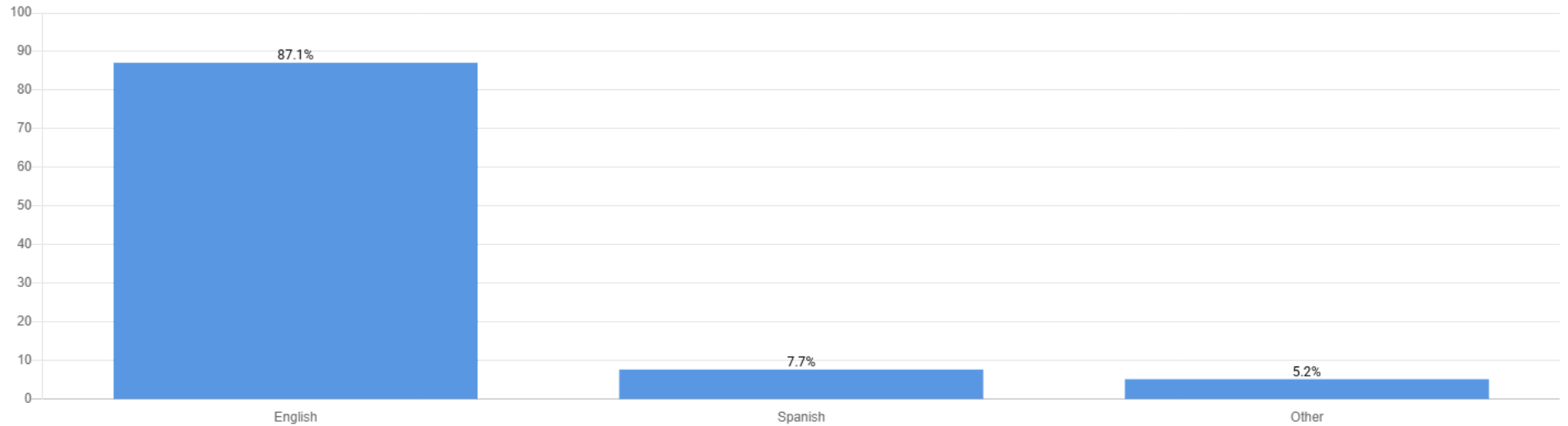

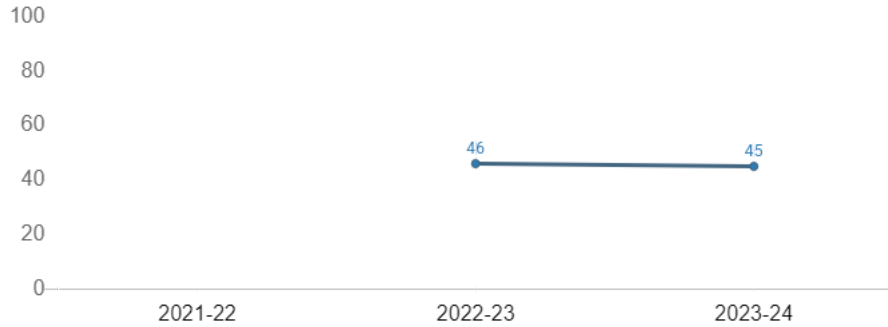

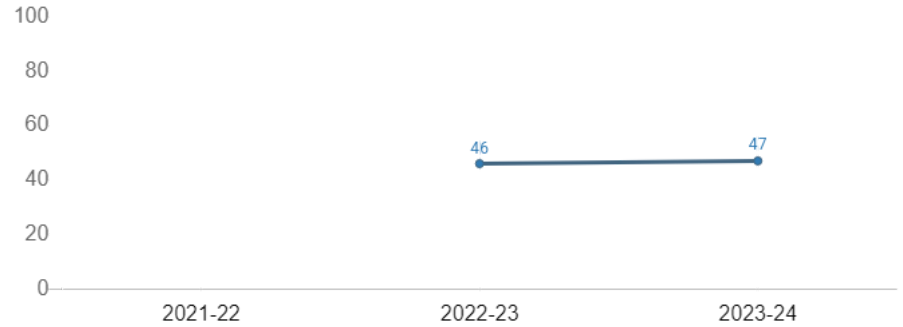

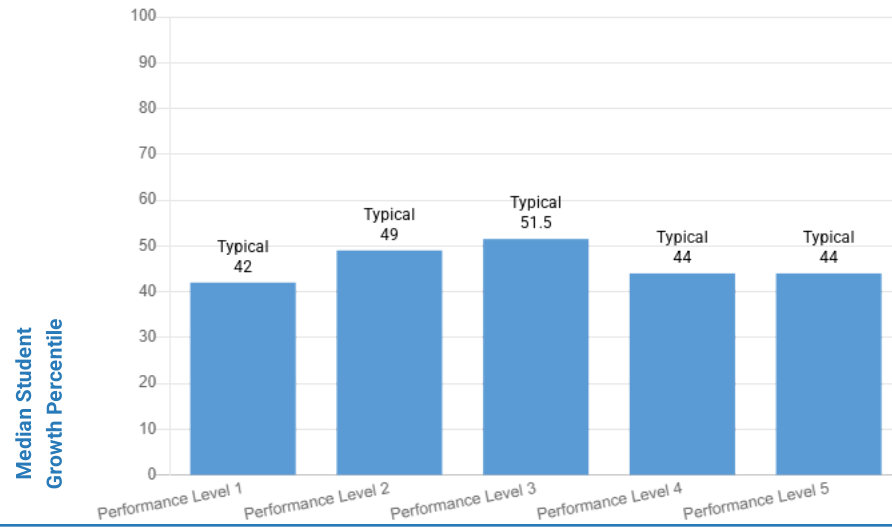

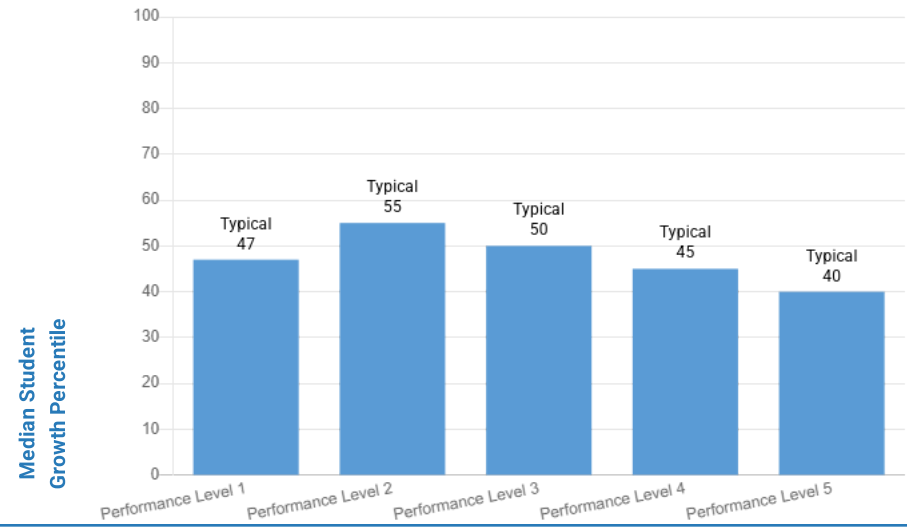

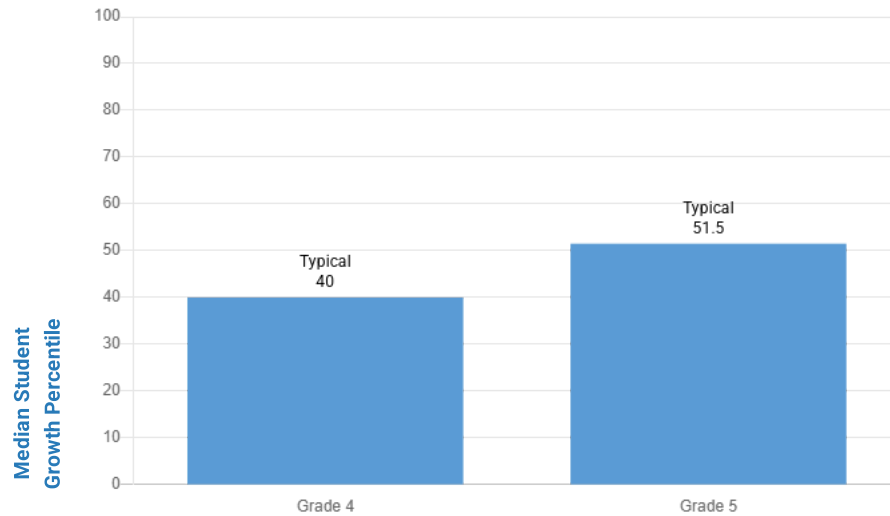

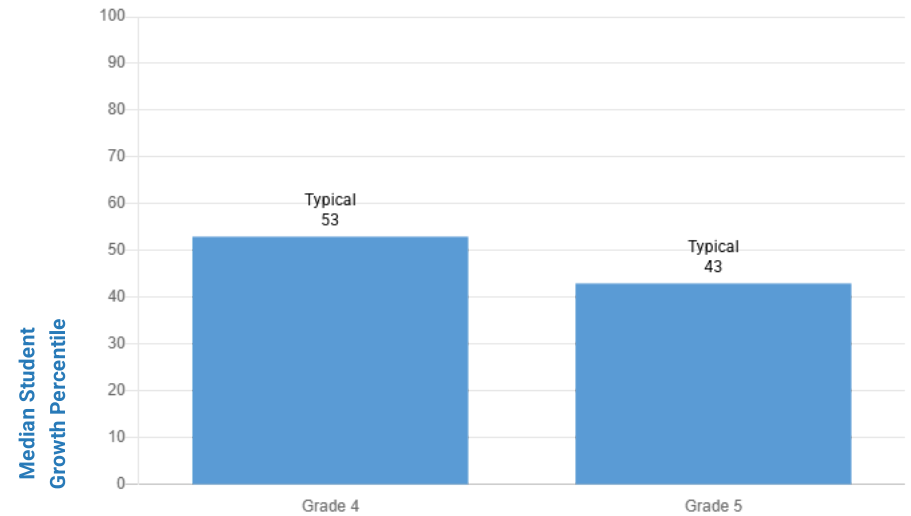

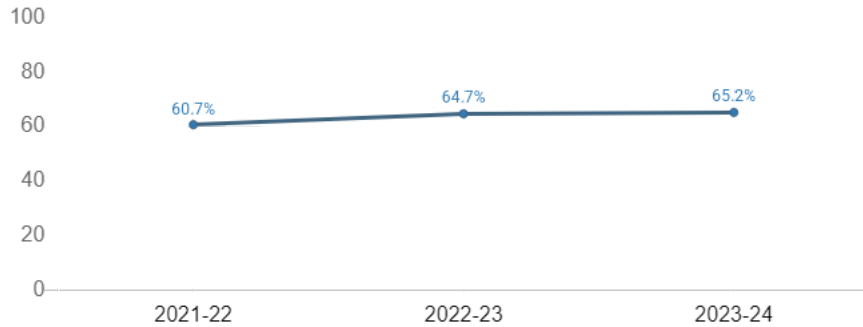

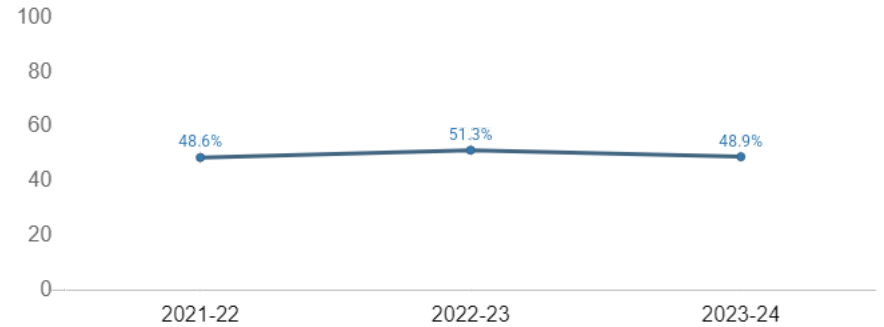
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 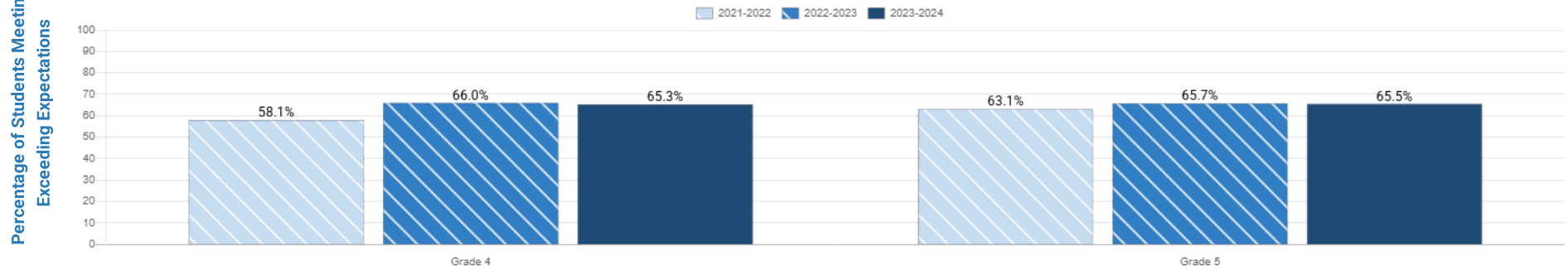

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

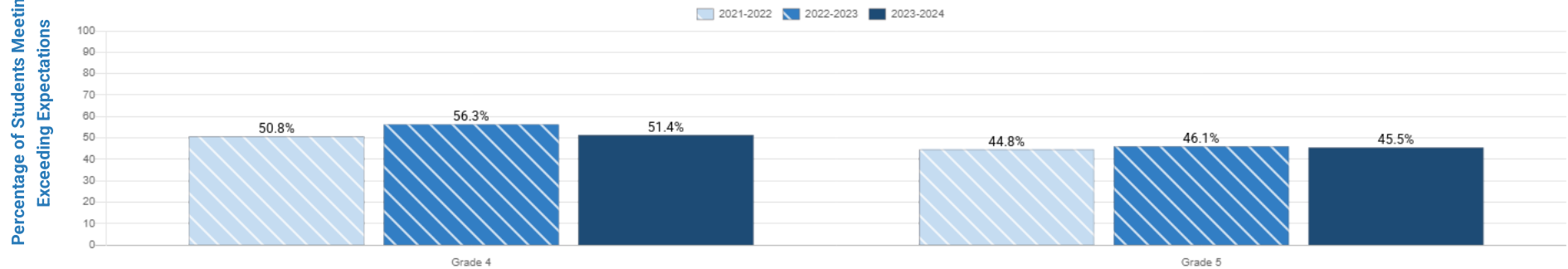

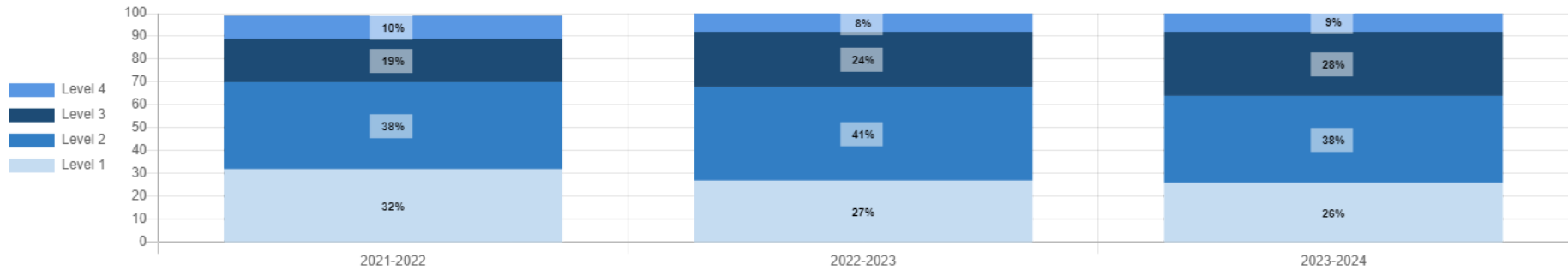

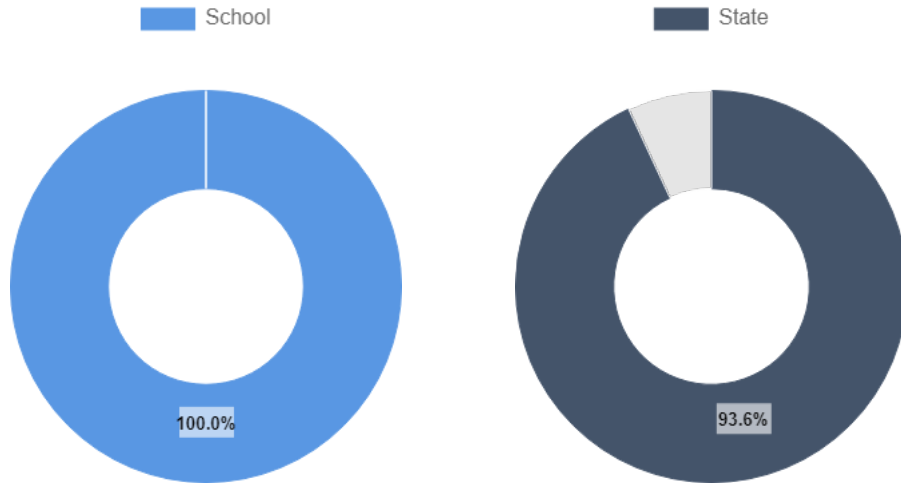

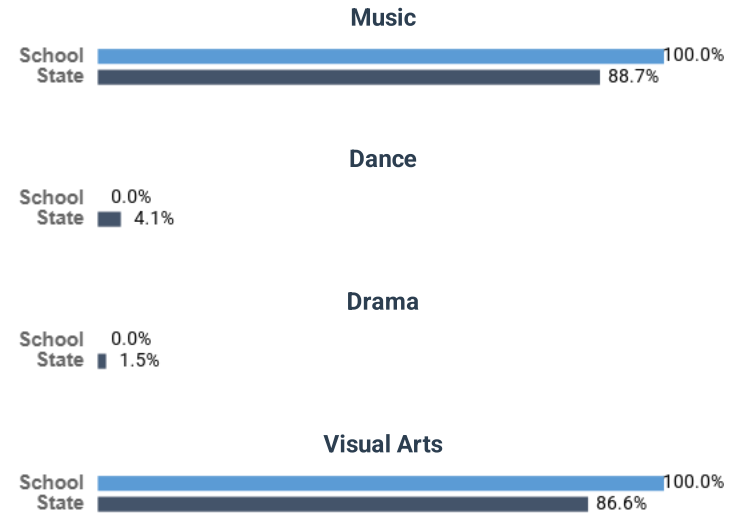

Students enrolled in one or more classes by discipline:



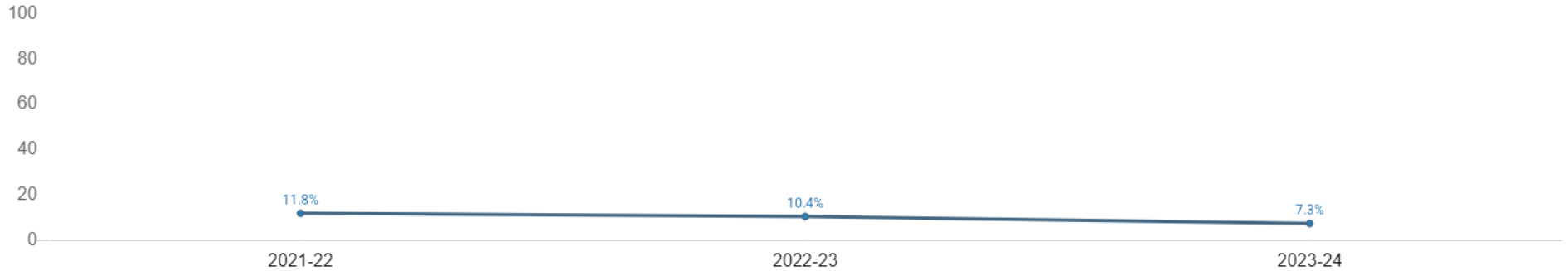

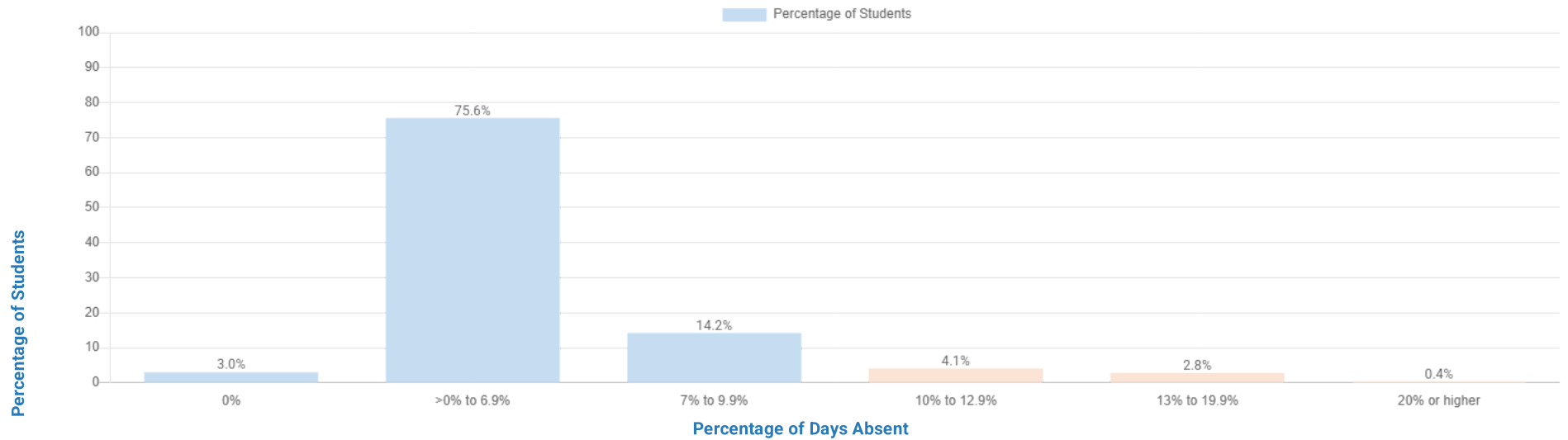

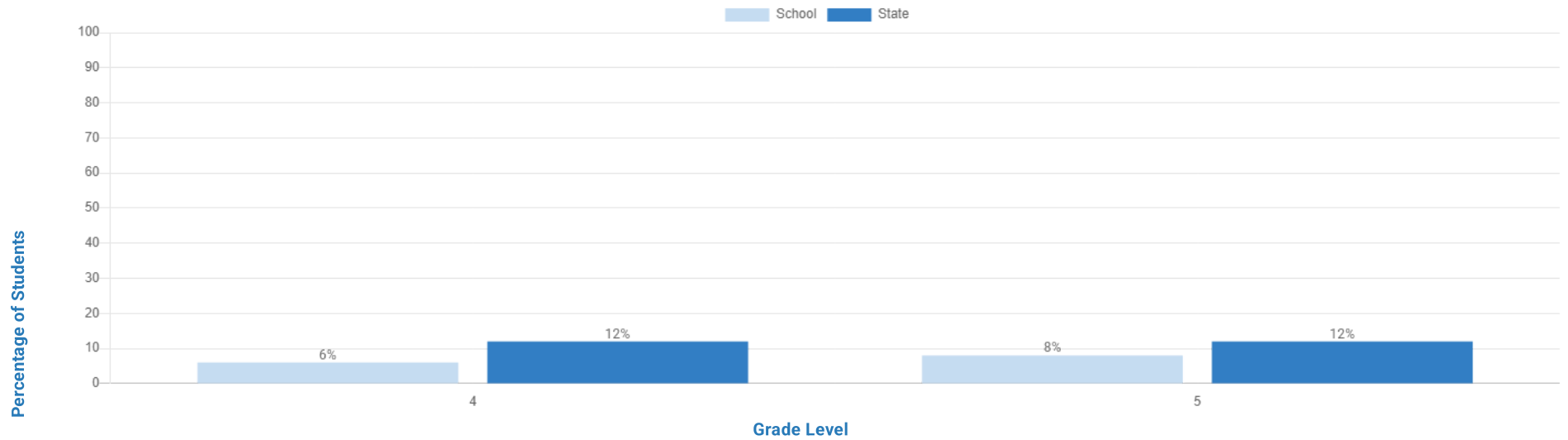

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

All curricula is aligned to the New Jersey Student Learning Standards (NJSLs) and integrate Computer Science and Design Thinking, Career Readiness, Life Literacies, and Key Skills to ensure all students have equitable access to achieve academically. All curricula are available electronically via the Atlas portal on the district website. Our school utilizes myView Literacy, an integrated literacy program for grades K-5 grounded in the Science of Reading and equips students with the literacy skills they need to be college/career ready. During the 2023-2024 school year, the Ready Math program was utilized to develop students' knowledge of math practices and content from basic fact fluency to higher-order thinking and problem-solving skills. All subjects integrate technology, interdisciplinary connections, and 21st Century College and Career Readiness, including hands-on learning and infusion of engineering design projects as part of the STEAM program.



Clubs and Activities:

Lloyd Road Elementary School offers a wide array of clubs and activities which include Student Council and Peer Buddies. Lloyd Road Elementary also offers the following afterschool clubs: Art, Chess, Soccer, Technology, Chorus, Board Games, Garden Club and Book Club.

All staff are afforded opportunities to engage in ongoing professional learning through district in-service days, as well as through monthly faculty and department meetings, peer-to-peer learning, embedded coaching, and out-of-district professional development workshops to grow and develop professionally, acquire new resources, and refine instructional practices.



Student Supports and Services:

Counseling, intervention, and integrated social-emotional learning support services are in place to assist and support students. The Intervention and Referral Services (I&RS) team works to provide strategies and resources to teachers to support their students. At the elementary level, a Multi-Tiered System of Supports (MTSS) provides identified students with targeted support and interventions in the areas of reading and math. ESL and G&T services and supports are offered to identified students, including enrichment for visual and performing arts. A supplemental tutorial program is also offered before school for identified students. Counseling and other related support services are available to our students.



Student Health and Wellness:

All classes participate in daily Morning Meetings and Classroom Circles to foster Social-Emotional Learning (SEL), along with the integration of mindfulness activities into daily lessons. Our school counselors provide both individual and group counseling support as needed, and lead monthly lessons in each classroom. Students receive weekly instruction in Comprehensive Health and Physical Education. Breakfast and lunch meals are available to students and focus on healthy eating habits.

Technology and STEM:

MARSD is fully one-to-one and will be providing a district-issued Chromebook to every PreK-12 student. All K-12 students will maintain their own district-issued Chromebook (CB), and carry their Chromebook to/from school each day. Students and teachers utilize an array of educational technology tools, platforms, and online resources to support the integration of science, technology, engineering design, the arts, and mathematics. Digital citizenship and cyber safety are infused into all areas. Science instruction promotes authentic learning and problem-solving using the engineering design process. STEM lessons are taught regularly by homeroom teachers and also monthly by specially-trained teachers for push-in enrichment lessons. MARSD also established Technology Support Lead positions in each school. This staff member has the important responsibility of providing ongoing and embedded professional development and support for school staff.



Attendance:

During the 2023-2024 school year, Lloyd Road Elementary School participated in the Scripps National Spelling Bee which included classroom, grade level and a schoolwide spelling bee.

Lloyd Road Elementary School is located in the southwestern section of the Matawan-Aberdeen Regional School District. The school educates grades 4 and 5 students only as we are a receiving school for our K-3 elementary schools. Our teachers and students use Google Classroom throughout the day to support learning, and we are close to a 1 to 1 chromebook ratio. We use a student of the month program that has one character education theme per month that is emphasized. Each month then culminates in one student from each class eating with the principal and assistant principal in a recognition lunch. We are also very proud of our choral and instrumental music programs. Grade 4 students are able to begin practicing an instrument of choice during their first year in Lloyd Road. Grade 5 instrumental students also have practice lessons throughout the year, but they also put on a spring performance to culminate each year. Our choral program is open to Grade 5 students who also put on a spring performance.
