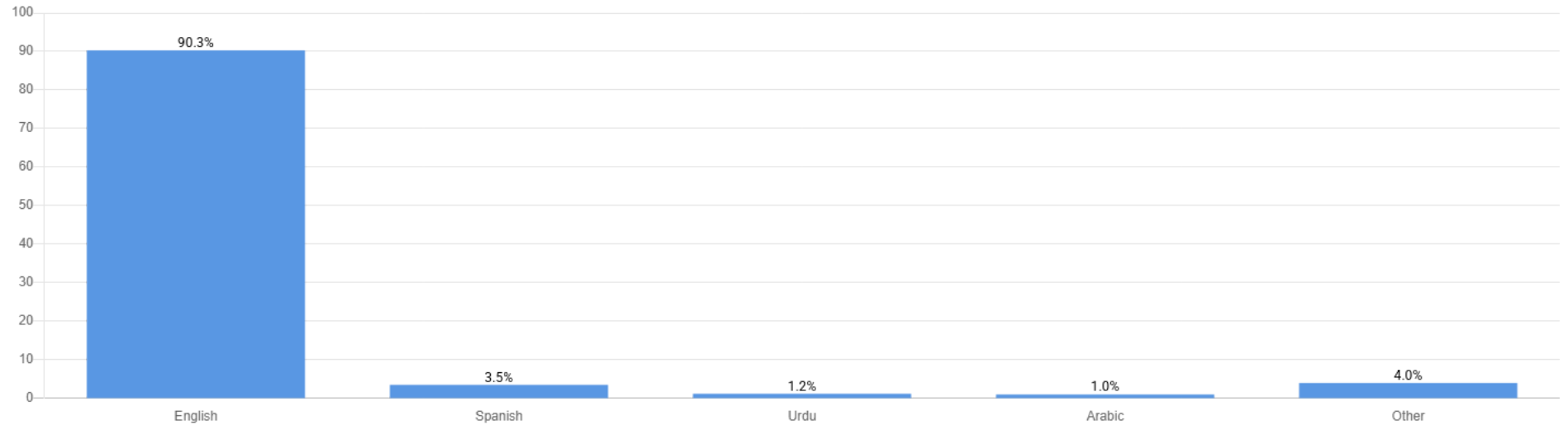

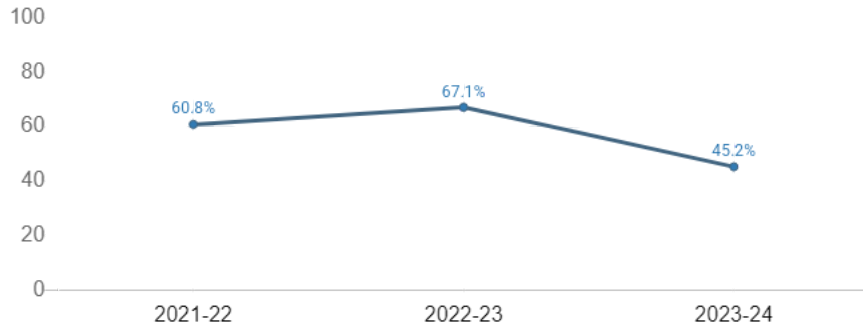

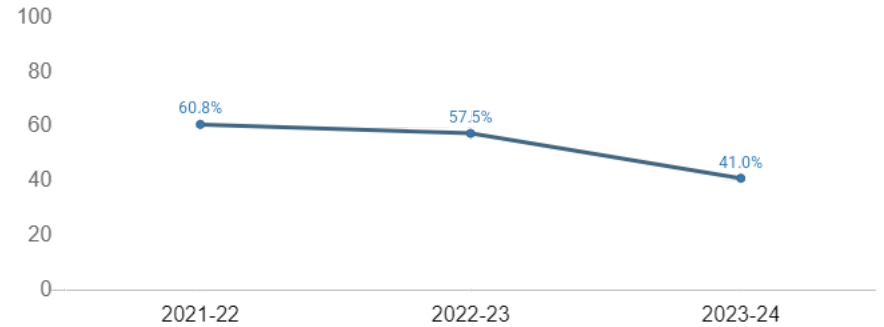
English Language Arts and Mathematics Performance Trends

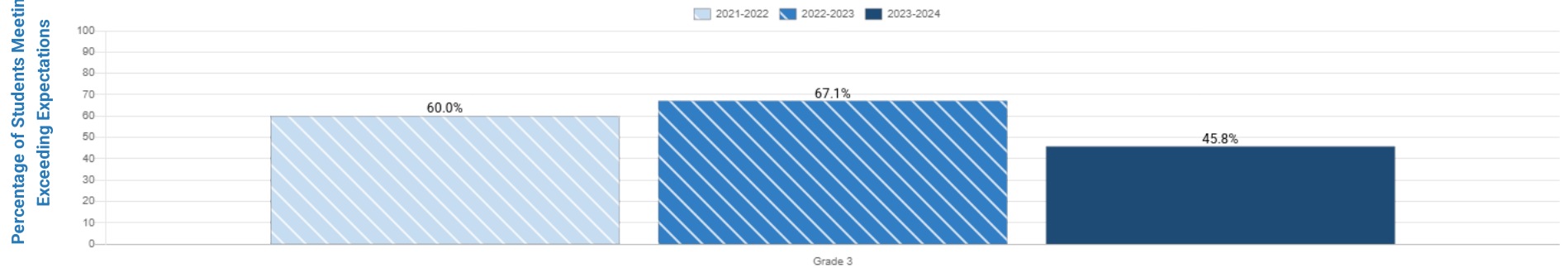

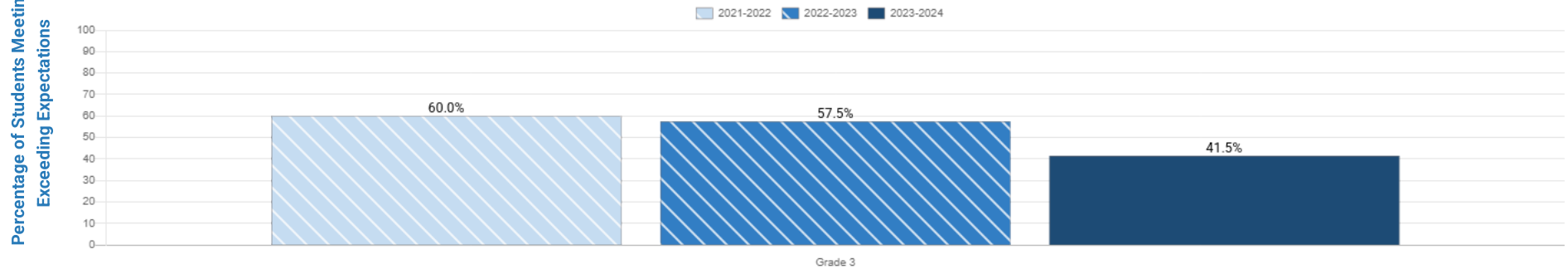

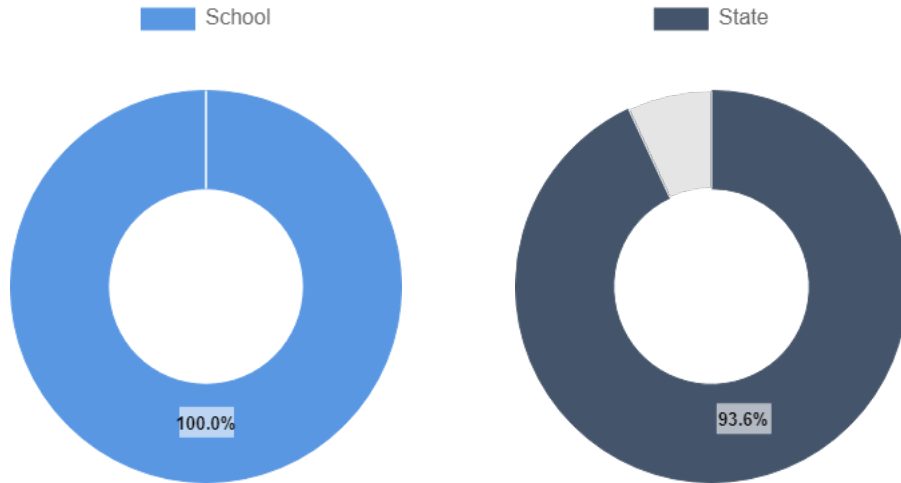

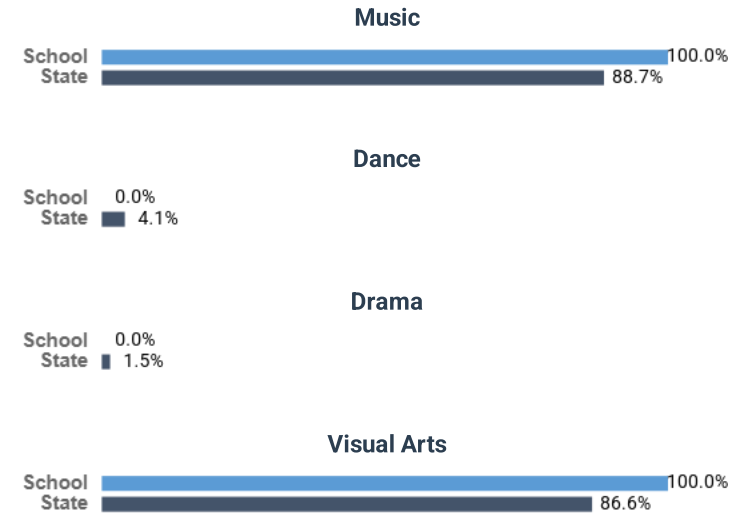

Students enrolled in one or more classes by discipline:



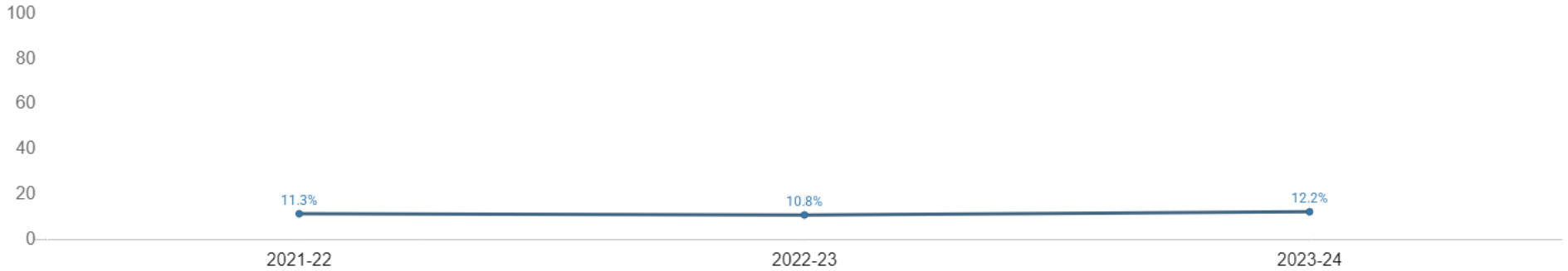
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 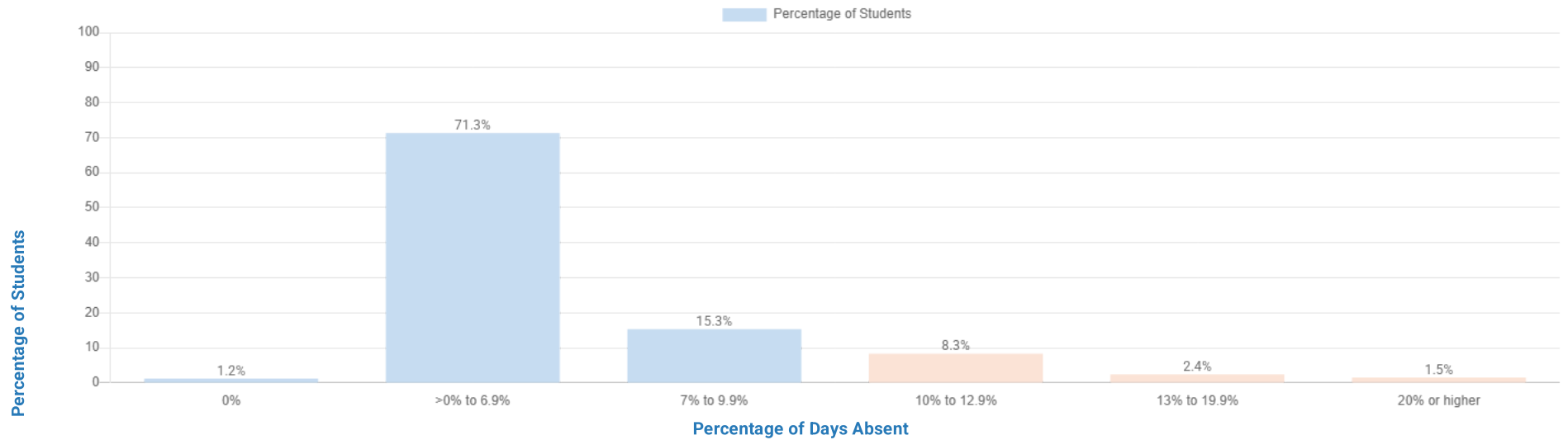

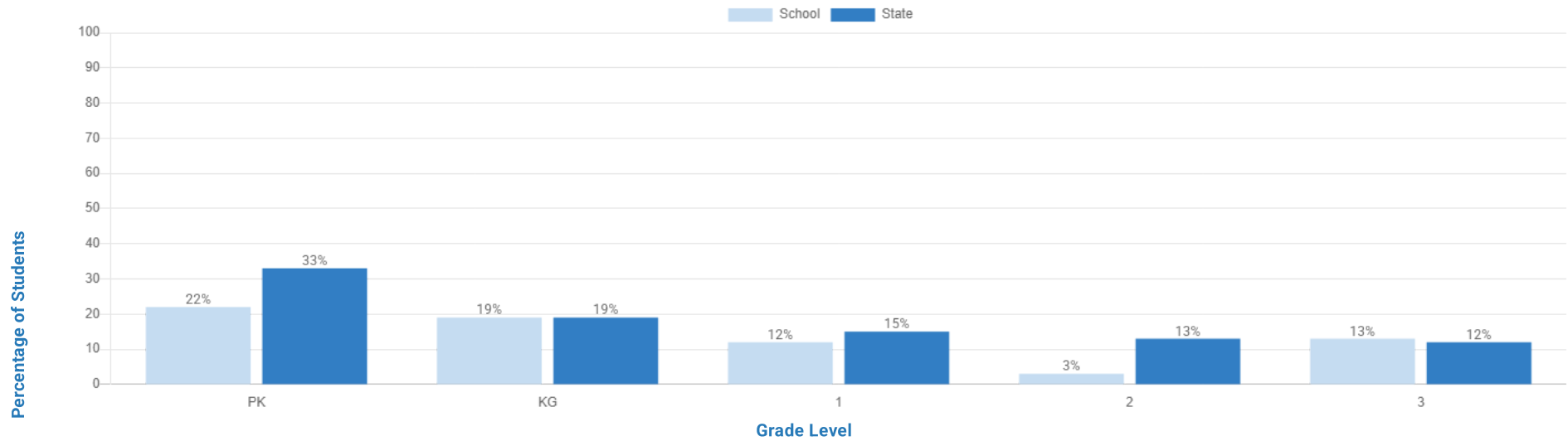

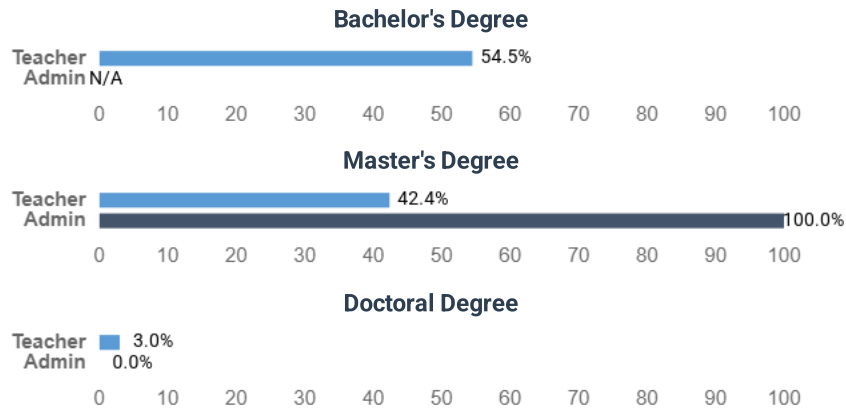

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

All curricula are aligned to the New Jersey Student Learning Standards. All K-3 curricula integrate Computer Science and Design Thinking, Career Readiness, Life Literacies, and Key Skills to ensure all students have equitable access to achieve academically. All curricula are available via the Atlas portal on the district website. Our school utilizes myView Literacy, an integrated literacy program grounded in the Science of Reading, and equips students with the literacy skills they need to be college/career ready. During the 2023-2024 school year, Ready Math was utilized to develop students' knowledge of math practices and content from basic fact fluency to higher-order thinking and problem-solving skills. All subjects integrate technology, interdisciplinary connections, and 21st Century College and Career Readiness, including hands-on learning and infusion of engineering design projects as part of the STEAM program.



Clubs and Activities:

Third-grade students take on a leadership role as members of the Safety Patrol. Second and third-grade students participate in the Environmental Club, Engineering Club, Music Club, and Art Club, which all foster the Whole Child. Students in Peer Buddies have the opportunity to develop new friendships while meeting with second-grade students.



Before and After School Programs:

The Peer Buddy Program gives students in all grades the opportunity to develop friendships in a natural environment. Students in third grade meet weekly with their second and kindergarten buddies. In addition, the district offers a comprehensive array of social-emotional, mental health and wellness services to address the needs of our students. We also partner with the YMCA to provide before- and after-school child care services.

Staff and Professional Learning:

All staff are afforded opportunities to engage in ongoing professional learning through district in-service days, as well as through monthly faculty and department meetings, peer-to-peer learning, embedded coaching, and out-of-district professional development workshops to grow and develop professionally, acquire new resources, and refine instructional practices.



Student Supports and Services:

Counseling, intervention, and integrated social-emotional learning support services are in place to assist and support students. The Intervention and Referral Services (I&RS) team works to provide strategies and resources to teachers to support their students. At the elementary level, a Multi-Tiered System of Supports (MTSS) provides identified students with targeted support and interventions in the areas of reading and math. EL and enrichment services and supports are offered to identified students. A supplemental tutorial program is also offered before school for identified students. Counseling and other related support services are available to our students.



Student Health and Wellness:

All classes participate in daily Morning Meetings and also integrate mindfulness activities into daily lessons. Our school counselors provide individual and group counseling support as needed, and lead monthly lessons in each classroom. Students receive weekly instruction in Comprehensive Health and Physical Education. Breakfast and lunch meals are available to students and focus on healthy eating habits.

School Safety:

The safety and security of all students and staff is our schools top priority. Our school is equipped with a visitor security vestibule for the safety of all occupants. The school's Safety & Climate team is composed of administrators, teachers, support staff, and parents. The team meets regularly to review and discuss student and staff safety matters and other aspects of school safety using data and feedback from safety walkthroughs.



Technology and STEM:
