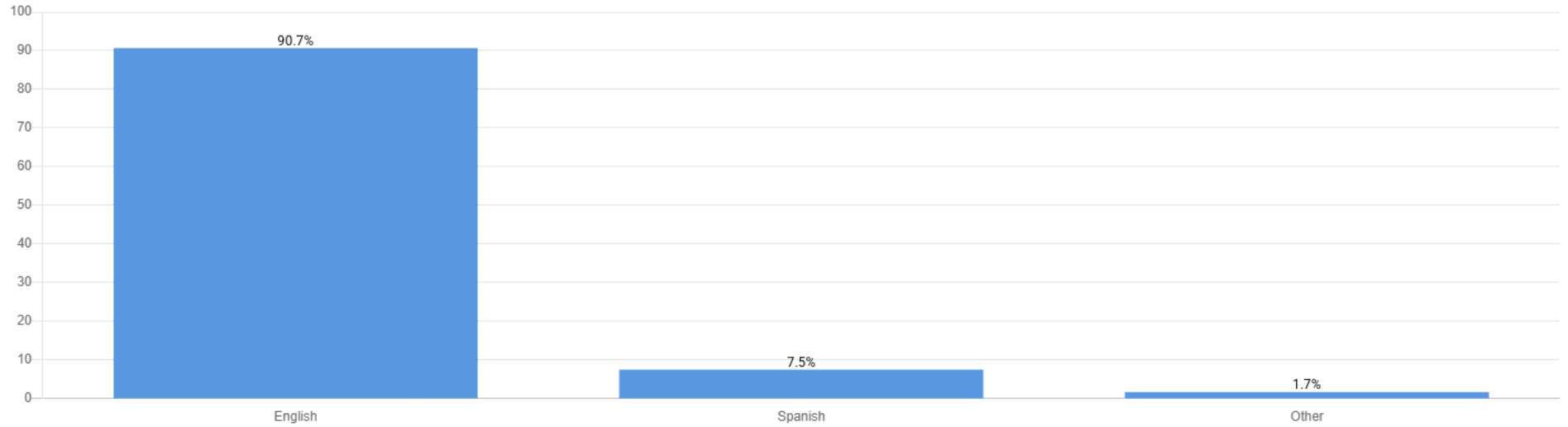

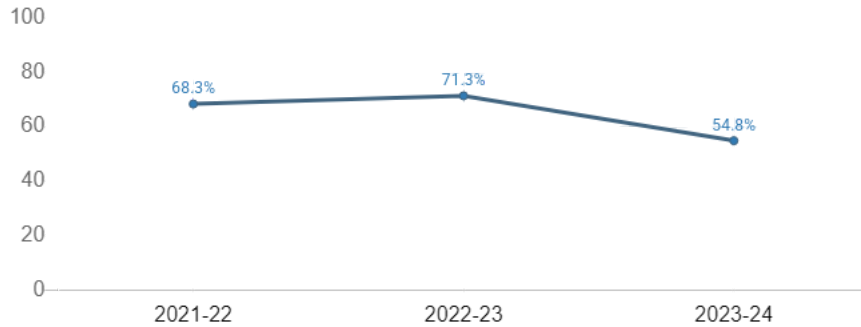

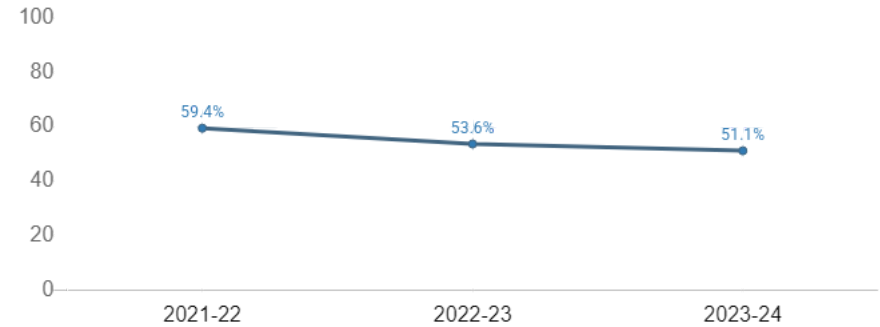
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 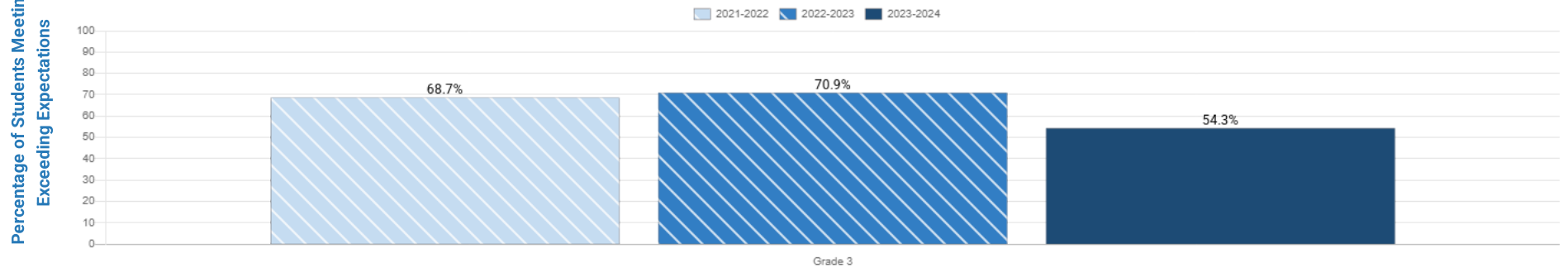

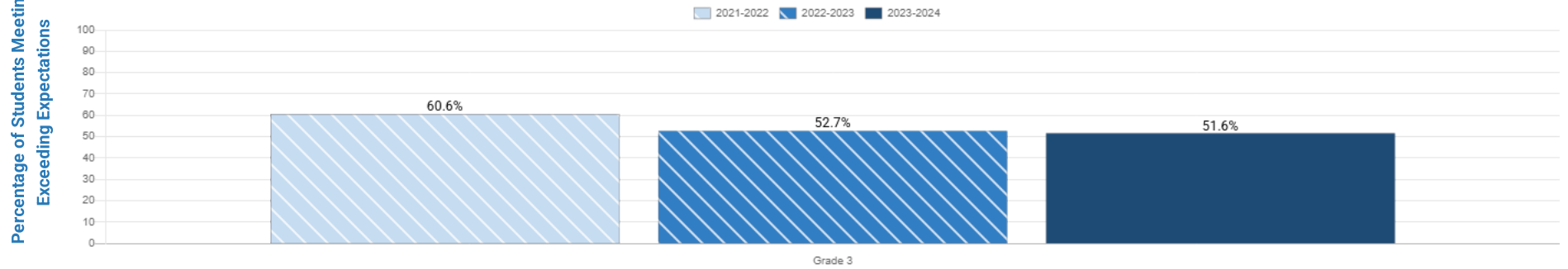

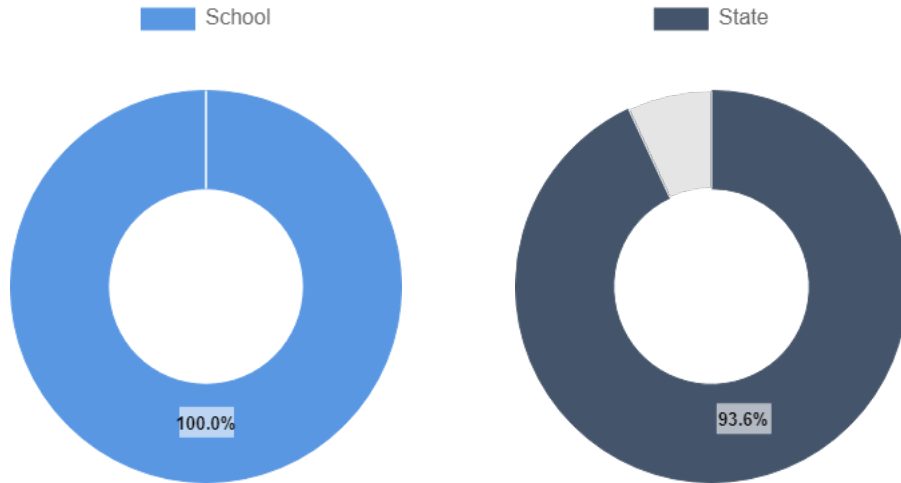

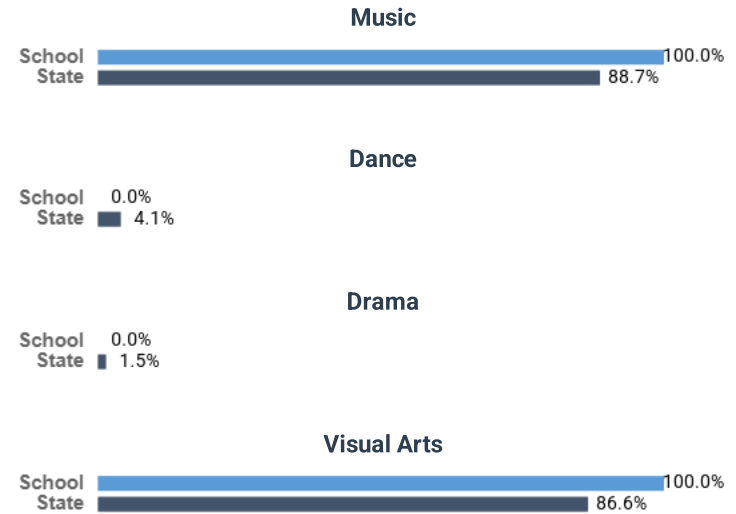

Students enrolled in one or more classes by discipline:



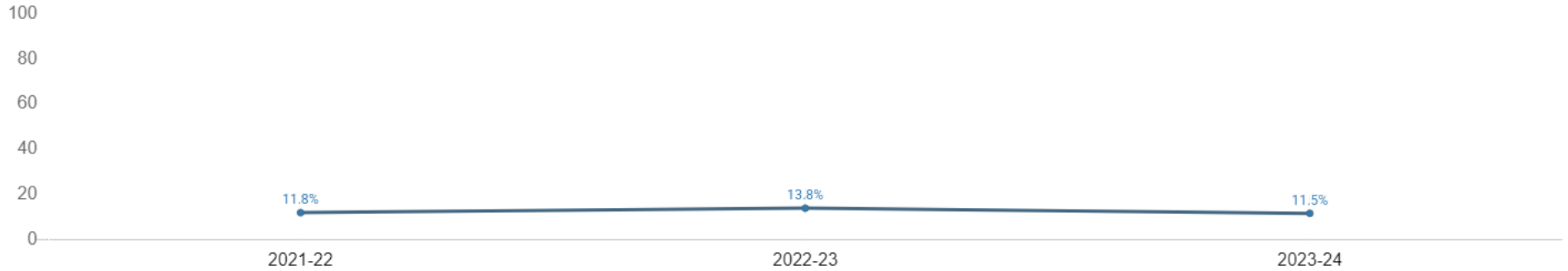
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 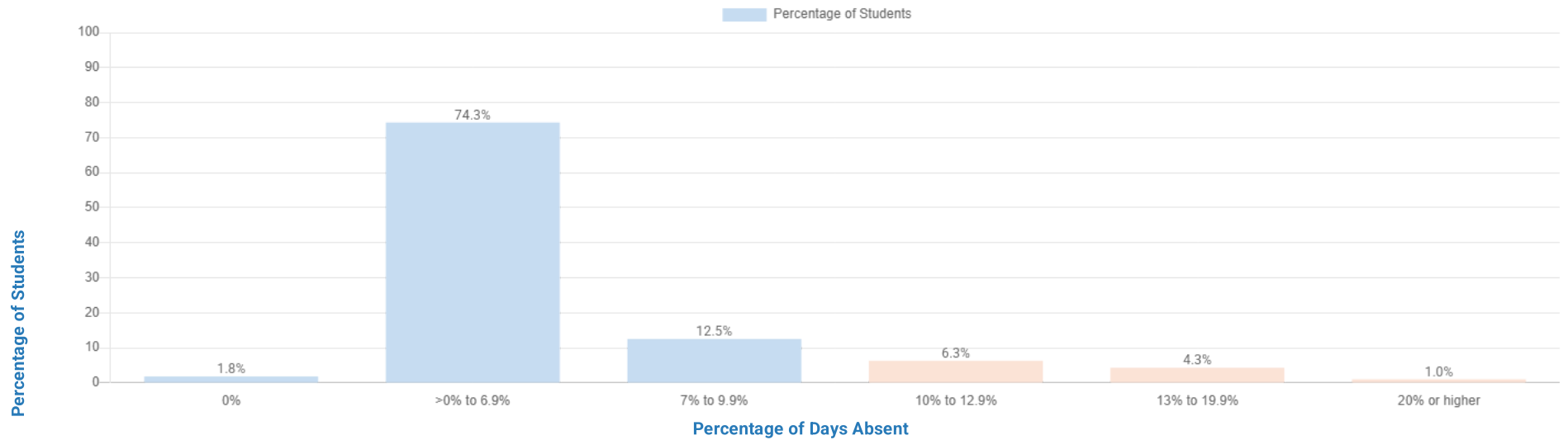

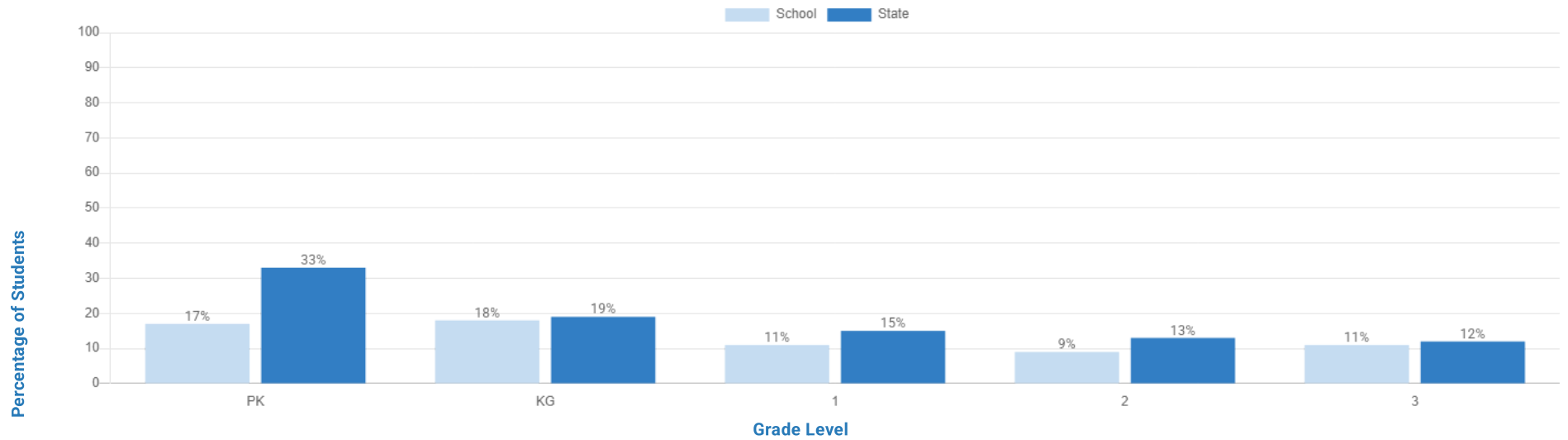

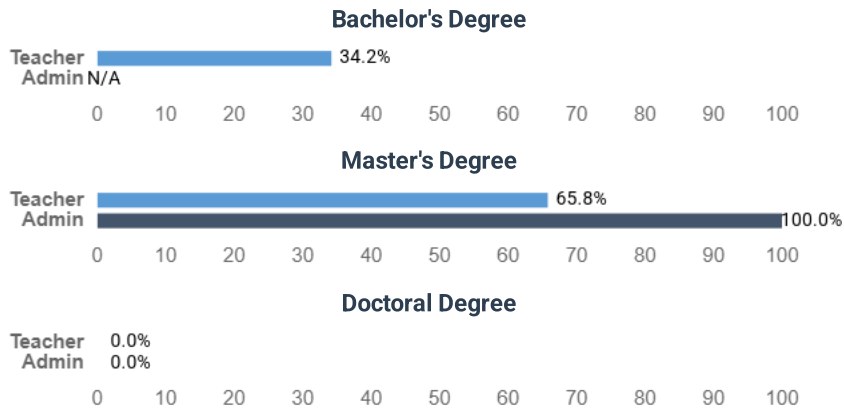

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. - Strathmore School's curriculum includes MyView literacy program and the Ready Math program. Social Studies is taught through an integrated approach using Studies Weekly. Science is taught using a variety of resources.
- Technology is infused into daily lessons utilizing Promethean Boards, document cameras, Ipads and Chromebooks

Strathmore Elementary serves approximately 450 students. Strathmore is the home for neighborhood students in preschool through grade three. At Strathmore Elementary, all students learn in a positive learning environment that welcomes exploration and enhances student confidence.

Each Year Strathmore Elementary Teachers participate in the Governor's Educator of the Year Program. Students are recognized monthly through the student of the month program.

Courses, Curriculum, Instruction:

All curricula is aligned to the New Jersey Student Learning Standards (NJSLS) and integrate Computer Science and Design Thinking, Career Readiness, Life Literacies, and Key Skills to ensure all students have equitable access to achieve academically. All curricula are available electronically via the Atlas portal on the district website. Our school utilizes myView Literacy, an integrated literacy program for grades K-5 grounded in the Science of Reading and equips students with the literacy skills they need to be college/career ready. K-5 students use the Everyday Math program to develop students' knowledge of math practices and content from basic fact fluency to higher-order thinking and problem-solving skills. All subjects integrate technology, interdisciplinary connections, and 21st Century College and Career Readiness, including hands-on learning and infusion of engineering design projects as part of the STEAM program.



Clubs and Activities:

Third-grade students become leaders through our supervised Safety Patrol Program. Grade 3 students also have the opportunity to participate in our Peer Buddy Program. Strathmore usually hosts family nights as well. Grade 3 students also hold their grade level chorus performance each Spring.



Staff and Professional Learning:

All staff are afforded opportunities to engage in ongoing professional learning through district in-service days, as well as through monthly faculty and department meetings, peer-to-peer learning, embedded coaching, and out-of-district professional development workshops to grow and develop professionally, acquire new resources, and refine instructional practices.

Student Supports and Services:

Counseling and integrated social-emotional learning support services are in place to assist and support students. The Intervention and Referral Services (I&RS) team works to provide strategies and resources to teachers to support their students. At the elementary level, a Multi-Tiered System of Supports (MTSS) provides identified students with targeted support and interventions in the areas of reading and math through a WIN block. During WIN teachers look to meet with students in need in small groups or individually. ESL services and supports are offered to identified students. Counseling and other related support services are available to our students.



Student Health and Wellness:

All K-3 classes participate in daily Morning Meetings and integrate mindfulness activities into daily lessons. School counselors provide individual and group counseling support, and lead monthly lessons in each classroom. Students receive weekly instruction in Comprehensive Health and Physical Education. Breakfast and lunch meals are available to students and focus on healthy eating habits.



Parent and Community Involvement:

Parents and the community play an integral part in our school. They are involved in all aspects of school life, enriching the activities for all of our students. School Safety:

The safety and security of all students and staff is our schools top priority. Our school is equipped with a visitor security vestibule for the safety of all occupants. The principal regularly collaborates with the district School Resource officer on security drills and procedures.



Technology and STEM:

At the elementary level, students and teachers utilize an array of educational technology tools, platforms, and online resources to support the integration of science, technology, engineering design, the arts, and mathematics. Digital citizenship and cyber safety are infused into the curriculum and students utilize chromebooks regularly. Science instruction promotes authentic learning and problem-solving using the engineering design process. STEM lessons are taught regularly by homeroom teachers and also monthly by specially-trained teachers for push-in enrichment lessons.
