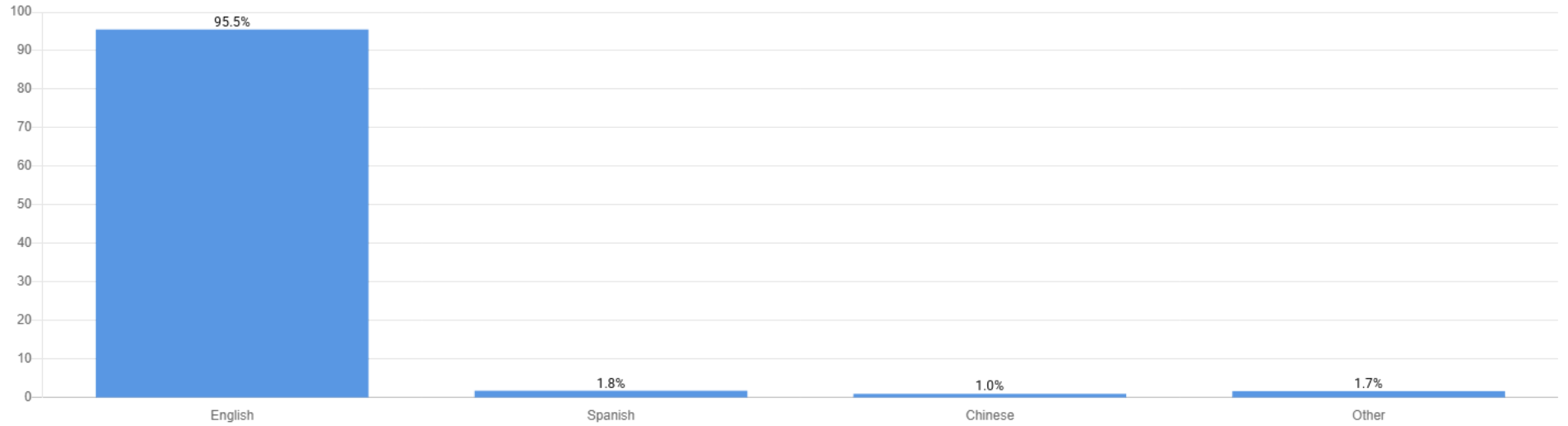

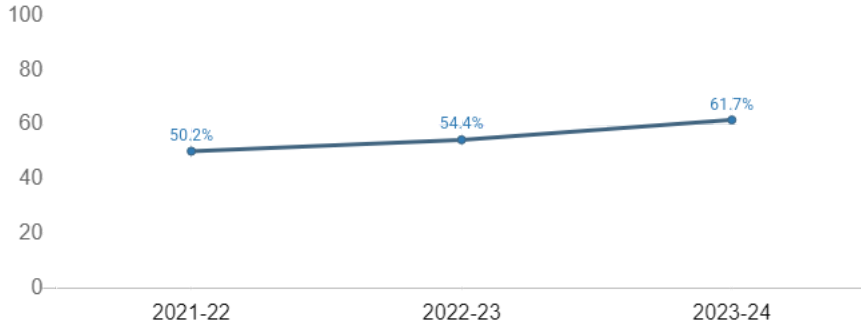

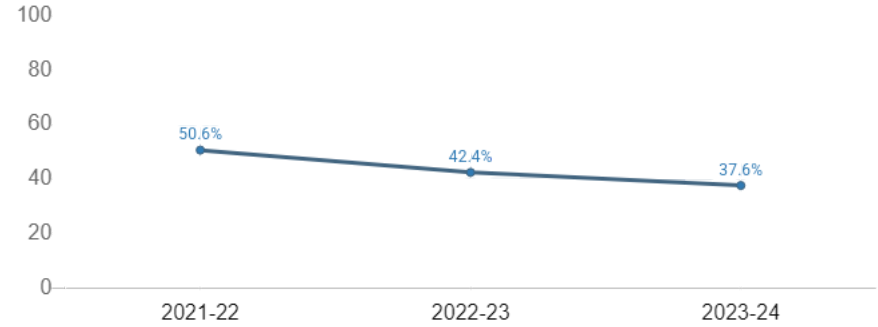
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 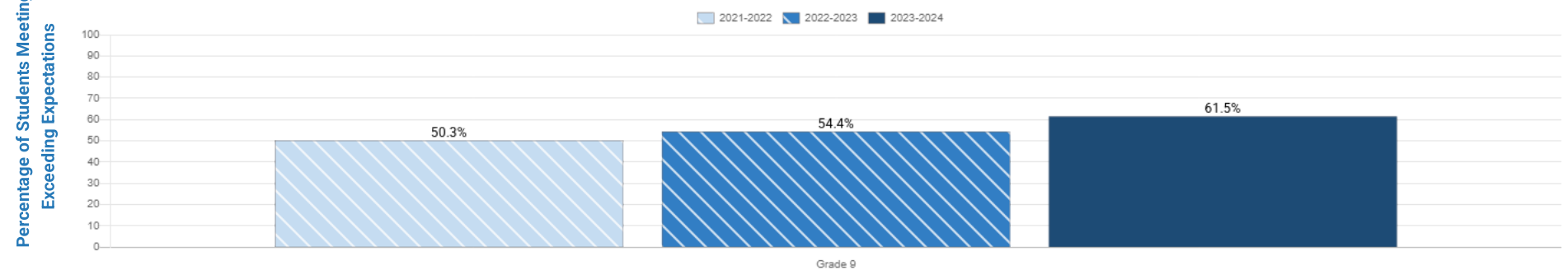

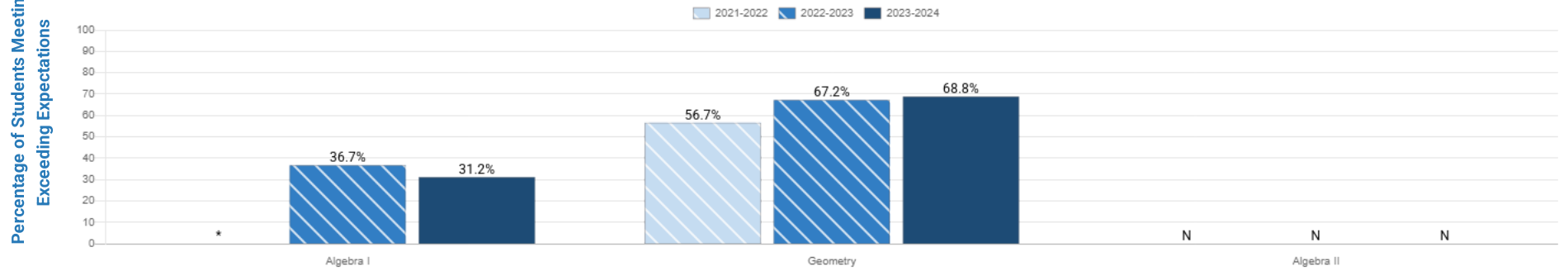

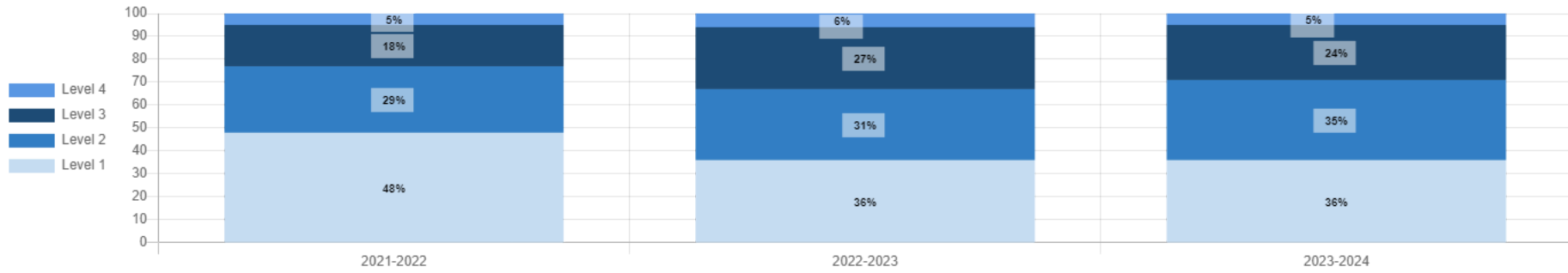

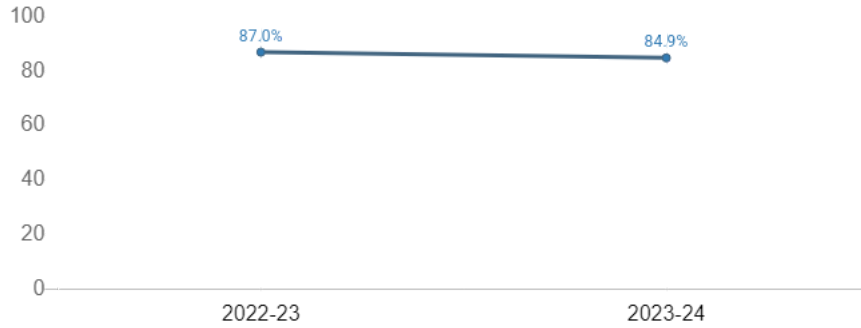

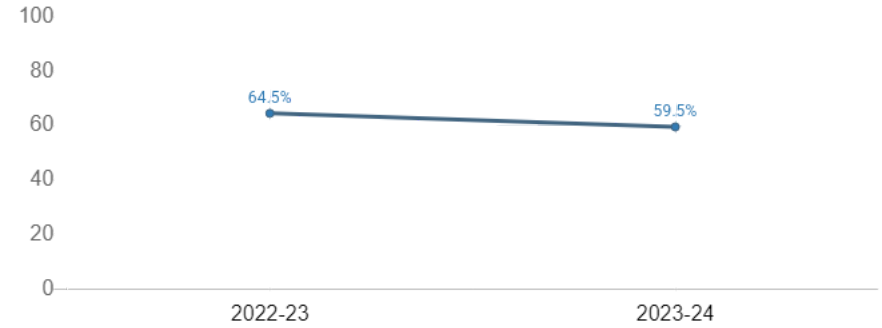

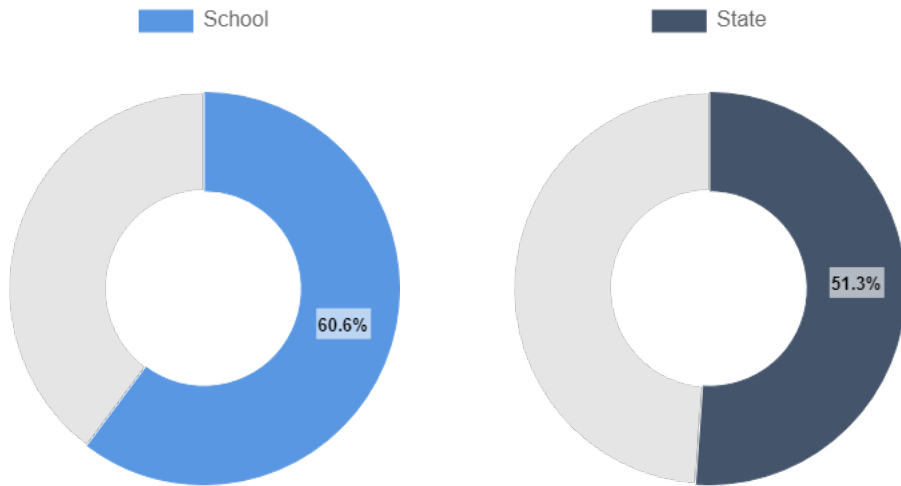

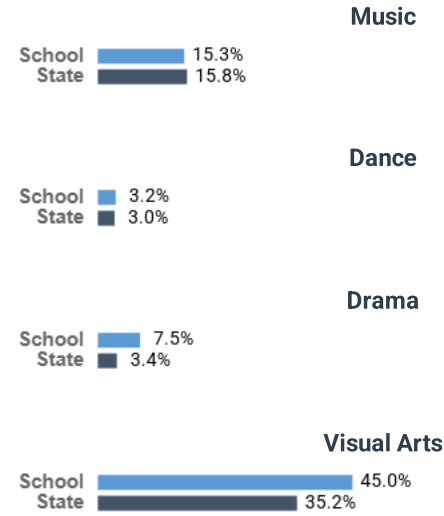

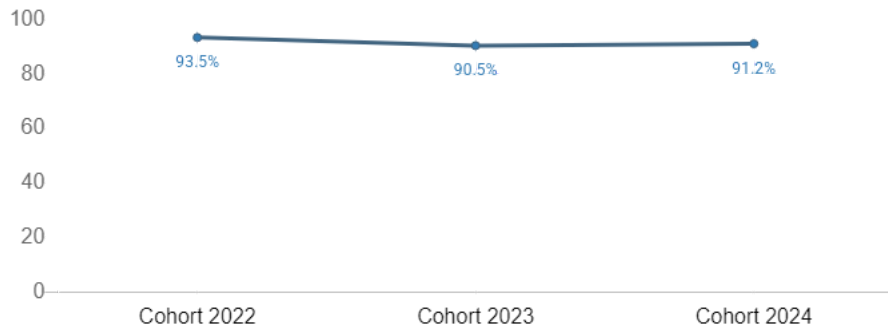

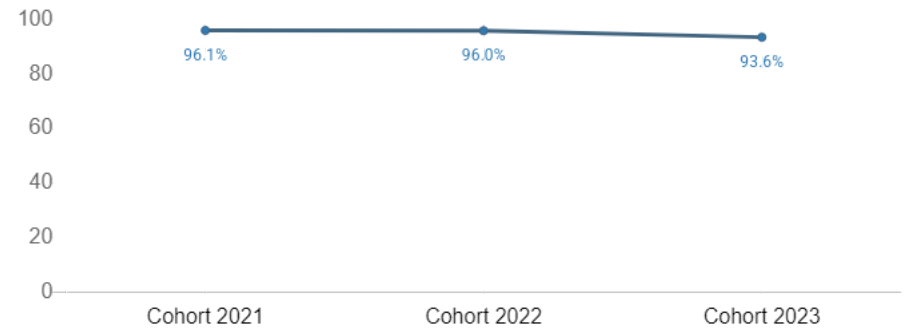

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

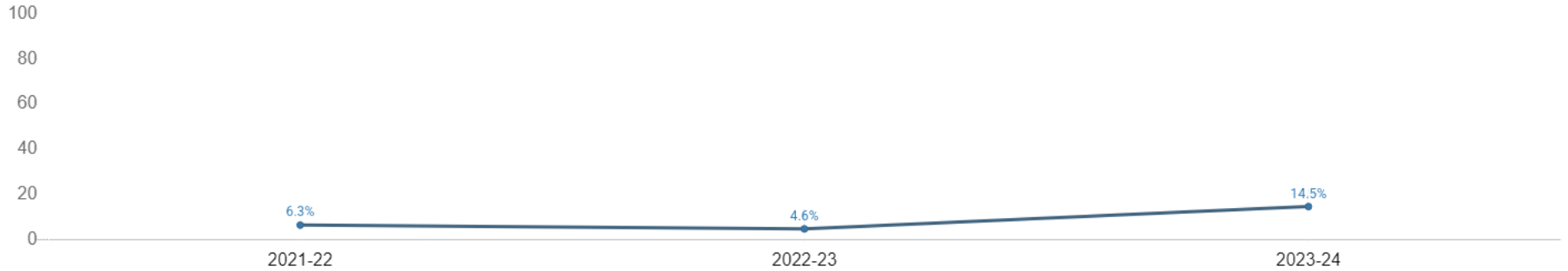

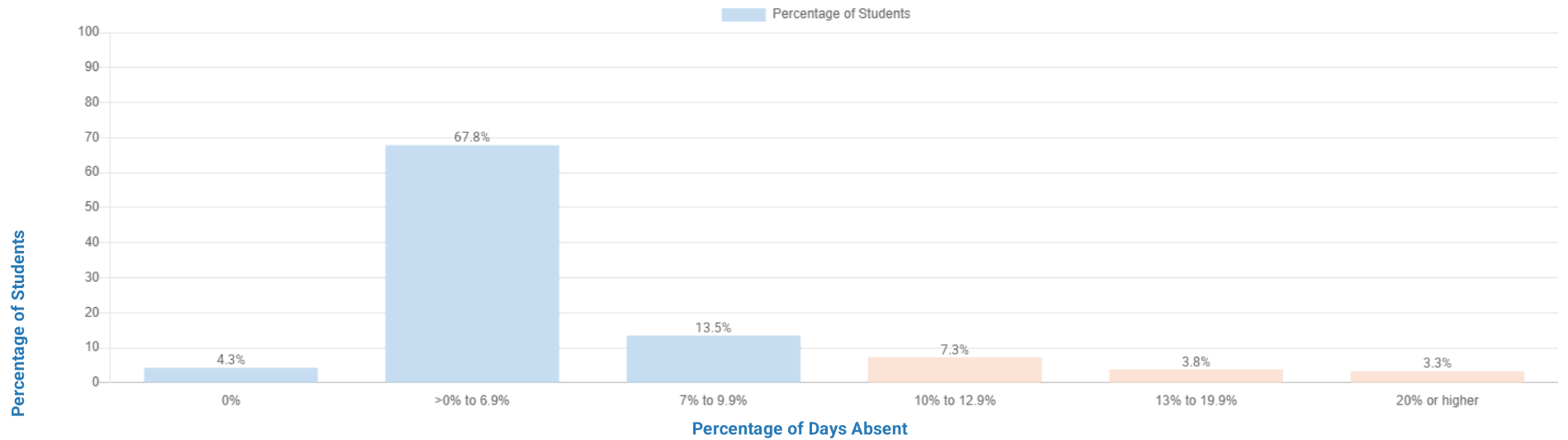

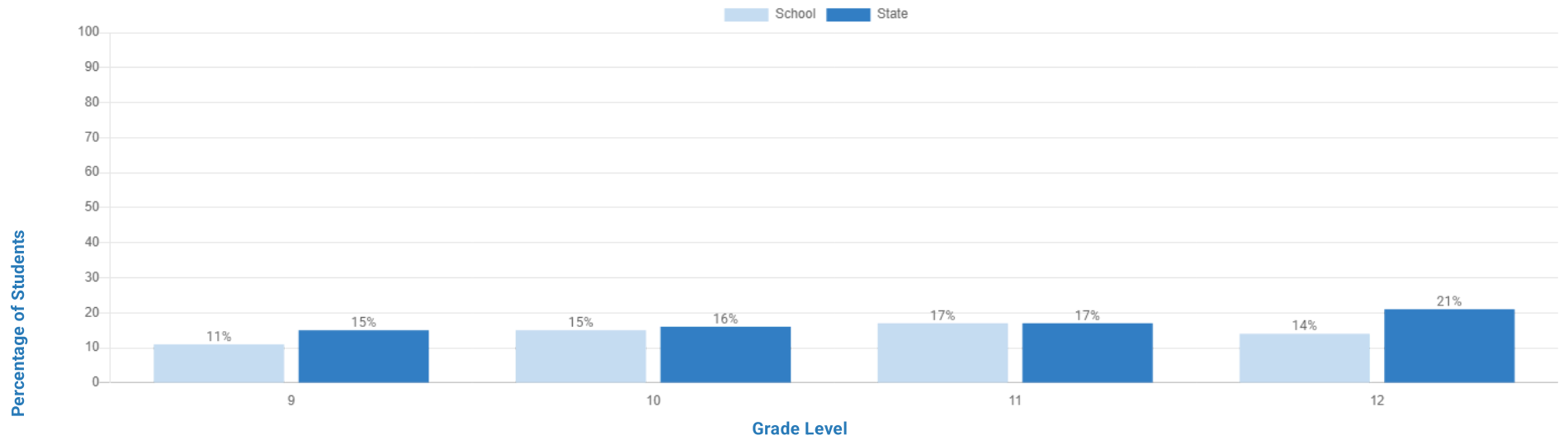

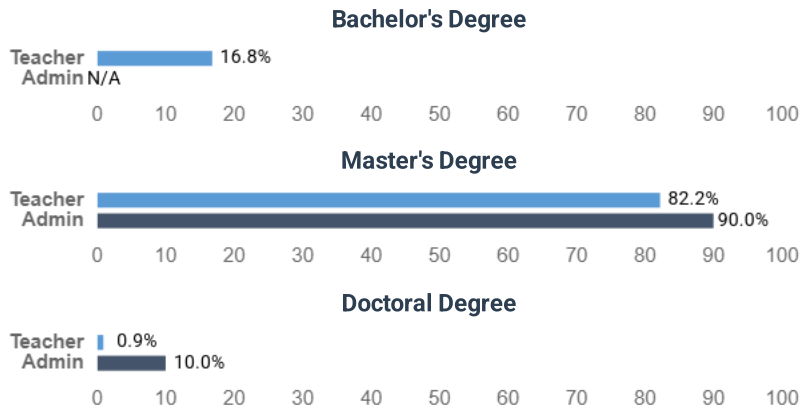

Middletown High School North offers 28 AP courses, 25 dual enrollment opportunities, 34 honors courses, 22 athletic programs, electronic textbook availability and student-centered daily advisory periods to provide support and enrichment. There are core and elective subject area directors and math/language arts interventionists. Our students have access to 17 shared time vocational programs and 1 full time program. All curricula are updated and aligned with state standards. The elective course options develop skills necessary for college and career readiness, Pathway and Academy Programs. College credits are awarded through Brookdale Community, Seton Hall, Fairleigh Dickinson and Rider University. Administrators attend School Safety, Security and Crisis Management workshops, HIB trainings and Lifelines Training.



Postsecondary Information:

In the 2023-24 school year, approximately 74% of Middletown North graduates pursued higher education by attending 2 or 4 year colleges/universities. The remainder of the Class of 2024 opted for business/technical schools, Armed Forces, full time employment or were undecided on their next steps. This diverse range of choices reflects the unique goals and aspirations of each individual as they chart their future. MHSN hosted college, trade and military representatives, NCAA Night, Financial Aid Night, Kick-Off to College Application Night, Awards assemblies. Yearly administration of school day PSAT testing for 10th & 11th graders. Student Supports and Services:

We have ELL and ESL courses. The Child Study Team at HS North offers services for students with IEPs. The Child Study Team consists of school psychologists, social workers and learning consultants. We have a full time SAC, guidance department, 2 full time nurses, Speech services, OT services, and PT services. Students can receive extra help from their teachers and NHS tutors. There is a Random Drug and Alcohol Program and additional supports for students in our Vision and Bridges programs. We also have a Dual Diagnosis Program through ESS and provide therapy sessions for students through ESS and YMCA counseling.



Student Health and Wellness:

Social, emotional and behavioral support services are provided through Effective School Solutions (ESS), the Vision Program, Bridges, Dual Diagnosis and outside mental health professionals who are housed in the school. Additional mental health/addiction treatment is offered on a referral basis. The Guidance Department and the SAC publish the monthly Community Resources Series on the website to focus on Social and Emotional Learning target areas. We have a Random Drug and Alcohol Program, a Breakfast Program and Blood Drives. Health screenings are provided by the nurses. Students in 9th and 12th grade participate in suicide prevention lessons from the Lifelines curriculum in their Health class. A selected group of identified freshman students meet weekly with the SAC for focus groups. Staff and students are trained in CPR.



Parent and Community Involvement:

PFA meetings are held with presenters from the community. We offer 8th grade Open Houses, 9th Grade Orientations, fall and spring musicals, partnerships with local senior citizen organizations and various NJ colleges and universities. The home-school connection is maintained through the Parent Portal and Naviance, phone blasts, the North website and twitter feeds. We have Middletown Friends of Different Learners and affiliation with Crossroads, Middletown Art Center, Middletown Public Library, Bayshore Success Center and YMCA. The district works collaboratively with the Police, Fire and EMS Departments.

Technology and STEM:

MHSN is a one-to-one device school that provides all students with Chromebooks and Google for Education accounts. An Educational Technology Specialist and Library Media Specialist support teachers in implementing digital tools and resources into the curriculum, as well as manage the school's Maker Space. Other technology/STEM programs/resources include, but aren't limited to Summer Technology Internship Program, Student Library Program, Tech Club, and eSportsClub. Classes are offered in Innovation and Design, Graphic Design, Technical Drawing, Aerospace. Design and Technology, TV and Film Production, Architecture and Spatial Design, Photography. There are 3-D printers for student and teacher use. Our new Active Learning Lab is equipped with wall whiteboards, personal whiteboards, and flexible seating. The District has furthered its commitment to technology/STEM through its high school STEM Pathway program and Digital Media Arts track of the New Arts Academy.

We have a pre-school program for children ages 3 - 5.
