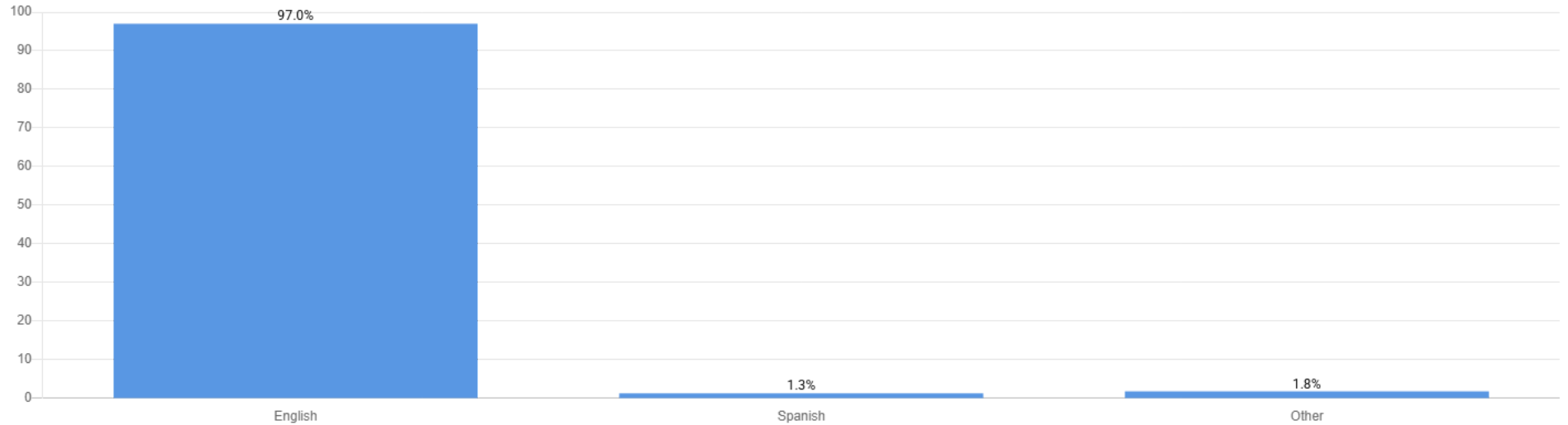

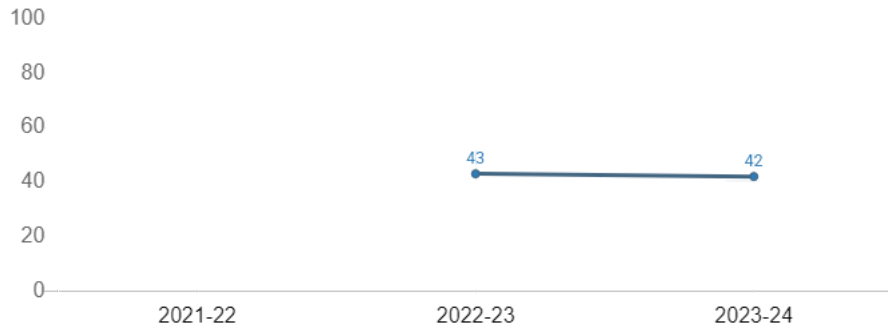

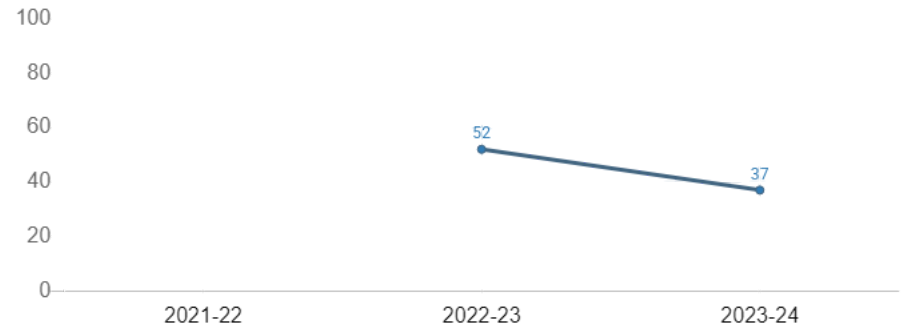

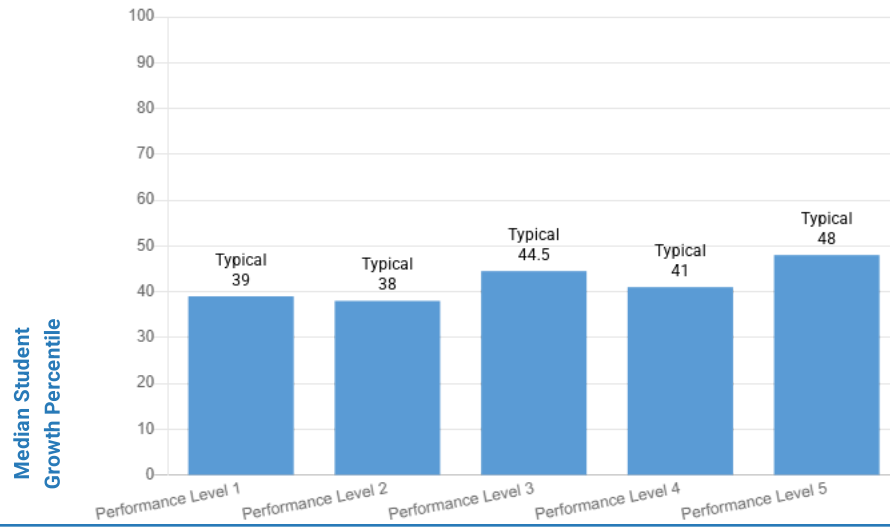

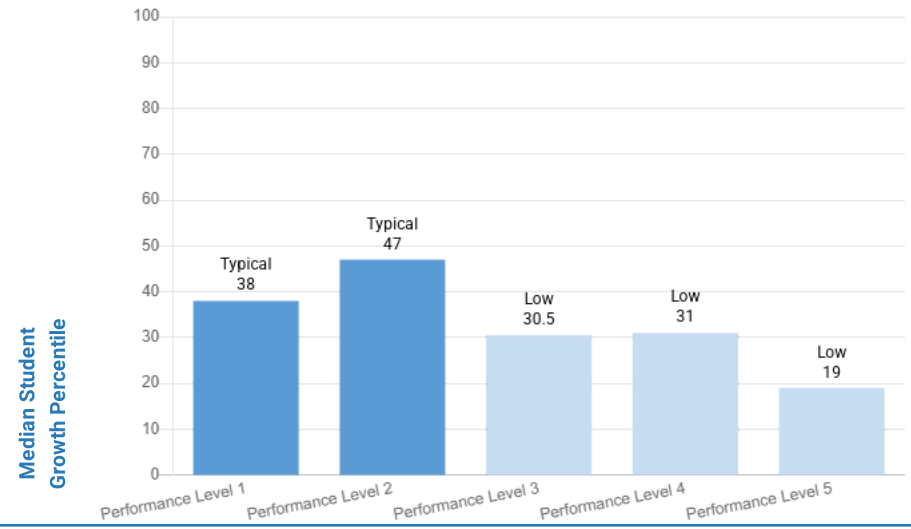

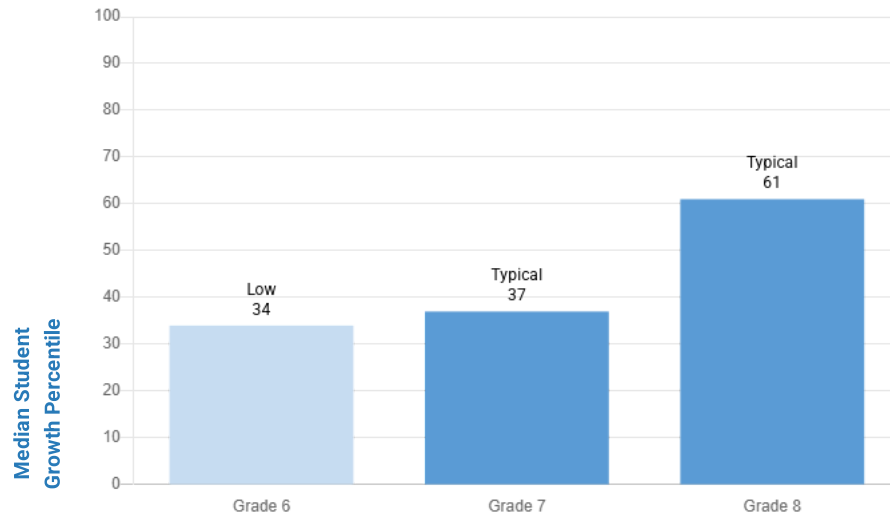

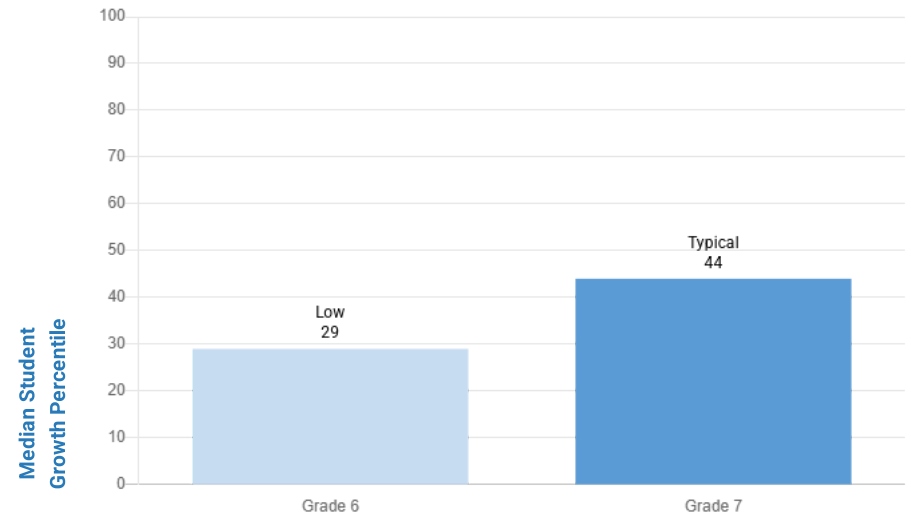

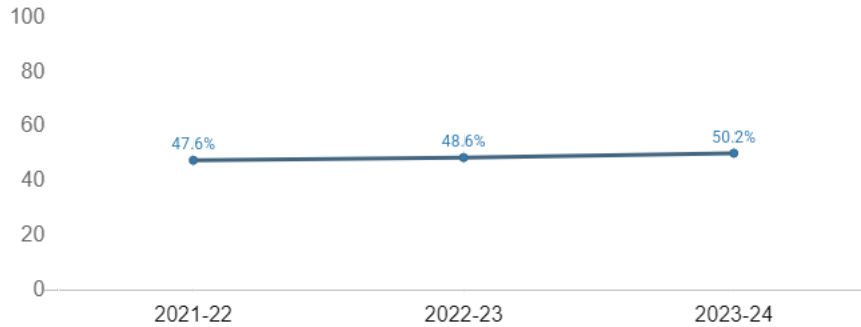

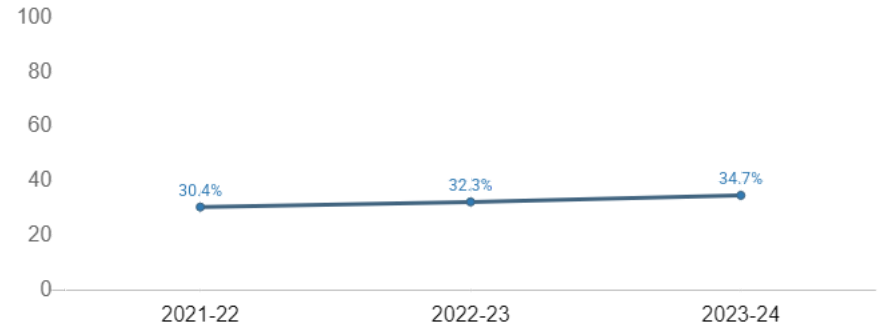
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 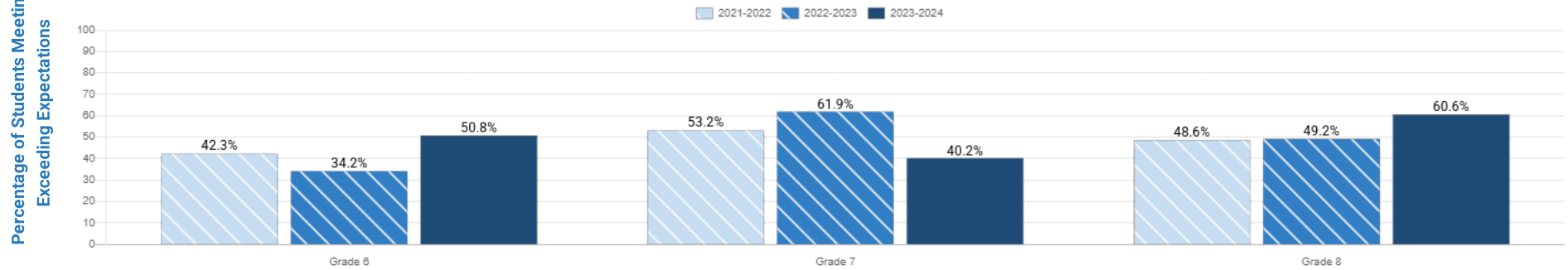

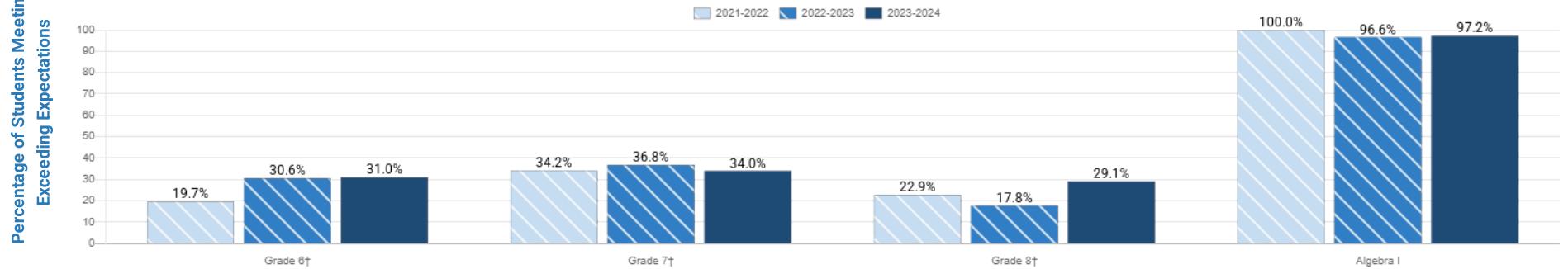

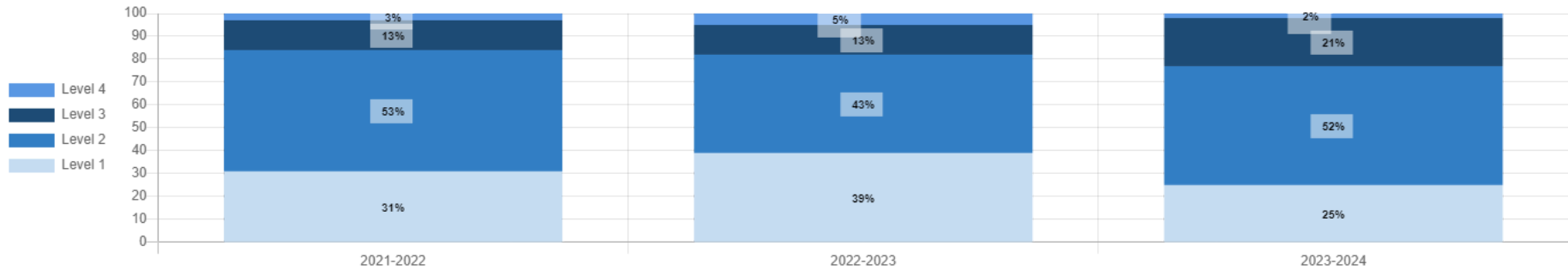

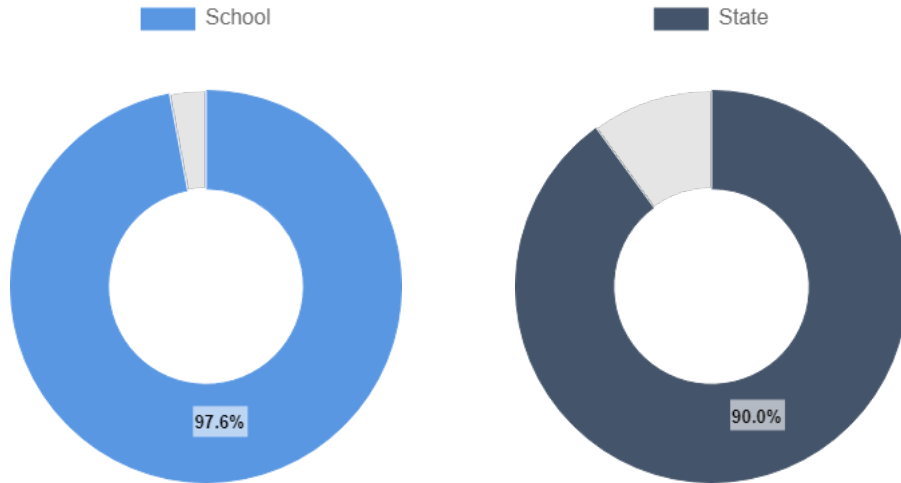

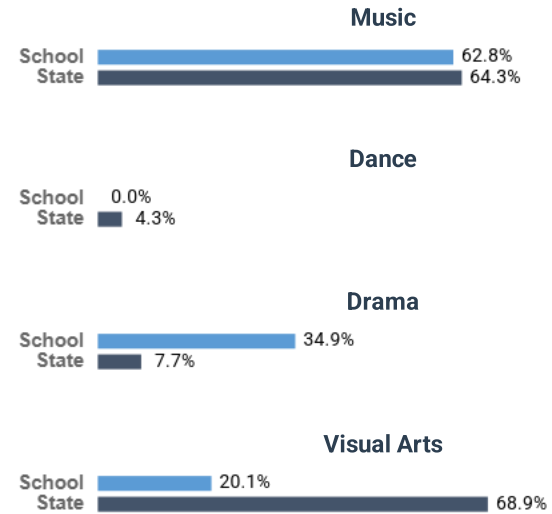

Students enrolled in one or more classes by discipline:



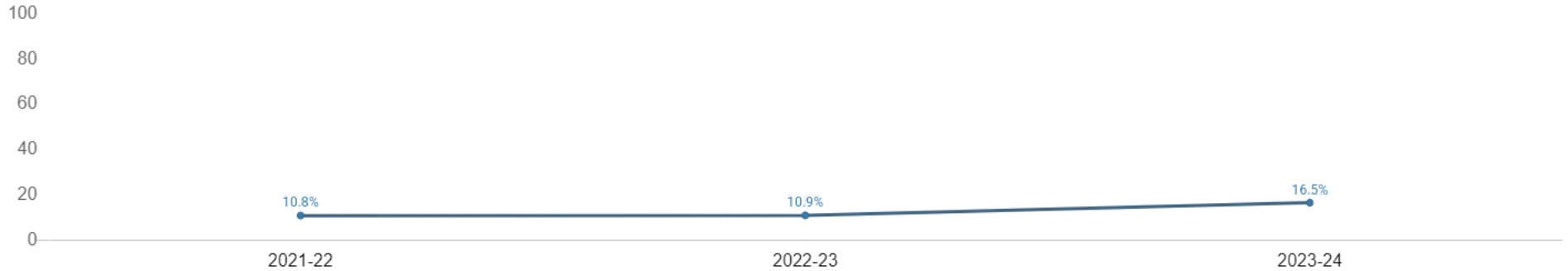

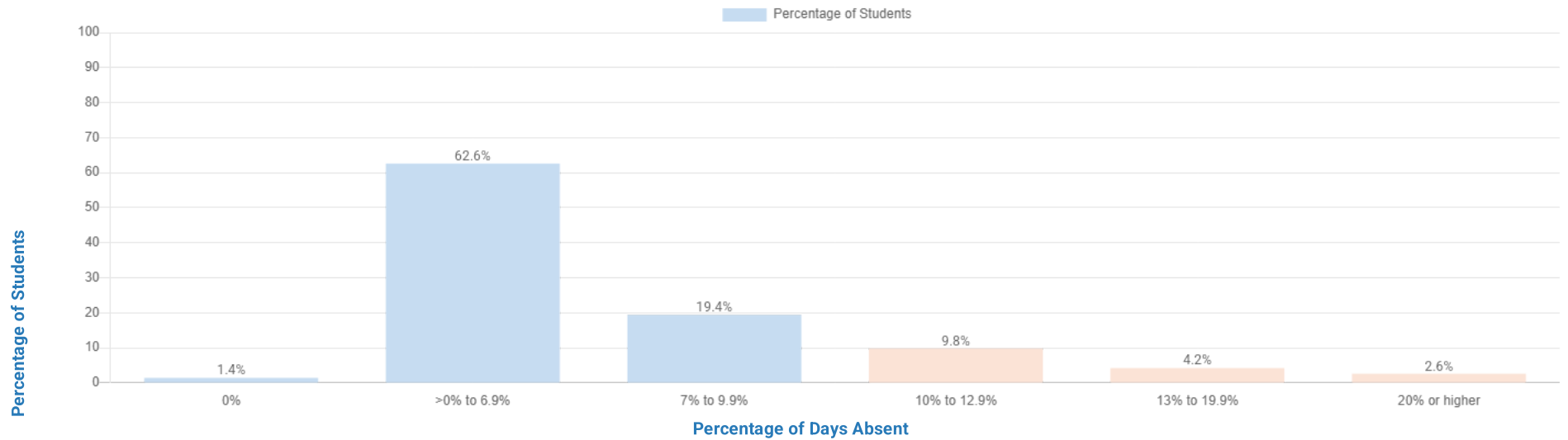

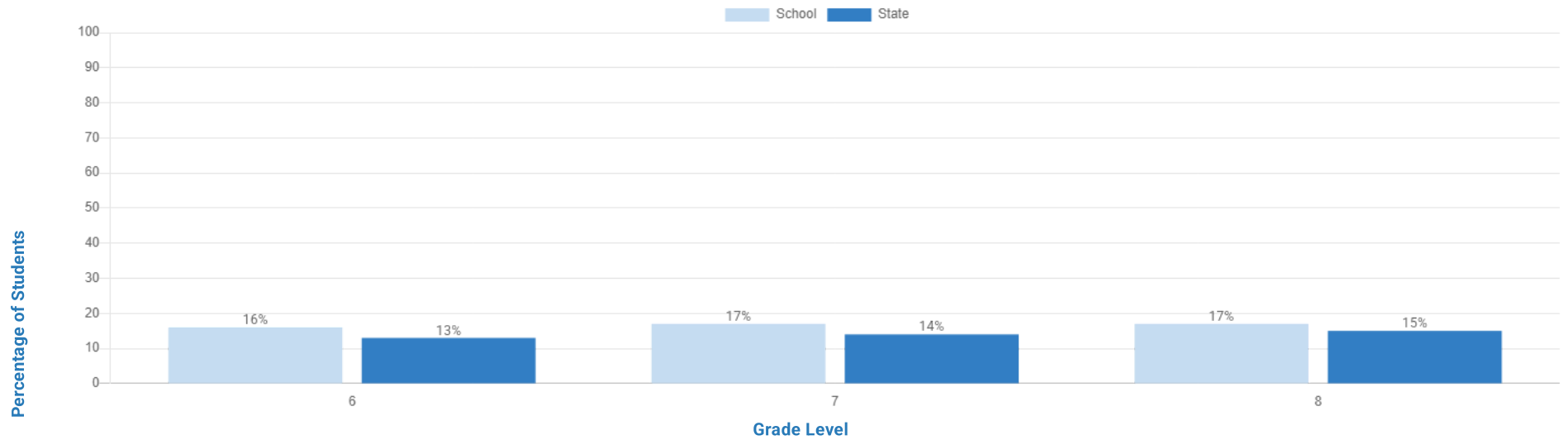

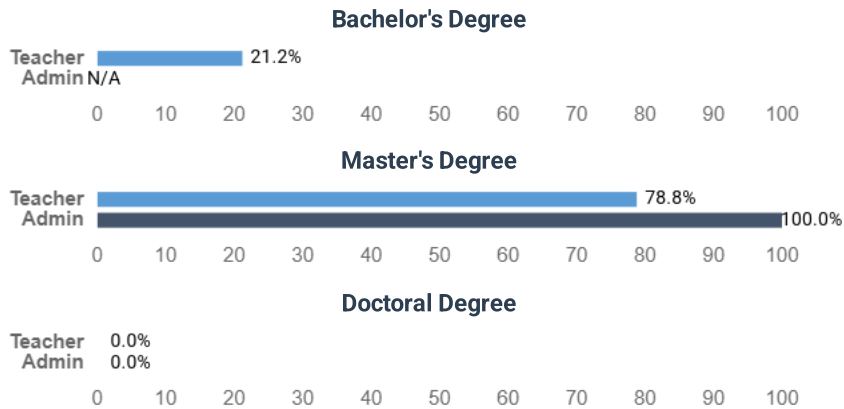

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. The academic program at Thorne has been designed to provide a rich learning environment for all students which consists of the four core subjects: Language Arts, Math, Science and Social Studies. In addition, students will take Physical Education and Health, a wide range of Activity Arts courses, or Band or Chorus. World Language offers both cultural immersion and language-based courses. All students have an Advisory period for 3 marking periods (out of 4) and the schedule is balanced with 6 sixty minute classes a day plus a lunch period.

The After School Learning Academy provides targeted instruction to bolster student achievement. The Lions Lead program has been developed by the School Learning Design Team as part of a Social Emotional Learning initiative. The program provides for after school activities in an effort to enable students an opportunity to feel more connected to the school and improve school climate.



Staff and Professional Learning:

Teachers are involved in departmental, grade level, and teacher teams for the purpose of articulation, planning, and best practices. Groups meet weekly and/or several times throughout the year, along with both district and building generated professional development. An emphasis is put on teacher leadership in the development and presentation of Professional Development. Teachers participate in the district's Professional Development Hub which allows them to personalize their learning. Teachers are provided with the opportunity to pursue a Personalized Reflective Practice and Independent Study option to help personalize their practice.



Student Supports and Services:

Thorne supports its students with special needs through in-class support, resource room, and self-contained educational programs within the school. Intervention and Referral Services are used as an additional means of student support as are student specific 504 plans. Thorne School Initiated ESS's Bridges Tier III Program for classified students and Tier II for all students who require additional services.

Thorne has a full student support staff consisting of grade level Guidance Counselors, a full Child Study Team, a Student Assistance Counselor and a full time nurse, all who participate on the school's Crisis Team. Thorne is provided with additional outside counselling services from the YMCA. The Lifelines curriculum has been embedded in the district's Middle School health curriculum.



Parent and Community Involvement:

The PTA meets monthly to update the community and solicit feedback. The PTA has a Facebook page and a page on the school website. The school communicates with the community via a website, a phone blast/e-mail blast/text blast system, Twitter, and Facebook. Each student has been provided with a Chromebook and actively works in a 1:1 digital environment on a daily basis.
