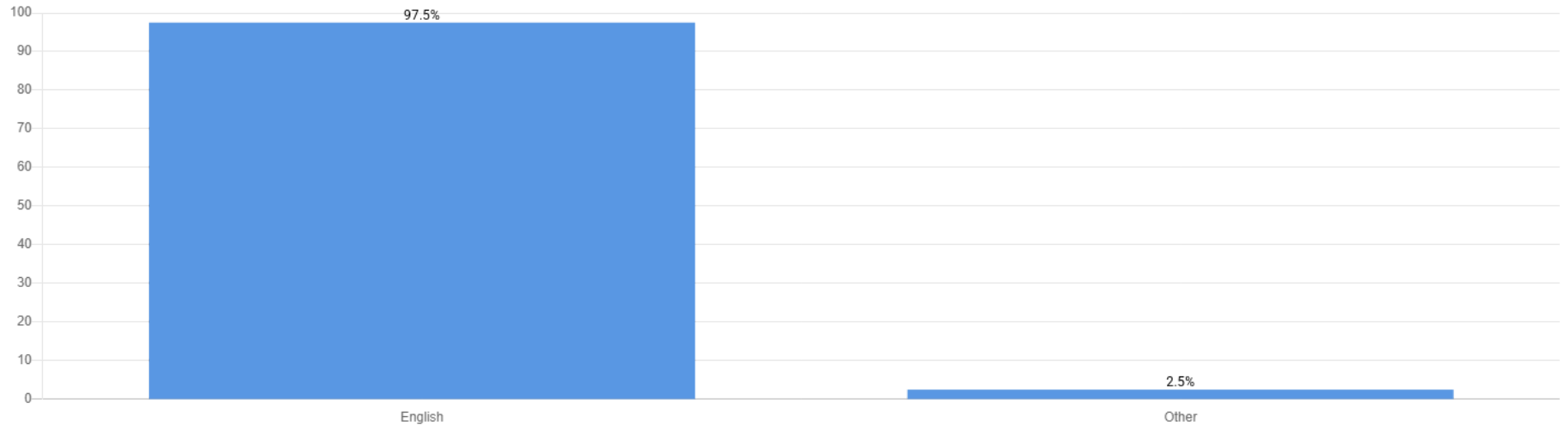

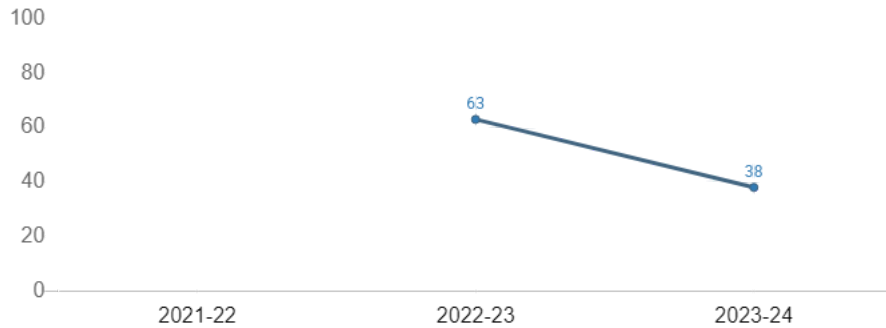

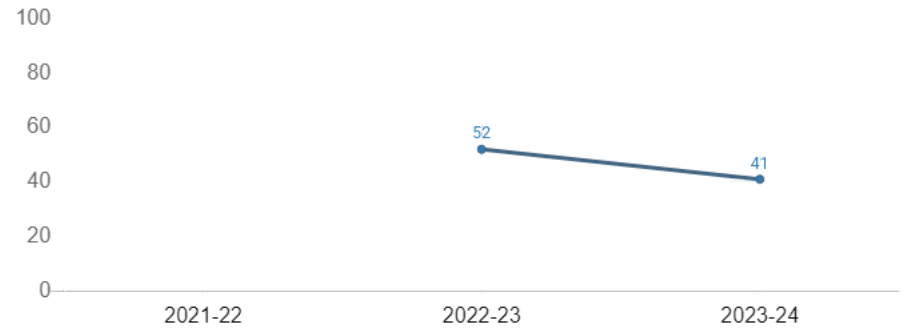

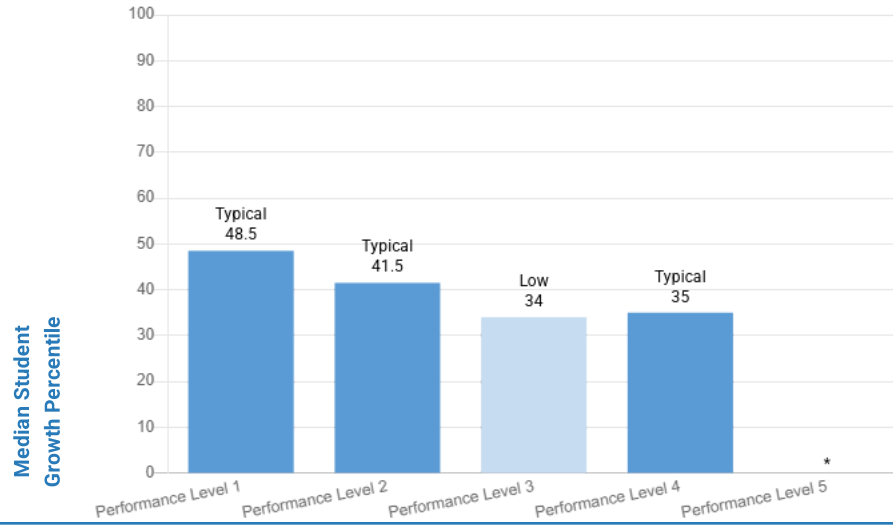

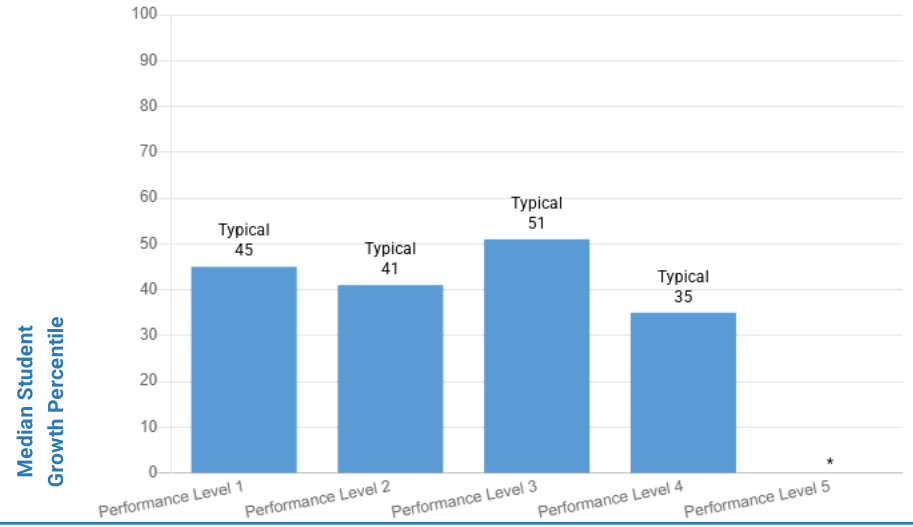

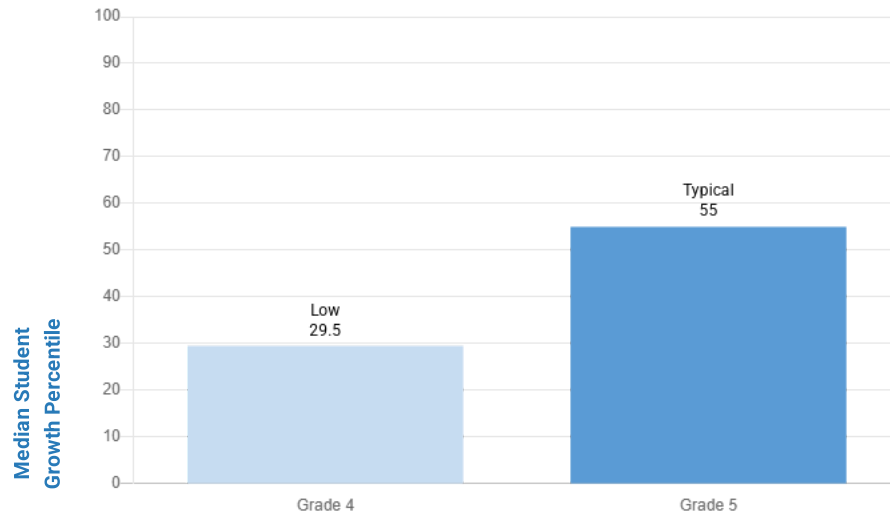

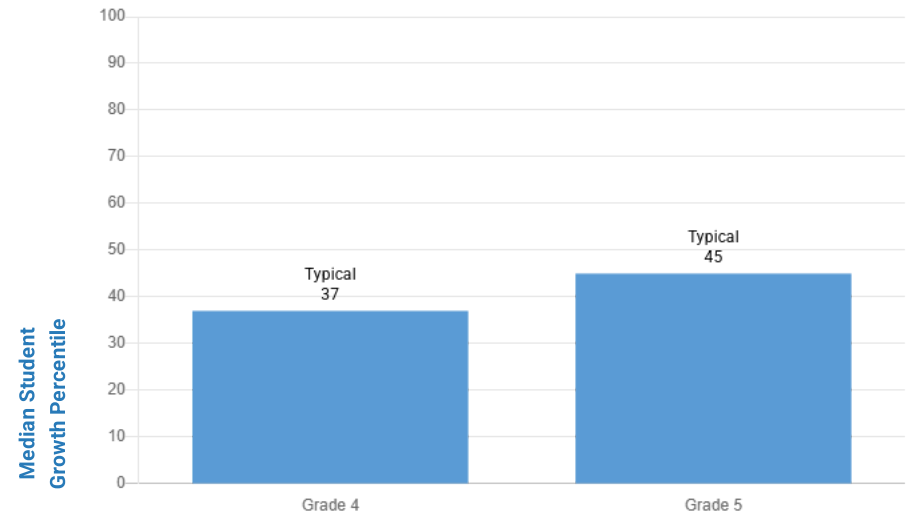

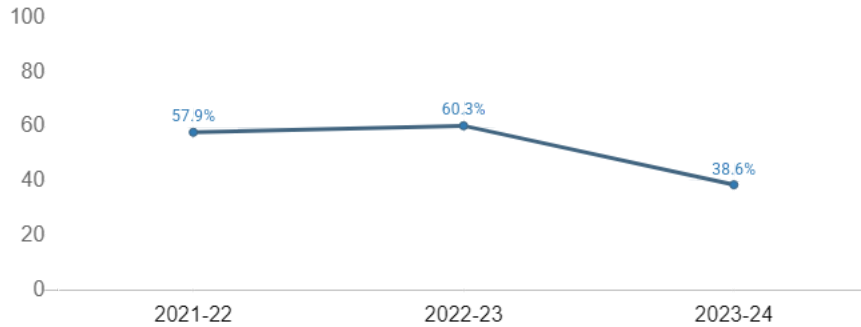

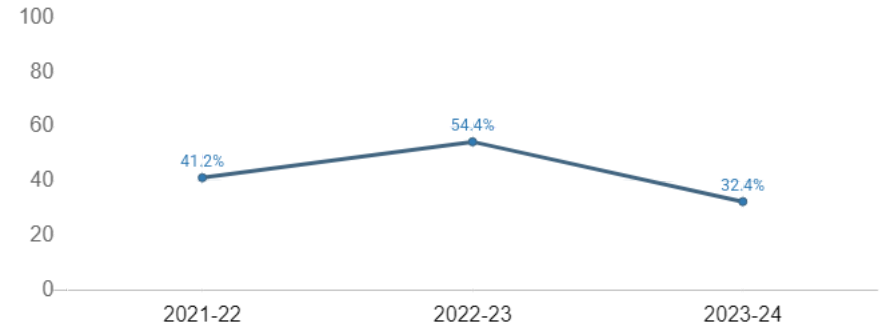
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 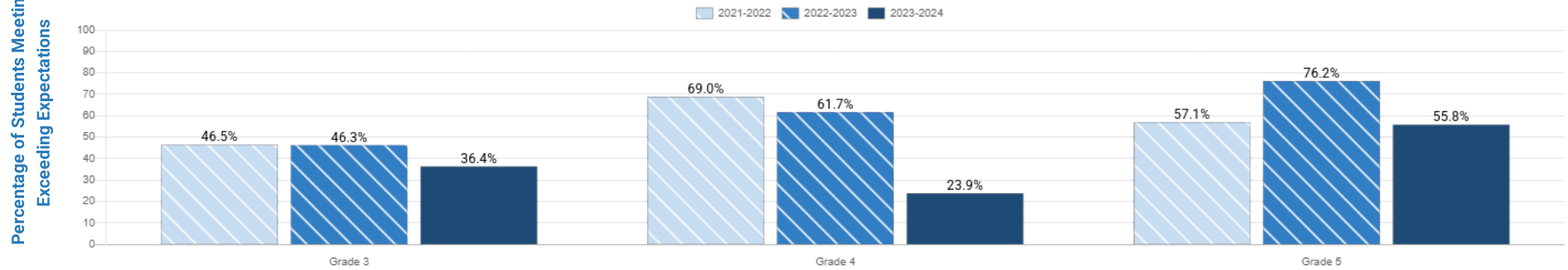

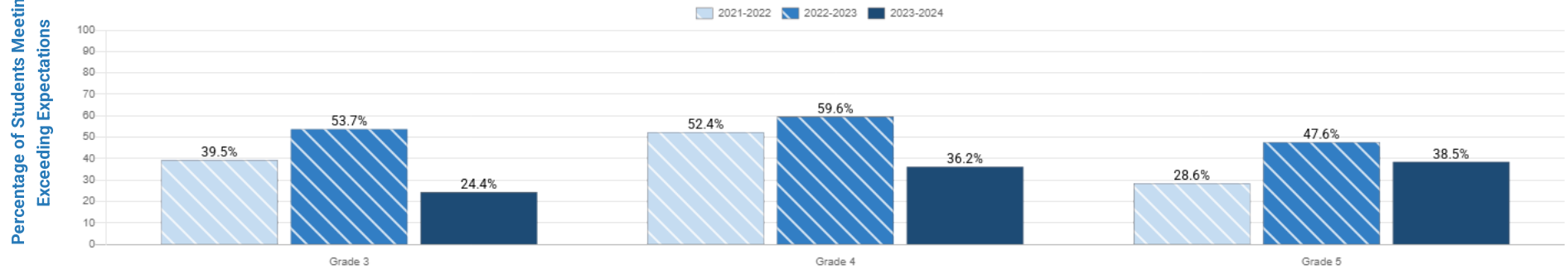

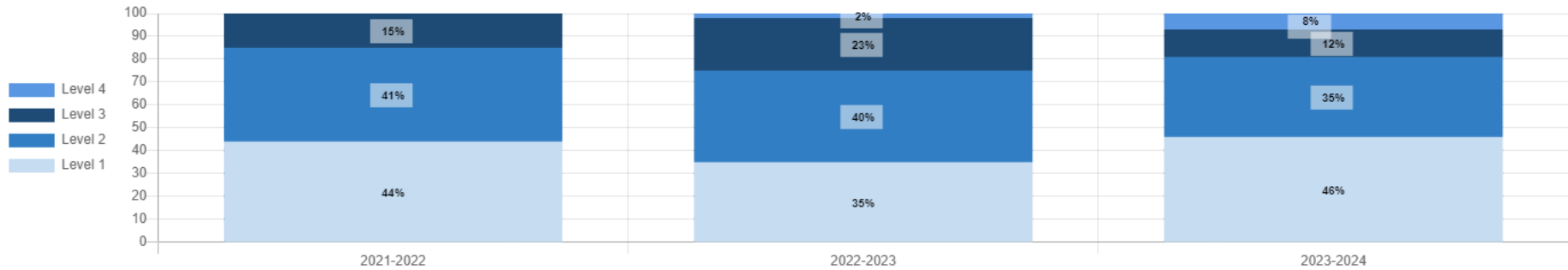

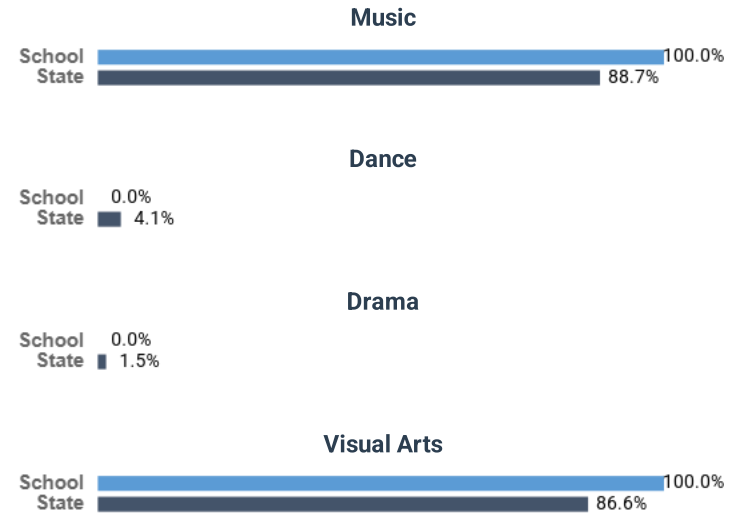

Students enrolled in one or more classes by discipline:



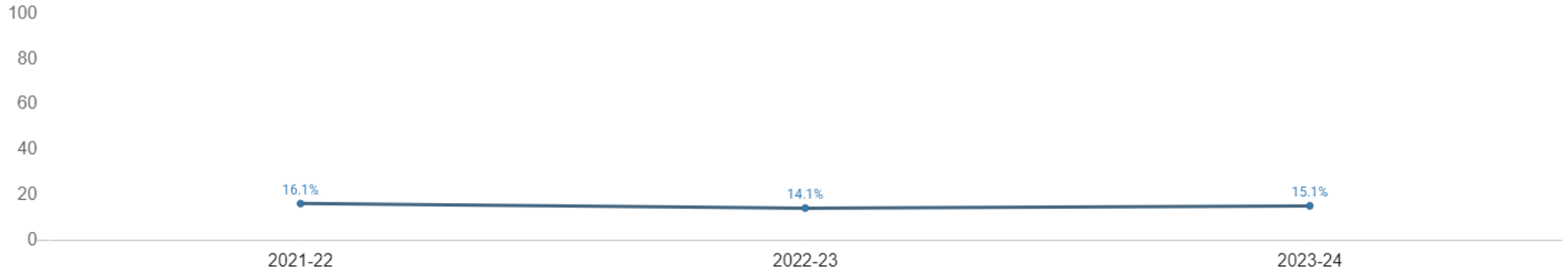

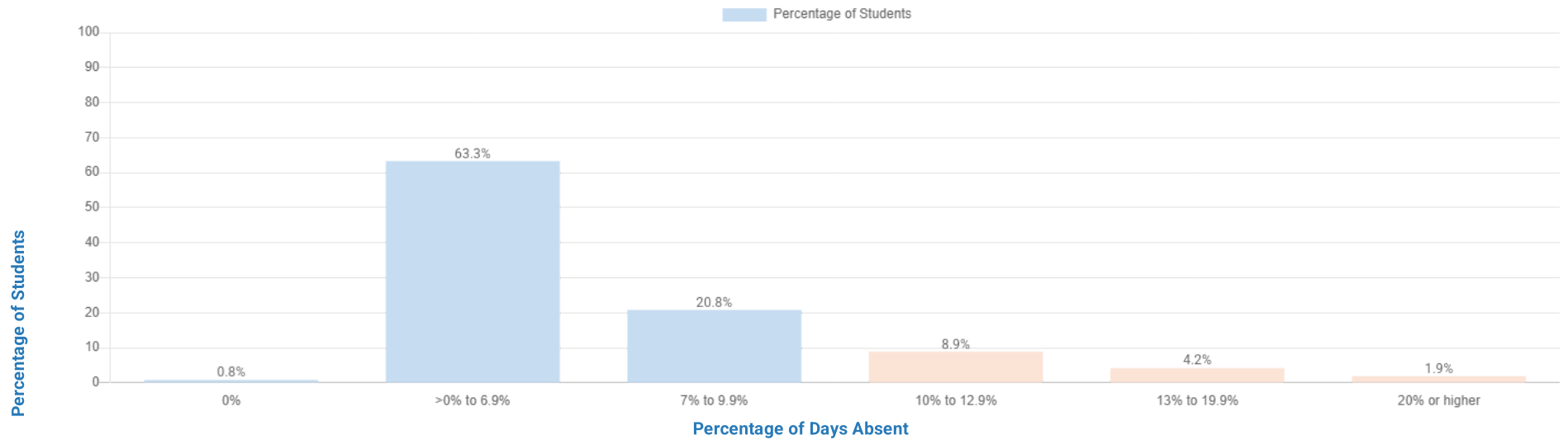

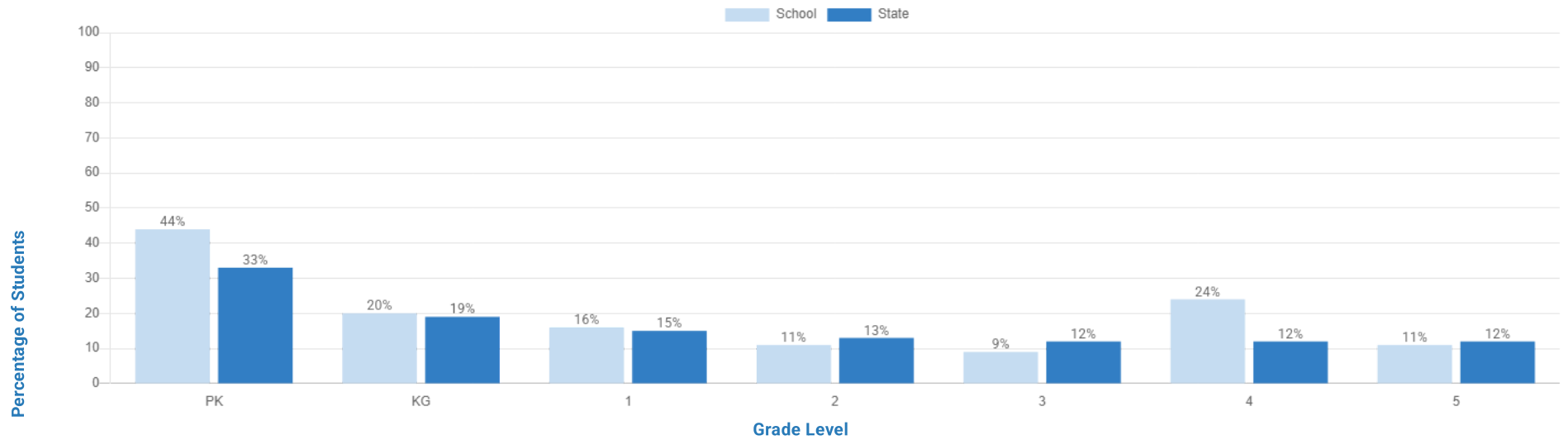

Staff

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. 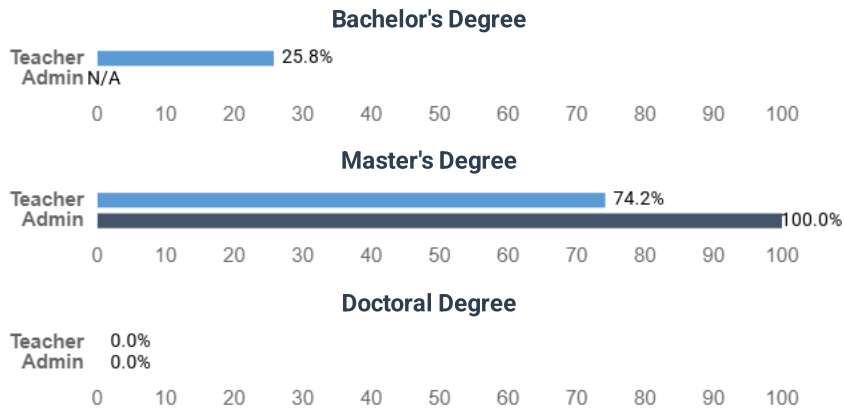

Staff and Professional Learning:

Teachers are engaged in purposeful and personalized professional learning experiences throughout the year. Within the district, structures have been put in place to support teachers as they participate in professional growth opportunities such as independent studies, personalized reflective practice experiences, job-embedded professional learning, micro-credentialing and teacher-facilitated conversations as they work towards individualized professional learning goals. All teachers also participate on an ongoing basis in Professional Learning Community work, which is spearheaded by the leadership of designated Learning Design Teams within each building. Learning Design Teams lead building-level experiences, through a PLC-like structure, that stimulate professional dialogue to inform decision-making and increase instructional capacity to positively impact student outcomes. Each teacher is provided an extra period per six-day cycle as an embedded grade level PLC session.



Student Supports and Services:

Ocean Avenue works hard to be a supportive and inclusive community and we are committed to supporting students, families, community members and staff. Our unique histories and experiences are central to building a strong community.



Student Health and Wellness:

Ocean Avenue devotes much time to developing the social and emotional capacity of our students. We partner with the Bayshore Family Success Center to offer on-site counseling services to our students. This program is offered by the YMCA. Our school psychologist provides a variety of groups that support coping, social skills, and executive function. We provide families with many community resources that offer nutritional, financial and mental health assistance.

We have assembly programs that enrich all areas of the curriculum and provide students the opportunity to enrich learning by attending field trips. The school community partners with many community agencies to foster involvement.

School Safety:

The Middletown School District continues to put student and staff safety as its top priority. We work collaboratively with police and other emergency management personnel to develop and carry out our strategic school safety and security plans and ensure maximum effectiveness and efficiency in allocating security resources.



Technology and STEM:

District initiatives based on technology and STEM are supported through daily innovative practices within our classrooms. Student driven, hands-on activities, that include coding, robotics, engineering and design, inspire students to demonstrate creativity, explore 21st century topics, generate projects of interest and develop deeper understandings that prepare them for future academic success. Our school is equipped for 21st century learners. Technology, such as Interactive Light Boxes, Chromebooks, iPads, and document cameras are utilized to engage learners and enhance learning. Students in grades 3-5 each have been assigned a Chromebook and actively work in a 1:1 digital environment on a daily basis. Beyond the classroom, we offer students opportunities to deepen their understanding through the Technology club's after school STEM programs. A course designed to support Digital Design and Literacy has been implemented in grades K-5.



Early Childhood Education:

The Middletown Township Preschool Program utilizes The Creative Curriculum- Teaching Strategies GOLD for Preschool. This curriculum is scientifically researched based, approved by the New Jersey Department of Education, Division of Early Childhood Education and aligned with the New Jersey Preschool Teaching and Learning Standards. The Online Creative Curriculum through Teaching Strategies, provides hands-on learning with best practices for developmentally appropriate activities. OAS currently has three Pre-k programs that are full day.
