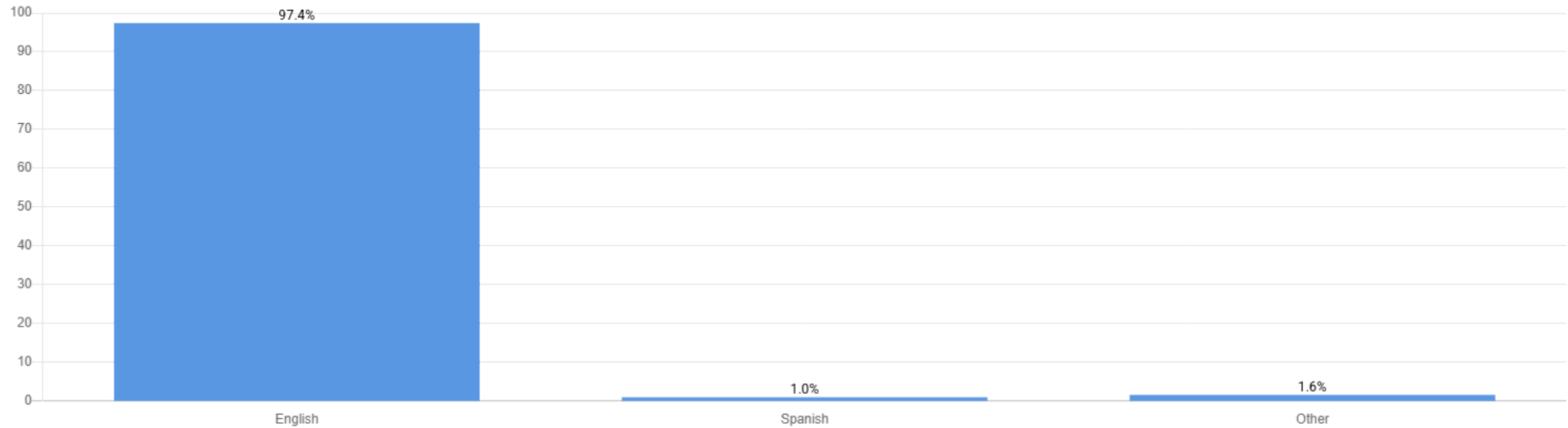

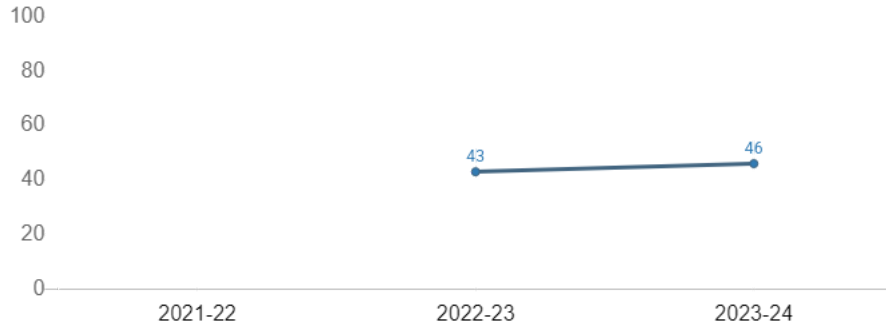

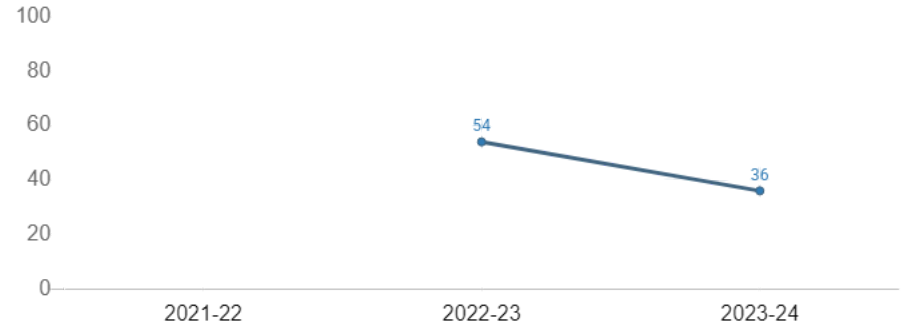

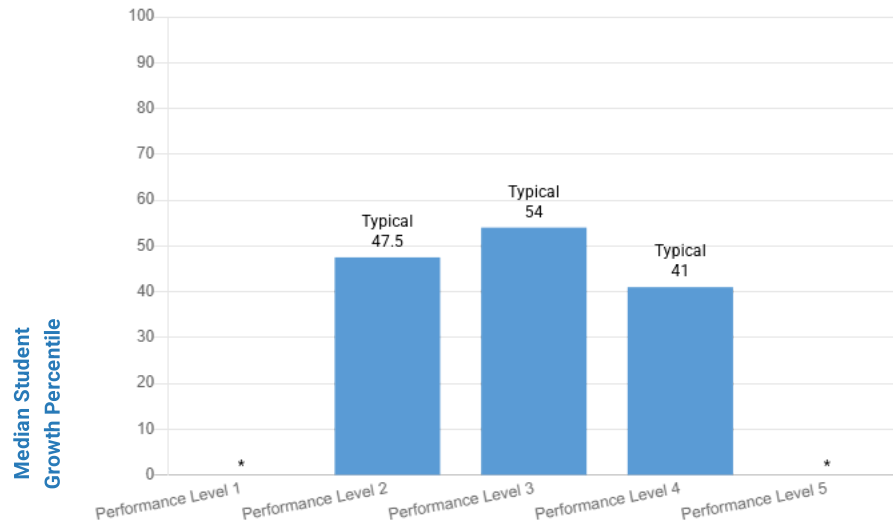

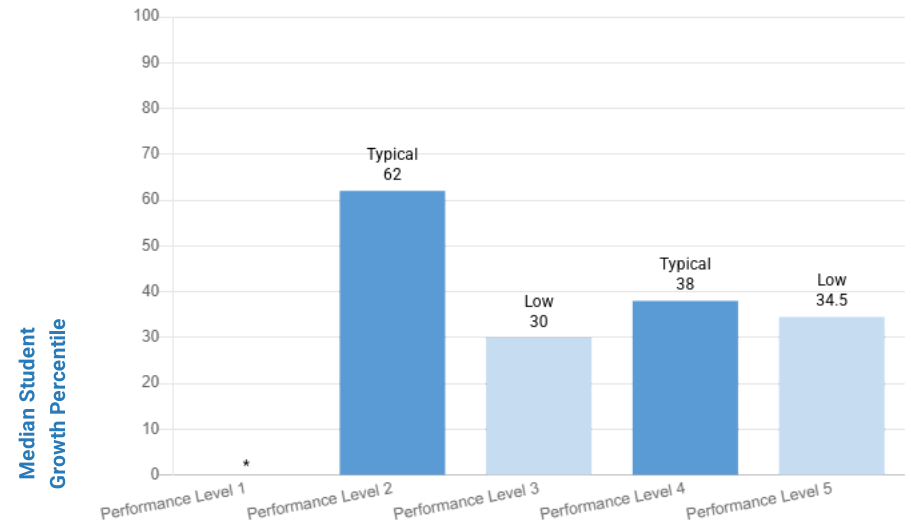

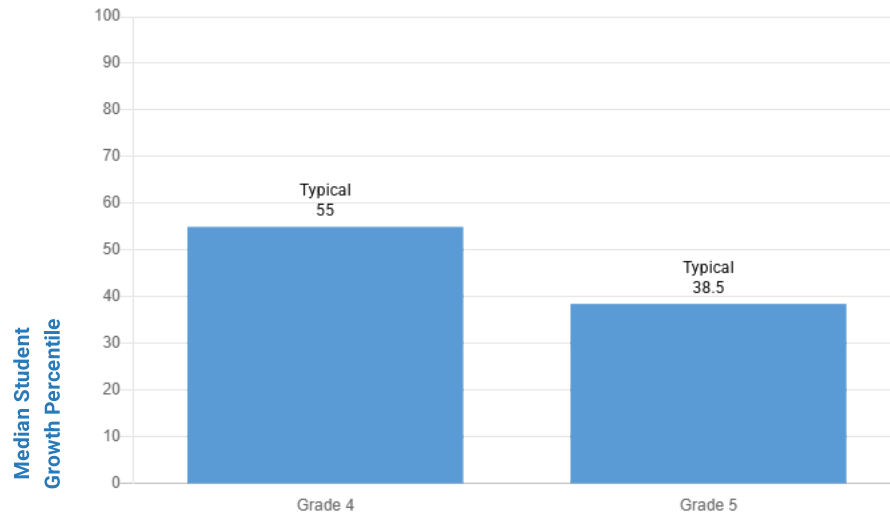

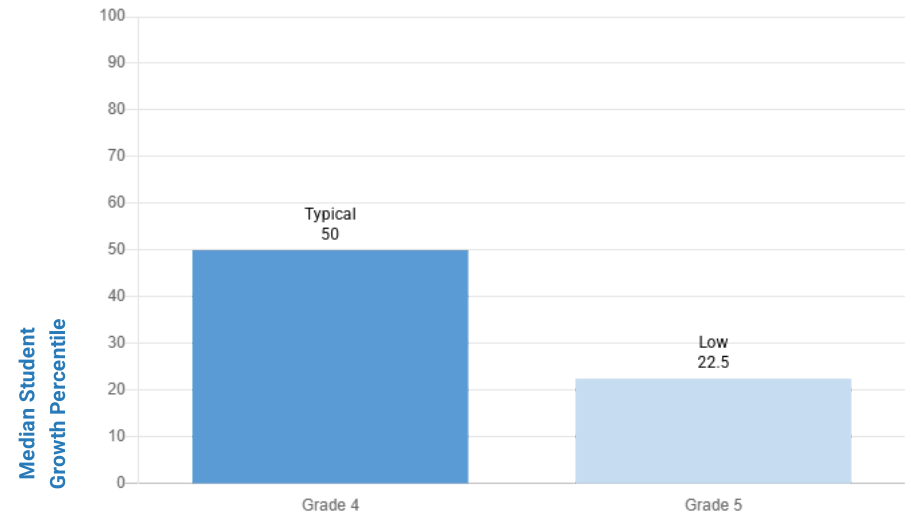

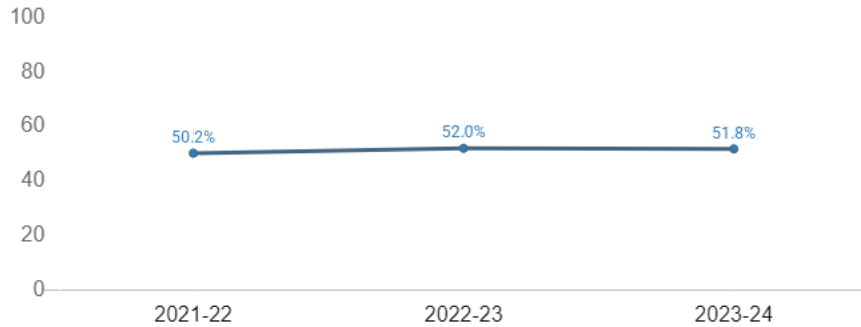

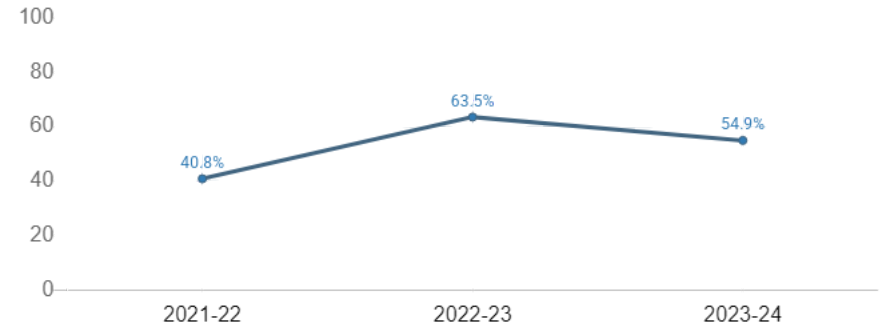
English Language Arts and Mathematics Performance Trends

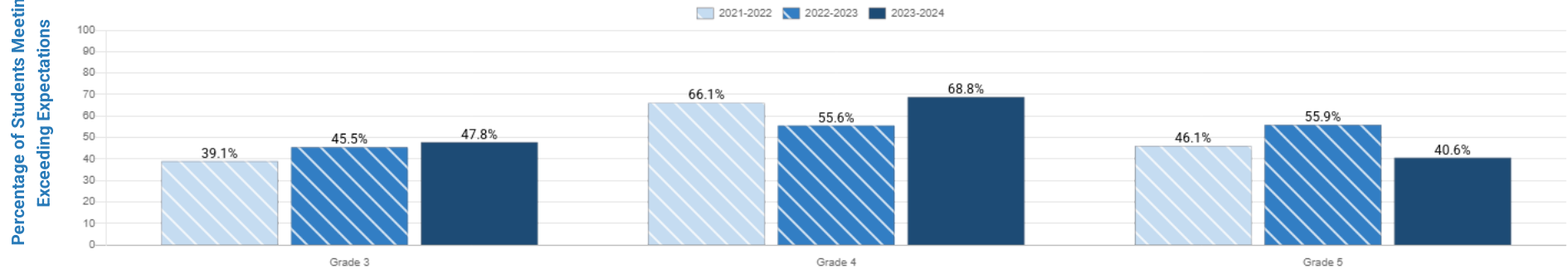

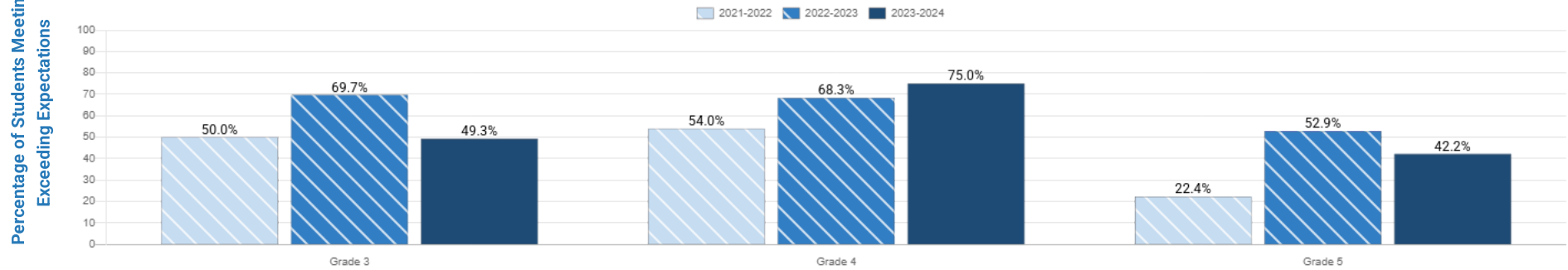

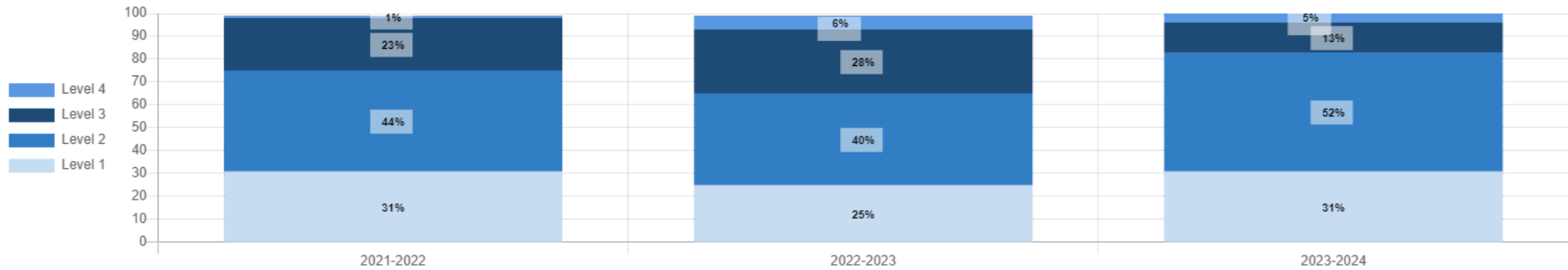

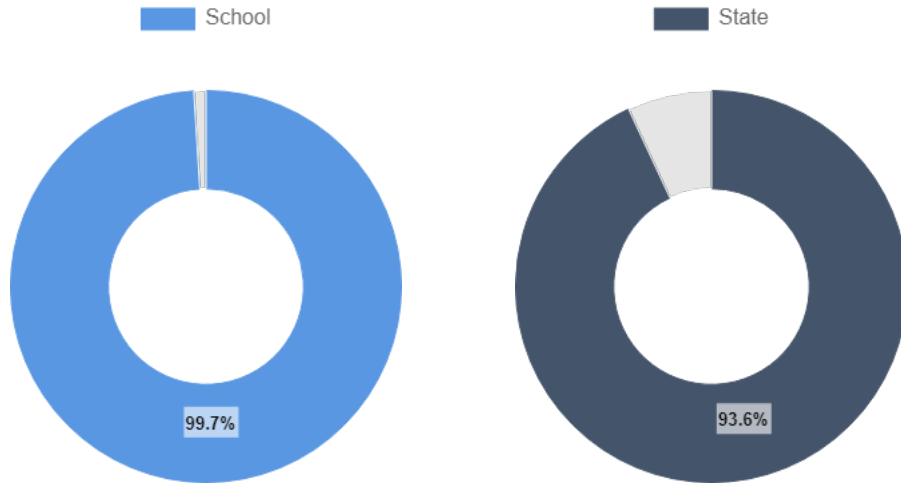

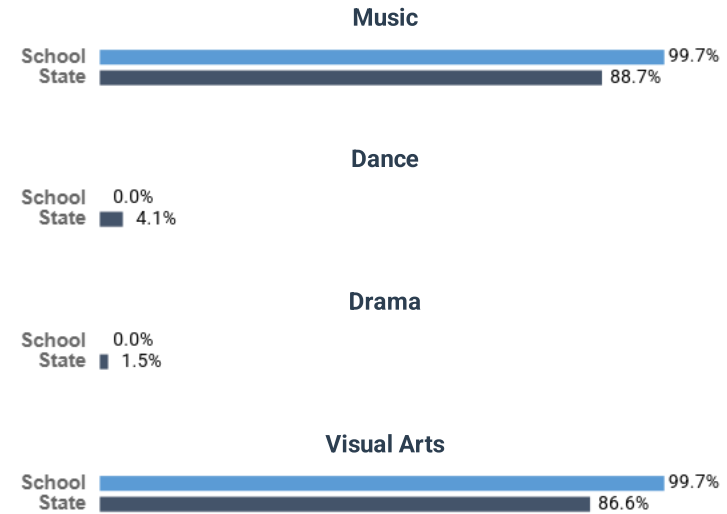

Students enrolled in one or more classes by discipline:



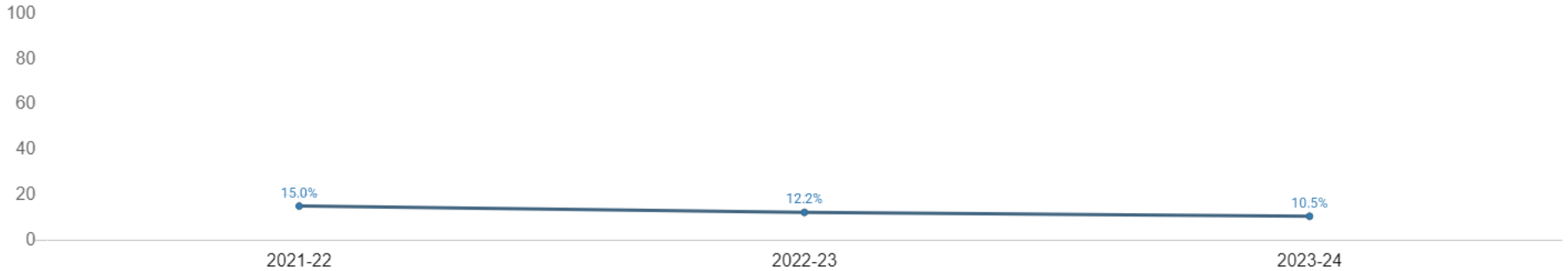

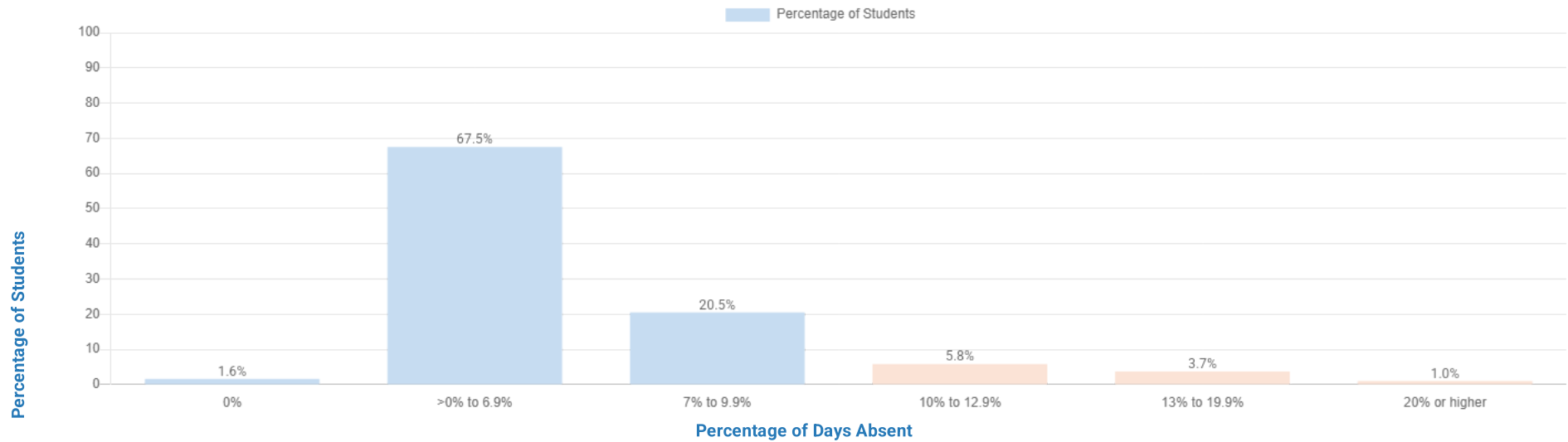

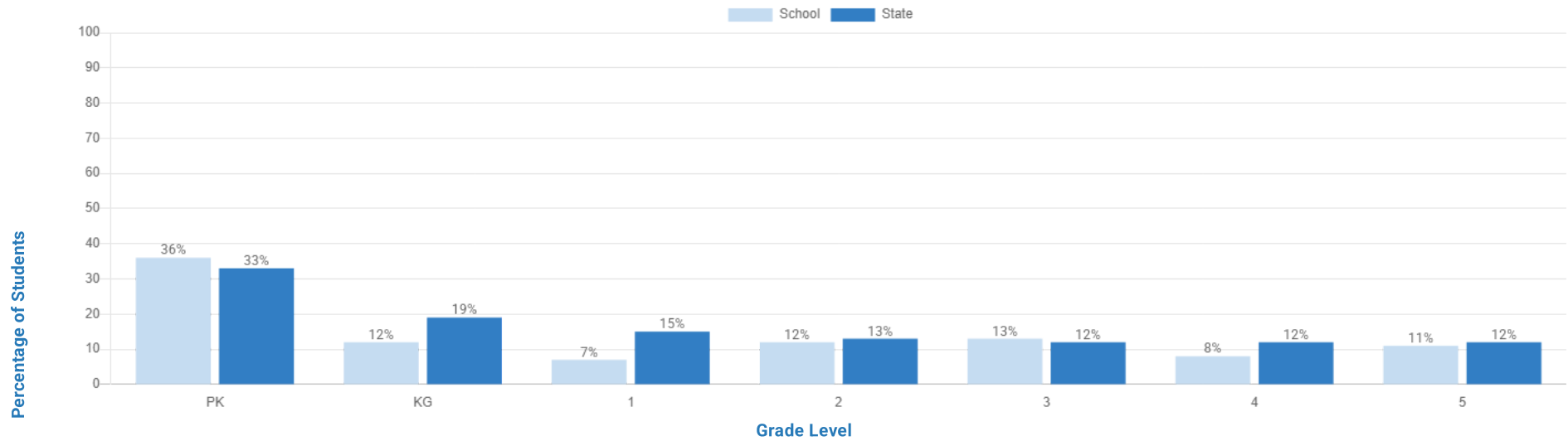

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

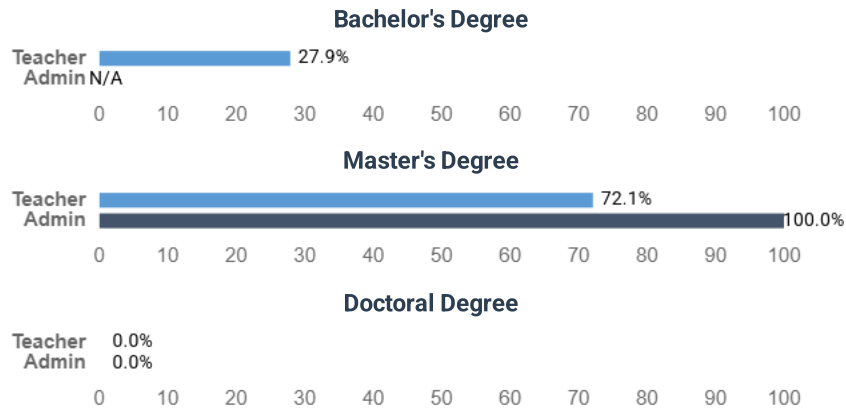

Courses, Curriculum, Instruction:

The teachers differentiate instruction and modify/adapt curriculum units to provide an interdisciplinary program. We use a workshop based literacy program that integrates the main components of Reader's Workshop utilizing authentic literature and informational text, word work and guided reading during instruction in grades 3-5. Formal writing instruction is through the workshop model of instruction in grades 3-5. In grades K-2 we are piloting Magnetic Reading and iReady diagnostics for ELA instruction. Harmony utilizes the district adopted Investigations and enVision math program and Mystery Science curriculum to address the state learning standards.

Staff and Professional Learning:

Harmony School offers a comprehensive education rooted in the belief that students will become life-long problem solvers. Staff learning is extended through professional development where a school based committee reviews data to suggest deeper content understanding.



Student Supports and Services:

Harmony School includes one pre-school disabled class, three 1/2 day integrated pre-school classes, two full day integrated pre-school classes, ICR sections at each K-5 grade level, Resource Rooms, and an I&RS committee. Student interventions are approached in a Tiered Model.



Student Health and Wellness:

Harmony School offers Fit Club to all K-5 students. In addition, we promote overall wellness with planned brain breaks throughout the school day. Recess time at Harmony is 20 minutes minimally with one of the most used pieces of playground equipment in the Township both during and after school. Through a state funded grant, Harmony was able to add a new piece of playground equipment and a preschool playground too.

Surveys are administered via Google forms and feedback is collected and calculated automatically. Questions are taken from climate surveys that have been shared by the NJDOE. On the parent survey there was positive feedback offered in all areas pertaining to safety, learning environment, intervention, communication, and parent engagement. Additionally, faculty and staff offered feedback on decision making, safety, accessibility to proper teaching tools, and equal treatment. Finally, the students offered opinions and feelings about safety, trust, and learning. School administration and staff review the survey data to make recommendations on programing and school based activities that promote a positive school climate.



Facilities:

Harmony School was built in 1961 and has had four principals in that time with Mr. Erik M. Paulson being the most current since January 2011. We have an extensively used All Purpose Room, Specials Room (art, music, & technology), and a state of the art conference room. Each classroom is air conditioned. The most recent large scale facility project included adding solar panels to our entire roof to promote clean-green energy consumption.

Student driven hands on activities, that include coding, robotics, engineering and design, inspire students to demonstrate creativity, explore 21st century topics, generate projects of interest and develop deeper understandings that prepare them for future academic success. Our schools are equipped for 21st century learners. Technology, such as Light Boxes, Webcams, Chromebooks, iPads, and document cameras are utilized to engage learners and enhance learning. Students in grades 3-5 have each have been assigned a Chromebook and actively work in a 1:1 digital environment on a daily basis. K-2 classes are equipped with a class set of Chromebook devices.

The Middletown Township Preschool Program utilizes The Creative Curriculum- Teaching Strategies GOLD for Preschool. This curriculum is scientifically researched based, approved by the New Jersey Department of Education, Division of Early Childhood Education and aligned with the New Jersey Preschool Teaching and Learning Standards. The Creative Curriculum provides hands-on learning with best practices for developmentally appropriate activities.

Other Information:

We believe that a student's education encompasses more than just academic success. Our students social emotional health as well as the school's positive culture & climate impact our students success. Responsive Classroom is an evidence-based approach to teaching that focuses on engaging academics, positive community, effective management, and developmental awareness. As we move towards full adoption of Responsive Classroom philosophies and practices, our current focus is on mastering the Morning Meeting component. Students academic success is credited to students, teachers and parents working together as a cohesive group. The teachers differentiate instruction and modify/adapt curriculum to provide an interdisciplinary program with an emphasis on personalized learning. Our workshop based literacy program integrates the main components of Reader's Workshop using authentic literature and informational text, word work and guided reading. Formal writing instruction is taught through the workshop model of instruction. We utilize Savaas/Investigations Math. Math skills and concepts are supported with hands-on approaches to foster understanding and an appreciation for the world of numbers. Technology engages learners and enhances student learning. Students in grades 3-5 each have been assigned a Chromebook and actively work in a 1:1 digital environment on a daily basis. The special subjects provide the children many motivating learning experiences. Art classes study the products of the masters and engage students in activities of individual artistic expression. During physical education the children stretch, run and jump to help develop young bones and muscles. Vocal and instrumental music classes provide the opportunity for students to develop a love of music, and students receive instruction in World Language to acquire basic knowledge of the Spanish language as well as the rich culture.
