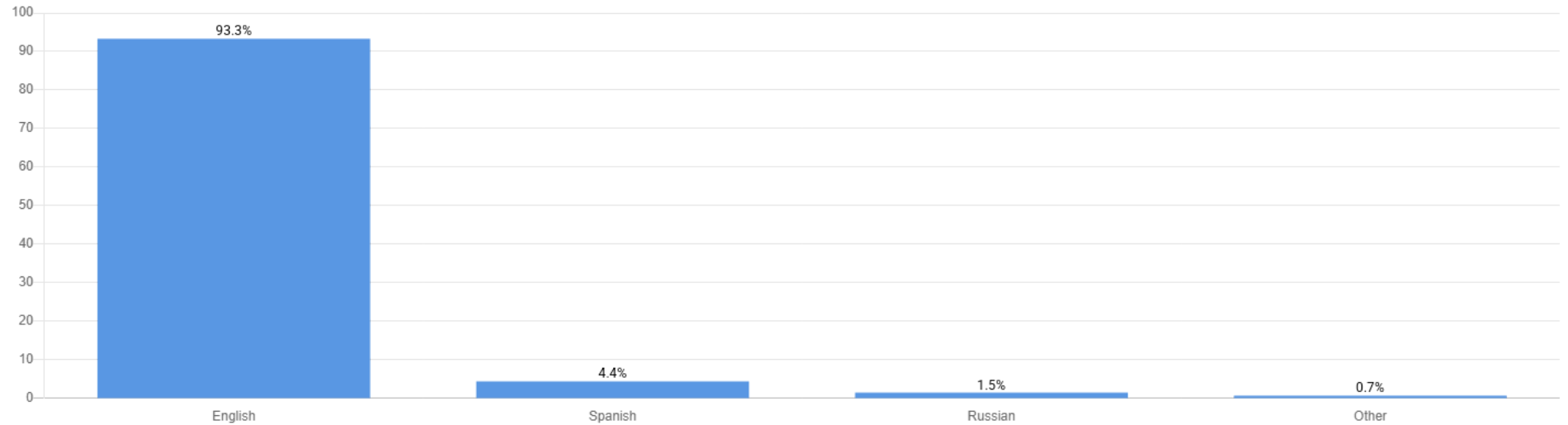

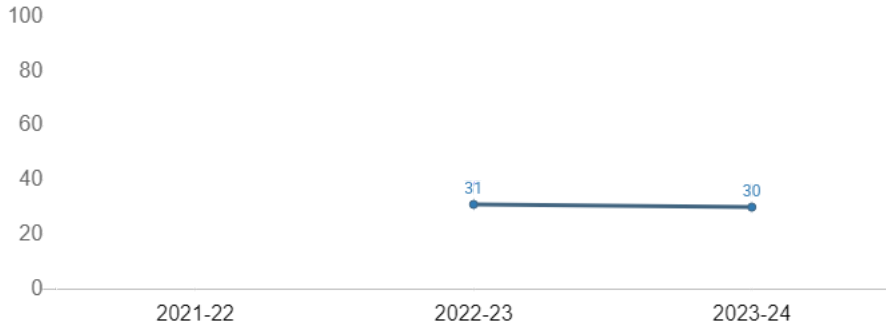

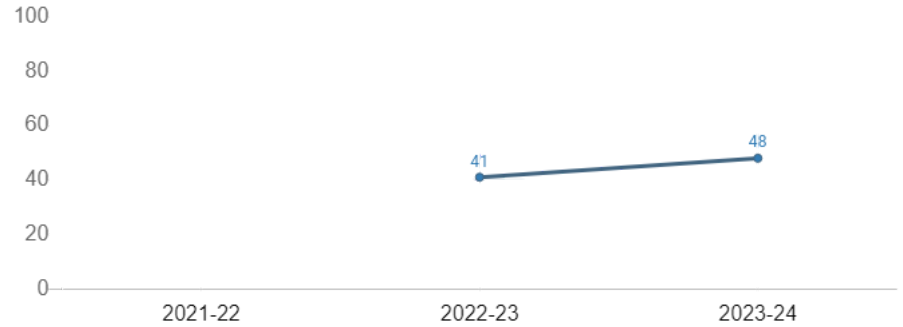

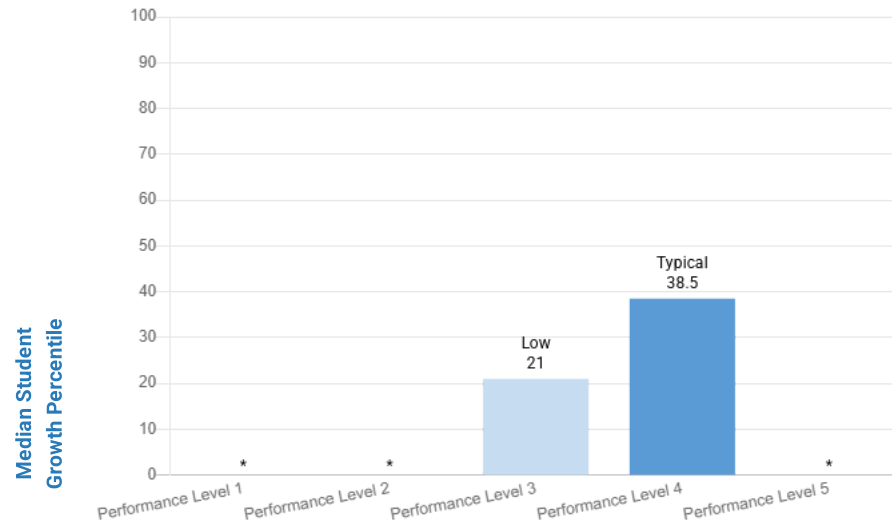

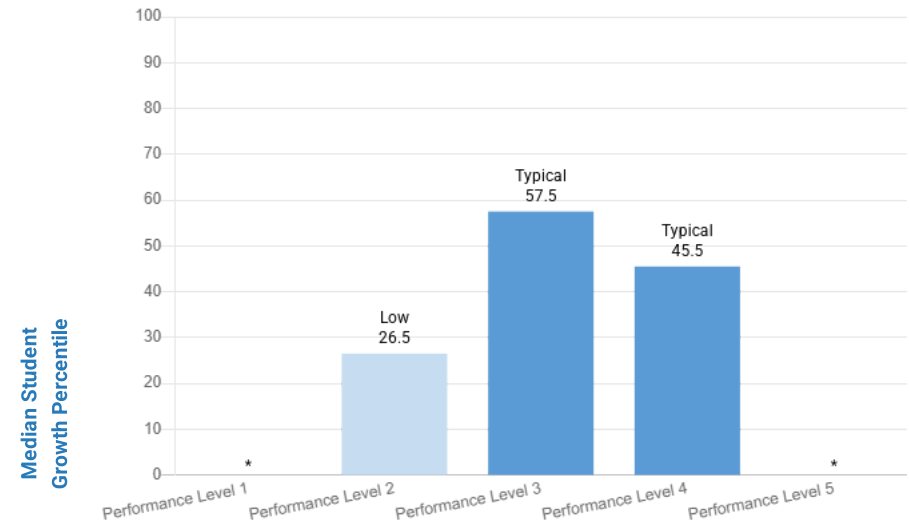

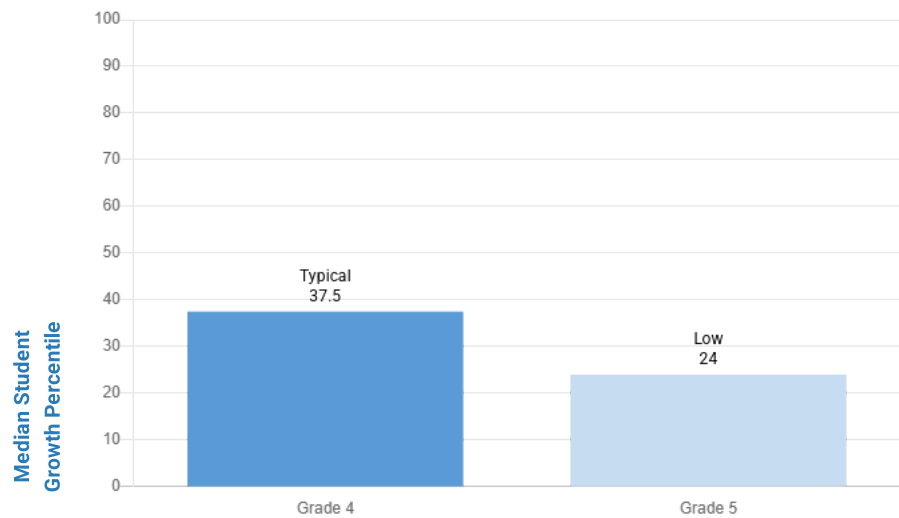

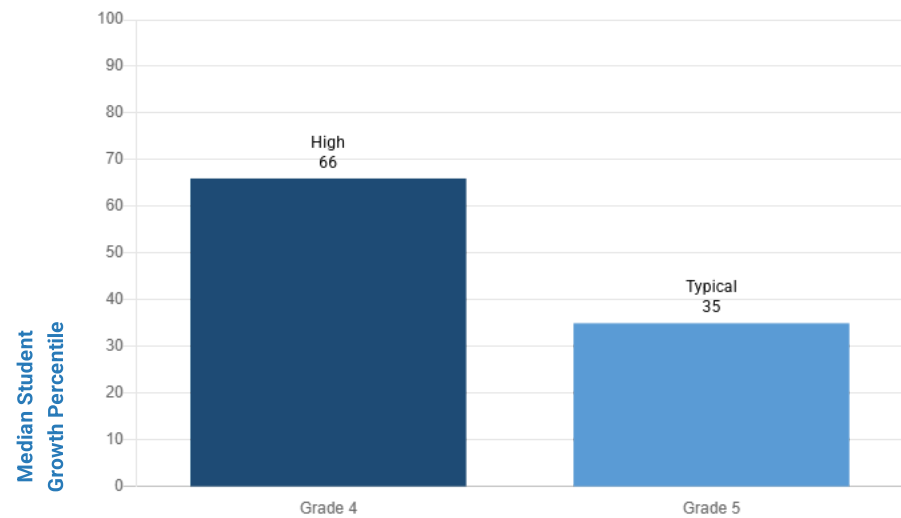

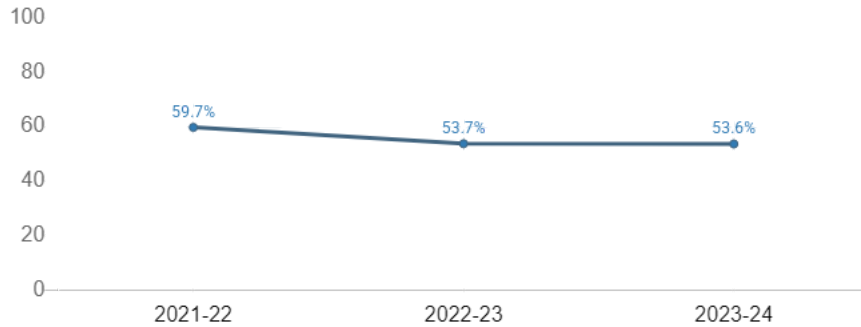

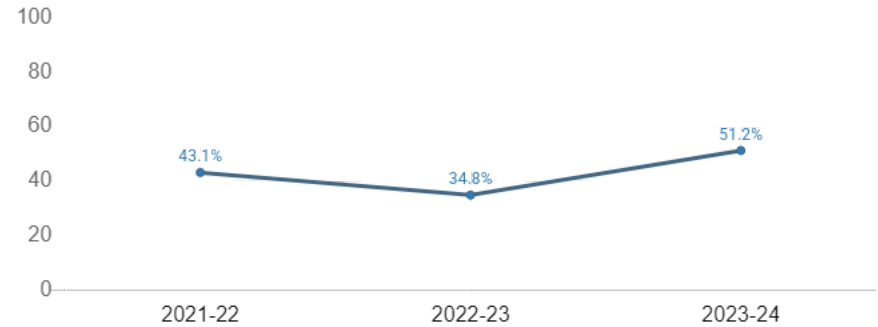
English Language Arts and Mathematics Performance Trends

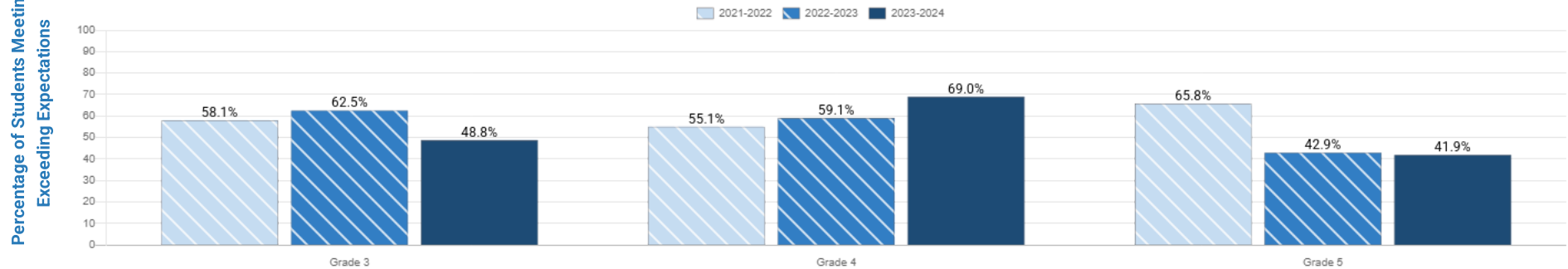

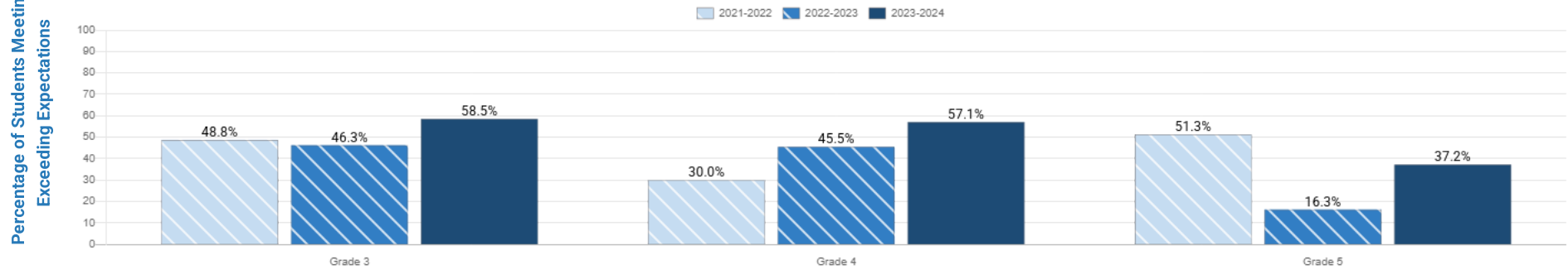

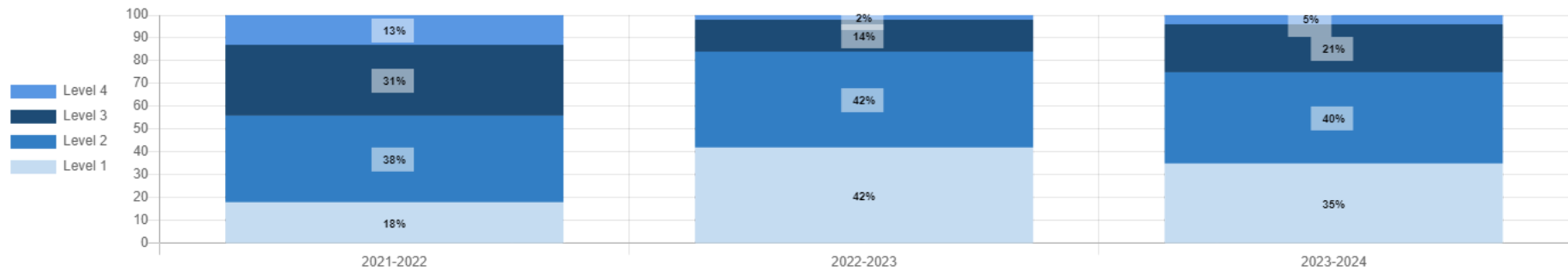

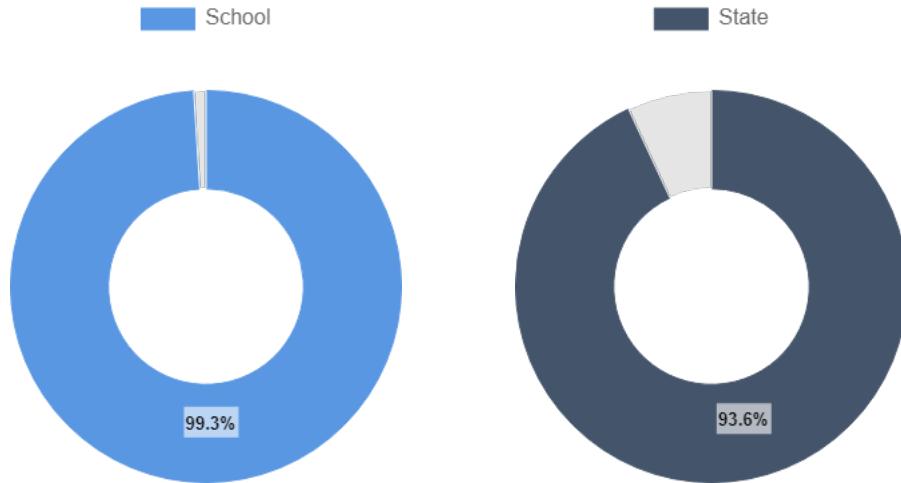

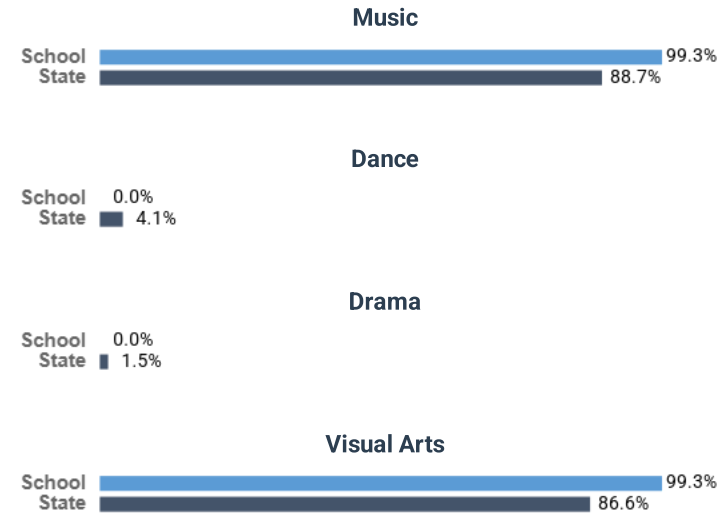

Students enrolled in one or more classes by discipline:



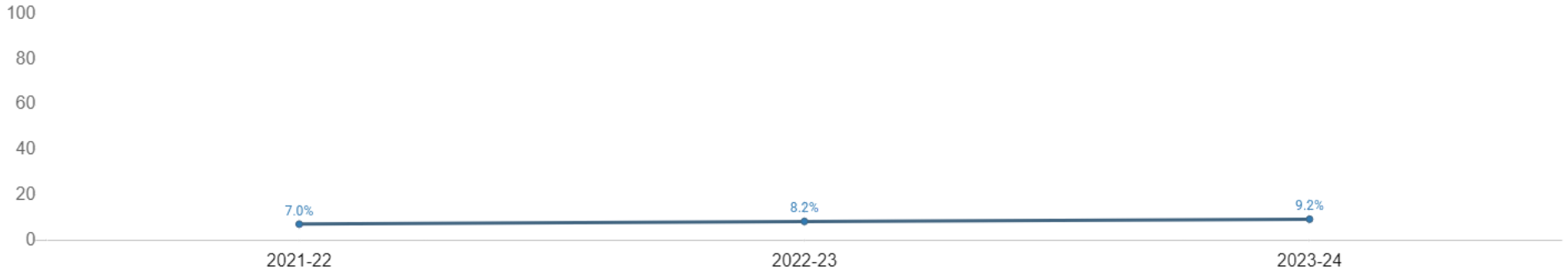

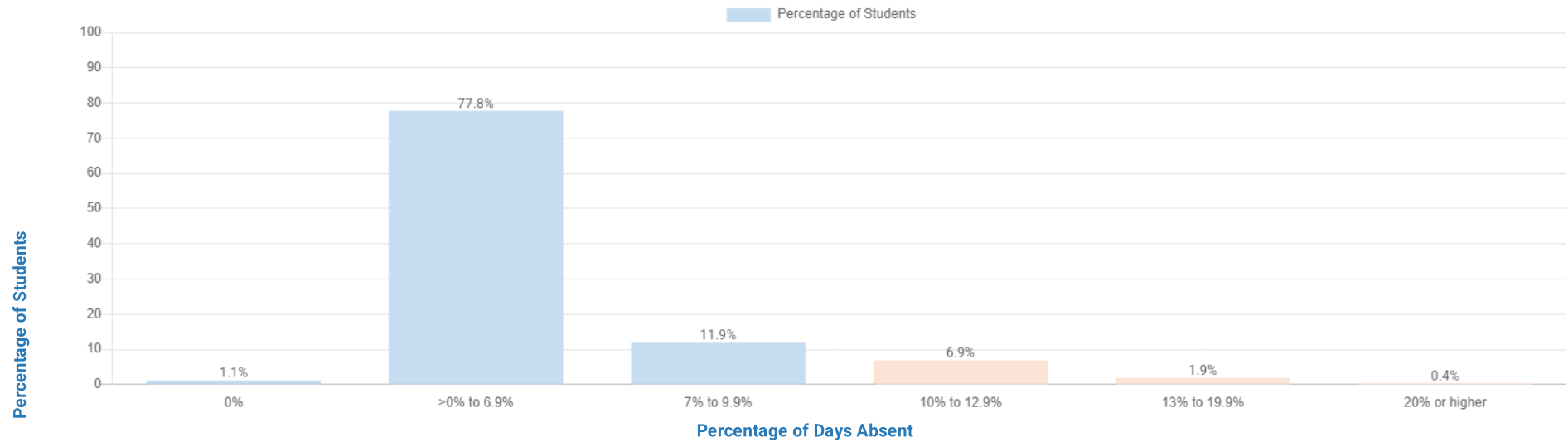

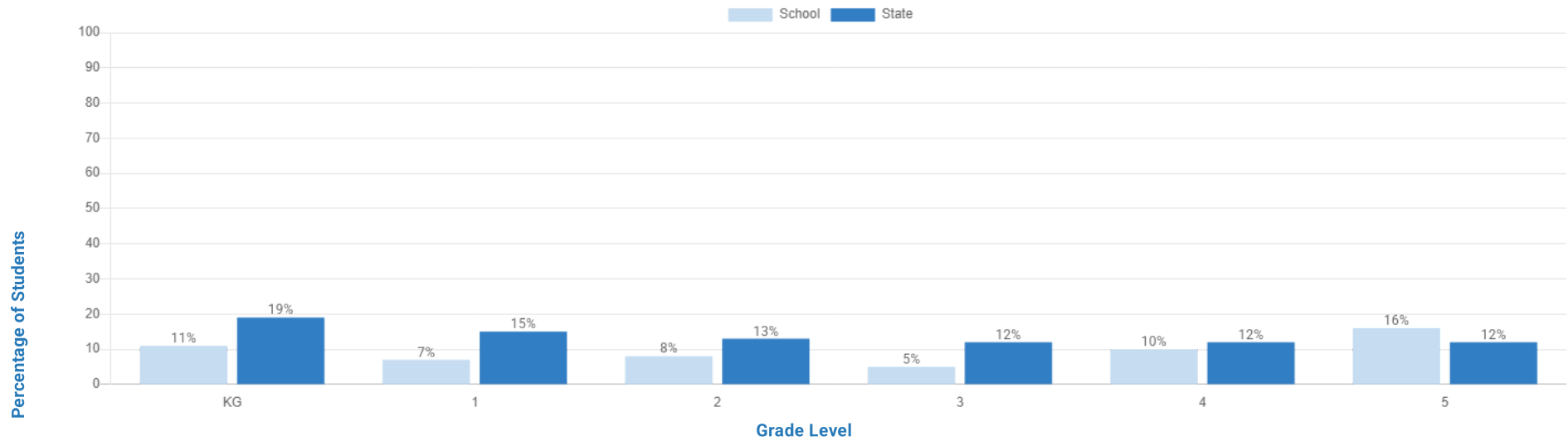

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

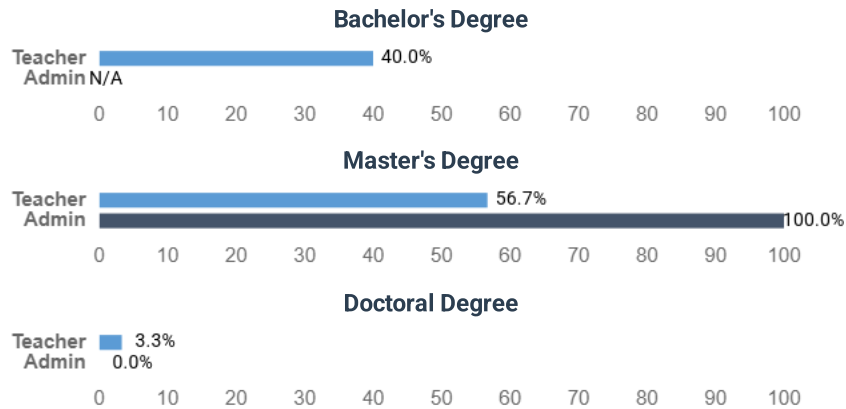

Within the district, structures have been put in place to support teachers as they participate in professional growth opportunities such as independent studies, personalized reflective practice experiences, job-embedded professional learning, micro-credentialing and teacher-facilitated conversations as they work towards individualized professional learning goals. All teachers also participate on an ongoing basis in Professional Learning Community work, which is spearheaded by the leadership of designated Learning Design Teams within each building. Learning Design Teams lead building-level experiences, through a PLC-like structure, that stimulate professional dialogue to inform decision-making and increase instructional capacity to positively impact student outcomes.



Student Supports and Services:

There are many special education services offered at Leonardo along with a comprehensive I&RS Program. A full time Social Behavior Support Specialist and LDTC provide counseling/group sessions for students in need.



Student Health and Wellness:

Leonardo runs CATCH Club Fitness programs for various grades. The students have Physical Education three times per week and health one time per week. A daily breakfast program is offered. YMCA conducts weekly clinical counseling at Leonardo Grade School.

Other Information:

We believe that a student's education encompasses more than just academic success. Our student social emotional health as well as the school's positive culture & climate impact our student success. Responsive Classroom is an evidence-based approach to teaching that focuses on engaging academics, positive community, effective management, and developmental awareness. As we move towards full adoption of Responsive Classroom philosophies and practices, our current focus is on mastering the Morning Meeting component. Student's academic success is credited to students, teachers and parents working together as a cohesive group. The teachers differentiate instruction and modify and adapt curriculum to provide an interdisciplinary program with an emphasis on personalized learning. Our workshop based literacy program integrates the main components of Reader's Workshop using authentic literature and informational text, word work and guided reading. Formal writing instruction is taught through the workshop model of instruction. We utilize the district adopted Savaas/Investigations Math program. Math skills and concepts are supported with hands-on approaches to foster understanding and an appreciation for the world of numbers. Technology engages learners and enhances student learning. Students in grades 3-5 each have been assigned a Chromebook and actively work in a 1:1 digital environment on a daily basis. The special subjects provide the children many motivating learning experiences. Art classes study the products of the masters and engage students in activities of individual artistic expression. During physical education the children stretch, run and jump to help develop young bones and muscles. Vocal and instrumental music classes provide the opportunity for students to develop a love of music, and students receive instruction in World Language to acquire basic knowledge of the Spanish language as well as the rich culture.
