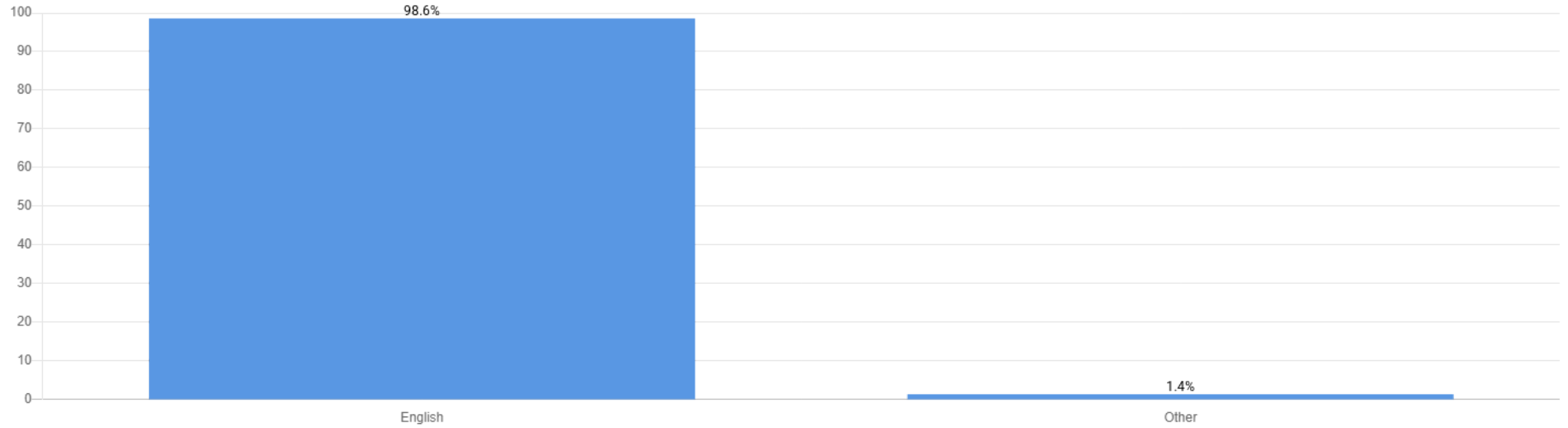

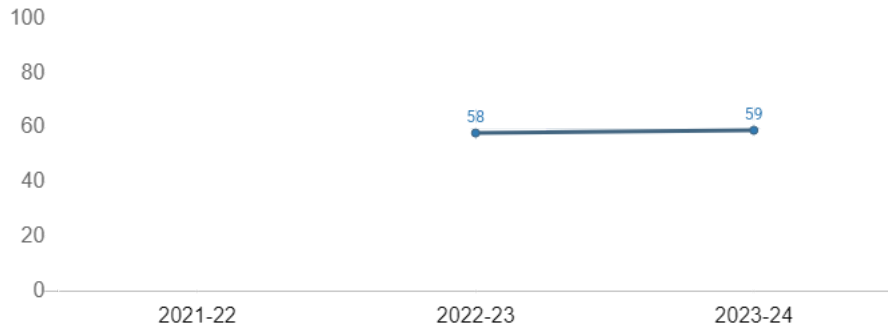

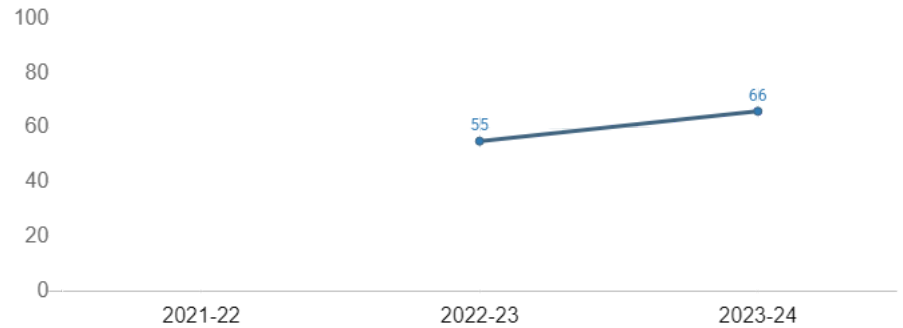

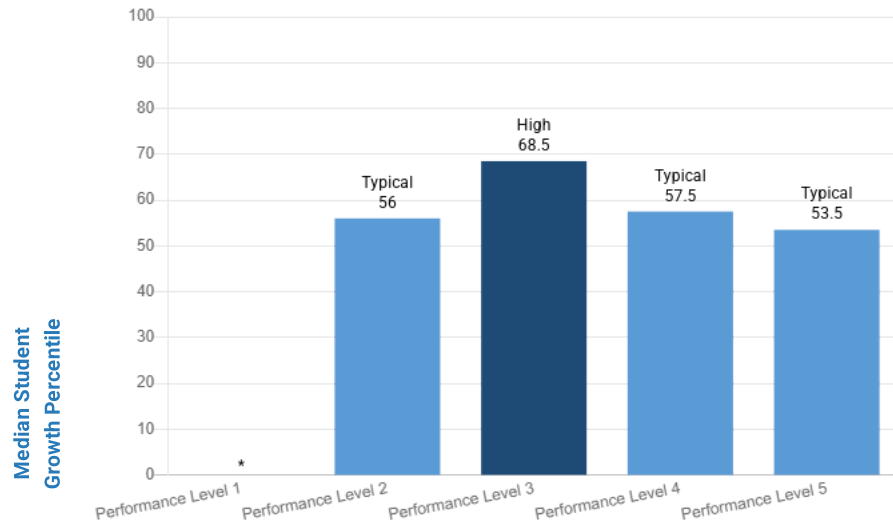

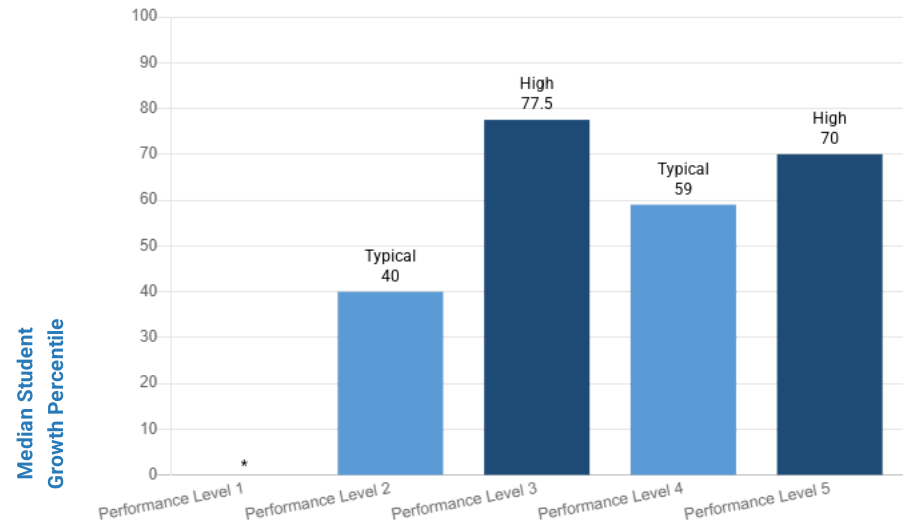

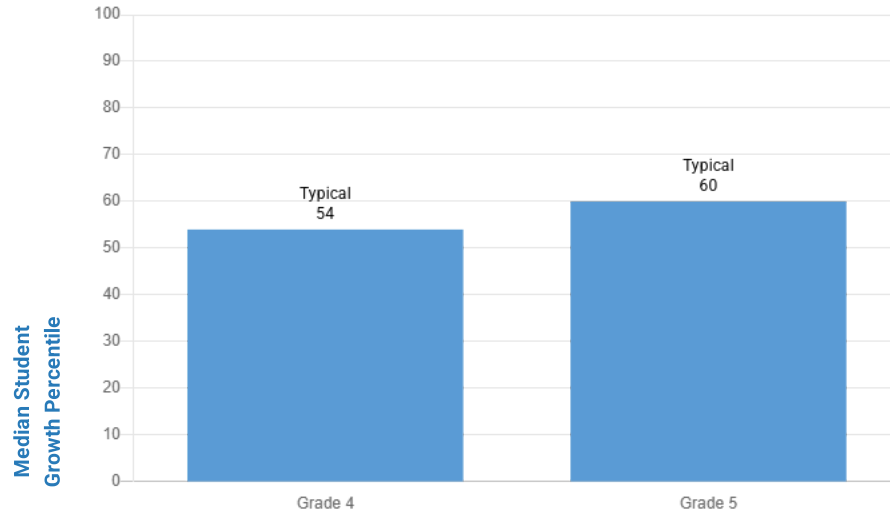

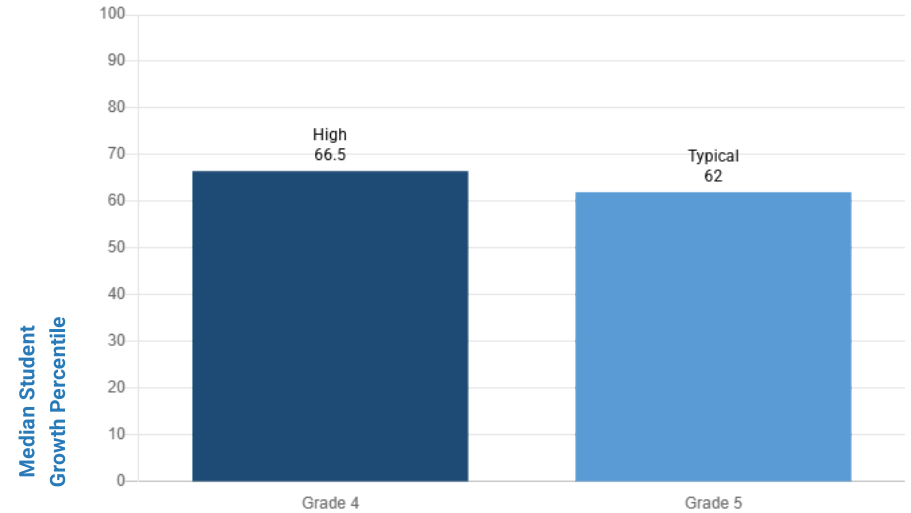

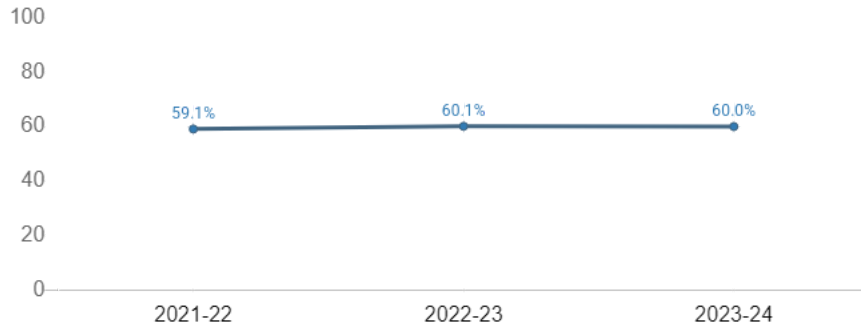

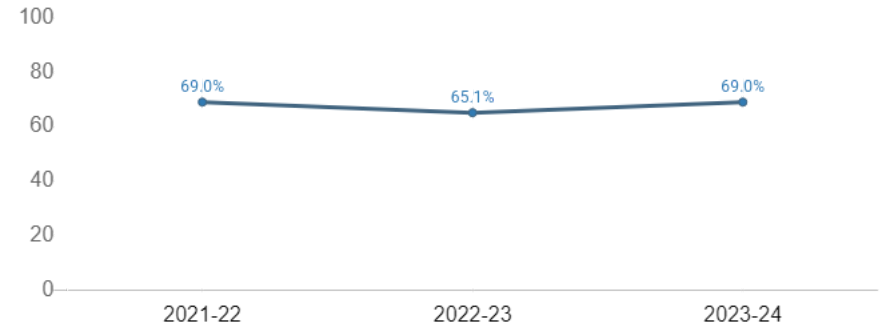
English Language Arts and Mathematics Performance Trends

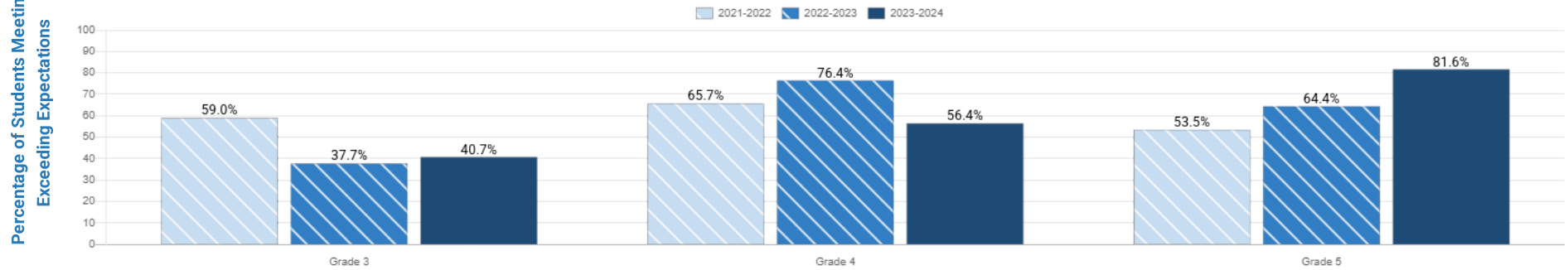

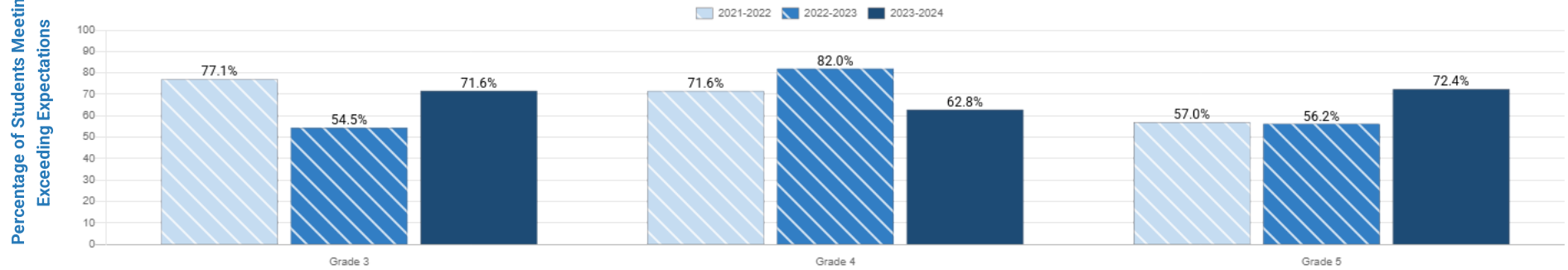

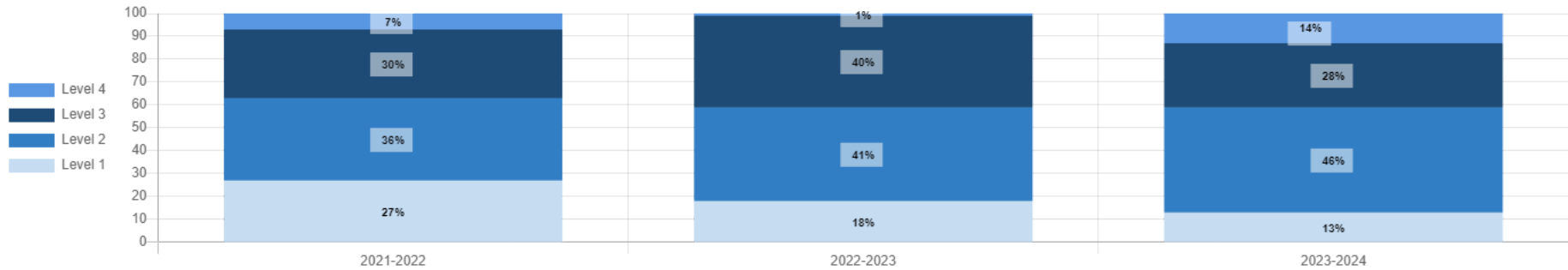

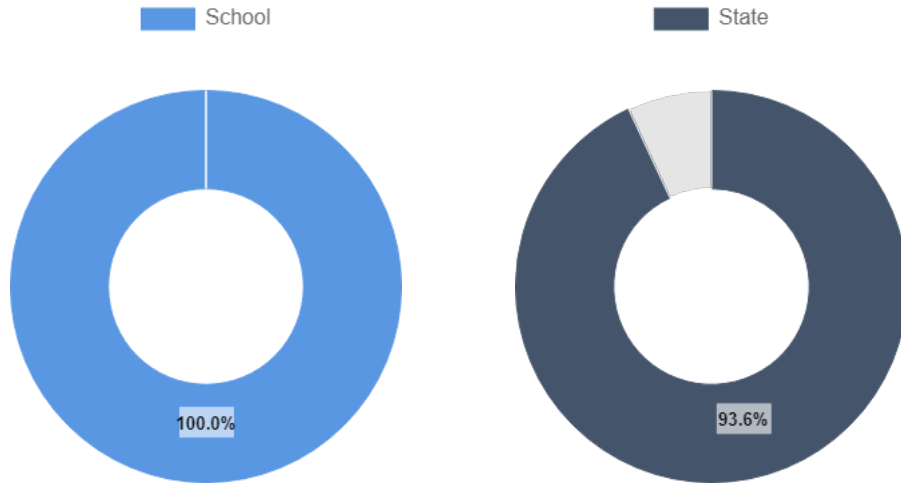

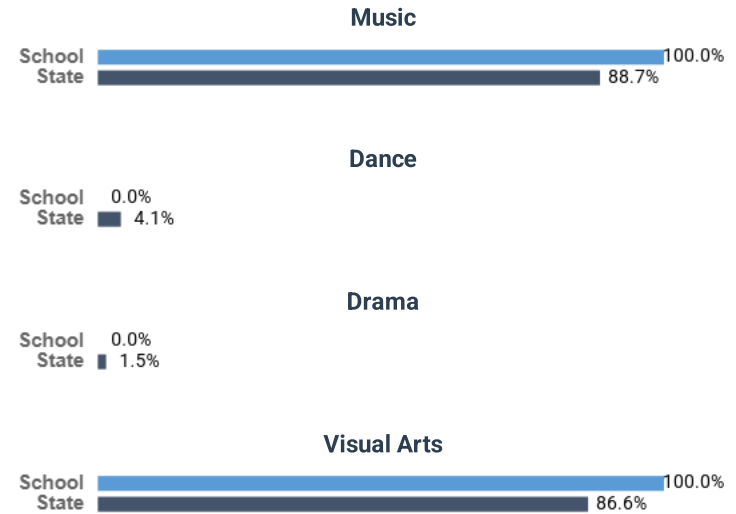

Students enrolled in one or more classes by discipline:



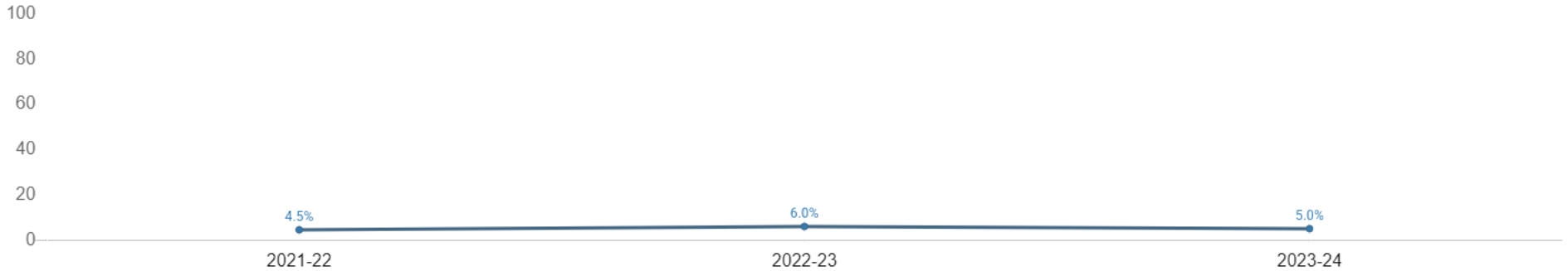

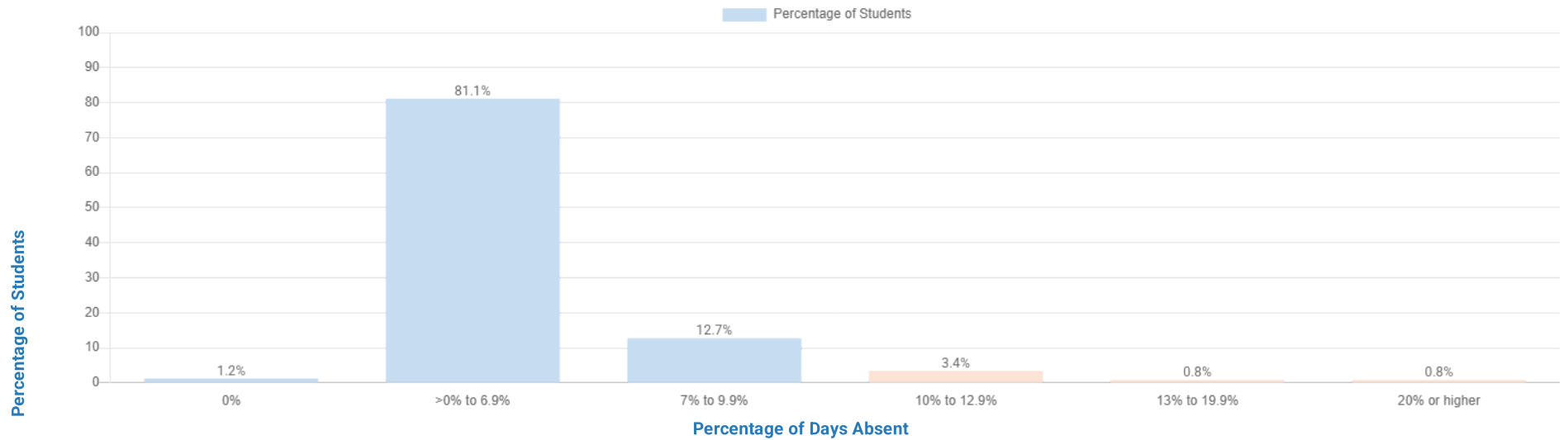

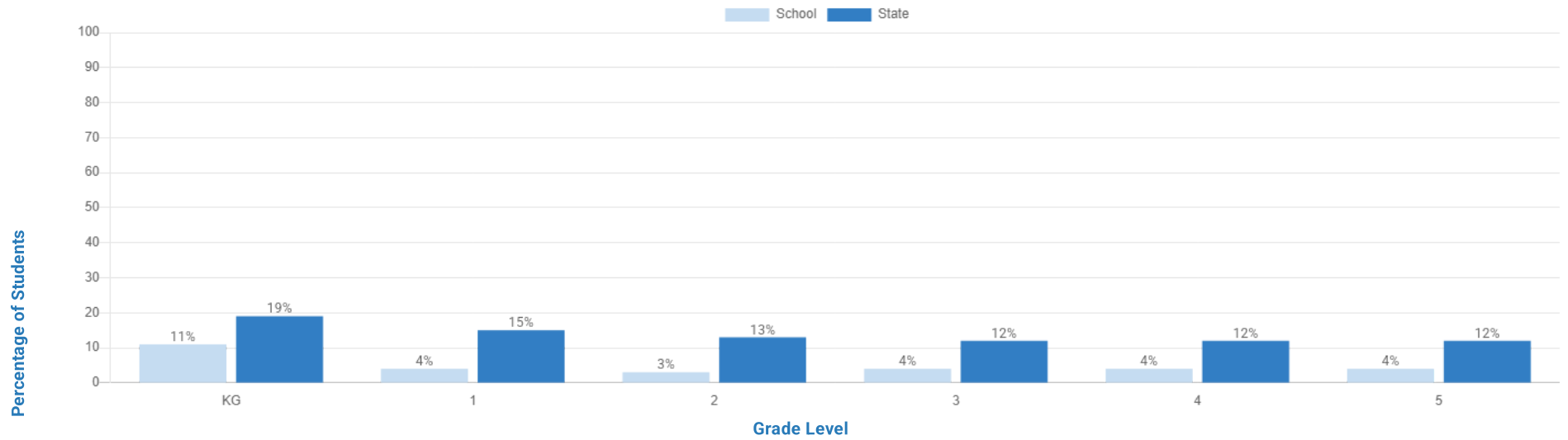

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 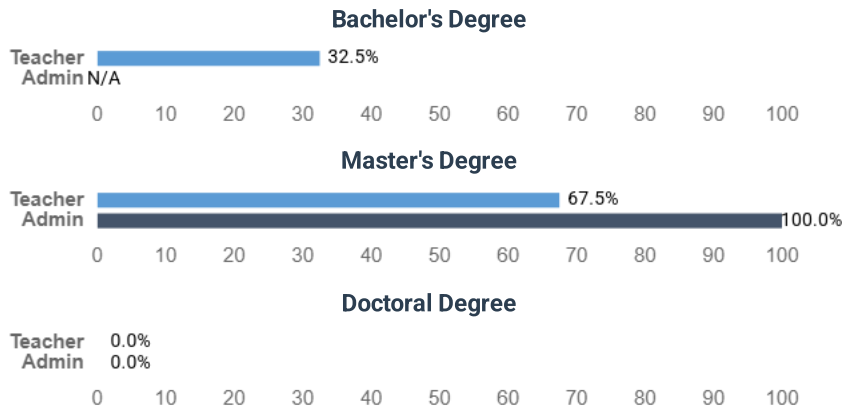

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Within the district, structures have been put in place to support teachers as they participate in professional growth opportunities such as independent studies, personalized reflective practice experiences, job-embedded professional learning, micro-credentialing and teacher-facilitated conversations as they work towards individualized professional learning goals. All teachers also participate on an ongoing basis in Professional Learning Community work, which is spearheaded by the leadership of designated Learning Design Teams within each building. Learning Design Teams lead building-level experiences, through a PLC-like structure, that stimulate professional dialogue to inform decision-making and increase instructional capacity to positively impact student outcomes.



Student Supports and Services:

In the spring the district and school offer a Learning Academy before or after school for selected students in the areas of reading, writing and Math which provides targeted instruction to bolster student achievement.



Student Health and Wellness:

In support of social emotional learning, the Responsive Classroom curriculum is implemented in all classrooms and students participate in morning meeting each day. Lincroft School offers Fit Club to all K-5 students. In addition, we promote overall wellness with planned Brain Breaks throughout the school day, and we host an Annual Jump Rope for the Heart Day to raise awareness for heart health.

The students at Lincroft Elementary School are active participants in meaningful activities to guide them in becoming lifelong learners and responsible citizens. Students are provided with classes in Art, Music, Health, Spanish and Physical Education. In grades four and five, students have the opportunity to participate in instrumental music. Academic success is credited to students, teachers and parents working together as a cohesive group. Curricula in all subject areas align with the state standards, and teachers differentiate instruction to promote individual student academic success and use an interdisciplinary approach to promote personalized learning. Our balanced literacy program integrates authentic literature and informational texts using best practices such as guided group instruction, Reader's Writer's Workshop and word work. Math skills and concepts are supported with a hands-on approach to foster conceptual as well as procedural understanding of the discipline and an appreciation for the world of numbers. Smart Boards, iPads, Chromebooks, desktops and laptop computers, as well as document cameras are utilized in classrooms to enhance student learning. Students in Grades 3-5 each have a Chromebook and actively work in a 1:1 environment on a daily basis. Read Across America Week, Battle of the Books and other programs help develop a love of reading. Educational Enrichment programs provide students an opportunity to have experiences beyond the classroom. Career Day for grade 5 exposes students to career opportunities for them to consider. A strong sense of civic responsibility is an integral part of the students' learning.
