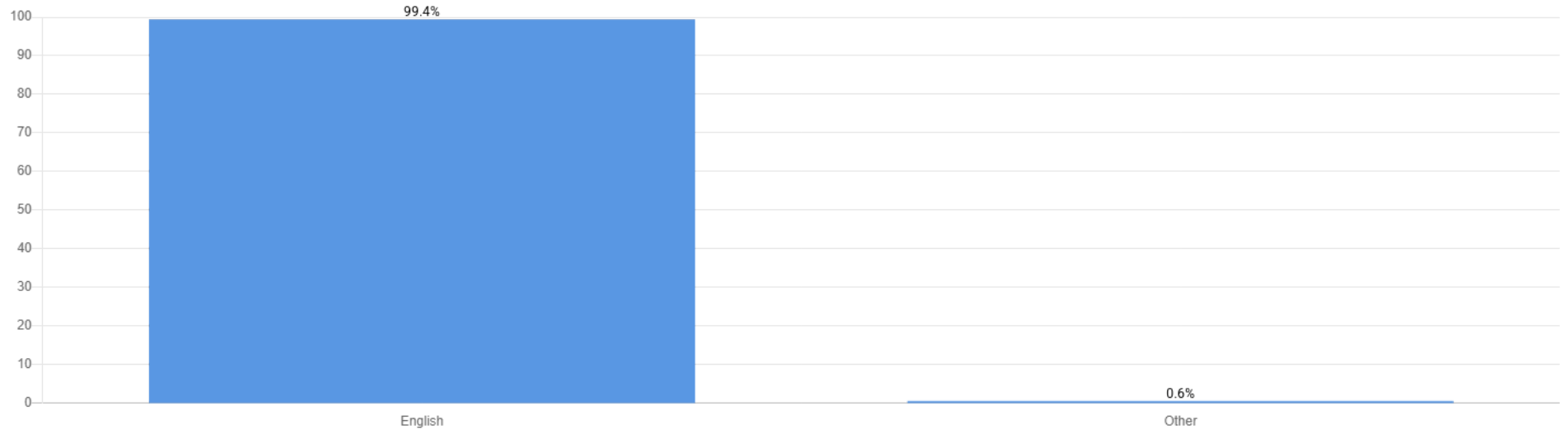

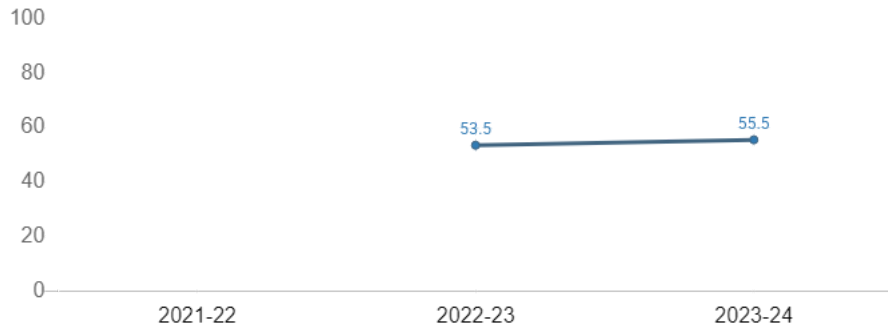

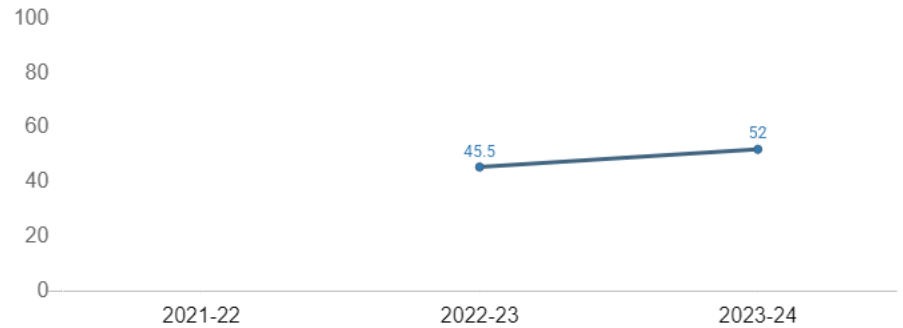

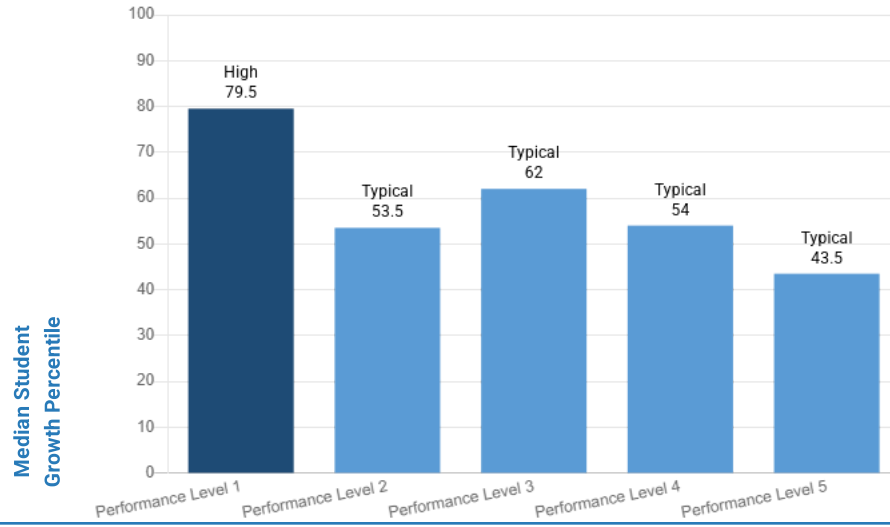

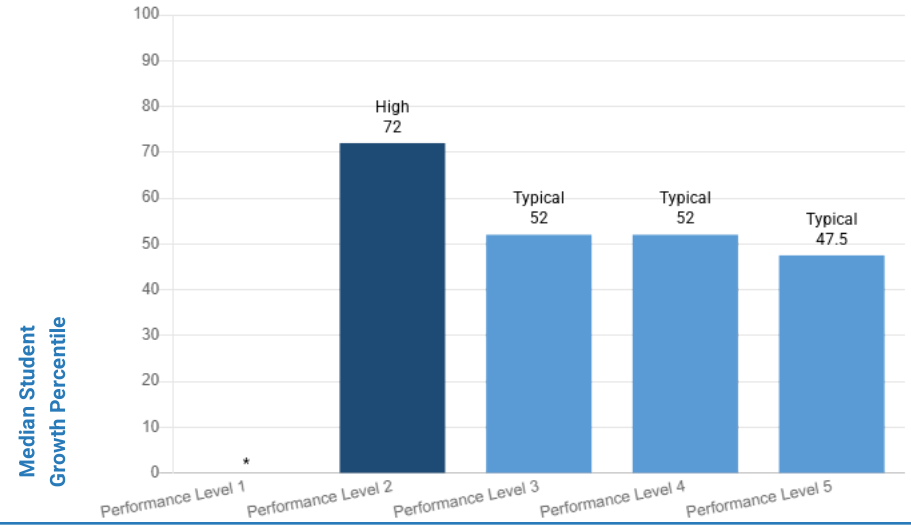

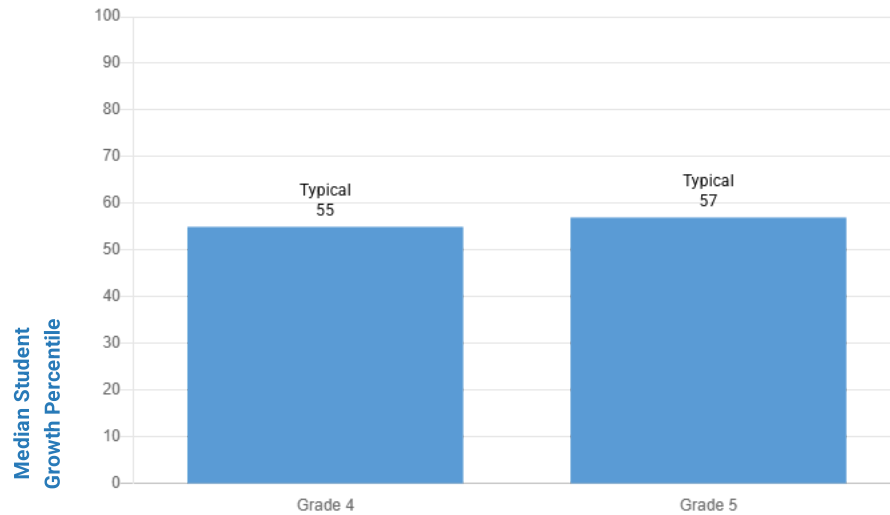

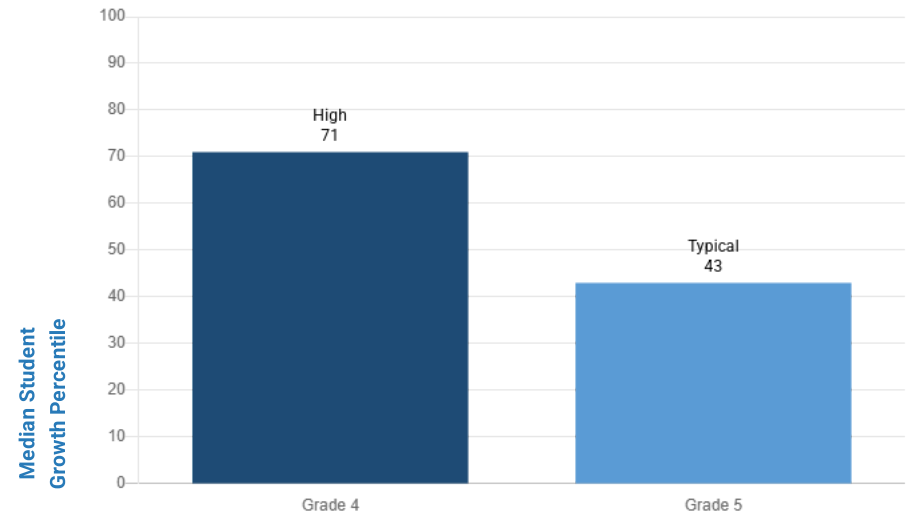

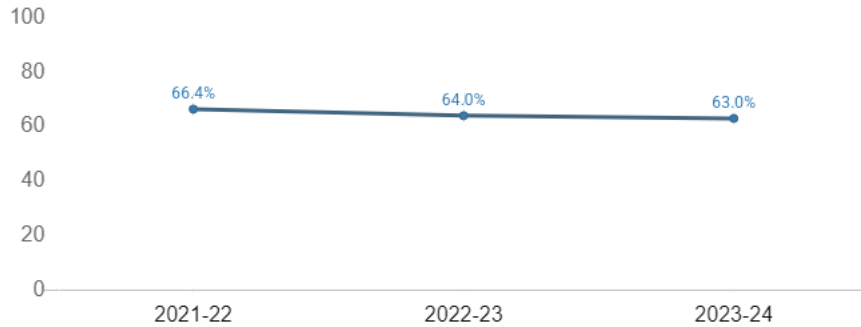

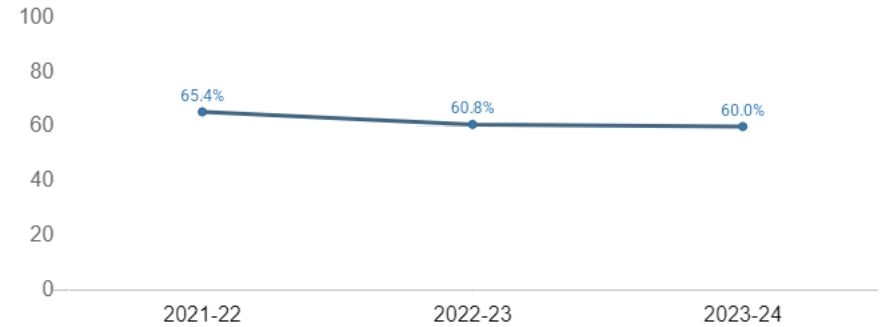
English Language Arts and Mathematics Performance Trends

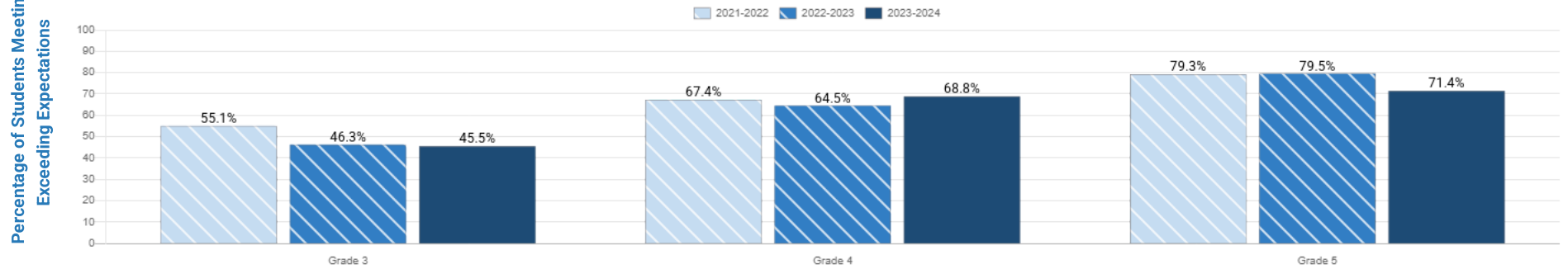

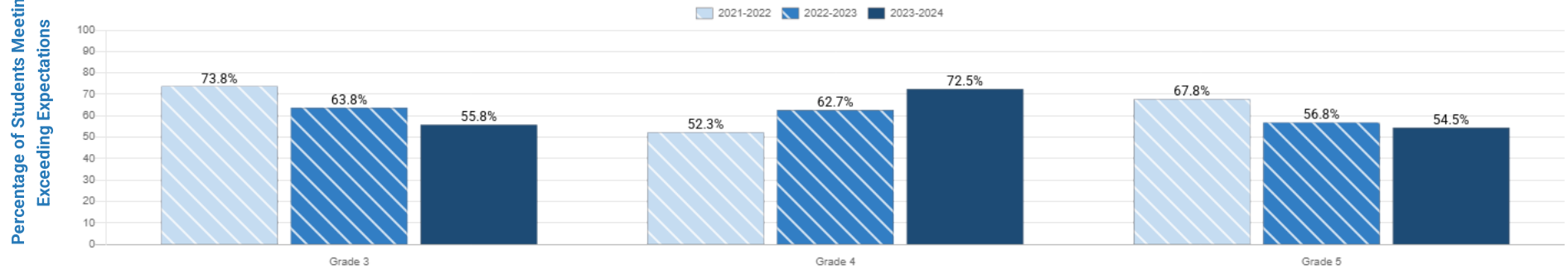

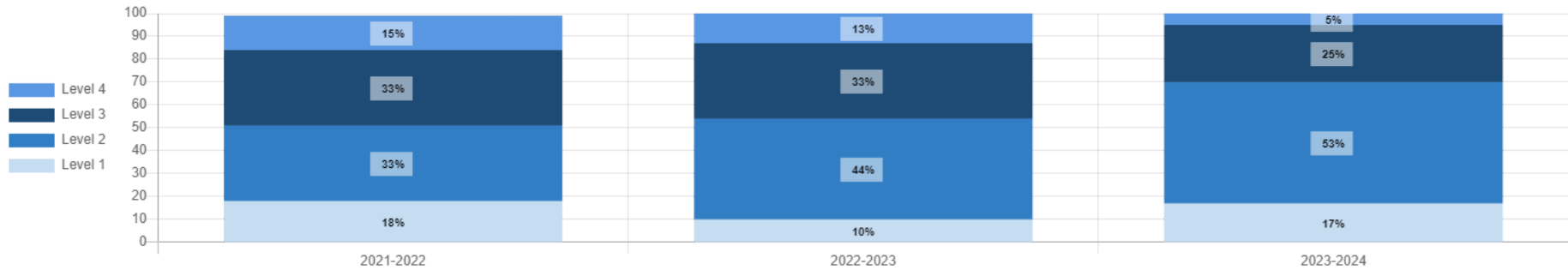

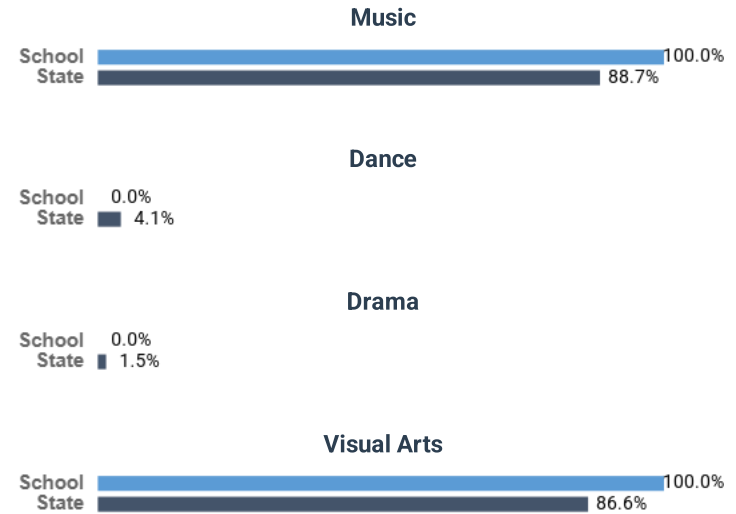

Students enrolled in one or more classes by discipline:



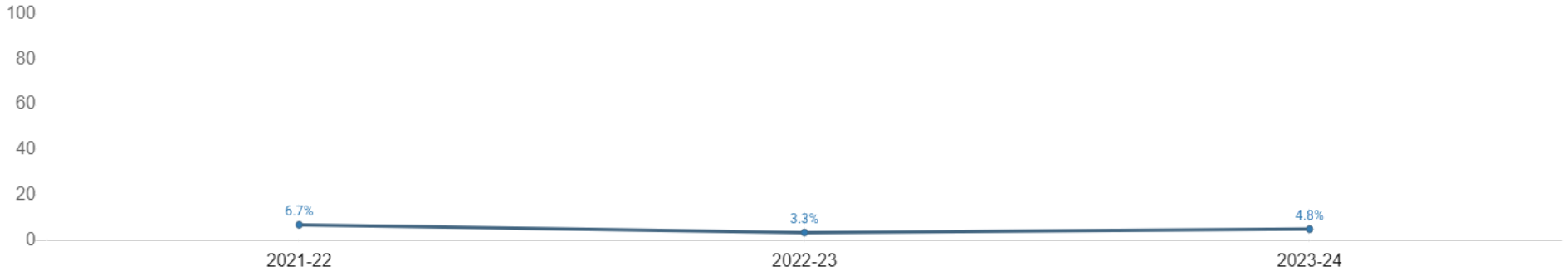

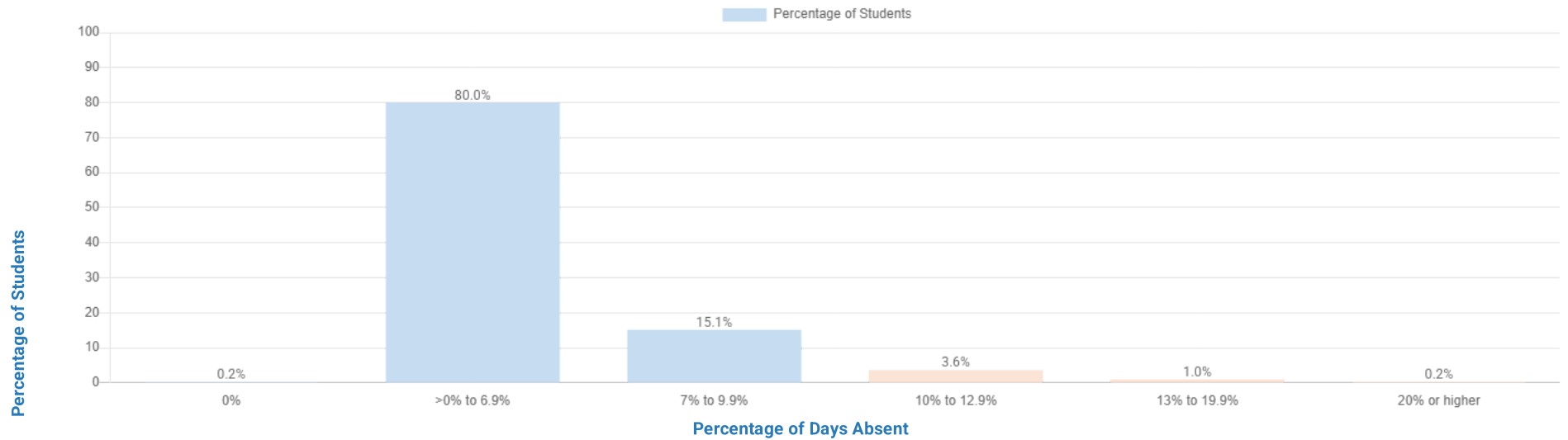

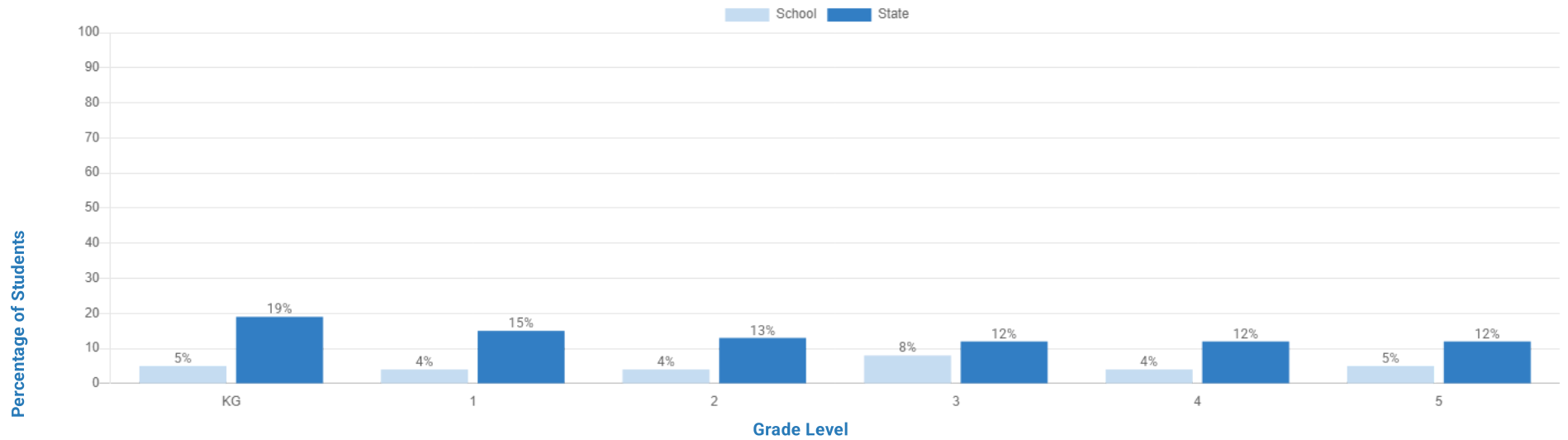

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

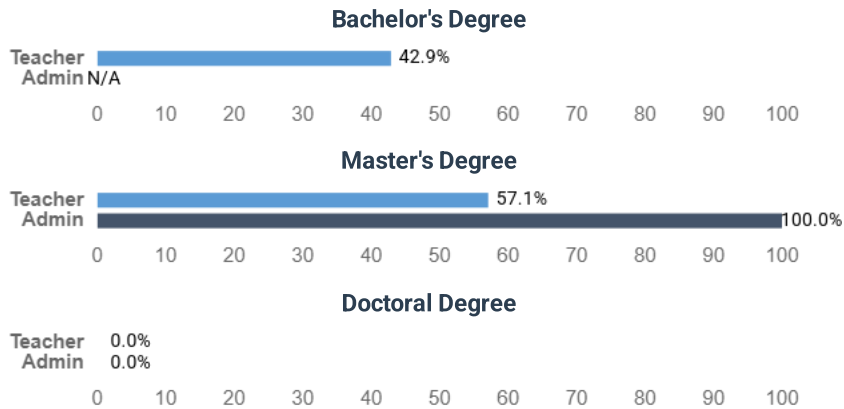

Staff and Professional Learning:

Teachers are engaged in purposeful and personalized professional learning experiences throughout the year. Within the district, structures have been put in place to support teachers as they participate in professional growth opportunities such as independent studies, personalized reflective practice experiences, job-embedded professional learning, micro-credentialing and teacher-facilitated conversations as they work towards individualized professional learning goals. All teachers also participate on an ongoing basis in Professional Learning Community work, which is spearheaded by the leadership of designated Learning Design Teams within each building. Learning Design Teams lead building-level experiences, through a PLC-like structure, that stimulate professional dialogue to inform decision-making and increase instructional capacity to positively impact student outcomes.



Student Supports and Services:

Nut Swamp School has one of the largest K-5 student populations in Middletown Township School District. We provide a continuum of special education services including ICR, Resource Room, and LLD with the support of our school psychologist and social worker. Our I&RS program provides targeted interventions for students who are experiencing learning, behavioral or health difficulties.



Student Health and Wellness:

All students participate in PE and Health classes each week. Posters in the Health Office and All Purpose Room promote making healthy food choices. Classes schedule physical movement breaks daily. Students engage in 20 minutes of recess, daily. Hearing and vision screenings are conducted by the school nurse. Students in grades 4-5 can participate in the Fit Club.

Other Information:

The academic success of our students is credited to students, teachers and parents working together as a cohesive group. The teachers differentiate instruction and modify/adapt curriculum units to provide an interdisciplinary program. Our workshop based literacy program integrates the main components of Reader's Workshop utilizing authentic literature and informational text, word work and guided reading during instruction. Formal writing instruction is taught through the workshop model of instruction. Nut Swamp utilizes the district adopted Savaas/Investigations Math program. Mathematical skills and concepts are supported with hands-on approaches that incorporate multi-media presentations to foster understanding and an appreciation for the world of numbers. Technology, such as Boxlights, SMART Boards, Chromebooks, iPads, and document cameras are utilized to engage learners and enhance learning. Students in grades 3-5 each have been assigned a Chromebook and actively work in a 1:1 digital environment on a daily basis. The special subjects provide the children with a variety of motivating and interesting learning experiences. Art classes study the products of the masters and engage students in activities of individual artistic expression. During physical education the children stretch, run, twist, and jump with their classmates to help develop young bones and muscles. Vocal and instrumental music classes provide the opportunity for students to learn the families of instruments and to develop a love of music, and students receive instruction in World Language to acquire basic knowledge of the Spanish language as well as the rich culture.
