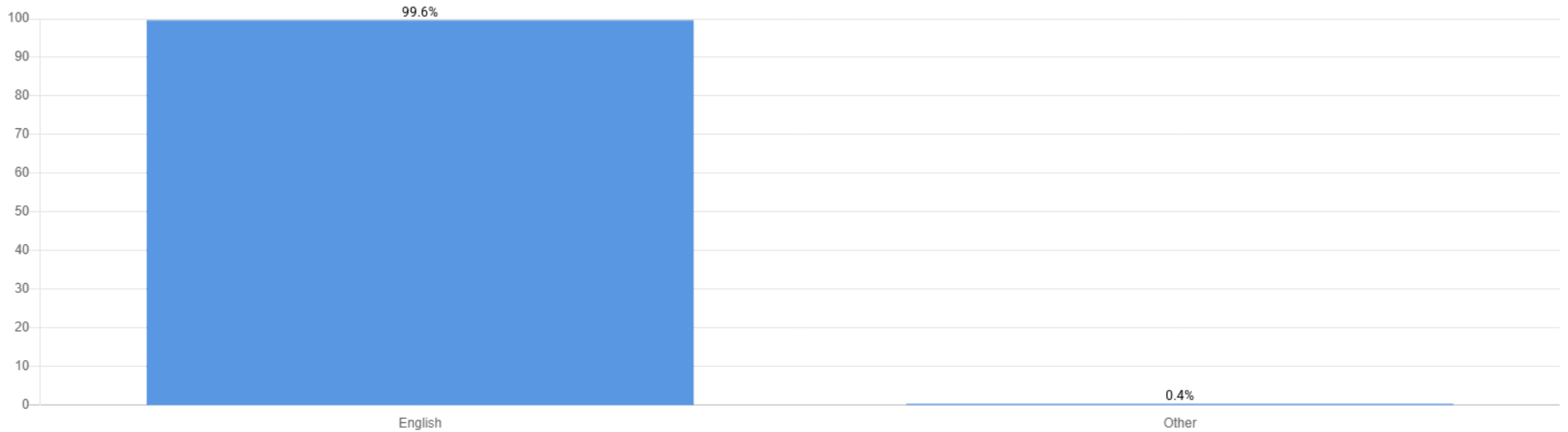

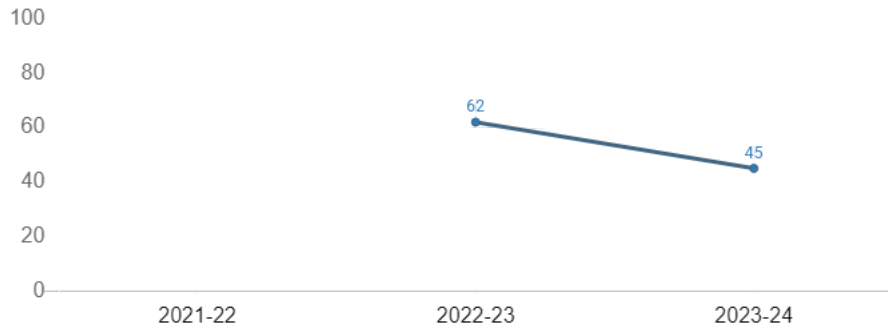

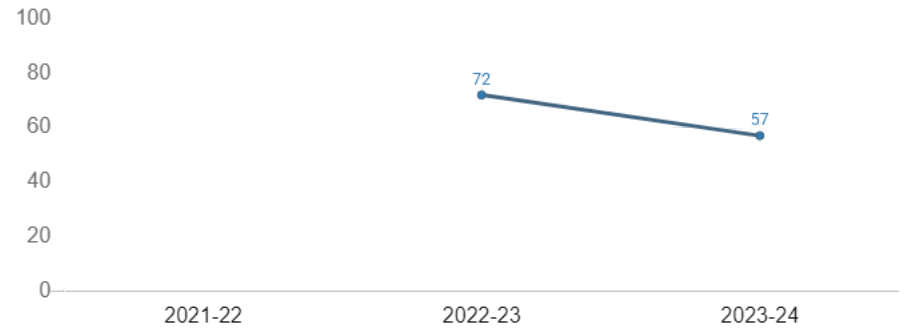

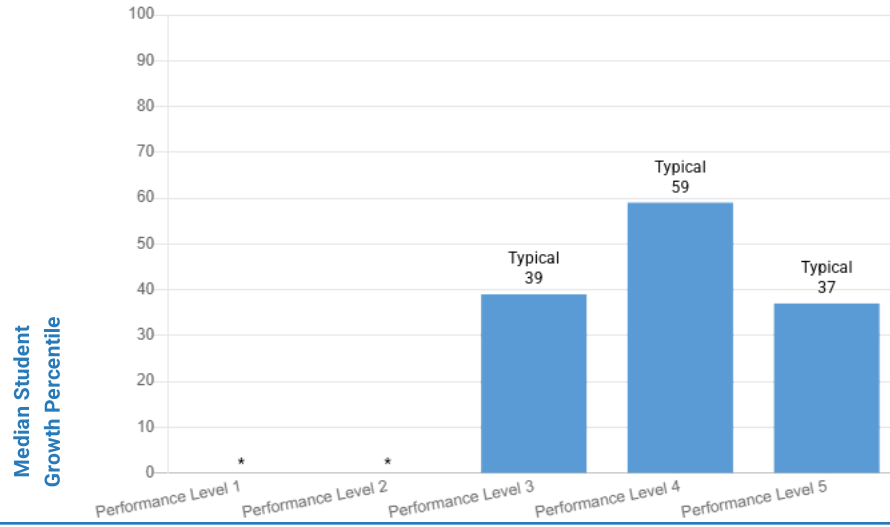

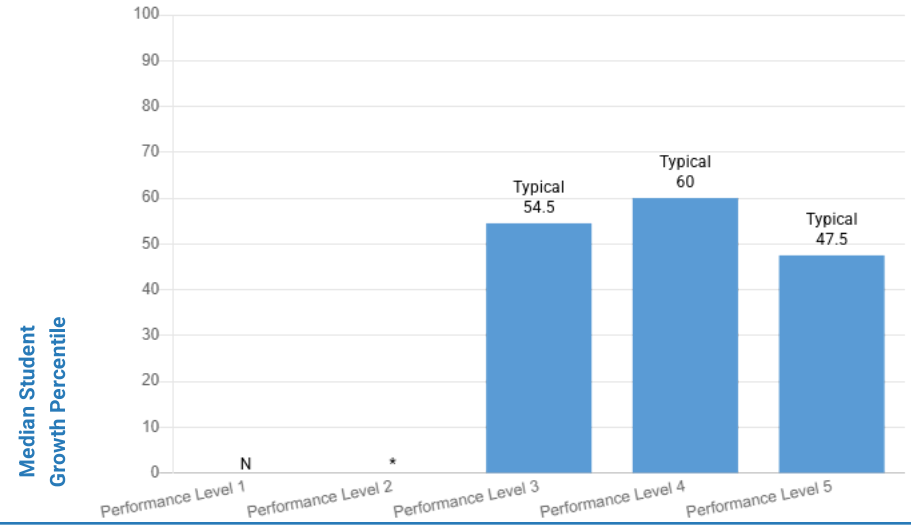

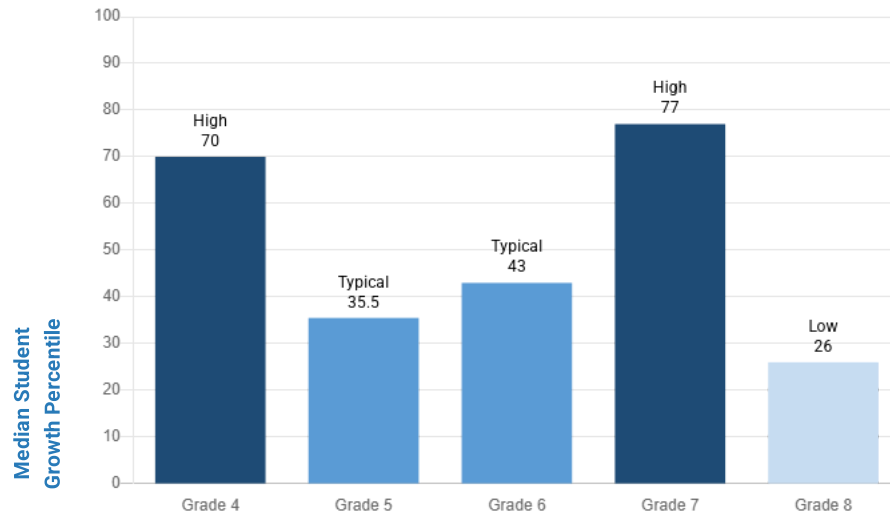

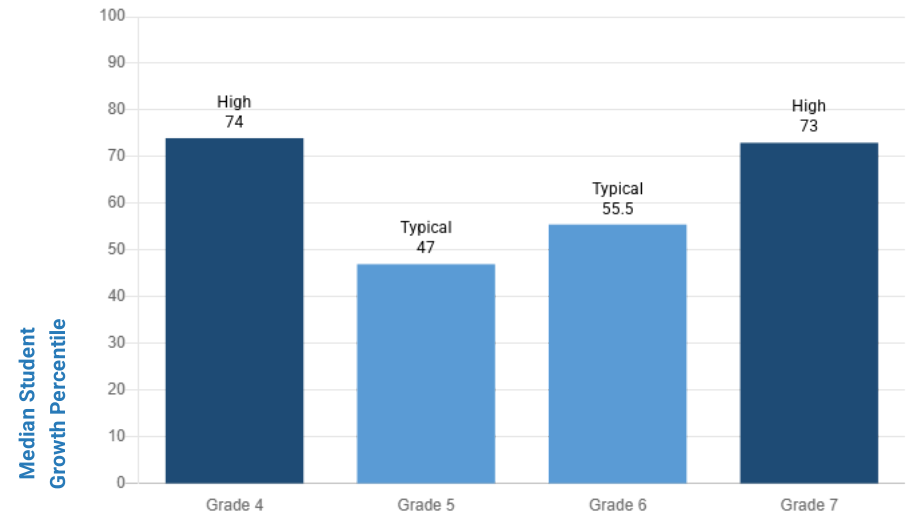

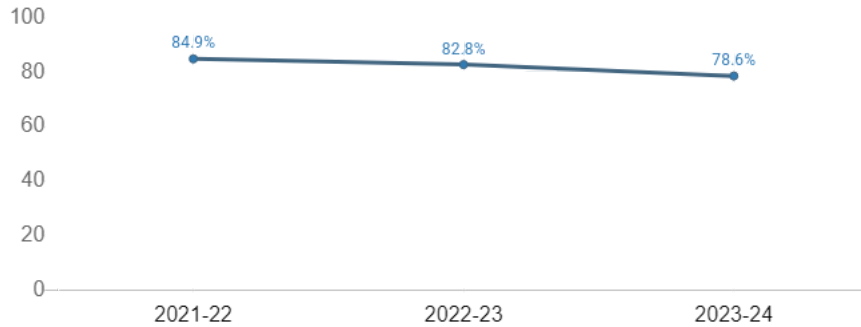

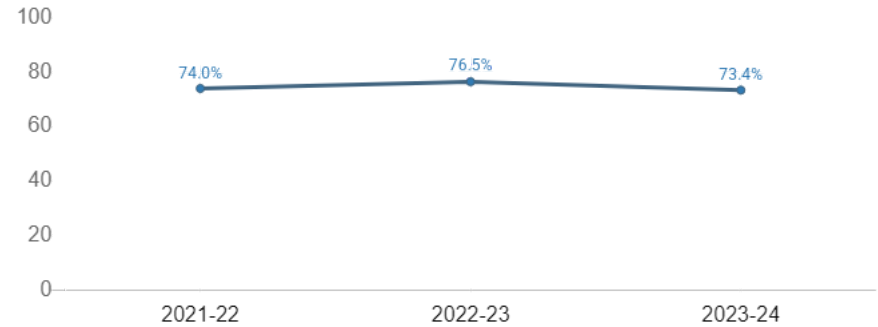
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 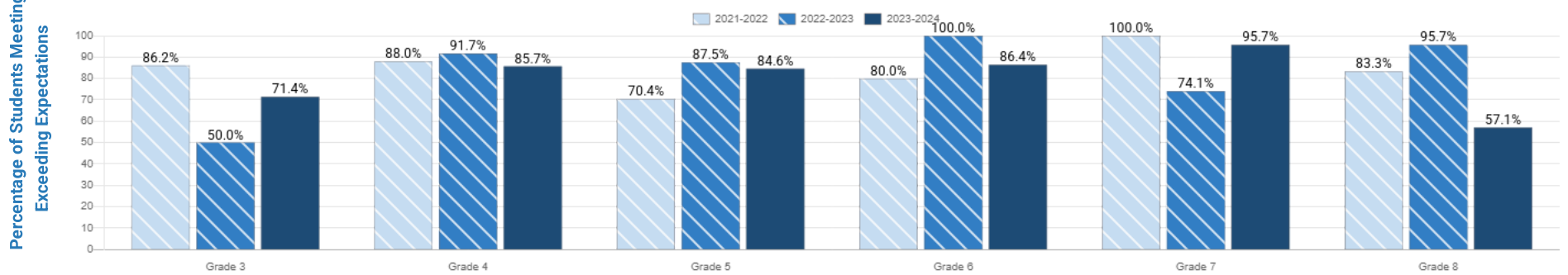

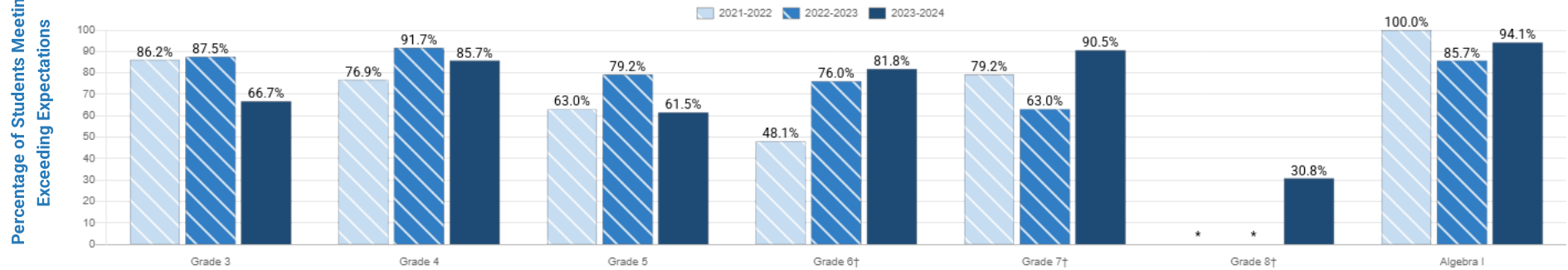

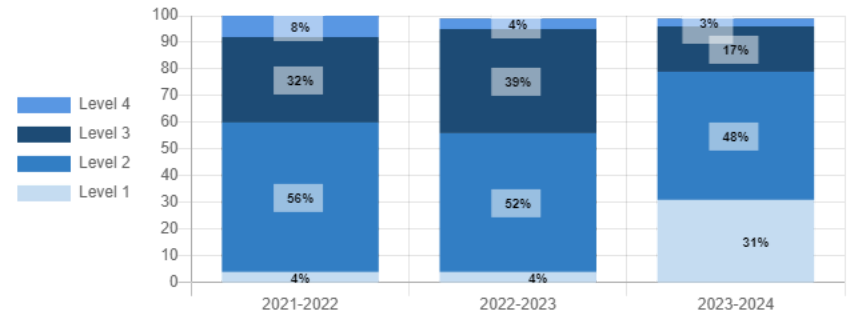

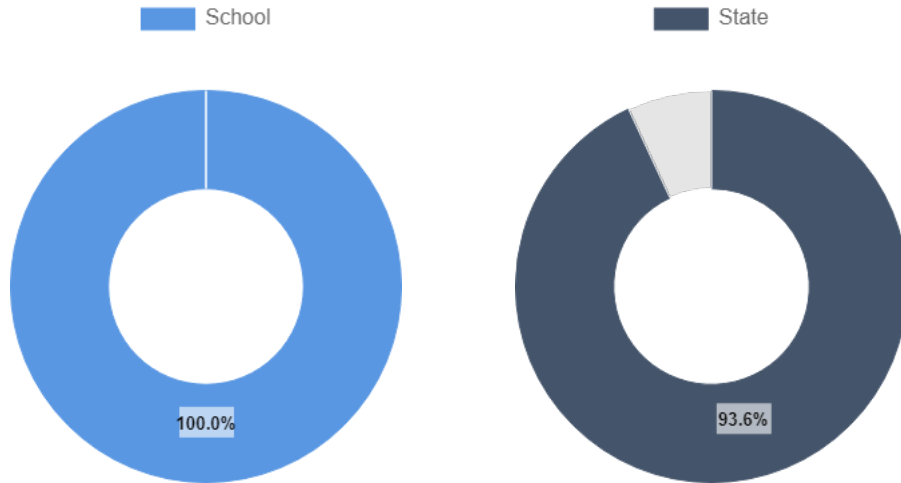

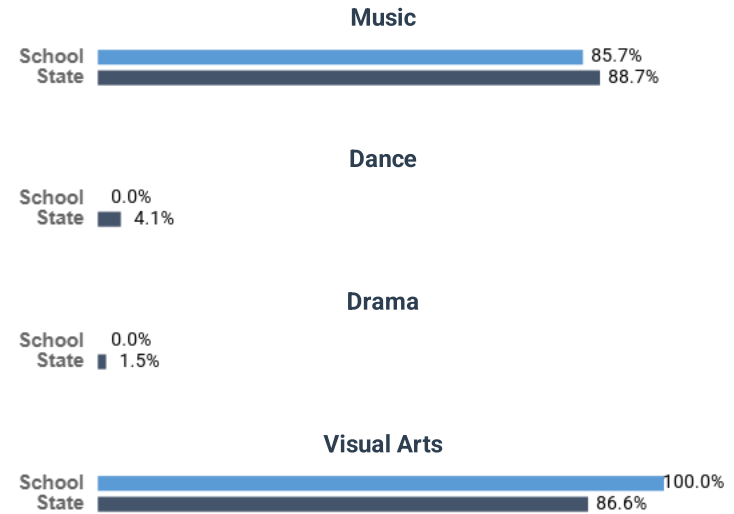

Students enrolled in one or more classes by discipline:



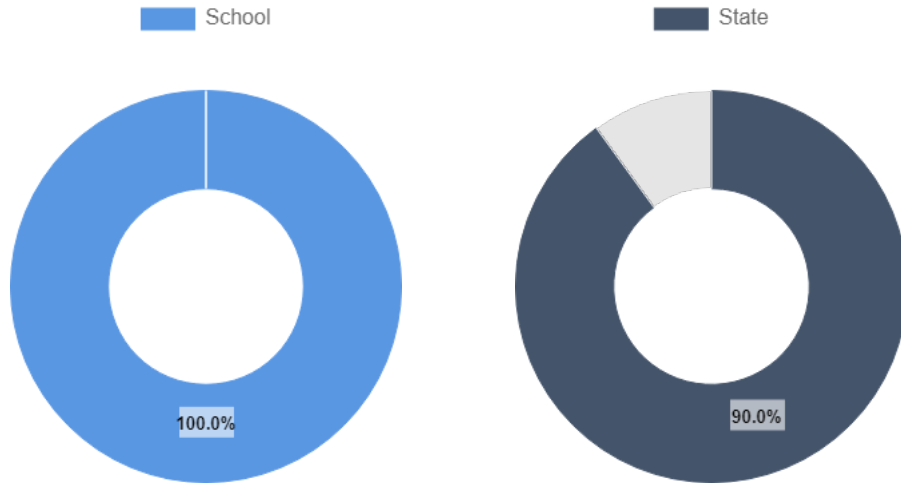

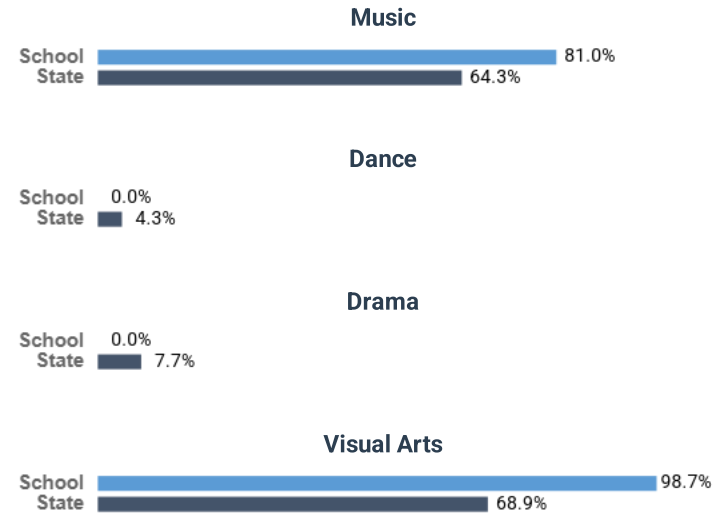

Students enrolled in one or more classes by discipline:



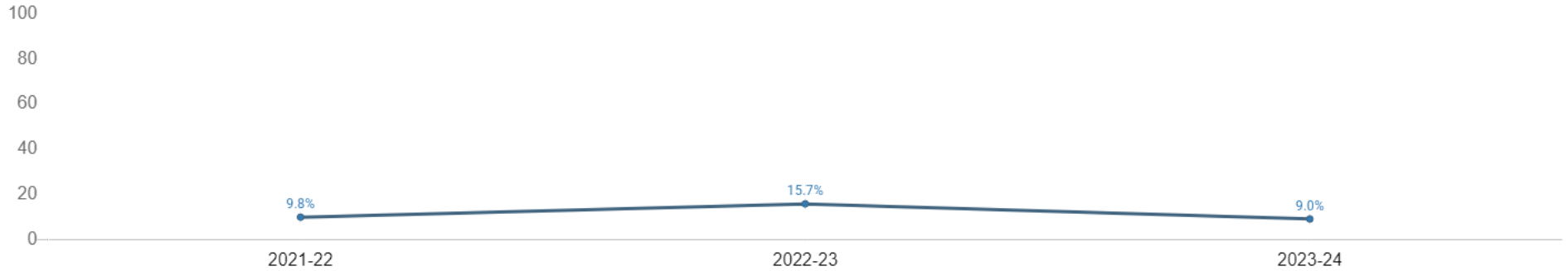

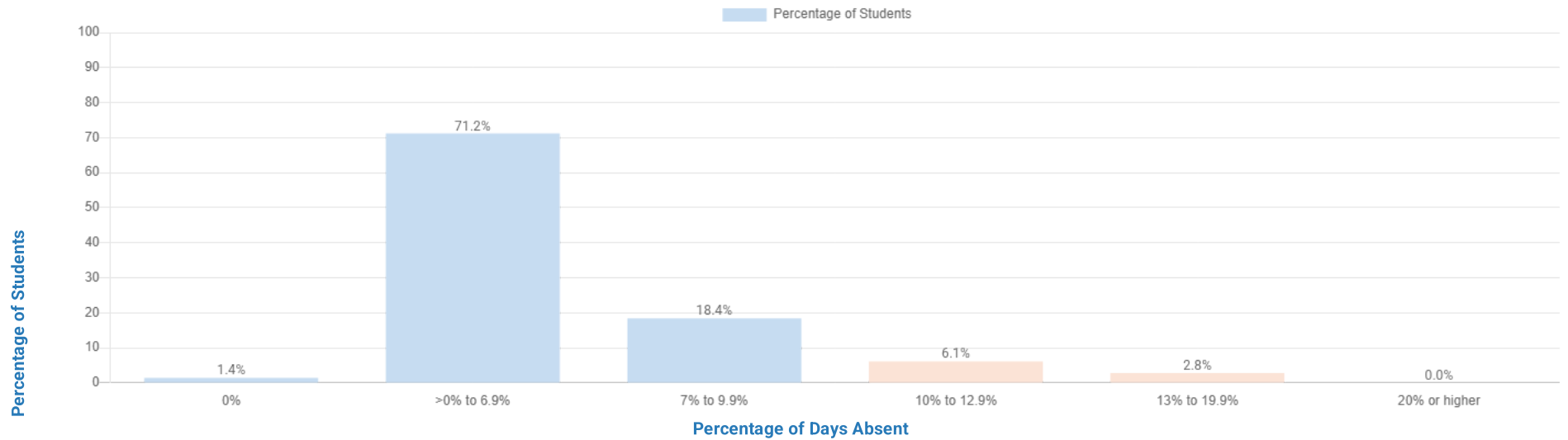

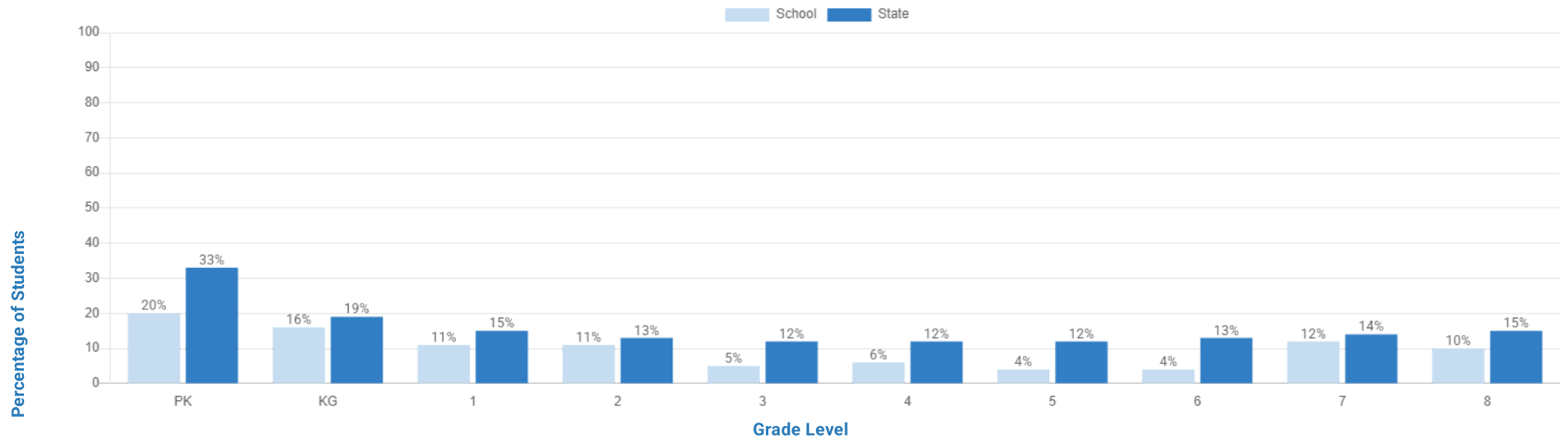

The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 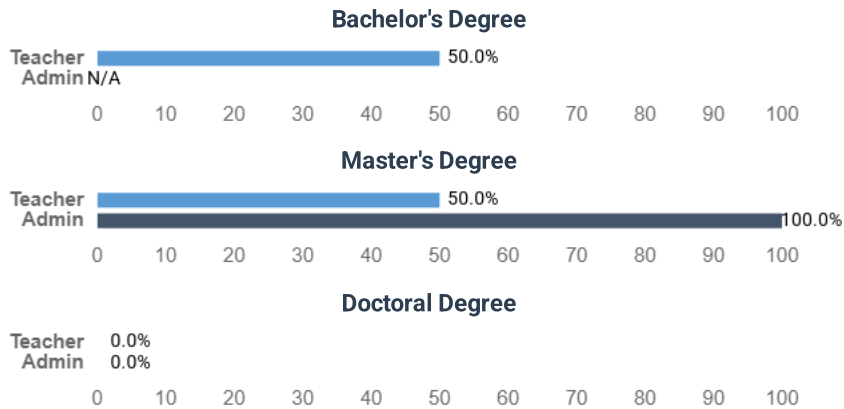

Student Supports and Services:

MBS has Intervention and referral services designed to assist students who are experiencing learning, behavioral, or health difficulties. The district also employs a Child Study Team, including a speech teacher, occupational therapist, learning disabilities teacher consultant, guidance counselor, psychologist, and social worker.



Student Health and Wellness:

All students participate in Physical Education classes as well as daily recess time. Our school nurse has the sixth grade students participate in the L.E.A.D. program (formerly D.A.R.E.) and also provides CPR training for students in grades 5 - 8. The Social Behavioral Support Specialist regularly delivers Character Education and Mindfulness instruction to all students PK-8.



Parent and Community Involvement:

Monmouth Beach School is proud of its active Parent Teacher Organization that sponsors many student enrichment activities and assembly programs. Community involvement is regularly encouraged at Board meetings, PTO meetings, and other events where parents are invited to attend. At Monmouth Beach School, challenges are overcome and needs are met thanks to the collaborative efforts of the Board of Education, administration, teachers, parents, students, and community members. This includes a strong and close working relationship with the local police department to help ensure that a safe and secure environment is maintained on a daily basis. The result of all these efforts is a high quality education made available to students that will enable them to meet with academic success, and experience social and emotional growth needed to become leaders in the twenty-first century.

Facilities:

Monmouth Beach School is located in the historic Borough of Monmouth Beach in northern Monmouth County with sandy beaches of the Atlantic Ocean as its eastern border. The only school in the district, Monmouth Beach School serves pupils in preschool through eighth grade with an enrollment of approximately 258 students.



School Safety:

Per State requirements, MBS conducts at least two active shooter drills, two lockdowns, two non fire evacuations and two bomb threats each school year in conjunction with our local police department as well as a fire drill each month. We have a Visitor Collateral System where visitors must register at the main office. Shelter shutters have been installed throughout the school along with film on exterior windows and one pull magnets for lockdown purposes. Panic buttons have been installed in each classroom with a direct phone line to the main office. Panic buttons in the main office area are connected via speakerphone to 911. Monmouth Beach also employs, in partnership with the township, a Student Resource Officer, to be on site on a daily basis.

Technology and STEM:

As part of the district's technology program, all students in K - 8 through receive instruction in the technology lab to develop computer skills and how to apply those skills to their classwork. Students in grades PK-8 also utilize online resources such as MyOn and Study Island to supplement daily lessons and curricular programs. Within the past several years, the District has made a significant investment in purchasing chrome book computers for use in grades PK-8. The school is currently at a 1:1 level with these devices for the students in grades PK-8 and has additional inventory to make these devices available for related arts use in music and in grades one and two as well. As of this year, students grades 6-8 have been given brand new 14 chromebooks with sleeves that they are able to take home daily. During the last year, an Innovation Lab with an e-gaming space has been added.
