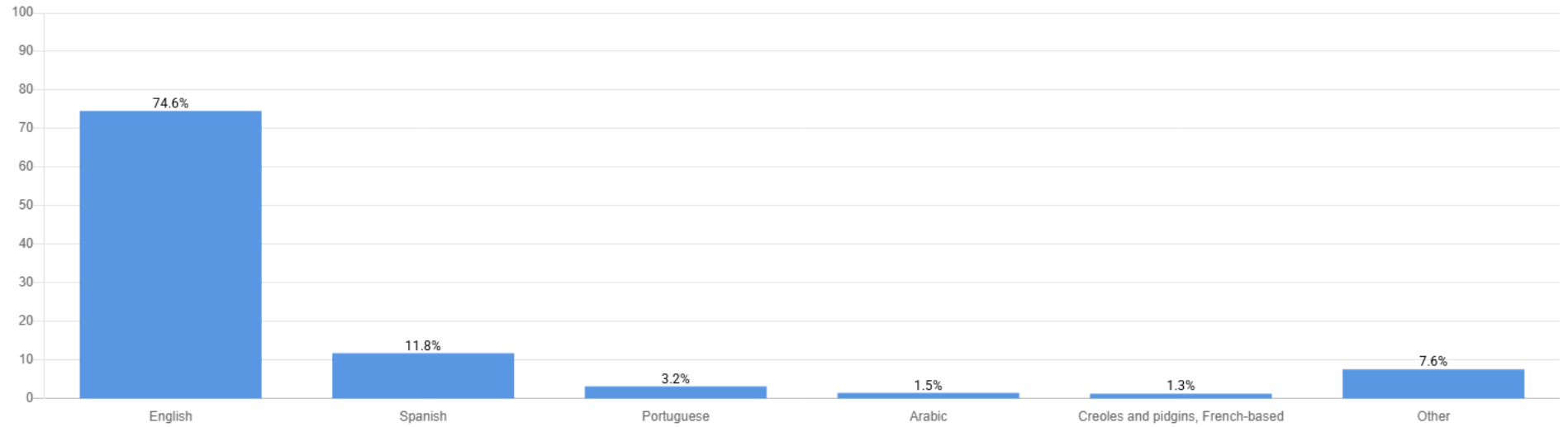

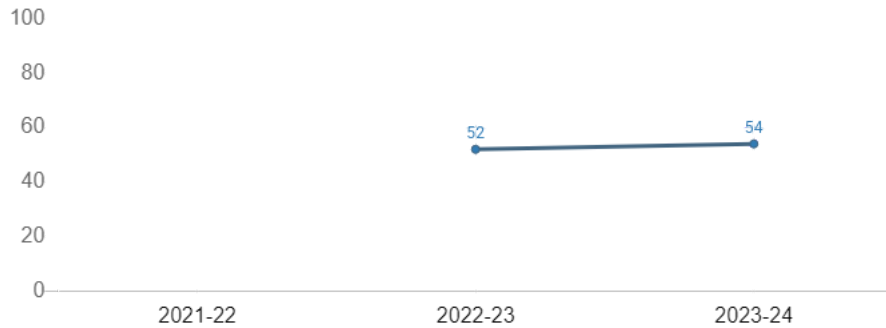

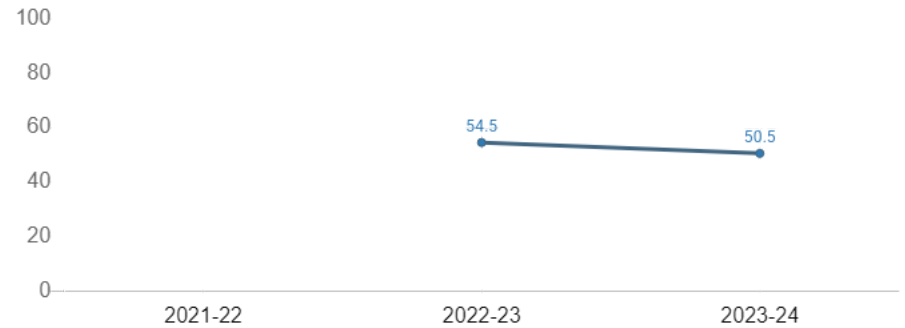

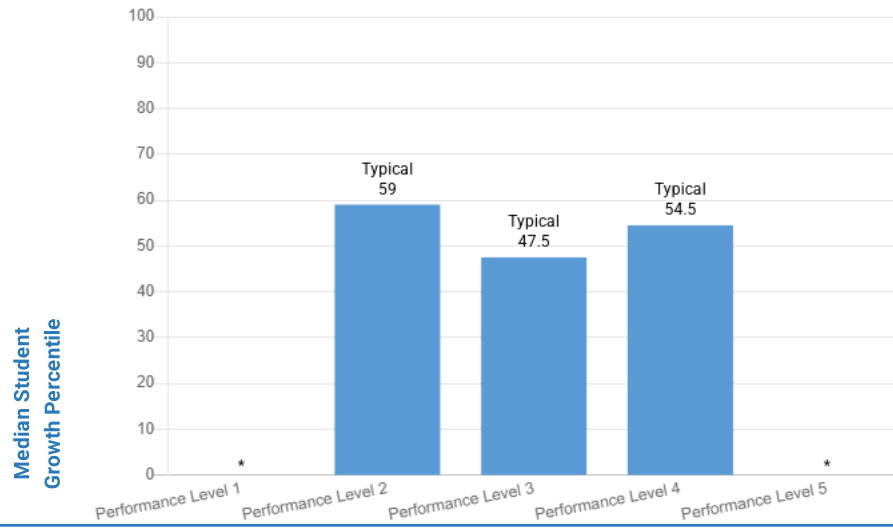

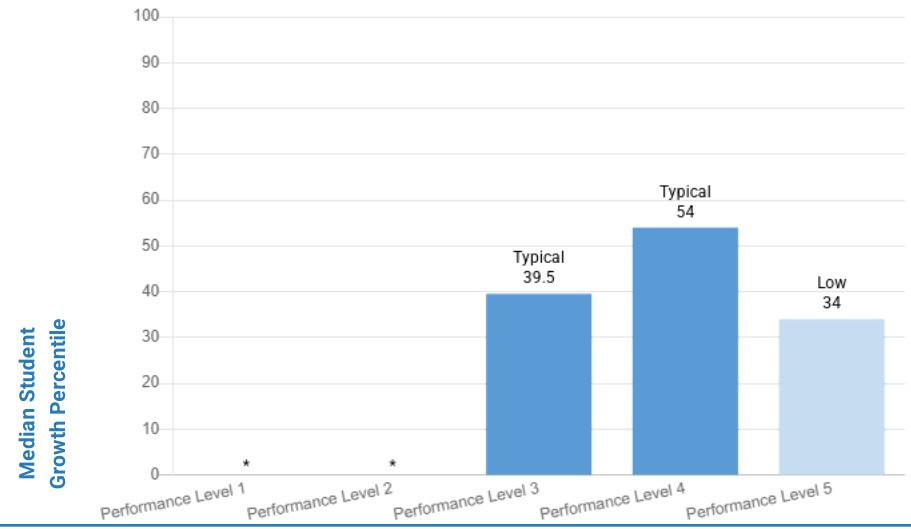

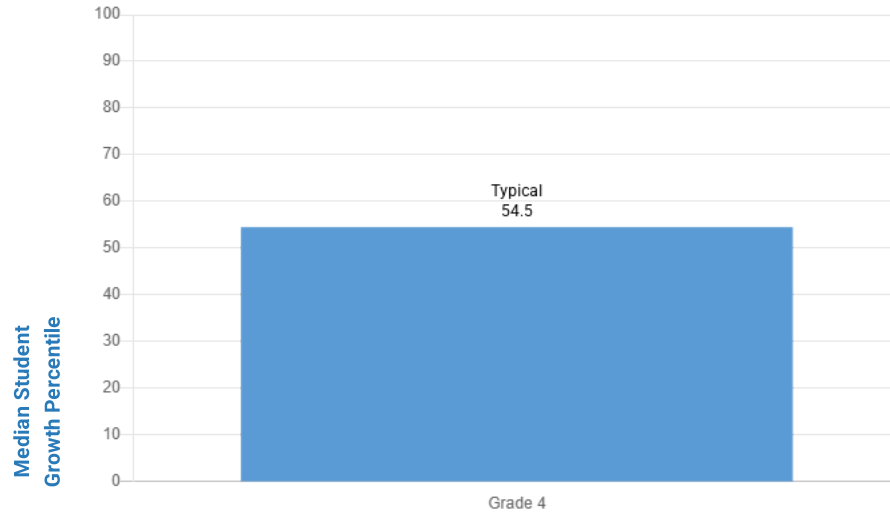

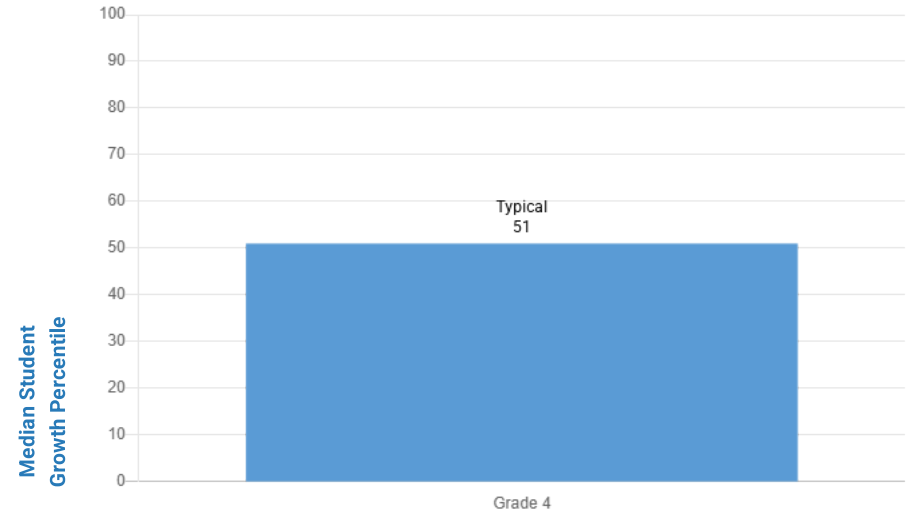

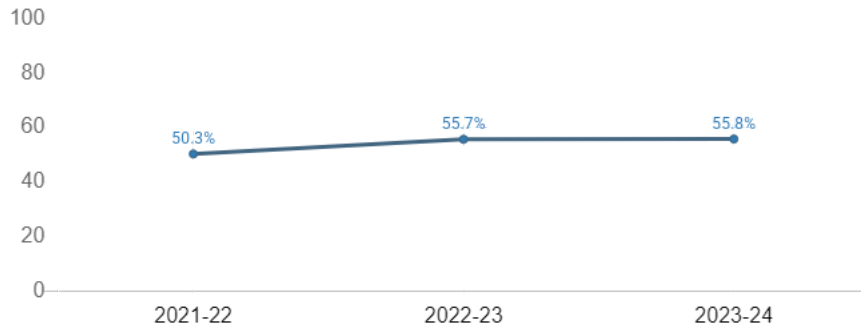

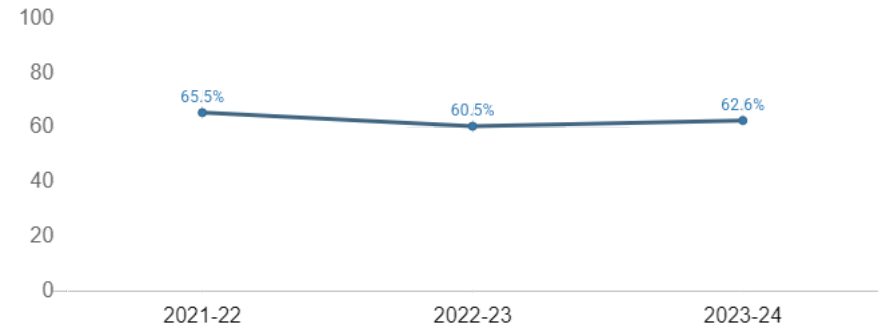
English Language Arts and Mathematics Performance Trends

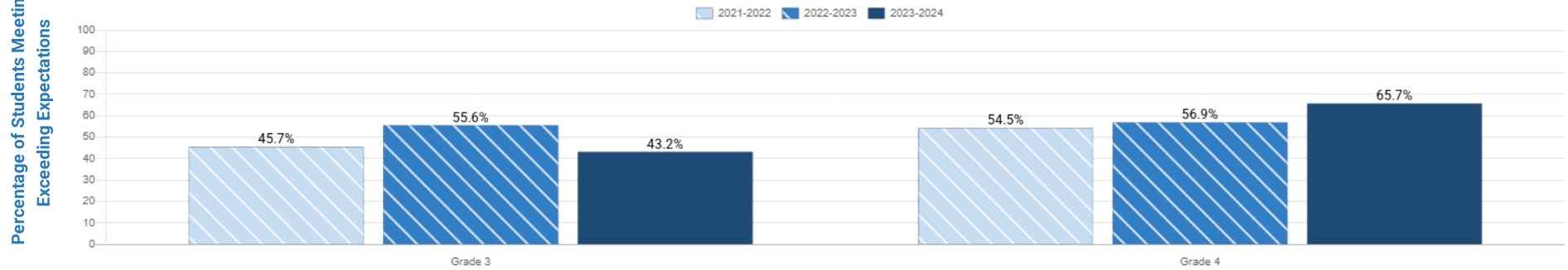

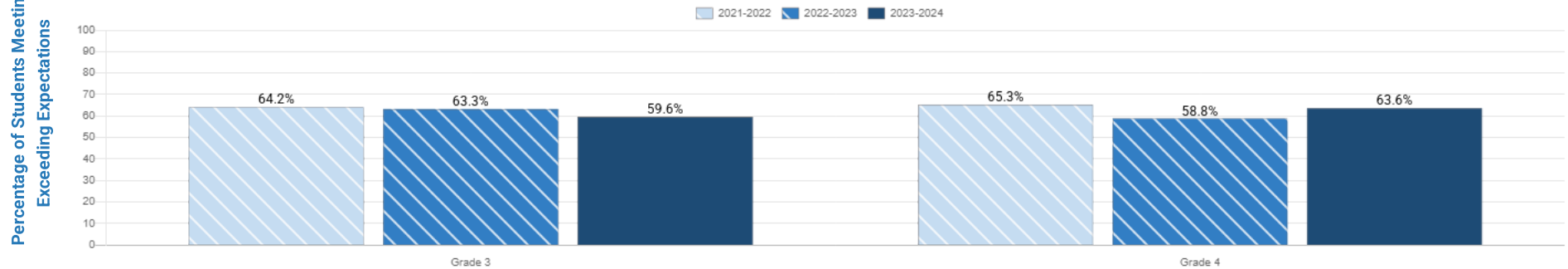

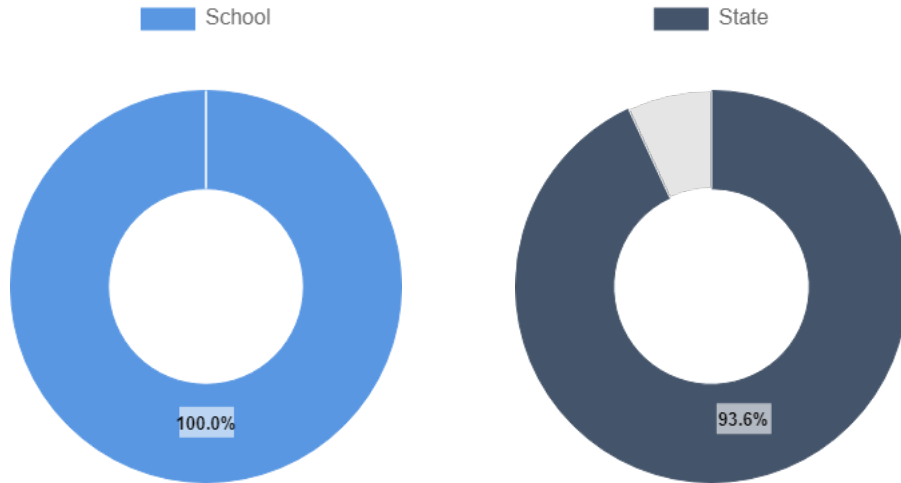

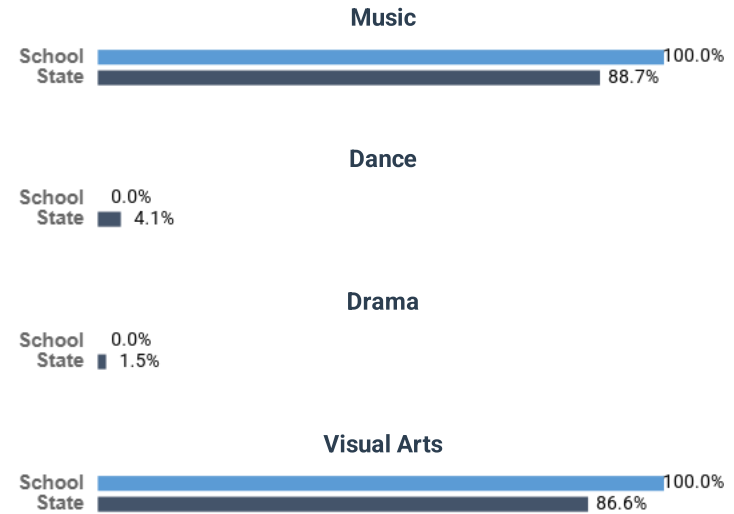

Students enrolled in one or more classes by discipline:



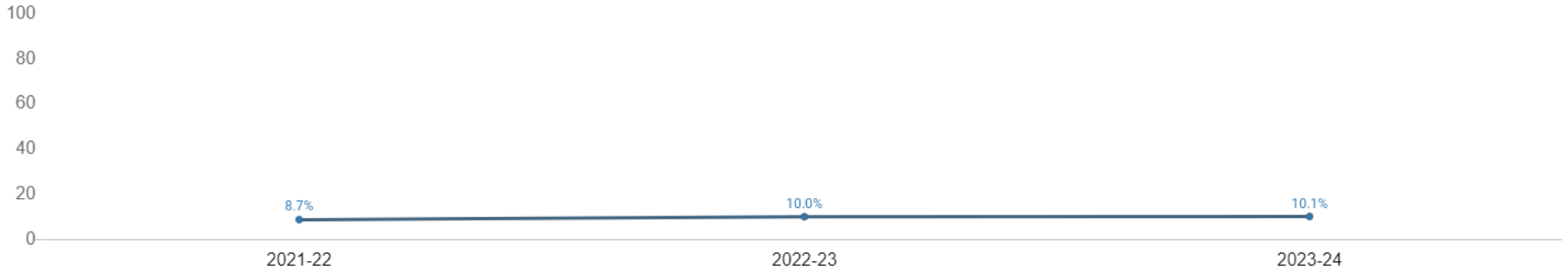

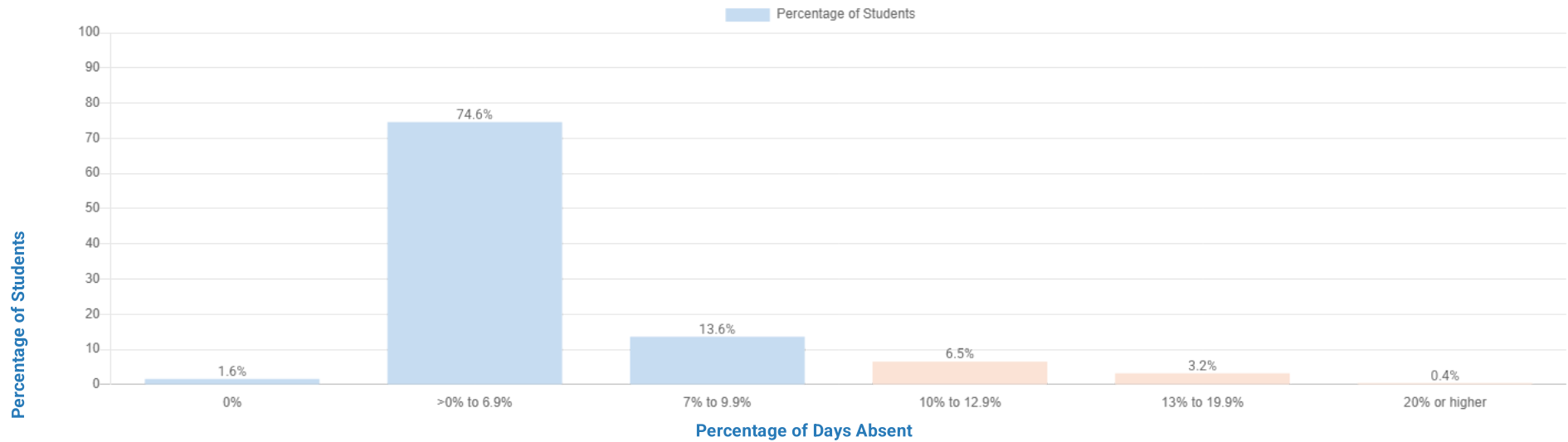

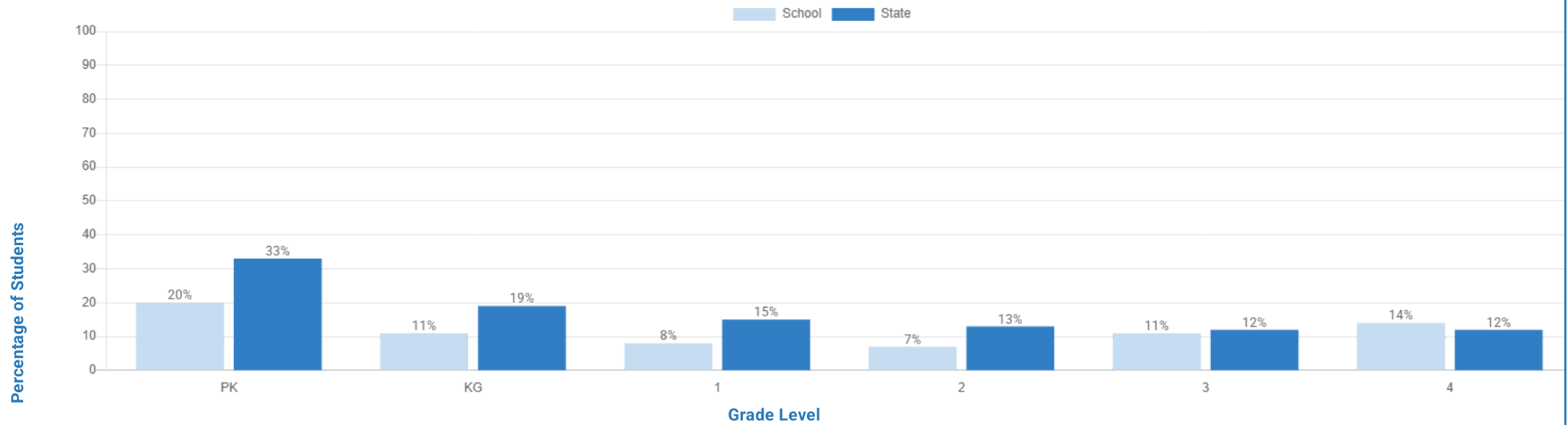

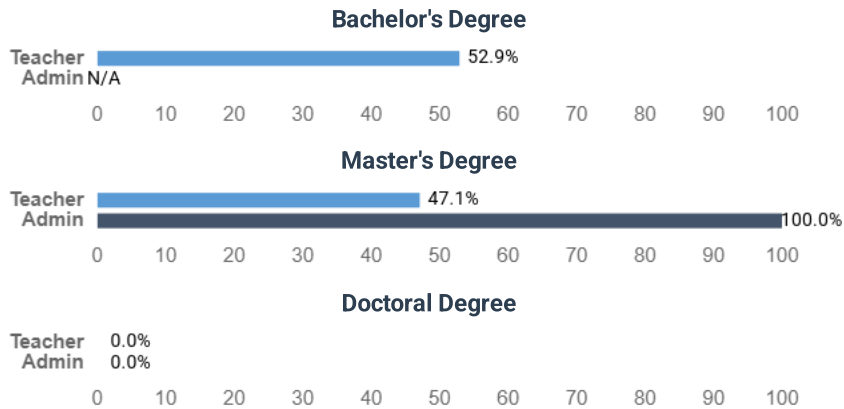

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Staff and Professional Learning:

Professional learning takes place throughout the year and is based on the belief that children learn best in real-world contexts that make sense to children; that all students deserve a richer and more challenging curriculum; and that a balanced and practical approach to learning is best for understanding concepts. PLCs at our school are centered around improving student engagement. We participate in the New Jersey Tiered System of Support Grant. This year's focus is to improve our core instruction in the area of ELA by prioritizing our instructional time in response to formative assessment. Our teachers participate in professional development provided by our State Coach. Individualized and grade level PLC professional development is provided by our building instructional coach, our ELA supervisor, and our building principal. Additional PD is being provided to our BSI/Intervention/RR1 teachers to improve our ability to use data to target intervention and monitor student progress.



Student Supports and Services:

Special education classes for resource center and self-contained learning and language disabilities classes utilize additional reading methods with an alternative approach for teaching skills. We also have a Spanish Bilingual program. English language learners as well as struggling learners receive supplemental instruction as needed. Tiered Intervention Plans address individual student needs through I&RS. A SAC counselor is available once a week.



Student Health and Wellness:

Breakfast is offered to all students each day. Students are given Physical Education classes 2xs a week. Students take part in a 10 minute recess in the morning and a 30 minute recess during the afternoon. Wayside has a Sensory Room available to use with staff guidance and sensory walks in the hallways to address student sensory concerns. The Guidance Curriculum implements lessons on Growth Mindset and Mindfulness. There are schoolwide SEL activities daily and a Week of Respect.
