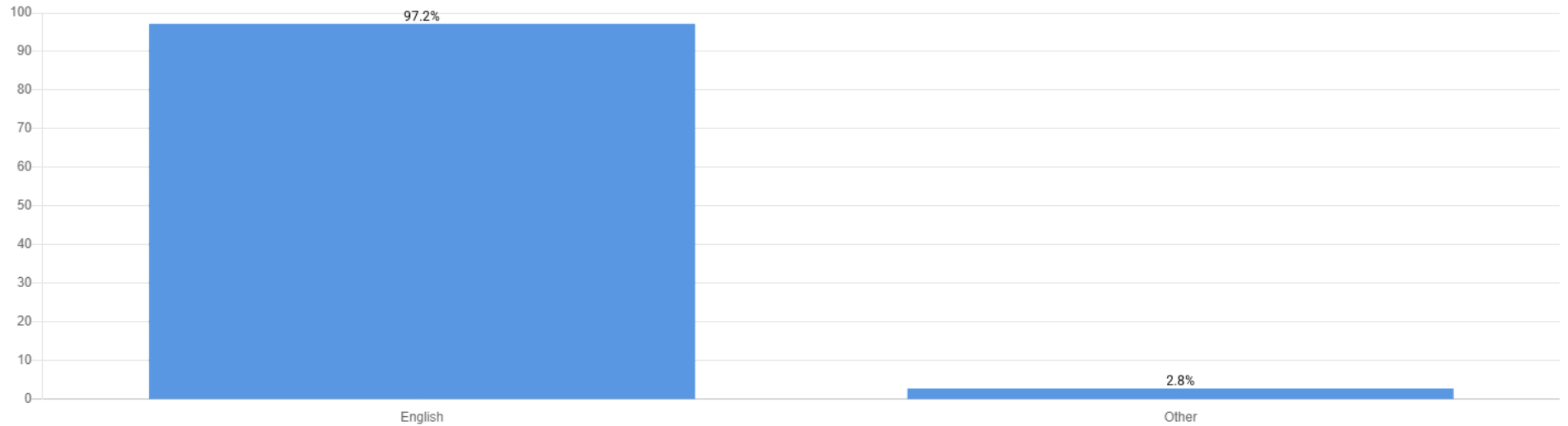

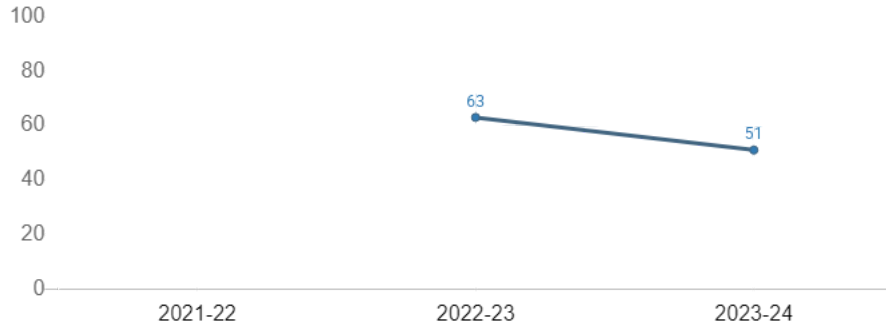

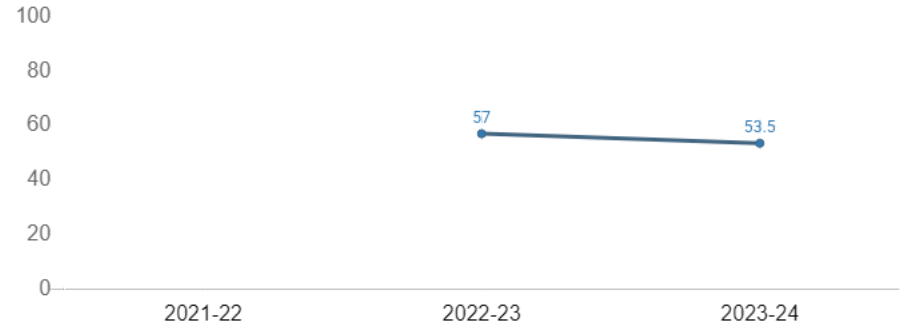

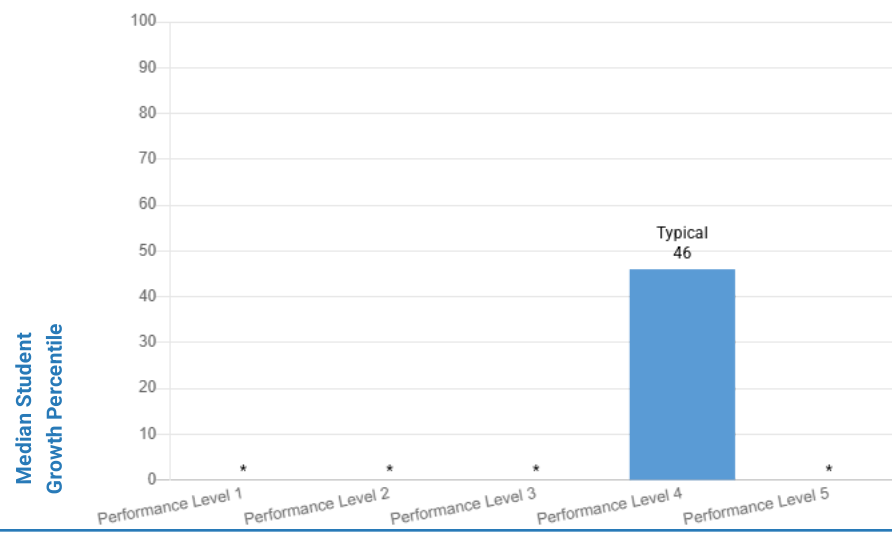

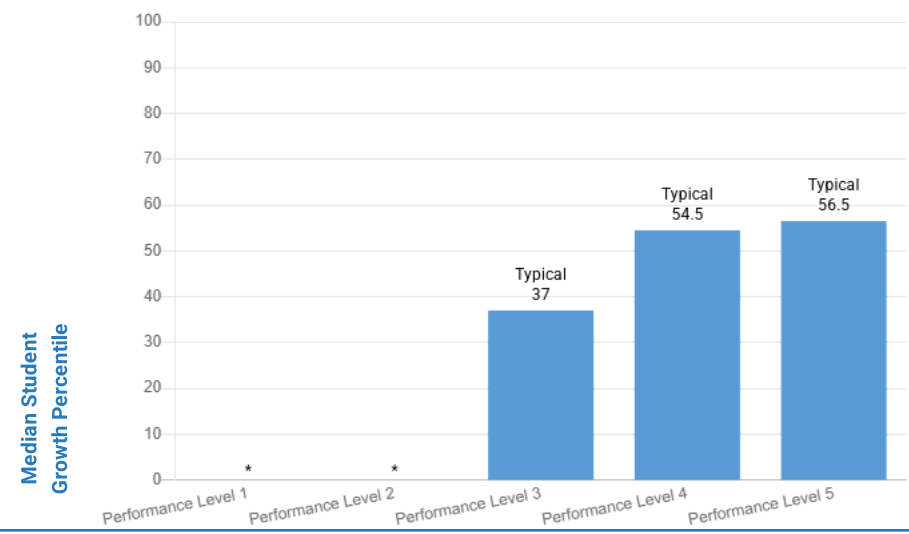

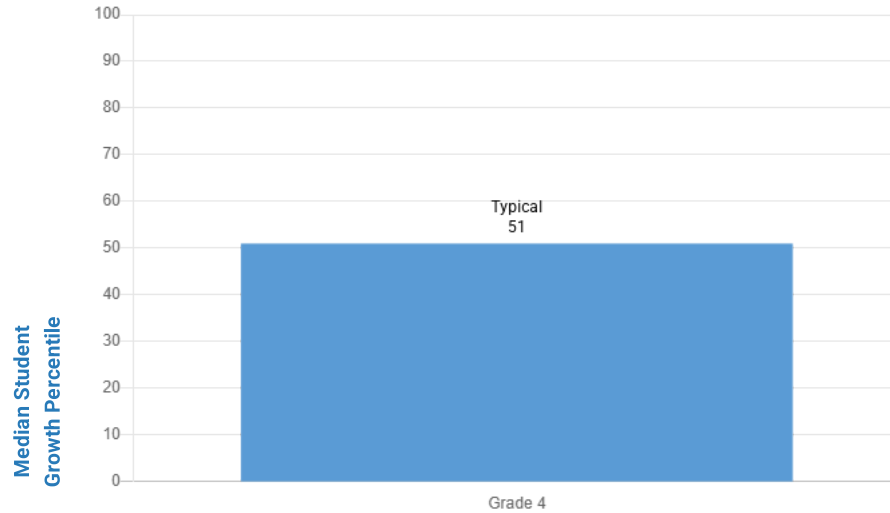

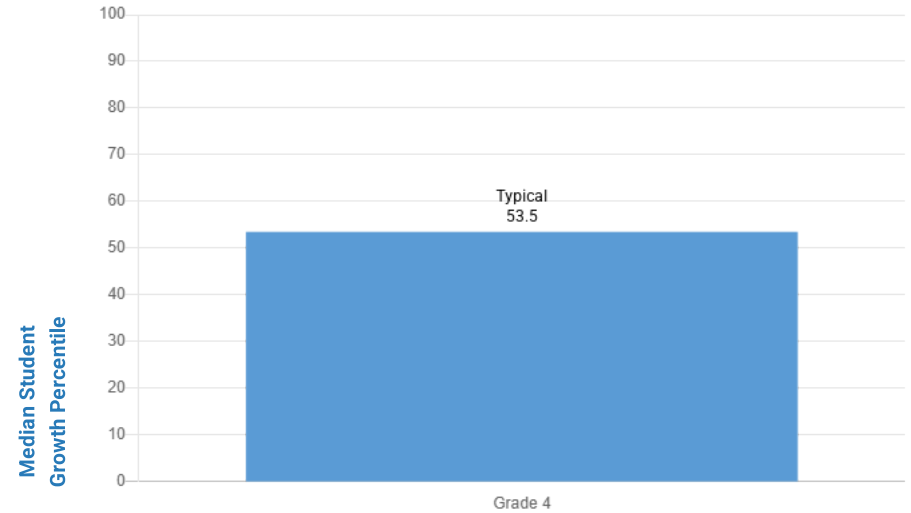

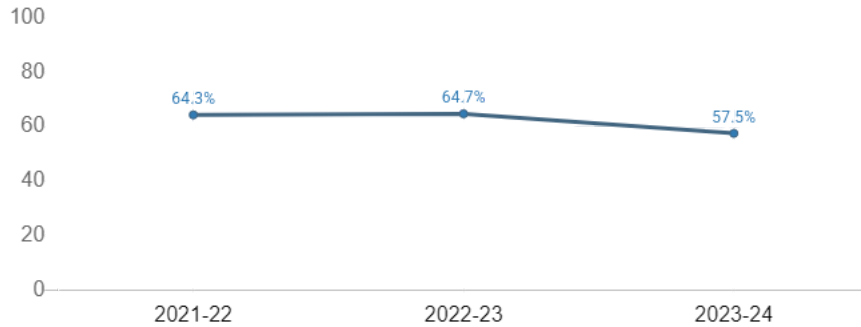

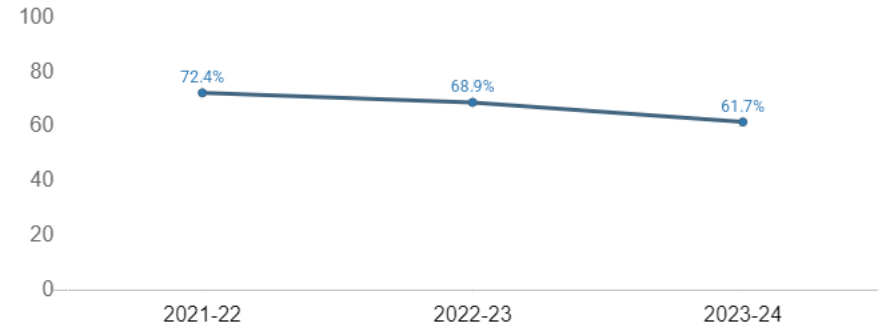
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 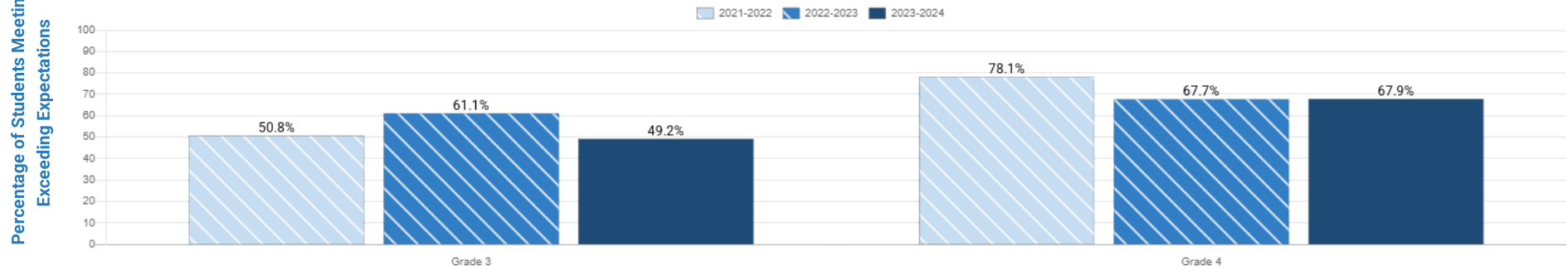

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

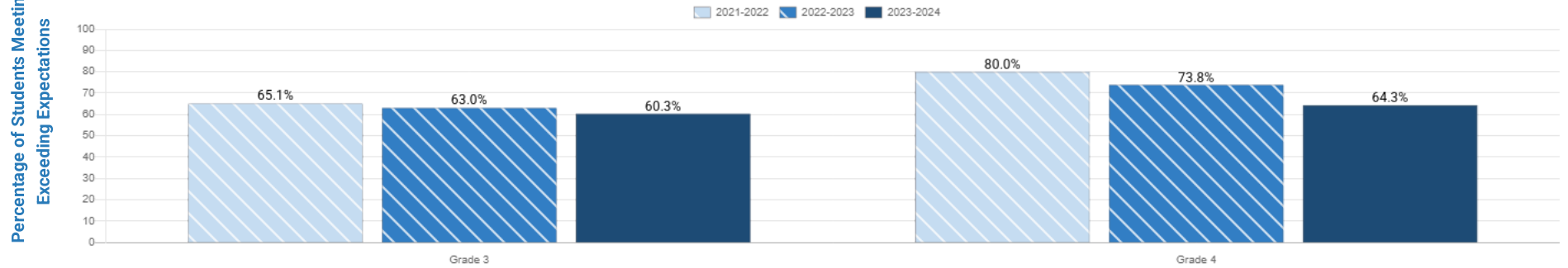

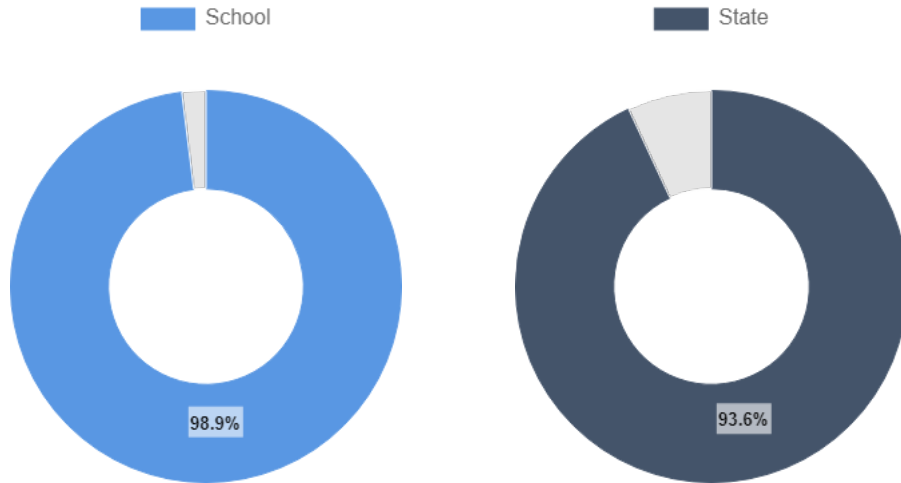

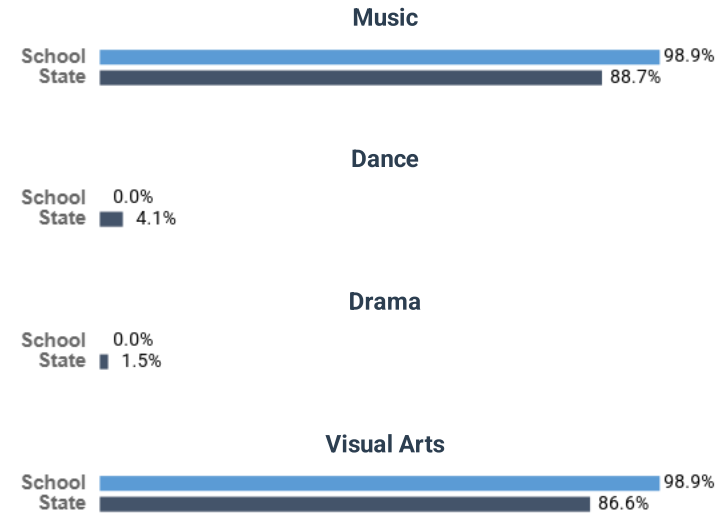

Students enrolled in one or more classes by discipline:



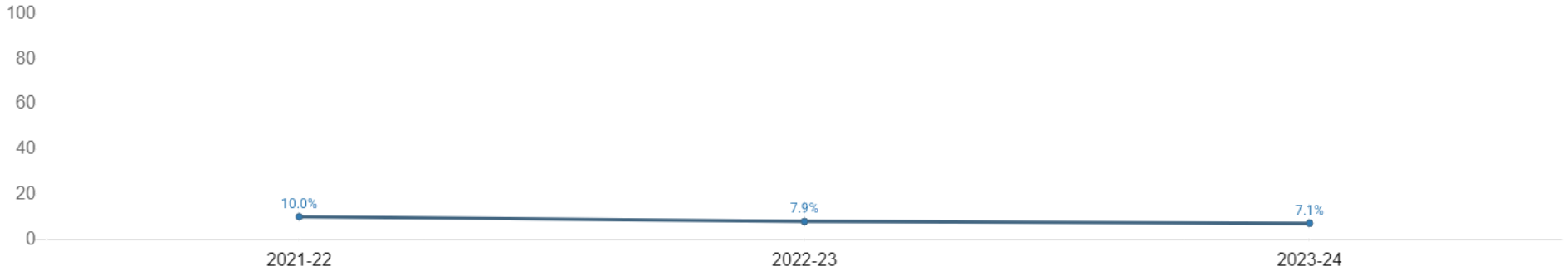

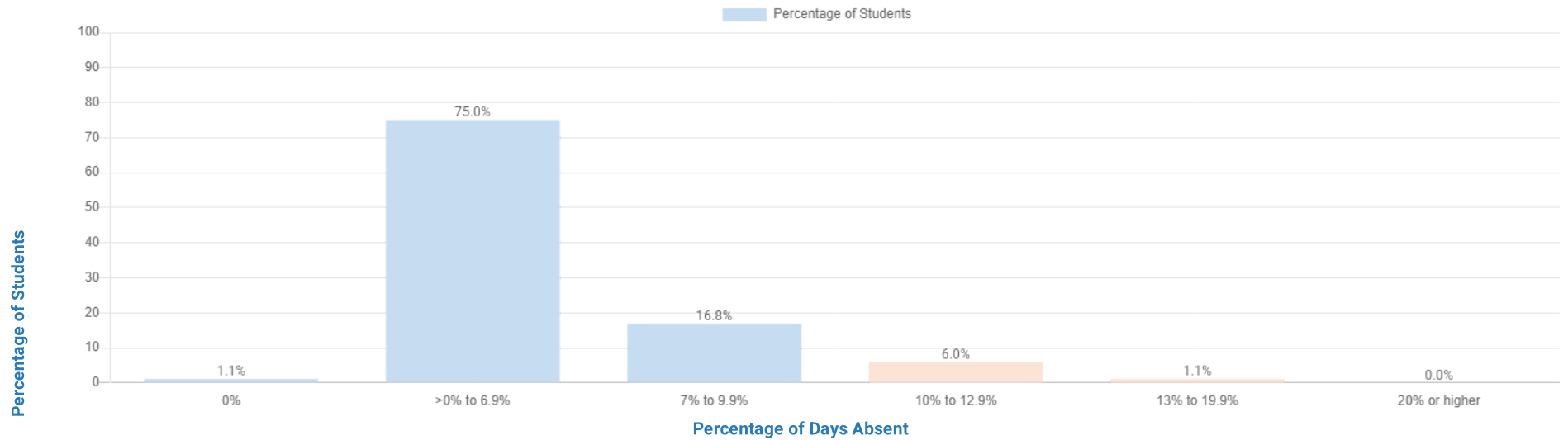

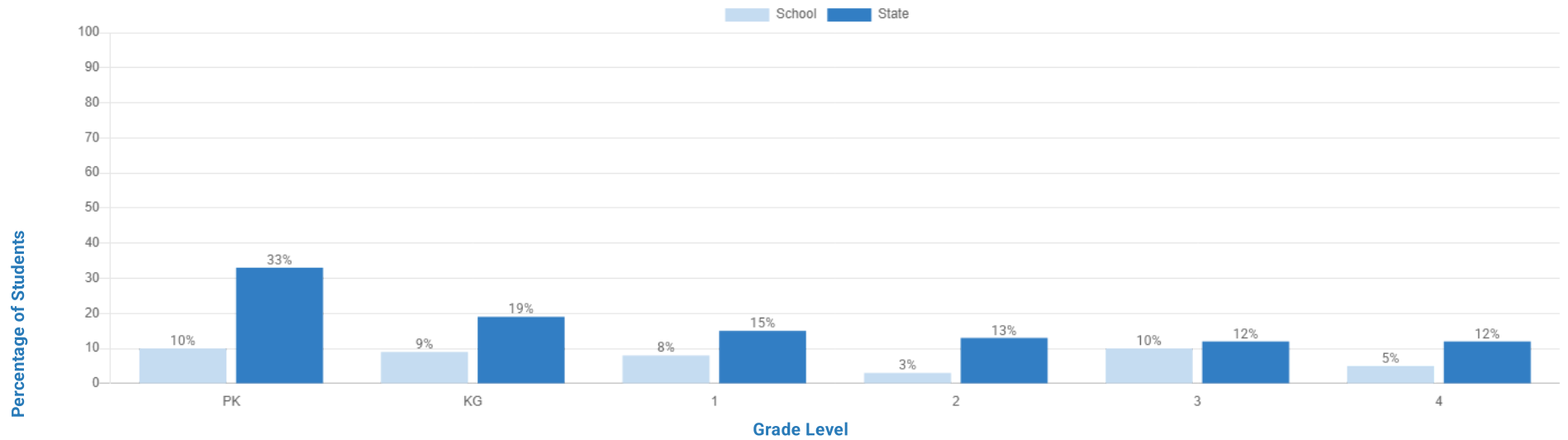

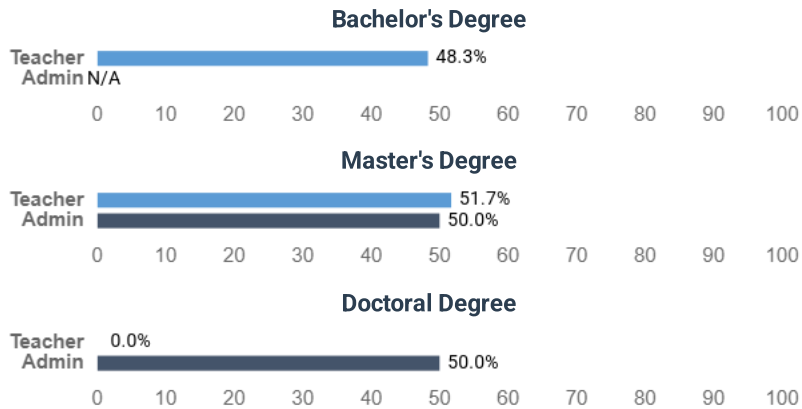

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. In addition to core courses, students at Wolf Hill school receive instruction in Art, Spanish, STEAM, and Music. Wolf Hill also offers a pull-out G&T program for selected students in grades K-4, and a pull out enrichment program in reading and math. All curricula are aligned to state standards.

Before and After School Programs:

The Before Care and After Care program is delivered on-site via Champions Child Care (a division of Kinder-Care. Champions Child Care is offered before and aftercare for students from Grades K-5 school. The Champions morning program began at 7 a.m. and the aftercare program ran until 6 p.m.



Staff and Professional Learning:

Oceanport's staff of highly qualified teachers continue to grow professionally through both in-district and out-of-district/virtual professional development and through workshops and conferences. We also have an Instructional Coach on staff that provides embedded professional development district-wide. In addition, a special education consultant has been working with the Oceanport staff to support Specially Designed Instruction (SDI) and research-based practices as it pertains to inclusive programming.



Student Supports and Services:

Students who are referred to the Child Study Team may be evaluated to determine eligibility for Special Education services. Students who are found eligible for Special Education and related services are provided with an appropriate array of programs, as per their Individualized Education Program (IEP). Speech, occupational therapy, behavioral services, and physical therapy are also available. Additionally, therapeutic services are accessible to all students through school guidance staff. Wolf Hill also has an Intervention and Referral Service (I&RS) committee. Tier 2 and Tier 3 interventions are provided to students who meet the requirements for support. Students may receive accommodations and/or modifications required by the ADA through a 504 Plan. English as a Second Language (ESL) services are available to those students who qualify through multiple criteria.

Student Health and Wellness:

The Oceanport District's Health Curriculum promotes health and wellness. Students participate in gym/health three days a week meeting the state requirement of 150 minutes/week. All students have outdoor recess every day (weather permitting). Social and emotional learning standards are integrated throughout programs. The school offers a student of the month program that recognizes students who display behavior and character traits aligned to the seven pillars of character. The school also implemented a student leadership program called Wingmen. This program helps to develop leadership skills in our fourth grade "Wingmen" by allowing them to interact with students in the lower grades levels to develop positive relationships through team building activities. The students model appropriate behavior and peer to peer problem solving skills.



Parent and Community Involvement:

The schools are an extension of the community in Oceanport and include various stakeholders in the educational and decision-making process. An active PTO sponsors multiple activities for students including dances, book fairs and assemblies. Additionally, the PTO raises money to fund teacher grant programs that benefit students in all classrooms. The district has an active Special Education Parent Group entitled, "Advocates for Diverse Learners." This parent-led group offers support to parents of diverse learners as well as articulates systemic concerns to district-level administration. The goal is to improve the overall quality of special education district-wide. Weekly principal newsletters and monthly Director and Superintendent newsletters are sent out to promote communication to all stakeholders.

School Safety:

The district employs a School Security Specialist who oversees all drills, security procedures and protocols, and works directly with our Class III Officer and the School Resource Officer (SRO) from the Oceanport Police Department.



Technology and STEM:

Wolf Hill is a "1:1 school" where all students have and use a school-issued Chromebook. These devices are regularly used through center-based activities, enhancing student learning in the content areas, and making practice experiences fun and engaging for students. Also, Smart Projectors are located in each classroom to provide interactive learning through technology. Wolf Hill also offers a related arts class for all students K-4 at Wolf Hill School in the area of STEAM. The class focuses on concepts such as design thinking, understanding technology and its impact on our world, and basic coding and animation.



Early Childhood Education:

Oceanport offered a tuition-based preschool program for children ages 3 and 4 until January 2024 when the district received the PEA funding from the state. The district then opened two new additional classrooms and provided free preschool services to 50+ Oceanport and Sea Bright residents. The program follows the highly acclaimed and research-based "HighScope" curriculum to prepare students for successful entry into Kindergarten. In addition to the integrated preschool class, Oceanport also offers a preschool disabled classroom for those students found eligible.
