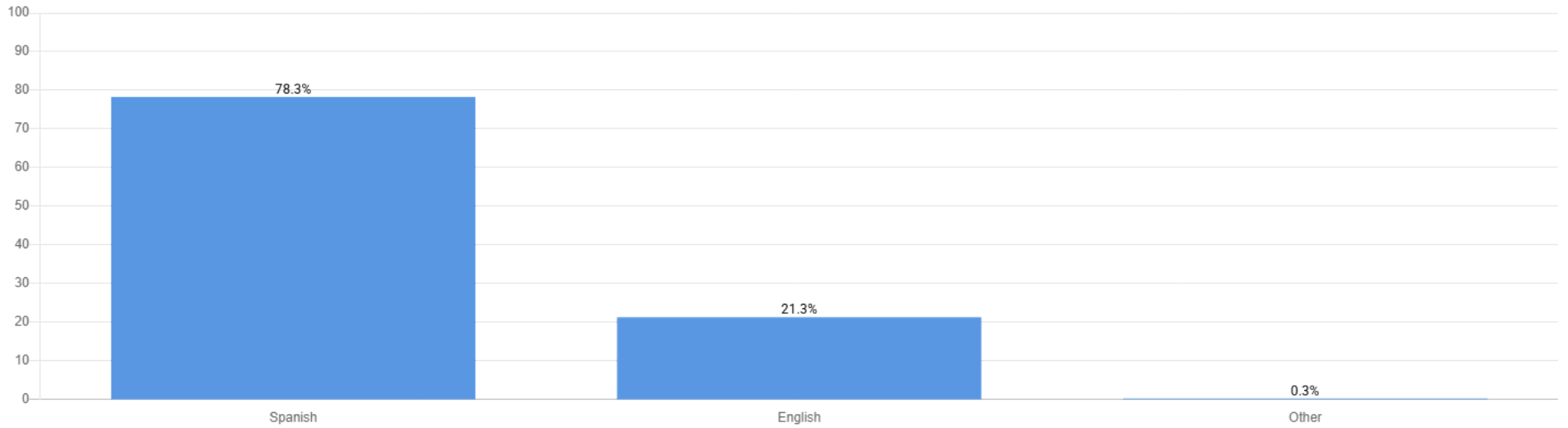

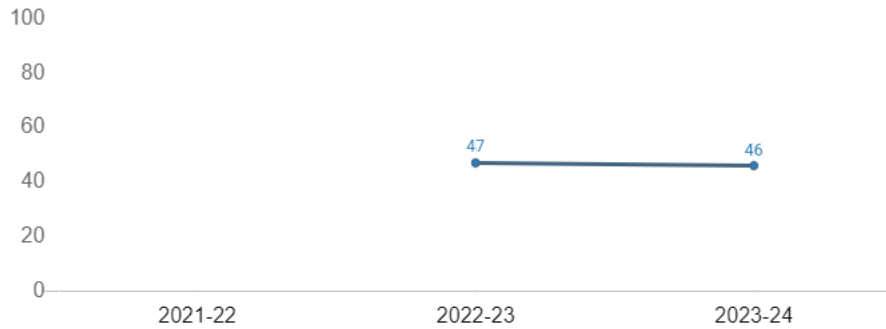

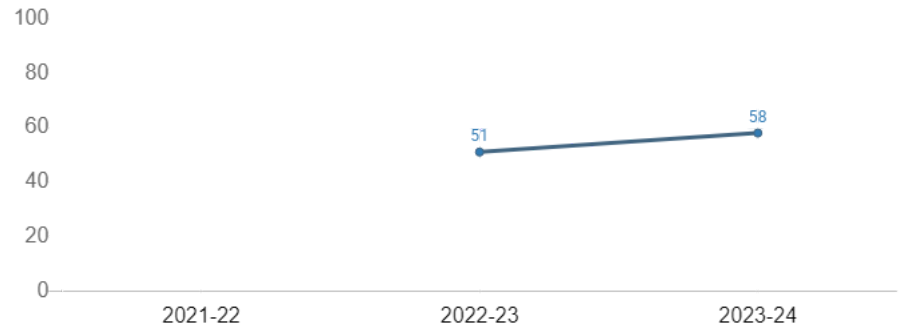

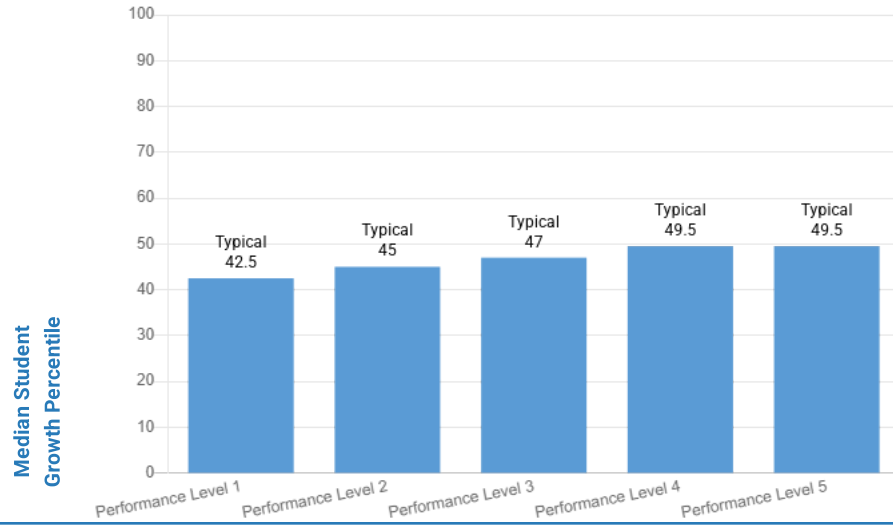

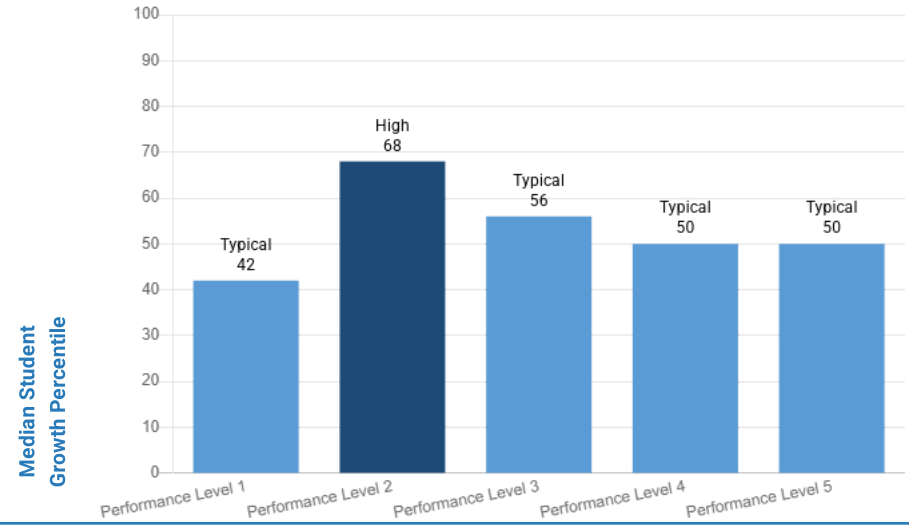

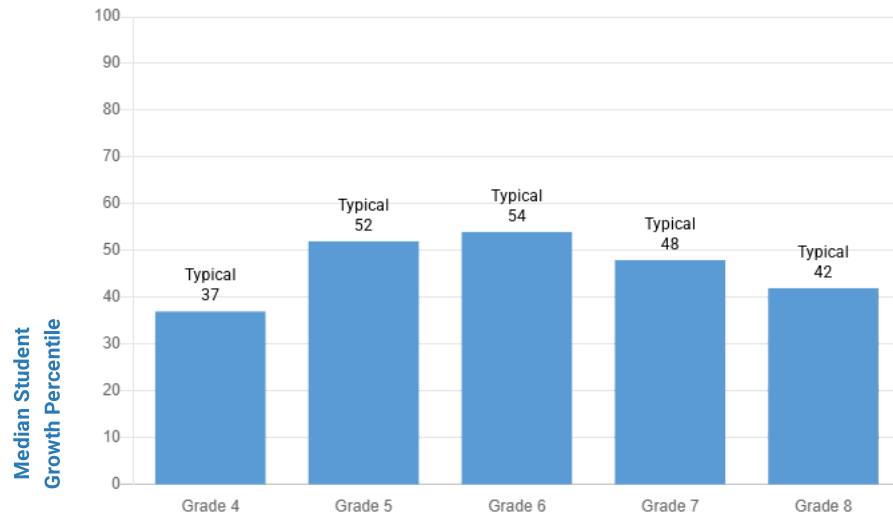

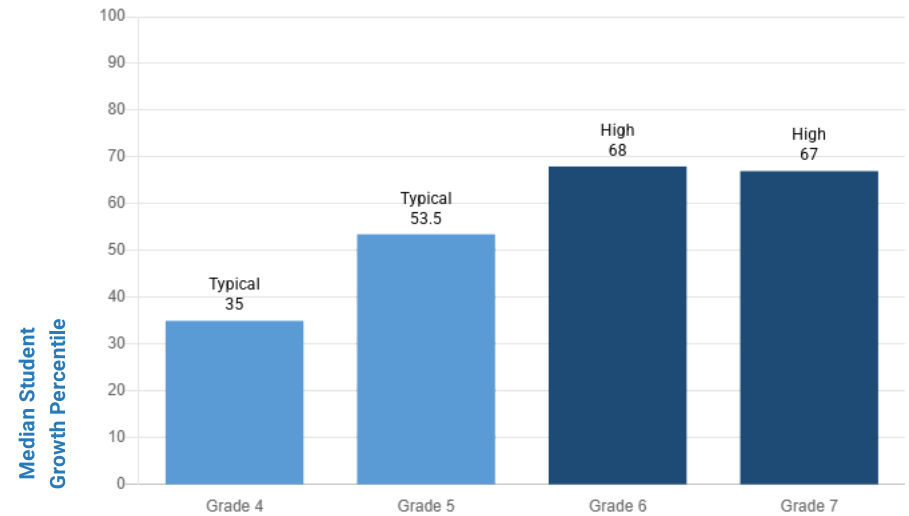

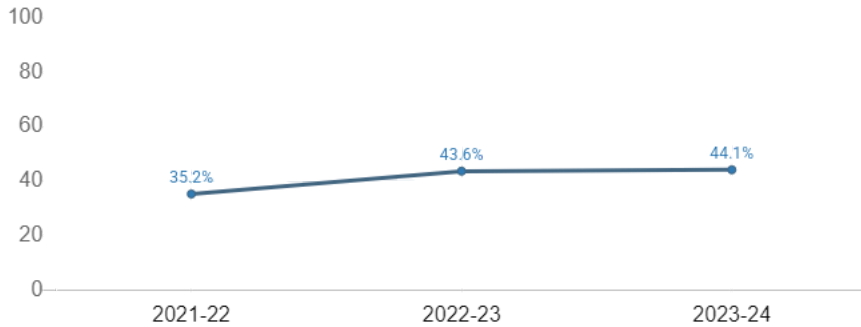

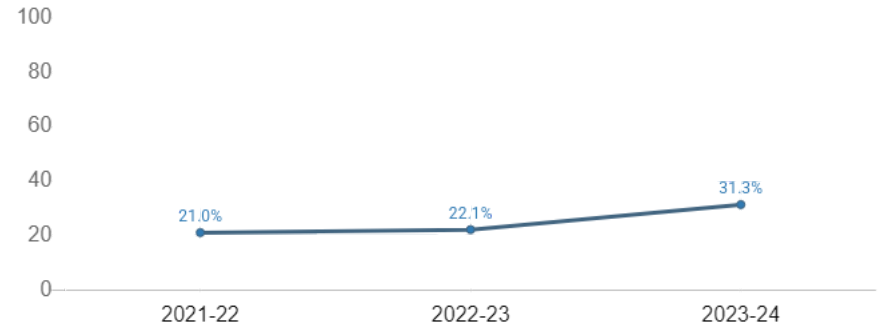
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 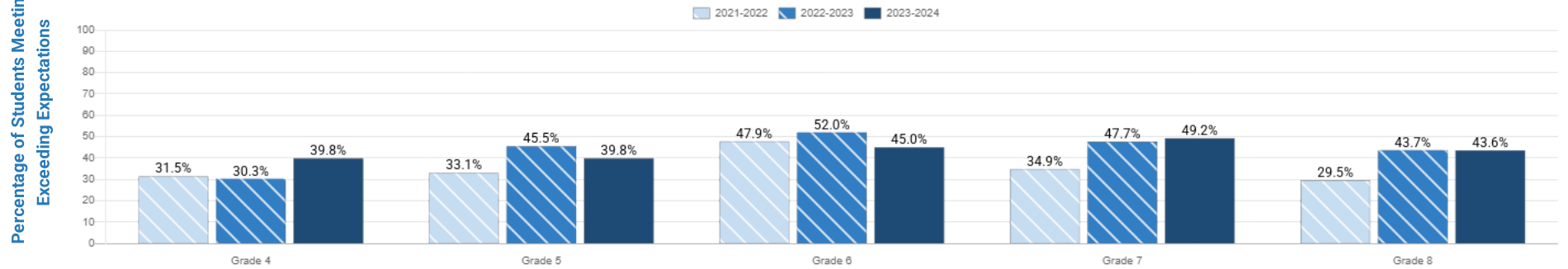

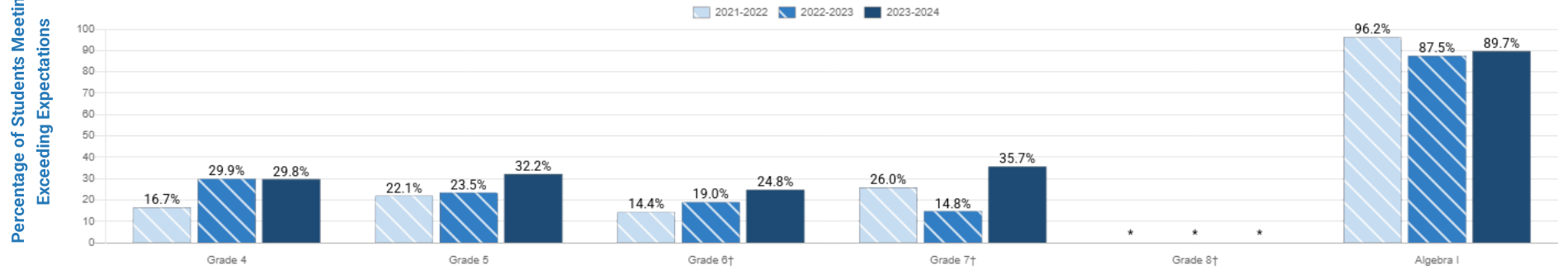

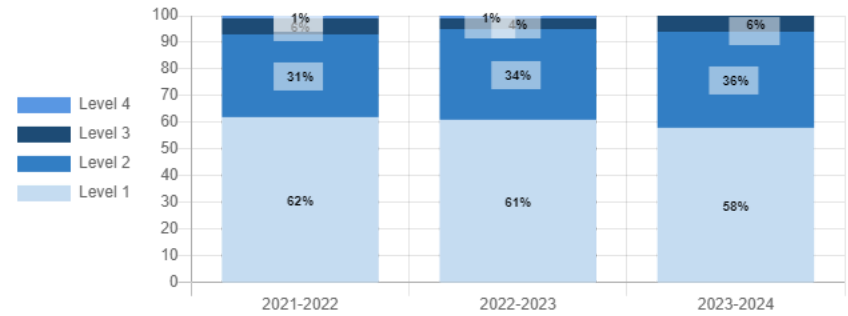

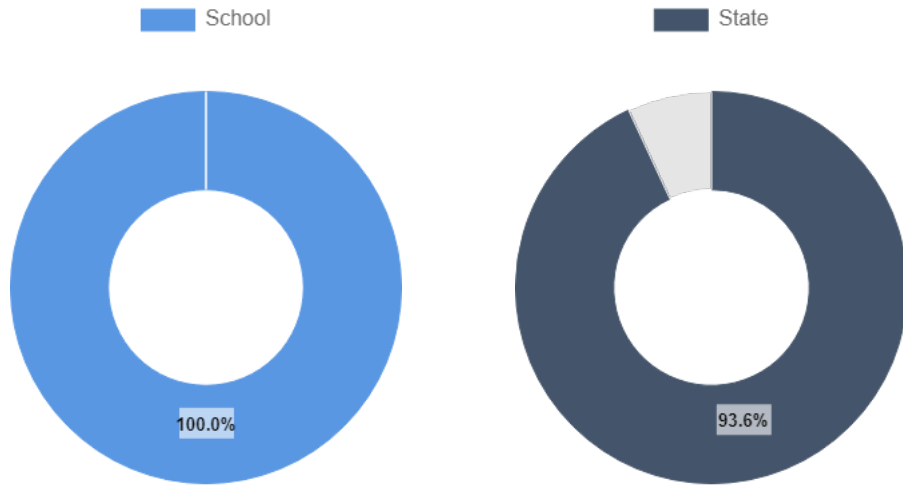

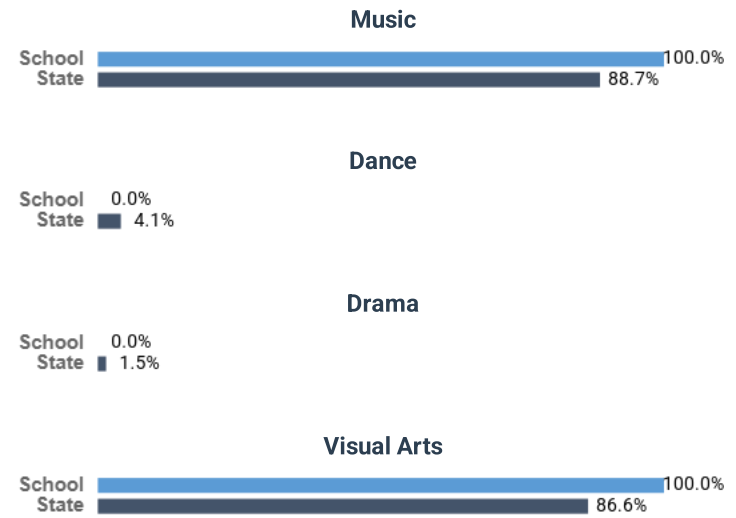

Students enrolled in one or more classes by discipline:



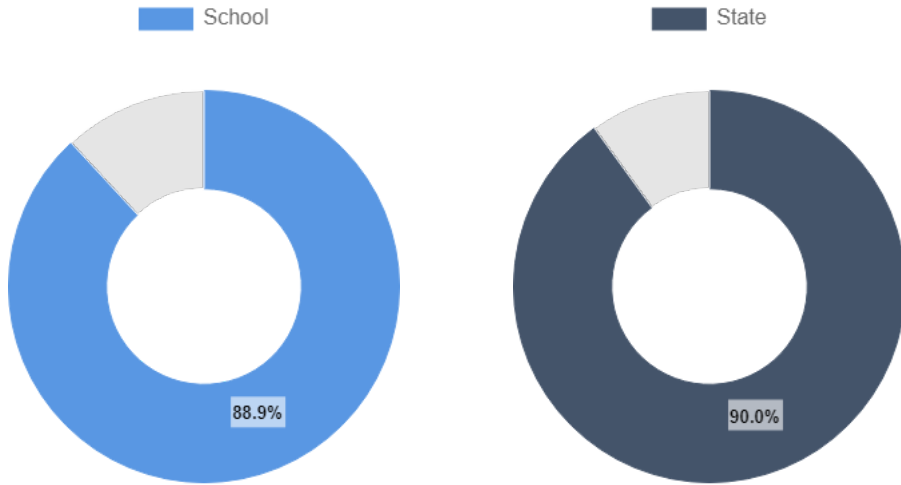

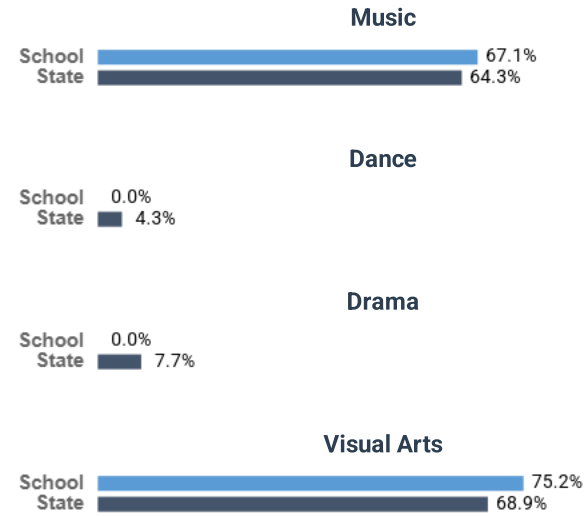

Students enrolled in one or more classes by discipline:



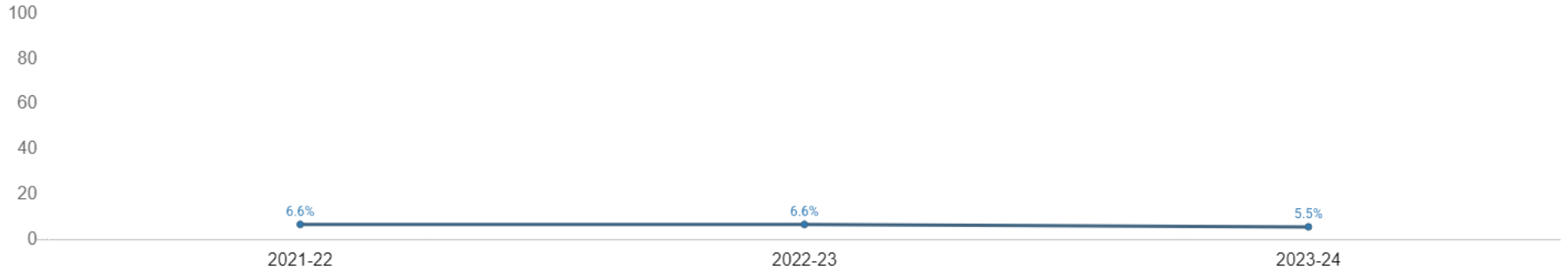

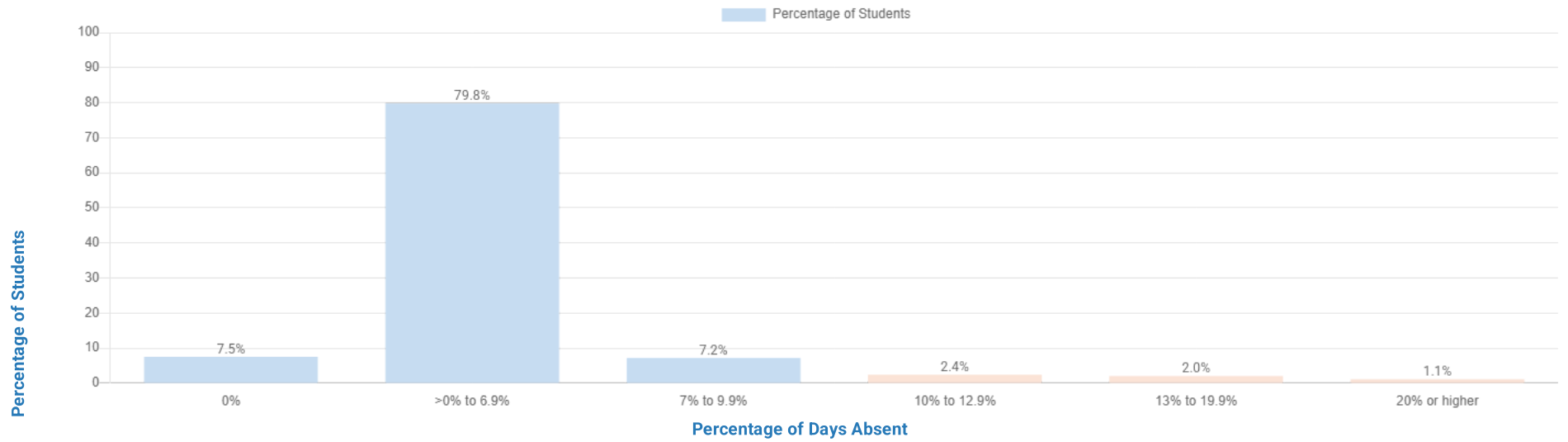

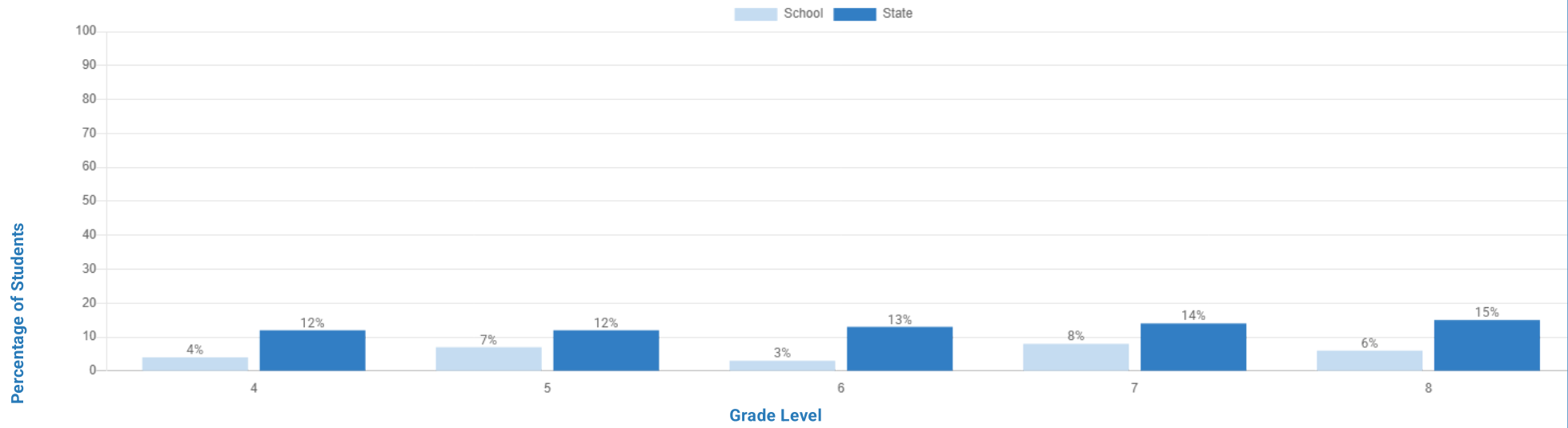

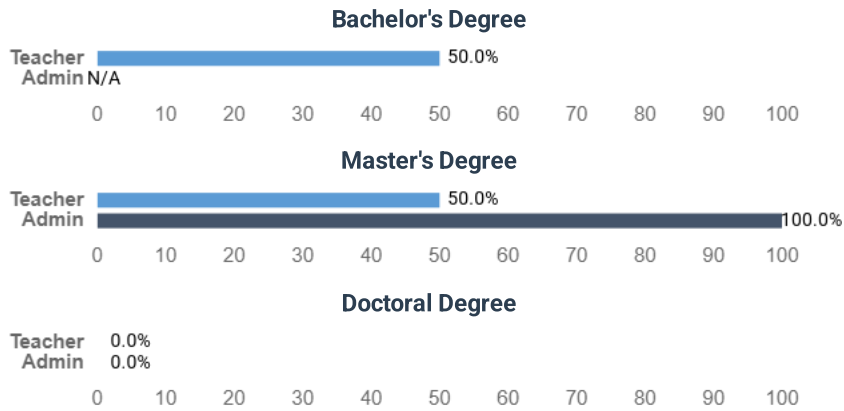

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Accountability Summary by Student Group - 2023-24 School Year

Our staff is trained in SEI and we offer personalized academic support. We have adopted a new ELA program Grades 4-8 that integrates ELA with Science and Social Studies. Additionally, our co-teaching model in Grades 4-8 provide extra support for our students, including more opportunities for targeted small-group instruction. Teachers in these partnerships are able to triangulate various data sources during PLCs and, with guidance from instructional coaches, to personalize student learning. We also continue to enhance and integrate the AVID model in Grades 4-8. This year, we are focusing our efforts on collaborative structures, organization and writing.

RBMS offers Boys and Girls Soccer, Baseball and Softball, Cross Country, and Boys and Girls Basketball. Our morning recreational program allows students to develop athletic skills through various drills and activities.

Our students are provided with unique opportunities that allow them to have exceptional experiences through a variety of partnerships that our district has established with Project Write Now, Horizons at Rumson Country Day School, YMCA of Greater Monmouth County, Boys and Girls Club, Salvation Army, Count Basie Center for the Arts, Monmouth Conservatory, Red Bank Parks and Rec, Red Bank Public Library, Red Bank Elks Lodge, and many more!



Student Supports and Services:

Student support services are a cornerstone of our school community. Through the RtI process, we provide early interventions that offer a range of supports for students and resources for teachers. Our Child Study Team enhances these efforts with additional services, including speech and language therapy, while Occupational and Physical Therapists work with staff to ensure students can apply skills across classroom settings. Students with disabilities are supported in various environments, including self-contained and full-day inclusion classrooms. Multilingual learners receive targeted support in bilingual classroom settings or from ESL teachers using a push-in model, ensuring equitable access to education for all.



Parent and Community Involvement:

Our school community maintains positive and collaborative relationships with parents and families. The Parent-Teacher conferences and the Genesis Parent Portal have enabled teachers, parents, and students to stay abreast of students' academic progress. Our Parent Involvement activities continues to support and promote the connections between home and school. Teachers, parents, and students take part in these fun-filled, educational, and hands-on programs to present educational concepts in a way that is meaningful and that the whole family enjoys. Teachers and staff give their time to prepare and organize special activities and events throughout the school year. Some of the amazing events that we offer include RocketFest, various themed dances and dinners, concerts and student performances, family informational sessions, various fundraisers and sales, and incentives and recognition activities that are held throughout the school year.

Climate Surveys:

Feedback is gathered, and the DREAM Team conducts data analysis. The analysis is used for the preparation and enhancement of educational planning for the upcoming school year.



Facilities:

Red Bank Middle School serves approximately 600 students in grades 4 through 8. The first floor houses grades 4 and 5, along with a cafeteria, gymnasium, auditorium, and offices. The second floor contains 6th-grade classes, additional offices, small-group instruction rooms, the AVID/Media Center, the Project Lead the Way lab, and the auditorium balcony. Seventh and eighth-grade classes are located on the third floor, along with small office and classroom spaces. Students enjoy daily lunch and recess, with indoor activities like foosball and basketball arcade games available during inclement weather. Upgrades include air conditioning in the gym, new carpeting, exterior window replacements, and rooftop HVAC units. A full boiler replacement is scheduled for spring 2025. The outdoor area has been fully renovated, featuring a Gaga Pit, pickleball and basketball courts, a walking track, two natural grass fields, upgraded landscaping, and a pavilion with amphitheater-style seating.



School Safety:

Our number one priority is safety and security. In collaboration with the Red Bank Police Department, a School Resource Officer supports the safety of our school community on a daily basis. All staff wear picture ID badges, which allow them access to various entrances. Visitors must show ID and share the purpose of their visit before being buzzed into a security vestibule and then the main office. All doors are locked throughout the entire day, and we house video surveillance cameras both inside and on the exterior areas of the building. Additionally, staff and students practice various types of safety drills monthly.

Technology and STEM:

Technology is central to daily operations at RBMS, enhancing personalized learning through the 1:1 Chromebook initiative. Teachers leverage Chromebooks, Interactive Whiteboards, and web-based learning platforms to foster student creativity and engagement. Tools like Google Classroom and Google Drive enable collaboration between teachers and students, facilitating real-time peer feedback and group work. Students also participate in Computer Science and Project Lead the Way (PLTW), a STEAM-based curriculum that integrates science, technology, engineering, art, and math. This hands-on approach builds problem-solving, critical thinking, and innovation skills. Additionally, RBMS offers a wide range of special area classes, including Art, Music, AVID, Physical Education/Health and Spanish.



Attendance:

The Middle School continually emphasizes how the importance of regular attendance is essential for a child's academic and social growth. Parents are encouraged to send children to school daily if they are healthy since consistent attendance builds routine and supports learning. Parents are reminded to send a doctor's note to school after their child is absent from school. If absences become a concern, reminder letters are sent home to parents, and meetings with the Principal or Vice Principal may be scheduled. In rare cases, a court referral may be considered or recommended. The Main Office makes phone calls home daily if absences aren't reported, and unverified absences may lead to a wellness check by the Red Bank Police Department. We pride ourselves on prioritizing attendance and on working collaboratively with the parents to ensure our student's success and well-being.
