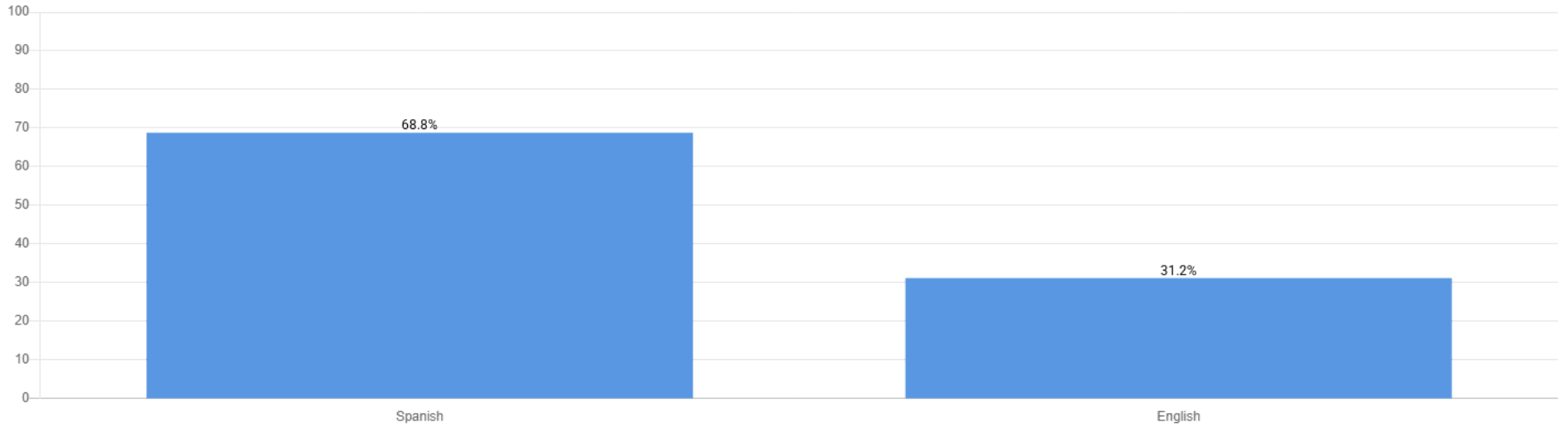

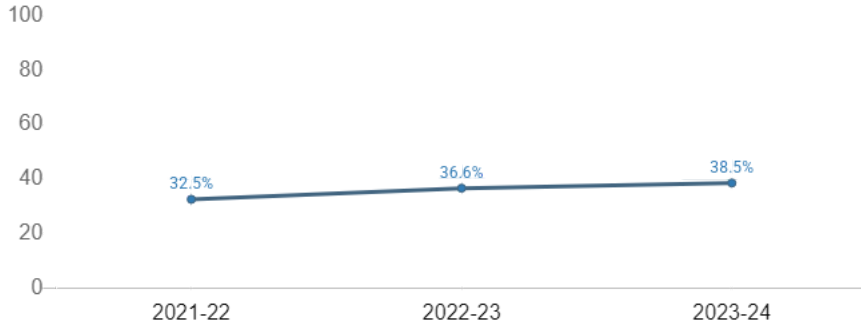

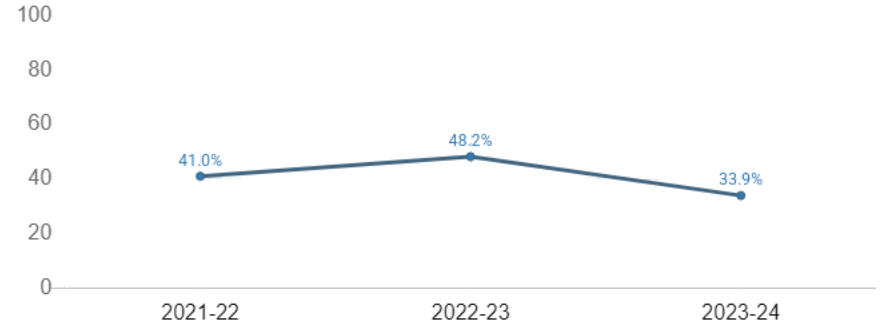
English Language Arts and Mathematics Performance Trends

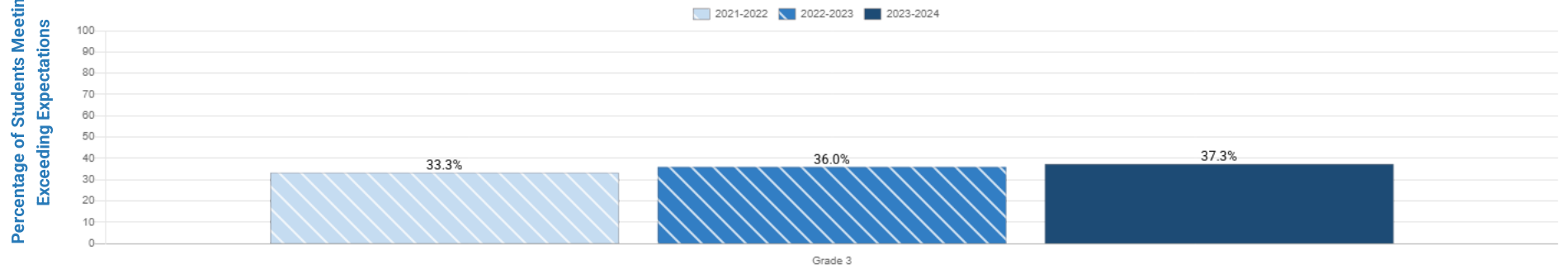

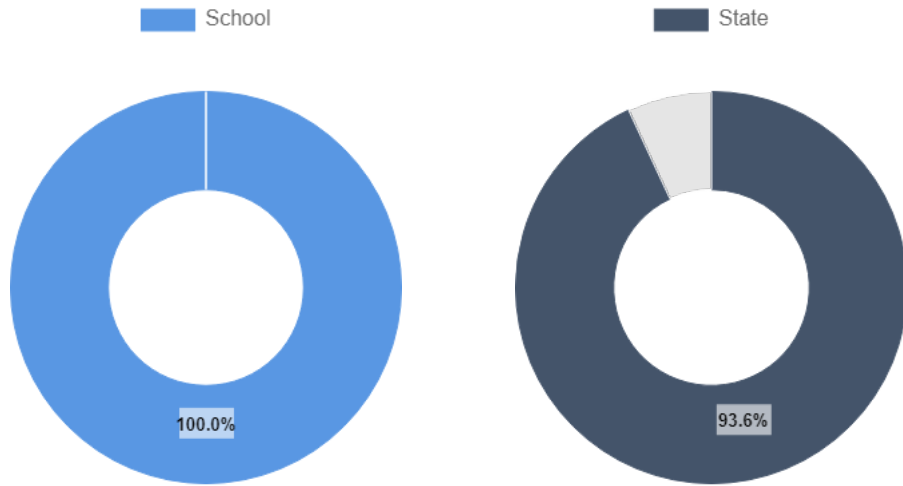

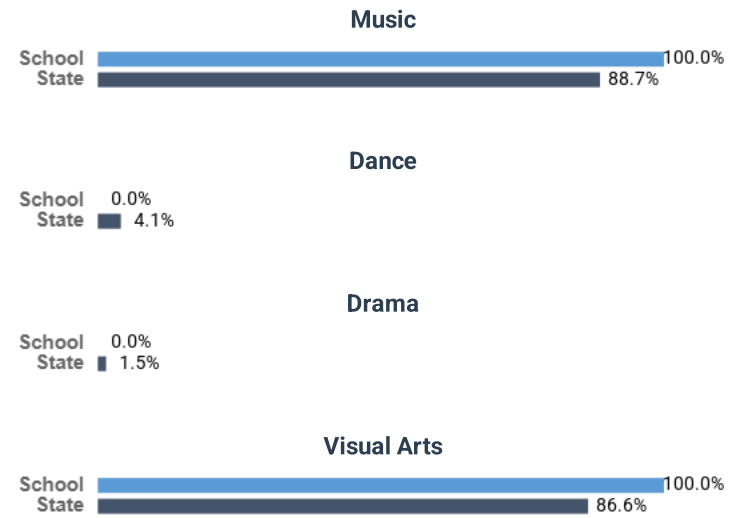

Students enrolled in one or more classes by discipline:



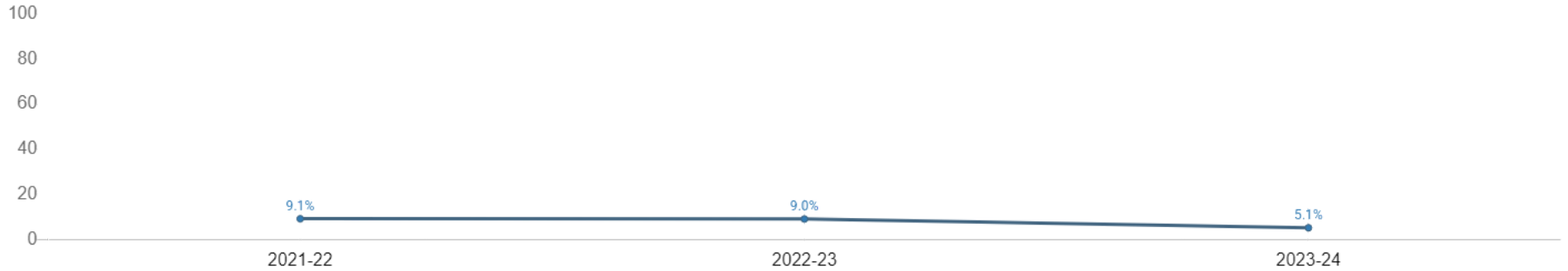

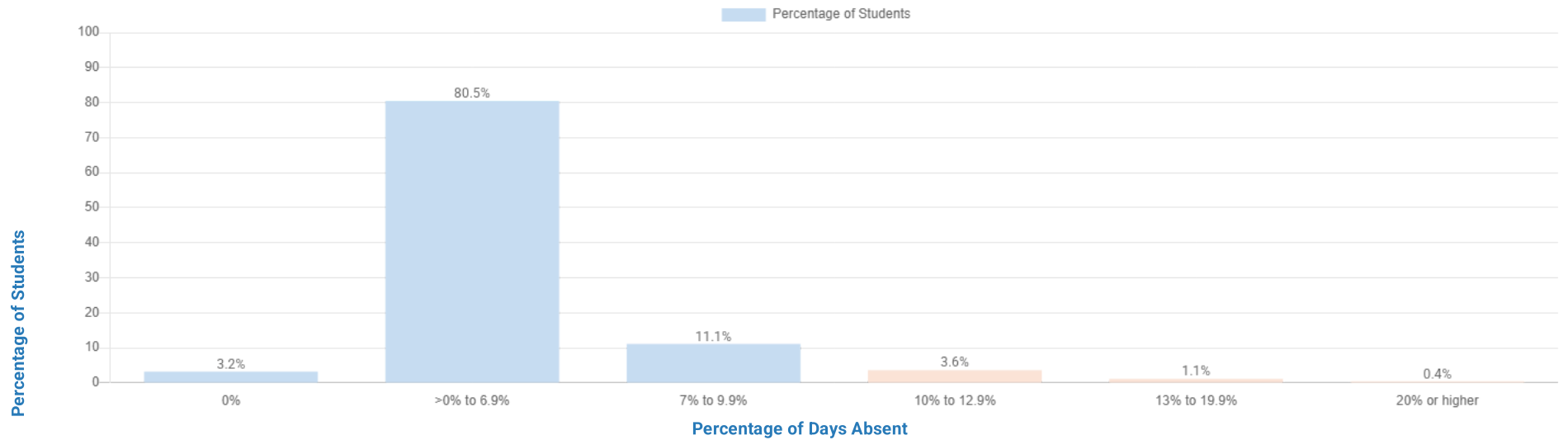

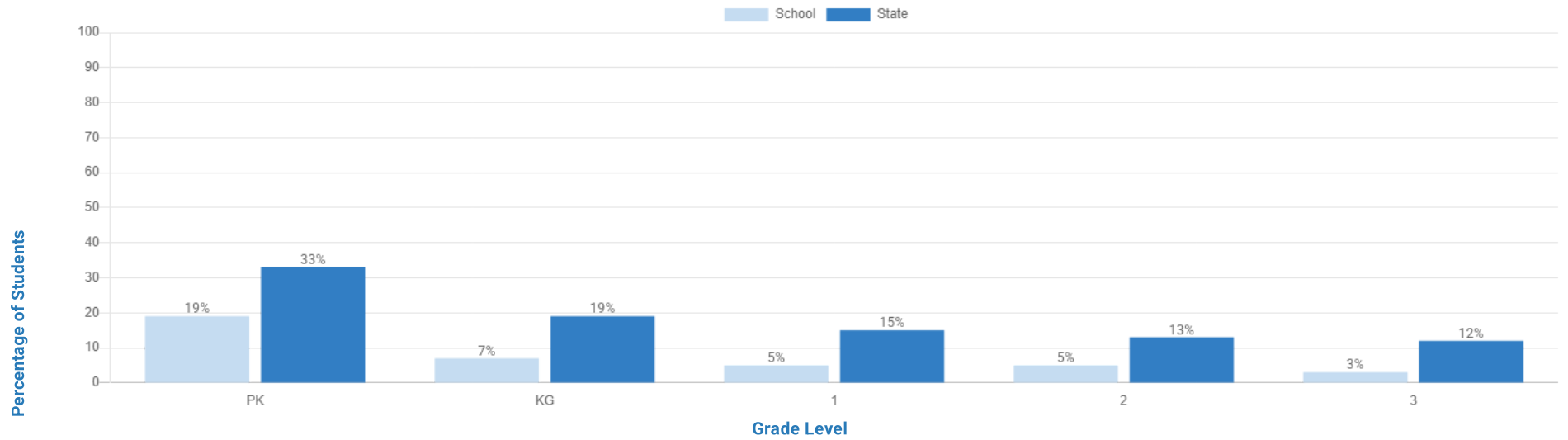

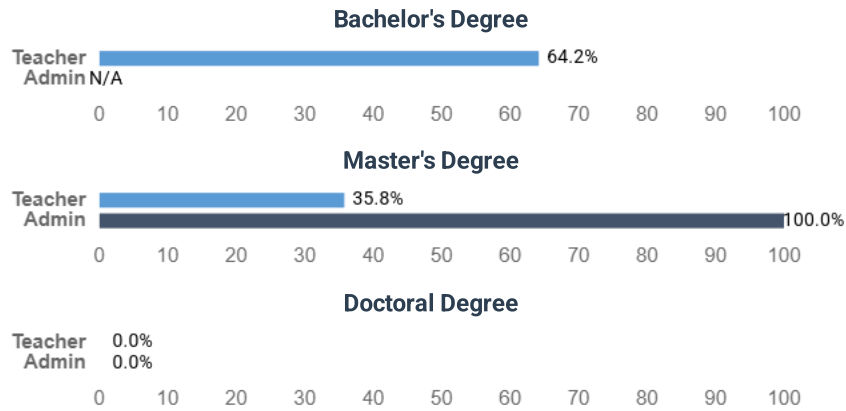

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

Our school utilizes a combination of Readers and Writers Workshop and Wit & Wisdom as primary resources in Kindergarten through Third Grade. Foundational Literacy skills are developed through engagement in the Foundations program. Students take classes in Art, Music, World Languages, Health and Physical Education. The curriculum committee has created units of study that infuse all subject areas into reading and writing. The co-teaching model allows for added teacher support with more opportunities for intense, small-group instruction. Co-teaching allows for a deeper focus on differentiating instruction in a more individualized manner for students with specific needs. Teachers work in PLCs to discuss curriculum, data, teaching, and their team goals. Interventionists collaborate with teachers to create targeted growth plans, provide 1-1 and small-group instruction, and offer valuable feedback during PLCs to support student learning outcomes.

Facilities:

Our school was built in 1971. The one-floor structure houses 31 classrooms plus a music room, art room, offices, rooms for small group instruction, a cafeteria, and gymnasium. Many upgrades have occurred in the past few years including new flooring, electrical upgrades, HVAC replacement, new doors, new furniture, and more. Two playgrounds welcome students. All classrooms are air-conditioned. In grades Preschool-2, each classroom has a private bathroom.



School Safety:

All doors are locked throughout the entire day. All staff wear picture ID badges which allow them special access to various entrances. Visitors are buzzed in via the main office and must indicate their reason for visiting school grounds. All visitors and guest teachers are identifiable via special lanyards and name tags. Staff and students practice various types of safety drills each month. Students assist on a daily basis by participating in our special Safety Patrol program. A School Resource Officer has been assigned to the Primary School and serves as an additional security measure to ensure that all areas are secure. Hallways and various exterior areas have video surveillance cameras.



Technology and STEM:

The Red Bank Primary School provides students in Grades Preschool-Grade 3 a technology-rich environment. All Kindergarten students have access to iPads and the District Chromebook 1:1 initiative begins in First Grade. All classrooms have an interactive whiteboard with a pendant microphone system and a teacher laptop. Every classroom has a document camera. STEM is embedded through our curriculum and before and after school activities. The Primary School also brings in special assemblies that relate to STEM and the science curriculum as extra opportunities to motivate students in these areas.

Attendance:

The Primary School continually emphasizes how the importance of regular attendance is essential for a child's academic and social growth. Parents are encouraged to send children to school daily if they are healthy since consistent attendance builds routine and supports learning. Parents are reminded to send a doctor's note to school after their child is absent from school. If absences become a concern, reminder letters are sent home to parents, and meetings with the Principal or Vice Principal may be scheduled. In rare cases, a court referral may be considered or recommended. The Main Office makes phone calls home daily if absences aren't reported, and unverified absences may lead to a wellness check by the Red Bank Police Department. We pride ourselves on prioritizing attendance and on working collaboratively with the parents to ensure our student's success and well-being.
