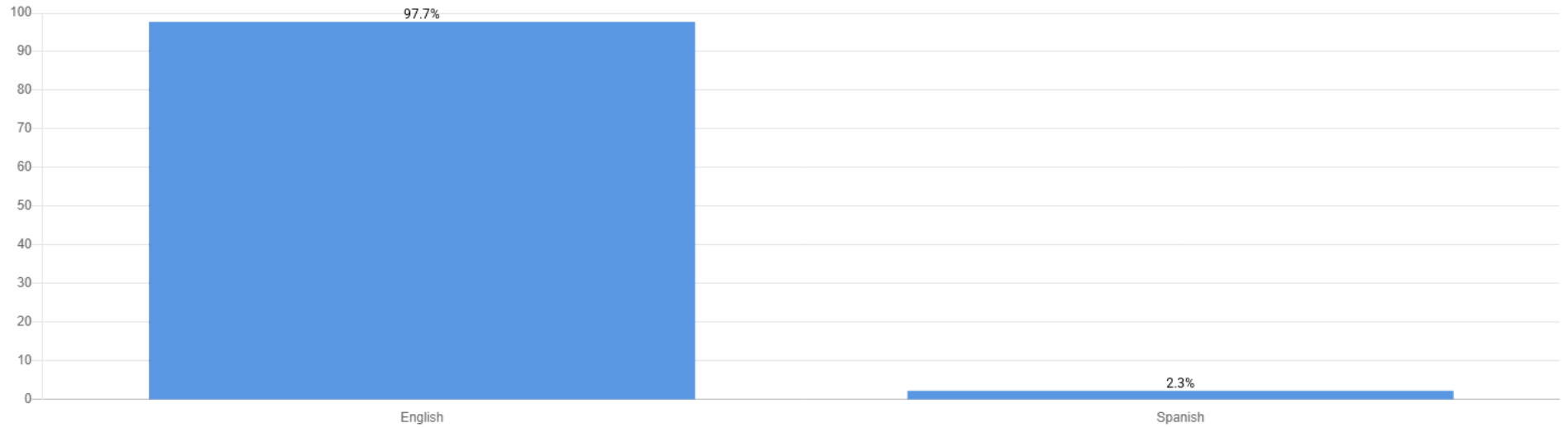

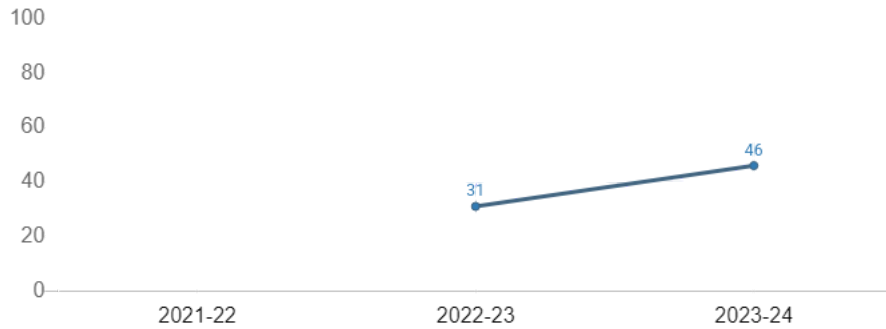

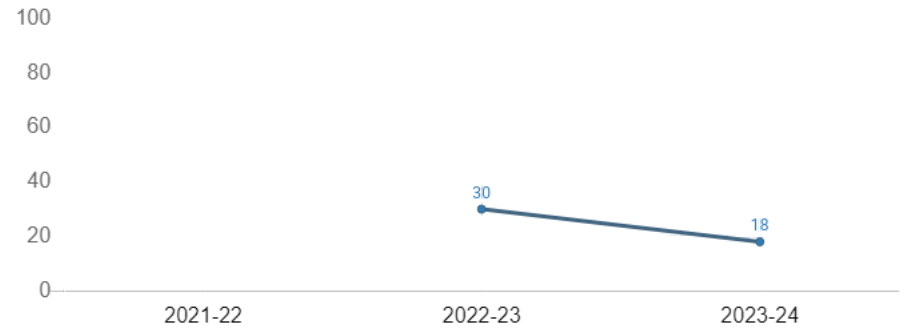

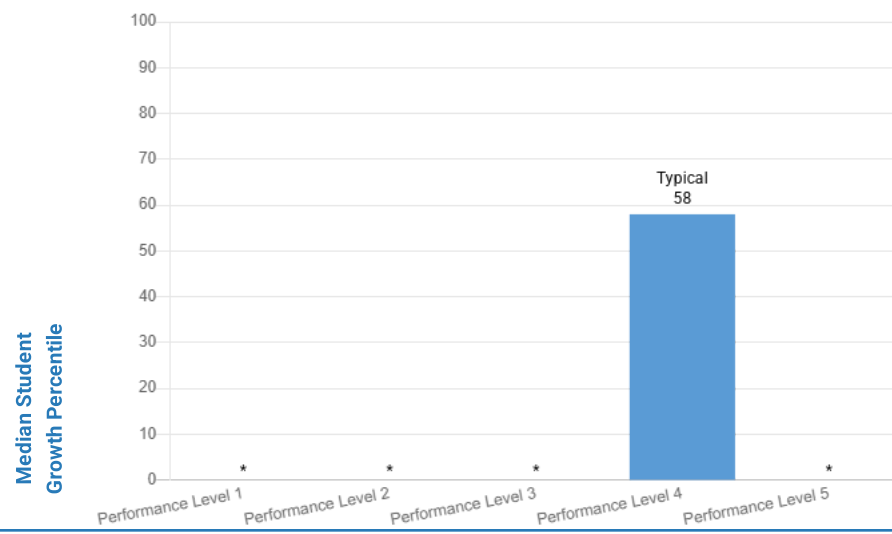

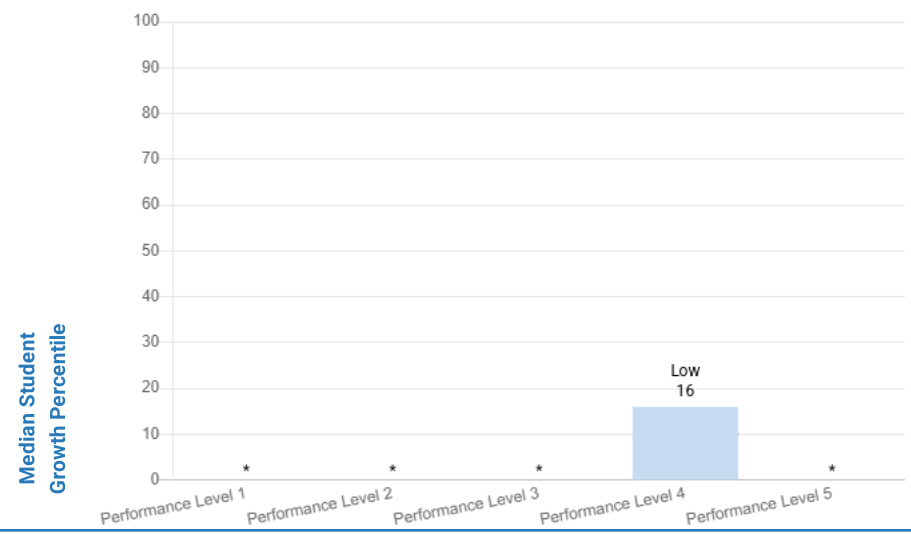

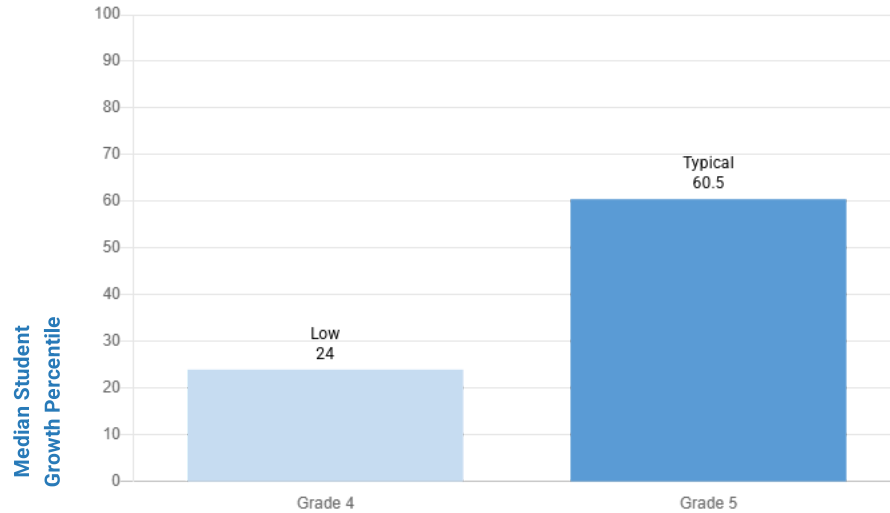

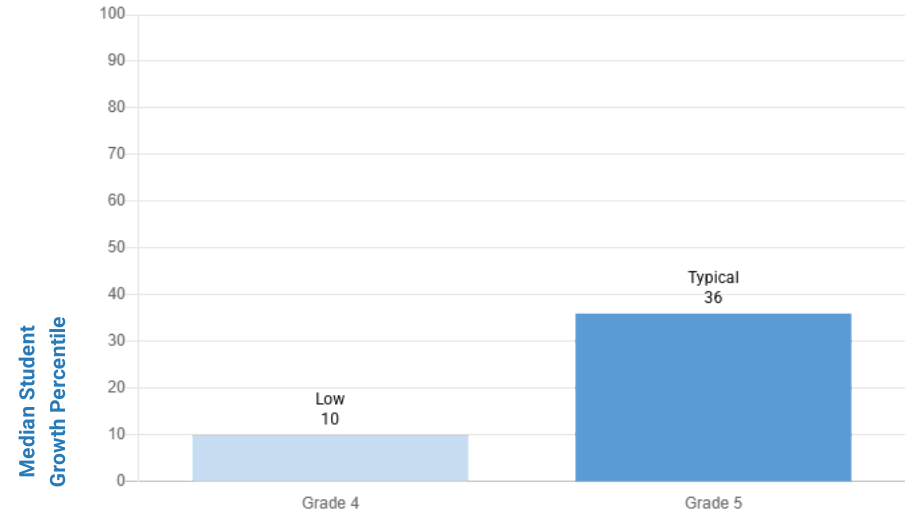

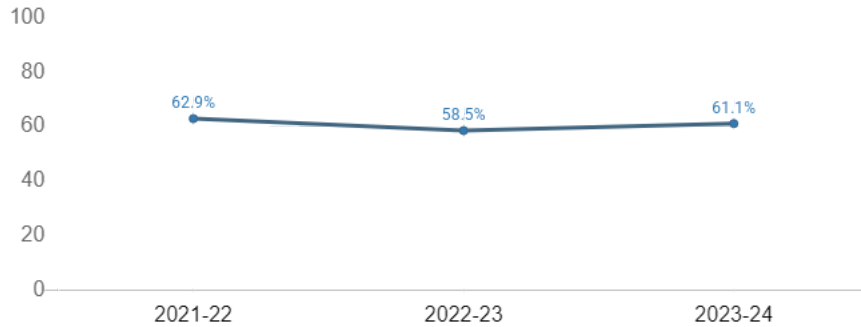

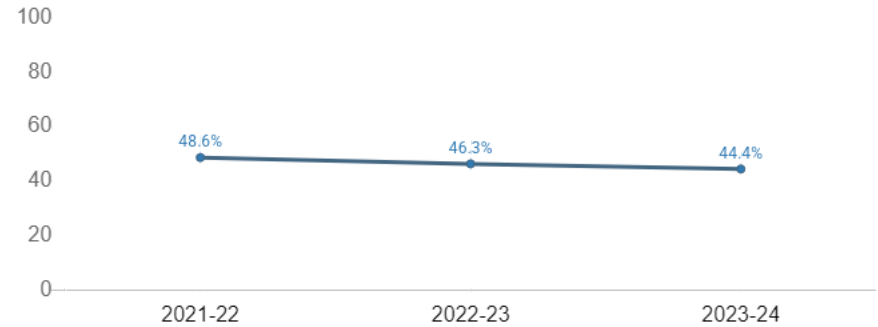
English Language Arts and Mathematics Performance Trends

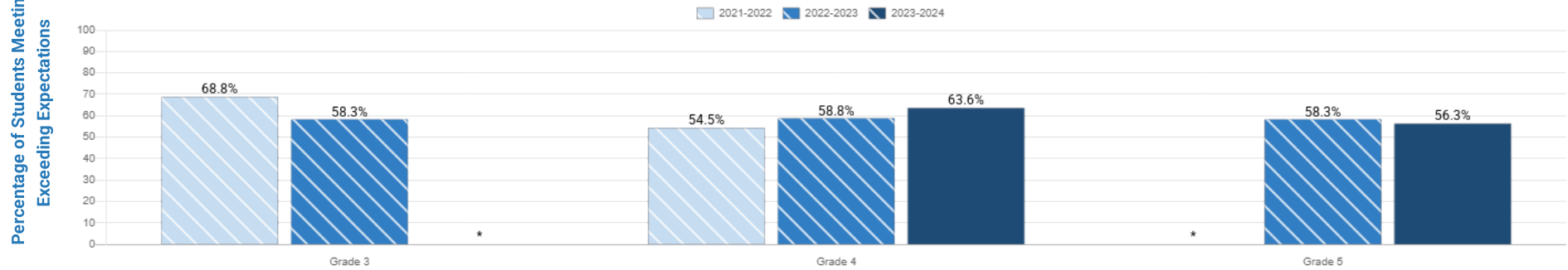

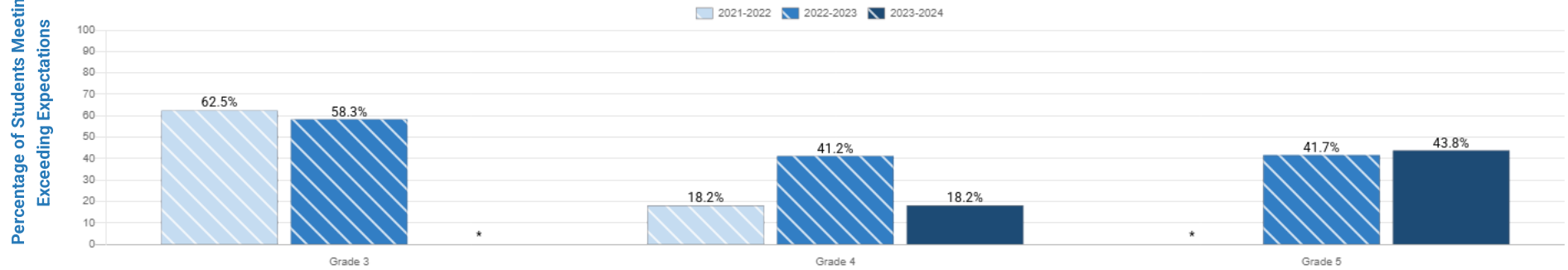

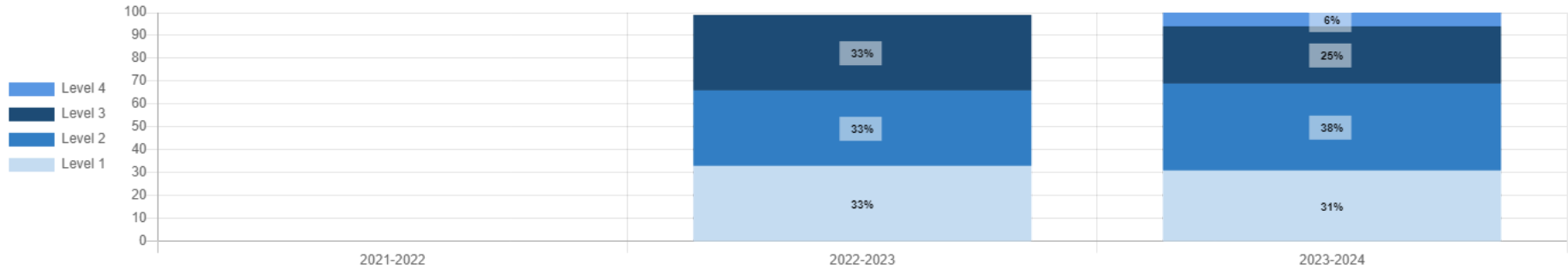

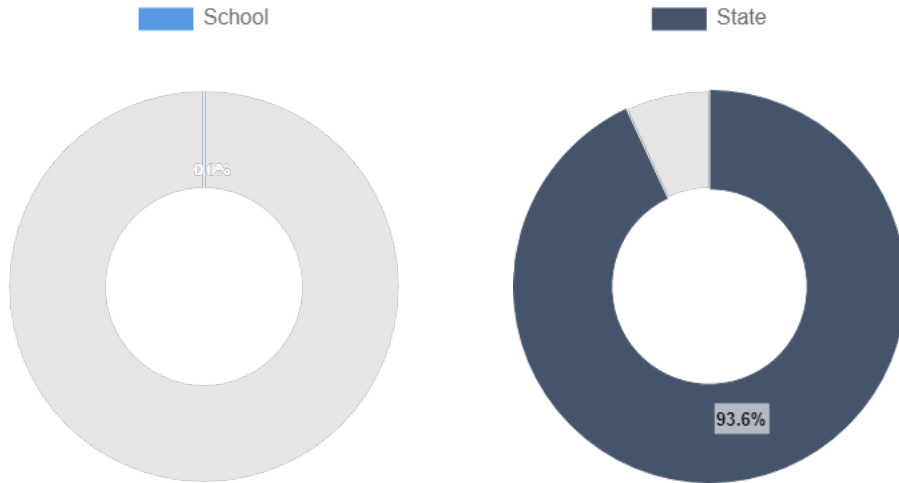

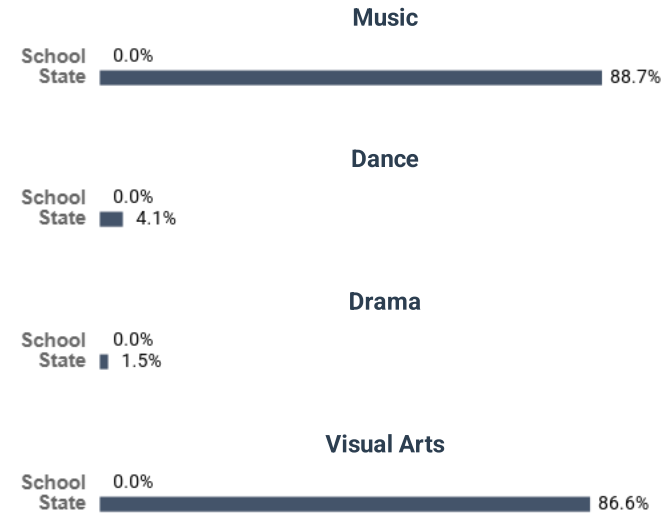

Students enrolled in one or more classes by discipline:



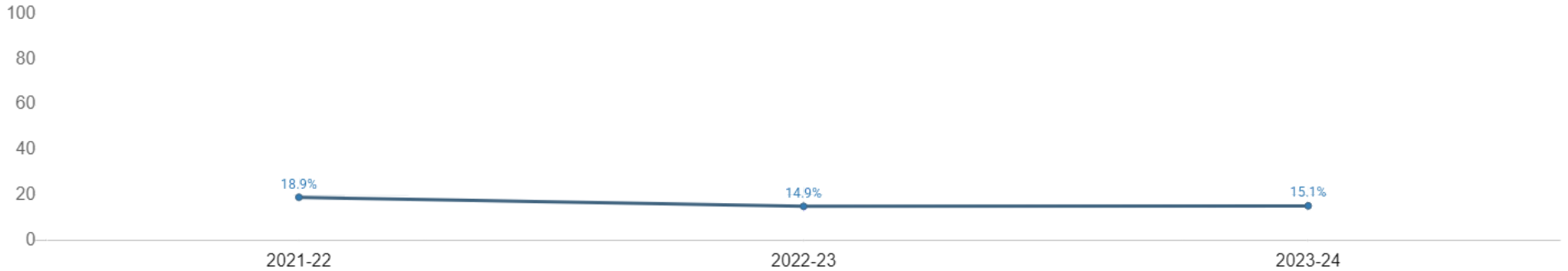

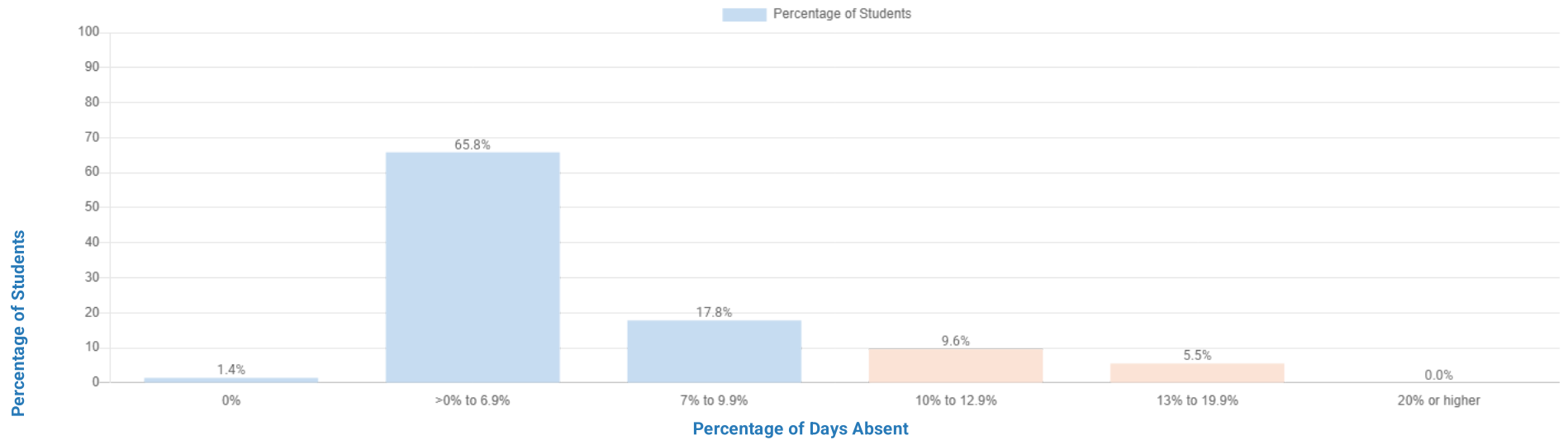

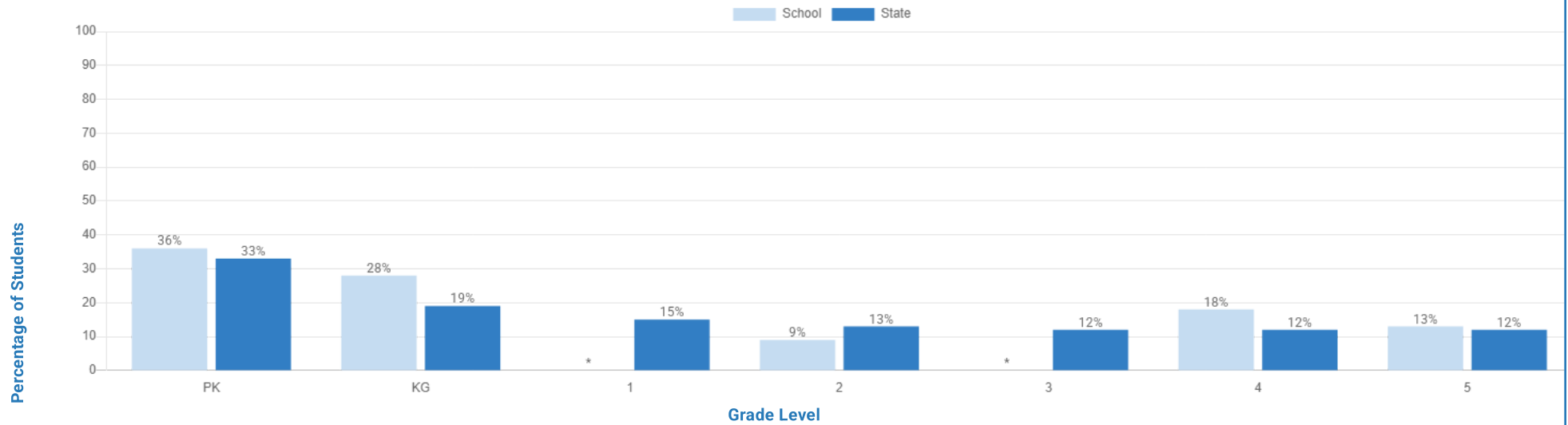

Staff

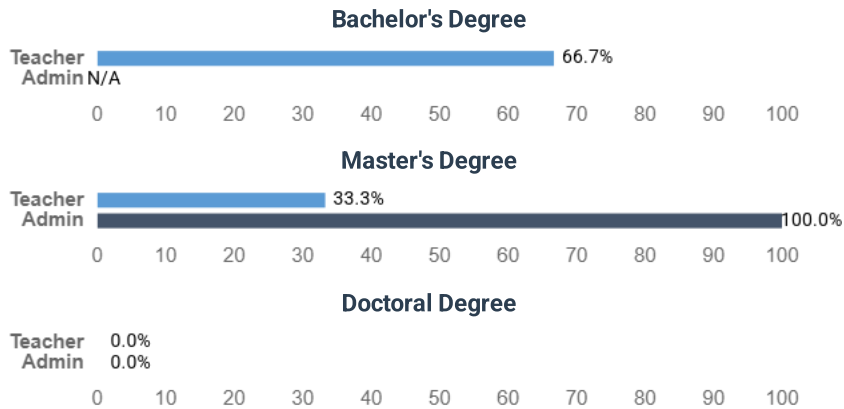

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. In addition, character education is integrated into all classrooms by the social workers or building principal on a monthly basis.

Roosevelt Borough Public School consists of one building that serves PreK through Grade 5. We maximize our space by offering preschool and full day kindergarten.

Our elementary school continues to work on chronic absenteeism and will utilize a corrective action plan for the 2024-2025 school year to improve attendance. The building principal and nurse will work collaboratively to monitor student attendance by sending tiered intervention letters to parents on a monthly basis. These letters, will highlight absences and tardies and will be sent home once a student has five absences and/or tardies. Each update will include the current count of absences and/or tardies, along with a clearly outlined intervention strategy.
