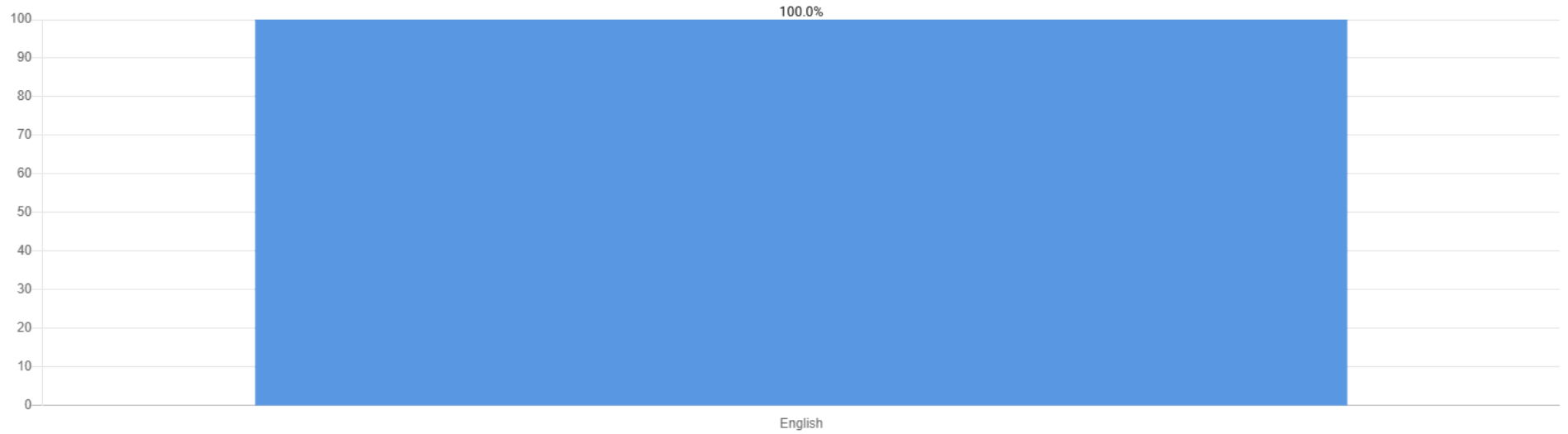

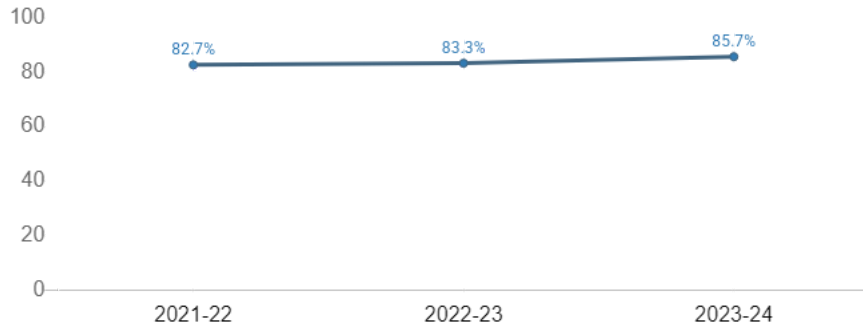

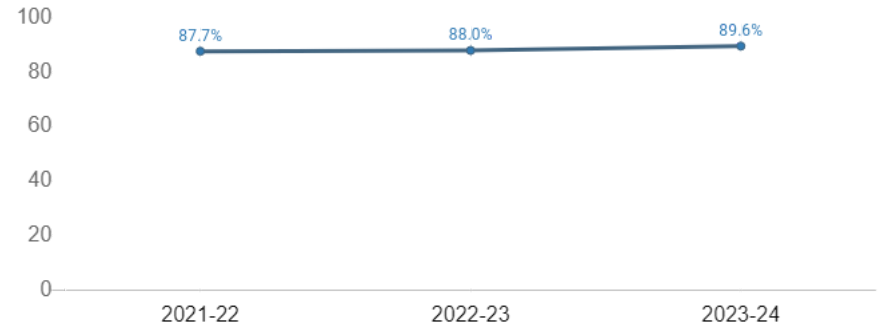
English Language Arts and Mathematics Performance Trends

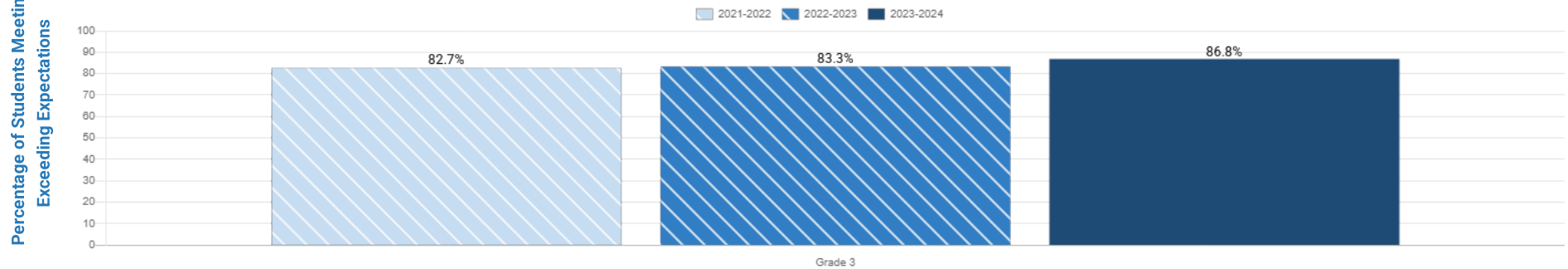

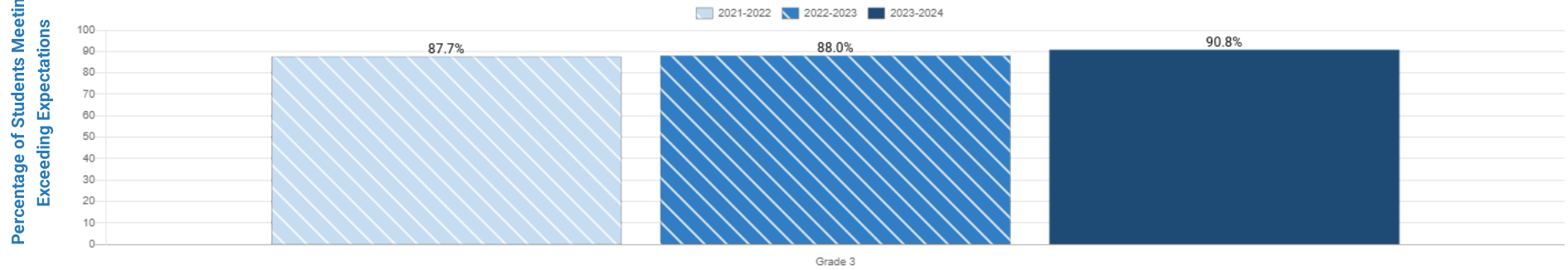

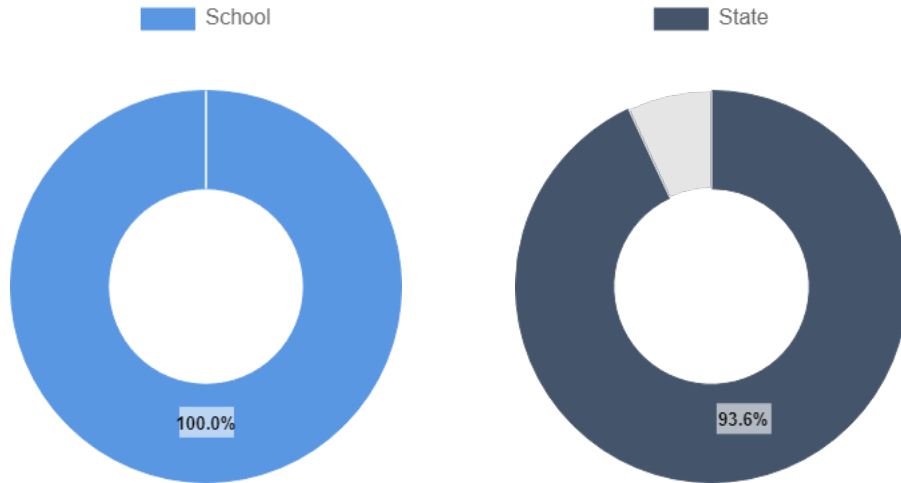

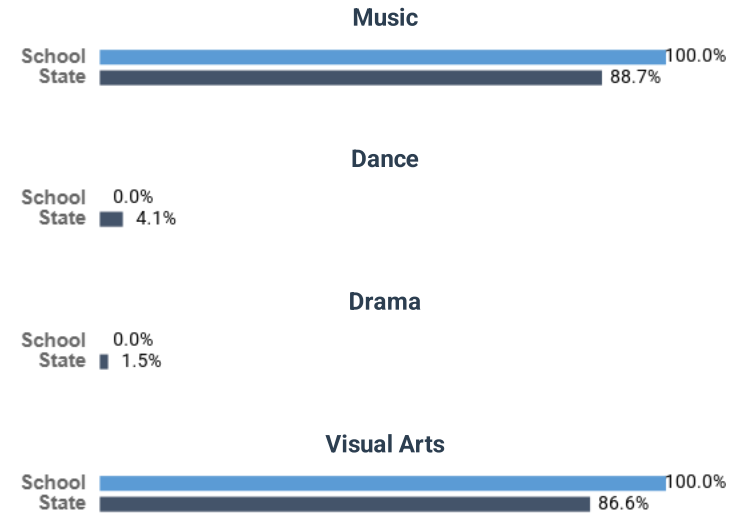

Students enrolled in one or more classes by discipline:



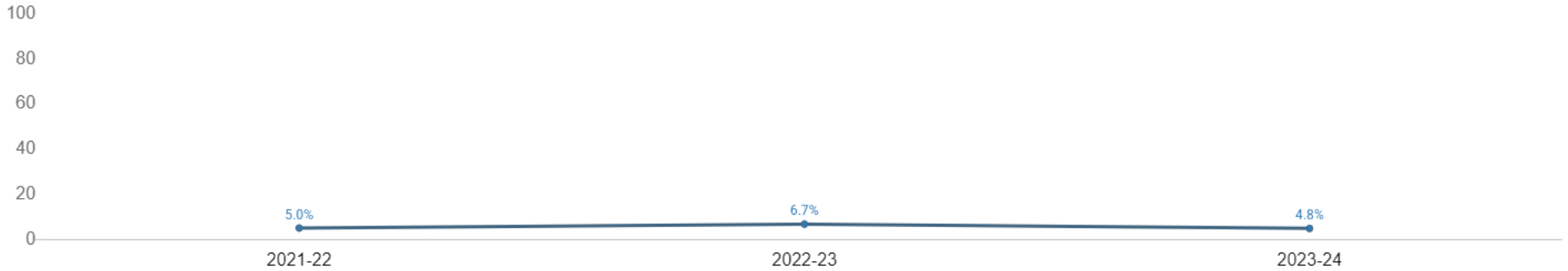
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

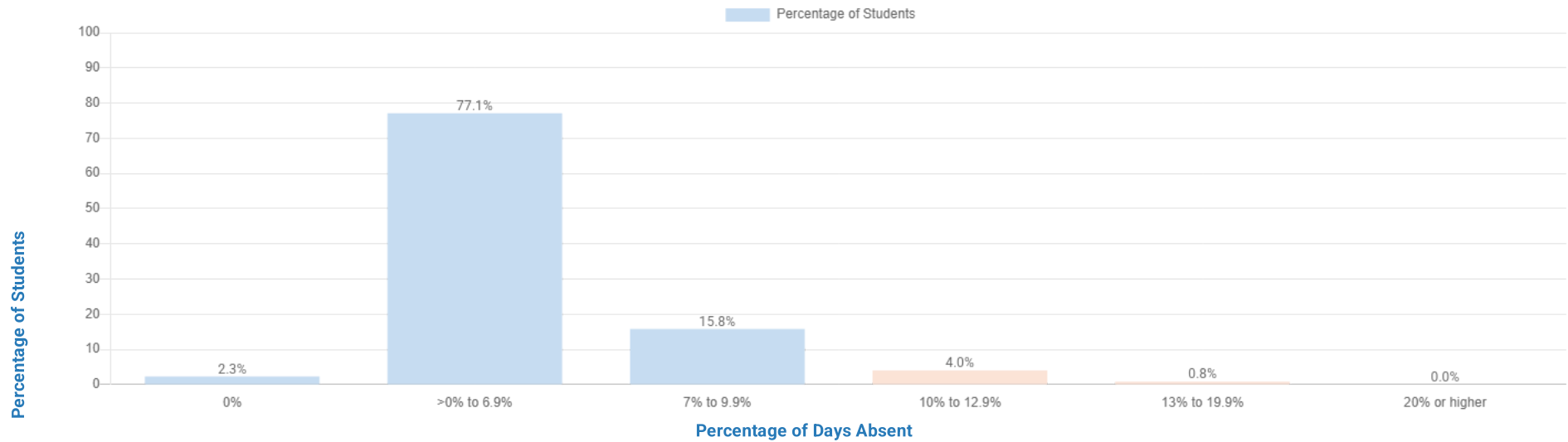

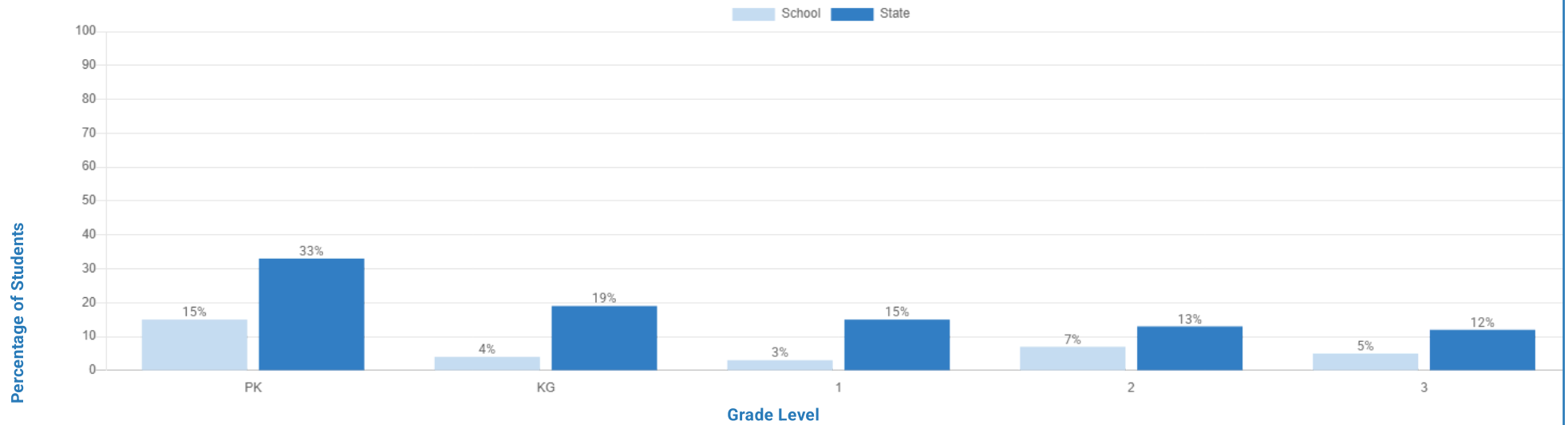

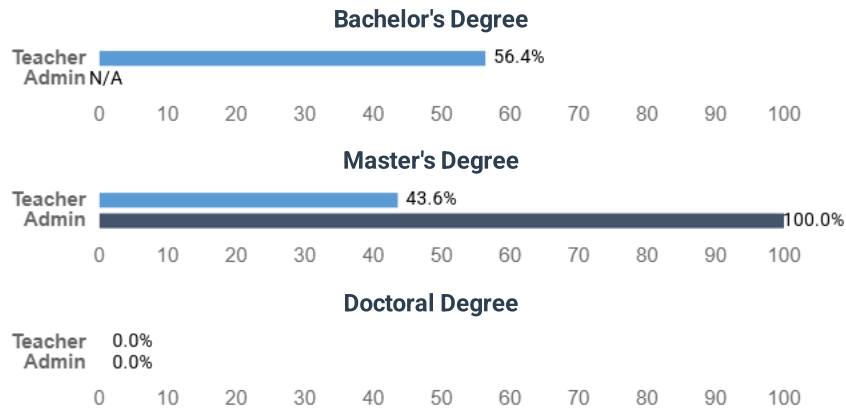

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. We are proud of our integrated language arts curricula which incorporates phonemic awareness(Heggerty),phonics(Fundations),decodable texts(Geodes), and high quality literature.EnVision supports our mathematical thinkers as they gain number sense.Zones of Regulation helps all students regulate emotions and choose coping strategies,and metacognition,thinking about thinking is employed across the curriculum.

Deane-Porter grade level and departmental teams meet in Professional Learning Communities to analyze student data and to plan data driven, rigorous, relevant, targeted instruction to engage students. Staff also participates in professional development focused on reading best practices and metacognition. Our professional learning is ongoing, always with the goal of academic excellence.



Student Supports and Services:

Language Arts is an integrated experience for our emerging readers who become literate readers, writers, speakers, and listeners. Students receive 120 minutes of daily ELA instruction with a focus on interdisciplinary connections; the program integrates phonics, reading and writing fluency, vocabulary, grammar, spelling and comprehension. Our reading specialists push into our Kindergarten and Grade 1 classrooms to co-teach phonemic awareness and phonics with the classroom teacher. The Multi-Tiered System of supports invites teachers to use data-based problem solving in order to provide individualized support to students across all levels of the educational system.



Student Health and Wellness:

Our Pups remain healthy and well because they participate in physical education, daily recess, and mindfulness work. Our food service team serves high quality, organic foods in our cafeteria. The Nurse is in frequent contact with families through newsletters and blasts. Every classroom has a sensory corner and Pups can walk sensory pathways all over the property. Pups rely on the Zones of Regulation to identify their emotions and choose coping strategies.
