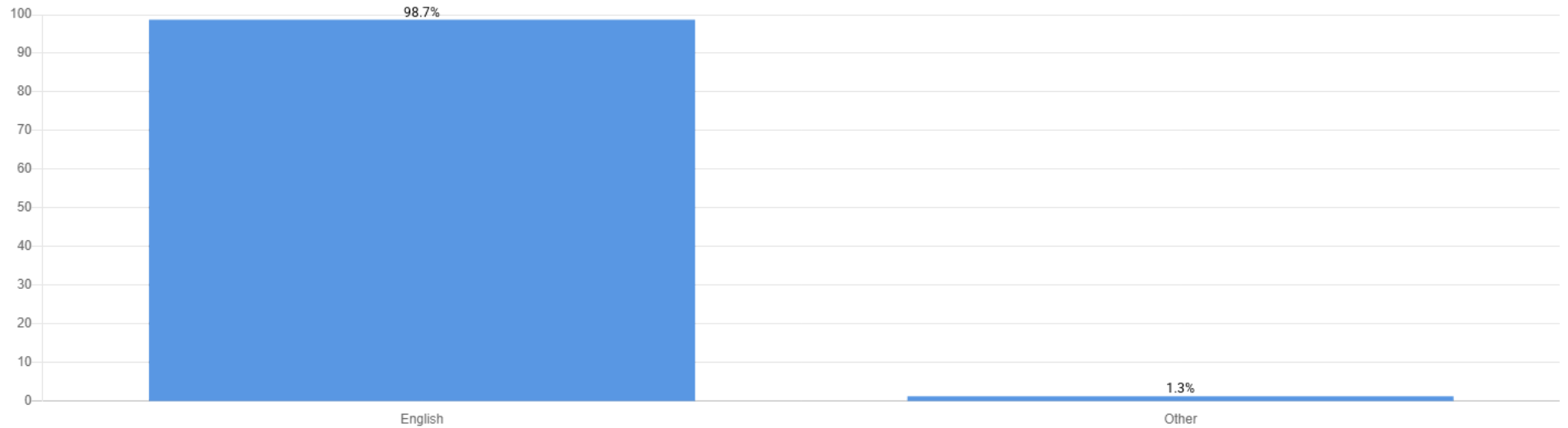

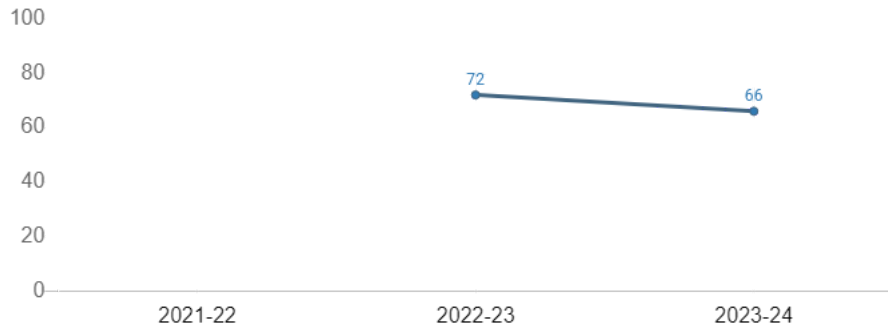

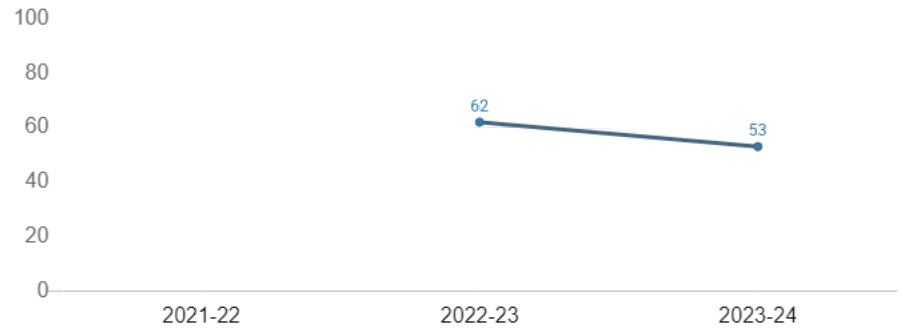

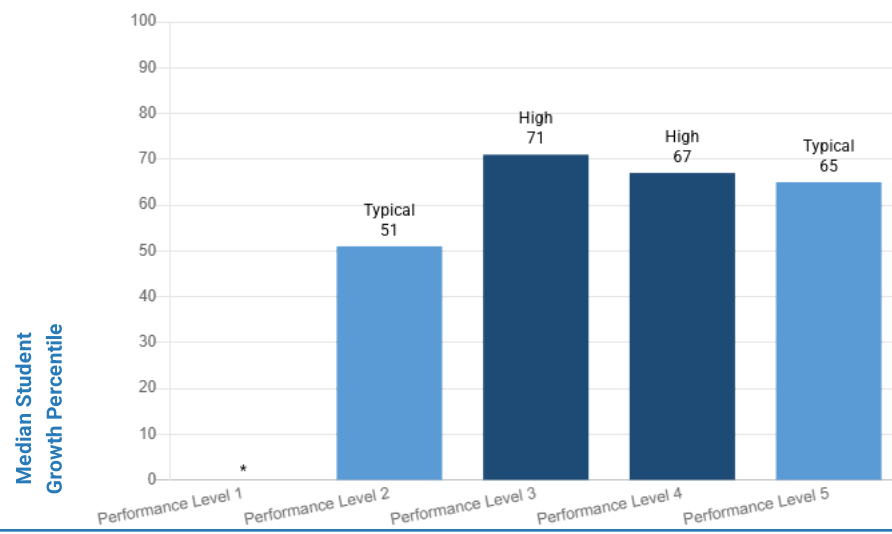

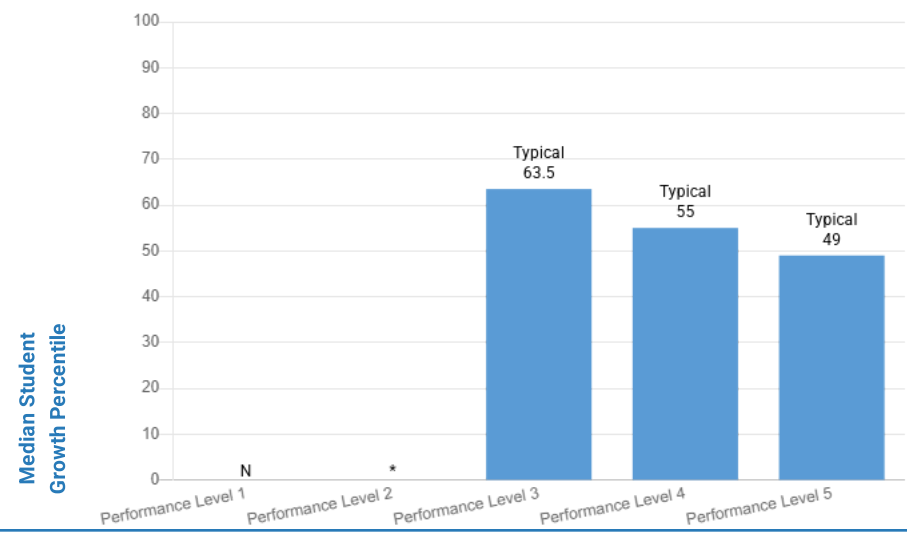

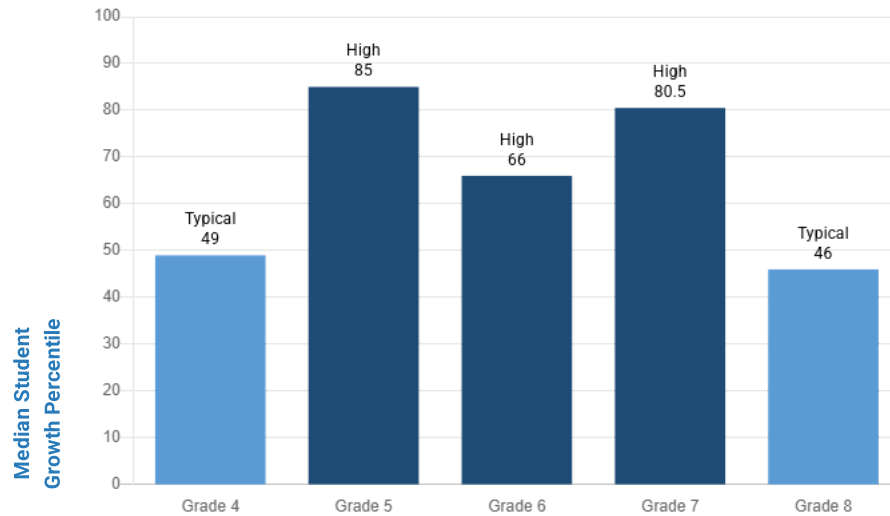

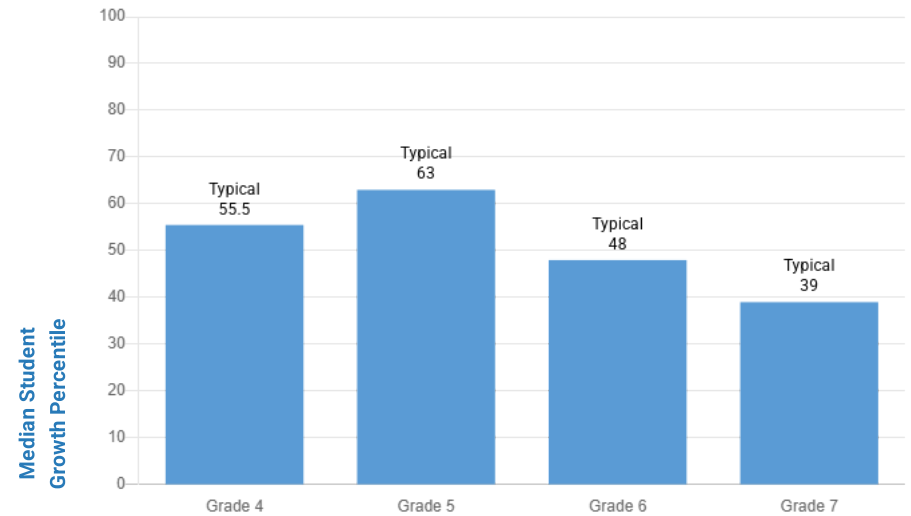

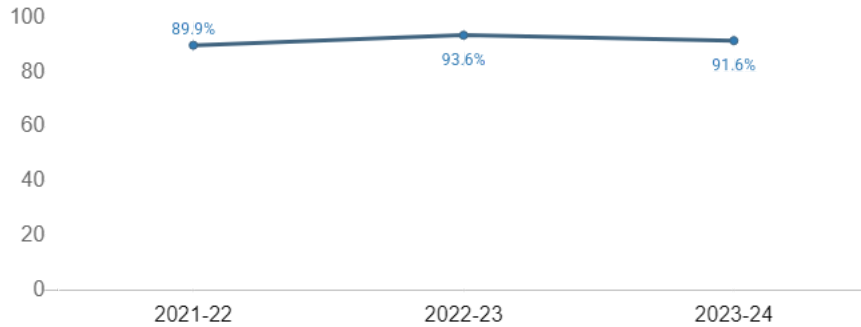

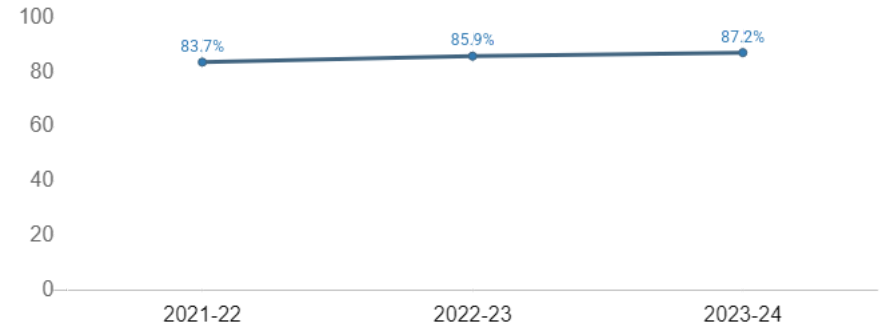
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 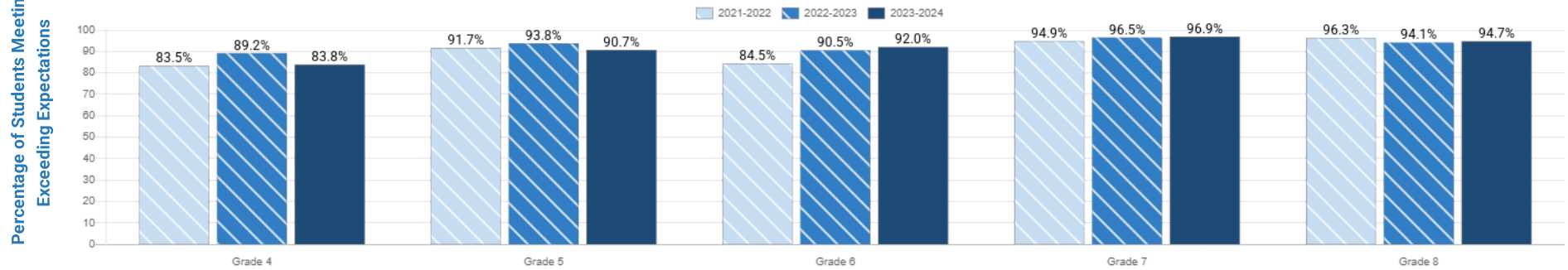

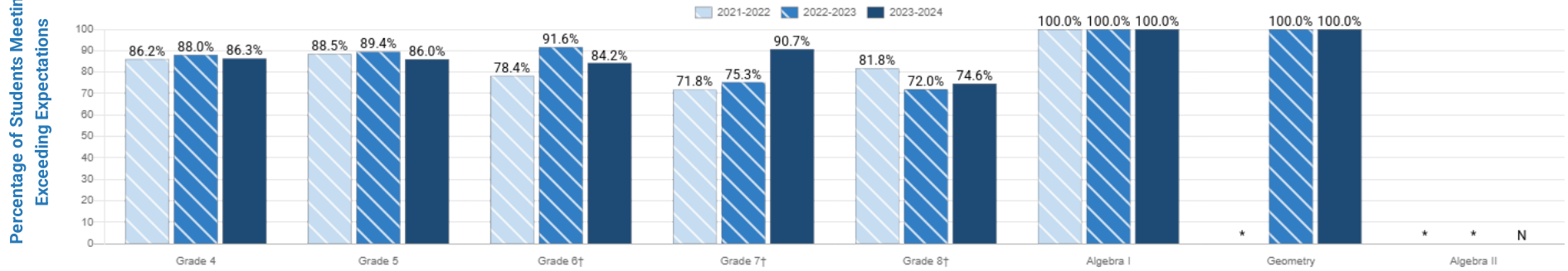

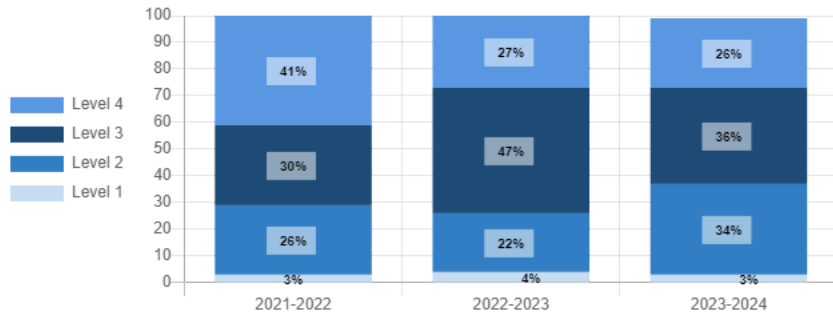

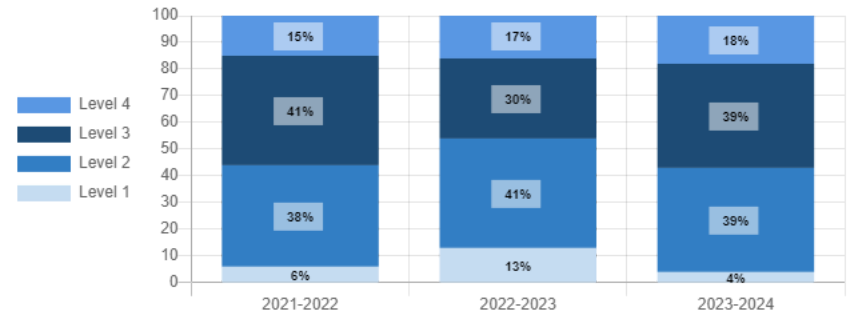

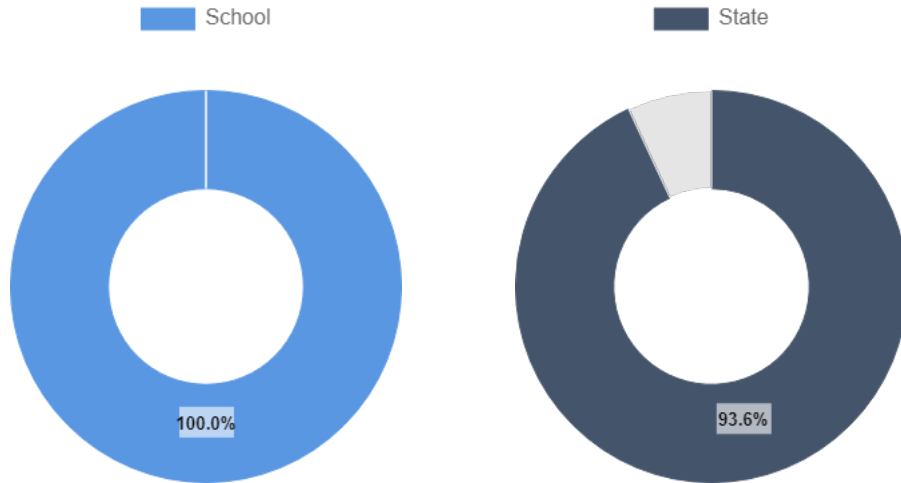

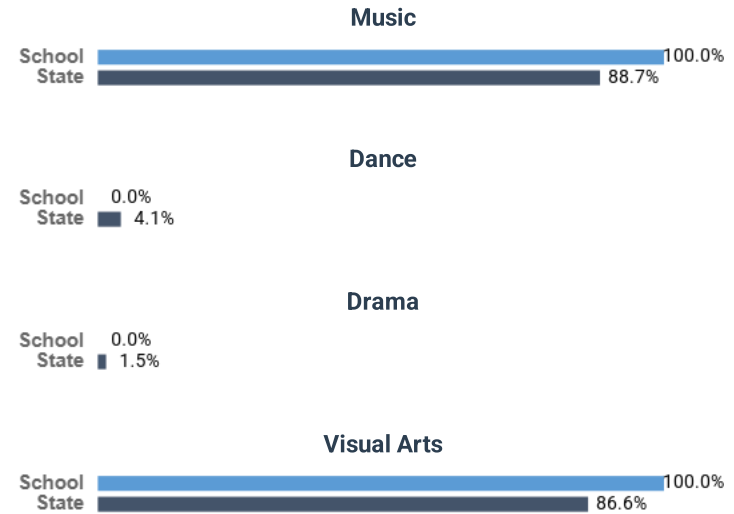

Students enrolled in one or more classes by discipline:



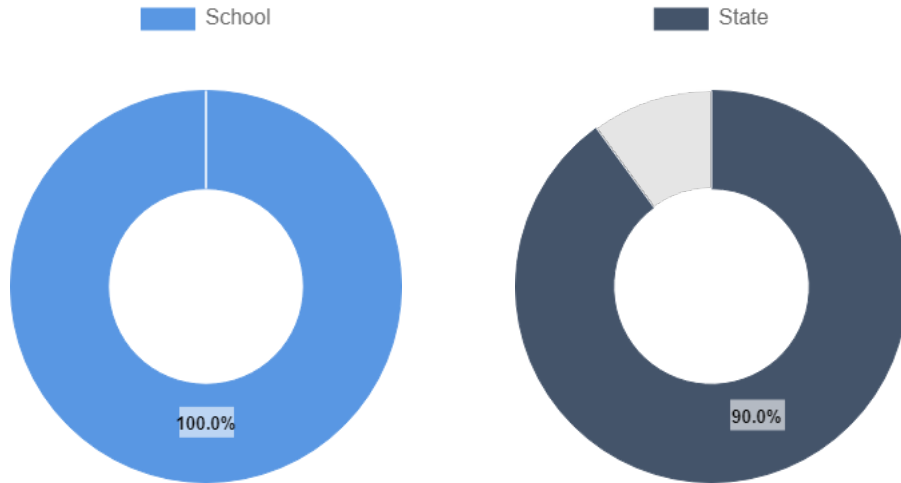

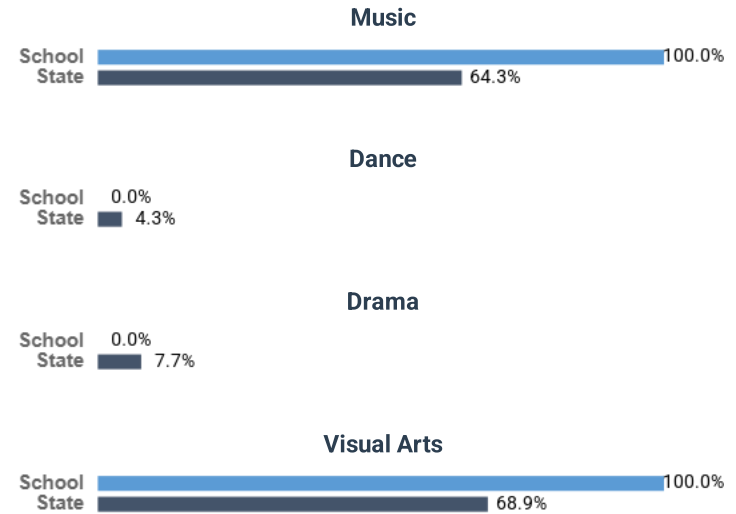

Students enrolled in one or more classes by discipline:



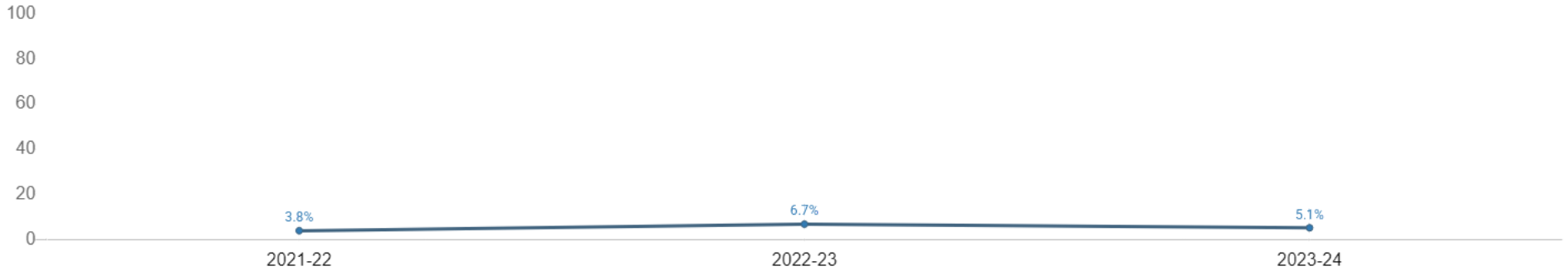

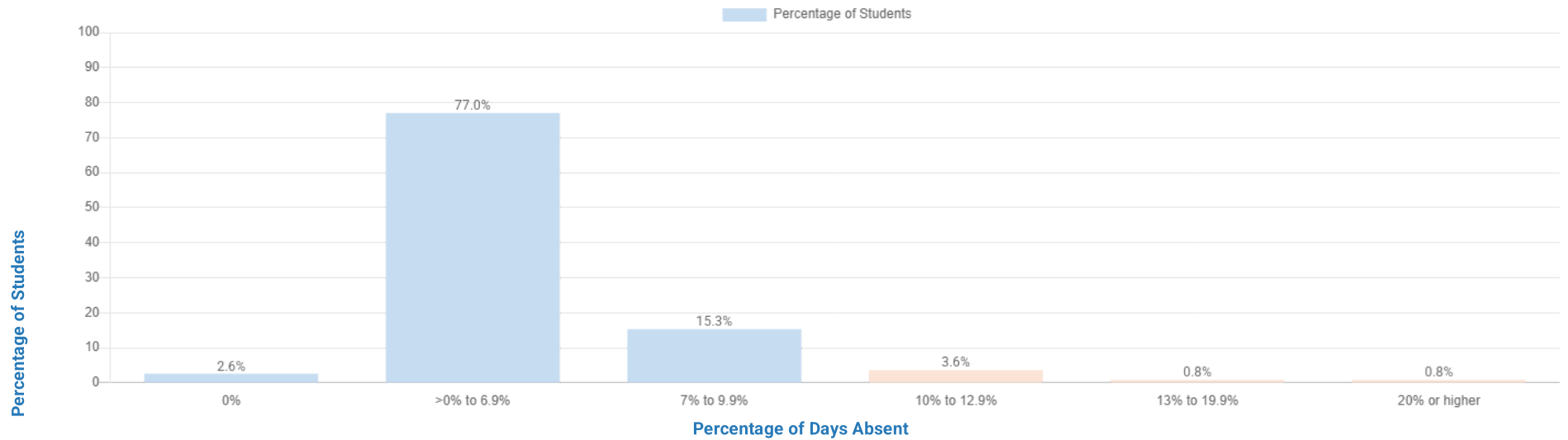

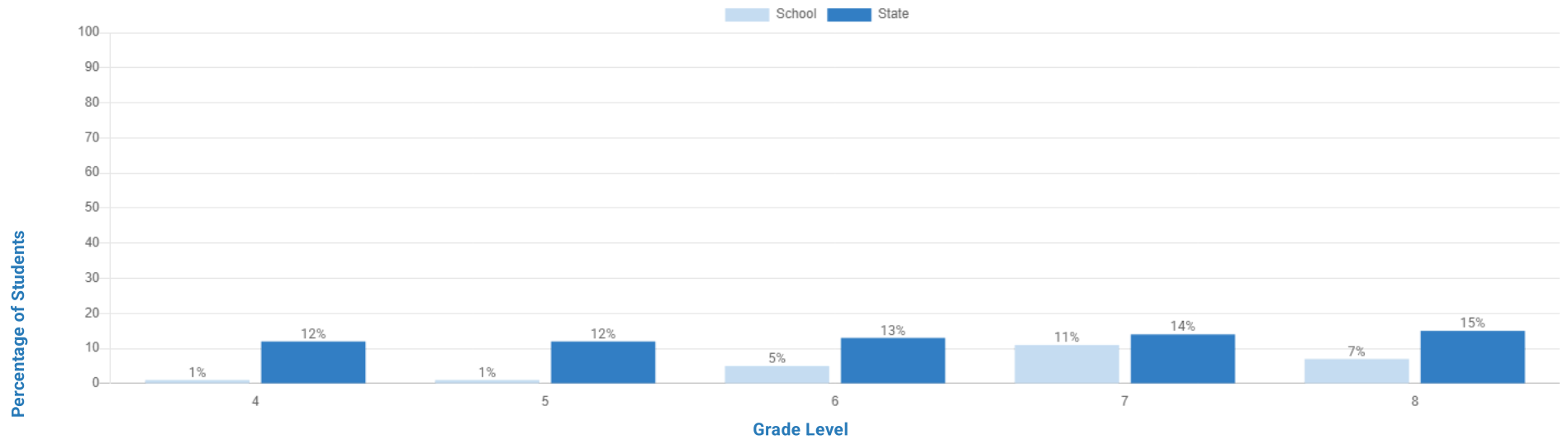

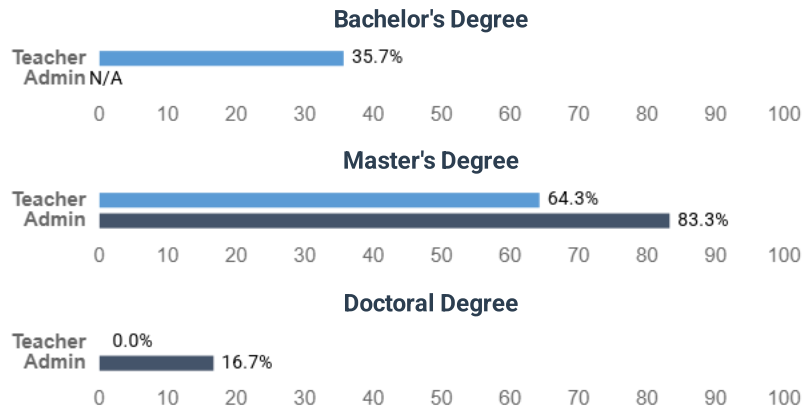

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Awards, Recognition, Accomplishments:

Forrestdale School was recognized as a 2024 national Blue Ribbon School. The staff at Forrestdale was recognized by the NJDOE and Mon County Bd of Chosen Freeholders and received the Axelrod Family Award supporting exemplary work in fields of Holocaust, Genocide Education and Prejudice Reduction. Forrestdale has been recognized with Silver Award for NJ Safe Routes Program sponsored by EZ Ride NJ. Two Gr 8 ELA teachers were selected to present at national teachers of English Annual Conf for their work with Holocaust Studies. 3 staff members awarded the title of Alfred Lerner Scholars. In past 3 years, a group of students from Forrestdale has won in some capacity the Future Cities Competition at Rutgers Univ. The district achieved the Bronze Award for Sustainable Schools Program in NJ. Forrestdale earned a "Spirit of Giving" Award from Monmouth County Food Bank for work with them and service learning projects. Forrestdale named an Honorable Mention for a National School of Character for NJ.

Forrestdale utilizes multiple means of assessment to personalize learning and meet the needs of students at their individual levels. This includes placement of students in the enrichment (JET) program in Grades 4 and 5 and accelerated ELA and Math courses in Grades 6 - 8. Data driven instruction is also utilized for flexible grouping in all classrooms, through iXL, Achieve 3000, ELA & Math Growth Measure, and F & P Reading Levels.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Boys & Girls), Cross Country (Boys & Girls), Field Hockey (Girls), Soccer (Boys & Girls), Softball (Girls), Tennis (Boys & Girls), Track and Field - Spring (Boys & Girls)
Forrestdale's sports teams are offered to students in Grades 6 - 8, with non-cut sports in the Fall (Cross Country) and Spring (Track & Field & Tennis). Our teams play in our conference as well as competitive tournaments, such as the Kettle Cup and the Run for the Roses Tournament.



Clubs and Activities:

Clubs are diverse in nature and offered to students at all grades, including: Gardening, Yoga, STEM, Newspaper, Yearbook, Chess, Debate, Broadcasting, Drama, Instrumental Music, Choir, and Environmental Club. Student Leadership groups have been established including: Peer Leadership, Student Government, and the National Junior Honors Society. Enrichment opportunities are also available with competitions for math and all academic areas.

Before and After School Programs:

Forrestdale offers an after school program for students, "Homework & Study Skills Club" and is facilitated by certified teachers and subject area specialists. This service is offered as a Tier 2/3 intervention for our students.



Staff and Professional Learning:

Our staff participates in ongoing in-district and out of district professional development. They also partake in twice weekly Professional Learning Communities. Focus of these PLCs is directly related to district goals including data driven instruction to promote personalized learning, promoting a positive and culturally diverse and equitable school climate, and student and staff wellness. Professional development more specific focus areas include the zones of regulation and metacognition to promote independent thinkers and learners as well as promote self regulation and executive functioning. The staff also received training in Artificial Intelligence as a means to explore implications on curriculum as an additional resource for students.



Student Supports and Services:

The district has established a comprehensive MTSS process and implementation team. General education students are serviced through varied tiers of support, which may include interventions through the I & RS Team, Title 1 & Basic Skills Instruction and counseling supports. Special Education students participate in programming in the LLD setting, resource rooms, and in-class resource classrooms.

Student Health and Wellness:

Health and wellness is promoted not only through Physical Education classes, daily recess, and health courses at all grade levels, but also through the district's SEL Team. Healthy choices are promoted and offered in the Cafeteria on a daily basis by our food service. The School Nurse sends weekly newsletters to families with health and wellness guidance as well. Student health and wellness is celebrated through a month-long Wellness Month. Students in Gr 4 & 5 participate in a Wellness workshop once in a cycle that promotes character education & mindfulness.



Parent and Community Involvement:

The district is supported through the PTO and the Rumson Education Foundation. Parents access students grades through the parent portal, Genesis. The school has forged a relationship with community organizations such as the American Littoral Society, Monmouth University related to unconscious bias and peer mediation, and the Change center at Brookdale.



Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. As part of the SCTP program, students, staff, parents have participated in a climate survey. Furthermore, students in Gr 3 - 8 participate in the universal SSIS survey based upon the CASEL principles of character education. This data is used to inform programming, as well as individual and small group need-based counseling groups, such as mindful art & executive functioning bootcamp. The district parent survey has resulted in the planning of multiple Parent Academy events on hot topics identified.

Facilities:

The school building includes a state of the art outdoor learning center which features a functioning greenhouse with aquaponics, hydroponics, apple orchard, mushroom farm, and chickens. This is utilized in the STEM Agriculture & Science classes. The renovations of the school Gymnasium and Cafeteria as well as the completed Multipurpose Room allow for student gathering areas, meeting spaces, and areas to highlight extra-curricular activities such as sports and performing arts.



School Safety:

The Rumson School District has collaborated with local law enforcement to add a Class III officer to our campus as a means of added security measures. In concert with state code, the district participates in monthly security drills as well as tabletop drills with local first responders. The drill, time, weather, duration and improvements needed are documented after each drill. This is reviewed and followed up by administration to make the necessary improvements. The district updates the MOA as well as Safety Plan annually, and Administrators attend annual training related to safety and security protocols in order to stay current.



Technology and STEM:

Students in Gr 4 - 8 participate in STEM classes as a part of the specials rotation. These classes include technology enriched project based learning opportunities as well as cross curricular connections to current units of study in Science and Mathematics. Students are exposed to the engineering design process when posed a problem in order to hypothesize, problem solve, design, and building prototypes. Teachers design lessons based upon the 5 E's instructional model, as a means to draw on students' existing knowledge, beliefs, and skills.

Student wellness focus includes character ed, responsive classroom, executive functioning initiatives, while expanding counseling supports on campus. Summer academic programming & SEL programming funded through ESSER grants. Our MTSS process is a means to allow tiered intervention & provide students/staff with intervention opportunities. This begins in general setting of classroom, with Tier 1 supports delivered by classroom teachers during daily schedule WIN period. This expanded to after school & summer programs, small group and 1:1 programming with certified reading specialists & math interventionists. Gr 6-8 has been expanded to push-in basic skills support in ELA & Math daily. The district used SSIS survey for data about students' SEL needs in concert with CASEL competencies. From here counseling supports were designed incl. mindfulness, social skills group, mindful art opport., use of research-based remediation in intervention, 1:1 counsel
