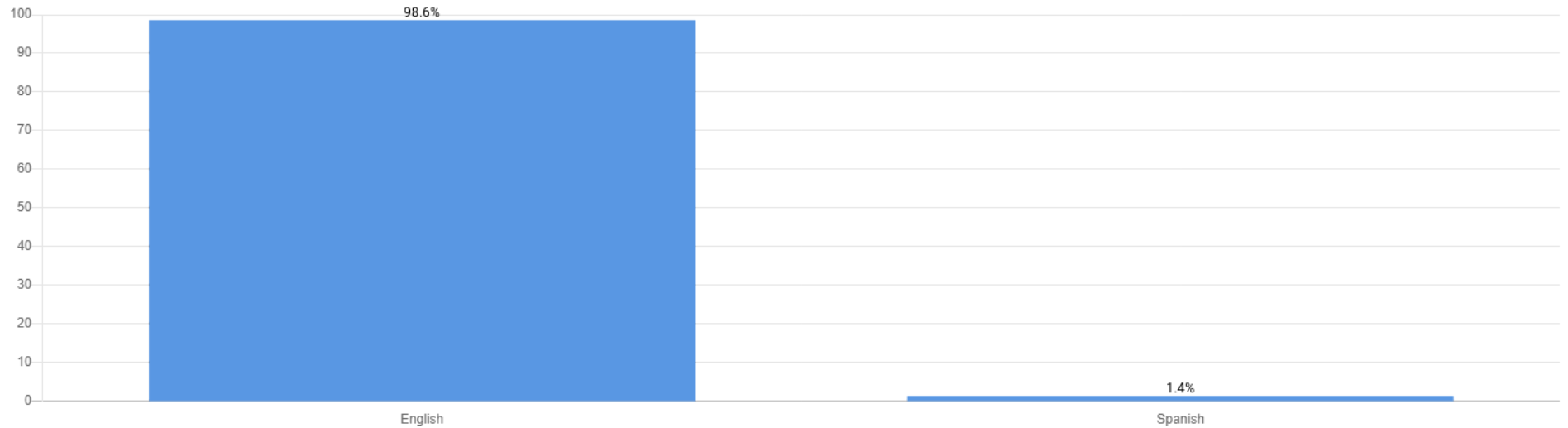

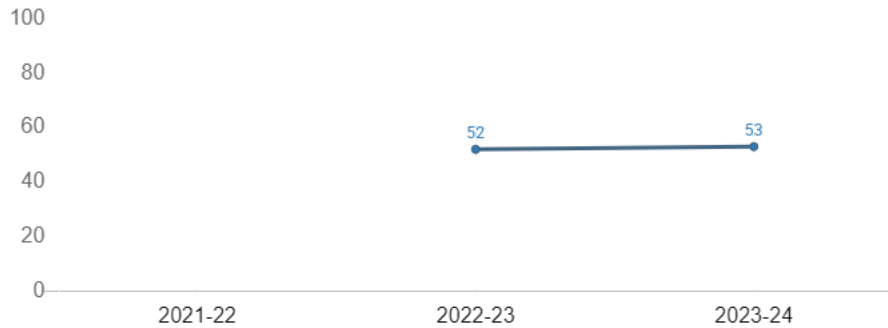

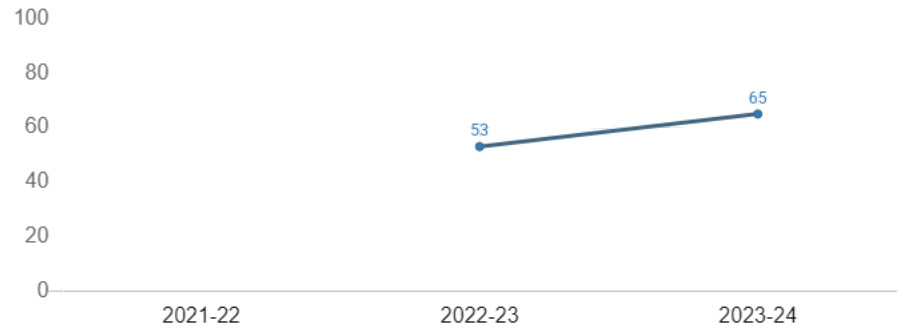

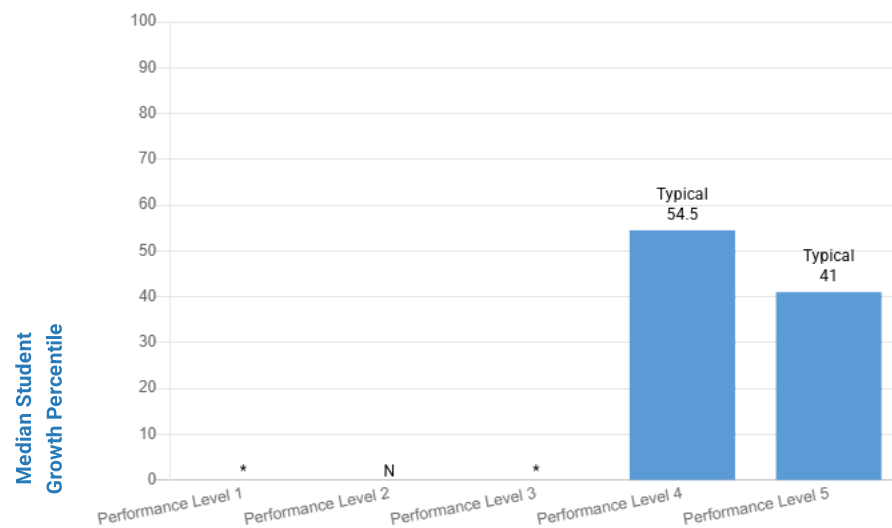

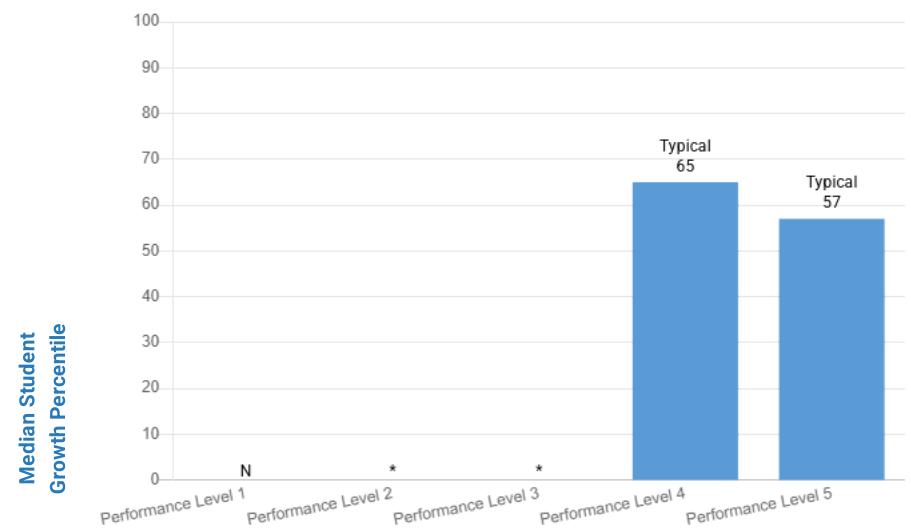

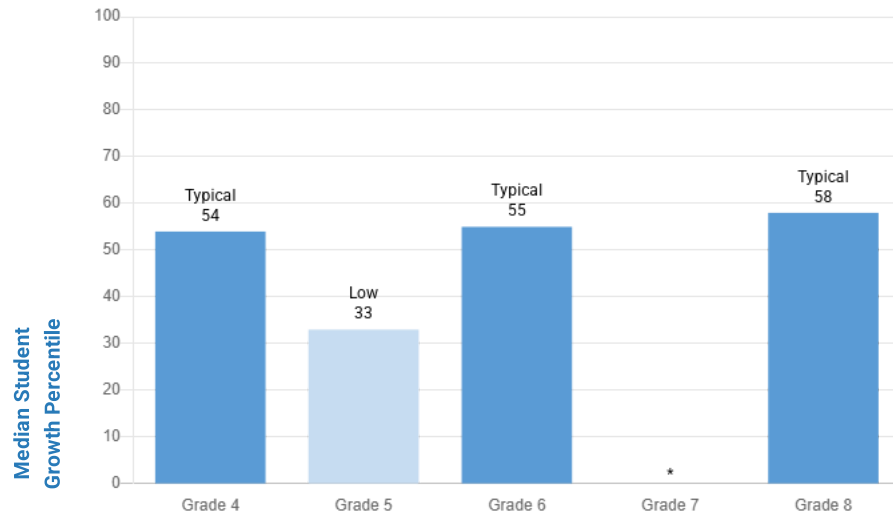

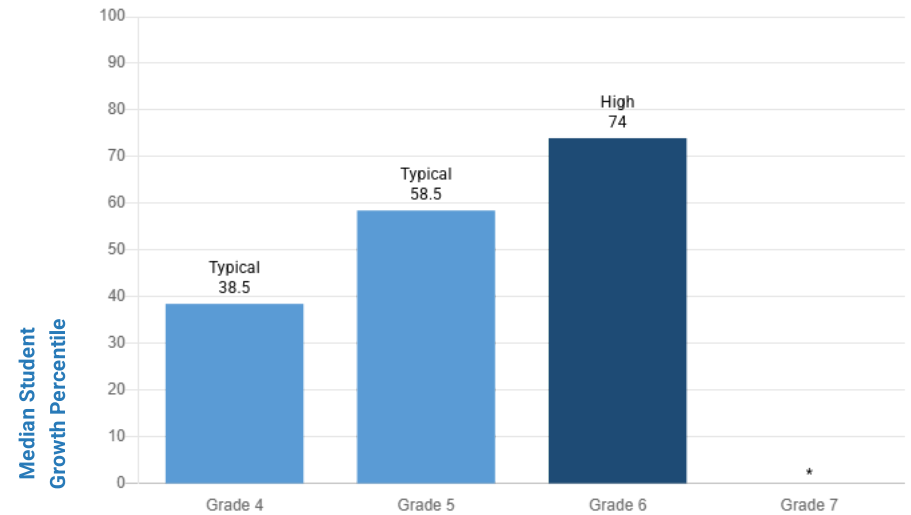

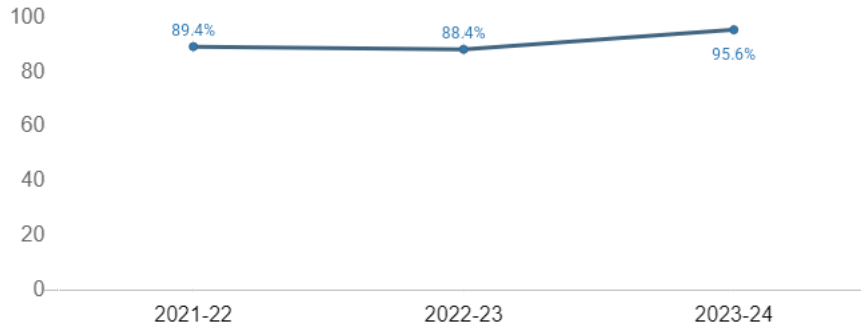

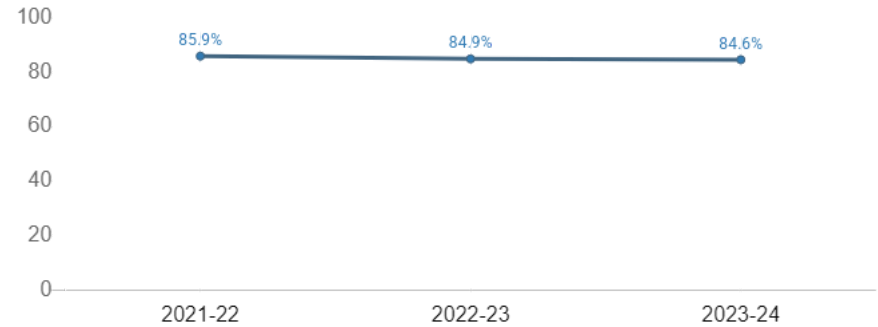
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 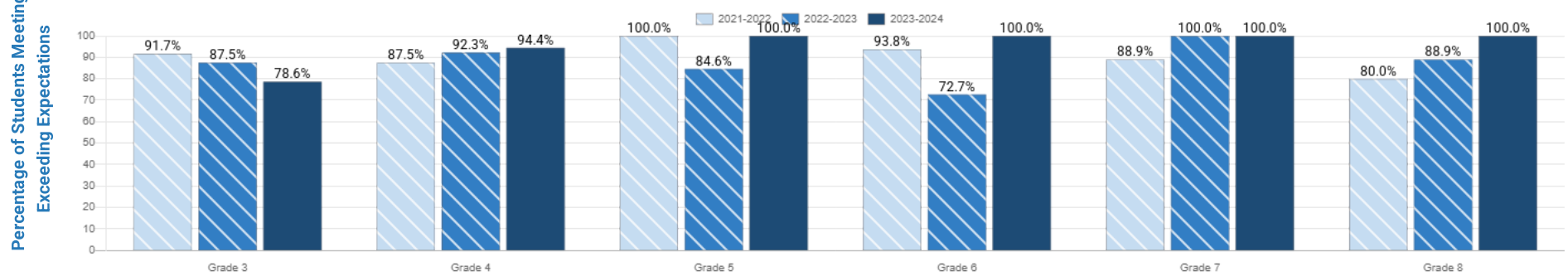

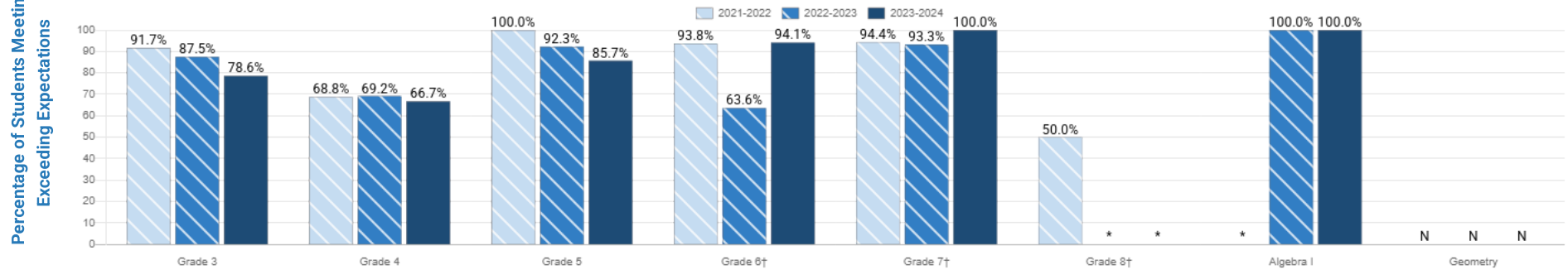

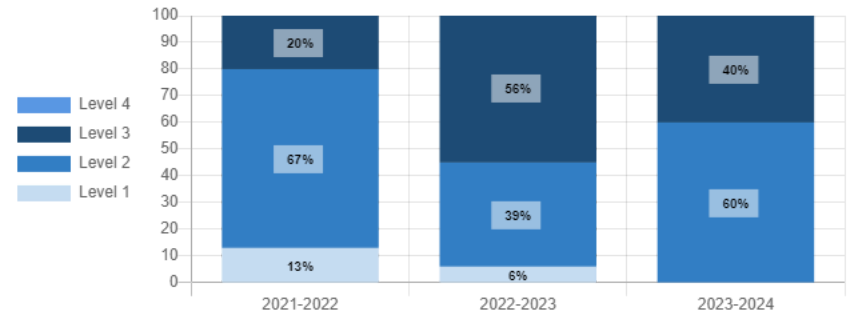

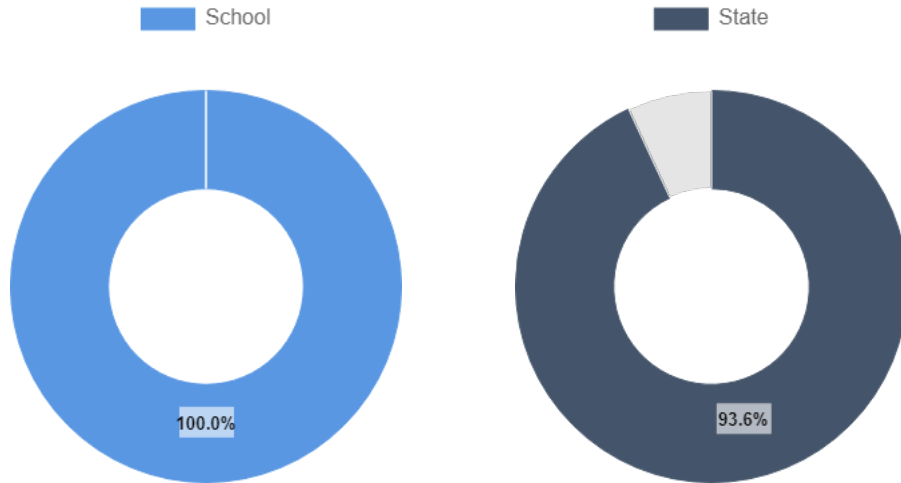

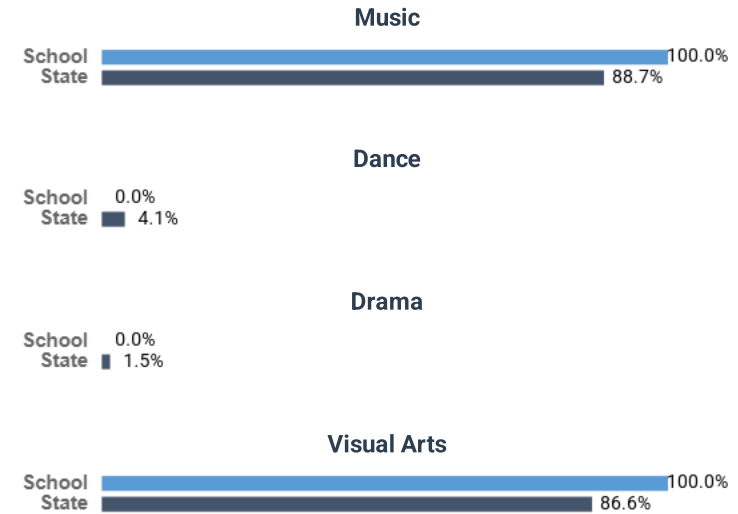

Students enrolled in one or more classes by discipline:



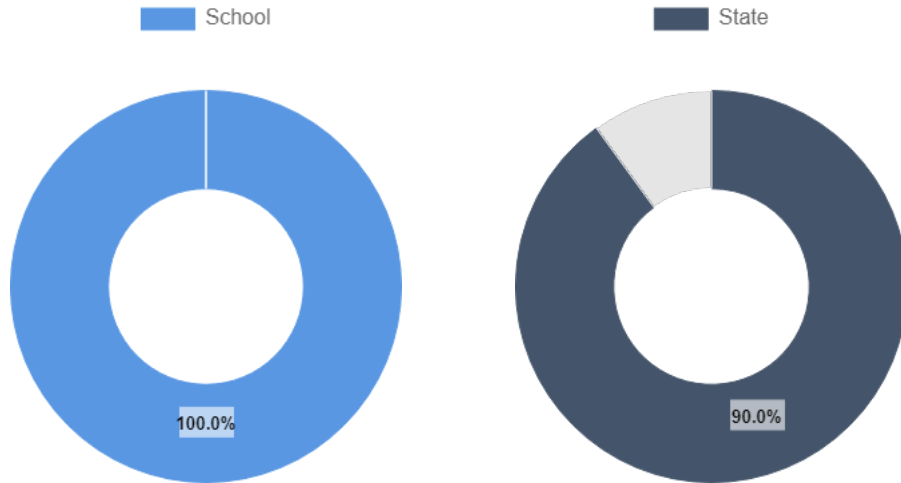

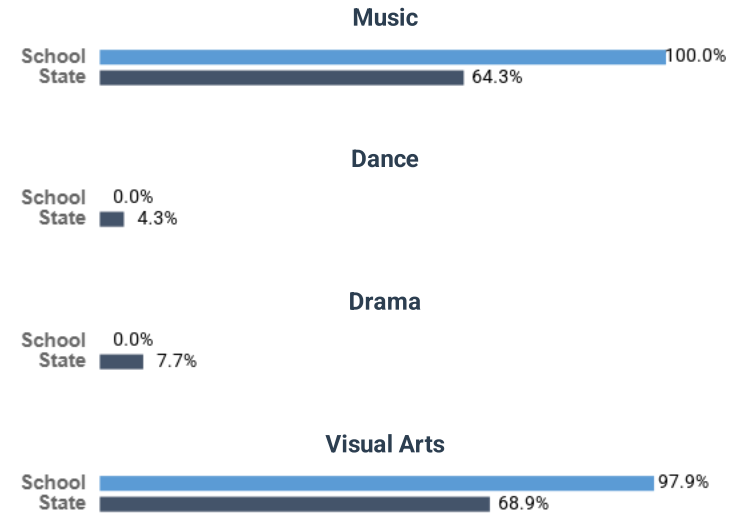

Students enrolled in one or more classes by discipline:



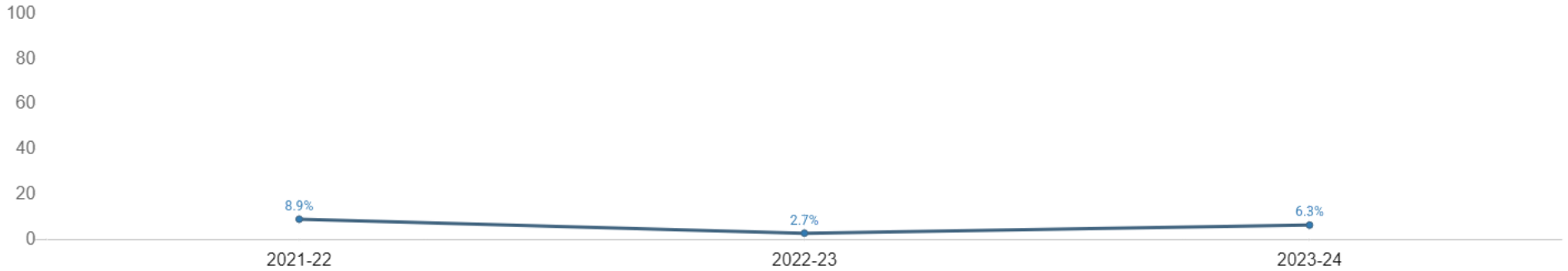

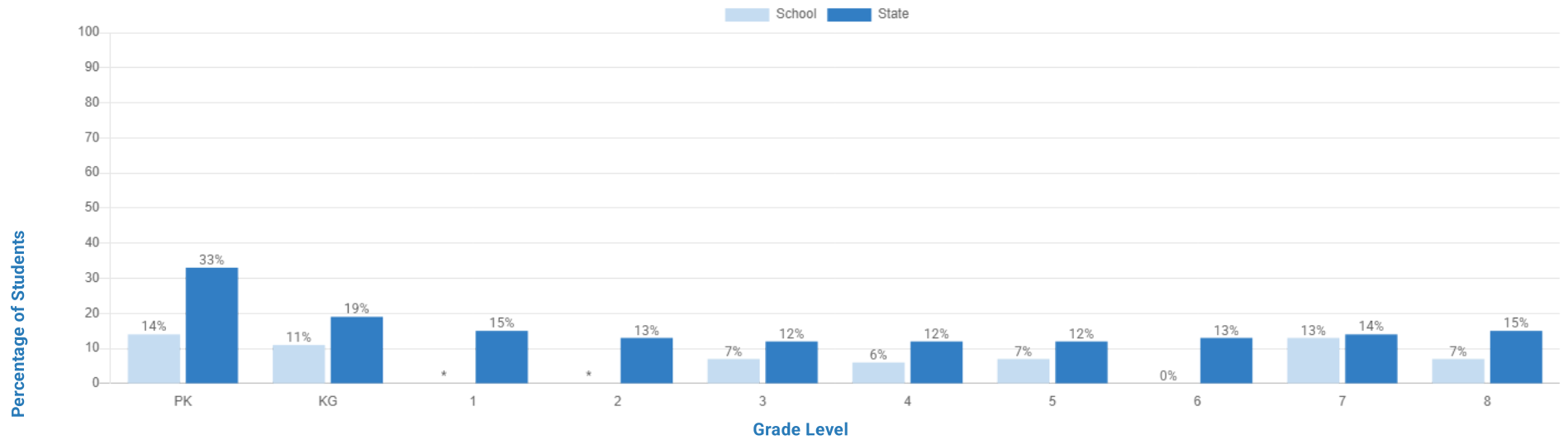

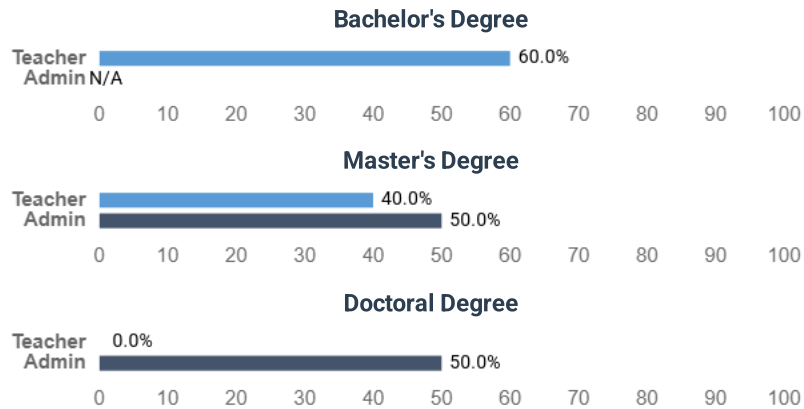

Facilities:

The school facilities play a crucial role in providing a safe and stimulating environment for students to learn and grow. With a spacious building of approximately 35,400 square feet situated on 4.8 acres of land, the school was originally constructed in 1970 and has been meticulously maintained to ensure it meets the needs of the students. Inside, there are various instructional spaces, including classrooms, a science lab, an art room, a media center, a gymnasium, and a multipurpose room, allowing for diverse learning experiences. Outside, the grounds are equipped with sports fields, a playground, basketball and tennis courts, a small turf play area, and an outdoor garden. These outdoor spaces are not only great for physical activities but also provide areas for outside dining and instruction, fostering a connection with nature and enhancing student engagement.



School Safety:

At SGES, the safety and security of students and staff are top priorities. The school collaborates closely with the SG Police Department (SGPD) to create a secure environment for everyone. A dedicated school safety committee regularly reviews security protocols and assesses the overall school climate to ensure it remains a safe place for learning. Additionally, students participate in Social and Emotional Learning (SEL) lessons that help them develop essential skills for managing their emotions and building positive relationships. To enhance safety, video surveillance is installed throughout the school building and grounds, providing an extra layer of protection. Furthermore, the Board of Education has partnered with the SGPD to have a School Resource Officer (SRO) present in the school every day during school hours, ensuring that help is always nearby.



Technology and STEM:

Each classroom is equipped with advanced interactive displays, known as ActivWalls, along with improved audio systems and webcams, allowing for engaging and interactive lessons. Every student is assigned their own device- be it an iPad, Chromebook, desktop computer, or laptop-ensuring a 1 to 1 device ratio that enables personalized learning throughout the school day. In addition to using these tools daily, students actively participate in STEM and Technology classes, where they explore subjects such as coding, robotics, and design thinking engineering practices. This hands-on approach not only fosters creativity and problem-solving skills but also prepares students to thrive in a technology-driven world, making learning both relevant and exciting.
