



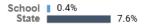





Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

The District implements a tiered system of supports. School counseling services are provided to all students. Certificated faculty facilitate Title I BSI Programs for qualified grade 9-12 students daily at the end of the instructional day during the Academic Support Period. A credit restoration program, administered by a certificated faculty member, is offered in the spring (12th grade) and summer months (9th-11th grade). During the summer months, various International Baccalaureate, Advanced Placement, and Summer Institute courses are offered for students, also run by certificated faculty members.



Teachers and administrators have been provided state-mandated professional development and ongoing support in TeachNJ, policy and procedures, and the use of the Danielson and Stronge staff evaluation models. Professional Development has been offered via in-district and out-of-district trainings, opportunities for peer observation, and participation in local and state national consortia. The district has a focus on incorporating differentiated instruction and use of innovative, instructional technology. Additional professional development offerings included opportunities which are aligned to assessment strategies, data analysis, and techniques to enhance data driven decision making processes. The district also has a keen eye on developing best practices pertaining to Al used in the classroom and throughout the field of Education. During the 23-24 school year, the administrative team participated and was awarded certification in NJPSA, Legal One, Master Level course in school law.



Over 90% of students from Shore Regional apply to various colleges and universities across the country. Shore Regional offers individual counseling to students and offers several programs to address the needs of students pertaining to the college application process and the specifics to apply for financial aid. During the year, students receive individual and group counseling regarding college, test prep for SATs, and PSATs. Students utilize the Scoir program, as well as many other online resources to assist in the college planning process. Student Supports and Services:

Shore Regionals' Child Study Team includes a School Psychologist, LDTC, and Social Worker. Specific IEP's identify the need for Occupational and Physical Therapists to be available to evaluate students and provide services to include in class support, basic skills, resource classes, ESL, and specialized programs. In the 23-24 school year, Shore Regional offered an Academic Study Period where students could seek extra help from teachers. NHS peer tutoring is also offered. Shore Regional has an I&RS team to help students who are experiencing difficulties and the Office of the Director of Student Services was trained on and implemented the beginning stages of using Intellispark to monitor student needs and supports.



Health curriculum, for grades 9, 11, 12, includes physical, mental, and nutritional health. Physical Education classes are primarily life-skilled based. In addition, Shore Regional offers an Advanced PE Concepts of Fitness, Strength, Mindfulness, and Conditioning course, as well as Foods for Today's Lifestyle which focuses on planning meals by healthy guidelines. Student organizations that promote health and wellness include the Red Cross Club, Student Athletic Trainers, and Medical Careers Club. In 23-24, the Shore Regional High School district implemented the Sports Medicine/Athletic Training program and an enhanced offering of dance classes which included IB level offerings. The Rutgers Behavioral Health Program is infused into district services and an on-site counselor is available for small group and individual services. The Office of the Director of Student Services also works collaboratively to utilize the Intellispark portal when applicable for student needs and services.



Parent and Community Involvement:

Various programs exist for parents and community to get involved at Shore Regional. Parent groups and events include Principal Parent Forums, PAAC, Community Alliance Group, Back to School Night, 8th Grade Open House, charity drives, and Strategic Planning allowing for community involvement. Parent and student portals are utilized for progress report/grading information, attendance reports, and special bulletins/announcements. Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The Shore Regional High School District embarked on a district-wide initiative to develop a new five-year Strategic Plan which included the creation and distribution of a district-wide survey. The survey instrument included a component and series of questions relating to school climate and culture. Data collected and mined through the strategic planning process was valuable and utilized to develop strategies, methods, and goals related to school climate for the futuristic growth in this area throughout the five year strategic planning cycle.



Shore Regional is a forty-acre campus situated on Franklin Lake in West Long Branch. The entire campus is designed for efficient and effective learning classrooms and spaces. The facility is wi-fi accessible and fully air conditioned for comfort and optimal instruction. Capital improvement projects included an updated Athletic Training Sports Medicine Center where student athletes are treated with state of the art equipment. The Athletic Training Sports Medicine program participates in a student centered, lab environment, for instruction. Shore Regionals' Dance Studio was renovated to be able to increase program offerings in our performing arts dance program, which began during the 23-24 school year. Beautification projects were completed in our auditorium. Campus signage updates included inside and outside facilities. The district began the process of developing continued facility and program expansion in 23-24 for a transitional plan and next phases for growth in 24-25.



Safety is a top priority at Shore Regional High School. Our Security Coordinator manages emergency operations. SRHS security members are retired law enforcement. Administration and security personnel lead monthly drills involving staff and students. Drills and real life scenarios are facilitated and local police are debriefed. Emergency information is provided to staff, which includes phone numbers and addresses of local police and fire departments, as well as any other pertinent information. SRHS utilizes a visitor management system to expedite an efficient check-in process with a focus on school safety. The district operates a video surveillance system both inside and outside the school. SRHS continues to explore grant opportunities to purchase next generation safety and security technology. Professional development will continue to be offered for all staff and administration to explore current best practices aliqued to school safety.

The District maintains a 1:1 student Chromebook program to support Google for Education suite of products, digital databases, online textbooks and coursework, as well as Newline interactive boards. Online programs and platforms are utilized to support instruction and assessment across the disciplines. Several classrooms, computer labs, and common spaces are fully supported with interactive boards and devices for student and staff use. Students enrolled in art, music, and film coursework also utilize technology to enhance learning. Devices which include iMacs and drones are just to name a few. The district purchased and provided staff and student training for the use of an epilog laser system to enhance learning in the area of architecture, CAD, and manufacturing. STEM related coursework and clubs are available to all students and continue to be explored to incorporate new and innovative learning opportunities.



In 23-24, Shore Regional High School demonstrated a less than 10% score of students chronically absent. SRHS is a nurturing educational institution where students are supported in all areas pertaining to the social, emotional and intellectual needs desired and necessary of high school students. A continued focus on school climate and the work of school climate teams remained a top priority. A deep dive into school climate data and district goals, in tandem with coaching visits and professional development learning opportunities, in conjunction with NJPSA, were a part of the districts continuous lens on providing a positive and safe school climate. SRHS is a public high school with a small college feel where administration, faculty, staff, and community partners work collaboratively to support student needs and to create a culture where all students are accepted and belong as evident by the number of cocurricular clubs and experiences offered to the entire student body.
