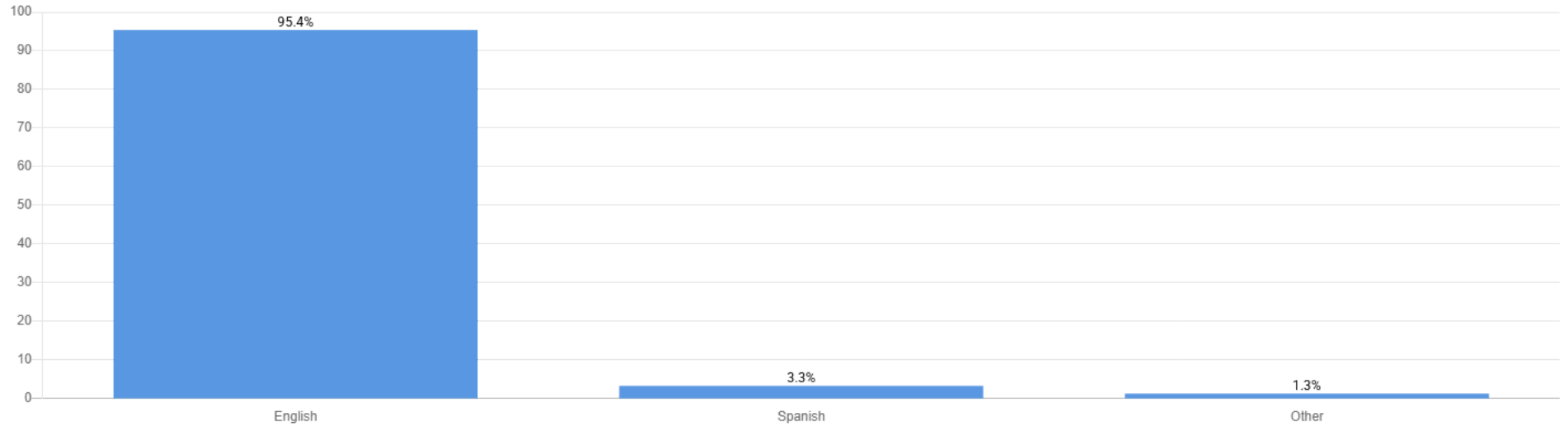

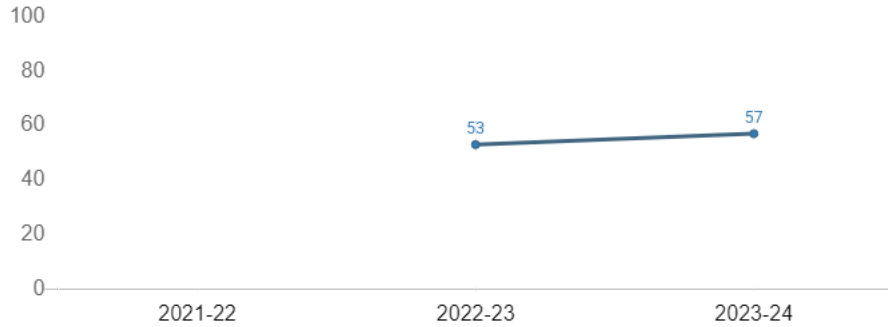

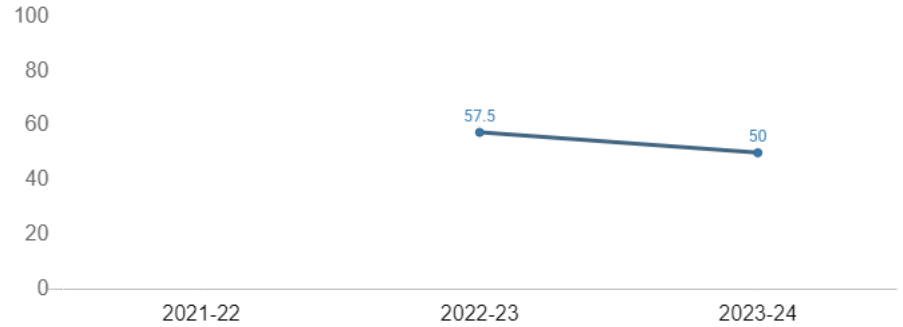

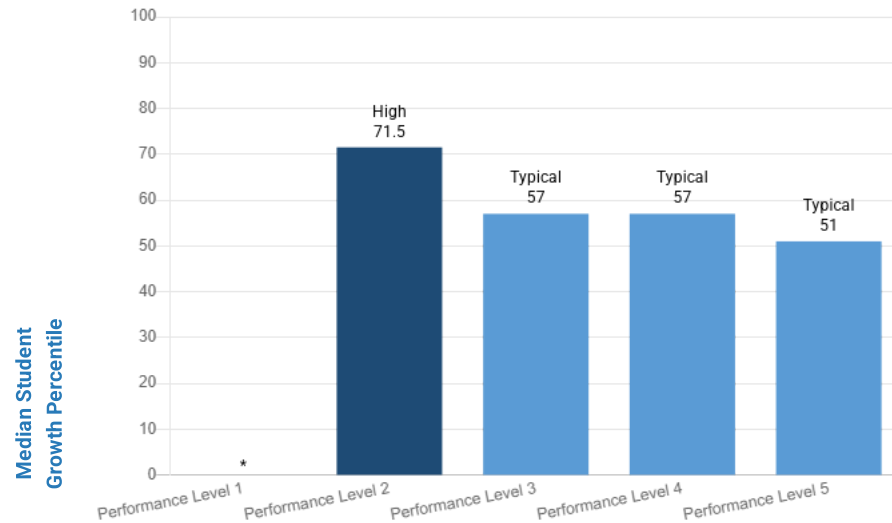

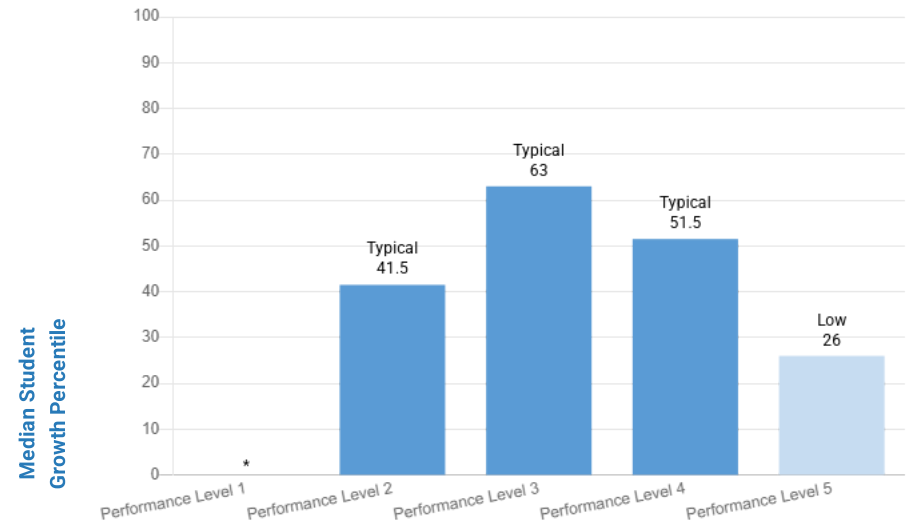

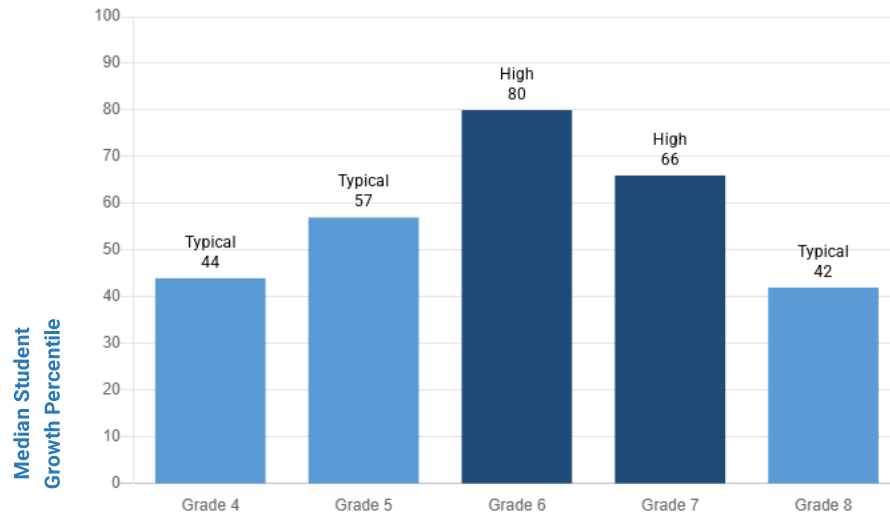

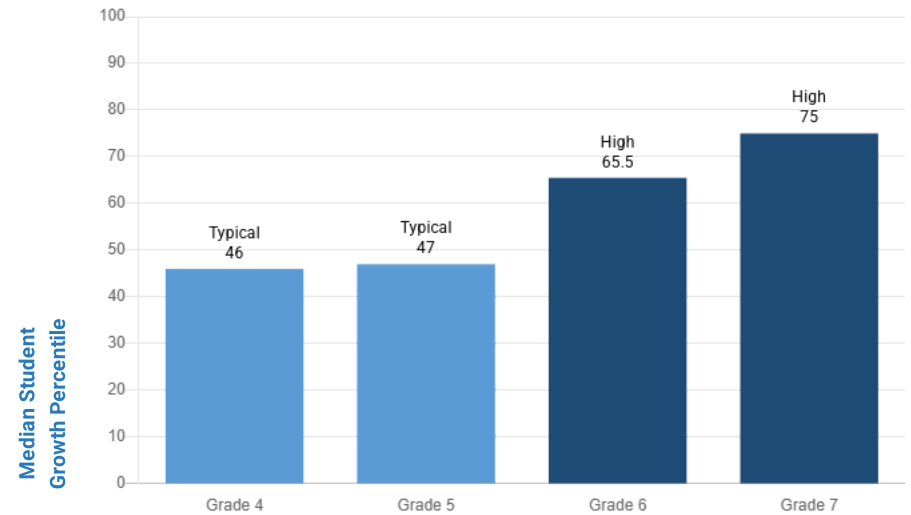

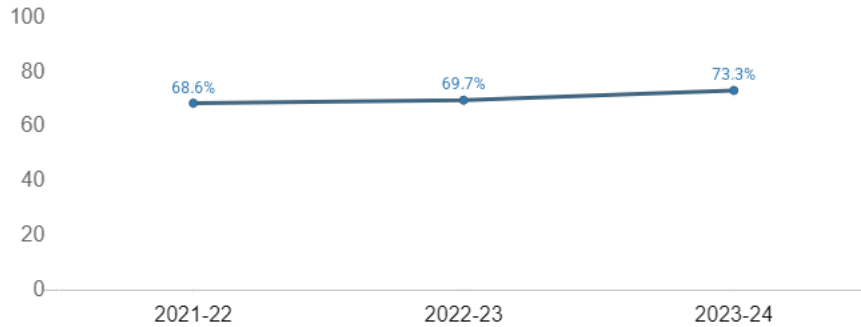

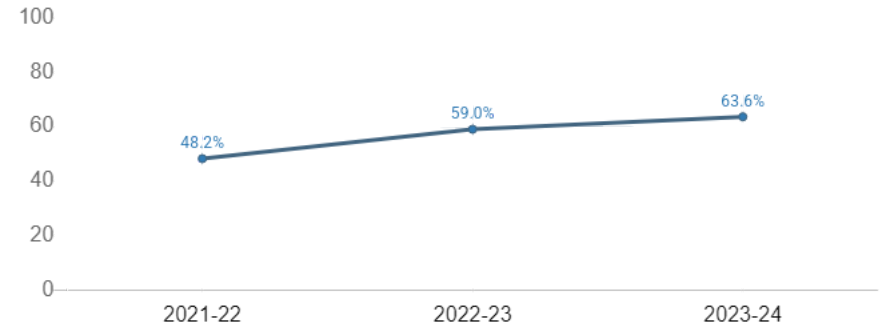
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 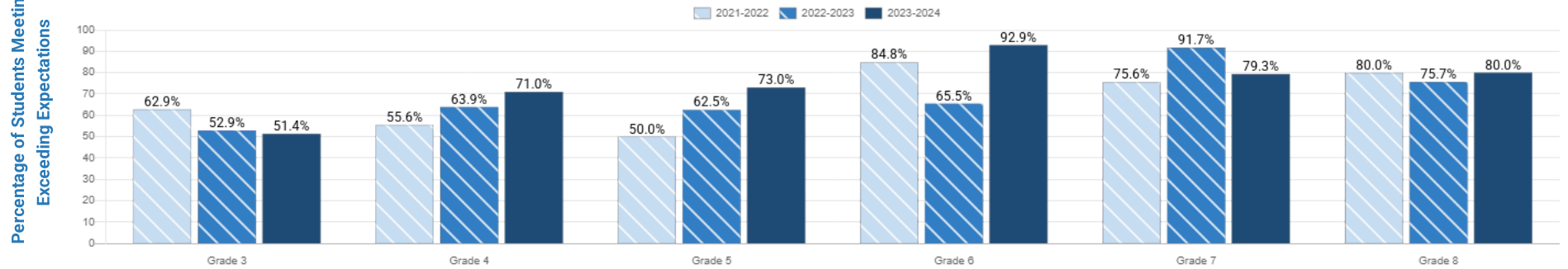

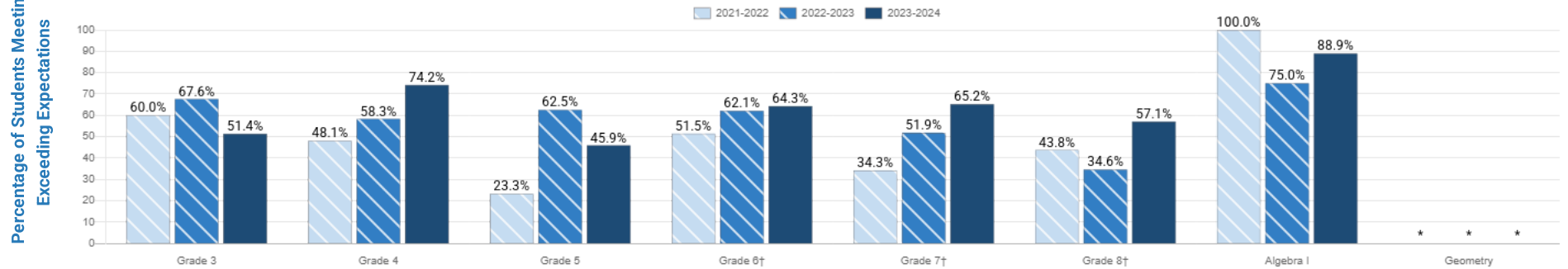

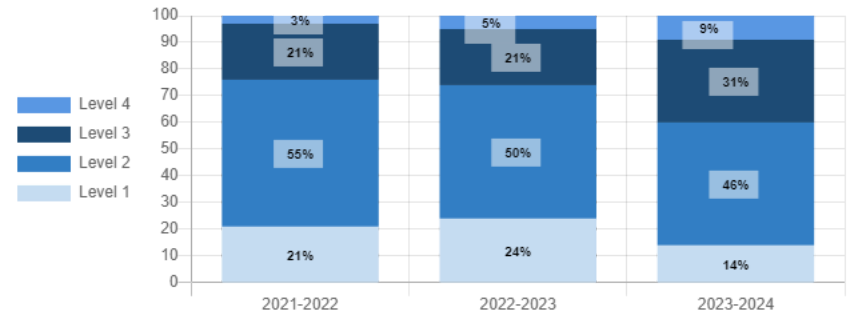

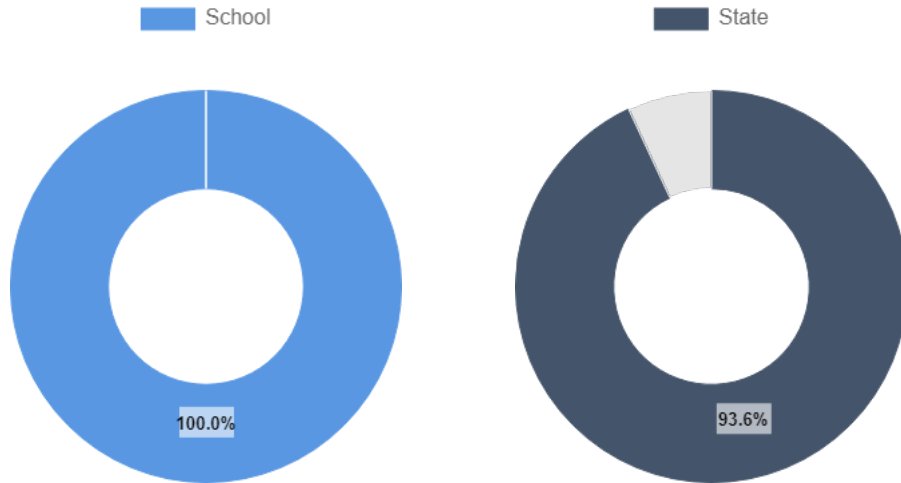

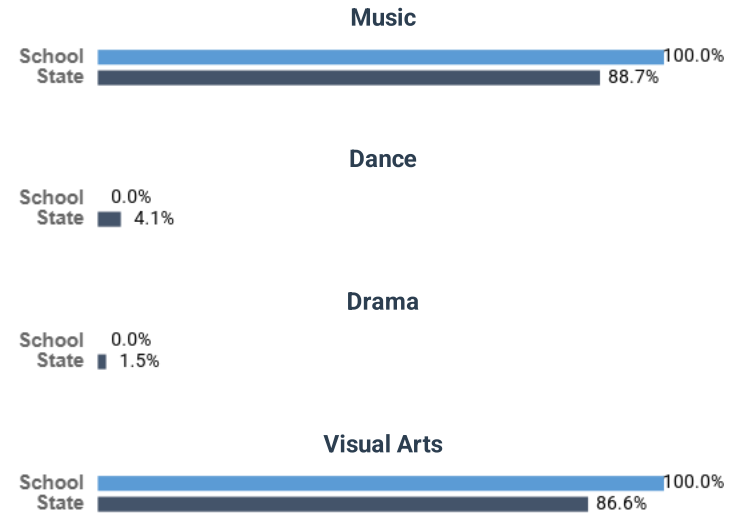

Students enrolled in one or more classes by discipline:



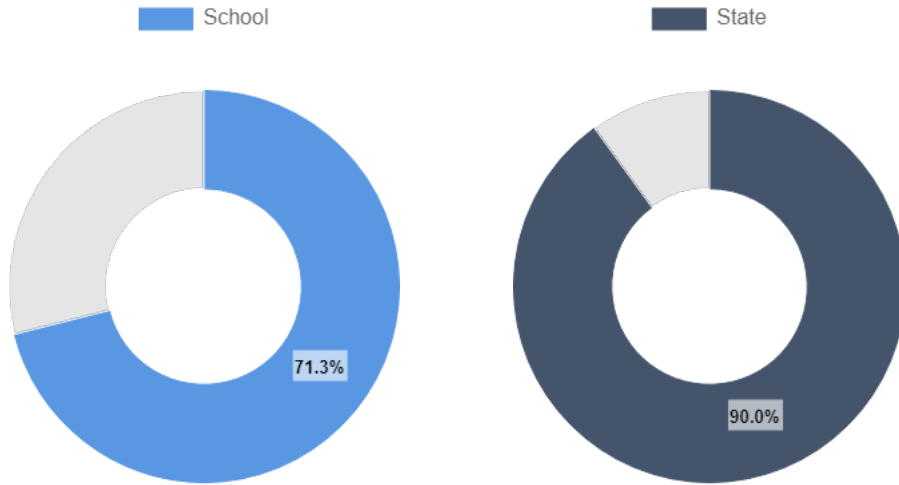

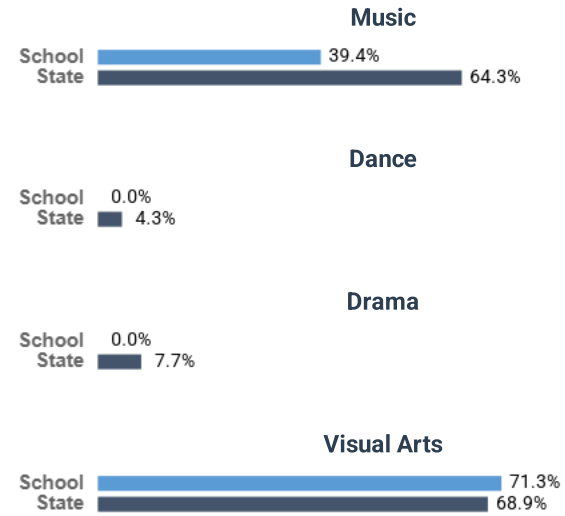

Students enrolled in one or more classes by discipline:



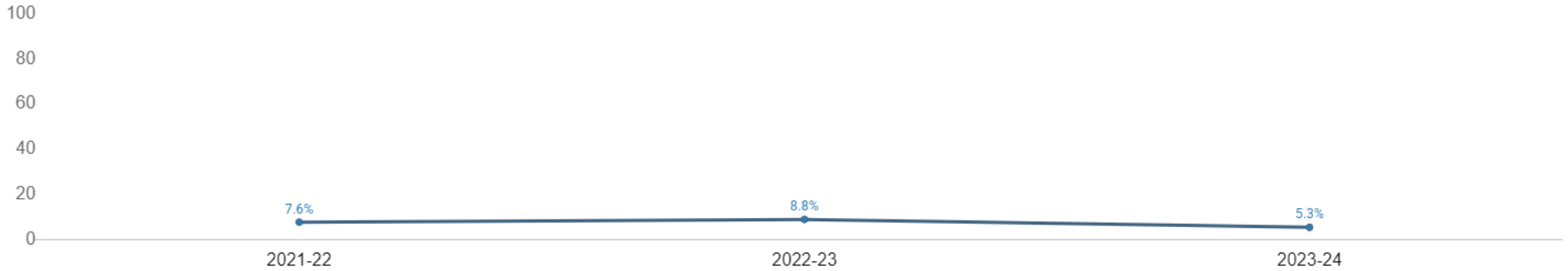
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. 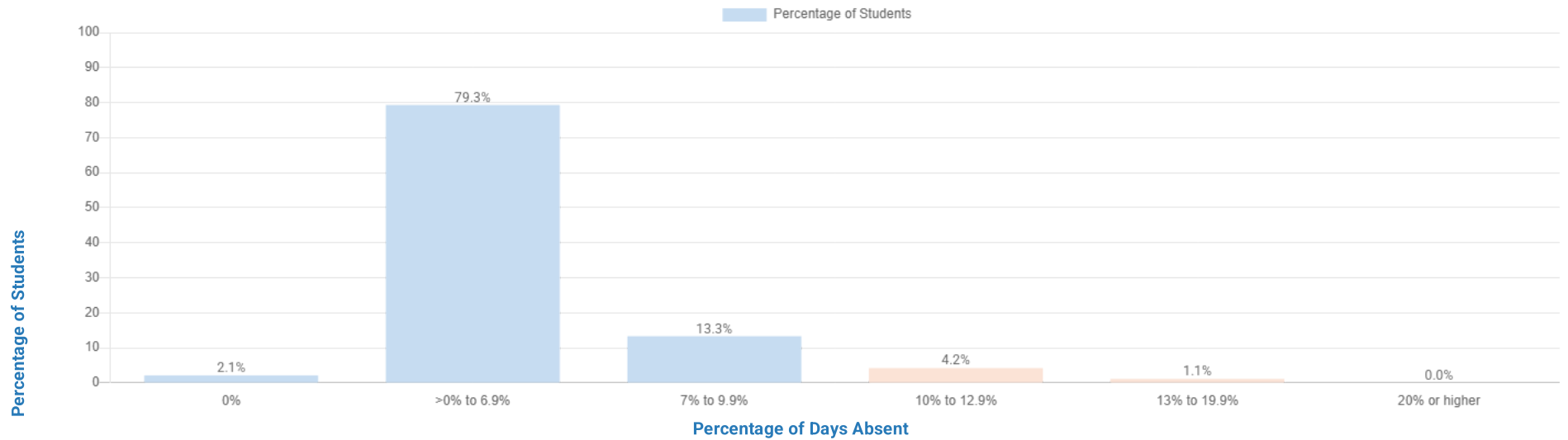

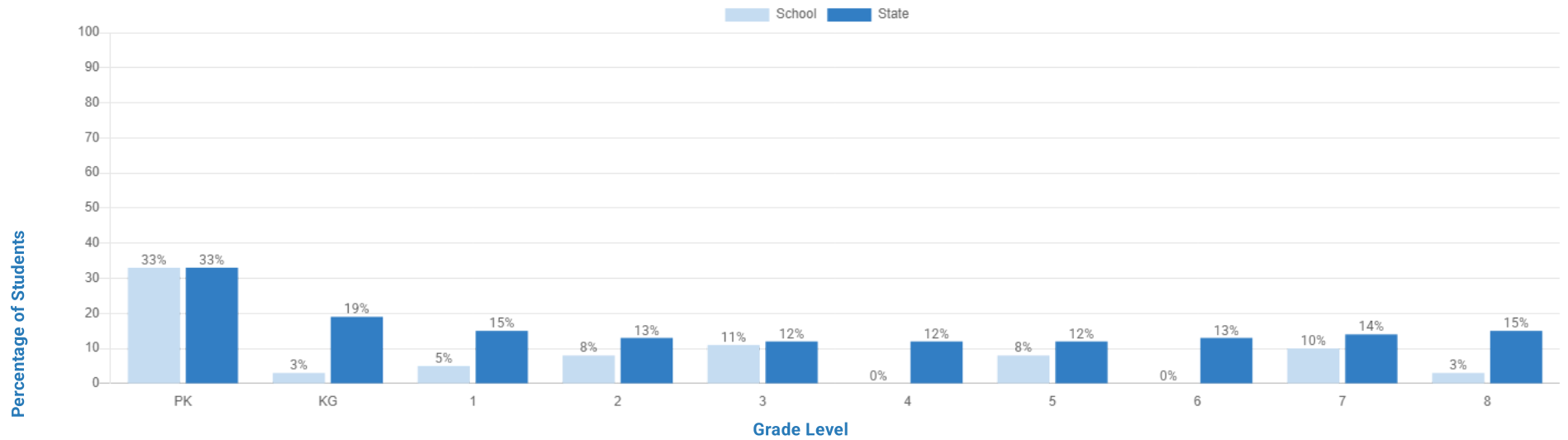

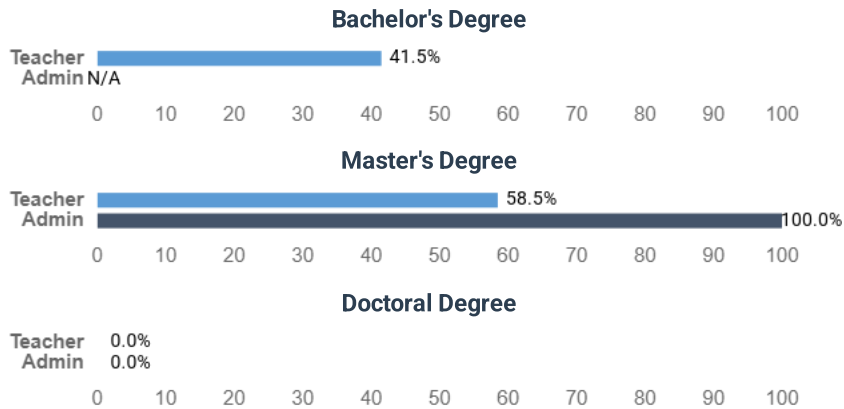

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Members of our small, supportive community actively participate in our PTA and Educational Foundation. They raise money that directly benefits our students. Parents can monitor their children's grades through our Parent Portal with easy access from our district website. We offer numerous opportunities for families to visit our classrooms, concerts, art shows and showcases! Additionally, we hosted a Geography Bee Tournament of Champions for local sending district students. We offer a Wingman Program through Wings of Change. We have an active SEPAG working to coordinate activities with local schools.



Facilities:

With the successful passing of a bond referendum in January of 2018, the District underwent major construction, upgrades, and renovations which were completed for the start of the 2019-2020 school year. An addition, housing new art and science classrooms, was created with a collaboration space and meeting space in the corridor leading to the classrooms. All interior lighting was replaced with new LED fixtures. All classroom doors and locks were replaced and a new security vestibule was constructed creating a safer environment for all. The entire roof was replaced, new HVAC systems installed, as well as a new fire alarm system. ADA upgrades were completed throughout the entire building as well. SLH also renovated three classrooms to create a new preschool classroom, music classroom, and multimedia STEM room. Two new playgrounds were constructed with one dedicated to our new preschool program. Lastly, 773 solar panels were installed on the entire school.



School Safety:

With the successful passing of a bond referendum in 2018, the District underwent major construction, upgrades/renovations. All classroom doors and locks were replaced and a new security vestibule was constructed to create a safer environment for all. Share911 is used for emergency notifications, all doors are only opened through swipe access and close to 50 security cameras are installed.

Technology and STEM:

Students in grades 5-8 are 1:1 with Chromebooks. Grades 5-8 take them home each day in district issued cases. Grades K-4 have full classroom sets of Chromebook devices. We utilize ST Math at all grade levels and Square Panda at our primary levels. STREAM concepts are incorporated into the curriculum at all grade levels. Many electives and interest-based G&T projects focus on STREAM principles.
