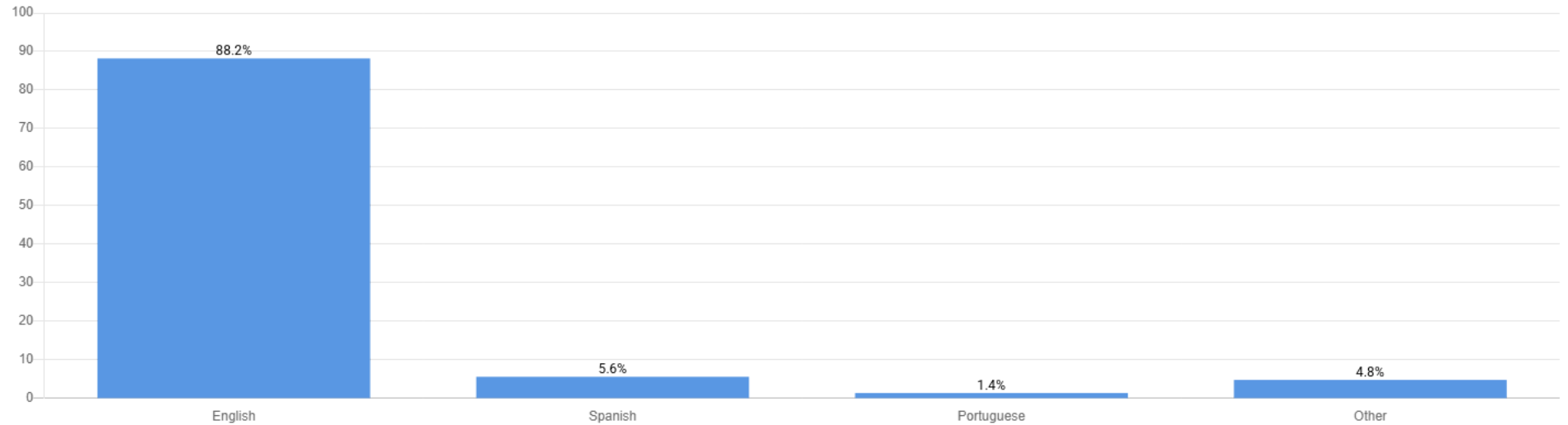

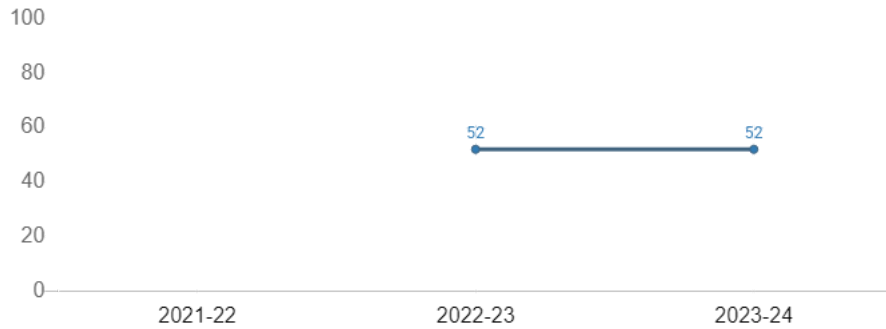

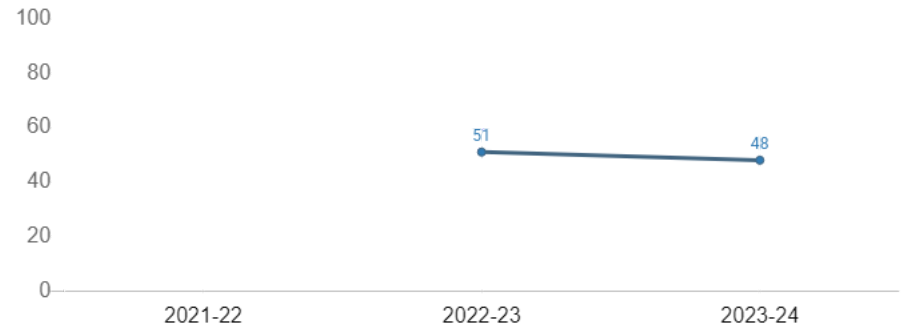

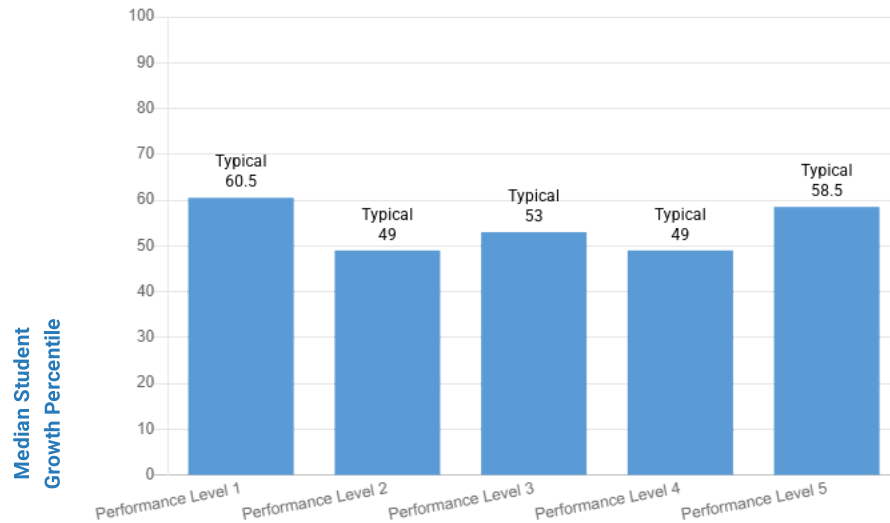

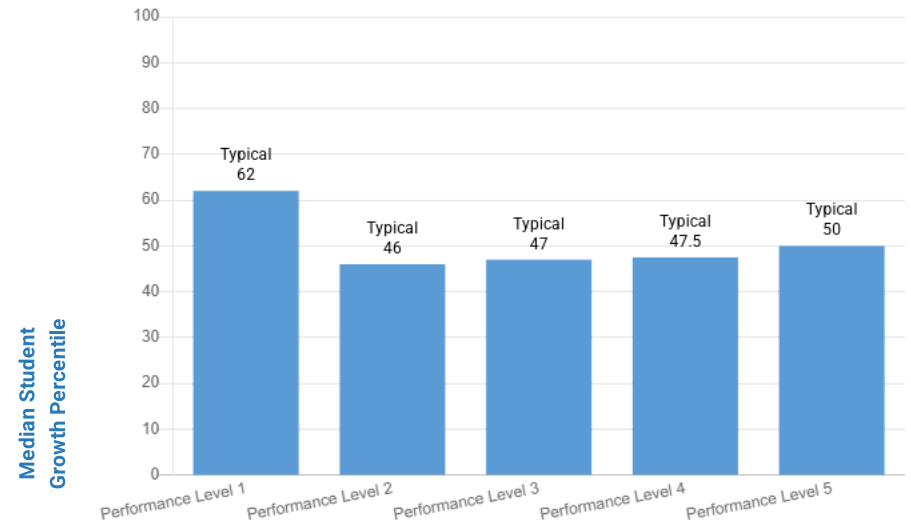

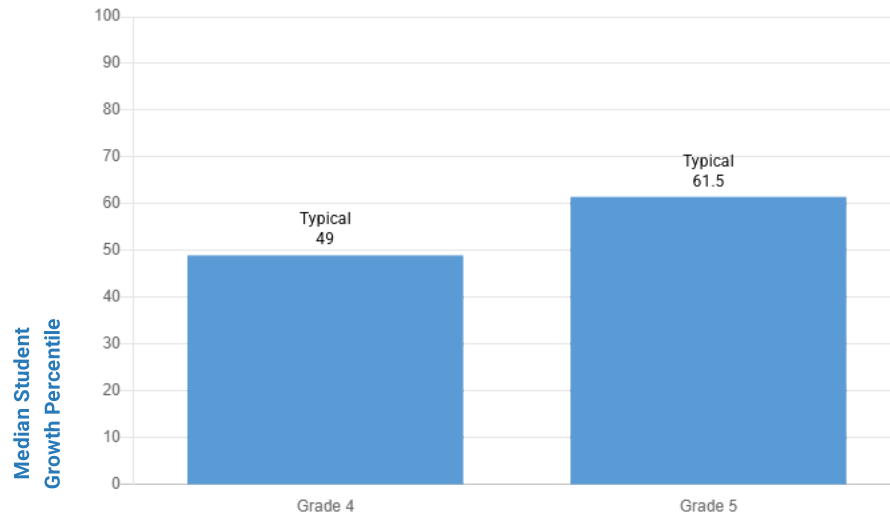

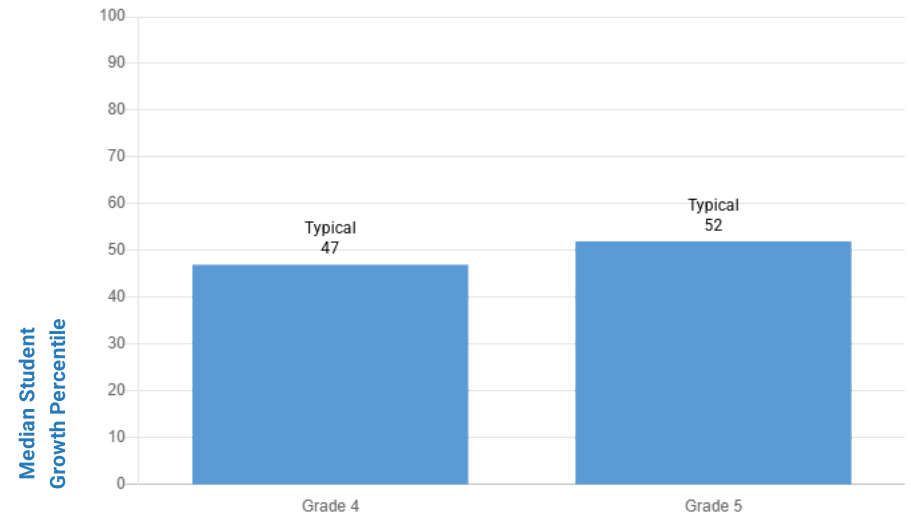

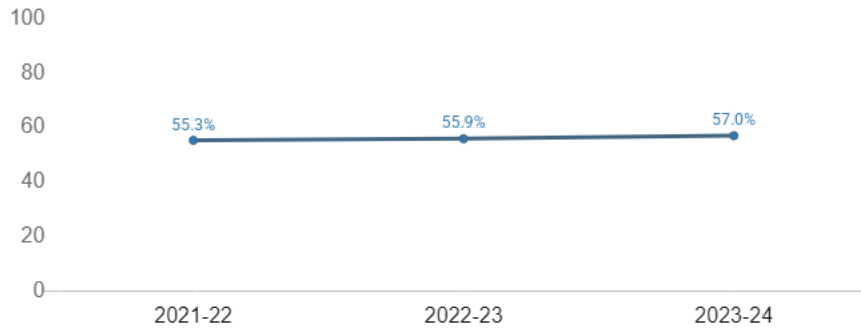

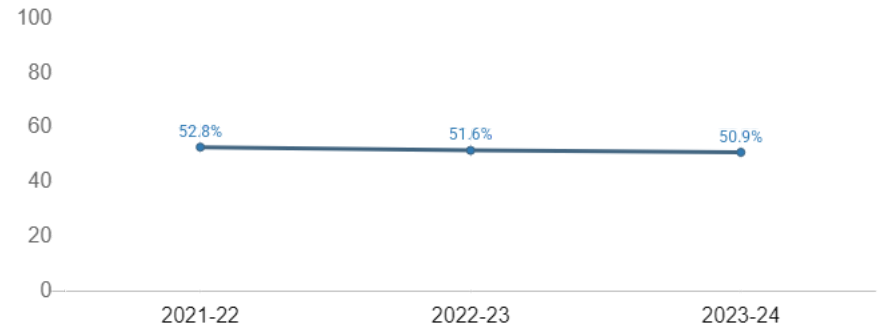
English Language Arts and Mathematics Performance Trends

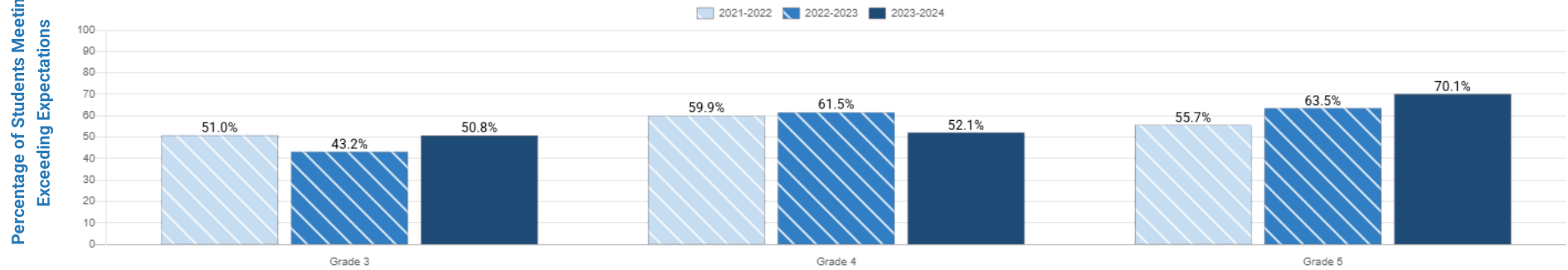

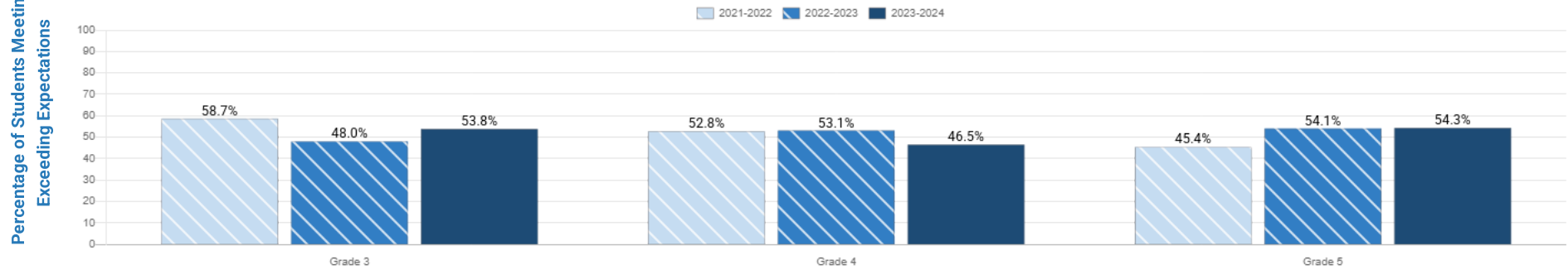

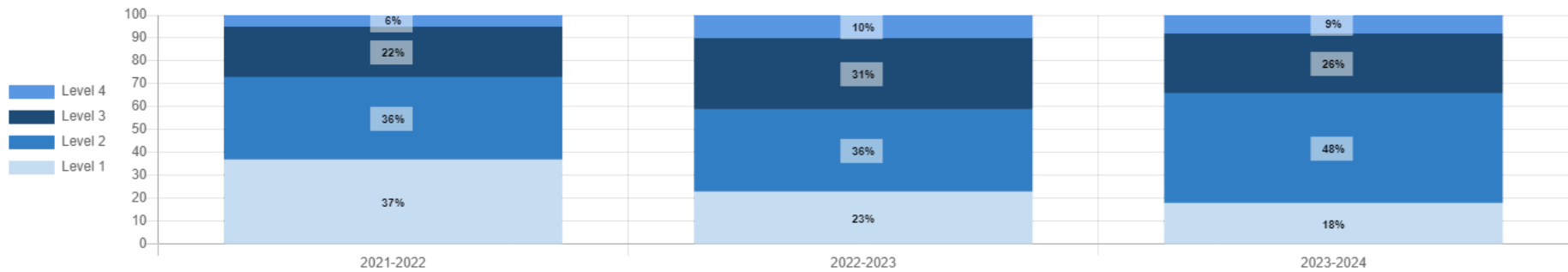

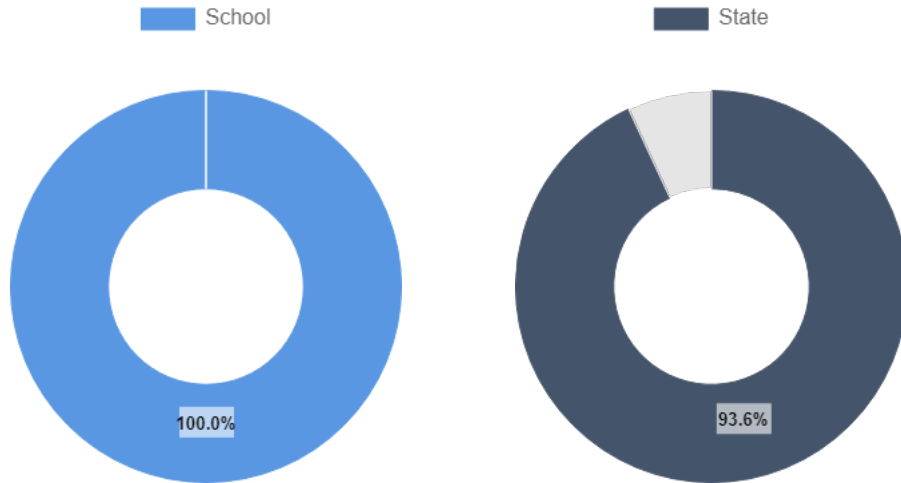

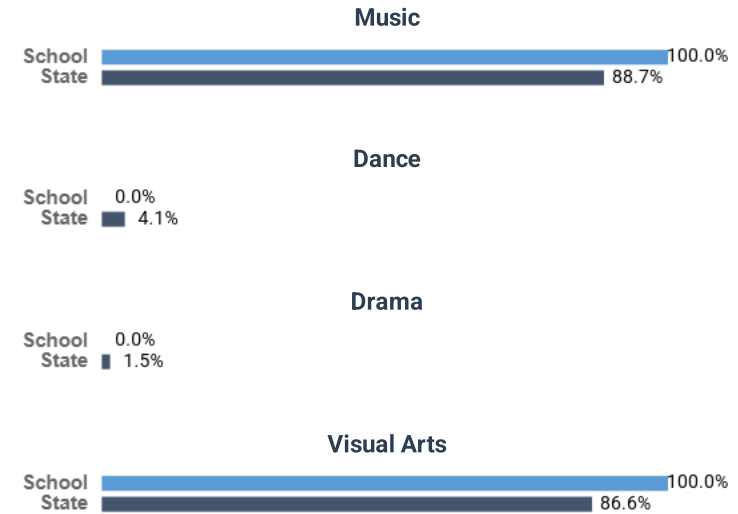

Students enrolled in one or more classes by discipline:



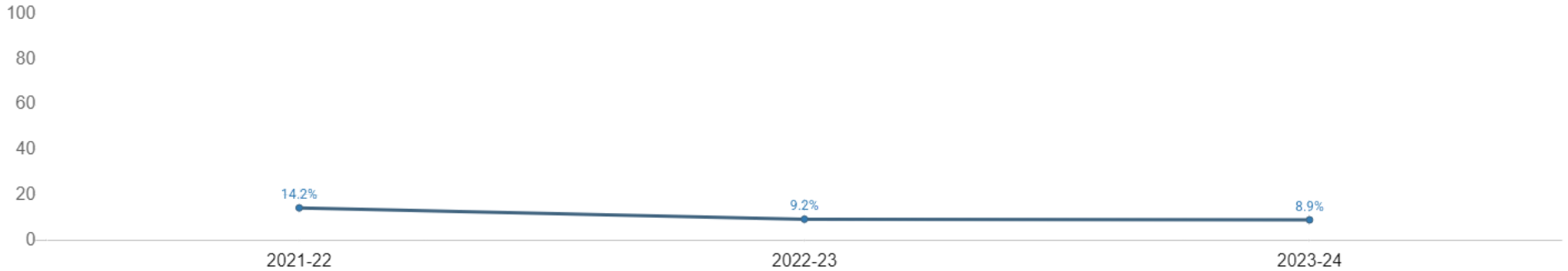

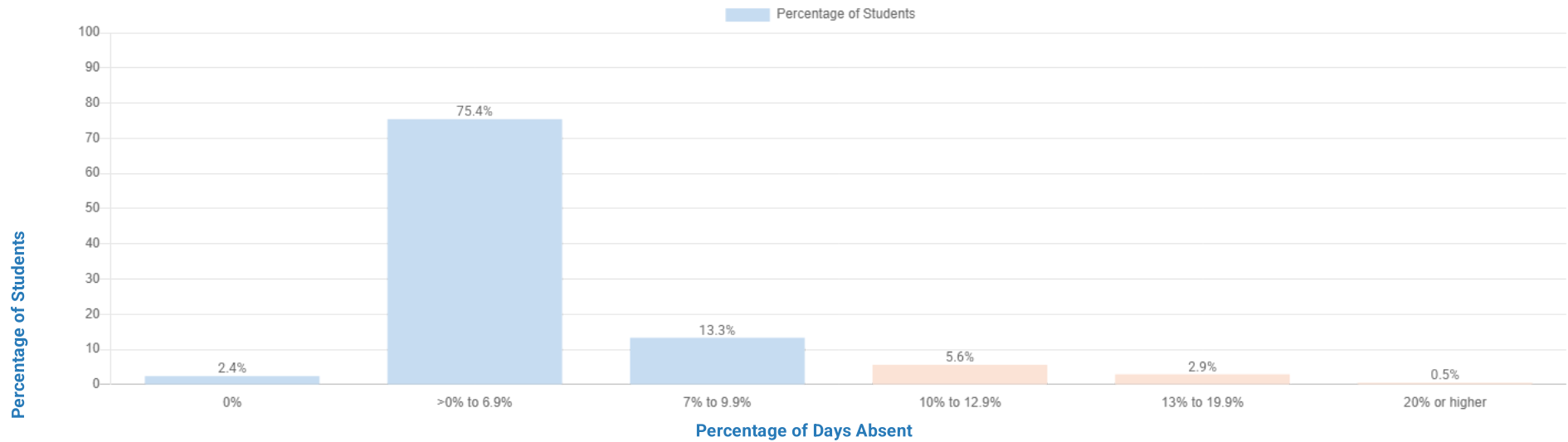

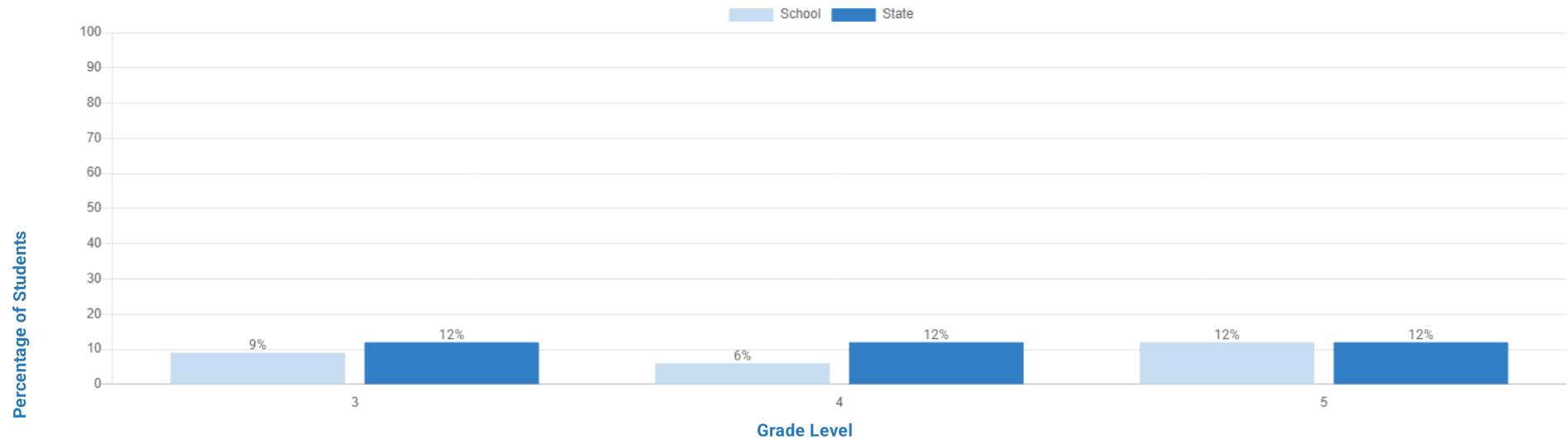

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

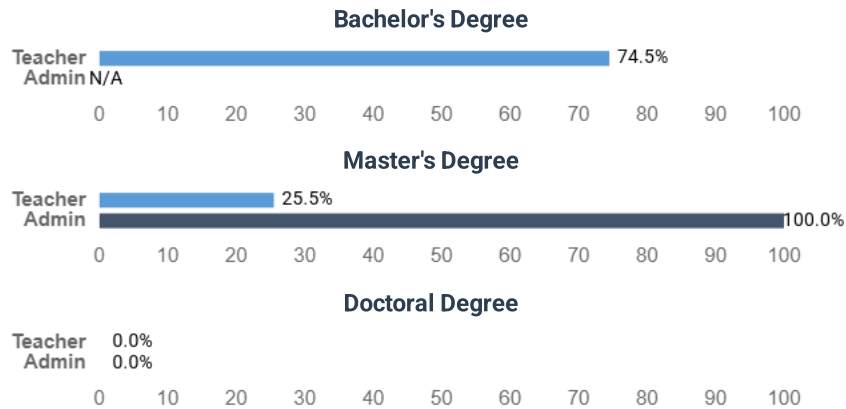

Technology and STEM:

Enrichment classes and small group classes are provided to students in grades 3-5 with a STEM focus. Technology resources in the Tinton Falls School District include a one to one Chromebook initiative in grades 3-8. Each classroom has a Promethean Board and a document camera. Technology is integrated into all subject areas with opportunities for all students to utilize technology both as a consumer and a producer. Coding and programming opportunities are included in technology classes as well. An after-school computer club incorporates many different interest based STEM projects.
