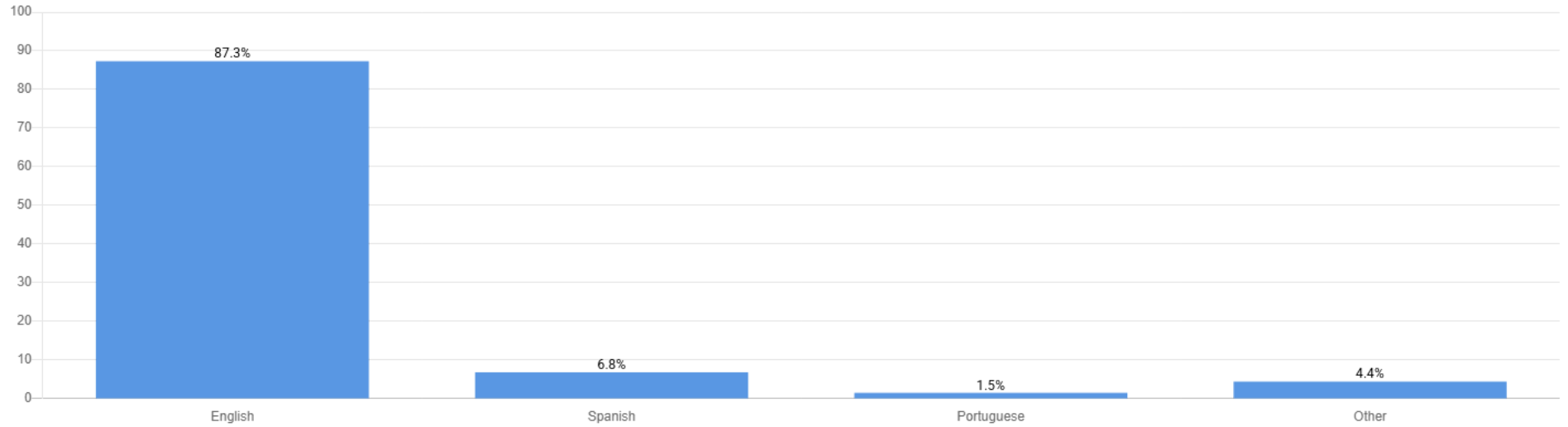

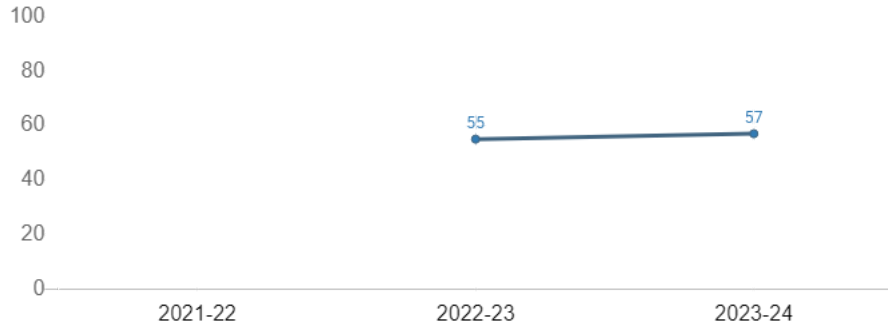

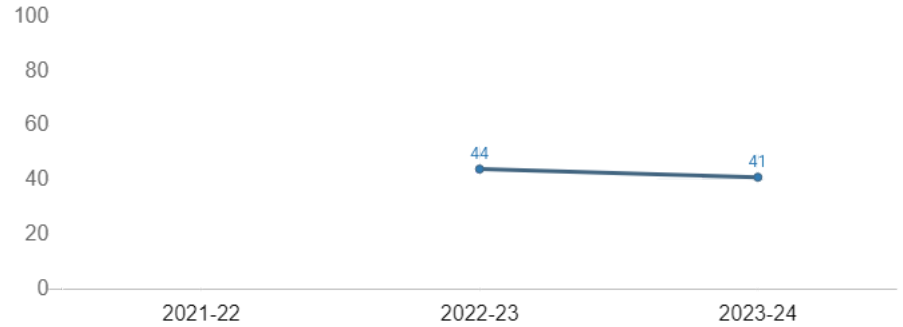

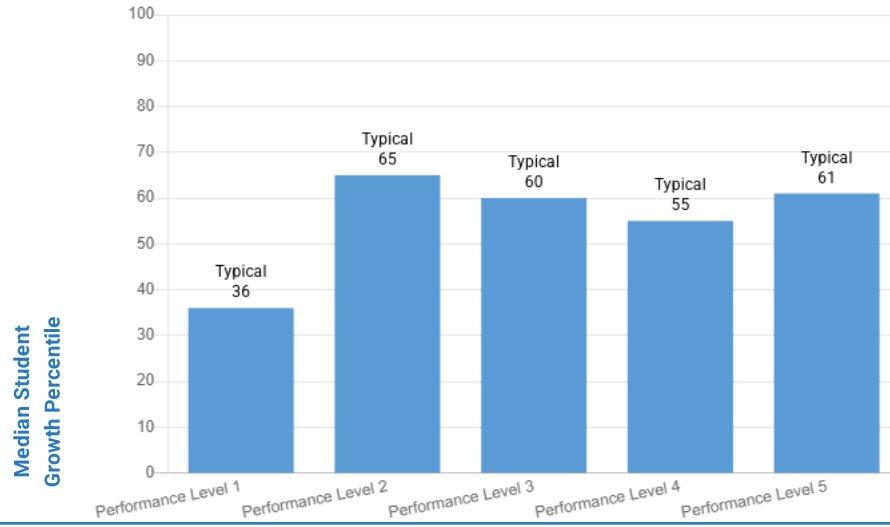

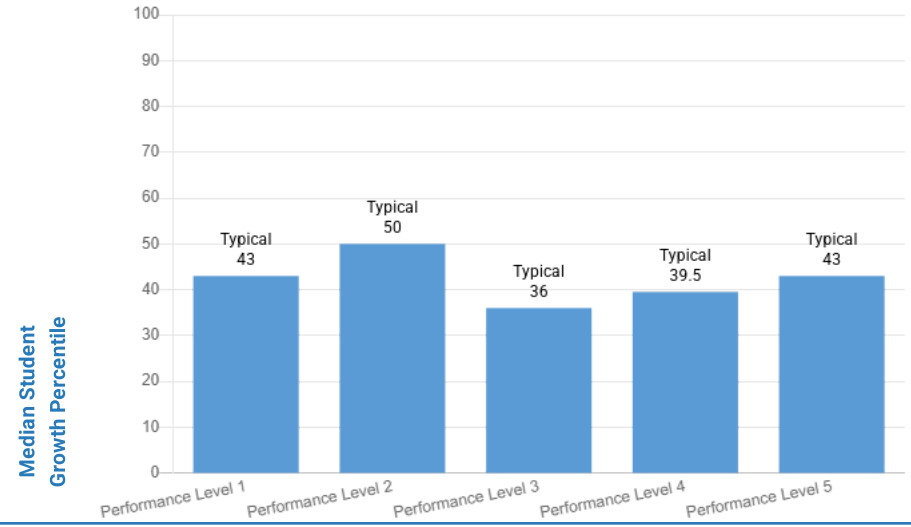

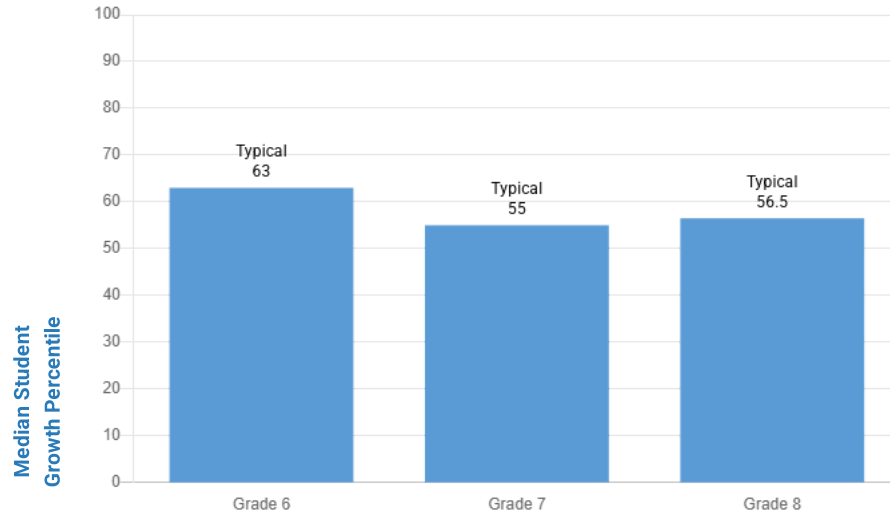

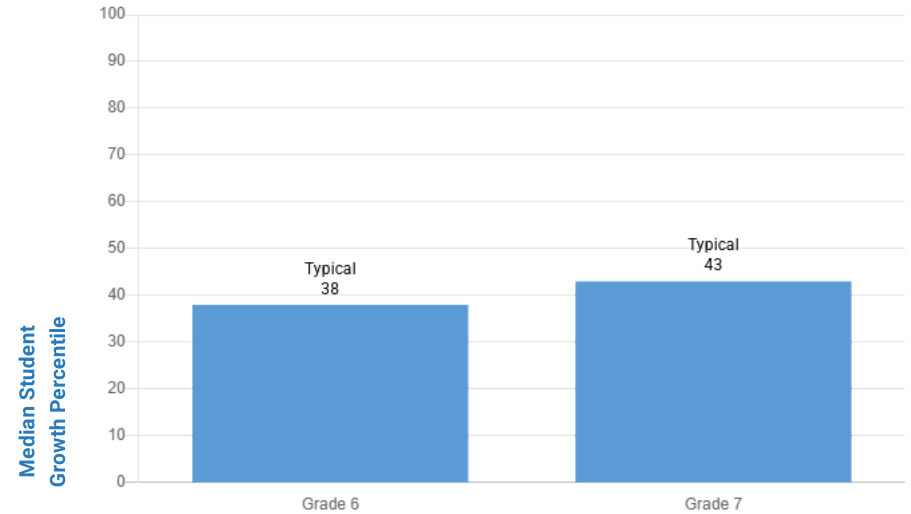

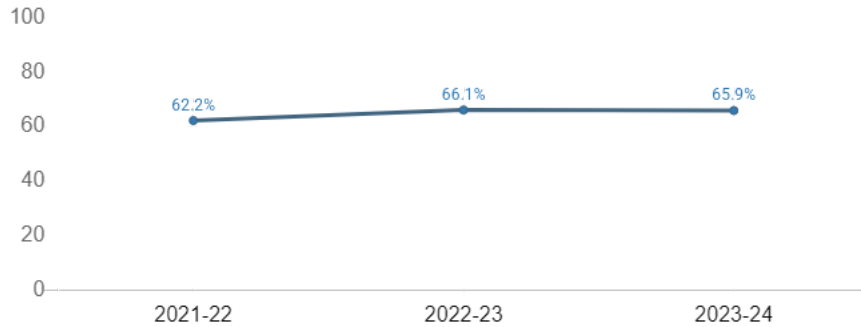

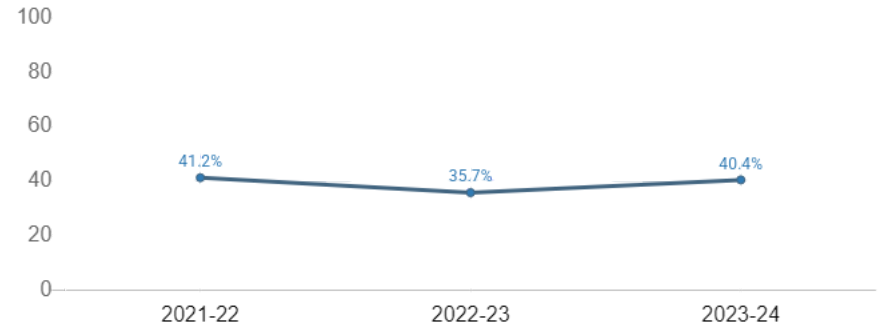
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 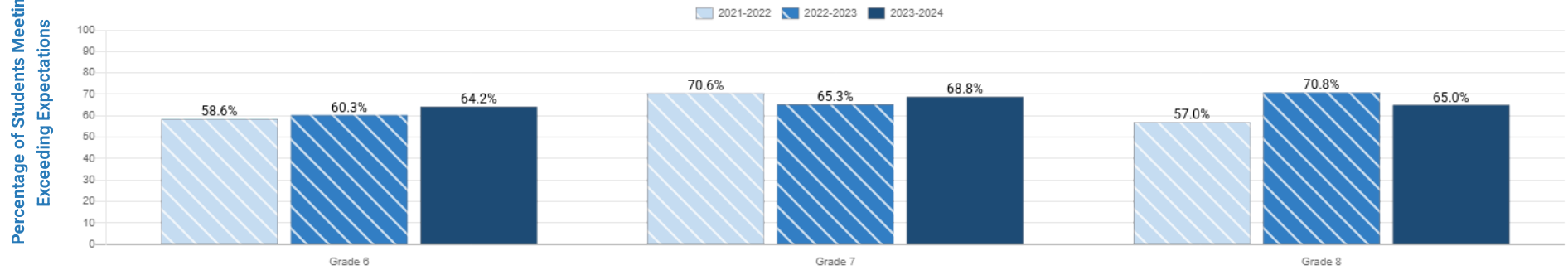

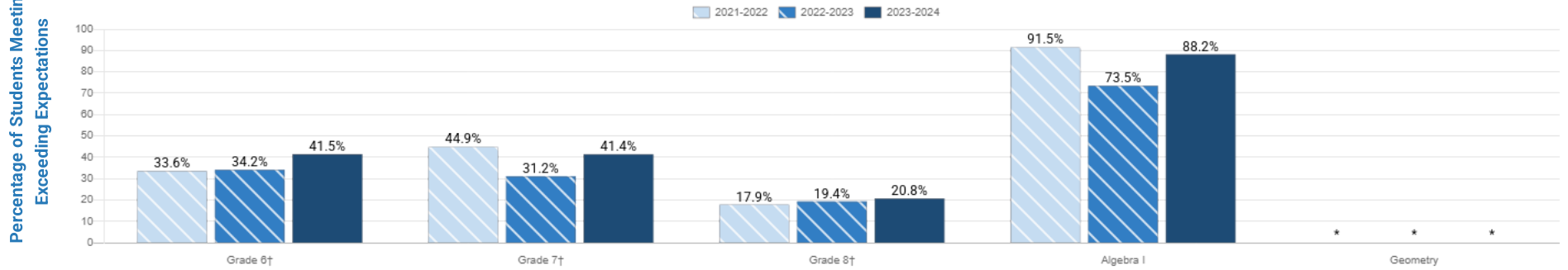

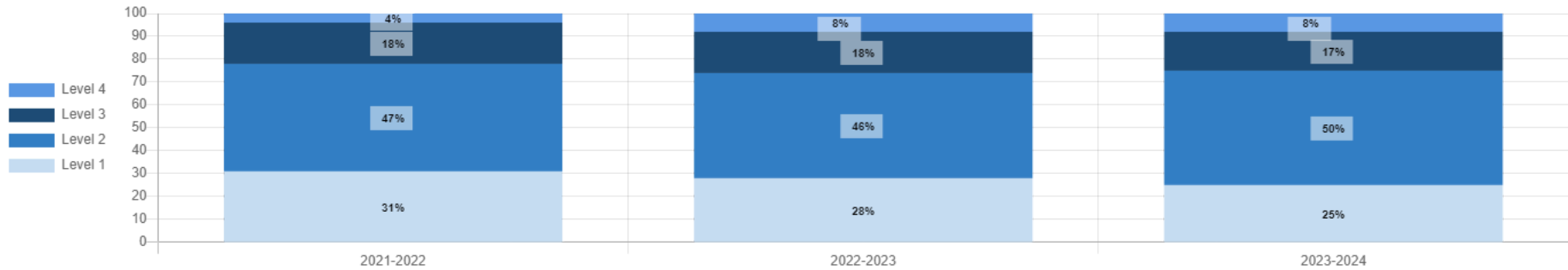

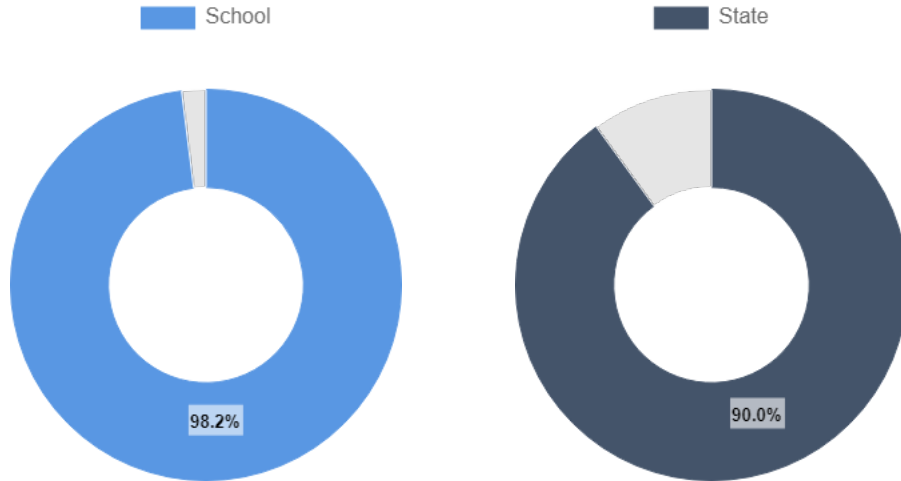

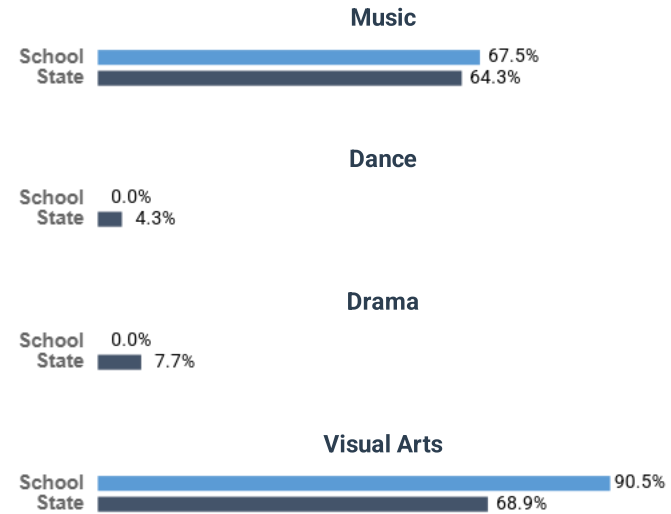

Students enrolled in one or more classes by discipline:



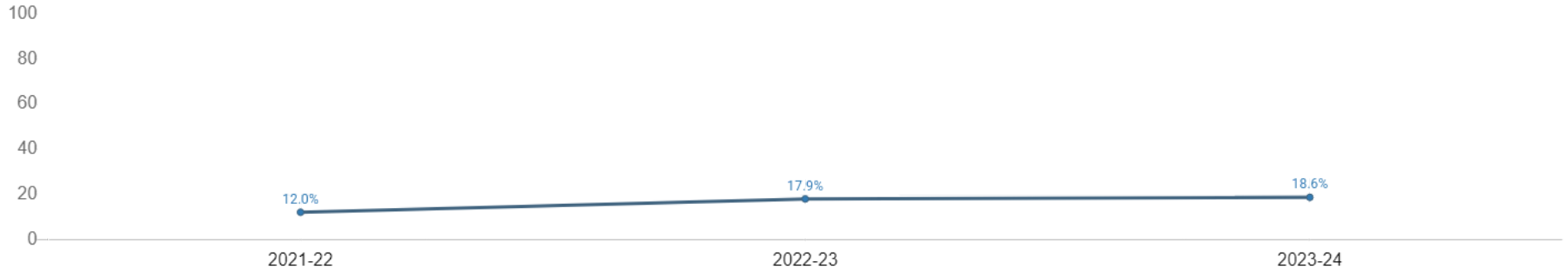

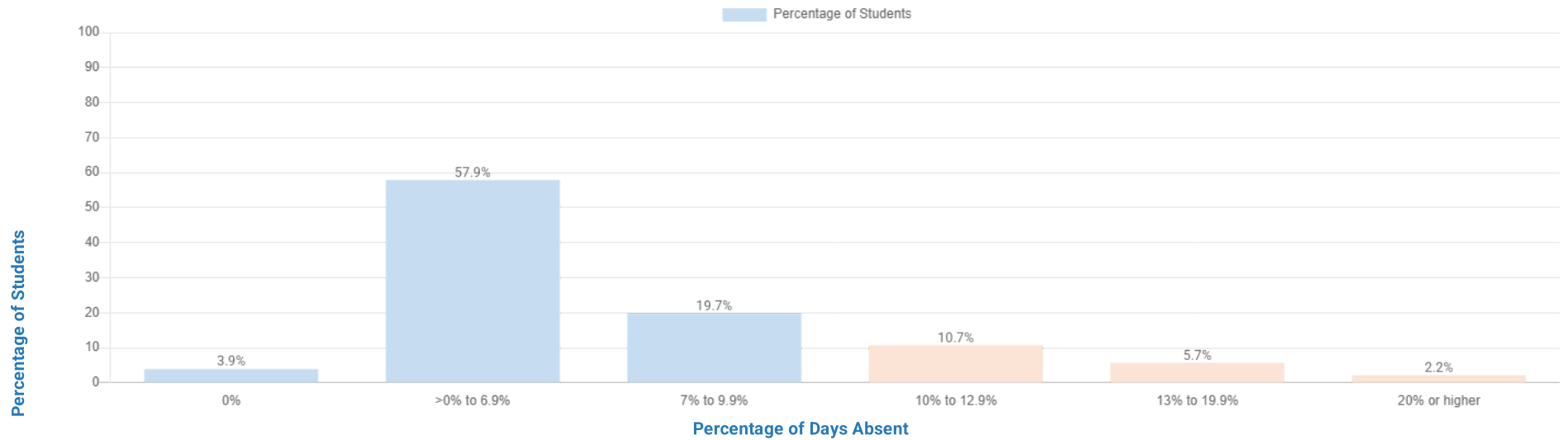

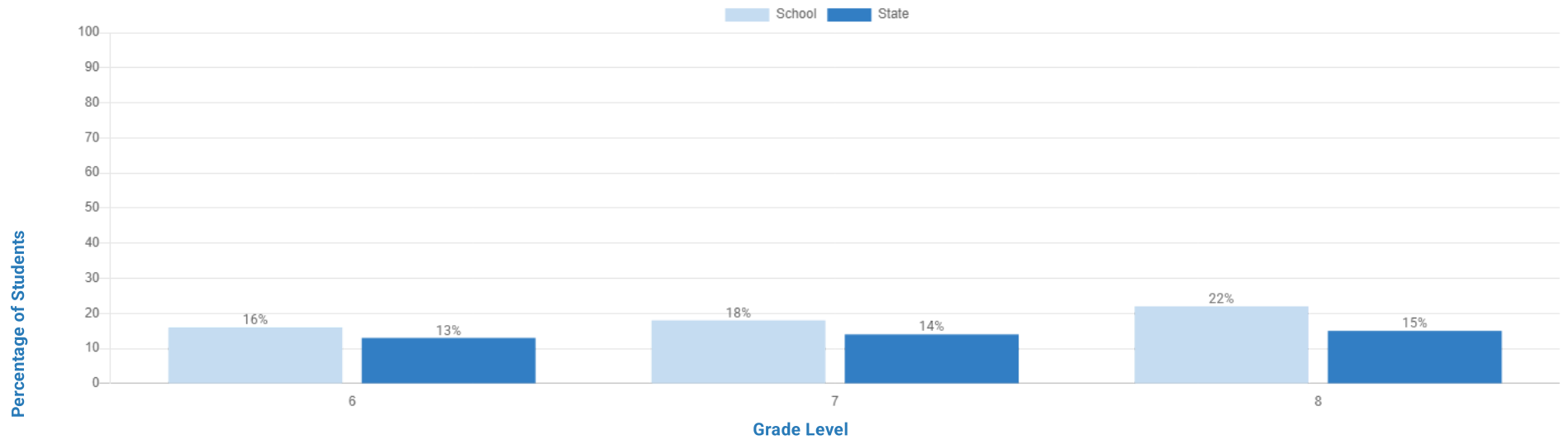

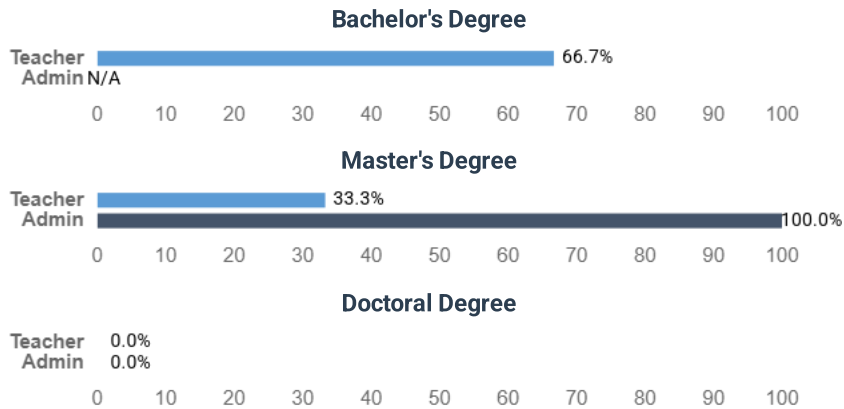

School Safety:

School safety is of the utmost importance. We have applied security measures as recommended by the Department of Education, the local police and state/federal security agencies. Character education, restorative practices, school code of conduct, and other positive programs help our students to learn ways to maintain a safe and healthy school environment. Our schools have full-time School Resource Officers as provided by the Tinton Falls Police Department. A school based behavioral threat assessment team has been trained and responds accordingly to different safety events. Necessary staff members have been trained on CPI techniques to both deescalate and respond appropriately to crisis situations.



Technology and STEM:

Technology resources in the Tinton Falls School District include a one to one Chromebook initiative in grades 3-8. Each classroom has a Promethean Board and a document camera. Technology is integrated into all subject areas with opportunities for all students to utilize technology both as a consumer and a producer. Coding and programming opportunities are included in technology classes as well. An after-school computer club, a STEM and STEAM club incorporates different interest based STEM projects for the students.
