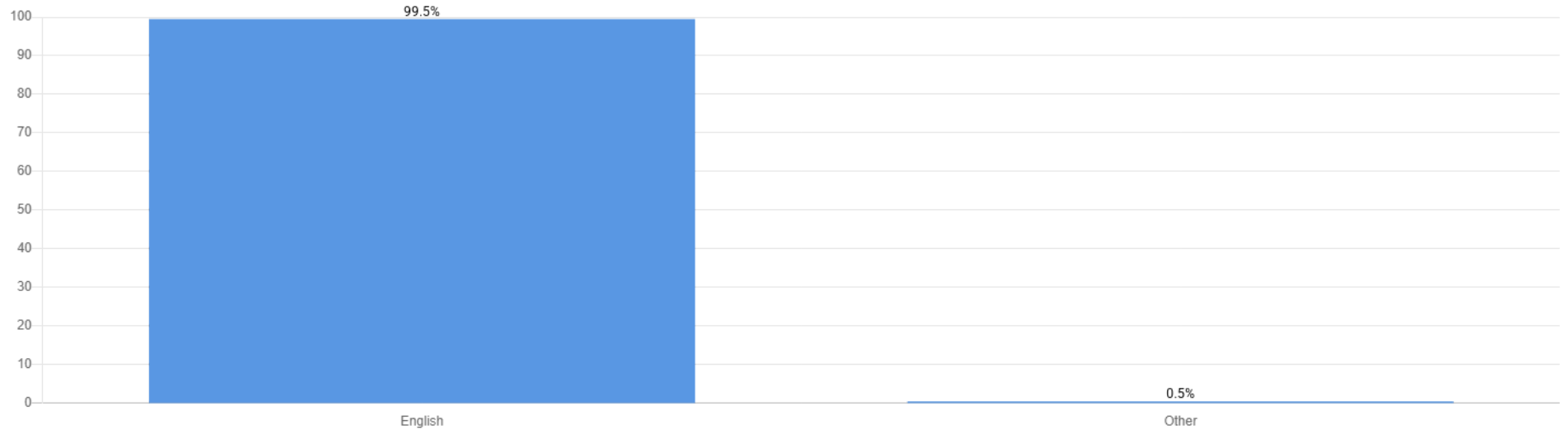

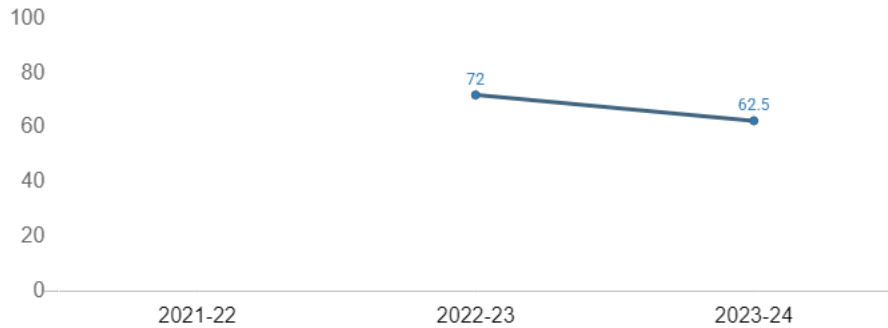

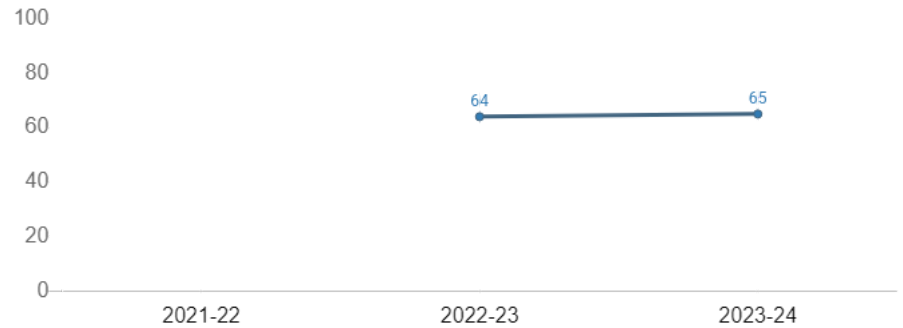

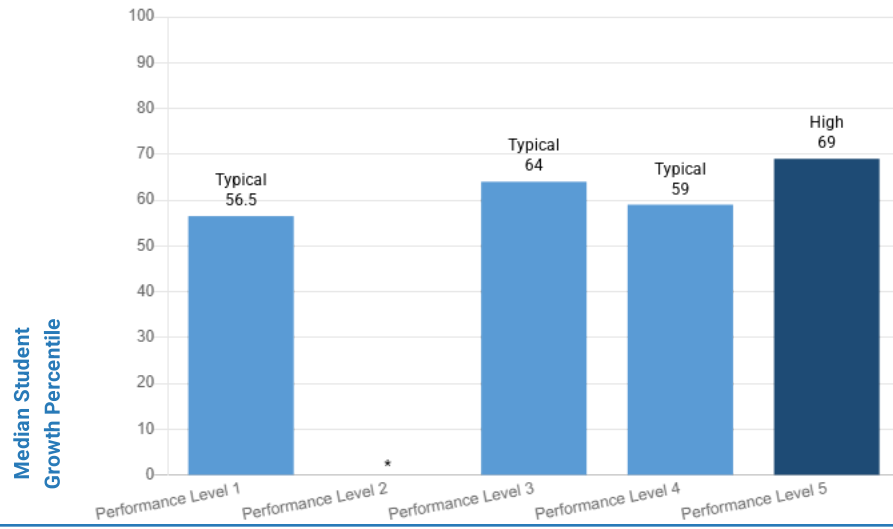

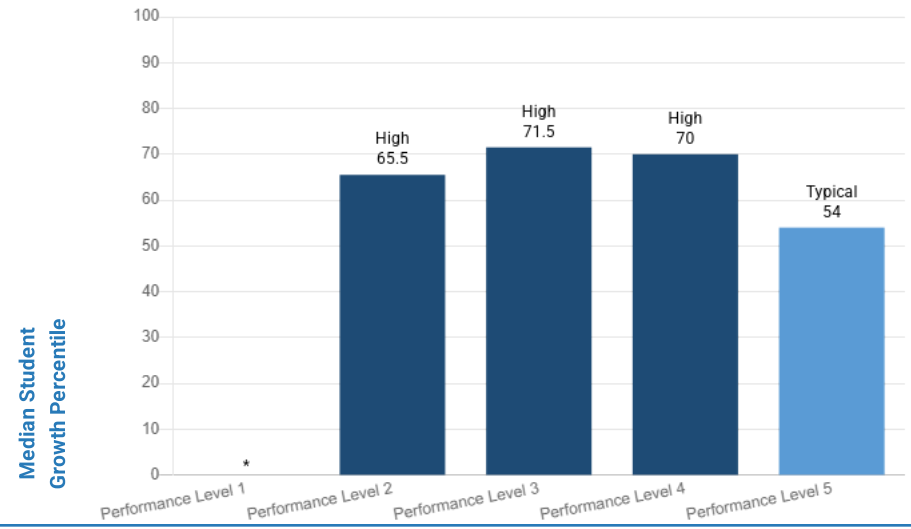

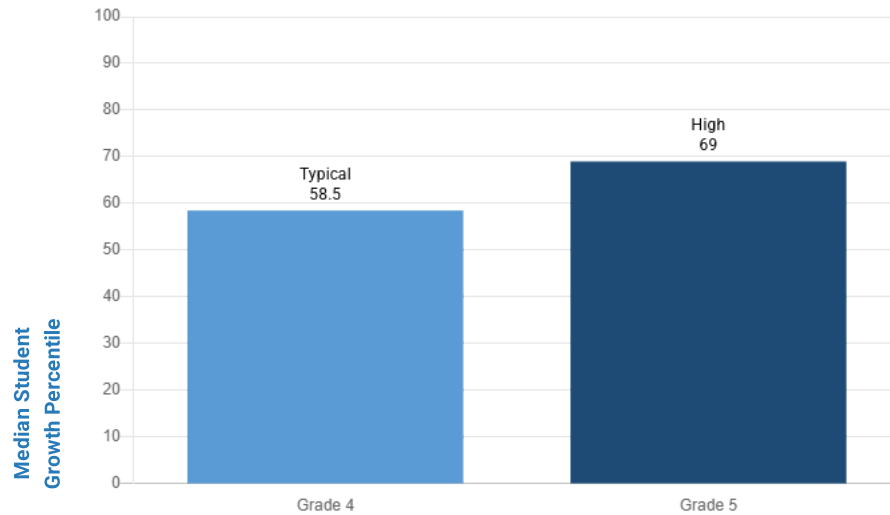

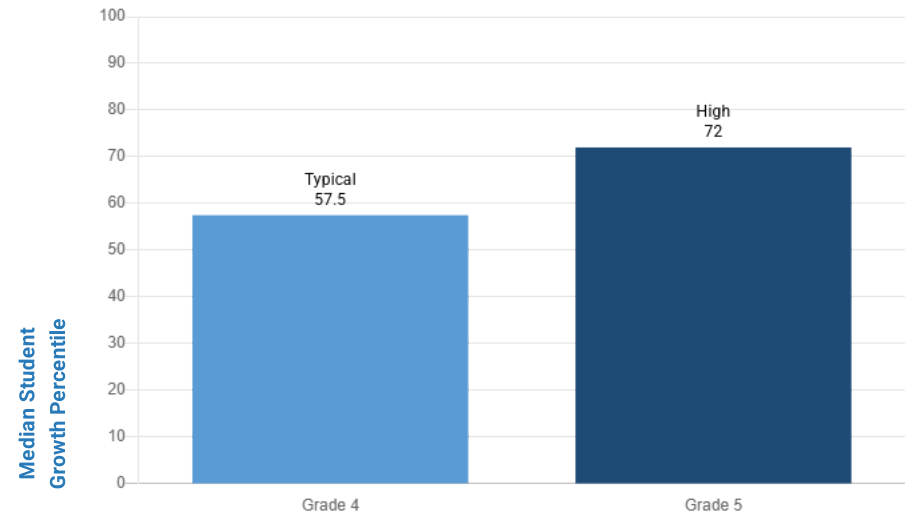

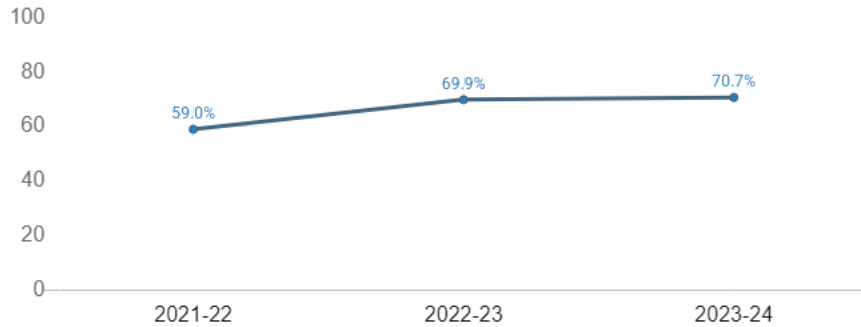

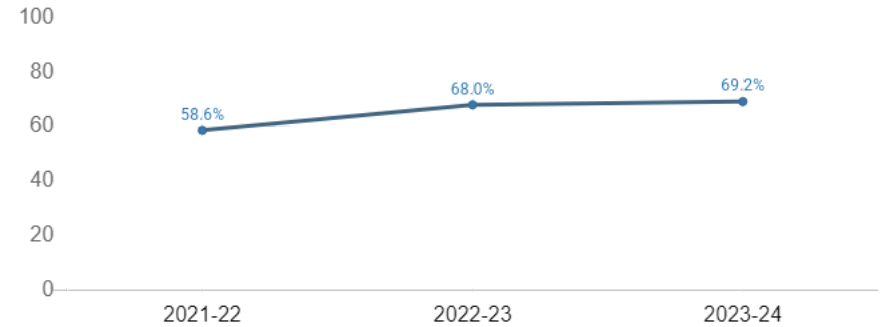
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 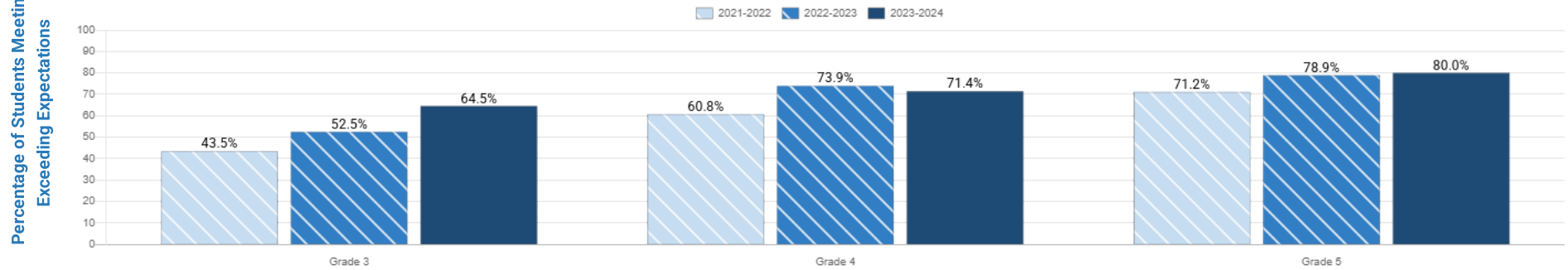

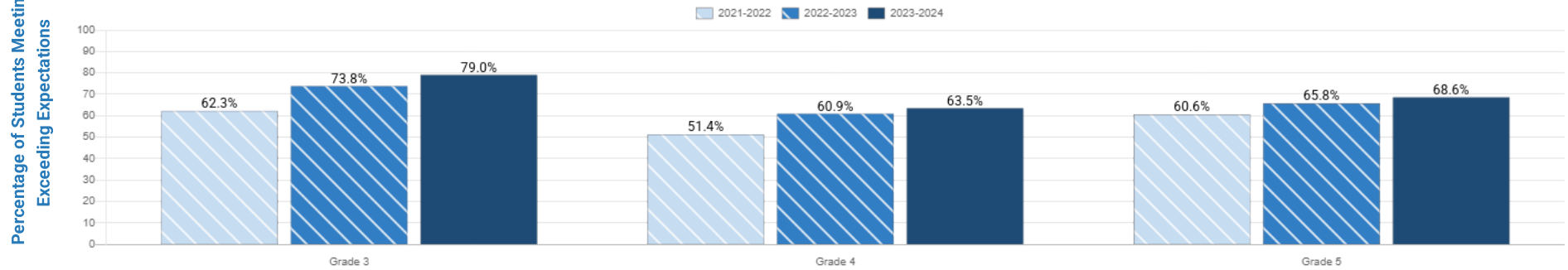

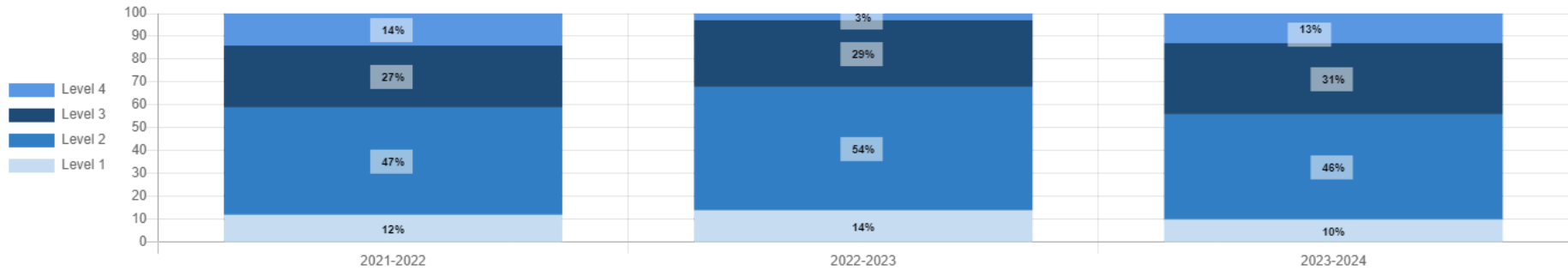

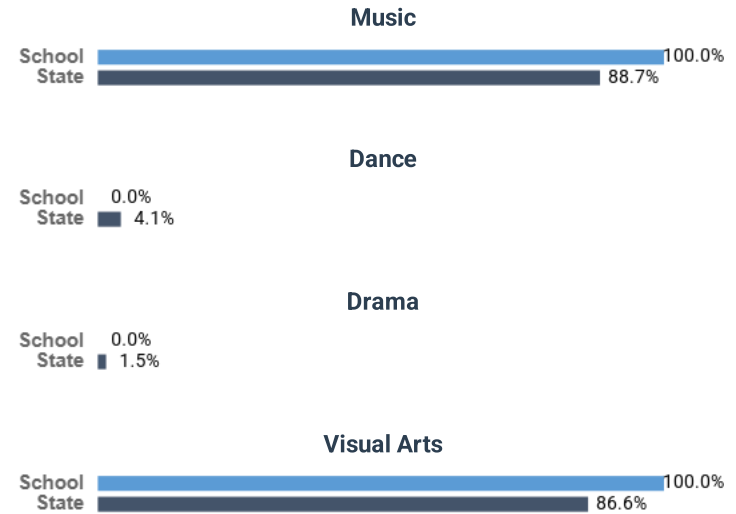

Students enrolled in one or more classes by discipline:



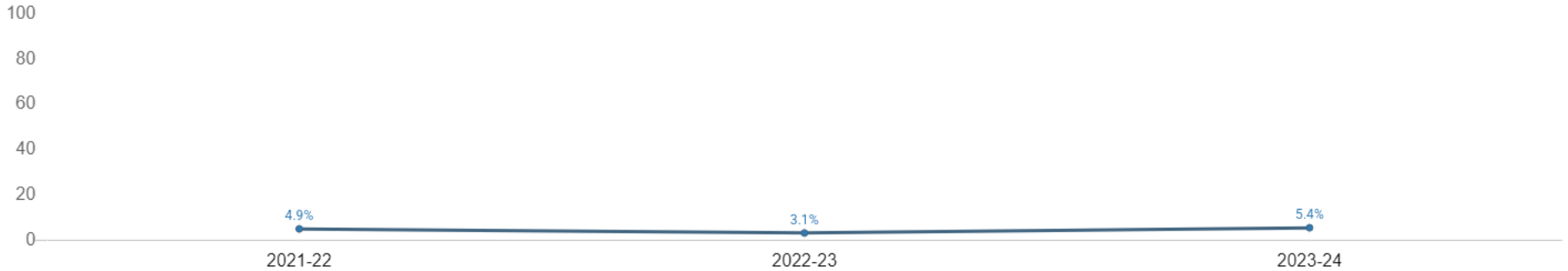

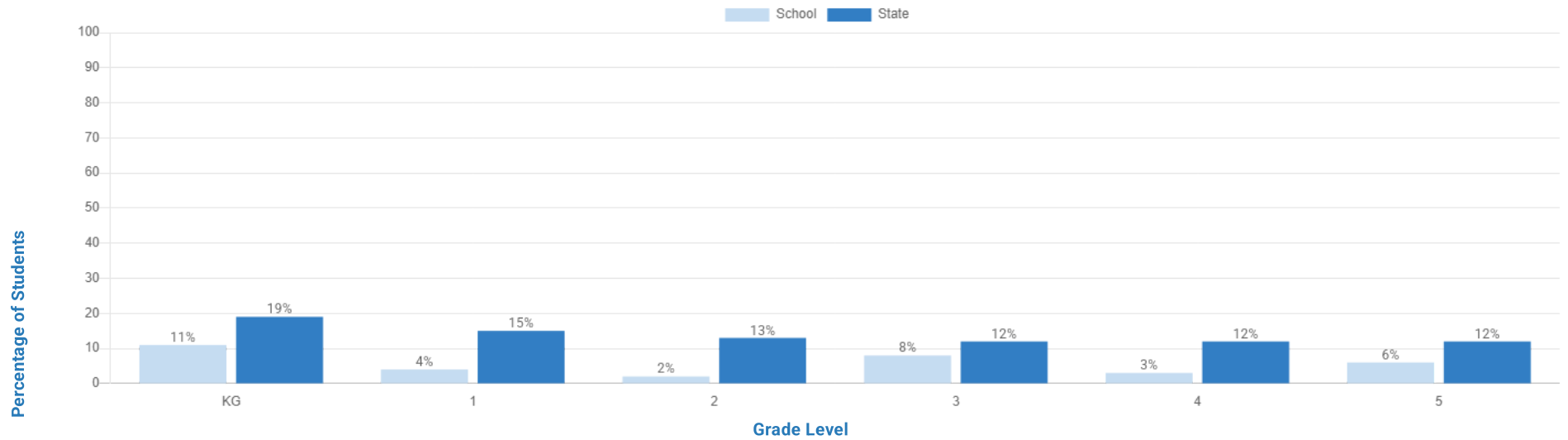

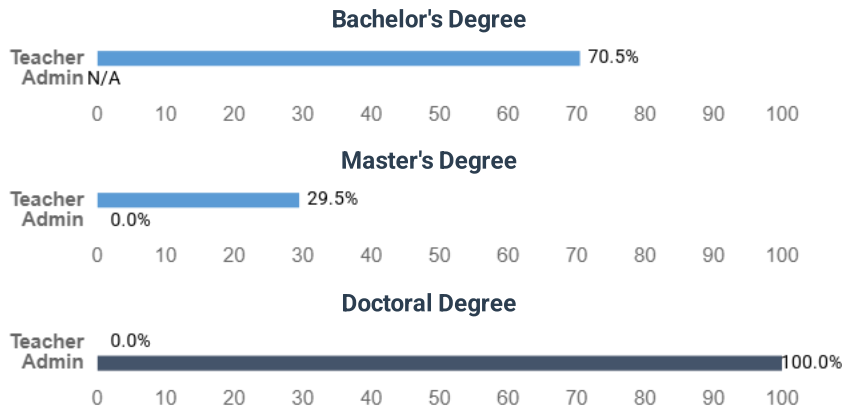

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. - Students participate in art, music, physical education, Spanish, and technology classes each week. Our media specialist provides biweekly lessons in literacy and STEM.

The mission of the Wall Township Public Schools is to empower all students to lead lives of fulfillment and purpose by providing a comprehensive and caring educational environment that will enable students to achieve their unique potential academically, socially and emotionally. Our students will become confident, creative and critical thinkers who communicate effectively and engage meaningfully as responsible members of a global society.



Awards, Recognition, Accomplishments:

At the elementary level, students and staff are recognized for individual accomplishments through morning announcements, monthly Student of the Month recognition, and through our newsletter, Dragons' Dish. Classes are recognized for model behavior in the cafeteria (Golden Spatula Award), management of devices (Golden Chrome Award), and for stellar participation in physical education (Golden Sneaker Award). Each year, one teacher and one education support staff member are chosen by colleagues and community members as the Governor's Educators of the Year.

Courses, Curriculum, Instruction:

Our academic program, anchored by the NJ State Learning Standards, includes English language arts, mathematics, science, social studies, physical education, music, art, technology, and Spanish. Our comprehensive literacy program relies on scientific practices to cultivate readers & writers. EnVision 2.0 encourages our students to develop their math skills through problem-based instruction, visual learning, and small group work. The district has adopted an evidence-based, multi-tiered system of supports to address the needs of struggling learners, both academically and behaviorally. Higher achieving students participate in our Gifted and Talented program. The school has a 1:1 student/device ratio, which is utilized daily by students/teachers. Our Intervention program helps to bridge the gap for students who are not performing on grade level.



Clubs and Activities:

Safety Patrol - Student volunteers help escort primary learners to the buses each afternoon. Theater Club - Interested students rehearse, design sets, and perform for the school community. Student Advisory Board - Select fourth & fifth graders work with administration to design spirit days and initiate new activities. Circle of Friends - Students play games with disabled peers using a reverse inclusion model. Mindset Mentors, students in grades 3-4-5, assist their classrooms during The 7 Mindsets webinars.



Before and After School Programs:

The Parent Teacher Group offers after-school enrichment that includes STEM courses, arts enrichment, and opportunities for physical activities. Students can attend before/after care through the WRAP Program.

Staff and Professional Learning:

The Wall Township elementary staff use weekly curriculum development time to collaborate and design challenging lesson plans including meaningful technology integration. Supervisors lead a monthly meeting dedicated to areas of curricular focus. Teachers are afforded two half-day articulation meetings to share professional discussion with their district grade level colleagues. Teachers are deeply involved in the district's RTI model, which provides a multi-tiered system of supports to meet the needs of at-risk learners. Professional learning is offered as both in-district and out-of-district formats. The district continues to build a cadre of teacher leaders to provide pathways to leadership and to build internal capacity for peer modeling/coaching.



Student Supports and Services:

Allenwood has myriad programs for students with special needs: general education classes, in-class resources, pull-out resources, Emotional Regulation Disabilities K-2, Emotional Regulation Disabilities 3-5, Multiply Disabled K-2, Multiply Disabled 3-5. Services include Speech and Language therapy, Occupational therapy, Physical therapy, BCBA services, Teacher of the Visually Impaired services, Teacher of the Deaf services, paraprofessional support, adaptive physical education, and counseling. ML students enrolled at Allenwood are taught by teachers who have been trained in Sheltered Instruction protocols in order to provide best practices to meet their unique needs as MLs.



Student Health and Wellness:

Student health and wellness is a priority for Allenwood's students. Learners have three days of PE each week (40 minutes/period), daily recess, and healthy lunches. Students participate in Field Days, Wellness Week Activities, and Fun & Fitness Day. The district has also implemented the 7 Mindsets - a program that provides students with strategies for being both happy & successful.

School Safety:

Allenwood School has a contained entrance vestibule that allows for all visitors to be screened before gaining access to the school building. Visitors are checked into a visitor management system; Hall Pass that reads a drivers license and can flag people who should not have access to the school. Allenwood currently staffs two School Safety Officers (SSOs) who are both retired law enforcement officers; the SSOs train annually with the Wall Police Department. Allenwood School uses electronic surveillance monitoring devices in the school building and on school grounds to enhance safety and security for students, staff, community members, and other building occupants and to protect the building and properties. Staff and students participate in two emergency drills per month.



Technology and STEM:

Every student has a device (Kindergarten students have iPads. Students in Grades 1-5 have Chrome Books). Our Technology Teacher pushes into classrooms weekly. Students use Clever to log into various programs including iReady, Reading A-Z, and Google Classrooms.
