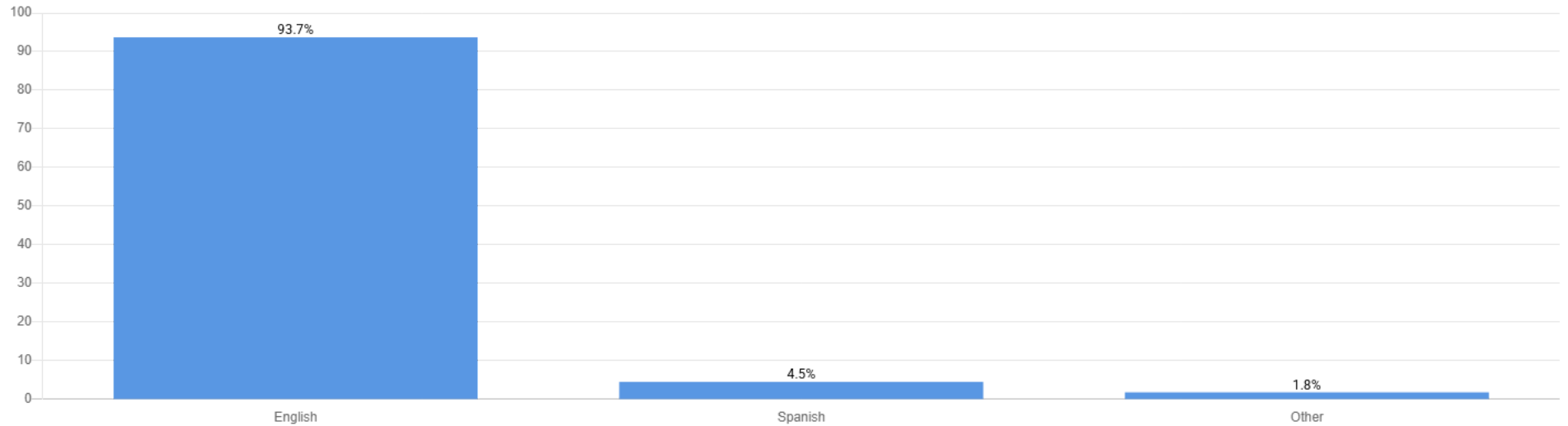

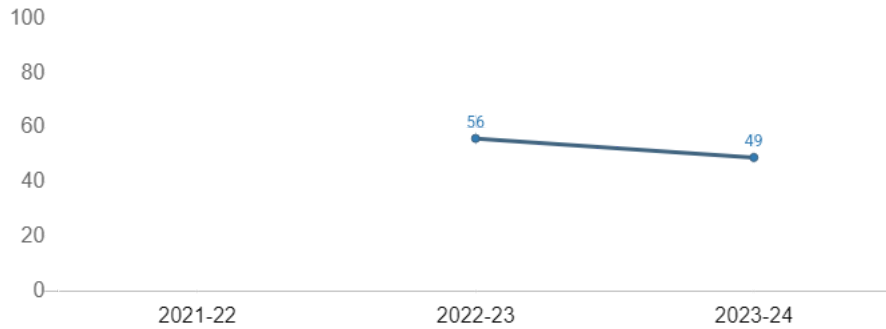

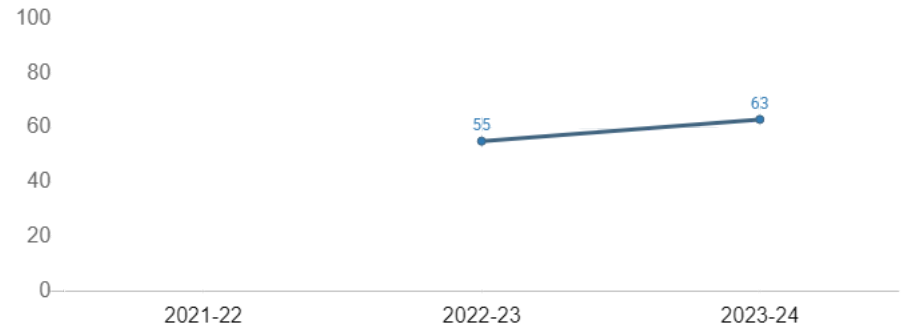

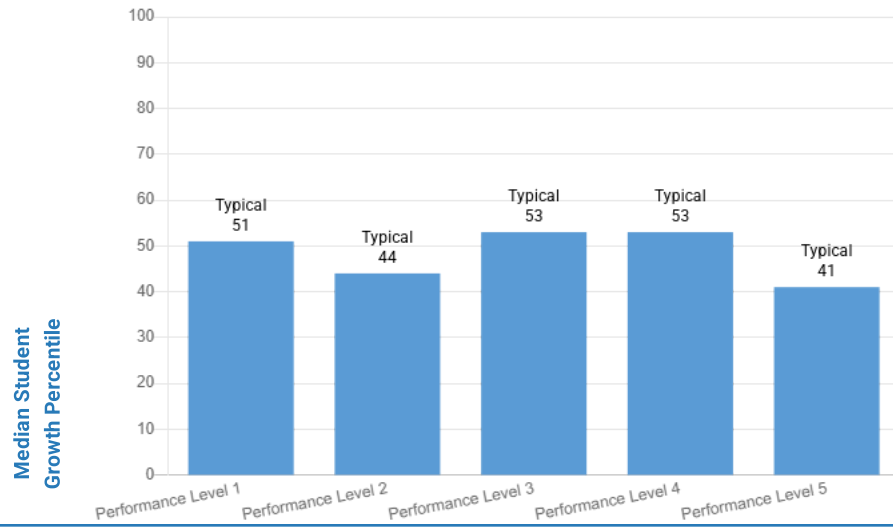

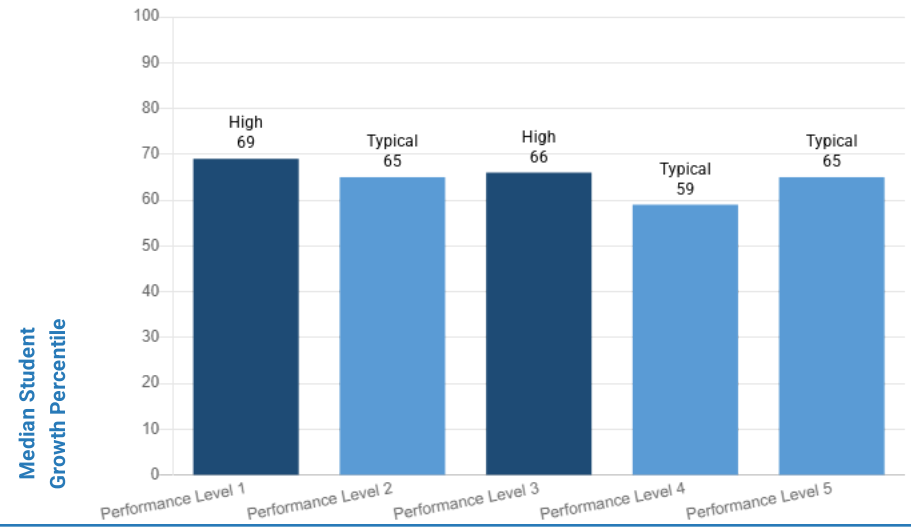

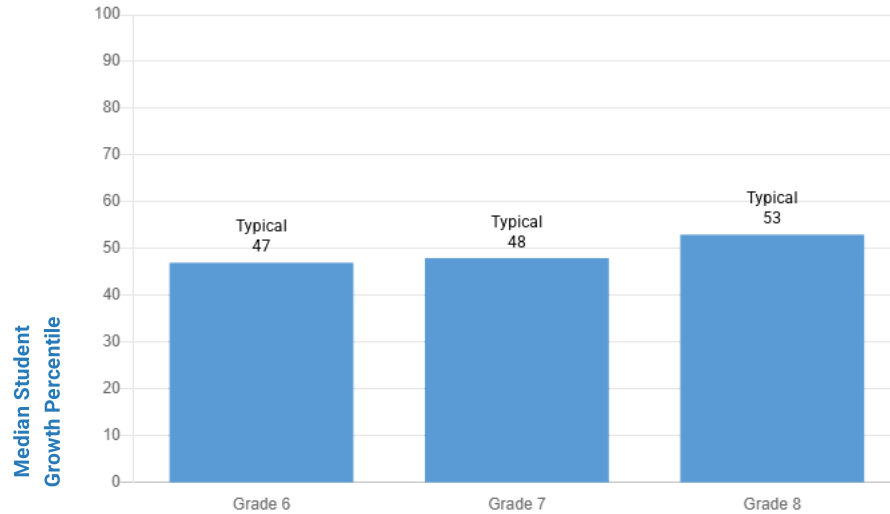

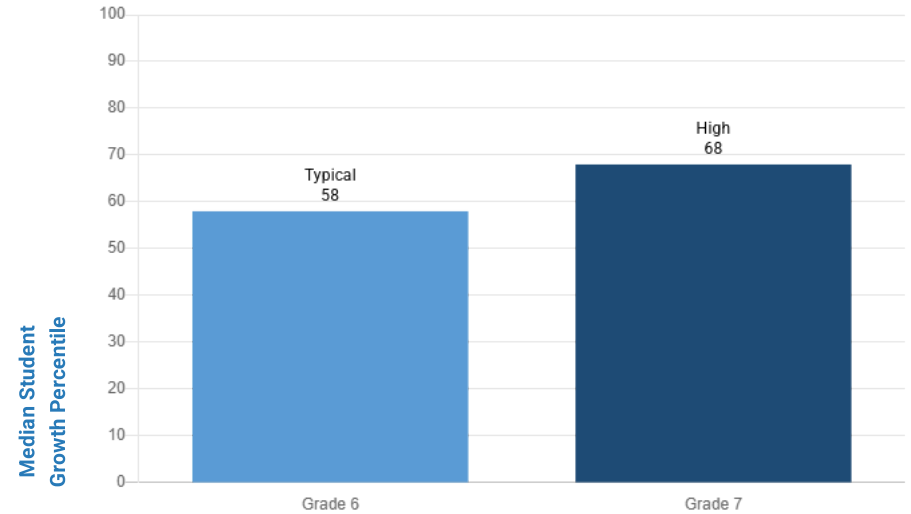

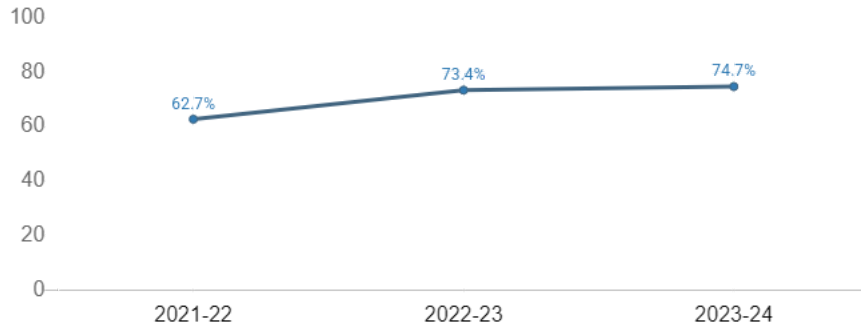

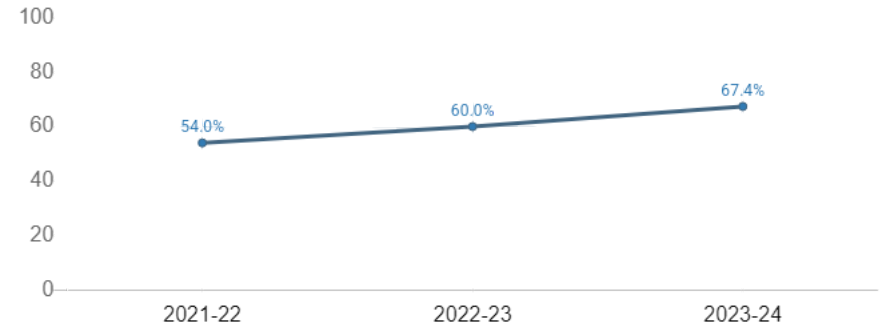
### English Language Arts and Mathematics Performance Trends

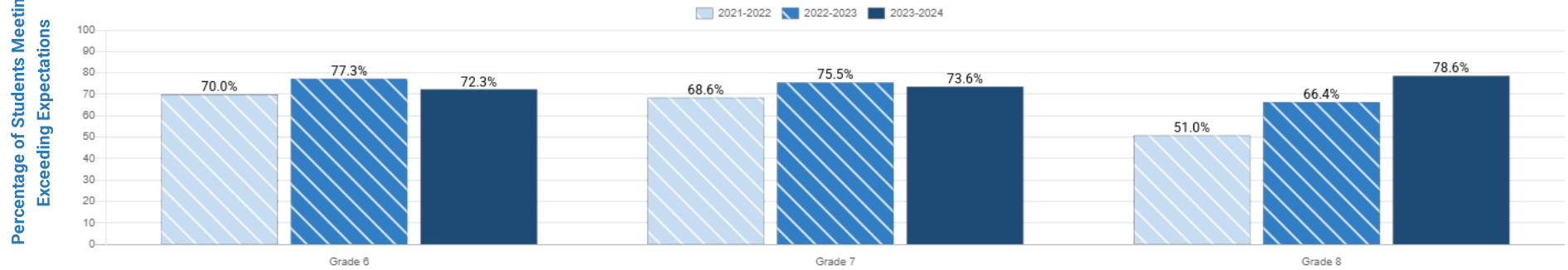

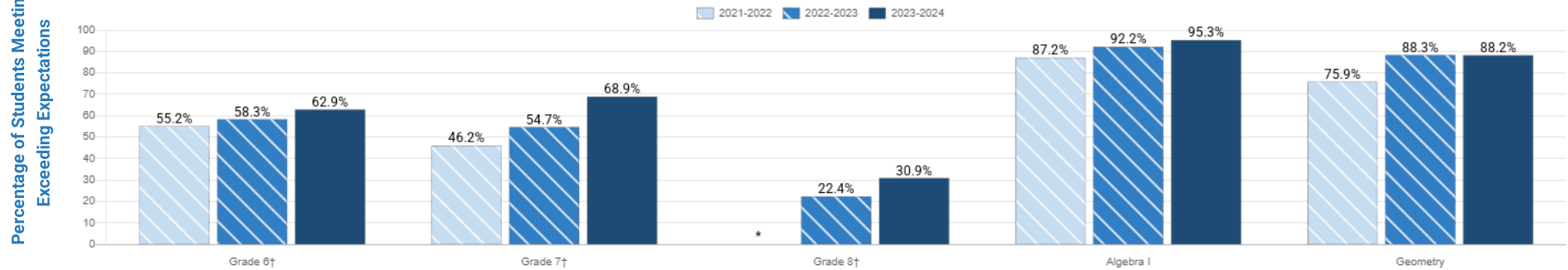

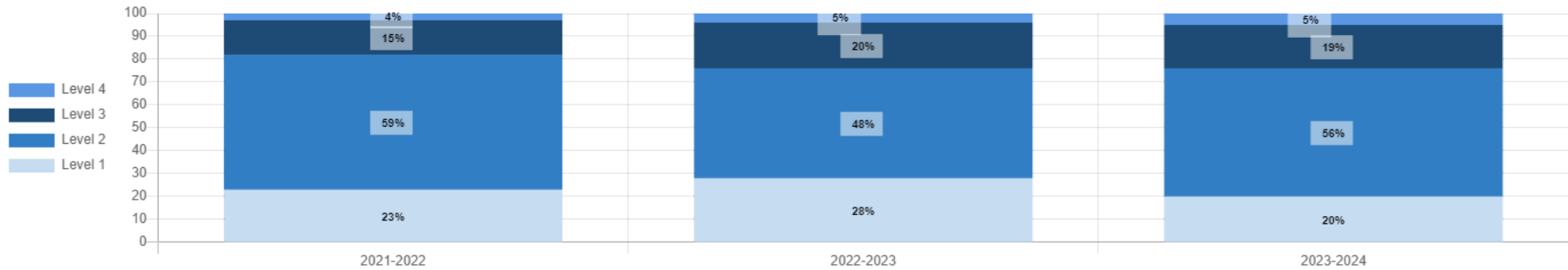

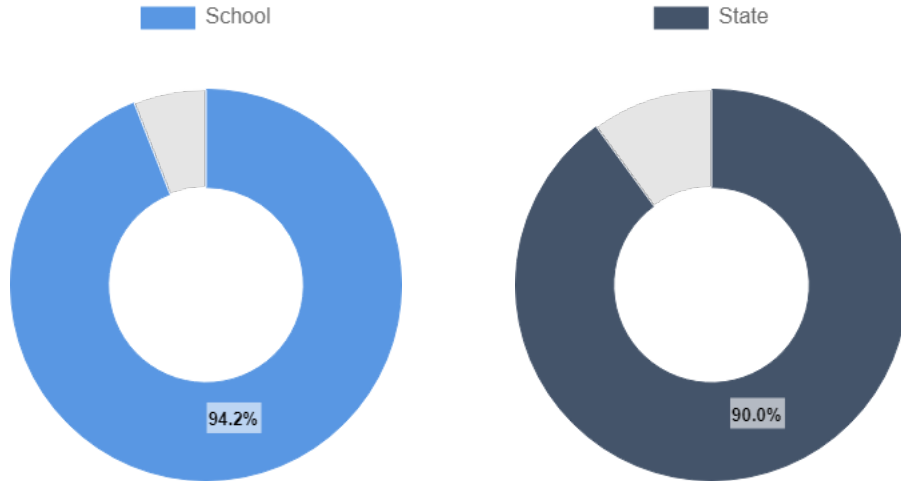

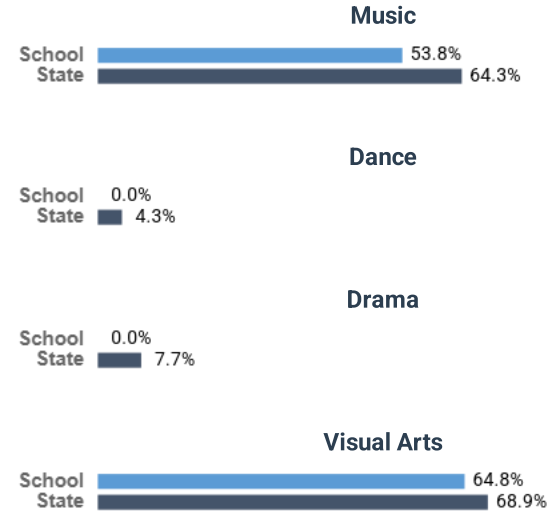

**Students enrolled in one or more classes by discipline:**



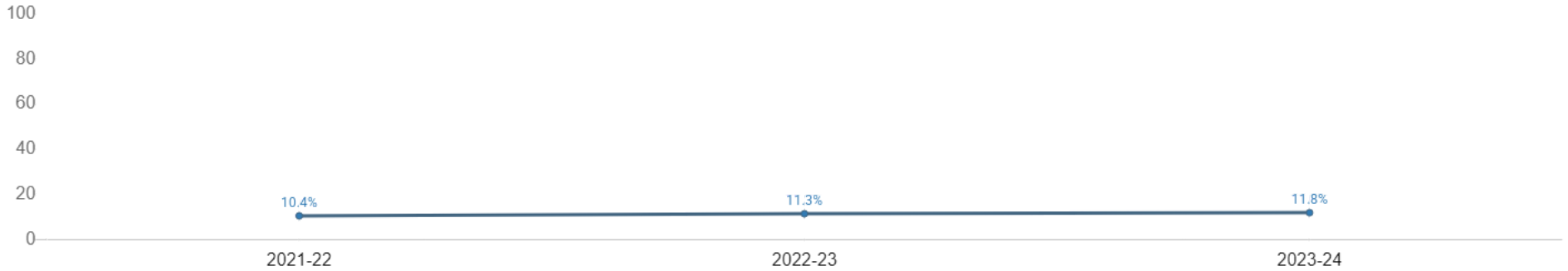

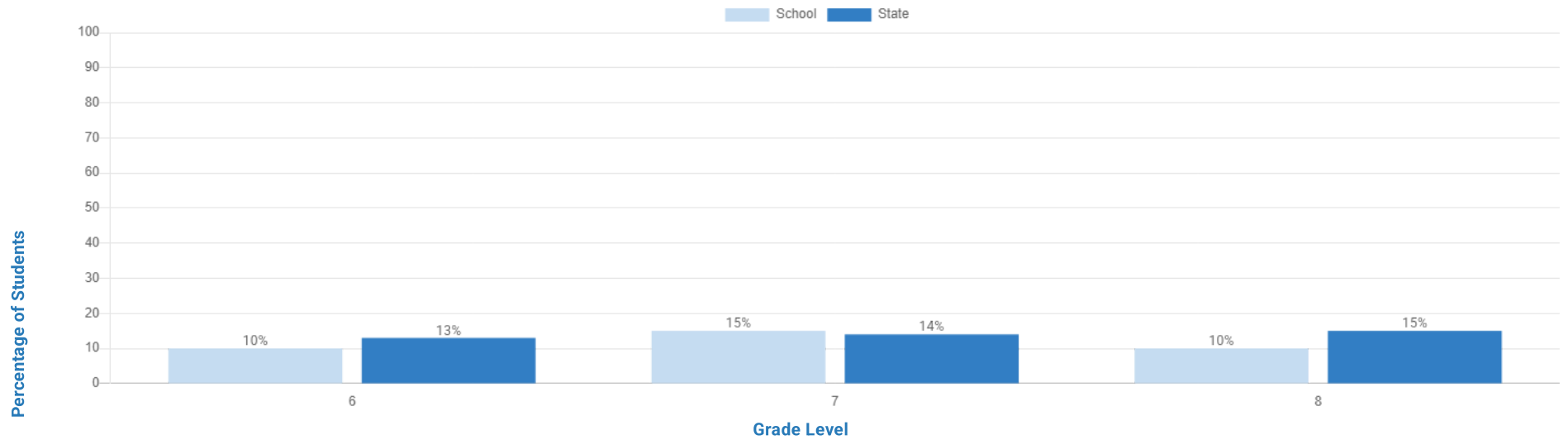

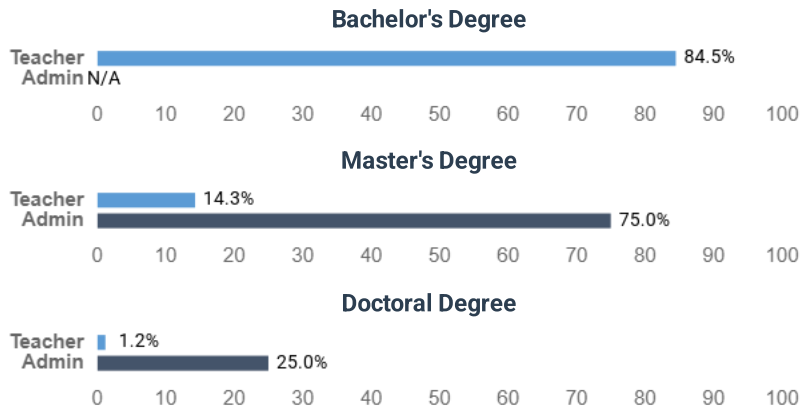

### Courses, Curriculum, Instruction:

At WIS, a student-centered approach to instruction is employed. A 74-minute period of mathematics and ELA is provided to all students daily. About 20% of the population take an accelerated path (Pre Algebra, Algebra & Honors Geometry) while the remaining students use the Envisions program for Math 6, Math 7, and Math 8 or Alg 8. Almost 60% of our students take Algebra 1 before graduating Wall Intermediate School. In English Language Arts, teachers use novels as mentor texts to teach the NJSLs, and students are provided time daily to read at their independent level and actively engage with and hone critical literacy skills. The District has adopted an evidence-based, multi-tiered system of supports to address the needs of struggling learners, both academically and behaviorally. We use iReady in Math & ELA to target learning gaps, so all students can attain grade level mastery.



### Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cheerleading (Coed), Cross Country (Boys & Girls), Field Hockey (Girls), Soccer (Boys & Girls), Softball (Girls), Track and Field - Spring (Boys & Girls), Wrestling (Coed)  
In addition to the many interscholastic sports that are available to students, WIS also offers a seasonal Intramural program in the Fall, Spring, and Winter. ### Before and After School Programs:

WIS offers a before-school and after-school tutoring program. FOCUS is held 2 days per week. Both are targeted intervention programs that are funded with ESSER and ESSA grants. In FOCUS, students work on closing learning gaps in ELA and Math.



### Staff and Professional Learning:

Wall Intermediate School teachers are provided daily curriculum development time to collaborate and design challenging lesson plans, inclusive of meaningful technology integration. This CD period is led by the building supervisor and includes a weekly focus goal to improve instruction and learning. Teachers are deeply involved in the District's RTI model, which provides support to meet the needs of at-risk learners. Professional learning is offered as both in-district and out-of-district formats. The District continues to build a cadre of teacher leaders to provide pathways to leadership and to build internal capacity for peer modeling/coaching.



### Student Supports and Services:

Programs for students with disabilities include: general education classes, in-class resources, pull-out resources, Learning and Language Disabilities classes, and Multiply Disabled class. Services include: Speech and Language therapy, occupational therapy, physical therapy, BCBA services, Teacher of the Visually Impaired and Teacher of the Deaf services as needed, paraprofessional support, adaptive physical education, counseling, and Community-Based Instruction. MLs at WIS receive daily ESL instruction. There are three ESL classes, and students are assigned to their classes based on their current language proficiency levels as determined by a normed assessment. This allows the ESL teacher to provide appropriate and individualized instruction that meets their unique needs as language learners.

### Facilities:

Wall Intermediate School was built in 1966 and has undergone several renovations during its time. The building is scheduled for additional upgrades and renovations during the summer of 2025 and 2026. Currently, the building serves sixth, seventh, and eighth grade students. In addition to traditional classrooms, the school has both a full-sized and auxiliary-sized gymnasiums, 2 art rooms, a large auditorium with theater seating, and two technology labs. While almost all education educational spaces are air-conditioned, the few remaining spaces which are not will be upgraded with HVAC as a result of the recent passing of the referendum.



### School Safety:

Wall Intermediate School has a contained entrance vestibule that allows for all visitors to be screened before gaining access to the school building. Visitors are checked into a visitor management system called Hall Pass that reads a driver's license and can flag people who should not have access to the school. Wall Intermediate School currently staffs two School Safety Officers who are both retired law enforcement officers and who train annually with the Wall Police Department. Wall Intermediate School uses electronic surveillance monitoring devices in the school building and on school grounds to enhance safety and security for students, staff, community members, and other building occupants and to protect the building and properties.



### Technology and STEM:

Students incorporate technology into lessons on a daily basis. Some of the daily opportunities are as follows: One-to-One Chromebooks. All students have access to iReady, the Google Suite, Envisions 2.0, SORA, and BrainPop. Teachers use Hapara to monitor digital activity during the school day. Technology Electives are available for grades 7 & 8: Technology Workshop, Pre-Engineering & Design, and Media Communications. All classrooms are equipped with a teacher computer station, computer-mounted projector, a digital camera projecting and ViVi projection software allowing each teacher to use their laptop to wirelessly project to any location in the school.
