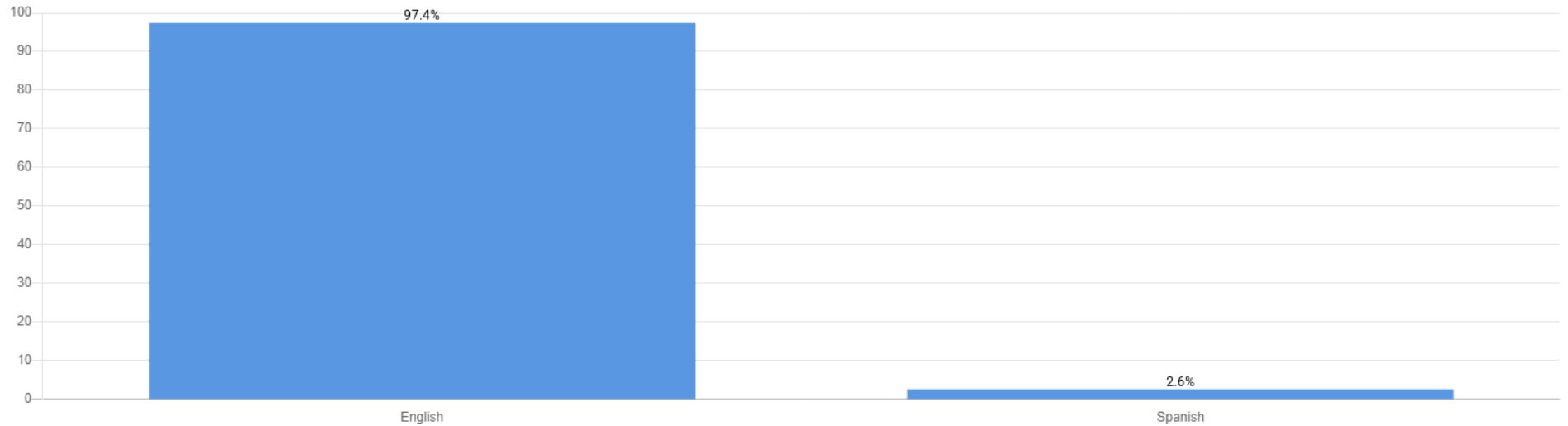

Staff

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 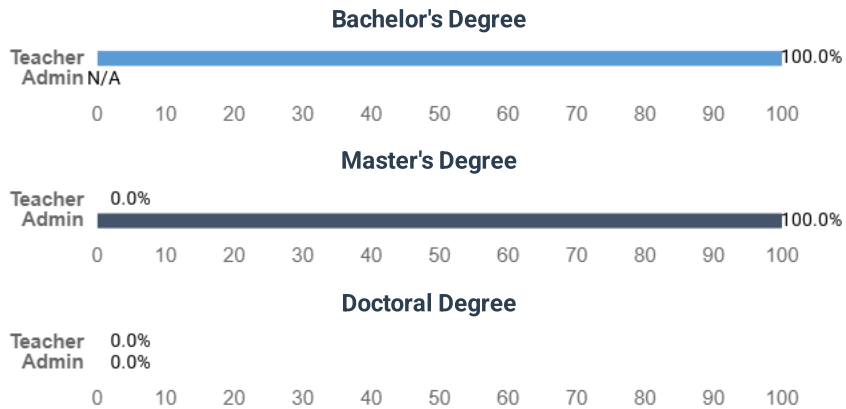

- Wall Primary School provides our youngest learners with a compassionate and inclusive learning environment that will foster and support physical, social, emotional and intellectual growth.
- We offer 2-hour & 20-minute sessions in the morning and afternoon for general and special education students, as well as a 4-hour program for identified students.
- WPS is funded with local funds & Individuals with Disabilities Education Act grants, as well as through tuition for general education students.



Mission, Vision, Theme:

The mission of the Wall Township Public Schools is to empower all students to lead lives of fulfillment and purpose by providing a safe, comprehensive and caring educational environment that will enable students to achieve their unique potential academically, socially and emotionally. Our students will become confident, creative and critical thinkers who communicate effectively and engage meaningfully as responsible members of a global society.



Courses, Curriculum, Instruction:

Using aspects of "The Creative Curriculum" combined with best practices in primary instruction, our teachers have created engaging, multi-sensory learning experiences that cover introductory skills in reading, math, social studies, and science, using a monthly building theme as a backdrop. Additionally, our teachers utilize the "Heggerty Pre-K Curriculum" to infuse phonological and phonemic awareness lessons in order to build strong foundational literacy skills. Art, music, health and physical education are infused throughout all lessons. Our dramatic play area offers opportunities to foster positive social interactions.

Staff and Professional Learning:

The Wall Township Primary School staff uses monthly curriculum development time to collaborate and design lesson plans to support students' needs. The Principal leads three faculty meetings a month, two of which are dedicated to areas of curricular focus. Wall Primary School staff are afforded two half-day articulation meetings to engage in professional discussions with their colleagues on relevant topics. Professional learning is offered as both in-district and out-of-district formats.



Student Supports and Services:

Wall Primary School serves preschool students ages 3-5 in both self-contained and integrated classrooms. Eligible students receive additional services including speech, occupational and/or physical therapy, and BCBA services. Teachers of the Visually Impaired and Teacher of the Deaf services are provided when needed. All classrooms at Wall Primary have at least 2 paraprofessionals for additional support.



Student Health and Wellness:

Preschool students are taught daily hygiene routines throughout the school day. Proper handwashing is stressed. Healthy eating habits are fostered through our curriculum. Students participate in daily gross motor activities encouraging play, self-regulation, and healthy friendships. Vision and hearing screenings are conducted by our school nurse.

Facilities:

Wall Primary School has undergone several renovations during its time. The most recent renovations occurred in summer 2024 resulting in all bathrooms becoming handicap accessible. Currently, the building serves general education and special education students, ages 3-5, who are in our district preschool program. Wall Primary School currently has 4 classrooms, 3 therapy rooms, and several office spaces. All educational spaces are air-conditioned at this school.

School Safety:

School safety and security are paramount at Wall Primary School. We have a contained entrance vestibule that allows for all visitors to be screened before gaining access to the school building. Visitors are checked into a visitor management system called Hall Pass that reads a driver's license and can flag people who should not have access to the school. Primary School currently has two retired police officers who share the role of our School Safety Officer. Both officers train annually with the Wall Police Department. Primary School uses electronic surveillance monitoring devices in the school building and on school grounds to enhance safety and security for students, staff, community members, and other building occupants and to protect the building and properties.



Technology and STEM:

Although all of our classrooms are equipped with interactive Activboards, it's important to note that we intentionally minimize the use of technology at this level.



Early Childhood Education:

Wall Primary School provides exemplary, student-centered instruction for preschool-age students. Our students rotate through a variety of both independent and teacher-directed centers, using aspects of "The Creative Curriculum." Additionally, teachers provide instruction in the "Heggerty Pre-K Curriculum," aligned to the Science of Reading, to ensure research-based early literacy practices are implemented with the preschool students.
